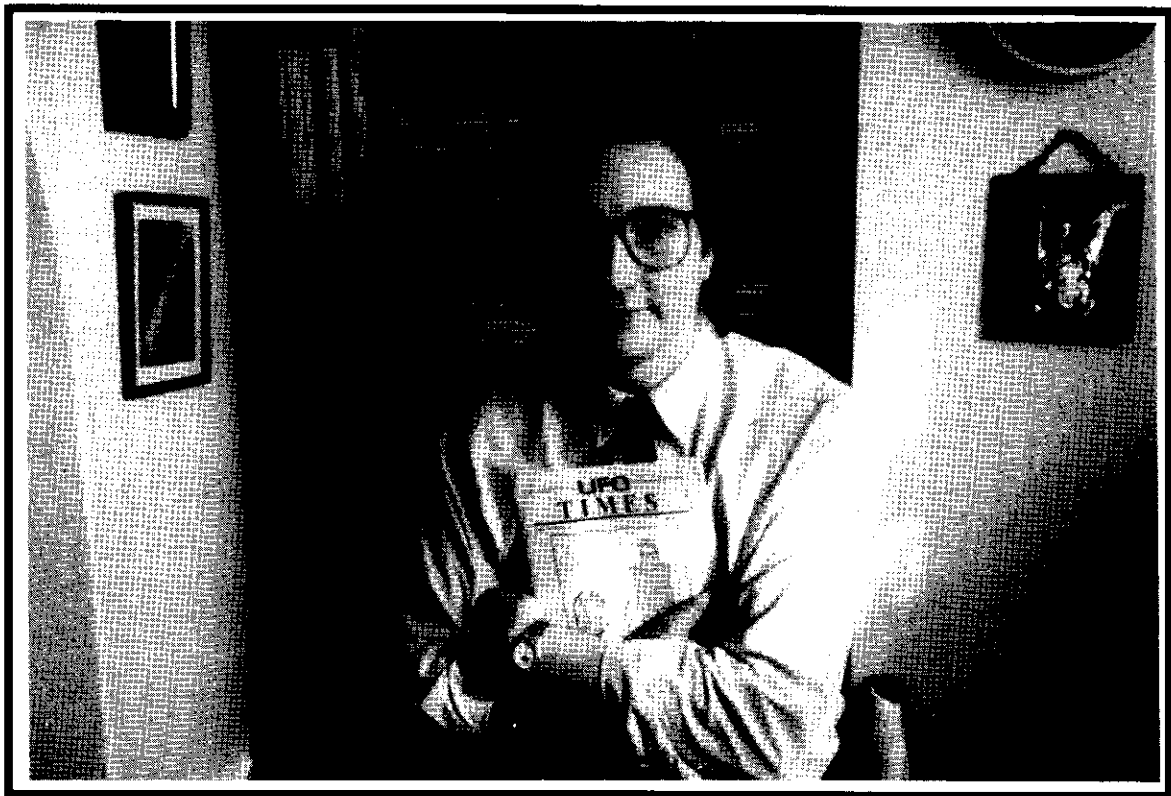

ALIEN ENCOUNTERS *ARE THE UFOs EVIL?* by Gordon Millington

Students of UFO phenomena cannot avoid developing hypotheses, bundling them into explanatory paradigms in the hope of drawing nearer, if not to a final solution, at least to a better understanding of the problem. These are by definition provisional, yet in every sphere of intellectual endeavour there are some who cannot live with uncertainty. They demand answers where as yet there are none, and will therefore create the certainty they crave. This emotional satisfaction will quell the mental discomfort induced by uncertainty, especially when shared by others of like mind.

Such was apparently the case with groups of fundamentalist Christians in the 1970s who, perturbed by the inexplicable character of UFO phenomena and yet unable to dismiss them as totally illusory, the usual defence mechanism in such cases, came up with a solution of some ingenuity which effectively reconciled the problem within their personal religious context. They decided that the ufonauts wereimps from the astral, sent by Satan as part of his ongoing plans for the subversion of mankind.

Representative of this philosophy is a book entitled *UFOs – What on Earth is Happening?*, and subtitled *The Coming Invasion*, by John Weldon and Zola Levitt (Bantam 1976), the source of all subsequent page references. The authors' position is not one liable to much change over time and still has its adherents. It certainly cannot be disproved, and on the flyleaf of their book they summarize it thus:

"We are not the first people in our world's history to see UFOs. Records of sightings exist from all periods, but to-day's sightings are accelerating in number. We think demons are behind this startling phenomenon, and we think their activity is connected with the upcoming Tribulation period."

The demons to which they refer have no connection with the Socratic daemon, but are the fallen angels of biblical theology, expelled from Heaven for rebelling against God and henceforth implacable enemies of both divinity and humanity, working against mankind by tempting him to make use of occult powers which will encompass his downfall. "As thinking members of a global society about to be brought to its final denouement by the activity of incredibly evil forces," they warn, "we mean to sound an alarm." (p.99) They

are warning of the coming of Antichrist, a diabolically clever and very evil ruler mentioned in the biblical book of 'Revelations', and they believe the UFOs to be his allies and agents.

The writers did not, like most of their American compatriots at that time, embrace the Extra-Terrestrial Hypothesis, arguing first that there was no evidence for the existence of planets outside our own solar system and secondly that in any case demons needed no planetary bases and could operate anywhere; in this sense only were they accepted as extra-terrestrial, since they were not held to be native to Earth. The authors give an exhaustive list, supported by biblical references, of the powers demons are said to possess, correlating these with reported behaviours of UFO occupants. The fallen angels are said to imitate good spirits and provide predictions, accurate initially but finally proving false; to control human minds and perceptions and assume human form, making physical contact with mankind, materialising or dematerialising at will, but always having the intention to harm and often the power to kill. (p.84) On a point of logic, though it may be true that both demons and ufonauts possess such powers, it does not therefore follow that each must necessarily be equated with the other.

Our authors are indeed unduly willing to ascribe great powers to the ufonauts, asserting for instance that their craft never crash or suffer malfunctions. They are also rather naively impressed by the "star map" supposedly recalled by abductee Betty Hill and "located" in space by Marjorie Fish. Though the recall under hypnosis may have been honest enough, the "map" itself is patently spurious and ludicrous as a navigation aid. Desire to

identify UFOs with occult evil easily leads to further logical fallacies, such as the following:

"Darkness is common to both UFOs and the occult. Coven rituals among witches, black magic ceremonies, seances etc. are invariably performed at night or in darkened rooms. Much of the automatic writing experienced by occult adepts occurs between 2.00 a.m. and 4.00 a.m. Similarly, UFOs prefer the night hours." (p.108)

So too of course do cats, badgers and all manner of nocturnal creatures not notably diabolical, and there have been plenty of daylight UFO sightings. Though it is to the writers' credit that their researches have provided them with plenty of valid UFO information, it is too often used to insinuate assertions the facts simply do not support. If UFOs do have evil connections, we shall need better proof of it. Similarly, UFO manoeuvres are said to be "scientifically" impossible (p.109), yet it is acknowledged that they do occur, in which case they can only be impossible in the light of some unscientific definition of science, for the impossible can never happen.

Having ruled out the ETH, the Christian fundamentalists needed a tenable origin for the occult UFOs they were postulating and found it in an early, unsophisticated exposition of the parallel universe theory. "This parallel world, as we are styling it," they wrote, "is a very full world, occupied by a variety of beings and entities, rather like the world we can see," (p.130) and went on to remark (p.113) that weak spots in the earth's crust produce corresponding weaknesses in its "psychic envelope", "gateways" through which occult entities from this parallel world can enter our own.

There is some support for this view in Charles Bowen's account of the Spectre of Winterfold (Flying Saucer Review, Vol.14, No.1 1968) which occurred at Hurtwood near Cranleigh in Surrey, haunt of the eerie 'Surrey puma'. It was in November 1967, towards the end of the major British UFO flap of that year, and took place near Pitch Hill, where UFOs have since been sighted. A young couple from Woking, driving home at night through the narrow, lonely lanes, stopped to wipe a misted windscreen. Philip Freeman got out of the car to do this and became aware of an unpleasant, sulphurous odour. Returning to the driver's seat, he saw a blank, featureless 'face' looking in through the passenger's window, faintly luminous and reaching an arm over the car's soft top. His companion, Angela Carter, seeing the horror in his looks, averted her eyes. Philip felt terrified and physically chilled. He managed to drive off, for he had not stopped the engine, and glimpsed the creature again in his rear view mirror. Similar incidents, such as the Flatwoods monster which emerged from a UFO in West Virginia, have been reported from the USA, and the sulphurous smell would certainly accord well with medieval ideas of diabolism.

Angela was probably wise to veto Philip's macho suggestion that they turn back to see the entity in the beams of the car headlights if it is true, as Weldon and Levitt assert, (p.106) that the proximity of an evil spirit produces nausea and actinic burns. They compare these effects with those reported by humans who have undergone a close UFO encounter of the third kind (CE3) and equate ufonauts with elemental spirits invoked by cabalistic magic. They also suggest (p.146) that the magnetic fields produced by UFOs may produce hallucinations through their effect on the brain. "We believe", they say, "demons can induce a whole series of experiences that, in fact, never happened." (p.147) It all depends, of course, on what you mean by 'happened'.

They instance a number of people said to have been deluded by these demons and pay special attention to Uri Geller, whose psychokinetic demonstrations have attracted widespread scientific interest. It appears that in June 1974 Geller claimed, in an article published in *Psychology Today*, to be merely a channel for energy directed through him from another universe,

and in collaboration with Israeli physician Dr. Andrija Puharich, to have been in communication with various extra-terrestrial entities. Some of these are described as android computers, others as humanoids from the unknown planet Hoova, where the normal lifespan is allegedly one million years. Another group claim to be from the far future.

Geller and Puharich are said to feel uneasy about their experiences, wondering if they are being made the victims of some enormous joke, but the fundamentalists have no doubt that demons are manipulating them and are certainly not joking. "Quite simply," they say, we think the demons are preparing the coming of Antichrist," and the UFOs are said to be producing the kind of changes in the collective psyche of mankind that will usher in the Great Tribulation of the seven-year rule of Antichrist, "the full wrath of God", who will, however, have first collected up all the Christians and placed them somewhere safe before the tribulation starts. Since all this is predicted in the Bible, it is presumably held to be inevitable, but Weldon and Levitt do stress that salvation is available to all who choose to avoid the tribulation by embracing Christianity in time. Moslems, Buddhists and Jews, not to mention agnostics and atheists, they say, can expect a hard time from Antichrist, who is coming fairly soon. "Concrete predictions of the prophets, such as the restoration of Israel, the common market, world ecumenism, famine and a host of others are present in the world right now, and they implicitly announce the end." (p.153) The true function of UFOs in the scheme of things has thus been revealed to the fundamentalists - they are here to warn us against getting tribulated by the future world dictator and their evil intentions have thus been subverted into salutary warnings for humanity.

The relationship, if any, between UFOs and spiritual evil remains of necessity an open question, but it is undeniable that humans who have experienced close physical contact with UFOs and their occupants have invariably been damaged in some way, though in most North American and European instances they have seldom suffered permanent harm. Such cases seem to indicate that the physical suffering inflicted has been incidental rather than intentional, so that the UFO occupants have appeared at worst uncaring rather than malicious. In the USA, the death of P.51 pilot Captain

Thomas Mantell in 1948 was promptly ascribed by the US air force to chasing the planet Venus, and when this was shown to be untenable the story was changed to one of an encounter with a naval weather balloon. We shall probably never know what caused Captain Mantell's decapitated body to be found in the wreckage of his aircraft after chasing a UFO to thirty thousand feet, when his three companions, who certainly did not have oxygen, levelled off at half that height. Mantell, however, a veteran pilot who had set off from a different airfield, could well have had oxygen, since it is difficult to imagine a pilot of his experience flying to such a height without it, unless of course something had happened seriously to disturb his judgement. He had radioed to Godman tower: "It's above me ... it appears metallic and to be tremendous in size ..." (Emenegger 1974)

In October 1978 Frederick Valentich, twenty years old and much less experienced, was flying a Cessna 182 over Bass Strait and in constant contact with Melbourne control. In this case the UFO was doing the chasing and he radioed: "It's not an aircraft ... It's got a green light and sort of metallic like. It's all shiny on the outside." And then: "Ah - Melbourne - that strange aircraft is hovering on top of me again ... It's hovering and it's not an aircraft!" His last call ended in silence and nothing was ever heard or seen of pilot or aircraft again, despite an intensive search. (Randles 1987)

In neither of these two cases is there more than a suspicion that the pilots died because of some action of the UFO, and certainly many other cases of UFO sightings and close approaches to terrestrial aircraft have been reported in which no harm at all was suffered by anyone. In Puerto Rico, however, Jorge Martin has described how, in full view of more than sixty witnesses, two US Tomcat F14 jet planes were "absorbed" into an enormous triangular UFO on 28 December 1988, preceded by a similar incident on 16th November, when two more planes were lost. Martin was told in confidence that radar tapes recording the incidents had been sent to Washington for analysis. (Martin J. in Good (ed.) 1990) Exceptionally high levels of UFO activity have since continued to be reported from Puerto Rico in successive years.

In recent years South America, and Brazil in particular, has suffered from the attentions of some especially vicious types of small UFO quite different from any encountered in North America or Europe. Bob Pratt, an American journalist who has investigated hundreds of such incidents in the area, says that "...nowhere have I found cases more fascinating – or more frightening – than in north-eastern Brazil ... UFOs have been terrorising people for at least ten years. They have injured some people and, I believe, killed a few." (Pratt B. in Good, *ibid.*) The most common instruments of the terror by night are rectangular objects the size of refrigerators, called 'chupas' by the deer hunters and fishermen who are their principal victims. They are said to produce a humming sound of constant pitch and to be equipped with one light on the bottom and another at one end which projects a beam, often seen as red. Bob Pratt described a typical case in which a man named Chico Gama in February 1981 at a place called Pecem went to fish on the beach one night. Two hours after midnight he was struck from above by a beam of radiation, experienced as light, from which he tried in vain to escape, as for three whole hours the chupa pursued him relentlessly. The beam left him shivering and progressively weaker, inflicting long term physical and psychological damage. This remorseless pursuit is more characteristic of a robotic machine that has locked on to a target than of a piloted craft, especially as there would be little space in a chupa even for one of the Bebedouro gnomes. Indeed, since it has been regularly observed that even the momentary flash of a cigarette lighter has been enough to attract its attention, just as any form of light is known to do, the chupa may in fact be some form of phototropically controlled source of intense microwave radiation, launched by whom and for what purpose we can only guess.

Jacques Vallée (1990) has also studied the chupa phenomenon and describes in his book the deaths of three men attacked in the area of Parnarama. Most of the available evidence from Brazil necessarily comes as hearsay from unsophisticated villagers, but experienced investigators have found it convincing and have often been able to interview the witnesses and see the after effects of their ordeals. Teams from the Brazilian air force have also conducted protracted studies, though

their findings have not been made publicly available. Vallée also describes how a concerted attack by a variety of UFOs, some twice as large as jumbo jets, continued for several months in 1977, causing almost the entire population of the island of Colares to flee in terror. Dentist, school teachers, even the sheriff, all fled to the mainland. Only the woman doctor in charge of the community health centre stayed at her post to note the effects of the powerful white beams of the invaders. From her evidence Vallée concluded that "UFOs are able to focus on selected human beings a beam of radiation that contains, among other things, pulsed microwaves that interfere with the central nervous system. Such a beam could cause the dizziness, headaches, paralysis, pricklings and numbness reported to us by so many witnesses. (*Ibid.*)

The military teams sent by the Brazilian government operated in full view of the public and are known to have obtained photographs, cine films and tape recordings to support their reports, but as Vallée concludes: "The evidence that has now been obtained by the major powers is so valid and it has such devastating implications for future military systems that the decision has been made to keep it under lock and key..." (*ibid.*)

Extraordinary cases involving death or severe injury have been reported from Brazil for at least forty years and Vallée (*ibid.*) has recounted a selection of them. The standard of verification is often less than adequate, but even if one were to suppose them merely folklore their content would still be most surprising. In 1946 Joao Prestes Filho, a villager returning from a fishing trip, was said to have been stunned, blinded and felled to the ground by a beam of light at his own front door. Witnesses claimed that his flesh detached itself progressively from his bones for six hours until he died, remaining fully conscious to the end. In 1962 Rivalino do Aleuia Mafra was called out of the house by his son to see what he later described as two large balls floating side by side in mid-air, emitting a humming sound. As his father walked towards them, the two spheres merged into one, emitting smoke that darkened the sky. Surrounded by a yellow, acrid fog, the father disappeared inside the cloud. The smoke dissolved and there was total silence but no trace of Rivalino, who was never seen again.

In 1976 Luis F. Barros, a wealthy business man and rancher, reported that

a large luminous object had projected a beam of light at him. Suffering at first from nausea, headaches and diarrhoea, after three months his speech deteriorated and his hair turned white. Six months after the event he had regressed to an infantile level of inertia. A number of less spectacular, though equally fatal, cases have been more credibly reported during the 1980s. Though all seemed to have varying degrees of association with some kind of UFO, no one has yet been able to explain the vicious and apparently random nature of these evil attacks.

Brazil is a vast country with poor communications and a little – known interior. The full extent of the UFO operations there and the intentions behind the imposition of this reign of terror can only be surmised, but it is scarcely surprising that Bob Pratt should have described his impression of the situation there as "frightening". We can have no certainty that the appalling experiences of the Brazilian peasantry will not be duplicated elsewhere, now that the techniques for doing so have apparently been tested and refined in the relative remoteness of their hinterland. If the government in Brasilia is taking any steps to protect its citizens, they have not been told of them. And all the negatives taken by news photographers at the time of the 1977 attacks are said to have been purchased by a nameless firm in the USA.

From Puerto Rico, Jorge Martin ends his latest report with a daring speculation that may also be relevant to Brazil:

"Due to the amount of activity here, I sometimes wonder if Puerto Rico has been selected as a place where open contact with an alien species will be tested, to check on the psychological and sociological reactions of such a contact. We must remember that Puerto Rico is a US territorial possession ... In the US and abroad, many believe that an agreement exists between the US government and a certain species of aliens. Although there is no specific proof, there is a lot of circumstantial evidence that in my view seems to imply just that."

THE FINAL SECRET OF FREE ENERGY – Part III

Energy Is Internally Infinite and Unlimited: A static potential – which is identically excess *energy* – is internally dynamic and infinite. Energy is internally infinite and unlimited! But it has finite *energy density* in a local region of spacetime. Since energy interacts with matter locally, we shall be concerned with the *local energy density* (Joules/Coulomb).

A Principle of Great Importance: The only way you can have a “chunk” or finite amount of energy to dissipate in a circuit as work is to first have a potential’s local energy density interact with a local finite mass collector. The normal interacting mass collector is the free electrons (the free electron gas) in the circuit. You can have, e.g., (Joules/Coulomb x Coulomb); (Joules/gram x grams); (joules/m³ x m³); etc.

Voltage, Force, Potential Gradients, Loads and Work: Now let’s look at circuitry aspects. Conventionally, they are a mess. *Voltage* is “essentially” defined as the “drop in potential.” In other words, it’s the dissipation (disordering) of a “finite amount” of potential gradient. But the only way you can get a “finite amount” of infinite energy/potential gradient is by first interacting the potential gradient’s internal, finite, excess energy density with a finite “collector” mass, e.g. (Joules/Coulomb available for collection) x (Coulombs collecting) = excess Joules collected on the interacting Coulombs, available for dissipation.

So *voltage* is really the dissipation of a finite collection of excess EM energy/potential gradient. The *dissipation* of potential or of its gradient is not potential! You cannot logically define either potential or energy as its own dissipation!

We presently use the notion of “voltage” in two completely contradictory ways in electrical physics. Here’s how we got the confusion: we take a potential gradient (which has a local energy density), and we “collect” it across some charged masses in a locality –

usually the free electrons in the free electron gas in our circuitry. That is, we express the finite energy density of the potential gradient (before collection onto charges) in the local region in terms of *energy per Coulomb*. The potential gradient actually is a change to the ambient potential, and so it contains an *excess* energy density (the magnitude may be either positive or negative). We then collect this potential (actually this potential density) on a certain number of Coulombs, which places tiny little gradients of potential across (coupled to) each free electron. The local excess energy density of the potential gradient multiplied by the amount of collecting mass gives the amount of excess energy collected (on the interacting charges/coulombs). On each collecting particle, that little gradient, together with the coupling particle, constitutes a tiny force. *F* is not equal to *ma* (non-relativistic case); instead, *F* [(*ma*), where (mass x acceleration) is considered as a unitary, inseparable thing. So that little *potentialised electron* (that little EM force) moves itself around the circuit. In the load (scatterer), the little potentialised electron (the little force) is subjected to jerks and accelerations, thus radiating energy (shucking [sic] its gradient). Since this is done in all directions in the scatterer (load), that gets rid of the gradient, reducing the “little force” (potentialised electron) to zero because the little potential gradient is lost due to radiation.

COLLECTING AND DISSIPATING ENERGY

Without further ado, we consider the scalar potential’s local energy density in terms of *Joules per Coulomb*. **That is, in a specific glob of charges (i.e. in finite circuits), the amount of energy collected from a potential gradient onto the finite number of charges receiving/collecting it, is equal to the number of Joules of energy per Coulomb that is in the potential gradient.**

The current is the activated (potentialised) Coulombs per second that dissipate their potential gradients during that second. The current multiplied by the time the current flows gives the activated Coulombs that dissipated their activation (potentialisation) during that flow time. Dissipating activated Coulombs, multiplied by the excess energy collected per activated Coulomb gives the energy dissipated (the work or scattering done) in the load.

We define **collection** as the connection of a potential gradient (a source) to the charged masses in a circuit element (the element is called the **collector**), which for a finite delay time does not allow its potentialised free electrons to move as a current. In the collector, during this delay time, these trapped electrons are ‘activated’ by potential gradients being coupled to them.

Technically, that delay time in the collector is known as **relaxation time**⁷, in the case of the free electron gas⁸ (in a wire or circuit element). A collector then is a circuit element that has a usable, finite relaxation time. During that relaxation time, the trapped electrons are potentialised without movement as current; each collecting/receiving free electron gets a little gradient across it, but no current yet flows. In other words, during this finite relaxation time (collection time), we extract potential from the source, but no current. Thus we extract energy (potential), but no power (which is voltage times amperage). During the relaxation time, we extract from the source only a flow of VPF, which is continually replaced in the source by the vacuum’s violent VPF exchange with the source’s bipolarity charges. We do not extract power from the battery/source during relaxation time, but we extract free energy density. That free energy density, coupling with a finite quantity of electrons, gives us a collected finite amount of energy. With that background, let’s start again, and go through this in a useful ‘free energy’ manner.

The Electron Gas. We refer to the conventional model of the free electron

gas in a wire⁹. Although the electrons in this gas actually move by quantum mechanical laws and not by classical laws, we shall simply be dealing with the 'on the average case'. So we shall speak of the electrons and their movement in a classical sense, rather than a quantum mechanical sense, as this will suffice very well for our purposes.

When one connects a circuit to a source of potential gradient (say, to a battery), the first thing that happens nearly instantly is that the potential gradient races onto the coupling wire and heads down it at almost the speed of light. As it goes onto the wire, this gradient 'couples' to the free electrons in the free electron gas. However, inside the wire, these electrons can hardly move down the wire at all; they can only 'slip' once in a while, yielding a 'drift' velocity of a fraction of a cm/sec.¹⁰ On the surface, things are just a little bit different. Most of the 'current' in a wire, as is well-known, moves along the surface, giving us the 'skin' effect. [For that reason, many cables are stranded of finer wires, to provide more skin surface per cm³ of copper, and hence more current-carrying capability per cm³ of copper]

So initially little gradients of potential appear on and across each free electron, with a single little $\nabla\Phi$ on each electron, and coupled to it. The couplet of $[\Phi, m_e]$, where m_e is the mass of the electron, constitutes a small ΔE_e . [This is rigorous: the conventional EM notion that an E field exists in the vacuum is absurd, and it is well-known in QM that no observable force field exists in the vacuum. As Feynman pointed out, only the potential for the force field exists in the vacuum,¹¹ not the force field as such. Or as Lindsay and Margenau pointed out in their 'Foundation of Physics', one does not have an observable force except when observable mass is present¹²] We have stated it even stronger: not only is $F = ma$, but $F \equiv ma$ [non-relativistic case]¹³. Since no observable mass exists in vacuum, then no observable force exists either.

FORCE, COUPLED GRADIENTS AND ELECTRON TRANSLATION

Electrons Coupled to a Potential Gradient Move Themselves. The point is, when activated by a 'coupled potential gradient', the activated electron *moves itself* until it loses its activation (its coupled potential gradient).

Let me say that again, in a little more detail. Forget the standard notion that a

force field such as the E-field causes electrons to move. Also forget the notion that the E-field is given by $E = -\nabla\Phi$. In 'Foundations of Physics', those equations are known to be incorrect for the vacuum. EM force fields are known (in QM-foundations theory) to be *effects*, existing only in and on the charged particles, and not existing separately at all¹⁴, or in the vacuum at all¹⁵. Instead of $E = -\nabla\Phi$, in the vacuum the correct equation would be something like this: $P_E = -\nabla\Phi$. In this case, we have correctly stated that the potential gradient P_E provides the potential for producing an antiparallel E-field in and on a coupling/collecting charged mass, and the magnitude and direction of that potential gradient will be given by $-\nabla\Phi$, if and only if a charged mass particle is first introduced so that it couples to P_E .

At any rate, the activated/potentialised electron moves itself. The reason is that it constitutes a force. Force \equiv (mass x acceleration) [non-relativistic case]. So the potentialised/activated electron is continuously accelerating. However, it is prevented from easily moving down the wire directly. To begin to do that, it essentially has to first move to the outer skin of the copper conductor.

The Collector: We now consider a circuit element that we called a **collector**. (It could be a special coil made of special material, a capacitor with doped plates rather than simple conducting plates, or any one of a number of things). The objective is for the *collector* to be made of special material so that it has free electron gas whose electrons are momentarily not free to move as current (they continue to move violently around microscopically, but essentially with zero **net** macroscopic translation) for a finite delay (relaxation) time, while they are settling themselves upon the surface and preparing to move as current. Let's call the electrons NNT (no net translation electrons) during that finite delay (relaxation time). During that 'no-current' delay time, the NNT electrons become potentialised/activated by the potential gradient impressed across the collector. So at the end of the NNT time, the NNT electrons are potentialised, and each is of the form $[\nabla\Phi, m_e]$.

At room temperature, by quantum mechanical considerations, these free electrons are moving randomly, but at an average velocity of the order of 10^6 metres per sec. E.g., see Martin A. Ponus, *Applied Electromagnetics*, McGraw Hill, New York, 1978, pp 54/8, 62/3, 376/7. If you wish to know just how much power exchange is driving the collisions of the electron gas in a copper wire, here is an illustration: in one cubic centimetre of copper wire, the power exchange in and out of the electron gas is some 4 billion watts. That's the equivalent of 4 billion large electric power plants, each of 1 000 megawatt capacity. And one cubic centimetre of copper is a lump about the size of the end of your little finger.

BELGIUM - TRIANGLE HOVERS OVER BRUSSELS

These cases are regarded as rather rare, yet as you will discover in this account, triangular UFOs continue to fly over our country.

On the 21st. August, approaching 23.30, Monsieur Philippe Bertels was going down the Rue du Bourdon at Linkebeek [a suburb of Brussels] in his car when he perceived a white, luminous source of great intensity low on the horizon [the source being the apparent size of a very large star] and heading towards the back end of the town.

Monsieur Bertels thought at first it was a plane coming head-on, and in so doing, was following the road in the direction of the parish of Forest.

Having arrived at the crossing of the Rue Rosendael and the Avenue du Domaine, an area of high ground that reaches a height of 100 metres in altitude and thus overlooks the surrounding neighbourhood, M. Bertels ascertained the presence of a dark, triangular mass in the sky and whose outline was adorned with lights of various colours, of equal intensity

and which were non-pulsating [yellow and blue notably]. The object was hovering perfectly stationary and emitted no sound. The viewing angle of the object was estimated at 45° and the apparent size measured about 30 cm at arms length.

The luminosity surrounding the machine gave the impression of an artificial twilight. We noted at this time of the year, and at the given time, the sky was already completely dark. Our witness, leaning with his elbows on the roof of his car, looked at the phenomenon for 15 to 20 seconds, then, becoming disinterested in the spectacle, he continued on his way.

According to M. Bertels, it was not a case of a plane. This observation registers itself perfectly within the continuity of other testimonies received over the past two years, and which thus attests to the persistence of the phenomenon flying across our skies; even though, in this case, it is only a matter of one isolated witness.

BELGIUM - AN EVENTFUL EVENING AT JODOIGNE

This relatively old case has not been published before, and thus is considered to be of merit when it was sent to us by José Fernandez. This observation was made by the Jodoigne Royal Athénée Staff at the Château des Cailloux in the district of Jodoigne [50 Km from Brussels]

The witnesses are two young boarders, Eric Bunda and Delanoy Michel. The time was at the beginning of January 1984, and outside the night was cold and frosty, the sky starry and there was no wind.

Eric Bunda was dragged from his sleep by Delanoy, a person who was

renowned for his sleepwalking states. Delanoy was lost in the dormitory and wanted to know the way to the toilets, therefore, after informing him how to access these, Eric tried in vain to go back to sleep but he was unable to do so. He then got up in order to go to the toilets himself, so he crossed the dormitory, went through into the washroom and then into the toilets.

Opening the door to the toilets, he mechanically looked out of the small window which overlooks the lawn bordering the château and was thereupon struck speechless at the sight of a very strong luminous source that was

stationary at about 20 metres from him and about one metre above the turf. By all appearances, the object was solid and measured about a dozen metres in length. It resembled a round dish which was bordered at its edge by a row of steady, multiple lights of green, white and red. A small dome was surmounted on the disc and the lower part of the object being bathed in light, therefore making it difficult to make out its structure.

Eric remained contemplating this machine for about 10 seconds, then he reacted by running to his friend, Michel, in order to alert him. Against his better judgement, the latter got up, and the two of them made their way to the toilets. Once there, they observed the object, which continued to hover stationary and in perfect silence above the turf.

Suddenly, a noise was heard in the washroom, so a little uneasily, the two lads locked themselves in one of the toilets. Some seconds later, they decided to venture out from their confinement, but by that time the object was no longer where it was; however, they did have the time to see it flying away very rapidly into the distance.

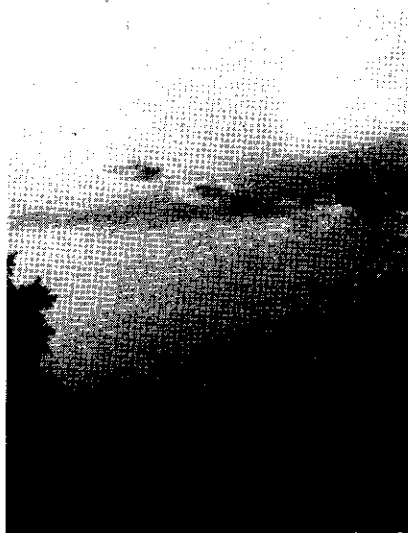

THE EMBARGO HYPOTHESIS

The Embargo Hypothesis, as advocated by Bill Dillon [see *Readers Write UT 27*], probably represents one of the more feasible answers to the enigmatic 'Fermi Question', "Where is everybody?" meaning, "If there is intelligent life elsewhere in the Universe – where is it? Why doesn't it show itself?" Another, more gloomy – but equally valid – idea is that the evolution of intelligence is also the path to self- destruction. We are close to the critical area right now, and if we make the wrong moves – end of story. However, if we can safely navigate the next 100 – 200 years, we should be able to ensure our survival somewhere in the Universe.

In such a context, the 'Embargo Hypothesis' raises a very interesting question, namely: "Would the Embargoers actively interfere to stop – or seem to stop – a world- wide population killing; our life-exterminating conflict?" Or would they just simply adopt the pose of all good anthropologists and let nature take its course? It might be catastrophe for us, but it might be a profound relief for them!

I would like to think they would intervene, but along very subtle lines, e.g. a government collapse here, removal of nuclear-exterminating capability there and the creation of an exciting diversion elsewhere. The net effect would be that "progress" (for want of a better word) would go on and our civilisation would continue onward and upward. In this context, the word "civilisation" serves as both noun and verb.

The questions then naturally arise: "Why should they 'protect' us and why should they interfere or intervene (no matter how subtle) if we show signs of self-destruction? What are they trying to conserve and protect?"

There is only one answer – the one quality we possess which marks us out as unique in the whole of the Earth's history is – a high order of intelligence with the potential to evolve to the highest possible forms of intelligent interaction.

I put the point that this is rare, possibly extremely rare, and is thus worth preserving, conserving, cultivating and developing – but at its own natural pace.

There is now general agreement among all branches of science and physics that our planet evolved some 4 – 4½ billion years ago and very shortly after our sun condensed out of primaeval gas, dust and ices. Very shortly after that, primaeval cells evolved – exactly

how we don't know. One school of thought suggests a mixing of organic compounds and warm water. Another suggests that primitive compounds already existed in the (then) abundant material of comets which bombarded the Earth's surface and oceans. It is unlikely we will find definite pointers one way or the other until we have the opportunity to examine the surfaces of other planetary and satellite bodies in the Solar System – e.g. Mars, Europa, Callisto, Ganymede and Titan, etc. This is a task for the next two centuries – and one we are, and will be, equipped to do. If the icy surfaces of Europa or Ganymede are found to be cratered with the remains of carbonaceous meteoric chondrites, and they contain unmistakable traces of organic compounds and primitive DNA, deep frozen since their formation billions of years ago – then a curtain lifts on a completely different "Stage of Life". We must expect carbonaceous life to be common throughout the Universe. There might even be the extra bonus that such life (and its DNA) will be spiralled in the same direction as ours. If primitive DNA chirality was settled by cometary debris throughout the Universe this would indeed be the case. Such discoveries on the surface of other bodies in our Solar System would totally justify the technological effort and expense that would be required and change our views on life.

So much for life in the Universe, and in this matter, Dr. David Hughes of Sheffield University has suggested and calculated that, "wet and warm slushy planets somewhere are probably the norm for sun-like stars."

Computer simulations and modeling as to how our Solar System evolved reach similar conclusions. There is usually a planet at the right distance from its central sun for that

planet to have liquid water. If that is bombarded with cometary material, then life could easily arise. Life in the Universe, therefore, could be quite common – and Dr. Hughes' calculations indicate 100 million minimum as the number of "wet and warm planets" in our galaxy alone.

Intelligence is another matter and may be extremely rare. Reptiles utterly dominated our Earth for over 150 million years, mysteriously dying out 65 million years ago (Despite the success of the giant asteroid hypothesis, it is not the complete answer). Yet during all that time, there were no real signs that they were evolving towards intelligence. If they were, it was with extreme slowness.

On the other hand, the anthropoid mammals developed intelligence of a high order in the short time of less than half a million years, i.e. 300 times less than the dinosaur/reptilian period. Extreme human-like intelligence seems to have developed over the last 100 000 years, making the contrast even more marked, i.e. 1 500 times.

To have so developed only once in 5 billion years against those chances implies rarity, and Universal rarity. Rarity implies value. Value is seen by us as requiring care, preservation and protection. This is precisely the stance we are now adopting (albeit slowly) in present times. Previously, we fought over valuables, stole them and exploited them.

We are slowly learning that this is NOT the way to preserve what we value.

THE SHADOW OF MAN PART II

The distinction between physical abduction and psychic contactee has now become blurred and it seems that one entails elements of the other. Just as the Shaman was told that he depended upon his crystals for power, so one abductee was told that the subject could be 'trained' because of a 'tuning thing' in their spine. People do appear to develop or lose psychic abilities after an encounter. Equally, there are a lot of psychic events and MIBs which home in on the witness after such an experience, so, if we accept what the Shaman has to say about his crystals, [particularly in cases where these crystals are supposedly implanted in the body] do we then follow this by suggesting that the development of psychic abilities and negative psychic occurrences are by virtue of some kind of implanted device? There is not enough evidence to draw any conclusions at this stage.

The reality of the phenomena is no longer the issue: it is the effect it is having that is important. Whatever the source, collective consciousness, delusion or real, alien beings, it seems to have the ability to destroy or rebuild a person; it has the potential to open up latent, psychic abilities and even alter the whole meaning of life. VallQe has entered into the argument as to why encounters with the aliens are rigged, postulating that encounters are staged for the human witness and are not due to chance alone. All this gives a slight and uneasy feeling of humans being targeted with the potential of that person's outlook on life being totally in the hands of these beings. It is unsettling to think that such forces could be rather deceptive, even to the point of lying about their point of origin and their purposes here.

The evidence supplied by investigations into the subject of abductions reveals there is far more going on than would be required for the surveillance of the human species by beings from another world. The abduction reports run into many thousands from all over the world. Among the contradictions and flagrant lies given by these aliens, one thing is very apparent: with virtually all their human subjects, they do perform some kind of experiments and investigations into the human reproductive system, the human brain and its emotional and mental contents. The raw material they seem to take from humans include predominantly sperm, ova and blood, and many very competent researchers have looked into the speculations as to why they do this, so we will not go into this here. What is of particular interest is the mental and emotional probings the aliens seem to

do, since many abductees have indicated the sensations of having the contents of their minds withdrawn, then replaced, sometimes with thoughts that were not there in the first place; their manipulation of the human mind is truly remarkable.

Why this interest in the human mind? Surely, if these beings have been interacting with Earth since Pre-Biblical times, they would know all they need to know by now. Why the presumed genetic investigations? Again, they should have all the information they need and even have produced the results by now.

For what it is worth, many abductions are treated almost like a first attempt since the aliens seem to have a distinct lack of understanding when they hurt their captives; many humans have even remarked upon their distinct feelings of being a guinea pig. By studying such cases, you will see that there is a constant lack of familiarity with humans, yet among these cases you will find a few where they treat the human with the utmost respect -but just a few.

It will be noticed that in many cases, humans are treated almost as an adult would treat a child, the aliens getting what they require from the human, while at the same time pandering to him. For instance, in one case, a hunter was asked about his gun - the aliens seemingly not knowing what it was or how it worked -so the hunter described it: and these beings are coming here with warnings about nuclear weapons! The aliens would know perfectly well what a rifle is! However, suppose they were treating him like a child, simply giving him reason to put his

mind at ease, thus distracting him from their main purpose?

There is every reason to believe that a mass manipulation of the senses is involved, from other-world journeys, to UFOs themselves, and no reason to believe that what is seen is actually taking place. This manipulation of the senses would also help to explain why contactees can take such a drastic turn in their lifestyles. When the deepest emotions and senses are touched, no further proof would be required, and this is part of the mechanism which locks out unwanted investigators and such like. With the aliens' principal manipulation of the human mind, archetypes and other symbology could be employed as part of a communicative system. The collective consciousness, which these beings themselves have helped to erect over the millennia by posing in various forms, comes into its own as a part of the greater scheme of things.

In *'Gods and Myths of Northern Europe'*, we hear that on Odin's shoulders sat two ravens who fly each day through the world and bring him back news of all that men do: their names are 'Huginn' and 'Muninn', which translates as 'Thought' and 'Memory'. So here we have an account of Odin's two personal messengers named after the two primary human emotions.

It is here that we tend to digress to other areas, namely, the world of the dead which, with Odin, is typified as Valhalla. As with the blurring between physical abductions and psychic contactees, we begin to find a blurring between the world of the aliens and the world of the dead. Many researchers find it almost impossible to reconcile the world of the dead, with its attendant

spirit guides, and this other world populated by aliens who abduct humans. On top of that, we have, of course, the fairies and numerous other nature spirits. The latter we will leave to one side since enough conjecture has been put forward by other writers, so we will only touch very briefly on the spirit-guides of the spiritualist-type nature.

I have been a practising Spiritualist medium, and I have encountered what claimed to be spirits of the dead and spirit-guides, or put another way, I have encountered a great many apparitional forms which knew at least as much as the humans they were apparently linked with. In many cases, they appeared to know a little more and were able to assist in resolving problems.

Dealing with spirits of the dead is a difficult subject at the best of times, and it is another area where you can accept what little evidence there is, or simply refute it; from my experience, none of it in any way substantiates survival of death. At this time, I am unable to pass any real comments on this, except to say as a clairvoyant, I have seen the spirits of the 'dead' appear as an inferior quality to that of supposed aliens.

The 'dead' appear less vibrant and a little 'wooden', which is the only way it can be adequately expressed, and possibly only another clairvoyant will know what I mean.

One of the first 'spirit-guides' that I was introduced to took the form of a Red Indian Shaman, a great many of which seem to be prevalent throughout the Spiritualist world, but this being seemed to use that form for a calculated function. Eventually, over a period of time, this entity dispensed with this guise and ultimately insinuated that it was a much more highly evolved being. So, at one time I believed that I had a human spirit-guide when in fact it was nothing of the kind, yet a deception of a detrimental nature doesn't seem to have been the aim. This 'Red Indian' claims that this kind of 'deception' is a regular occurrence with many people, so if he is to be believed, we have here a blurring between the spirit-guide and the alien. The only reason I am prepared to accept what he says is because, to date, there is nothing he has said that has proved false. He has prophesied on many occasions and these things have come to pass; should anything prove

false, I would then question him very closely.

That is something which every contactee should be prepared to do, regardless of how deep and moving the experience of their 'alien' contact, and they should be prepared to question both themselves and their contact if anything proves false. In a few cases, with abductions, the humans have had reason to question the truthfulness of the aliens, and they have done so.

Unfortunately, a contactee can have his or her life turned completely around: yesterday's nobody is tomorrow's saviour, and there is no way a contactee will let that go. Then there is the publicity and the potential of followers, which are the accursed elements that will cling to a contactee whether their alien sources are genuine, delusion or the ever-popular collective consciousness. If prophecy fails, the contactee will be puzzled, possibly a little deflated, but on the whole, will make excuses for the failure and then just carry on believing everything else they are told.

We shall then have reached immortality. Destruction of the Earth by whatever means will not be the end of the human race. Perhaps then, and only then, will the "Embargo Agencies" reveal themselves.

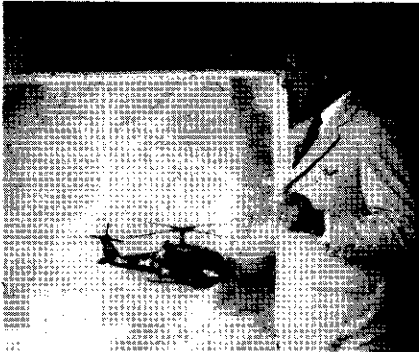

TRANSMIGRATION OF THE GREYS (OR A LITTLE BYRD TOLD ME SO)

by Dr. Harley A. Byrd



This briefing ex-PIO Officer USN Dr Byrd points out locations where Zeti Recutilli aliens were flown. In 1991 dozens of unmarked helicopters were used to transfer greys, to Rio, & Puerto Rico

Since the now historical crash of an alien group in the Corona, N.M. area near Roswell AFB, the legend of the little grey aliens from a distant star system, known as Zeta Reticuli, has been steeped in mystery, controversy and most definitely a covert military cover-up. As certainly as we have established their presence in the Dreamland Area 51, S-4 sector of the United States, the greys have been transferred to two separate regions in the southern hemisphere, as well as to a not-too-distant of Puerto Rico during June, July and August of 1991.

At a recent conference in Pasadena, with over 100 000 in attendance, I was literally swamped by angry and concerned people who demanded my source of such a story and how I was privy to such information. I repeated myself, as I had in the lecture, that when you are billed as a Top UFO Expert you'd better have more data than just hearsay to back up such a bizarre claim, and I repeated again: "I've conferred with the 5 leading UFO experts on the planet and we were all in agreement that the greys were being systematically put under the ELF (electronic low frequency) Programme by the N.I.H. (National Institute of Health) and the U.S. Government". One woman blurted out: "What is the ELF Programme?" I kindly spelled it out for her: "The Electronic Low Frequency

System is a bio-medical process that subjects humans and animals – and in this case to EBEs – to magnetic and electrical field waves which affect brainwave spectra." She was spellbound and said: "This is unbelievable. Can you tell us more?" I looked around at about 20 other astonished faces and I continued: "Yes, this neuronal synchronisation, or de-synchronisation and brainwave entrainment can be demonstrated clinically in cats, monkeys and human sensitives in the presence of ELF oscillations of both natural and man-made signals; in this case the signals were given off for the EBEs, or little greys from Zeta Reticuli." She then asked: "Why have they done this to the little greys?" I continued: "Well, the local people in the Dulce N.M. area, mostly Hopi Indians who inhabit that region, have complained since the beginning of the cattle mutilation syndrome in the sixties. The N.I.H., with the cooperation of the B.I.A. (Bureau of Indian Affairs) and the U.S. Government, thought it would be in the best interests of the local citizens, and others concerned, that the greys would be put under by the ELF process and then flown into the Puerto Rico and Rio De Janeiro regions of the southern hemisphere". I said: "Basically, that's it. We have the right to know, but the military feels we don't have the right to know; in the name of national security of course." One angry gentleman kept probing: "You really just believe that we can accept this preposterous story just because you tell us so?" I then continued softly: "Sir, I'll repeat again for you, I currently hold a very high security clearance from the U.S. Government and I make it my business to be up on this data, and even though I've been accused of giving out 'disinformation', I can assure you that what I'm telling you is true." "What other sources do you have that could verify this?" he asked, pen and pad ready. I replied: "As I said in the workshop just now: Fate Magazine covered the story a month after this major event went down, and that would be in the fall

issue of FATE 1991. Also, for further verification, UFO CA Magazine recently published a newspaper story from Puerto Rico – not a tabloid story I might add – but a legitimate press-cover of recent UFO/SUFO activity, with the usual cattle mutilation scenarios, local citizens being abducted or killed and general pandemonium in that area, 15 Km north of the SETI Dish in the eastern sector of Puerto Rico." I continued: "I might add that there has not been any cattle mutilations or abductions or lots of UFO activity in the S.W. region of the U.S., especially around Dulce, N.M. Dreamland Area, except for the usual Wednesday evening test flights for the alien reproduction crafts built by Northrop and Westinghouse.

There are no longer throngs of on-lookers at the mail-box road near Dreamland, Area 51, and the local tours that have been running to that area have dwindled to just a few people each month. Recently, John Lear addressed a large group at the Pasadena Convention Centre, and related the following: "There have been reports of underground conflicts between the 'Ultra-7-Level' officers and the greys, and my reports have indicated that 44 military guards were killed in the ensuing melee during the attempted ELF Programme. The rest of the greys, few in number, are grappling with the DRACOS (Lizard Men) on the 6th and 7th levels, in the Dreamland S-4 bio-engineering tanks.

When this story first came to my attention, I was not startled in that the Hopi Indians had been negotiating with several VEEPs [sic] who head the NIH and the Anthill Complex problem. The cattle mutilations were the last straw that broke the camel's back for the greys, and, of course, for the on-going abductions as late as 1990. Since that time, the only cattle mutilations, abductions, UFO/SUFO activity has been extensively in the Puerto Rico area, 15 Km north of the SETI group. The other faction of the greys, probably 500 or so,

were flown to Rio De Janeiro, S.A. to a U.S. military installation about 50 Km north of Rio. A story broke in the major UFO magazine supporting my beliefs and opinions, and a Puerto Rico paper reported new cattle mutilations, abductions, UFO activity, frightened, local citizens; ironically, there is none of this activity now going on in Dreamland.

Al Berlik and I conferred privately at the '4th Annual UFO Conference' and he indicated there were a handful of greys grappling with the DRACO group for control of the nightmare-hell level 7 in the Dulce Caves. Al said he would stake his life on this as I pressured him for confirmation, and he indicated that the DRACOs would be causing problems for Earthlings in the future in that they are a determined and non-believable group [sic]. Since I have been giving the Transmigration briefings, I have been shadowed by two groups from the AFOIS (Air Force Office of Intelligence Services), a covert group out to neutralise the UFO

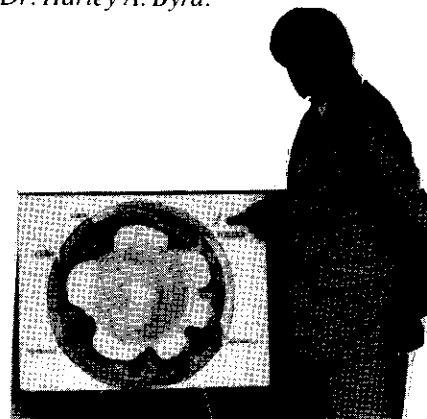
movements in general. Fear is not in my vocabulary, as I have served civil court orders on these groups currently working out of Malibu and Big Bear Lake, Ca.

I won't name a circulating video tape* that claims the U.S. or U.S.S.R. or other powers have landed a spacecraft on Mars in 1962. This is highly improbable because in 1962 the late President Kennedy put together a 10-year plan to catapult us to the Moon in 1969. So you have to learn to separate the wheat from the chaff and take a lot of what you might feel is information and take it as disinformation.

[* The video referred to here might be 'The Global Conspiracy' which refers to 'pre-space age' landers on the Moon and Mars put there with the aid of German technology founded at underground bases in the Antarctic where, oddly enough, the author's uncle, Rear Admiral R.E. Byrd, carried out a number of scientific expeditions which led to the infamous 'Hollow Earth

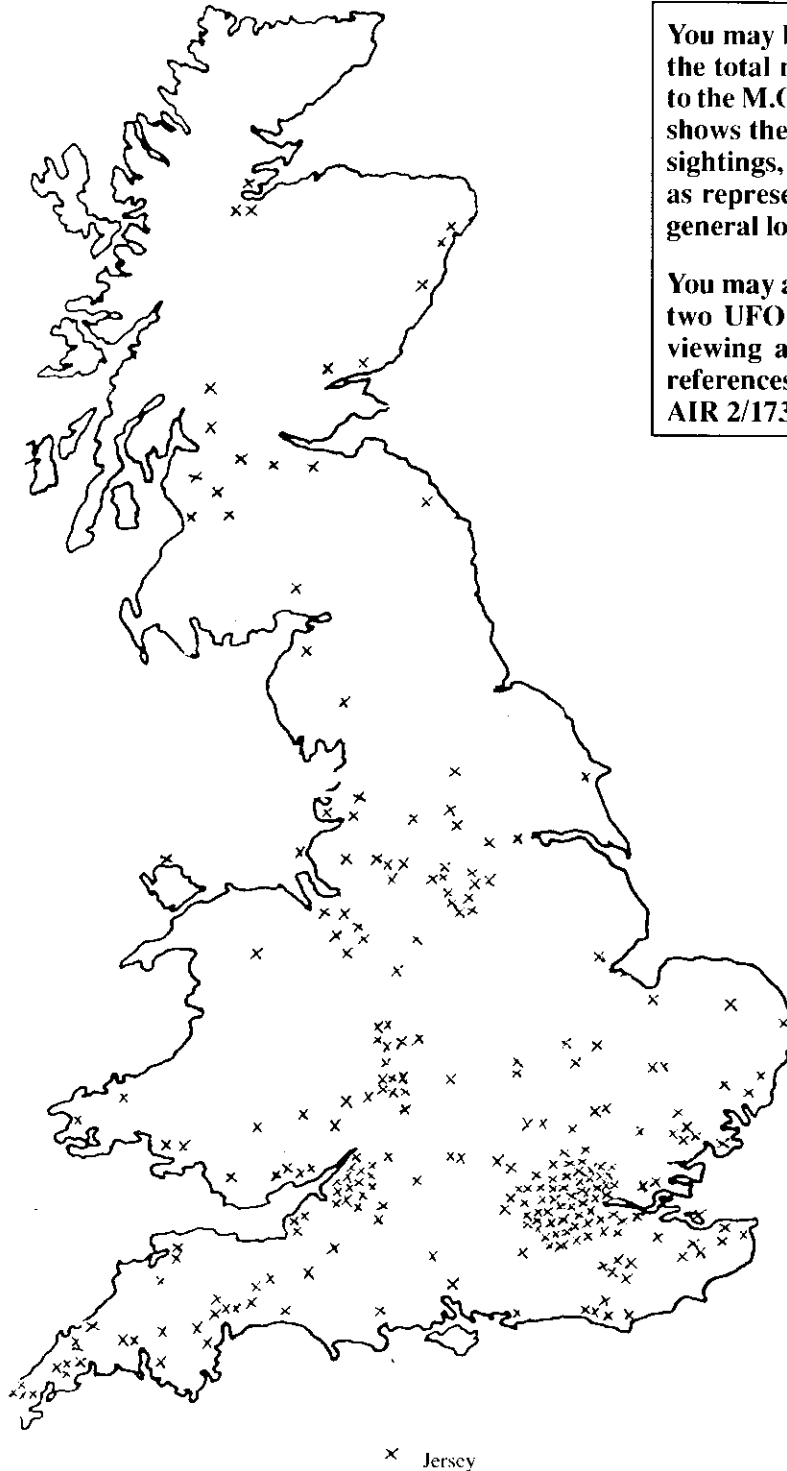

Hilary has a very valid point. Surely there must be thorough debate as to the validity of studying UFO phenomena through the lines of the abduction phenomenon (not necessarily linked) and the position this should occupy in the hierarchy of BUFORA activities.

As a registered mental nurse, I am very experienced in the field of counselling. One of the things I have learnt from this is that no amount of counselling and support will establish proofs of events that cannot be verified externally, and if we are not seeking, ultimately, proofs then what is our *raison d'être*?

If we are ultimately to seek proofs and truths, then we must consider how these are to be assimilated into our human psyche. I agree with you that there is a large body of evidence to suggest UFO activity [lies] within the domain of E.S.P. However, no amount

of research and investigations into this will provide physical proofs, otherwise we have nothing other than theories, beliefs and religion.

It is important that the abduction phenomenon is examined. A (relatively) recent, worldwide conference of psychiatrists gave legitimacy to the phenomenon when it decided that the high, general, uniform rate of incidence does not constitute a psychiatric illness, or part thereof. However, what this did was to abandon their responsibilities to the witnesses.

In the absence of others, BUFORA has filled this role over the last few years.

'Fire In The Sky', Based On The True Story Of Travis Walton, was released in the U.K. on June 25th 1993.

The video version was released on 31st December 1993, but only on rental. No date has been given when it will be available on sale in the high street.

Having viewed the movie several times, I have to say that, apart from the abduction sequence, it does stay fairly true to the original story. This is a very important statement since it is very much in accord with the very latest hypothesis, known as the 'Embargo

Another important contribution to the subject is her evaluation of the close-encounter witness as being an artistically-creative individual who possesses a proneness to extra-sensory phenomena. Again, this statement is of enormous importance because many high-ranking scientists today are aware (strictly in private!!!) that *paranormality exists and is real!*

From the above considerations alone, this book is a must for all those who are interested in the subject. It is written in an entirely plain-English style and free of jargon and waffle, thus, many important points concerning the vexed issue of entity encounters can easily be assimilated by the reader. I generally found the magazine interesting and informative, but just feel it lacks a spark.

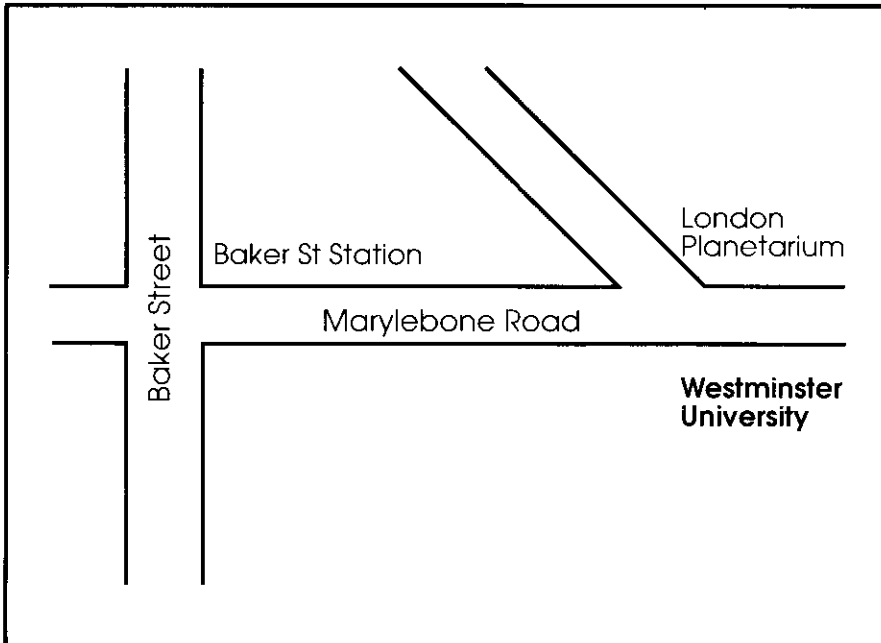
