
We refer to the contract for works of dredging, land reclamation and shore protection of the Marginal da Corimba, entered into on April 27th, 2016, by Gabinete de Gestão do Pólo de Desenvolvimento Turístico do Futungo de Belas e do Mussulo ("GABINETE") and by the external consortium formed by URBINVESTE – Promoção e Projectos Imobiliários, S.A. ("URBINVESTE") and VAN OORD Dredging and Marine Contractors, BV ("VAN OORD"), with the global price of USD 615.208.842,78 ("CONTRACT").


