The Beverages Were Left in the Hot Sun!



While I was investigating why the US troops were not getting the beverages they needed, I came across 2 troubling memos. Both memos directed personnel to hold the beverages for ‘inspection’. That puzzled me because what kind of inspection could already sealed cans of soda need? Inspection for insect infestation? Clearly, not. They needed to be delivered on time. So, why were they held for weeks to months in Iraq and Afghanistan while the troops needed them? Was it to allow them to be ‘stolen’ and sold on the black market? That was my starting premise. I asked the intelligence officer (see Case 17) who had already been shot out twice to go to a specific warehouse in Iraq to look into it. This was not at the port where he had already determined that ships were arriving with empty

crates. Halliburton-KBR was charging high costs for the shipping of items. This warehouse was inland, near Basra, if I remember correctly. It was supplied by trucks from factories where brand named sodas were made by adding water to imported concentrates. Those factories had their own quality control programs and inspections of the fluids which went into the cans.

The CIA officer reported to me that no further sampling and testing of the beverages were done at that “warehouse” site. He said that the sodas were not stored in a warehouse. They were in a large fenced in lot where the truck’s metal container shells sat in the hot sun in row upon row. When he had asked about why the beverages were required to sit there, he had been told, “They are getting their heat treatment”. He asked how long that took. He was told by the foreman of the lot that it takes at least a week of sitting in the sun in hot weather and in the winter it could take a few months. The foreman should him his clipboard record of the daily temperatures. He said that he was not allowed to release the beverage shipments until they had been in the sun for at least 7 days of hot weather (over 90 degrees F), or a month’s worth of days of warm weather (over 78 degrees). He said that was to ensure their sterility.

That made no sense to me. If the cans were contaminated with germs, then heating them days later in the sun would yield putrid beverages. That would be true whether or not they were sterilized later by the heat. I asked the CIA officer to measure the temperature of sodas in the crates as I doubted that they got up to temperatures needed to sterilize them. It was about June when he was there. He measured the temperature of cans at the top, the sides and about a meter into a crate about an hour after noon on a day that it was about 90 degrees F outside in the shade. The temperatures were about 140 degrees F average. At the top of the stack the temperature was over 160 degrees which was enough to slowly cook a steak. But in the middle of the stack the temperatures were only about 110-120 degrees. In short, in June even a month of such treatment could not sterilize the cans in the middle of the shipment. The protocol did not make any sense whatsoever from a public safety point of view. The cans had to be sterile when they were sealed, no if ands or buts, to have a useful product.



The first thing I did after that was call up the Center for Disease Control (CDC) to find out if they were seeing diseases from improperly canned sodas. The man I spoke to was an expert in beverage contamination and said that he had not had any such problems come across his desk. Then he added, “But in Iraq if a person gets sick it is likely due to bad water. Even touching it might make a person sick later because some parasites can burrow through skin. I then explained the situation with the beverage shipments more thoroughly. He said that there should be an off taste if the cans were not properly sterilized in the first place.



I then tried to figure out why those memos had been written. I did not yet have the theft rates from the fenced compound as it would take time to wait for them to be stolen. The first memo came from Rumsfeld’s office. I had to be at the Pentagon periodically anyway. I walked into Rumsfeld’s area and asked to speak to the official who had written that particular memo. I had unearthed it originally in the CIA’s document room for Pentagon records. Rumsfeld’s citadel of offices had its own security personnel, as if he needed to protect himself from the US military. I had picked a time to make the appointment while one of my former students was a guard at the door. The secretary looked at me like I was trouble and then went into Rumsfeld’s office to ask what to do with me no doubt. In the time she was in

Rumsfeld’s office, I had found the memo writer’s name on a door just a few doors down inside of Rumsfeld’s suite of offices. So, I had knocked on it. He was in. After telling him that I wanted information on that memo, I set up a time to meet with him.

Then I returned to her desk to wait for her official reply. She came back out and said, “That man does not work here anymore.” I had to laugh at that ploy of Rumsfeld’s.

I met with the official in the cafeteria about 2 hours later. He said that he was just following orders when he wrote the memo. Then he pulled out the memo from Halliburton-KBR to show me. He had indeed faithfully copied it almost word for word, though he had made it conform to military style. I asked him why he had duplicated a private contractor's memo and made it into a military order. He acted like I was mentally deficient and said, "Look at the signature". I had, it was Dick Cheney's. But the memo was not on White House stationery, so I again asked him why. He said, "That is the way things are done around here now." I asked him why he didn't insist on getting a proper US govt. memo to follow. He said, "Liability complications. This is secret. No one is supposed to know about this Halliburton memo. But it is my neck on the line. I want you to know that this plan did not originate with me. It was never my idea." I asked him who else knew about it. He said, "Well, obviously Rumsfeld and Cheney." I asked him about Rice and Bush. He said he didn't know that for certain but had heard that Rice had approved it. When I asked him how much he had been paid to write that memo he shook his head sadly and said, "Maybe money isn't everything." I later was able to give the GAO a copy of the bank transaction which put about \$20,000 into a hidden account for him the day after he wrote the memo. The money came from a KBR account. KBR listed the \$20,000 payment on their books as a "consulting fee".



Then he fled back up to Rumsfeld's citadel of offices.

Because it was in his interests not to be seen as the originator of that memo, he had left me a copy of the Halliburton-KBR memo. I handed it over to the GAO to prove that Cheney was still running Halliburton-KBR.

About a month later, the CIA officer in Iraq reported to me that he had not been able to document any thefts of the sodas. Instead he had uncovered a drug smuggling operation through that same yard. He had determined that it was another CIA operation and then decided to stay out of its way. But in the process he had made friends with one of the CIA operatives. That man had told him "Don't drink that soda. In fact, don't drink soda in Iraq. That stuff is bad for you. Real bad." He was not sure whether his new friend was just against sugar, while for illegal drugs, so he let it ride.

When he later saw his new friend eat a second jelly donut, he asked him “What about the sugar?” His friend said, “It ain’t the sugar in the sodas I am worried about. I hear that they are putting oil in them.”



That still did not make any sense. But it was possible that crude oil had contaminated the water either while in the aquifer or in a river.

By now, I was giving up on the theft hypothesis. Since the CIA was running illegal drugs through that yard, they were not going to let the security be lax on it. From within the CIA I was able to verify

that the CIA was running drugs through that “warehouse”. In the process of that I came across another curious fact; there was a memo to those CIA operatives warning them not to drink the ‘ripe sodas because of contamination with oil byproducts’.

I wanted to know if all the factories in Iraq making the beverages had the problem, or just some of them. And I wanted to know who was drinking those beverages. I decided to be bold and called the VP at Halliburton I knew. We chitchatted for a few minutes. Then I asked him what the point of holding those sodas in the sun was. There was dead silence in response. About 30 seconds later he hung up.” Well, clearly he knew that there was a big problem and that he would be in trouble if he told me the truth.

Next, I called Cheney up and asked him. He started swearing at me. Then his swear words turned to threats. He said that I had better back off “or else”. So, he knew that holding those sodas in the sun was a topic he wanted to kill me for, if I exposed it.



Immediately, I called Bush. I knew that they would both be in at that time, I had just left a party at the White House with Tenet. I also knew that they had both had enough to drink that their tongues might be looser than normal. Bush had slightly slurred speech. We talked for a few minutes about the party and then another matter of CIA importance, which was why he and Cheney had taken my calls. Then I asked him if he liked to drink hot

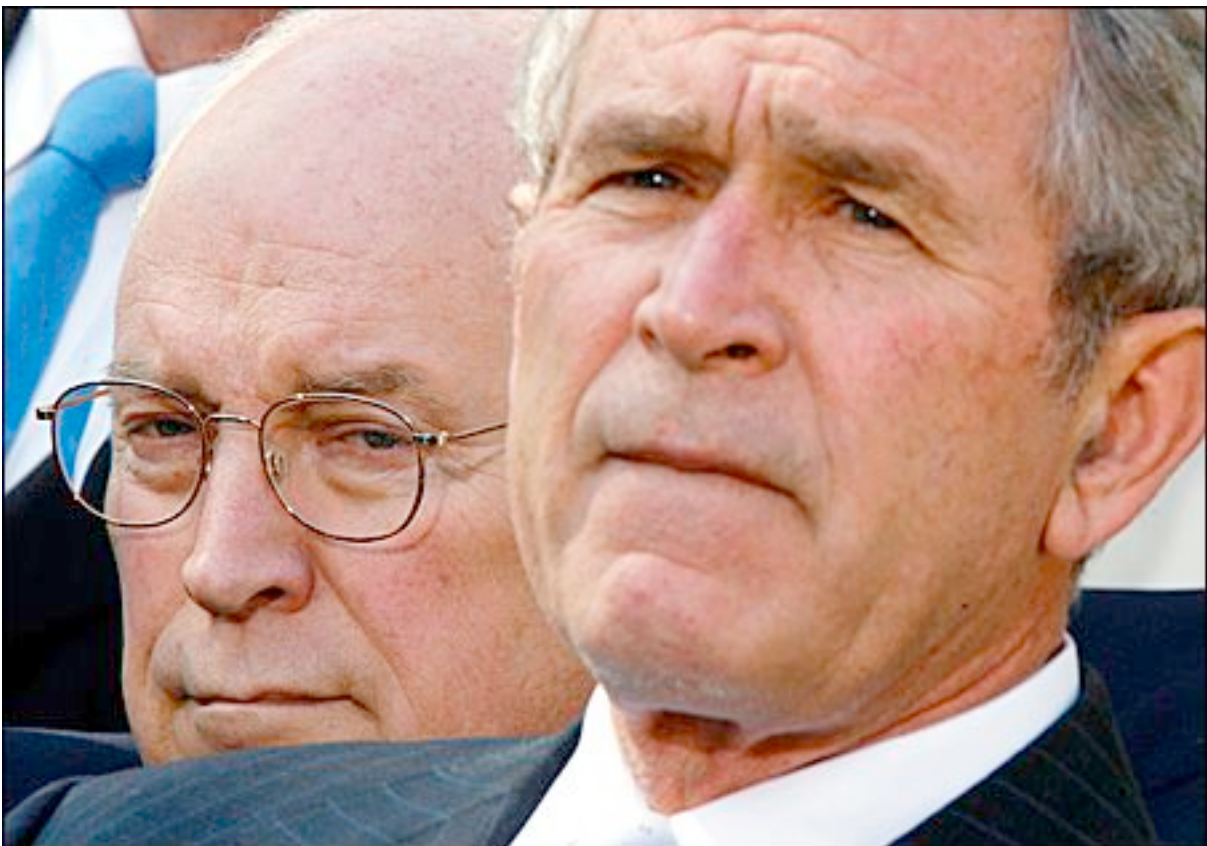
sodas. He said, “No, that is not good for you. You have to keep them cold, even before they get to you.” I asked him about the reason for heating it in Iraq.



He said, “Well, we are just having some fun.” Since when was poisoning others with petroleum derivatives fun? Then realizing that he had said too much he added “It foams better when it is hot.” I asked him who they were serving it hot to in Iraq. He said, “I guess Al-Queada would be drinking it”. I said, “I would like it to be released to the soldiers before it sits out there for months. Would you please write an order for that.” He said, “I couldn’t do that. I would get in trouble, if I did

that.” I asked him “What will David Rockefeller do to you, if he finds out?” as it was my opinion that that was where the idea had really originated. He replied, “I am not so worried about David. It is Cheney I am most worried about. He becomes President if anything happens to me. Do you think I am in any danger?” I asked him, “What keeps you from getting a different Vice President?” He said, “Boy, that is not the answer I wanted to hear from you. I was hoping you would say that I was not in danger. David would not be happy if I told Cheney to leave. He would not at all be happy. I can’t talk about this anymore. I have to go now....”

I sent both tapes over to the GAO for the investigation of why the troops were not getting those beverages when they needed them. But was there a deeper significance to those sodas sitting in the sun by decree of Cheney? The rest of these many pages are relevant to that question. I apologize that they are more a heap of information than a coherent book. Can you solve the mystery?

As a CIA physician I examined prisoners at three US prisons in Iraq, after the US Administration said that those who committed the crimes had been arrested. Because I was in a position in which I was called upon by DCI's to give educated guesses, I read avidly in both the CIA's files and the Rockefeller Archives. I had access to the later after DCI Helms ordered me as a young woman to try to keep track of what Nelson Rockefeller gave the Russians. Since the Rockefeller Family had helped fund the Boleshevik Revolution, DCI Helms had reason to want to keep an eye on the Rockefeller's Russian dealings. Dangling a young woman in front of Nelson was one way of Helm's doing that. Very powerful people are often not clever spies like Ames or Walker. They do not feel that they have to be exceedingly secretive since they have the power to obstruct the wheels of justice from turning.

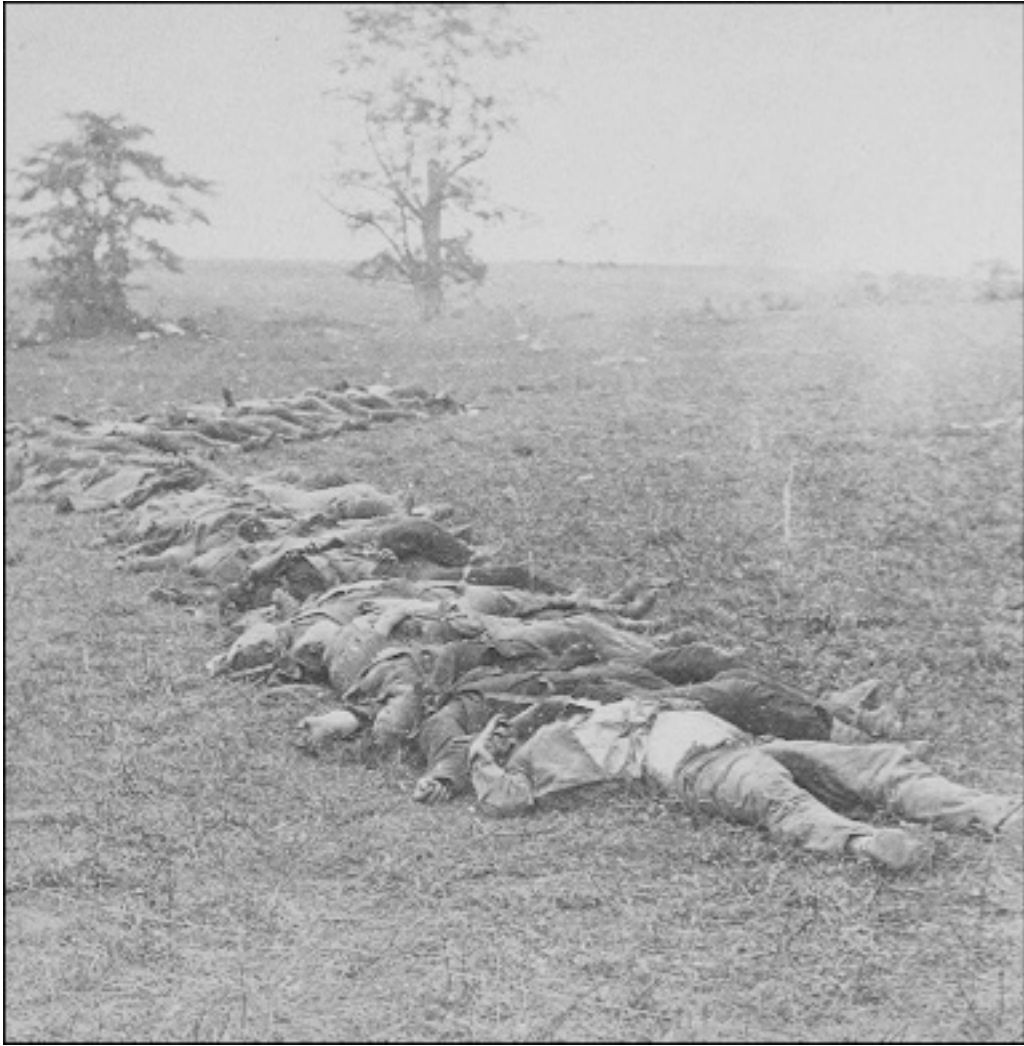
The Rockefeller Archives are not open to the public. Since I had access to them for decades through Nelson and later David and Rodman Rockefeller, I want to say a few words about that attempted coup. I am not an unbiased source in so much as I had reason to complain about the conduct of the CIA, the Rockefellers, and the KGB towards me, in about that order. Young women are frequently the targets of sexual harassment, especially in espionage settings.

The plans for the New World Order preceded the start of WWI. Per the documents in the Rockefeller Archives the New World Order was envisioned as a way to enslave the populace to do the bidding of elite. Basically, they wanted a feudal system again in which people were dependent on the Masters in order to eat and had to obey them to live. John D. Rockefeller and his wealthy Robber Baron friends sent many letters back and forth extolling the virtues of slavery. John D. Rockefeller, Sr. had made money off of war profiteering during the Civil War.

The US Civil War



Although I did not do a thorough analysis of John D. Rockefeller's Civil War profiteering which allowed him to buy oil refineries, I did run across documents in the Archives would shed some light on it.

His father, William Avery Rockefeller, Sr. (1810 – 1906) was a traveling salesman selling medical remedies, including opium laced ones. The Archives had a display case of some of the remedies he had sold. Both opium and tar were ingredients in his potions.

John D. also continued selling the nostrums that his father had sold. He started selling opium to the Union Army which it needed as a pain killer. But to make a profit at it he watered the Chinese obtained opium down from the formula his father had used. Before he was caught selling a largely ineffective product, he had branched out into selling many types of goods, including produce and rifles to the Union Army. Soon afterwards, he managed to make contact with a cheaper supplier of opium--a member of Skull of Bones. Skull and Bones was started as a secret society at Yale in about 1833 by an opium running pirate by the name of Russell. Russell wanted young men who would become lawyer, politicians, judges, etc. who could protect



his illegal business. Realizing that he could make much more money selling opium to wounded soldiers directly, he hired men to be camp followers. They sold the opium in bottles to the wounded at exorbitant prices on the battlefields in the Civil War. He then had them recruit some of the Confederate wounded to be his distributors. In addition, to opium he was supplying rifles, blankets, and food stuffs to both sides of the War. Since selling them to the Confederates would have been treason, it is no wonder that that fact was not published outside of the Archives. Since he was very proud of his skills as an entrepreneur, he had saved many invoices showing what he had paid for lots of goods and what he turned around and sold them for.

I remember one lot of wool blankets he had bought for only 2 dollars because they were disintegrating due to being eaten by bugs. He then hired local women to individually wrap them in butcher paper so that the damage to them would not be seen until they got to the front lines. Then it would be hard to return them. He turned around and sold them as new to the Union Army for about 180 dollars. He wrote in his journal that it had only cost him 4 dollars to have them wrapped up to hide their sorry falling apart state. He said that they were so bad that it was nearly impossible to tell where one blanket started and another ended. In the end he had told the women just to weigh out a 'blanket's worth' of wool scrapes for each packaged. He used bribery of inspector and judges, backed up with intimidation to cover up his deceits. War profiteers are people willing to make a killing off of the suffering of others.



One of the most poignant series of letters I read was from a married woman of a Confederate Soldier in the Civil War. She was applying to the Rockefeller in question for help getting her husband released from a Union prison. She wrote saying that since her husband had been wounded by a rifle sold by Rockefeller that she expected that he had the connections to make sure his wound in prison was treated. She said that her letter from her husband indicated that the minor wound was festering and might prove her a widow ere long. In that file was a letter from the Warden on the Union Prison acknowledging receipt of the Rockefeller's letter. It stated that the man was a prisoner under his care and did have a wound which appeared grave and distressing to him. It also confirmed that the Confederate Soldier had bought the rifle at an exorbitant price in those days of 100 dollars. It is my opinion that the rifle was probably a Remington based on that company starting before the Civil War, Remington's plant in Upstate NY where the Rockefeller's lived, the fact Percy Rockefeller later had Samuel Bush on the board of Remington <http://www.ecosyn.us/Bush-Hitler/>

[Rockefeller Institute for Medical Research Eugenics.html](http://Rockefeller_Institute_for_Medical_Research_Eugenics.html) , and my memory of the letter. The Warden stated that two Confederate prisoners, other than the wounded one, stated that the wound was due to the rifle misfiring on the inside of his right arm as he tried to fire it for the first time in the battle in which they were captured. In those days, the Confederate Army did not supply weapons or kit. Without a rifle and wounded that man was quickly captured with his friends who were trying to bind the wound to keep him from bleeding to death. The prisoner and his wife were only asking for a physician to be sent to see to the wound.

The next letter from the Warden reported the man's death. It said, following your instructions to withhold all food the prisoner weakened and stopped asking for a physician. But it was only after your most recent letter and keeping the bastard from all water, that I am able to report to you his demise. The physician pronounced him dead but I swear on the Bible that that was the first he seen him. Don't forget your promise. My misses is counting on that 5 dollars and so is the grocer with his bill. That letter followed about 4 months later.

The next letter in the file was from the widow, thanking the Rockefeller for having a physician come to see her husband while regretting that it had been too late to save his life.



Adjacent files showed that the Rockefeller was paying private thugs to run rifles into the South where they could be sold at 'any price we care to name'. In one file were deeds to land and houses in the South sold for the price of a rifle(s). That Rockefeller was aware that he was committing treason as judged by his instructions to his gun runners. The rifles were given to them with a flyer which made it appear that another supplier, his competitor, had supplied them.

"William Avery Rockefeller, "Big Bill," was a traveling salesman who advertised himself as a "William Rockefeller, the Celebrated Cancer Specialist" and who hawked "herbal remedies" and other bottled medicines." He guaranteed "All Cases of Cancer Cured Unless They Are Too Far Gone". Those claims allowed him to charge \$25 for his magic cancer,



which he retailed for \$25 a bottle, a sum then equivalent to two month's wages. The "cure" survived until quite recently as Nujol, consisting principally of petroleum and peddled as a laxative. Nujol was manufactured by a subsidiary of Standard Oil of New Jersey, called Stanco, whose only other product, manufactured on the same premises, was the famous insecticide, Flit.

"William posed as...[a] peddler that sold cheap novelties with a small board with the words "I am deaf and dumb" chalked across it, tied by a string to his shirt. Big Bill can be described as a faker that lived-off scamming from others,..."

He fled from a number of indictments for horse stealing, eventually disappearing altogether as William Rockefeller and magically re-emerging as a Dr. William Levingston of Philadelphia, a name which he retained for the rest of his life....He married Eliza Davison in 1837, and shortly thereafter brought Nancy Brown home, as a "housekeeper" who became an alternate lover and who also bore his children.

"On June 28, 1849, he was indicted for raping a hired girl in Cayuga, New York; he later was found to be residing in Oswego, New York and was forced once again to decamp for parts unknown..." See <http://www.seekgod.ca/rockefeller.htm> .

There was evidence that Wm. Rockefeller did know that his cancer remedy was poisonous. In one of the journals I ran across in the Archives, John D. Rockefeller, Sr. retold a story about his father discounting the Cancer Cure to sell a lot of it to a man as an internal "remedy for baldness". Wm. wanted the man dead because he was interfering with his profits by selling cheaper products. The story went that he

sold him 12 bottles of it telling him if he would drink a bottle of it a day on the last day he would have a full set of hair. He later delighted that the man was dead before the 12th day "all without use of a pistol". The gullible man was laughed at by the Rockefeller because he had paid for his own death. [Note: The refining of petroleum gives fractions with varying degrees of human toxicity. His formula was unlikely to be standardized at that time.]

'He called his bottled petroleum "Nujol" (meaning new oil) and sold it to those who had cancer and those whom he could make fear they would have it.

This [later] sounded good to Standard's researchists. It sounded even better when they found it cost but \$2.00 a barrel to concoct Nujol from crude petroleum. And that from one barrel of the raw stuff they could make 1,000 six-ounce bottles of finished Nujol. Instead of calling it a cure for cancer they called it a cure for constipation.

The latest trade catalog lists Nujol as going to the druggist at 28-2/3 cents a half pint (8 fluid ounces). The druggist thus pays about 21 cents for a 6-ounce bottle of Nujol which costs Standard Oil 1/5 of a cent.



These breath-taking profits from Nujol make it inevitable that America's largest and most ruthless industrial combine (the **Rockefeller** Empire) should soon add the drug traffic to its already vast production and sales domain. It wasn't until 1939, however, that the Drug Trust was formed and the upward curve in their drug profits began to assume the present gigantic proportions which today make it a macabre \$10,000,000,000 a year business. How the American Drug Trust was formed by an alliance with its opposite number in Germany is almost a story in itself.

Soon after the present-day Nujol was put on the market it was discovered by physicians to be harmful. It robbed the body of fat soluble vitamins and caused serious deficiency diseases. Standard Oil checked the loss in sales by adding carotene (one of the fat soluble vitamins) to Nujol and claiming this overcame these injuries. Physicians disagree with the sales department of Standard Oil on this point.



And what of Nujol, now being sold to the public as a laxative. For some years before his death Senator Royal S. 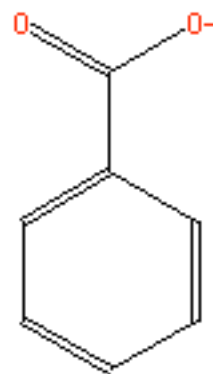
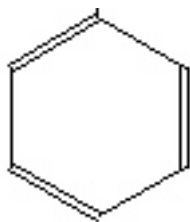

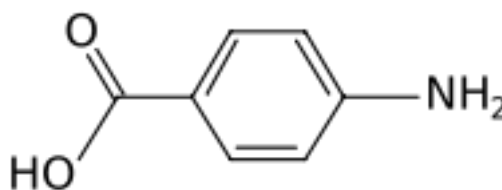

"In 1883, Dr. Wiley moved to Washington D.C., to become Head of the Bureau of Chemistry in the U.S. Department of Agriculture, at a time when the adulteration of food was pandemic and horror stories abounded. Wiley concluded that there should be three major legislative goals: the control of adulteration of foods and the elimination of misbranding and false advertising of foods. He decided to try to provide the scientific background in food analysis to minimize adulteration... Wiley was elected president of the Association of Official Agricultural Chemists in 1866 and then served as secretary of the organization for 25 years. He became president of the American Chemical Society,

helping to reorganize it after a difficult beginning, and held many positions in the American Association for the Advancement of Science. ...Wiley persuaded Congress to increase the budget for USDA's Department of Chemistry and then proceeded to launch an all-out attack on adulteration. His staff investigated all major categories of food and reported their findings in his Bulletin 13, Foods and Food Adulterants. Wiley was interested in a wide variety of products, including the colorants used to make foods more appealing.

Apparently, a purveyor could add almost anything to foods and frequently did! Copper arsenate and lead chromate were reportedly used to color tea leaves for resale, one druggist gave a caterer copper arsenate to color a pudding for a public dinner. Wiley hired German dye chemist Dr. Bernard Hesse to survey the situation. Hesse evaluated more than 600 "coal-tar" dyes used in industry, 80 of which were offered for food use in the United States. Thirty had never been tested at all. He reduced the list to seven and recommended that these seven dyes should be the only ones certified for food use in the United States.

Wiley knew that, to get legislation passed to control these practices, there would have to be some public outrage. He was a commanding speaker and a prolific writer, but he realized that he would need help, so he enlisted the aid of the public media. They were only too pleased to translate his technical bulletins on adulteration into readable articles that, incidentally, sold a lot of papers. Wiley then instituted the "poison squad" (not his term), 12 volunteers who ingested quantities of food preservatives and tested the outcomes. Boric acid, ...,

sulphurous acid, benzoic acid and its derivatives, and formaldehyde were tested and publicly declared harmful. The press, needless to say, loved it. As consensus was built in legislative circles, it was essential to establish rules to prevent the more blatant practices in food handling and adulteration.

In February 1906, novelist Upton Sinclair published *The Jungle*, an account of the handling and packaging of meat in the Chicago stockyards, a truly horrifying report of unsafe handling by any standards, caused public outrage and the Food and Drugs Act of 1906 passed in Congress on June 30, 1906.

Wiley was instrumental in promoting of the passage of this Act, and his testimony, including displays of adulterated food, supported its passage. It is important to note, however, that Wiley's main concern was the elimination of deceit instead of the practice of food safety. 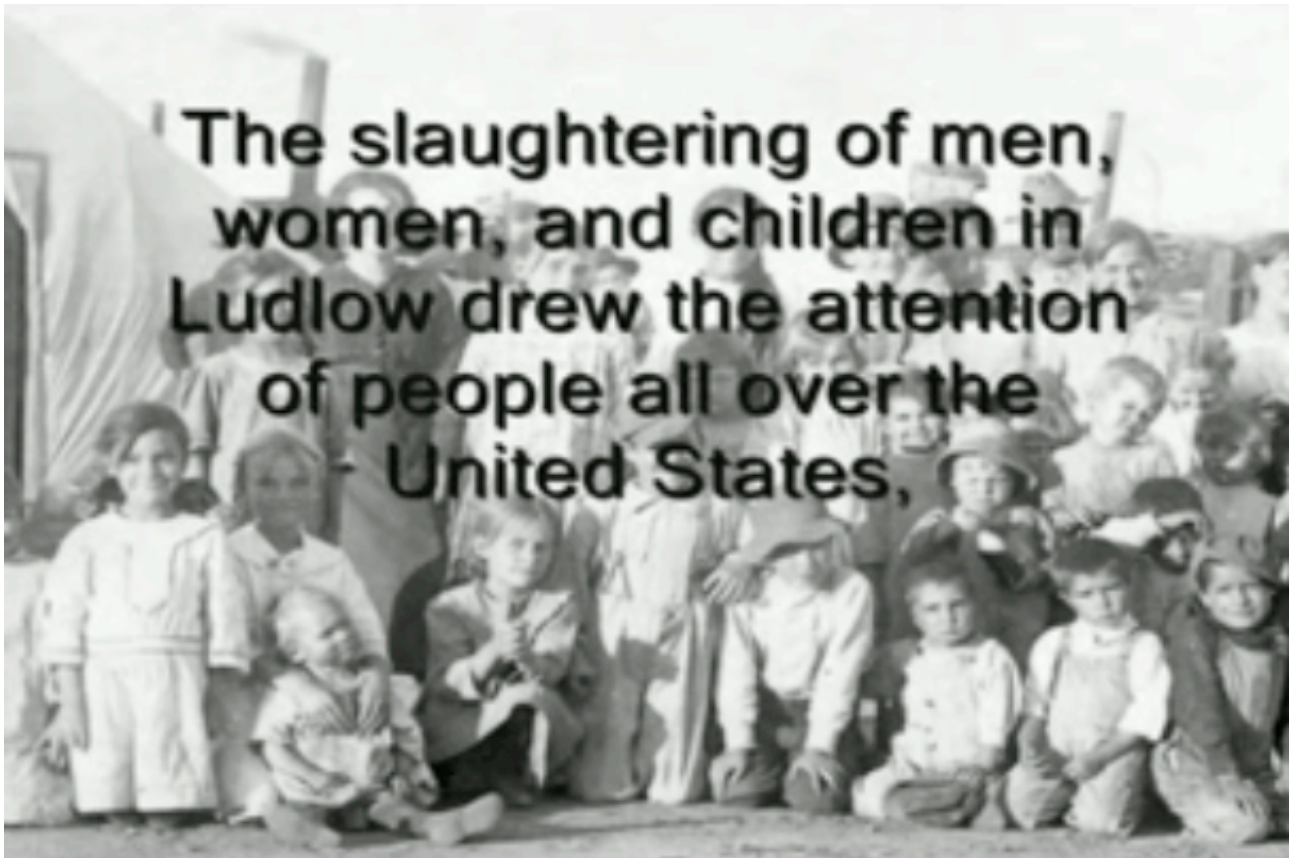

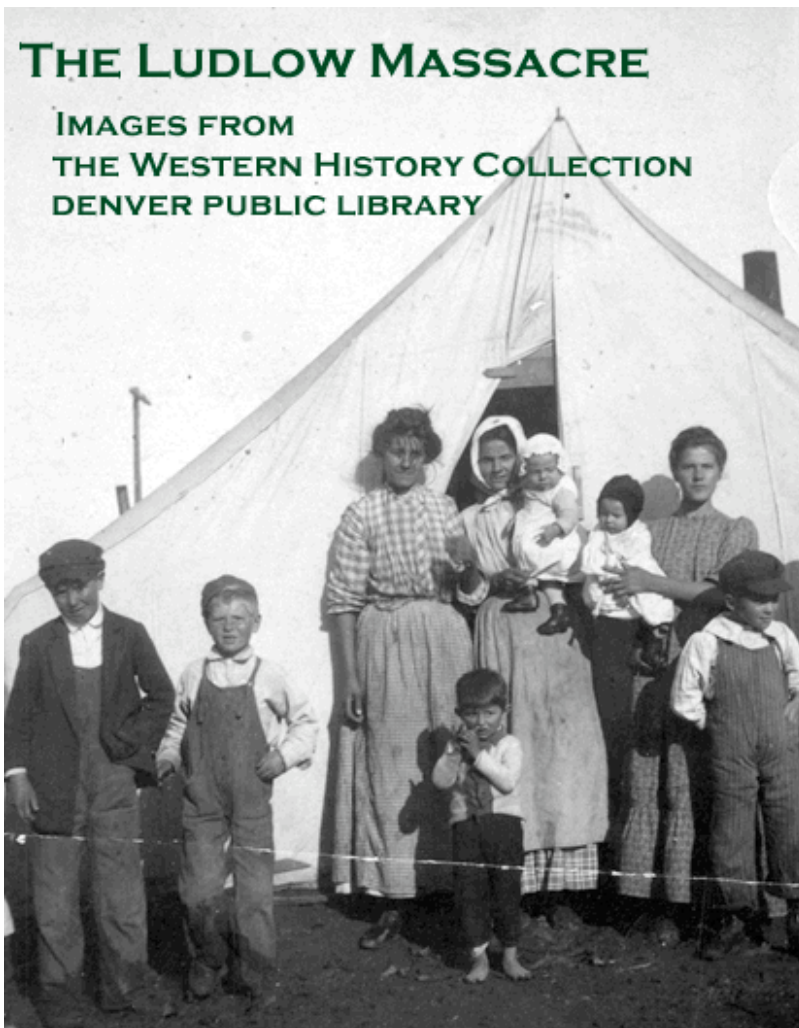

“This was the bloodiest event in the 14-month 1913-1914 southern Colorado Coal Strike. The strike was organized by the United Mine Workers of America (UMWA) against coal mining companies in Colorado. The three biggest mining companies were the Rockefeller family-owned Colorado Fuel & Iron Company (CF&I), the Rocky Mountain Fuel Company (RMF), and the Victor-American Fuel Company (VAF)....The UMWA decided to focus on the CF&I because of the company's harsh management tactics under the conservative and distant Rockefellers and other investors. As part of their campaign to break or prevent strikes, the coal companies had lured immigrants, mainly from southern and Eastern Europe and Mexico. CF&I's management purposely mixed immigrants of different nationalities in the mines to discourage communication that might lead to organization.....As was typical in the industry of that day, miners were paid by tons of coal mined

and not reimbursed for "dead work," such as laying rails, timbering, and shoring the mines to make them operable. Given the intense pressure to produce, mine safety was often given short shrift. More than 1,700 miners died in Colorado from 1884 to 1912, a rate that was between 2 and 3.5 times the national average during those years. Furthermore, the miners felt they were being short-changed on the weight of the coal they mined, arguing that the scales used for paying them were different from those used for coal customers. Miners challenging the weights risked being dismissed.



Most miners also lived in "company towns," where homes, schools, doctors, clergy, and law enforcement were provided by the company, as well as stores offering a full range of goods that could be paid for in company currency, scrip. However, this became an oppressive environment in which law focused on enforcement of increasing prohibitions on speech or assembly by the miners to discourage union-building activity. Also, under pressure to maintain profitability, the mining companies steadily reduced their investment in the town and its amenities while increasing prices at the company store so that miners and their families experienced worsening conditions

and higher costs. Colorado's legislature had passed laws to improve the condition of the mines and towns, including the outlawing of the use of scrip, but these laws were poorly enforced.

Despite attempts to suppress union activity, secret organizing continued by the UMWA in the years leading up to 1913. Once everything had been laid out according to their plan, the UMWA presented, on behalf of coal miners, a list of seven demands:

1. Recognition of the union as bargaining agent
2. An increase in tonnage rates (equivalent to a 10% wage increase)
3. Enforcement of the eight-hour work day law

4. *Payment for "dead work" (laying track, timbering, handling impurities, etc.)*
5. *Weight-checkmen elected by the workers (to keep company weightmen honest)*
6. *The right to use any store, and choose their boarding houses and doctors*
7. *Strict enforcement of Colorado's laws (such as mine safety rules, abolition of scrip), and an end to the dreaded company guard system*



Militia

The major coal companies rejected the demands and in September 1913, the UMWA called a strike. Those who went on strike were promptly evicted from their company homes, and they moved to tent villages prepared by the UMWA, with tents built on wood platforms and furnished with cast iron stoves on land leased by the union in preparation for a strike...

The company hired the Baldwin-Felts Detective Agency to help break the strike by protecting the replacement workers and otherwise making life difficult for the strikers.



Baldwin-Felts had a reputation for aggressive strike breaking. Agents shone searchlights on the tent villages at night and randomly fired into the tents, occasionally killing and maiming people. They used an improvised armored car, mounted with a M1895 Colt-Browning machine gun that the union called the "Death Special," to patrol the camp's perimeters. ...Because of frequent sniping on the tent colonies, miners dug protective pits beneath the tents where they and their families could seek shelter...See [http://en.wikipedia.org/wiki/](http://en.wikipedia.org/wiki/Ludlow_massacre)

The following account from a reporter on the scene was printed in the *New York World* at the time;

“AN EYEWITNESS ACCOUNT



“Then came the killing of Louis Tikas, the Greek leader of the strikers. We saw the militiamen parley outside the tent city, and a few minutes later, Tikas came out to meet them. We watched them talking. Suddenly an officer raised his rifle, gripping the barrel, and felled Tikas with the butt.

Tikas fell face forward. As he lay there we saw the militiamen fall back. Then they aimed their rifles and deliberately fired them into the

unconscious man's body. It was the first murder I had ever seen, for it was a murder and nothing less. Then the miners ran about in the tent colony and women and children scuttled for safety in the [underground] pits which afterwards trapped them.

We watched from our rock shelter while the militia dragged up their machine guns and poured murderous fire into the arroyo from a height by Water Tank Hill about the Ludlow depot. Then came the firing of the tents. . . . The militiamen were thick about the northwest corner of the colony where the fire started and we could see distinctly from our lofty observation place what looked like a blazing torch waved in the midst of militia a few seconds before the general conflagration swept through the place.” <http://a4a.mahost.org/ludlow.html>

In the Rockefeller Archives there were a number of documents that I came across which showed the depths to which the Rockefeller Family had been willing to go to enslave others. They are almost too painful to speak about. One of them was a letter thanking John D. Rockefeller, Sr. for his advise to burn down a building. The letter said that the insurance company had paid up nicely. It went on to say that he was glad to be free of the garment workers, better that they died than that he had be forced against his will to pay them more. I thought that he must be referring to the big fire in which many women had lost their lives, so I typed his name into a computer to pull up the information. Alas, I was correct. His name was Max Blanck.

*"The Triangle Shirtwaist Factory fire in New York City on March 25, 1911, was the largest industrial disaster in the history of the city of New York, causing the death of 148 garment workers who either **died from the fire or jumped to their deaths**. It was the worst workplace disaster in New York City until September 11, 2001. The fire led to legislation requiring improved factory safety standards and helped spur the growth of the International Ladies' Garment Workers' Union, which fought for safer and better working conditions for sweatshop workers in that industry."*

"On March 25, 1911, a pleasant springtime afternoon, a fire broke out in a garment factory near Washington Square in New York City's Greenwich Village. Within minutes, the entire eighth floor of the ten-story tower was full of flames. Onlookers, drawn by the column of smoke and the clamor of converging fire wagons, watched helplessly and in horror as dozens of workers screamed from the ninth-floor windows. They were trapped by flames, a collapsed fire escape and a locked door. Firefighters frantically cranked a rescue ladder, which rose slowly skyward—then stopped at the sixth floor, fully extended. Pressed by the

advancing blaze, workers began leaping and tumbling to their deaths on the sidewalk. Other workers perished in the flames, still others plunged into an open elevator shaft, while behind the factory two dozen fell from the flimsy fire escape. In all, 146 workers, most of them immigrant young women and girls, perished in the Triangle Shirtwaist Factory fire. For 90 years it stood as New York's deadliest workplace disaster....Worst of all, I couldn't find the official transcript of the trial of Isaac Harris and Max Blanck, the Triangle factory owners, who had been charged with manslaughter on the theory that their negligence caused the workers' deaths. Their three-week trial in December 1911 collected sworn testimony from more than 150 witnesses who were questioned while details of the disaster were still relatively fresh in their minds. Dozens of survivors, including Harris and Blanck themselves, recounted their narrow escapes, while firefighters, police officers and building engineers added details of the factory layout and the fire's awful progress. No other document could take me closer to that factory in the moments before and after the fire erupted.

*"I knew that a transcript had been prepared, because Stein had used it in his research: his notes were part of the labor history archive at the Kheel Center at Cornell University. Yet when I contacted the New York City archives, I was told that, well, the transcript—all 2,000-plus pages—seemed to have been lost. It apparently vanished, wouldn't you know, during a project to preserve historic documents. Sometime around 1970, an archives official explained, New York's John Jay College of Criminal Justice **received a grant** to transfer important court records to microfilm. **Somewhere between the courthouse and the college, the Triangle record was lost forever...***

[Later however, he found a copy left behind from the defense lawyer].

Those who experienced the horror firsthand could not have anticipated the impact. Nor could they have imagined that, someday—thanks to a lawyer's vanity, a buried footnote, a diligent librarian and the power of technology—their long-silent voices could speak directly of their experiences to readers around the world....

*Specially designed bins held hundreds of pounds of scrap cotton and tissue paper at a time. A Robber Baron's Delight in the Suffering of Others—1929 Stock Market Crash

Nelson Rockefeller used to brag to me that John D. Rockefeller caused the 1929 stock market collapse. It ruined his competitors, the smaller investor who were caught by surprise when it happened. He said that this forefather of his was delighted by the sight of his business rivals jumping out of Wall Street buildings to their deaths. He had told Nelson how much he enjoyed that and wanted to repeat that highlight of his life again. It was his dying request that it get repeated. This was something that Nelson told me many times, almost every time Helms sent me over to see him.

After 9-11, the Rockefellers made life-sized bronze statues of the people jumping out of the WTC as they fell to their deaths. They put them on public display in NY. The public outcry against the callous disregard of the victim's families required them to remove them. The businessmen in the WTC towers were not the ultra wealth Robber Barons that could afford their own buildings. They were the international competitors of them. Perhaps the Rockefeller family thought the similarity of the events, both occurring near the NY Stock Exchange was sufficient to fulfill that death-bed wish of their extremely wealthy ancestor.

“Years later, during the great depression, Congressman Louis T. McFadden (who served twelve years as Chairman of the Committee on Banking and Currency) asked for congressional investigations of criminal conspiracy to establish the privately owned 'Federal Reserve System'. ...McFadden even suggested that the Federal Reserve deliberately triggered the great stock market crash of 1929, in order to eventually force the passage of the Emergency Banking Act of March 9, 1933, which suspended the gold standard.

In describing the FED, McFadden remarked in the Congressional Record, House pages 1295 and 1296 on June 10, 1932:

"Mr. Chairman, we have in this country one of the most corrupt institutions the world has ever known. I refer to the Federal Reserve Board and the Federal reserve banks. It has done this through the misadministration of that law by which the Federal Reserve Board, and through the corrupt practices of the moneyed vultures who control it".

“During the 1920's. America enjoyed a decade of prosperity, fueled by the easy availability of credit. Between 1923 and 1929 the Federal Reserve expanded the money supply by 62%. When the stock market crashed, many small investors were ruined, but not 'insiders'. In March of 1929 Paul Warburg [of the Council on Foreign Relations] issued a tip that the crash was coming, and the largest investors got out of the market, according to Allen and Abraham in None Dare Call it Conspiracy.” With their fortunes intact, they were able to buy companies for a fraction of their worth. Shares that had sold for a dollar might now cost a nickel, and the buying power, and wealth, of the rich increased enormously. Louis McFadden, Chairman of the House Banking Committee declared: “It was not accidental. It was a carefully contrived occurrence...The international bankers sought to bring about conditions of despair here so that they might emerge as rulers of us all.”

The letter writer, Blanck, said that he made \$15,000 off of the insurance. In 1911, \$15,000 was a lot more money's worth than it is today.

In the letter he said that the gods had smiled on him. Certainly, he did not mean Christ and his Father who gave the commandment "Thou Shalt Not Kill."

Apparently, John D. Rockefeller, Sr. had written back demanding half of the profit as his due from giving the advice. The next letter from Blanck was not as glowing. He said that there were many expenses which he had not considered and the total profit was only \$200. There was a note in handwriting in the margin saying \$100 in cash received. Apparently, Rockefeller was not satisfied. He then appeared to have taken steps to land Blanck in court over the fire. Blanck wrote a letter to him offering to pay \$1,000 if he would call off "the legal war". There was a note in the file that the judge in the case had been paid by Rockefeller, but to do what was unspecified. But it was made a day later. The next letter from Blanck promise to pay Rockefeller the rest of the \$15,000, if Blanck was not sent to jail. Again there was a note that the judge was paid the next day. This time the amount was specified as \$2,000. There was a final note in the file with an obituary of Blanck which closed the file.

It was because I had been assigned by the DCI to find out if Nelson Rockefeller was selling US National Security Secrets to the Russians that I was looking into ways that he or his Family could be blackmailed. Also, from that era of time, there was another historically important case. This case also involved a fire to harm workers on a labor strike.

The setting was again replete with women and children. The workers were, like at Ludlow, directly working for John D. Rockefeller, Sr. The documents in this case were not private letters. They were documents from a US Court Case. That case was a suit filed against the Rockefeller owned Company for damages to the building because the insurance company had paid up and then found evidence of arson. They wanted the insurance money back. That case was filed a couple of years after the fire. The allegation of arson had arisen out of an investigation of another fire in which a man confessed to setting both fires. In both instances he was working as a manager for Rockefeller owned businesses. He had been found dead in his jail cell shortly after his confession, if I remember correctly. It was the same insurance company which had paid up in each of the two instances and they were less than pleased to do so. The Court Case which I read the documents on however only dealt with one of the two fires. It was from about the 1920's, if my memory serves me. What burned down was a dock and its related facilities which included several tenements along the waterfront. What was put up later brought in much higher rents as the tenements were very run

down and housed only poor people. At least that is what the insurance company was alleging and saying that they had been misled as to the value of the property at the time that they paid out on it. If I remember correctly, the location was Boston or New York.

What I found so upsetting as I read the court document was that the tenement's exits had been locked for the first time with padlocks on the night of the fire. Those who escaped did so by climbing out of windows. The tenements were about 3 stories high and some people had jumped out of those upper floors. The tenement buildings which burned were two of them side by side. Both had suddenly been locked for the first time that night. The fire occurred in the middle of the night while the residents were asleep. The manager who confessed was a manager at the dock. It is my opinion that that was for the Hamburg-America shipping line. He was a manager for the same company the whole time, but had been moved from overseeing workers at one harbor to another. The tenement housed the dock workers. They had organized a strike for better wages as their children were having to go barefoot even in winter due to their low wages. The strike was precipitated by one 7-year old boy losing one of the soles of his feet to frostbite requiring it to be amputated. So, the strike started inconveniently in the wintertime. The excuse of the fire allowed the company to turn the strikers out of the housing in the middle of winter. That broke the strike I believe, because the workers had to scatter to find a warm place to sleep. From what I read in the Rockefeller Archives, it appeared that the manager had set fires on two docks on different harbors some years apart, each time in response to a strike and on Rockefeller's orders. I say that because I read his employee file in the Rockefeller Archives. Each time after there was a fire affecting his dock workers he immediately within a week received a promotion.

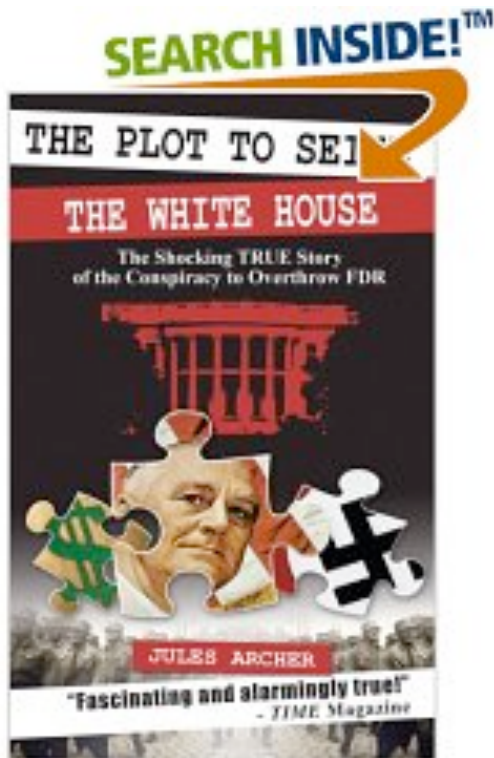
People perished as a result of the fire that I read about in the Court document. I may not have the exact figure right but my memory of it was that at least dozens died and others were burned or suffered smoke inhalation. More disturbing to me was a journal entry of John D. Rockefeller, Jr.'s which appeared to greatly delight in the suffering of those injured. He had written that success in causing them suffering had led to his god(s) being pleased and increasing his financial wealth. I did not doubt that his wealth was increasing, but to believe that it was the result of his causing people suffering (as many of his journal entries indicated) seemed superstitious to me. Still his beliefs did seem to be driving his behavior, though not in a way beneficial to Mankind. Because he had funded Eugenics projects I looked into the nationality of the dock workers. http://www.eugenics-watch.com/eugbook/euod_ch1.html They were mostly from Irish and German stock, with a few Italians and Greeks. The motivation thus appeared to be violence directed against the poor with a profit motive. Of course, I cannot be sure that there were not more personal motivations involved. But given the number injured and killed, I did not think so.

These issues, although in the distant past, are relevant ones to how the CIA was formed and how it operated. In my opinion it was formed to put down labor strikes around the world for Rockefeller and the other Robber Barons, including the Rothschilds. I say that because the first actions that the CIA engaged in after its formation had to do with destroying or hampering labor organizing in Italy, in France, in Guatemala, etc. If you read Philip Agee's [CIA Diary](#) about CIA operations in Latin America you will see that the CIA's activities continued in the 1970's being centered around breaking unions. That ensured low wages for the Rockefeller Family's many enterprises in Latin America.

I urge you again to read Howard Zinn's [A People's History of the United States](#) which gives the history of the workers. Most people know only the history of the US as taught to them in the public

Much has already been written about the attempted coup in 1934 by the Robber Barons to try to install a Fascist Government in the White House. In brief, fed up by FDR's New Deal policies to help the poor, the Morgans, Duponts, Rockefellers, Harriman-Bush and others, paid US General Smedley Butler via a front called the American Liberty League to have a fascist coup against the US government. It failed when the US General Smedley Butler refused to

go along with it. Clearly, they were not for democracy.

*"In **War Is A Racket**, Butler argued for a powerful navy, but one prohibited from traveling more than 200 miles from the U.S. coastline. Military aircraft could travel no more than 500 miles from the U.S. coast, and the army would be prohibited from leaving the United States. Butler also proposed that all workers in defense industries, from the lowest laborer to the highest executive, be limited to "\$30 a month, the same wage as the lads in the trenches get." "War is a racket pamphlet"

"War is just a racket. A racket is best described, I believe, as something that is not what it seems to the majority of people. Only a small inside group knows what it is about. It is conducted for the benefit of the very few at the expense of the masses.

I believe in adequate defense at the coastline and nothing else. If a nation comes over here to fight, then we'll fight. The trouble with America is that when the dollar only earns 6 percent over here, then it gets restless and goes overseas to get 100 percent. Then the flag follows the dollar and the soldiers follow the flag.

I wouldn't go to war again as I have done to protect some lousy investment of the bankers. There are only two things we should fight for. One is the defense of our homes and the other is the Bill of Rights. War for any other reason is simply a racket.

There isn't a trick in the racketeering bag that the military gang is blind to. It has its "finger men" to point out enemies, its "muscle men" to destroy enemies, its "brain men" to plan war preparations, and a "Big Boss" Super-Nationalistic-Capitalism.

It may seem odd for me, a military man to adopt such a comparison. Truthfulness compels me to. I spent thirty- three years and four months in active military service as a member of this country's

most agile military force, the Marine Corps. I served in all commissioned ranks from Second Lieutenant to Major-General. And during that period, I spent most of my time being a high class muscle- man for Big Business, for Wall Street and for the Bankers. In short, I was a racketeer, a gangster for capitalism.

I suspected I was just part of a racket at the time. Now I am sure of it. Like all the members of the military profession, I never had a thought of my own until I left the service. My mental faculties remained in suspended animation while I obeyed the orders of higher-ups. This is typical with everyone in the military service.

I helped make Mexico, especially Tampico, safe for American oil interests in 1914. I helped make Haiti and Cuba a decent place for the National City Bank boys to collect revenues in. I helped in the raping of half a dozen Central American republics for the benefits of Wall Street. The record of racketeering is long. I helped purify Nicaragua for the international banking house of Brown Brothers in 1909-1912. I brought light to the Dominican Republic for American sugar interests in 1916. In China I helped to see to it that Standard Oil went its way unmolested.

During those years, I had, as the boys in the back room would say, a swell racket. Looking back on it, I feel that I could have given Al Capone a few hints. The best he could do was to operate his racket in three districts. I operated on three continents.” http://en.wikiquote.org/wiki/Smedley_Butler

"War is a racket. It always has been. It is possibly the oldest, easily the most profitable, surely the most vicious. It is the only one international in scope. It is the only one in which the profits are reckoned in dollars and the losses in lives."

"There are 40,000,000 men under arms in the world today, and our statesmen and diplomats have the temerity to say that war is not in the making. Hell's bells! Are these 40,000,000 men being trained to be dancers?"

"In the World War [I] a mere handful garnered the profits of the conflict. At least 21,000 new millionaires and billionaires were made in the United States during the World War. That many admitted their huge blood gains in their income tax returns. How many other war millionaires falsified their tax returns no one knows.

How many of these war millionaires shouldered a rifle? How many of them dug a trench? How many of them knew what it meant to go hungry in a rat-infested dug-out? How many of them spent sleepless, frightened nights, ducking shells and shrapnel and machine gun bullets? How many of them parried a bayonet thrust of an enemy? How many of them were wounded or killed in battle?

Out of war nations acquire additional territory, if they are victorious. They just take it. This newly acquired territory promptly is exploited by the few -- the selfsame few who wrung dollars out of blood in the war. The general public shoulders the bill.

And what is this bill?

This bill renders a horrible accounting. Newly placed gravestones. Mangled bodies. Shattered minds. Broken hearts and homes. Economic instability. Depression and all its attendant miseries. Back-breaking taxation for generations and generations.

To summarize: Three steps must be taken to smash the war racket.

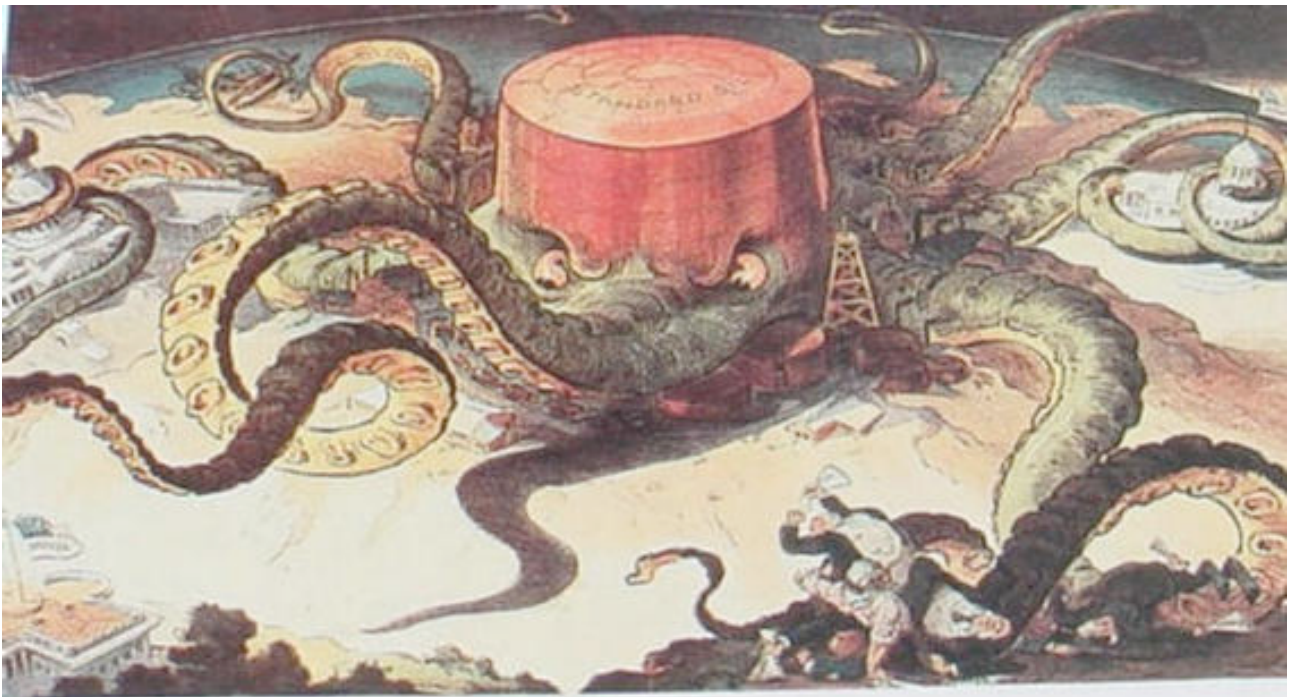
- 1. We must take the profit out of war.*

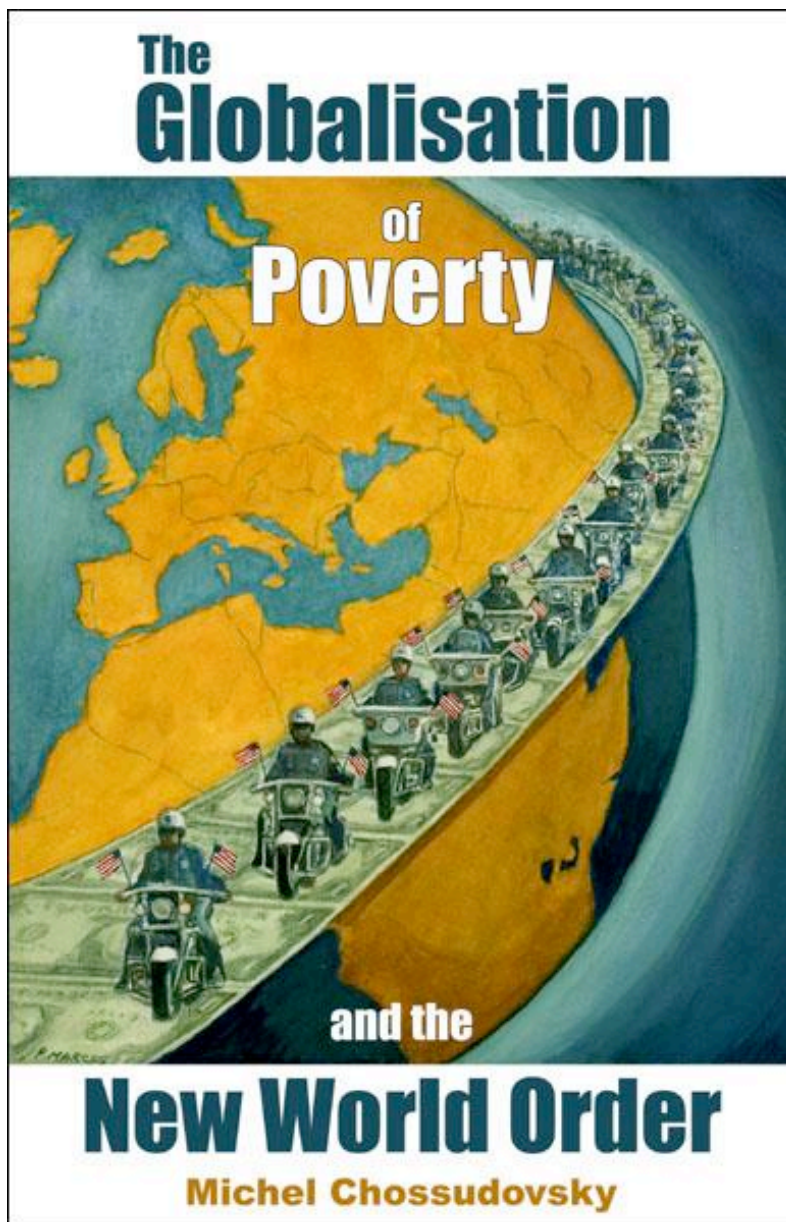

The American Eugenics Movement Predated the Nazi One

Eugenics or Democracy

"In 1930 John D. Rockefeller and John D. Rockefeller Jr. were members of the American Eugenics Society. Furthermore, in the Twenties Raymond Fosdick, an important official of the Rockefeller Foundation, was a member of the American Eugenics Society Advisory council. In this period the Rockefeller Foundation gave money to build quarters for Ernst Rudin, the man who later wrote Hitler's 1933 Sterilisation Law.(6) As co-founder with Alfred Ploetz of the German Eugenics Society, Rudin claimed credit as the inspiration for all Hitler's racial laws, including the Nuremberg laws which made Jews second class citizens in Germany.(7) In the early part of the century Mrs. E.H. Harriman, who inherited the fortune based on the Union Pacific railroad, created the Eugenics Record Office. Her endowment helped fund the work of Harry Laughlin, the director of the Eugenics Record Office. Laughlin wrote the Model Sterilisation Law which Nazi eugenicists used as a model for their 1933 Sterilisation Law. He accepted an award from Heidelberg University honouring him for his part in developing this law.(8) He was also an important witness at the Congressional hearings on the Johnson Act, the immigration Act which began the policy of national immigration quotas. Such initiatives became a terrible trap for the Jews in the late Thirties. The Johnson Act ultimately resulted in the exclusion from America of the Jews attempting to flee Nazi Germany and its racial laws - laws inspired by Laughlin, Rudin and other eugenicists....

Followed these Quota Acts which said to the world: America, still overwhelmingly Nordic, proposes so to remain! These acts began a gigantic eugenic experiment in population control."(9) After this came the genocide. That which we now call genocide was then called eugenics.(10) Auschwitz showed the world the true face of eugenics. Yet some among the wealthy continued to support it.(11) For example, we find the names Rockefeller and Harriman, supporting the introduction of abortion and contraception, the means of eugenics. John D. Rockefeller III gave Margaret Sanger money with which to develop a contraceptive. Mrs. E.H Harriman's son was Averill Harriman, Governor of New York in the Fifties. Harriman allowed Robert Moses to follow a policy of letting Harlem deteriorate. (See Robert Moses and the Fall of New York., Robert Caro) It was then possible for the next governor, Nelson Rockefeller, to speak of the dreadful conditions in Harlem and the need for contraception and abortion as a solution for the problems of the people trapped there. Hence, in the Sixties, abortion, a eugenic goal, came to be seen as "progressive" in New York State. In the early Seventies, Nelson Rockefeller signed one of the first state law allowing widespread abortion, and the Rockefeller family gave money for the first legal abortion facility in New York State.... <http://www.eugenics-watch.com/roots/chap10.html> John D. Rockefeller's leadership in the Population Council was not the first Rockefeller foray into eugenics. When Alexis Carrel wrote his book advocating euthanasia institutions with a suitable gas for exterminating various people, he was on the staff of the Rockefeller

Institute. The Rockefellers financed the Kaiser Wilhelm Institute in the 1920s, and provided funds for Ernst Rudin for genetic research in the 1920s. ...

A feminist author, Germaine Greer, commented on the post-war movement, saying: "It now seems strange that men who had been conspicuous in the eugenics movement were able to move quite painlessly into the population establishment at the highest level, but if we reflect that the paymasters were the same -- Ford, Mellon, Du Pont, Standard Oil, Rockefeller and Shell -- are still the same, we can only assume that people like Kingsley Davis, Frank W. Notestein, C. C. Little, E. A. Ross, the Osborns Frederick and Fairfield, Philip M. Hauser, Alan Guttmacher and Sheldon Segal were being rewarded for past services." In other words, the population control movement was the same as the old eugenics movement -- the same money, the same leaders, the same activities -- but with a new excuse. ... "

Eugenics and the Nazis -- the California connection

"In California, decades before Hitler came to power. California eugenicists played an important, although little-known, role in the American eugenics movement's campaign for ethnic cleansing....Ultimately, eugenics practitioners coercively sterilized some 60,000 Americans....

Eugenics would have been so much bizarre parlor talk had it not been for extensive financing by corporate philanthropies, specifically the Carnegie Institution, the Rockefeller Foundation and the Harriman railroad fortune. They were all in league with some of America's most respected scientists from such prestigious universities as Stanford, Yale, Harvard and Princeton. These academicians espoused race theory and race science, and then faked and twisted data to serve eugenics' racist aims.

Stanford President David Starr Jordan originated the notion of "race and blood" in his 1902 racial epistle "Blood of a Nation," in which the university scholar declared that human qualities and conditions such as talent and poverty were passed through the blood.

In 1904, the Carnegie Institution established a laboratory complex at Cold Spring Harbor on Long Island that stockpiled millions of index cards on ordinary Americans, as researchers carefully plotted the removal of families, bloodlines and whole peoples. From Cold Spring Harbor, eugenics advocates agitated in the legislatures of America, as well as the nation's social service agencies and associations.

The Harriman railroad fortune paid local charities, such as the New York Bureau of Industries and Immigration, to seek out Jewish, Italian and other immigrants in New York and other crowded cities and subject them to deportation, confinement or forced sterilization.

The Rockefeller Foundation helped found the German eugenics program and even funded the program that Josef Mengele worked in before he went to Auschwitz....

The most commonly suggested method of eugenicide in the United States was a "lethal chamber" or public, locally operated gas chambers. In 1918, Popenoe, the Army venereal disease specialist during World War I, co-wrote the widely used textbook, "Applied Eugenics," which argued, "From an historical point of view, the first method which presents itself is execution . . . Its value in keeping up the standard of the race should not be underestimated." "Applied Eugenics" also devoted a chapter to "Lethal Selection," which operated "through the destruction of the individual by some adverse feature of the environment, such as excessive cold, or bacteria, or by bodily deficiency."

*Eugenic breeders believed American society was not ready to implement an organized lethal solution. But many mental institutions and doctors practiced improvised medical lethality and passive euthanasia on their own. One institution in Lincoln, Ill., **fed its incoming patients milk from tubercular cows** believing a eugenically strong individual would be immune. Thirty to 40 percent annual death rates resulted at Lincoln." ...*
