## Case 23 Did the US Administration Threaten Me with 'Endless Torture' Today?



CIA Rendition Plane at the Perugia, Italy's Airport Today 9 July 2008

Today I went to the Perugia airport to fly out of Italy before my 90 day tourist status expired on July 12, 2008. I have been writing my eye-witness account of corruption of high officials; are they so angry at me they want me tortured? Here is part of the message that I sent to the FBI via their tips hotline and also to the US Congressional Govt. Oversight and Reform Committee;

To the Directors of National Intelligence, the FBI, the FBI's head of Counter Intelligence, the CIA, and all those handling the message in between;

"As former Special Operations Advisor for DCIs, I am submitting information to the US Congressional Govt. Oversight and Reform Committee (see Special Report at <a href="www.libertycalling.com">www.libertycalling.com</a>) on CIA and US Administration corruption. That includes the evidence that the Rockefeller and Bush Families funded Hitler into power and built the Auschwitz Labor Camps in order to the slave labor. It includes the evidence that Bush, Jr. is using slave labor to build the US Embassy in Baghdad. It includes that Bush, Cheney, Rockefellers, Rumsfeld, Rice and others got big kickbacks on KBR's contract of more than 300 million dollars to build US Concentration Camps. And it includes that

the heating of sodas to fed the US troops was done intentionally while the US Administration knew that could kill them in the event of a wound via secondary bacterial infection. I was told by a US Army Biological and Chemical Warfare researcher, Dr. "Bud" Hamilton, if I remember the name correctly, that the point was to reduce VA costs by converting potential amputations to death. When the soldiers die in the hospital in Germany, their deaths are not listed as combat deaths even though they received the wounds in combat. Thus, I am at high risk of the CIA or its proxy forces retaliating against me, even if it causes the death of other innocent lives...."



Perugia's airport is the size of a postage stamp with one waiting room. There were a few dozen people inside that waiting room. None of them seemed to recognize the plane sitting directly in front of its wide windows today was a CIA rendition plane. That fact, however was not lost on me. I did not think that the several CIA rendition planes on that tiny field were meant for any of them. There were no terrorists in the room that I could see; I didn't see a single Muslim to represent the "official enemy". I thought that those planes were there to threaten me with endless torture, sensory deprivation and, detainment without trial.

I am not a terrorist and the US Administration and CIA know it. I was the CIA's expert on non-violent resistance. That is why I was a "Special" Operations Advisor. The CIA's standard operations were all dirty ones. The US Administration was not happy with me after Tenet authorized me to conduct studies on my non-violent ethical operational

methods. In 2004, after 4 months of a study in which the computer assigned tasks to me or Executive Deputy McLaughlin randomly, the results came in. McLaughlin used the CIA's usual dirty methods. And I, using CIA operative that I trained in my methods, used only clean methods which did not require a single bullet, blackmail, or black method. The results showed that the CIA would run better on each of the 17 criteria that the CIA judged the results by, if it converted to only using clean ethical methods. One of the criteria was profits to the Defense Industry. I took care to find other ways they they could make money other than threatening, maiming, and killing people. It is not only possible to convert weapons to plowshares, it is more profitable!



Here is the second rendition plane which was parked right in front of the waiting room windows. How could I not take that as a visible threat to my life, liberty, and pursuit of happiness? It was an obvious attempt to intimidate a witness giving written testimony to the US Congress. That is obstruction of justice, plain and simple.



A close up of the call letters on it show how carefully lettered they are. But the people rendered in the planes end up tortured in ways that few people even want to hear about.



Bush talks about freedom. He seems to mean the freedom for him to lie, torture, and get away with war crimes, treason, and destruction of the US Constitution. He sure isn't interesting in tearing down the US Concentration Camps; he hasn't even told you about them.

He has lied for a long time about the fact that the US does kidnap people, innocent people, not just terrorists.

The fact is that that almost all of the people that the CIA kidnaps and tortures are innocent.

These kidnap and torture programs are making the world less safe for Americans, not more safe.

One cannot fight crime and terrorism, by

committing it.



Here is the third CIA rendition type plane at Perugia today. Isn't that a show of overwhelming force in this tiny airport. The first plane was lined up against the fence as one drove up to the airport. It was impossible to miss seeing it. The second was even more impossible to miss seeing as it filled the waiting room window. But this one with the call letters on a fuselage in the mid-line of the plane was parked further away. The number is not big enough for me to read.

A fourth one is not seen as it took off with a bunch of brown suited and black suited officials before I could get a good photo of it. I did try to photograph it and some of the people. But when I was taking photos inside the airport, a security guard forced me to erase the picture on penalty of confiscating my camera, if I did not. Usually, people are free to take photos out the windows of an airport--not today with the CIA there in force.



And this all white plane without an Air Line insignia on it, what is this, is this a European version of a CIA rendition plane? I know that the men I say get into the plane which took off were not all US or UK; I spoke to one of them near the train station. When I asked him where to catch the bus to the airport, he answered me in heavily accented imperfect English. Who in the EU has been aiding and abetting the US Administration's kidnapping and torture spree? Did they fund the Nazis and use the slave labor also?

When I tried to get help from the EU Parliament's Legal and Human Right's Committee, members of it refused to meet with me. When I ended up meeting with the secretary of that Committee, Mr. Schmeier, it turned out that he worked in the capacity of gatekeeper to that committee apparently with a security clearance directly from CIA! That Committee claimed to be investigating CIA renditions; were they also covering up CIA renditions by their refusing to meet with me and hear the full awful story? Clearly they have not taken much action to stop CIA renditions in Europe or all those CIA rendition planes would not have been sitting on that field in Italy today to threaten me with endless torture and false imprisonment.
