I should add that to date, the MOD knows of no evidence which substantiates the existence of these alleged phenomena.

With regard to your particular observation, I can confirm that we received one other report of a 'UFO' sighting for the 4 September 2008, and that was from Guildford in Surrey. We are satisfied that there is no corroborating evidence to suggest that the United Kingdom's airspace was breached by unauthorised aircraft.

Finally, with regard to there being any low flying military aircraft in the area, I enquired, and have been informed that there was a Tornado in the vicinity at 21.00 at 250 ft, but that was only there for one minute as it flew by, on the way to RAF Marham.

Just got into the hot tub to relax and looking at the stars and clouds, Suddenly I spotted something moving in the sky. It was at an altitude of approximately 500 feet heading in a north /north east direction at about 30-40 miles an hour (slower than a light aircraft). best way to describe the shape would be a chewing gum pack that was about 150 feet long 50 feet wide and about the same in height . It came right over where I was and passed over my house

It was black in colour and had 3 circles of lights/ exhausts underneath it emitting a dull orange light, similar to embers in a fire. I could see it quite clearly as it was visible by the ambient light and the cloud that was above it. It made no noise whatsoever and the only variation to the shape was a slight ridge around where the lights/ exhausts were. The lights were spread out the length of the object similar to traffic lights, one in the center and the others at about 10 feet from each end the diameter of the lights were all the same at approximately 30 feet, leaving 10 feet on each edge.

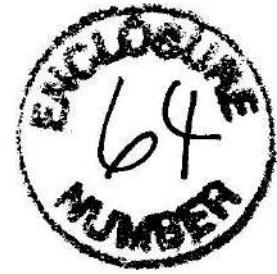

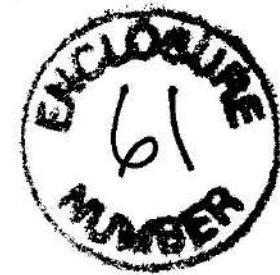

As I came down the hill I saw people stopping to look at the sky. Further down a couple were stopped and were pointing at the sky to the East. I saw three very low, very bright lights travelling in formation then breaking off and doing acrobatics seen in sky over Canterbury. The lights were distant (probably a couple of miles) but large globe-like, travelling very fast and then coming to an almost immediate stop, changing direction in an instant, and changing colour in a pulsating way (not the flashing lights of a plane or helicopter), ranging through bright white light through red, green, blue, and orange. The incident was so strange I pulled the car over in the St Stephens Road area (just before the railway crossing) as dozens of people had come out of their houses and were pointing and staring at the sky. One commented that "they flew really low over our house and then shot off really fast, a few miles in a second".

I watched them for a few more minutes as they again reformed into a formation and travelled East towards Sturry / Broad Oak. One broke off and headed rapidly back towards my position before stopping and following the others. I jumped in my car and drove onto the Broad Oak Road to follow them, but could not see them in the sky any more. I did see some bright red lights stationary on the hill above the Broad Oak Road but could not ascertain what they were in the dark (I know there are pylons there so although unusually bright they could have been the hazard warning lights on those).

East of Canterbury is Manston International Airport, but this is not a usual flightpath and most significantly these lights were accompanied by no sound (indeed I could say they seemed to be accompanied by a silent stillness).

They looked and behaved like no plane or helicopter I have seen.

Were there any low flying military flights in this area at this time? Were any objects detected on radar in the area at this time.

If not, can you register my concerns over what I saw?

The speed was considerably faster than an aircraft or satellite, yet not so fast that it disappeared in an instant. My wife had time once seeing it to call my attention to it before it disappeared. We would describe it as silver \ white in colour.

We are of the opinion that there is a totally reasonable explanation for what we saw. However we are at a complete loss as what it was and can offer no intelligent suggestion.

I am writing with reference to your report of an 'unidentified flying object', seen on 23 July 2008, the details of which you left on our answerphone. This office is the focal point within the Ministry of Defence for correspondence relating to 'UFOs.'

First, it may be helpful if I explain that the Ministry of Defence examines any reports of 'unidentified flying objects' it receives solely to establish whether what was seen might have some defence significance; namely, whether there is any evidence that the United Kingdom's airspace might have been compromised by hostile or unauthorised air activity.

Unless there is evidence of a potential threat to the United Kingdom from an external source, and to date no 'UFO' report has revealed such evidence, we do not attempt to identify the precise nature of each sighting reported to us. We believe that rational explanations, such as aircraft lights or natural phenomena, could be found for them if resources were diverted for this purpose, but it is not the function of the MOD to provide this kind of aerial identification service. It would be an inappropriate use of defence resources if we were to do so.

The MOD does not have any expertise or role in respect of 'UFO/flying saucer' matters to the question of the existence or otherwise of extraterrestrial life forms, about which it remains totally open-minded. I should add that to date, the MOD knows of no evidence which substantiates the existence of these alleged phenomena.

With regard to your particular observation, I can confirm that we received no other reports of 'UFO' sightings for 23 July 2008 from anywhere in the UK. We are satisfied that there is no corroborating evidence to suggest that the United Kingdom's airspace was breached by unauthorised aircraft.

The Sun has reported a UFO sighting over Ternhill Barracks in Shropshire at about 11pm on 7 June 2008. It appears that a number of soldiers saw lights in the sky and made a video which they have passed to the newspaper. They have not made a formal written report on the matter, although they did inform their superiors.

The MoD in London became involved when the press office was contacted by the newspaper on 24th June. On 25th June I requested a copy of the video from Media Ops at HQ 5 Div where it had been passed by the unit concerned. It shows a number of lights in the sky. As reported in the paper, the lights change colour and appear square, but this looks like the pixels showing up as the photographer zoomed in. They do not appear to be moving very quickly.

The BBC has reported that at the same time as the alleged incident, a local hotel was letting off Chinese lanterns and, apparently, the hotel manager thinks the whole UFO story is "highly hilarious".

I do not intend to investigate any further as I think we have our answer and, as I suspect there might be copyright issues surrounding the video, do not intend to retain a copy on our files.

I took a call this morning from the 2IC rear party at 1 Royal Irish at Tern Hill Capt Section 40 on Section 40
 Section 40

A soldier who was part of a fire picket stagg on at the camp on 7 June took video footage with a camera on a mobile phone of what he says were "UFOs" in the sky above the camp – which they have emailed to The Sun – and which The Sun is apparently planning on splashing – probably tomorrow.

I don't have all the details/timings but what I do have is the following:

1. Soldier is Cpl Section 40 who the phone belongs to – he was accompanied by Pte Section 40 who also witnessed the "UFOs".
2. The footage was taken on 7 June at 23.03hrs – with a 5 megapixel camera on the phone.
3. 2IC rear party says the video images are very good.
4. The 2IC says the images could not have been anything to do with nearby RAF Shawbury.
5. They show lots of multi-coloured dots and zoom in on a cube shaped object which then flattens.
6. The Sun has already interviewed Cpl Section 40 he has explained to them what he saw.
7. There is some suggestion of payment being offered – though I think a discussion about that has still to happen.
8. I have reminded all, the 2IC and Cpl Section 40 about their responsibilities ref the DIN on communicating with the media.
9. Cpl Section 40 spoke to Section 40 an editor at The Sun (?)
10. Cpl Section 40 mobile number is Section 40
11. I spoke to the CRO at RAF Shawbury who said he was not aware – Sqn Ldr Section 40

In my opinion it completely undervalues and ridicules the ultimate sacrifice that someone has paid. The soldiers involved in the release may just like to ponder that.

I reiterate the point from my previous E mail that these soldiers must be dealt with under the Defence Instructional Notice for unauthorised engagement with the media but that is Chain of Command business.

Media Enquiries - The Way Forward. The MOD Line currently is: **The MoD examines reports solely to establish whether UK airspace may have been compromised by hostile or unauthorised military activity. Unless there is evidence of a potential threat, there is no attempt to identify the nature of each sighting reported.** We have no reason to change that line and anything else we say will only give the story legs. Therefore I believe we should not say anything more or do anything more on this. I cannot see any opportunities here especially when contrasted with the recent deaths and the funerals that are taking place. There should therefore be no further release of the video or comments made and then the story will hopefully die quickly.

Sir,

I have spoken with theatre and the CO agrees that this matter should be investigated and disciplinary action follow. We have ascertained that Pte [Section 40] was merely present but has not been in contact with the press and was surprised when his name was mentioned. The case against is being put together and sent to 5XX Legal for formal legal advice, once we have this disciplinary action will be conducted. Cpl [Section 40] has been warned that disciplinary action may follow.

5XX COS has now spoken to us on two occasions (both before the news broke and after the explanation for the 'UFOs' came out) and GOC 5XX is well aware of the issue. COS is satisfied that unless legal advice says otherwise, we the unit will deal with disciplinary action.

Cpl [Section 40] his part has shown genuine remorse and did come to us as soon as he realised what he had done. He had attempted to keep what he said from the Sun and is himself seeking legal advice against the Sun for publishing details he specifically asked them not to publish. In addition, the Sun have misrepresented him and his video footage, showing a street light in the still picture but not explaining that this was a street light.

The DIN has again been published on Part 1 Os, in addition, the Rear Party has been briefed on Media Contact so that they are aware of more than the G1, G2, Operational G3, and G4 aspects of our current Op tour. I don't expect legal advice to come back until the week after next.

The Sun have not approached us in London about this yet but probably will do in due course.

Handling. I have agreed with SIO 5 Div that we are not putting the soldiers up for further interviews. There is no opportunity to get our messages out and there is nothing reputation enhancing in this story and risk that it will be revealed as a fake and the soldiers/Bn will look stupid. Cpl Section 40 has already given enough to the Sun when he spoke to them and they have his video. He has been sent a contract which I suggest SIO 5 Div needs to see to ascertain whether or not we can stop publication of the video. I suspect we will not be able to. It may be that we meet the Sun half way and get them to run it without saying who passed it to them but that is a very very long shot.

DIN Breach. I have just explained to Capt Section 40 that while it is a Chain of Command issue the soldiers have breached the DIN on engagement with the media and should be disciplined for that. To hear that a Cpl is claiming that he is unaware of the rules I find somewhat incredulous. I have made it clear to Capt Section 40 that the soldiers need it explaining very clearly to them that they are to have nothing more to do with the media even if called by them about this or anything else. For example, the scenario of a death in theatre from the Bn and them then being called to give comment is very credible.

The Future. Any oxygen given to the story will simply incur lots of work subsequently and if it is printed in the Sun tomorrow there will then be lots of subsequent regional interest As explained to Capt Section 40 instead of dealing with the huge interest in the recent 9 fatalities and helping prevent aggressive media intrusion with the families I am now spending time on this (avoidable) incident. If it runs tomorrow then the unit will be approached by regional outlets who will want a piece of the action preventing the unit from getting on with supporting those on ops and those remaining behind. The soldiers may just wish to ponder the subsequent effects of what they have done!!
