WEEKEND AT PARLIAMENT HILL

Freedom Convoy 2022 continues to maintain a strict non-violent policy. We assess that the most significant threat to public safety comes not from the convoy, but rather from outside agitators who wish to cause disruption to discredit the convoy. Freedom Convoy 2022 remains in constant communication with front line officers of the Ottawa Police Service.

POLICE RELATIONS

Freedom Convoy 2022 continues to assess those relations with police forces overall remains positive. The exceptions remain certain mid-ranking Ottawa Police Service officers who continue to agitate and attempt to create drama and fear over non-significant events.

PREMIER FORD AND PRE-CRIME ACTION

"Conservative" Premier Doug Ford of Ontario obtained a court order to freeze all monies associated to Give Send Go and Adopt a Trucker. This evidence-free overreach of power has several important implications. Among them are:

a. Regardless of your views on Freedom Convoy 2022, the actions of Premier Ford should frighten everyone. Premier Ford, with no evidence, is attempting to defund and criminalize average citizens who do not wish to submit to the Trudeau/Ford policy line. If this action succeeds, it will then be possible for

governments to destroy any group or citizen by simply declaring them a threat and then taking their money. Canada continues to move away from a viable democracy towards a Venezuela style failed government.

- b. Give/Send/Go has publicly stated that Premier Ford's decision will have no effect on their operations. The money sent to Give/Send/Go is resident in an American bank and is not subject to Canadian law.
- c. Beyond the legal concerns about Ford's actions, there is the moral element. Every time a government official attempts to cut off Freedom Convoy 2022 from funding, fuel, food, firewood or other resources, the organic support from the citizens increases at no financial cost to Freedom Convoy 2022. Food and fuel remain plentiful.

LIBERAL PARTY ACTIVITIES

Member of Parliament Housefather is now the third Liberal MP to break with Prime Minster Trudeau and his positions of mandates and other related information.

POLICE FUTURE ACTIONS

Freedom Convoy 2022 assess that despite their attempt to make a major push against Freedom Convoy 2022 over the last week, their attempts are failing. Among the reasons for this are:

- a. The legal justifications for seizing fuel are doubtful at best. They appear to be incompetent of court based on an earlier injunction ruling.
- b. The concept of arresting Freedom Convoy supporters on mischief charges is, legally speaking, doubtful. The police chiefs are aware of it.
- c. Police forces and induvial officers are starting to assess their own role in the Freedom Convoy movement. Many individuals are questioning the legality of the actions of their own forces.
- d. Resource management is becoming an issue for police forces. The large number of officers from outside of Ottawa (Durham, Peel, London, Hamilton, Toronto, etc) is straining manning levels at their home units. Additionally, most of the outside officers are spending their time doing aimless patrols around downtown Ottawa.
