## **Gabby Petito and Brian Laundrie**

The FBI announced about an hour ago that the remains of Brian Laundrie were in fact found yesterday. Years ago I decided not to do police work because there is zero protection for the psychic. Posting this after Laundrie's remains were identified was equally intentional as I have no desire to do future police work. That choice doesn't keep the information from coming in.

This post is going to get graphic. You have had your trigger warning. If Gabby's family stumbles across this, they may not want to read any further.

The Gabby Petito and Brian Laundrie case gripped the nation since mid-September 2021. I spent a lot of time hoping the information I was getting would prove to be wrong. Unfortunately much of it was accurate.

I don't enjoy remote viewing of human remains. Let alone full color, detailed images. I got them with both Gabby and Brian at different points. I also had an unexpected and rather different encounter with Brian's shade the day before his remains were found.

I am going to work backwards from Brian's remains being identified to my earlier remote viewing perceptions of Gabby's fate.

There was a lot of sketchy behavior and actions on the part of the Laundrie parents that looked really bad to members of the public. There persists a lot of understandable anger. We may or may not ever get full answers to the many questions involved. It will probably depend on how things unfold in the courts in the aftermath of today's news that Brian is in fact dead. My job is not judge, jury and executioner. So I am going to stick to what I picked up on and future public disclosures will fall where they may.

Normally when I read a situation I DO NOT follow media coverage or research the situation prior. I go into readings as cold as possible so the information I get is not tainted by news coverage. This time I was just following the case with everyone else, so the psychic hits came in interspersed with media coverage. It is not a best practice, but I had no idea I was going to write about this and no client asking me to look into it.

I have known for weeks Brian was dead. Not much a stretch, a lot of others had come to the same conclusion. A couple days ago on October 19th I had just gotten up for the day. Like many people the first thing I did was head to the restroom. That is when Brian's shade showed up.

Brian was in an emotional state. Crying he told me Gabby's death via throttling at his hands was an accident. He didn't mean to do it. Things went too far. Then he collapsed into a sobbing heap on my bathroom floor.

I didn't want him to remain there so I called in the guidance I frequently use in sorting out dark entities or unsettled graves. That appropriate archangel arrived and I asked what could be done?

A young, four or five year old Brian came out of the sobbing heap of wretchedness on my bathroom floor. He was still innocent and quite confused about being there. Toddler Brian asked the angel, "What is happening? Where are we going?" The angel replied Brian was going to see his grandmother shortly. Sure enough an elderly lady showed up with her husband standing a short distance away from her keeping an eye on things. Toddler Brian recognized her immediately, called out "Bubbie!" and ran into her arms. I realize Laundrie is an English name and Brian's mother's maiden name is an Italian one, so not sure why he used that particular endearment, but that is what I heard. She scooped him up and cuddled him, clearly delighted to see him. Brian's grandfather joined them and they headed in the direction of a gathering group of late relatives who were there to welcome him home.

That left the sobbing wreck of adult Brian on my floor. I asked that wretched, ill, distraught shell be dealt with as I wasn't about to live with it hanging about. The same angel collected the mess, brought it up to the face of God and it was dissolved. Thus the part of Brian that could be salvaged was. The ill, murdering, wretched part that could not was no longer in existence. I had never seen that happen with a human soul before. Dark entities yes, humans, no.

The next day when news reports started to come in that human remains had been found not far from where Brian had parked his Mustang when he went "hiking" on September 13th or 14th depending on how his parents story kept changing, I figured it was what was left of him. Reporting and common sense made it clear those remains were not gong to be intact. I got a full color visual of authorities finding his head. Half was unrecognizable due to animal activity and mud. The other half was pretty rough due to decomp, dehydration etc... The somewhat

recognizable features slid off the skull when law enforcement tried to pick it up. The remaining goop would have to be identified via dental records.

Today when the news broke confirming the remains were those of Brian, established by dental records, the additional information was added that law enforcement had found parts of a human skull the day before. Check.

I saw a backpack near the remains that was nothing like the white wet bag seen on TV news last night (10/20/21). I saw an orangish red hikers pack with an aluminum metal frame in the mucky ground that only recently dried out enough to reveal Brian's remains. Today it turns out there was a backpack in addition to the white wet bag. Color has not been released yet, but I won't be surprised if it turns out to be the bag I saw via remote viewing.

I don't have anything on the notebook. I will have to wait for the FBI's painstaking forensics work to be released like everyone else.

With only a head, really a skull or parts of a skull it is going to be hard to determine Brain's cause of death. I was shown a small, round, orange, unmarked pill bottle with white capsules inside it. It was his last ditch resort when his attempt to run was planned out. If that bottle is in the wet bag or the backpack and enough residue of the sleeping pills it contained remain, that may shed some factual light on how he left this world. Since his parents had unsupervised access to the wet bag before law enforcement saw it, it is unknown what may or may not have been altered. I wouldn't be surprised if several things were altered.

I am convinced the Laundrie camping trip taken a few days after Brian arrived home in Gabby's van minus his fiancé was an extended planning session for his escape attempt. He was enough of a narcissist to think he could escape. He was mistaken but he was certainly going to try. He had help. Multiple burner phones that have not been reported on quite yet. His parents were in in contact with him until his final call when he told them he was going to take the last resort pills and where to find him. He had money, food, gear and contact support until he decided death was the only way out.

I believe his sister Cassie. She was cut out early as she has claimed first to hounding self-styled reporters who frankly do not deserve that title and later to more reputable outlets like GMA. Sure bits of her interrogation when she finally decided to talk to the self-appointed professional outrage activists were aired, but if you watch the entire encounter you will understand why it was edited the way it was for use by mainstream media. The way it was obtained was abhorrent. Both Cassie and her husband handled themselves extremely well. If you watch the entire interrogation she notes that she is eight years older than Brian and right after that stated they "were not friends." She knew how sick and twisted her brother was and didn't want to have a darn thing to do with him or his murder of Gabby. I think Cassie, her husband and her young children genuinely cared about Gabby. Cassie is an articulate and intelligent woman. She had all the same questions everyone else did. She knew more of the backstory than the general public but not the events that transpired around Gabby's death or Brian fleeing. I hope she will now be left alone to rebuild her life.

Turning to look at Gabby and her awful death, I knew she never made it to Yosemite. Her mother was right about that. I think she died on August 27th. I knew Brian had killed her via throttling. I think my visuals were at an earlier stage than the point at which she was found September 19, 2021. It was prior to animal activity and partial reduction to skeletal remains. Her intact body was sprawled out, open arms, tangled hair. She was wearing a red/scarlet sweatshirt and blue jeans. She looked like a child's doll, carelessly tossed aside. The dark marks on her neck were more pronounced in the soft tissue on the right side of her neck then the left although the bruising as quite marked around her throat. I know dead men don't bleed but until her heart stopped soft tissue damage and bleeding under the skin would have been happening and darkened later after rigor mortis released. I only interacted with her spirit briefly. She was seriously distraught as every murder victim I have ever talked to has

been. It was hard on her to wait by her body until it was found. I have run into that before, such as with Caylee Anthony years earlier. It is not uncommon for murder victims spirits to stay near their bodies until those bodies are found and properly taken care of. In a few cases I have encountered the spirits of First Nations murder victims that stayed near their unmarked graves for over a century until for one reason or another someone like me got called in to sort out the situation. Most murder victims desperately want their stories heard. I know I would in their situations.

Other than that brief interaction of distress I have not talked to Gabby in spirit since her body was found. Thankfully she had loving family, friends and massive public prayers for the repose of her soul. She did not need any help from me.

Situations like this I hate being right. It is the awful side of psychic abilities you don't see or hear a lot about on TV or in the movies. Or if you do, the sheer horror is glossed over. It is not easy. Most of the time I keep such knowledge to myself since I don't want to become a target. More power to the psychics who do such work. It is not for me. I will look into a murder or a suicide or otherwise murky death for clients, friends and family, but I don't work for law enforcement. Fortunately there are plenty of gifted psychics who do.
