Dear Mr. President:

The unauthorized use of your image in "Contact" has prompted me to write you. Since 1992, I have specialized in the law regarding virtual humans and particularly digital actors. Included in that field is the digital manipulation of pre-existing images in new formats such as the Diet Coke ads featuring Cagney, Bogart and Cary Grant and now the use of your image in "Contact." Before your views on the use of your image in "Contact" were made known publicly, I was interviewed by the Los Angeles Daily News (copy enclosed). I said that a public figure has a right of publicity which cannot be disregarded by invoking the First Amendment.

The unauthorized use of your image in a fictional film may offend the dignity of your office but at least it is not dangerous. There lurks in the future, however, the possibility of misuse of a president's image for deadly purpose. As you may know, there is ongoing research in U.S. laboratories and overseas that promises totally digital replicas of individuals. On July 28th, a segment of CNN Show Biz was devoted to your "role" in "Contact." In that segment I pointed out the danger that misuse of the technology will permit. I believe that in the near future the technology will have progressed to the point that a totally digital replica of the President will be practical. The possibilities for misuse of such a digital image are limitless. For example, a spurious digital President blaspheming a religion over the Internet could cause immediate havoc before the phony "President" is unmasked. I say this not as an amateur hooked on video games, but as a 64 year old submarine officer/engineer turned law professor of copyright/trademark and entertainment law, who specializes in virtual human technology and its legal implications.

I enclose an article I wrote in 1993 on the legal issues involved in digitally resurrecting dead celebrities: "Casting Call at Forest Lawn . . ." While the article focused on the right of publicity and moral rights of deceased celebrities, it also applies to situations involving living celebrities illustrated, for example, by the unauthorized use of your image in "Contact."

In "Casting Call", I suggested that the legal community examine the legal issues of virtual human technology while the problems are merely theoretical and not real as they will be in the not too distant future. Protecting our precious First Amendment rights is of extraordinary importance. The price, however, should not be the surrender of the right to ourselves.


