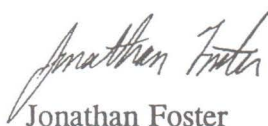

As per the attached letter to me by Barbara Ann Ferguson, please consider this letter as an appeal of your no records response.

The reason for this appeal follows:

- 1- Some time back under FOIA I was sent an extensive file of correspondence TO your agency regarding the UFO subject.
- 2- Since about 2 years there must be a voluminous file of correspondence TO your agency. I would appreciate a list of that material for us to decide which to order.
- 3- Since this office has clear and documented proof from the Department of Defense agencies that High Technology Spacecraft (NEV- non earth vehicles) have interfaced with our military - your department must be studying this technology to report to President Clinton. It would be a severe omission not to have you studying this phenomena.
- 4- Since this company is pro-government and pro-military in its media projects, produced in the public interest, we should be given materials to present/show, to show our government in a good light.
- 5- Since by information and belief, the Clinton administration wishes to start informing the American public on this subject, we offer a friendly medium through which to present this information.
- 6- Since a large part of the media is hostile to President Clinton (we are not) and on the UFO subject attacks our military, we offer a good resource through which to present information.
- 7- Since our docu-drama feature film "BEYOND THIS EARTH" is being finished now and is going to major buyers, so that at least 100 Million people will see it- we should be given serious consideration for assistance in this production.

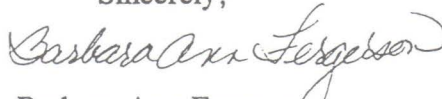
OSTP FOIA 97-08

Dear Mr. Sherman:

This is in response to your request, received in this office on March 20, 1997 under the Freedom of Information Act, 5 U.S.C. § 552. Your March 18, 1997 request to the Office of Science and Technology Policy (OSTP) sought records pertaining to any documents, visual materials and related information, etc. regarding sightings of anomalous aerial objects, unconventional aerial vehicles, unknown submerged objects and extraterrestrial intelligence on and above the planet.

Since your last request, FOIA 96-23 dated October 23, 1996, we were unable to locate any records responsive to your request. If you consider this to be a denial of your request, appeals may be made in writing within 30 days of receipt of this letter. Both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal." Determinations of administrative appeals are required within 20 working days.
