Here are a few articles reporting on the inquest in to the death of Carole Kasir – the former owner of Elm Guest House (<https://scepticpeg.wordpress.com/2016/01/29/elm-guest-house/>). Allegations against MPs and other VIPs were mentioned during the inquest.

There were rumours that her death wasn't accidental and Carole herself had claimed to have been followed by (what she suspected to be) MI5 in the lead up to her death. However, Dr John Burton concluded that the cause of her death was suicide. I will cover that in more detail here in due course, but in the meantime I have collated/published them for ease of reference.

**A RICHMOND children's home supplied young boys to a Barnes guest house for sexual and pornographic purposes, it was revealed at an inquest this week.**

The court heard how the guest house owner, Mrs. Carole Kasir—found dead at her flat in June—was caught up in a massive pornography ring involving Grafton Close Children's Home.

It was alleged the home, run by Richmond Council, supplied boys under the age of 14 to the gay guest house during the early 1980s said to be frequented often by top MPs and judges.

Miss Mary Moss from the National Association for Young People in Care (NAYPIC)—a London-based group which 47-year-old Mrs. Kasir turned to two years ago for help and advice—said the home's head, Mr. Neil Kier, and deputy head, Mr. John Stingemore, at that time, were part of the ring and that the latter had been convicted of child pornography in 1985 after he had left Grafton Close.

She claimed the mother of two was merely an innocent pawn in a ring which involved her lover, David Issett, and convicted child pornographer David Hamilton-Grant, currently facing extradition from

Turkey on further charges.

"She was a great laugh, a lovely lady but not really with it," Mrs. Moss said. "She was terribly naive and had no idea what was happening in her own back yard."

She claimed Mrs. Kasir's children were taken into care in 1980 to deflect her attention away from what was happening at her guest house and the children's home.

Mrs. Moss said her children were taken on order of the then director of social services at Richmond Council. He had claimed that Mrs. Kasir and her husband, Harron, were abusing their son and daughter.

The inquest heard how German-born Mrs. Kasir died at her home in June from an insulin overdose. A diabetic, her insulin container was on a cabinet next to the bed where her body was found.

Pathologist Dr. Richard Shepherd confirmed the cause of death as profound hypo glycemia—excessive insulin injections.

But friends from NAYPIC claimed in evidence that the case was not so cut and dried and that Mrs. Kasir had lived in fear of her life, since a raid on the hotel and a conviction for running a disorderly house in the early eighties.

Adult advisor for NAYPIC, Mr. Christopher Fay told the court that Mrs. Kasir had been continually threatened by a man known as Patsy Puddles and followed by two men who were often seen outside her house.

## Horrorified

Private investigator Mr. Clive Godden added that Betsy Puddles, David Issett and David Hamilton-Grant, were all part of the same ring and that Mrs. Kasir was "frightened out of her life."

Miss Moss, Mr. Fay and Mr. Godden all stressed that Mrs. Kasir had had no idea what she was involved in and she was horrified when she found out about the home supplying boys. "She has spent the last eight years trying to prove her innocence," said Mr. Fay.

All three asked the coroner to look into allegations saying her death could have been in suspicious circumstances. "There was certainly something or someone frightening her," said Mr. Godden.

Coroner Dr. John Burton adjourned the inquest until August 22 pending further investigations. He said that although Mrs. Kasir had left two notes to David Issett the night she died he would have to investigate the allegations made in court.

# MYSTERY DEATH OF CHILD SEX RING WOMAN

WHILE Wraybury child pornographer is awaiting extradition to Britain from a Turkish jail on fraud charges, a London Coroner has ordered further investigations into the death of a woman said to have been involved in his child

pornography ring.

Mrs. Carole Kasir was found dead at her Barnes guest house in June following an insulin overdose.

But following allegations that she was 'being frightened' and that the circumstances of her death were 'suspicious', Coroner Dr. John Burton adjourned the inquest for two weeks until August 22.

While accepting that Mrs. Kasir had left two notes to her lover David Issett the night that she died, he claimed that he would have to investigate the allegations made in court.

Issett, Mrs. Kasir and Hamilton Grant were all said to be part of a child pornography group involving the Grafton Close Childrens Home run by the local authority in Richmond.

It was alleged that the home supplied boys under the age of 14 to Mrs. Kasir's gay guest house for sexual and pornographic purposes during the early 1980's, said to be frequented by top MPs and judges.

However Miss Mary Moss from the London based National Association for Young People in Care (NAYPIC) said that the 47 year old mother of two had merely been 'an innocent pawn' in the ring, the breaking of which had led to convictions for child pornography for the Head and Deputy Head of the Home.

The inquest heard how German born Mrs. Kasir died at her home from an insulin overdose. A diabetic, her insulin container was on a cabinet next to her bed, where the body was found. Pathologist Dr. Richard Shepherd confirmed the cause of death as Profound Hypo Glycemia-excessive insulin injections.

But friends from the NAYPIC claimed in evidence that the case was not so cut and dried and that Mrs. Kasir had lived in fear of her life, since a raid on the hotel and a conviction for running a disorderly house in the early 80's.

An allegation emphasised by private investigator Mr. Clive Godden who supported suggestions that a man called Patsy Puddles, known to have been part of the ring, along with two others were often seen outside her house. He added that Mrs. Kasir had not known what she was involved in and was 'horri-fied' when she found out about the home supplying boys.



# CHILD SEX: TOP TORY NAMED

A FORMER Tory Cabinet minister has been sensationally named at an inquest into the death of a woman claimed to be the owner of a gay hotel involved in child pornography.

The woman, 47-year-old German-born Carole Kasir of Carmichael Court, Barnes, West London, was found dead from an insulin overdose. She had made her claims to members of the National Association of Young People in Care and a private detective.

## Gay hotel orgy scandal of boys in care

workers and a member of the Royal household were part of the child porn racket at the hotel, the Kingston-on-Thames inquest heard.

Kasir was convicted of running a disorderly house in June 1982.

Until her death eight years later, she claimed to have been tormented by police and secret agents because of what she knew and witnessed.

Christopher Fay of the NAYPC said: "She came to us in the realisation of the activities that had gone on without her knowledge.

#### Concerned

"She was very concerned that young boys from a children's home called Grafton Close in Richmond were being supplied for use by individuals who, it seemed, used her guest house for sex and pornography."

He said Mrs Kasir was receiving considerable harassment from the Metropolitan Police and security services.

"She told us she was being followed around and gave us various car registration numbers and related a number of incidents where she was clearly followed and harassed.

*"She named a lot of very well-known people as being involved."*

"There were a number of photographs. She was able to identify boys and which area they came from.

"Many were from Grafton Close."

He told the court that in 1985 the deputy principal of that home was convicted of child porn and sex offences against young boys in care.

### **Young**

Private investigator Clive Godden said she named a man who brought young girls and boys under 14 to the hotel.

*"She said who was in the hotel. They meant nothing to me — except they were MPs."*

Miss Mary Moss of NAYPC said Mrs Kasir told her she thought the raid was "gay-bashing."

She told the court Mrs Kasir had said boys from Grafton Close had been supplied for prominent people to use without her knowledge.

She added that two companies, which had links with a former Tory Cabinet minister, whom she named, were involved.

The Sport has not yet revealed the identity of the ex-Cabinet minister because yesterday he was not available to answer our inquiries.

The inquest, which was opened on Wednesday, was adjourned until August 22.

# HOUSE OF PORN

VICE squad detectives are to quiz a former social worker over a photograph of a former Tory Cabinet minister in a sauna with naked boys.

Christopher Fay, now adult advisor to the National Association of Young People in Care, says the picture was among several shown to him by a woman who ran a gay guest house from 1979 to 1982.

The other photographs were said to have featured a former top policeman, and Russian spy and Master of the Queen's Paintings Anthony Blunt, who died in 1983. Two are believed to

show sex acts taking place.

Mr Fay says the woman also claimed a bishop, a high court judge, social services director and top businessman were also among those who were captured on video at the hotel.

And she said young-

sters were brought in from a children's home to be used for sex.

Mr Fay claims the photographs were shown to him by German-born Carole Kasir, 47, of the Elm Guest House, Barnes, London, in March.

Three months later she died from a suspected insulin overdose. He said

"I don't know where the photographs are now.

"I begged her to hand them over to me, but she was afraid."

Mr Fay spoke out after an inquest into Mrs Kasir's death was last week adjourned to August 22 at Kingston Coroner's Court.

And he said: "I would like to see a top-level investigation into just what went on at the guest house - young children were being corrupted

A senior Scotland Yard detective said: "If what Mr Fay says is true then it must be investigated."

"He is making allegations involving people in high places which cannot be ignored."

# Inquest adjourned due to child sex ring allegations

17/8/1990

AN INQUEST into the death of a Barnes woman was adjourned after Kingston Coroners Court heard allegations of her involvement in a child sex abuse case.

Forty seven year-old Carole Kasir, of Grove Road, was found dead on Sunday June 17th. She was discovered lying motionless on a double bed by another occupant of the house where she was living.

Police constable Timothy O'Sullivan, giving evidence, said that syringes and an insulin container had been found near to her body, as well as a suicide note. Another note was found elsewhere in the house.

Coroner Dr John Burton read out a pathologist's report that gave the cause of death as profound hypoglycemia resulting from excessive insulin levels. He explained that Mrs Kasir had suffered from diabetes.

The court was told of suggestions that the deceased had been involved in a child abuse case eight

years ago but she had vehemently denied this.

Witnesses, including Christopher Fay, an Adult Advisor from the National Association of Young People in Care, stated that she had been subjected to a certain amount of persecution in the community because of it.

Private Investigator, Clive Godden, and Mary Moss, a member of the National Association of Young People in Care, said Mrs Kasir had always denied her knowledge of the incidents of child sex and was trying to clear her name.

The coroner was told by Mr Fay that the deceased had revealed she had received threatening telephone calls.

Mr Godden added that she had complained to him of being harassed by police and followed by members of MI5.

But her estranged husband, Haroon Kasir, said that suggestions of an international conspiracy were nothing but "hearsay".

And he stated that

despite the claims of the other witnesses, his wife had not given information to groups investigating child pornography.

The coroner ruled that evidence about large scale child sex rings was not relevant to the purposes of the inquest.

He said that although it suggested suspicious circumstances, talk of police corruption and international child sex rings did not help decide the verdict on Mrs Kasir's death.

Dr Burton concluded that the allegations of conspiracy made by those giving evidence meant that doubt was thrown on the accuracy of the suicide notes.

These, he added, might otherwise have been proof that Mrs Kasir intended to take her life.

The inquest was adjourned for two weeks for the coroner to contact some of the organizations mentioned, including special police investigation teams, Mrs Kasir's own GP, and so that a man she had previously lived with could be present in court.



# EXPOSE THESE EVIL CHILD SEX VIPs

## Call for vice hotel probe



FAY: 'She was hounded'

POLICE should probe claims that MPs and social workers were part of an evil child sex ring, a child charity worker demanded yesterday.

Fulham Coroner's court had heard that youngsters were taken from a children's home to an hotel for pornography and sex games to satisfy the kinky lust of a string of famous names.

But coroner John Burton said he could not comment further on claims made at an inquest into the death of

the hotel's 47-year-old boss Carole Kasir  
Dr Burton recorded a verdict that the German-born woman killed herself. At an earlier hearing social worker Miss Mary Moss alleged

Mrs Kasir had said kiddies in care had been supplied for prominent people without her knowledge.

Miss Moss claimed two companies which had links with a former Tory Cabinet Minister were involved.

Outside the court yesterday, Chris Fay, of the National Association of Young People in Care, challenged the finding and said Mrs Kasir would never have committed suicide.

Mr Fay, 43, declared: "She was too angry for that. She would not have killed herself."

"The reasons for her death are all tied up in this child pornography ring at the hotel."

### Agents

"She was hounded and harassed by police and security services. She knew all the top people who had been involved in the ring at the hotel."

"We need a full police investigation into this - the porn ring at the hotel and the taking of youngsters from the home in Richmond."

The inquest earlier heard that Mrs Kasir was convicted of running a disorderly house at Elm Guest House, Barnes in June, 1982.

The hotel was raided by MI5 but none of the celebrities was arrested, the inquest heard.

Eight years later her body was discovered after an insulin overdose - amid claims that she had been harassed by police and secret service agents because of what she knew.

The coroner was told that young boys from

Grafton Close Home in Richmond were taken to Mrs Kasir's hotel for the celebrities.

But yesterday Dr Burton said the allegations of a child pornography ring were outside the bounds of his inquiry.

He said: "My difficulty was that although I was obviously concerned about what was being told to me, the inquest was a limited inquiry."

### Fear

"Was she in fear? If so what was it? What people did she choose to be associated with? I can't say."

"She didn't say anything of this in the letters she left."

And he added: "There are underground organisations. There is subterfuge. But my difficulty is what part it played in her life. I can't say."

"I am satisfied she died as a consequence of a voluntary act and she conscious of what she was doing."

Outside the court, private investigator Clive Godden said: "They can't sweep these allegations aside. This goes very far."

# Suicide verdict

31/8/1990

AN INQUEST into the death of a 47 year old Barnes woman resumed at Fulham on Wednesday, with Coroner Dr John Burton recording a verdict that Carole Casir took her own life.

Mrs Casir, was found dead in the bedroom of her home in Carmichael Court, Grove Road, on Sunday, June 17th.

The original inquest had been adjourned from August 8th, after witnesses testified that she may not have taken her own life.

However, the court heard that two suicide notes had been found in her house, and that she had died from "a profound overdose of insulin."
