is a notation that he had been in New York for the past few months on theatre work. It has not been possible as yet to establish the exact whereabouts of LAWSON, but it is contemplated that this information will presently become available through the confidential contacts established in connection with this investigation.

It is desired to set forth briefly an indication of BIBERMAN's known status in the Communist front movement. The Los Angeles files herein cited disclose that he assumed the local leadership of the former American Peace Crusade in June of 1940; and wrote a long article in the "New Masses" on August 20, 1940, which reflects the alleged motives of that organisation. His close associates in this movement, which has been definitely shown to be a Communist sponsored organization, are:

BIBERMAN has appeared publicly on many occasions, speaking on behalf of the American Peace Mobilisation, which succeeded the American Peace Crusade, and Confidential National Defense Informant L. A. #3, whose identity is known to the Bureau, describes him as follows:

"He is one of the most menacing figures in the local revolutionary ranks today by reason of his smooth manner, his unquestionable brilliance of mind, his quick thinking, his pleasant personality, and a quality which seems to make him equal to any exigency. He possesses a pleasing speaking voice, and is billed at all of these affairs as a motion picture director."

JOHN HOWARD LAWSON has been present in Los Angeles at numerous meetings at which BIBERMAN spoke, and it is evident that they were closely associated.

The present offices of the American Peace Crusade are located at 426 South Spring Street, telephone MIchigan 2092, and a source usually found extremely reliable has been established to obtain information of value from his office.

It has been established that THOMAS P. CULLEN, above mentioned, is most frequently in charge of the office; and that BIBERMAN visits this point rarely. A Hollywood office of the American Peace Mobilization is located at 1558 North Vine Street, and by observation, it has been determined that this is a one-room office on the second floor of the Otto K. Olson Building, at the corner of Selma and Vine Streets.
