- B. IN HIS TESTIMONY IN ENGLAND MR. ITKIN CLAIMED TO HAVE BEEN RECRUITED BY CIA IN AN "UNDDERCOVER CAPACITY" IN ABOUT 1954. HE CLAIMED HE WAS WITH THE C.I.A. UNTIL MARCH 1963 AT WHICH TIME BY SOME ARRANGEMENT HE WORKED FOR BOTH THE FBI AND CIA, UNTIL MARCH 1965.
- C. MOFFITT AZKZ FOR INFORMATION ON THE STATUS OF MR. ITKIN DURING THE YEARS 1964 TO 1969 AND FOR COPIES OF "AMY RELEVANT AFFI-DAVITS OF PERSONS IN AUTHORITY IN THE FBI OR CIA USED IN PROCEEDINGS."
- D. MOFFITT NOTED THAT IN THE INTERESTS OF PRIVACY HE ROUT-ED HIS LETTER VIA THE AUSTRALIAN-DIPLOMATIC POUCH, AND ASKED THAT THE REPLY BE RETURNED TO HIM BY THE AUSTRALIAN EMBASSY IN WASHINGTON.
- 2. MR. MOFFITT'S REQUEST WAS HANDLEDD BY THE OFFICE OF GENERAL COUNCIL {OGC} WHO MADE AVAILABLE FOR MR.
