1. We are most appreciative of the effort represented by OIRA 27542, and it appears from the contents that our purpose in having MAGONETTI contact the Subject of the dispatch has been accomplished. If any further action is desired, we shall inform you. Please convey our thanks to CLARKSON and MAGONETTI for a job well done.

2. Re the Station comment at the end of the dispatch: The question concerning the extent of tracing of potential agents for this KUTUBE/D purpose has been fully discussed at Headquarters, and the following policy has been established: Candidates will be traced in selected U. S. files; tracing in foreign files will be permitted only when the foreign indices concerned can be traced personally by a KUBARK staffer who will be in a position to certify that the foreign service or police does not know who was traced. Tracing by a penetration agent is not unilateral enough to fit this maximum sensitivity effort since there is no acceptable guarantee that a record of the tracing is not left in foreign files. Theoretically, tracing Subject of OIRA 27542 in Italian files would be desirable; practically, we cannot take the slightest chance of exposing our interest in Subject to a foreign service and will therefore have to forego the additional tracing. For your information, our tracing at Headquarters consists of the following minimum: RL, RI archives, Greenlist, KUSODA files, Italian Branch files (and other branches as appropriate).

3. Please handle any future traffic pursuant to OIRA-27542 in accordance with paragraph 5, OIRW 18582. The use of the RYBAT slug alone ain't what it used to be.
