THE LEE WHYEY OUTALD CARE -351164

- 1. According to a newspaper column of "Allen and Scott" in the Chicago American of 6 December 1963, on the O MALD Case, Abram (MAYE). Legal Officer of the State Separtment, was one of two persons inmultistely responsible for Obald's being permitted to return to the Maited States from the Scriet Union in June 1562. The other individual numed was Liewellyn THOMFROE, the then Albasander to Buncia. Another said to have been involved in the handling of OMMAID's case was Canada MICE, Counsel of the American Embacoy in Moscow.
- 2. Abras CHATES, 352234, who as of 16 Pebruary 1961 was described as "the new Commsel in State", was granted scurity approval for linison contact with J. Poster COLLEGY (in the office of the Chief of the Covert Action Staff) on 6 Earch 1961. The request for CHATES' clearance was a "Blanket' request to permit discussion with him of MSC 5412/2 ratters on a need-to-know tasis.
- 3. In September 1361 there was a White House namecheck request on CHAYES' wife Antonia (Toni) Leigh CHAYES, nee: HAMBLER.
- 4. In March 1962, CRAYES was greated a renewal of his lisicon contact clearence with C/CA on a continuing basis. This time his contact was Archibald MORNELL, Jr.
- 5. On 10 February 1962, NHAN EVENTS reported as follows with reference to CHAYES:

"30FT ON CONSTINE: Representative Francis E. Walter (R.-Pa.), Chairran of the House Committee on Un-American Activities, has scored the new State Department regulations on passports, claiming they would allow Reds denied passports to "rifle freely the confidential files of the PRI, the CIA and other investigative agencies." The man behind the new regulations, which falter claims violate the Internal Security Act of 1950, is reportedly State's chief legal officer, Abram Chayes, Chayes, a Kennedy appointee, is an ex-Harvard professor who was Charter howles top legal advicer when Bowles was Governor of Oxmecticut. Walter has introduced legislation to remedy the new passport regulations."

- 6. Parcel WISE, "Councel in the American Pabassy in Moscow" who is referred to above, any well be Samuel Grickin WISE Jr., 77-574, ED & Th, who apparently was once a contract employee on ACR TUVE.

 The State Repartment reviewed WISE's file on 2 June 1954; and as of toptember 1962 a Samuel G. WISE was Record Secretary of the American Thinsay in Moscow. At that time WISE advised in a cable to the State Department that it appeared that bruce Frederick DAVIG, 352957, who describe from the United States Army in Germany on 18 August 1960, had not expatriated himself. DAVIS' case is very similar to that of OTAID; and be; like OSWALD, lived in the Soviet Union for two years after his described and prior to making application for return to the United States.
- 7. FINE was an applicant for CIA employment in early 1993 and was security approved subject to polygraph on 11 August 1995. He did not enter on duty and in September 1995 the office which had been interested in him was 'no longer interested". On 13 November 1993, WINE was granted a CMA to permit his use as a contract employee on AMACTIVE in New York City. His CMA was cancelled on 25 March 1993.
- 8. WISE was named as a friend of William Crville MUNIAL, %61693-DL. during an investigation of the latter for possible (TA employment in 1952. WISE, according to MEMPIL's lendledy and social acquaintance in Dashington, D.C. during the period of about a year which ended in April 1992, was the only person she knew by mane with whom MAMPILL was friendly. According to the informant, WISE was a student at Columbia University whose address was \$23 Furnald Hall. MAMPILL was recurity disapproved for TA employment in June 1962 because of his choice association on a professional and social basis, while attending Denver University from 1996 to 1991, with persons of questionable loyality. In Hovember 1994, PURMILL was of interest to project FUALIVE with reference to assignment to because of the derogatory information regarding him.
- 9. WISE from 1951 to 195% attended Scaradale Righ School in Scaradale, New York, which was attacked by a Citizense Group, which alleged Communict influence in the school system. He had several questionable associates in addition to MERCEL.
