Subject: ANTI-FESTIVAL ACTIVITY BY TWO CUEAN REFUGEES

Date: 10 August 1962.

At 1800 hours on Eunday, 29 July 1962, a procession composed of various nationalities attending the World Youth and Student VGII Peace and Friendship Festival was enroute to the Clympic Stadium along Eannerheimintie. As it passed the annerheimintie-Pohjois-Rautatiekatu intersection, students Enrique Antonio Felix Beloyra and John Koch, Cuban refugees living in the USA, were standing on the top of a Wolkswagen. They shouted something at the procession and opened up a white banner (about 7½ by 4½ feet) on which the following text was written in Spanish, French and English:

D.R.E.

LIBERTAD 15,000 jovenes presos CUBA LIBEREZ 15,000 jeunes Prisonniers CUBA Free the 15,000 youth in jail in CUBA

Escause it was suspected that the conduct of Esloyra and Koch might lead to an incident involving them and the Festival procession; they were taken by police to the Helsink! Criminal Police Department where their banner was confiscated.

Inspector of the Criminal Police Department, made a preliminary interrogation at which Esloyra and Koch said they they had come to Finland on 26 Jul 62 (sic) with the intention of making contact with the Cuban youth at the Festival and to ask them about current conditions in Cuba. With this in mind, they painted the above text on a white sheet with black paint at their (sic) quarters in the Klaus Kurki Hotel, meaning it to be seen by the Cutan Festigal participants when displayed.

Student Enrique Antonio Felix Selogra, citizen of Cube and now a refugee in the USA, declared In Havanna, Cute, and that he now lives permanently at 1528 South West 5th Street, money Florida. He did not wish to disclose where he had lived in Cuba, for his parents are still there. He is a university student, and in Cuba was studying to be an electrical engineer. His father was arrested in 1960 for political reasons but had told his son before arrest to get a passport and get out of the country at the first opportunity. Enrique Belogra applied for and received a passport through the Minister of Internal Alfairs. He now has a Cuban passport, number 24192/1.6.1950. He had made contact with the English Embassy in Havanna and had made the acquaintance of an official in it. When he left Eavanna on 10 Sep 62 on a Pan-Azerican Airways plane, the first stamp was put into his passport on page six. The English Erbassy official whom Leloyra knew was also on the plane to help Feloyra if any difficulty arose in departure. The reason Beloyra did not leave earlier was that an invasion was expected at any moment. At exkiami he turned himself over to the American authorities and applied for a residence permit. There is a residence permit stamped on page seven of his passport and it is dated 9 Oct 61. Pelogra could not continue his studies in the USA due to financial difficulties. He took a job as a kind of guide or functionary in the service of the Cuban refusee organization there. His function was to receive and

distribute aid shipments at a school where there were many shake children of Cuban refugees. In the USA he belonged to a club of Cutan refuree students. About two weeks before his arrival in Finland he was in this club. They had heard that the Communist countries were preparing the Festival in Finland and they tegan to discuss That anti-Castro enlightenment activity ought to be undertaken among the various Festival youth delegations, particularly the Cutan one, by making It known to then how many Cutan youth and students are in Cuban prisons. They were sure than the people of Cuba were not aware of these things. There were financial difficulties in getting started, but after it was arranged for Beloyra to pay 50% now and 50% later in installments (customary there) the matter was settled. Eeloyra had had (600.00 in the tank and he used this as the down payment, the total cost being about £1200.00. His last paycheck gave him £400.00 for spending, and he now has {-242.00 left.

For his enlightenment work, Feloyra managerought some booklets with him from an organization named <u>Directorio Revolucinario Estudiantil</u> (D.R.E.) (Cuban Students' Revolutionary Leadership). They were printed in Chile in English, French, and Epanish, and tell about conditions in Cuba and the students' fight against dictatorship beginning in the MERAPTISTA (sic) era. Earlier they were distributed in the countries of North and South America. According to Tegloyra, the books he had here were in English and French, and were distributed primarily to West Eurosean newsmen, although his original intent had been to distribute them to all non-Communist Festival perticipants. If Feloyra maremembers correctly, he still has one care of this publication in his hotel room.

On page nine of Feloyra's passport is a Finnish visa, number 55/C2, which his student organization got for him in the office of the Consul General of Finland in New York on the same day the visa was stamped, 20 Jul C2. It was granted from 24 Jul to 7 Aug 62.

and arrived first at Katerup, Denzark, as stamped on page eight of his passport. From Denmark he flew to Arlanda, Sweden, on 25 Jul 62, also stamped on page eight of his passport. He cam'ty air to Finland on 27 Jul 62 (sie) and took a foom at the Hotel Kamp where he still stays.

Feloyra met John Koch, a Cutan student whom he knew and who was on a similar trip, in Stockholm and they came to Finland together. Koch first got a room at the Klaus Kurki Hotel but on 31 Jul 62 he had to move to the Hotel Perho (a summer hotel in the Restaurant Fersonnel School) becauses of a room shortage.

Their original intenst was to visit the Cuban Festival delegation's quarters and inccribe the walls with the letters D.R.E. But after they learned that the Finnish youth had anti-Festival opinions, they decided to bring out openly their anti-Castro position to the Cuban delegation. With this in mind, Beloyra and Koch bought some black paint from a Helsinki paint shop on Saturday and main the afternoon of Sunday, 29 Jul 62, they took a sheet from Koch's bed at the Klaus Kurki Hotel and they painted on it the Spanish, French, and English text appearing in the opening part of this report. Koch had borrowed Ra Wolkswagen, and they drove at 1800 hours that same evening to see the procession as it moved

intersection and waited for the Cuban delegation. As it began to pass them, they me raised the banner they had made at the Klaus Kurki for the Cubans in the procession to see. A policeren came to the scene, however, and urged them to get down from the top of the car where they had been displaying their banner, and he took them to the police station where their passports were inspected and their banner taken away. A short interrogation was made as to their conduct.

delegation's quarters and took some pictures; several times they whom addressed Cuban delegates/they met in town. In the afternoon of 1 Aug 62, they left Koch's quarters for a drive in the same Wolkswagen, and at 1930 hours were driving along Aleksanderinkatu towards Unioninkatu. At the intersection of these two streets, they had a collision with a police car coming from the left and the car they were driving sustained some body damage.

Following the accident Feloyra tend Koch were held at the to Criminal Folice Department for reasons unknown them.

Fe/oyra had in his possession (without a Weapon-bearing Fermit) a Spanish-made 32-caliber Star pistol, number 612843. He said that he had gotten it, as had the other Cuban refugees, from the Cuban refugee organizations in the USA. Fecause such a pernit in the USA is not required to be on one's person, Eelogra did not have one with him in Finland, although he does have it at home (sic).

Beloyra declared that is is leaving Finland today for home in the USA via Eveden by plane.

Cuba, declared that the was born on 29 Tay 1940 in Havanna as the legal child of United States subject Herzan Koch verking there, and his Cuban wife. How John Koch lives at 1027 South West 12th Avenue, "lami, Florida. He had lived in Havanna (where he was cludying to be an electrical engineer) from the time of his tirth until 15 Jun (0, Tahen he and his parents were forced to leave Cube and go to the USA for political reasons.

In the USA Koch belonged to the same Cuten student organiration that Enrique Beloyra did. They had studied at the same inversity in Cuba. After going to America, Koch had not chance to continue his studies. He got a job as a salesman for a steel company.

Each and dependent participated in the Cuban student organizazation's activity with the same intent Belogra had. Each began to make preparations for the trip to Finland for the Communist countries' Festival. He had saved about \$500.00 and had gotten about \$700.00 from his parents and friends meand thus was able to purchase the necessary tickets. This money sufficeed, and Koch still has \$150.00 in his possession.

Koch left Hew York on 25 Jul 62, coming to Finland via

Kastrup and Stockholm by air on 27 Jul 62 (sic). He had met his

friend Feloyra in Stockholm and here with him. Koch took a

room at the Klaus Eurki Hotel and from there, due to a room chartege,
had to move on 31 Jul 62 to the Hotel Ferho. Each told the same

story that Feloyra did concerning the rest of the matter.
