Regarding the Korean Air Line Flight 007 which was shot down over the Soviet Union in 1983, we would need to know more specifically what kind of records you are looking for. For example, the Air Traffic Inquiry package would cost about \$9.50. Latitude/longitude computer extractions from the King Salmon and Kenai radars would be about 4.00. Voice tapes of air traffic control communications would be \$25.00 per hour or portion of an hour for each communications channel in Anchorage Center, Anchorage Tower, and Anchorage Flight Service Station.
