(15:17:48) **Detente@jabber.ccc.de:** Danny Clark does not seem worried about the psychoactives; he does not seem to think that Bradley is being forced to take them against his will. But Danny Clark did say that Bradley seemed unusually calm.

Manning's attorney, who seems to have an eye for Public Relations, thinks that this may come back to hurt Bradley. Bradley agreed on this topic to Danny.
