Synopsis:

On October 1, 2017, at approximately 2208 hours, the Las Vegas Metropolitan Police Department (LVMPD) received a call reporting gunfire at the Route 91 Harvest Festival located at 3901 S. Las Vegas Boulevard, Las Vegas, Nevada 89119. Uniformed LVMPD Officers working the event confirmed several people had been shot and requested assistance.

Notification of Homicide Detectives

Homicide Detectives were notified of the incident and responded to South Central Area Command for a briefing. Homicide Detectives Grimmert, Ochsenhirt, Boucher, Sanborn and Mauch were assigned the responsibility of documenting the Route 91 Harvest Festival scene and the deceased within the venue and exterior perimeter. Homicide Detectives Dosch, Bogotay, Merrick, Cody and Jaeger were given the responsibility of assisting Patrol Detectives with the interviews of witnesses and patron who fled the scene and were gathered at the UNLV Thomas and Mack Event Center. As the scene investigation progressed, additional Homicide Detectives arrived and assisted with the recovery of the deceased.

Description of Scene and Visible Evidence

The crime scene was located at the Route 91 Harvest Festival. The outdoor festival was held at the MGM Las Vegas Village, located at 3901 Las Vegas Boulevard South, Las Vegas, Nevada 89119. The Las Vegas Village was oriented on the east side of Las Vegas Boulevard South, bordered by East Reno Avenue to the north, East Mandalay Bay Road to the south and Giles Street to the east.

The Route 91 Harvest Festival was an open air music event. The festival was dimly lit with street lights, variable stage lighting and lights from temporary light stands on the perimeter. There was a chain link fence, with dark netting surrounding the entire venue. On the west perimeter of the venue there was a decorative concrete block wall between Las Vegas Boulevard South and the chain link fencing. This wall ran nearly the entire length of the west side of the venue, from East Mandalay Bay Road to East Reno Avenue.

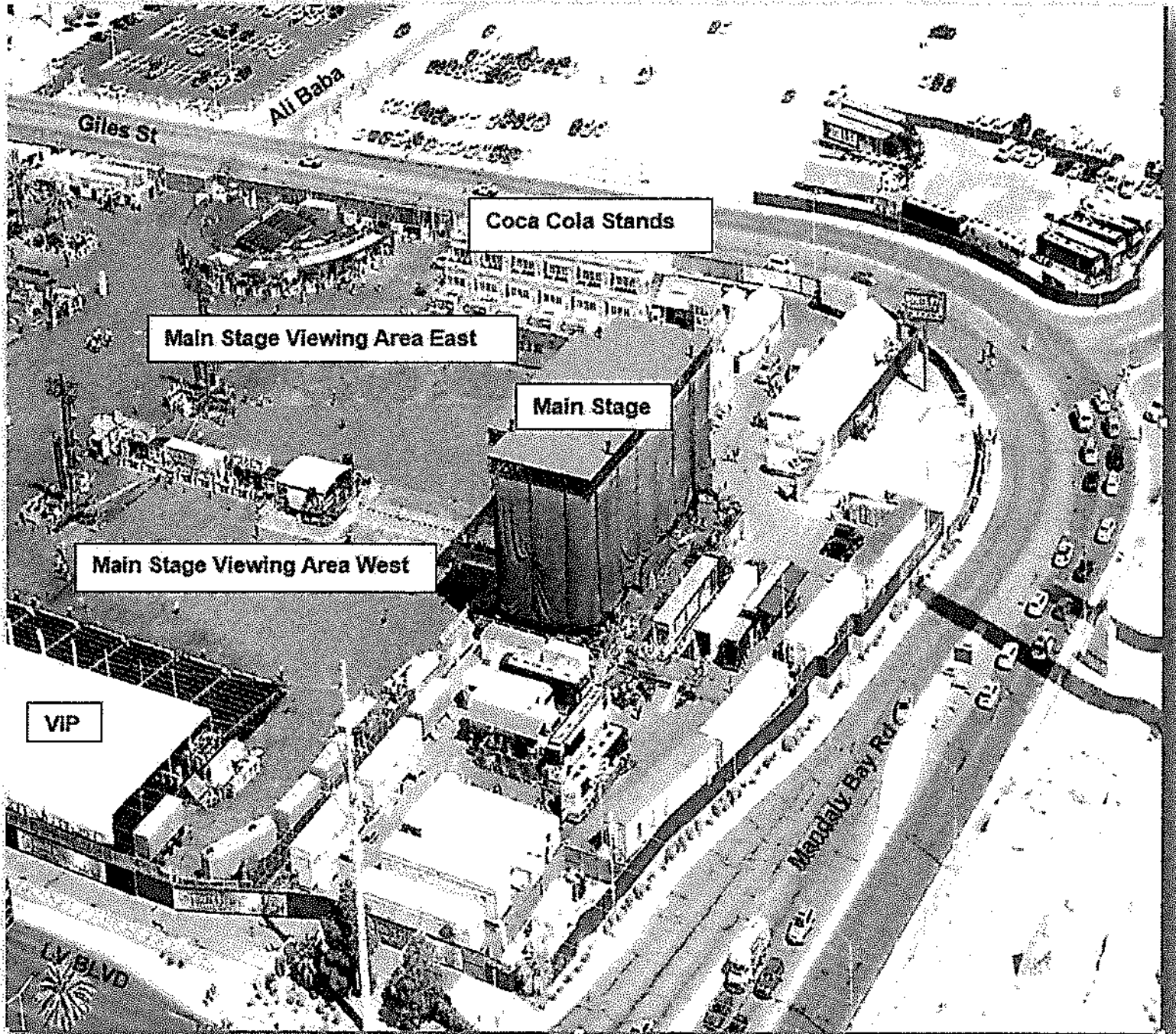
The surface of the venue consisted of black asphalt, with defined seating areas covered with artificial grass on both the northwest and south ends of the venue and vendors throughout. The northwest artificial grass area was used for lawn chair seating. The large artificial grass areas on the southern end was surrounded by seating, food vendors and portable bathrooms. A large seating area with elevated bleachers and a covered VIP area was oriented near the southwest corner of the venue. Four (4) pedestrian gates ran along the west side of the venue.

The Coca-Cola suites, additional seating areas, vendors, the medical tent and three (3) pedestrian gates were located on the east side of the venue. The event's Command Post (CP), a television broadcast tent and one (1) pedestrian gate were oriented on the north end of the venue.

The main stage was oriented on the south side of the venue. The main stage was covered by green roofing and the sides were covered with black mesh. The main stage viewing area was located in the southern portion of the venue, north of the main stage and was divided into two (2) seating areas by metal pedestrian fencing. The fencing ran from a production tent, located in the center of the viewing area, and eventually encompassed the main stage. In addition to the fencing separating the east and west side grass areas, the production tent and vendors, helped to define the two (2) areas. Production vehicles, concert buses, and trailers were oriented south of the main stage.

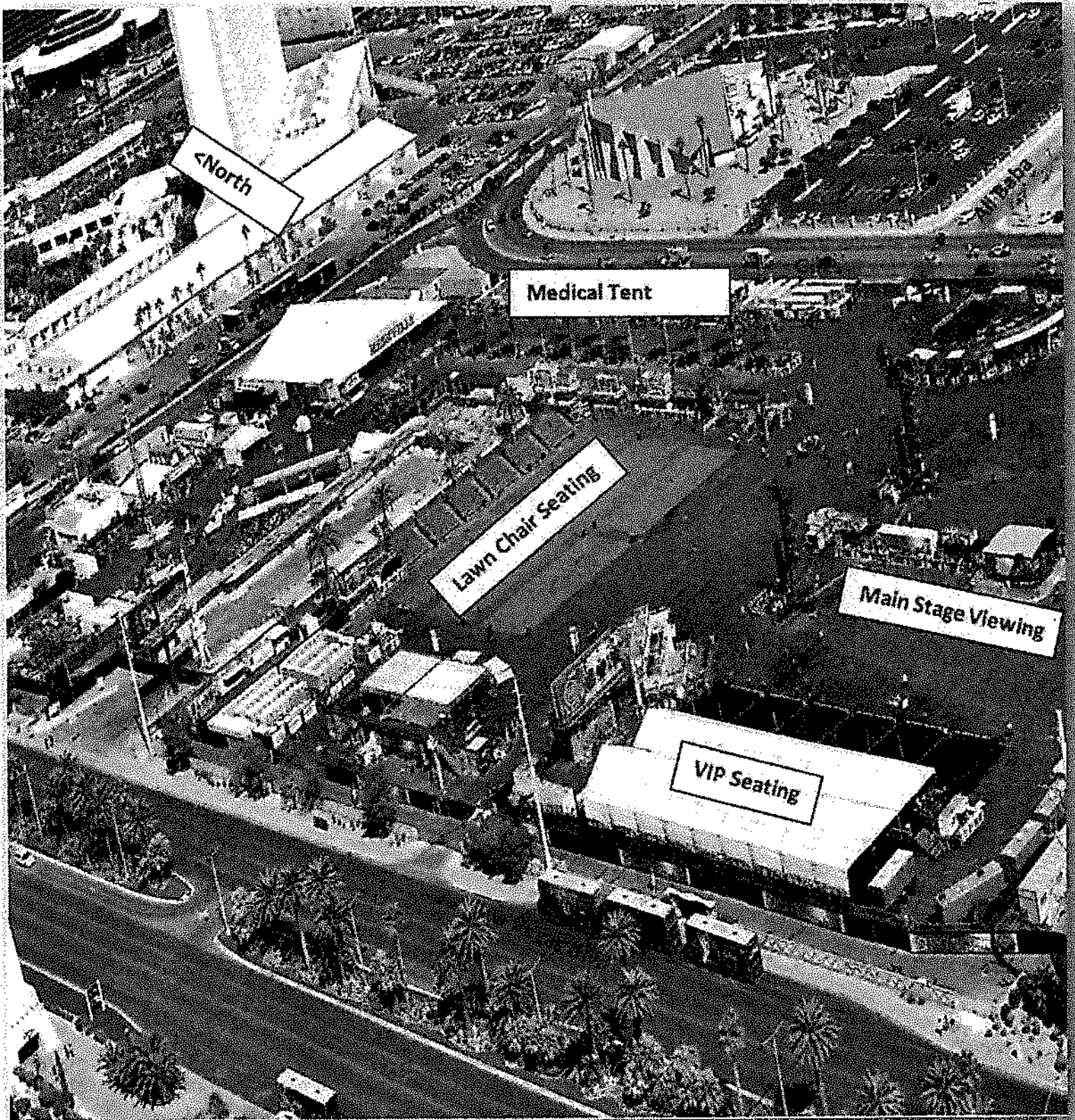

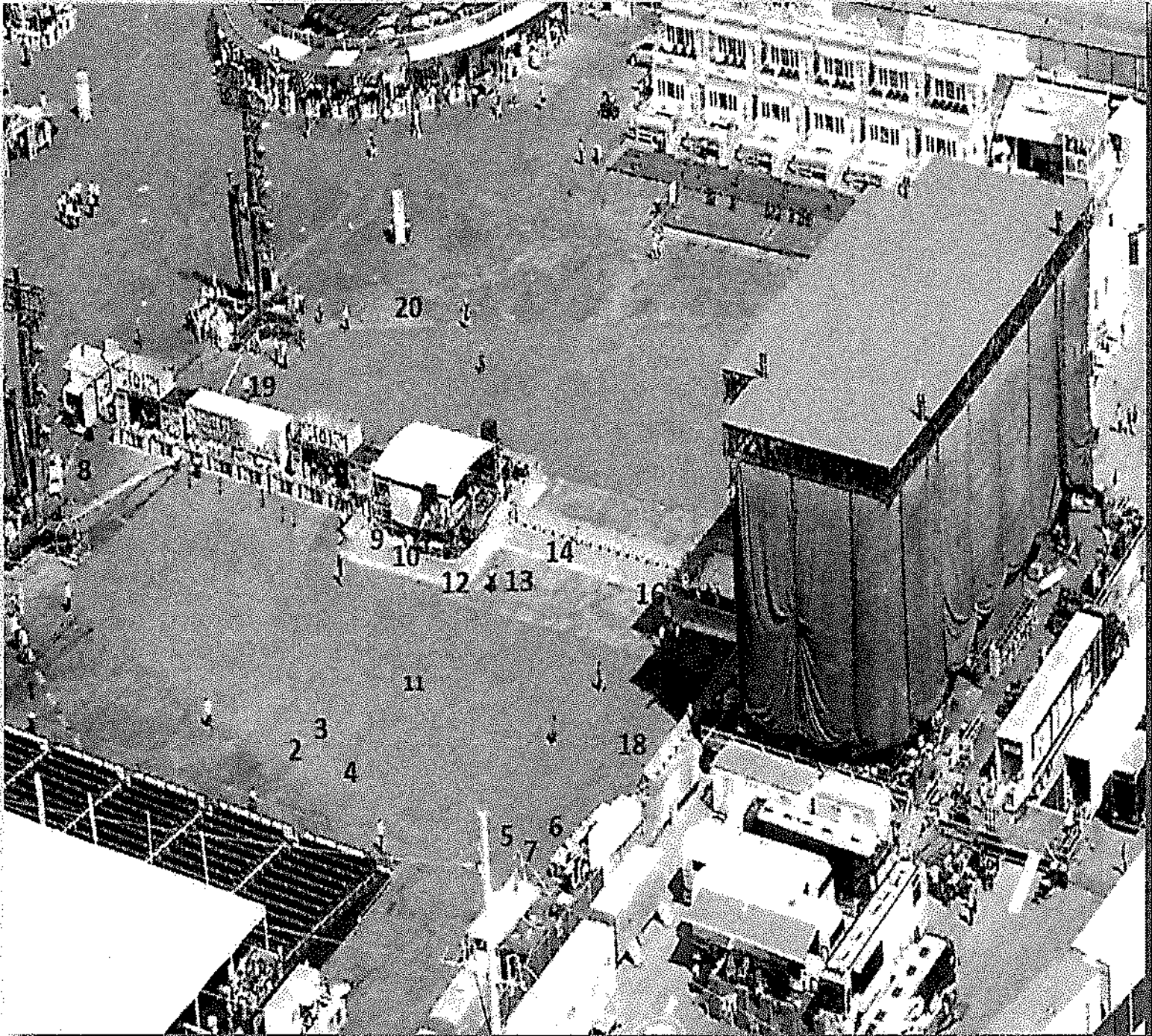

Location and Description of the Bodies

Note: the synopsis/description were created by the Homicide Detectives who assisted the Clark County Coroner Investigators with the recovery decedents from the Route 91 venue.

A total of thirty one (31) bodies were located, documented, and eventually recovered from the inside of the venue and on the exterior perimeter. Clark County Coroner Investigators Tiffany Brown, Priscilla Chavez, Scott Lautzenheiser, Tricia McCafferty, Amie Modglin, and Michelle Otero responded and assisted LVMPD Homicide Detectives and Crime Scene Analyst conduct the preliminary death investigations. Each victim was given an individual Clark County Coroner's Case and Seal Number. The time of death was determined to be 0545 hours for those recovered from the venue and exterior perimeter. Davis Funeral Home responded and transported the deceased to the Clark County Coroner's Office for a complete examination.

Twenty (20) bodies were on the artificial grass areas north of the main stage.

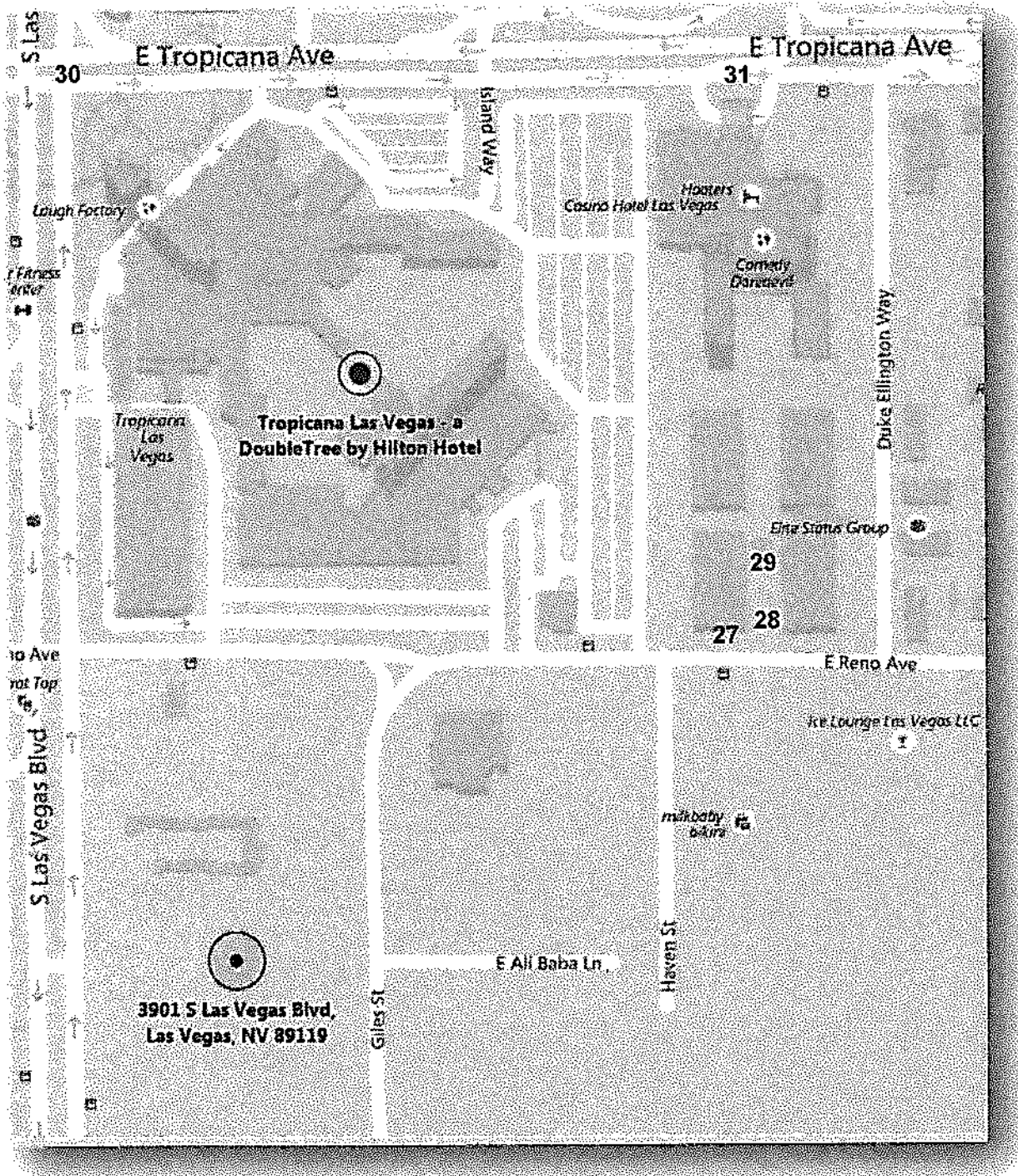

Detective Carpenter received an event briefing from Sergeant Jonathan Riddle, and was assigned to assist with auto and pedestrian traffic near the intersection of Mandalay Bay Road and Las Vegas Boulevard.

At approximately 2206 hours, Detective Carpenter heard several gunshots being fired from an unknown direction. Detective Carpenter initially retreated to his vehicle and retrieved his patrol rifle and attempted to assist pedestrians stay clear of the area. Together, they took the elevator to the 31st floor and took the stairs up to the 32nd floor where they were met by additional Mandalay Bay Engineers and Security Officers.

Officer Smith removed his reflective traffic vest and assisted with the evacuation of several guests' rooms. Together, the LVMPD Officers tactically moved toward the suspect's room when they realized the shooting had stopped. They held their positions and Officer Smith retreated back toward the elevator bay for rear containment. Moments later Officer Smith was joined by LVMPD SWAT Officer Levi Hancock. As Sergeant Riddle and his strike team entered the Mandalay Bay through the House of Blues, the shooters location on the 32nd floor was broadcasted over the radio. Sergeant Riddle and his strike team began to evacuate patrons from the casino floor with the assistance of an off duty federal agent and other uniformed and plain clothed LVMPD Officers. Sergeant Riddle and others provided their reflective LVMPD Traffic Vests to the plain clothed officers so that they could be immediately identified as officers.

Sergeant Riddle noted there were no equipment failures. Sergeant Riddle felt the training provided by LVMPD did not adequately prepare him to address a shooter in an elevated position. Sergeant Riddle felt the reflective traffic vest officers were required to wear, made them an easy target for the shooter. Sergeant Riddle suggested the department consider the deployment of a sniper to large outdoor events.

On October 23, 2017, Detective Sanborn interviewed Sergeant Harrison Porter regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview LVPMSA Attorney Thaddeus Yurek. During the interview, Sergeant Porter relayed the following information:

On October 1, 2017, Patrol Sergeant Porter was assigned to work a 1300-0100 hour overtime shift at the Route 91 Harvest Festival. Sergeant Porter was assigned to the east traffic detail and spent the majority of the shift outside the venue. Sergeant Porter stopped by gate 4 on the north side of venue and heard several pops, which sounded like possible gunshots. The pops were followed by automatic gunfire, which sounded like it was coming from the main stage area. Sergeant Porter entered the venue through gate 4 and

The two posted up at gate 2 and directed citizens to exit on the east side of the venue by the medical tent. Sergeant Porter heard a radio broadcast, which indicated the shooter was above them in Mandalay Bay, but he never saw the shooter. Sergeant Porter observed several subjects who had sustained gunshot wounds. He provided his tourniquet to another officer to help the injured. Sergeant Porter stayed and cleared the venue, until a possible active shooter call came out at the Paris Hotel, which he responded to as part of a strike team.

Sergeant Porter did not feel adequately trained or prepared to defend himself or citizens from a subject shooting from an elevated position at great distance. Sergeant Porter thought maybe training and arming special patrol officers with sniper rifles to engage a long distance threat would help. Sergeant Porter also believed more patrol shields would have helped to keep officers and citizens safe during evacuations efforts.

After the shooting ended, Officer Frederick remained on the scene and coordinated the removal of the dead and injured to a casualty collection point by the medical tent. Officer Frederick also coordinated the evacuation of the performers from backstage.

Officer Frederick thought having more medical supplies available on the officers' persons may have helped the situation.

Officer Jeffrey Bengel PN6710

Detective Sanborn conducted an audio recorded interview with LVMPD Officer Jeffrey Bengel regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Myron Hamm, PN6675. During the interview, Officer Bengel relayed the following information:

Officer Bengel was assigned to the Traffic Bureau. On October 1, 2017, Officer Bengel was assigned to work a 1500-2200 hour overtime shift as traffic enforcement at the Route 91 Harvest Festival. Officer Bengel completed his shift and responded to the traffic bureau to return him and his partner's body worn cameras. He arrived at traffic and heard radio traffic from the event regarding shooting and multiple victims. Officer Bengel could hear gunfire in the background of the radio broadcast. Officer Bengel responded to Russell Road and Las Vegas Boulevard, where he deployed his patrol rifle. Officer Bengel attempted to stop traffic, and observed a white pickup truck with several bodies in the bed. He allowed the truck to continue southbound. Officer Bengel was contacted by a Sergeant, possibly Price, who formed a strike team. Officer Bengel ran to the Mandalay

Bay and entered via the Shark Reef area with several other officers. Officer Bengel's strike team encountered another strike team at the Mandalay Bay main elevators. Officer Bengel was assigned to secure the elevators with Officer Barker. Officer Bengel remained at the bottom of the elevators until approximately 0300 hours.

Officer Philip Zaragoza PN13738

Detective Sanborn conducted an audio recorded interview with LVMPD Officer Phillip Zaragoza regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Myron Hamm, PN6675. During the interview, Officer Zaragoza relayed the following information:

Officer Zaragoza was a patrol officer assigned to the Northwest Area Command. On October 1, 2017, Officer Zaragoza was assigned to work a 1300-0000 hour overtime shift at the Route 91 Harvest Festival. Officer Zaragoza was assigned to the Northeast area of the interior of the venue, by the medical tent. Officer Zaragoza was in the medical tent in the middle of an arrest when his partner said something reference a shooting. Officer Zaragoza listened and then heard rapid gunfire and started to see numerous people running out of the venue. Officer Zaragoza released his arrestee as numerous people started to arrive at the medical tent suffering from various gunshot wounds. Officer Zaragoza had left his tourniquet inside his patrol vehicle, which was parked in the church parking lot, so he started to cut up medical sheets into strips to be used as tourniquets. Officer Zaragoza looked out of the medical tent and believed he saw muzzle flashes coming from the Mandalay Bay, which he related to dispatch over the radio. Officer Zaragoza felt pinned down in the medical tent and unprotected. He ran out to his patrol vehicle and put on additional equipment and deployed his rifle. Officer Zaragoza returned to the venue and joined up with several officers and started to methodically clear the venue over an extended period of time, until eventually released.

Officer Zaragoza did not feel adequately trained for such an event. He felt more training in open field movements and clearing techniques for unique environments would be beneficial. Officer Zaragoza was not comfortable with how far his equipment was from his position, and felt it would be beneficial to be able to have your rifle and tactical gear deployed prior to any incidents, rather than have to go get it, which took up valuable time and exposed him to additional danger.

Officer Ryan Rotta **PN13422**

Detective Sanborn conducted an audio recorded interview with LVMPD Officer Ryan Rotta regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Michael Ramirez, PN9057. During the interview, Officer Rotta relayed the following information:

On October 1, 2017, Officer Rotta was assigned to work a 1700-0000 hour overtime shift at the Route 91 Harvest Festival. Officer Rotta was at an interior position when he heard the first pops, which he thought were fireworks. He heard additional pops, which he still thought were fireworks. Officer Rotta realized it was gunfire due to the crowd's reaction. He thought the shots were coming from the southwest, outside of the venue, maybe on Las Vegas Boulevard. Officer Rotta was told by his partner the shooting was coming from Mandalay Bay. Officer Rotta had his pistol out and scanned the crowd for possible suspects. A wounded woman approached and he evacuated her to the medical tent. Once outside, Officer Rotta put on additional tactical gear and deployed his rifle. Officer Rotta acted as a cover officer at several different positions. He provided his handcuffs to a civilian at the medical tent to be used as a tourniquet. Officer Rotta assisted with evacuation efforts until relieved.

Detective Warren Gray **PN5118**

Detective Sanborn conducted an audio recorded interview with LVMPD Officer Warren Gray regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Myron Hamm, PN6675. During the interview, Officer Gray relayed the following information:

On October 1, 2017, Detective Gray was assigned to work a 1300-0100 hour overtime shift at the Route 91 Harvest Festival. Detective Gray was assigned a solo position at gate 4 on the north side of venue. Detective Gray was returning from a trip to the restroom, when he heard rapid gunfire. It sounded like fireworks initially, but he quickly determined it was gunfire. Due to the sound, Detective Gray did not believe the shooter was inside of

the venue. Detective Gray immediately started to encounter thousands of patrons attempting to exit the venue through gate 4. Detective Gray directed people toward the Tropicana Hotel. Detective Gray encountered numerous subjects with serious gunshot wounds, which he staged alongside his patrol vehicle. He made several requests for medical over the radio, but never received an ambulance. Several citizens stayed with Detective Gray and helped the wounded; two female nurses, a combat medic, and an LAPD Lieutenant. An injured male arrived at Detective Gray's position in a vehicle, which he said he found in the street. The male was going to the hospital and Detective Gray helped him load up several victims into the vehicle for transport to the hospital. Detective Gray also hailed down at least three (3) Uber drivers, and loaded victims into their vehicles to be transported to the hospital. Detective Gray began to hear radio broadcasts of active shooters along the strip. It was confusing and Detective Gray did not know if there were more than one suspect involved. Detective Gray responded to an active shooter at the Tropicana Hotel with an unknown Patrol Detective, but there were no shooters there. Detective Gray returned to the venue and continued to assist with getting victims to the medical units staged at Tropicana and Las Vegas Boulevard. Detective Gray was ultimately relieved and debriefed before clearing the scene.

Detective Gray felt he was adequately trained and believed everyone did a great job. He felt a lot of time was wasted chasing false active shooter reports and wondered if a system could be implemented to reach out to strip property camera operators over the telephone to quickly determine if an active shooter existed.

Officer Cameron Sims PN15054

Detective Mauch conducted an audio recorded interview with LVMPD Officer Cameron Sims regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Bryan Yant, PN6956. During the interview, Officer Sims relayed the following information:

Officer Sims was partnered with Officer Ryan Rotta and was near the House of Blue's Bar, which was on the left side of the stage. When the gunfire started, Officers Sims, Rotta, and two other officers formed an arrest team and moved across the venue near the stage from the east to the west. They were unable to gain access to the House of Blues since people barricaded the entrance with tables. The officers were joined by an

unknown off-duty Downtown Area Command Officer, EMT's, and a nurse, who all rendered aid to numerous victim's. Sims observed flashes coming from Mandalay Bay, about half way up the hotel, and updated the information over the radio.

Officer Sims had concerns about officers wearing reflective vests during assignments and believed it put officers in harm's way, since it made them too visible. Officer Sims suggested a tactical vehicle stationed closer to the venue with medical equipment and tactical gear could of assisted officers. Officer Sims believed bringing the involved officers back into the scene hours later for debriefing purposes was a poor choice.

Officer Mark Baumann PN4301

Detective Mauch conducted an audio recorded interview with LVMPD Officer Mark Baumann regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA President Steve Grammas, PN6090. During the interview, Officer Baumann relayed the following information:

Officer Baumann was partnered with Officer Anthony Raymond. Officers Baumann and Raymond were assigned near Gate 6 near the church. Their vehicles were parked in the center median with the overhead lights on in order to slow the traffic down in the area. Baumann heard a couple of pops and thought it was fireworks.

Officer Baumann assisted people with leaving the venue and then went to his vehicle to get his rifle. A large amount of people were around Baumann's vehicle using it as cover. He worked his way back into the venue towards the left side of the stage; working his way around towards the center of the venue. Officer Baumann believed the shooting was happening from a distance based on the sound delay. Officer Baumann ended up outside the venue on Las Vegas Boulevard and made contact with the responding officers that took on gunfire at the corner of Las Vegas Boulevard and Mandalay Bay Road.

Officer Baumann expressed concern over wearing the yellow traffic vests. He felt the vests made them a target. Officers were requested to change radio channels during the incident, which created issues with communication. Excessive radio traffic by involved officers also made it difficult for pertinent updates to be made over the radio. Having officers assigned with rifles when they were not easily accessible was another concern.

Officer Michael Polion PN9800

Detective Mauch conducted an audio recorded interview with LVMPD Officer Michael Polion regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Officer Polion refused representation from the LVPPA. During the interview, Officer Polion relayed the following information:

Officer Polion was partnered with Officer James Tennant. Officers Polion and Tennant were assigned to traffic control at Giles Street and Ali Baba Lane, near gate 6. Officer Polion heard a couple of pops and thought it was fireworks. Once he realized it was gunfire, he could tell the shots were coming from the west. Officer Polion assisted with rendering aid to the victims and helped with getting them out of the venue.

Since the officers were unable to make contact with the shooter, Officer Polion explained their job functions changed to assisting with the medical needs of the victims. More training with medical related issues and triage would assist officers in the future. Officer Polion also expressed the need for more tourniquets and tactical vehicles stocked with supplies.

Officer James Tennant PN9817

Detective Mauch conducted an audio recorded interview with LVMPD Officer James Tennant regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Myron Hamm, PN6675. During the interview, Officer Tennant relayed the following information:

Officer Tennant was partnered with Officer Michael Polion. Officers Tennant and Polion were assigned to traffic control at Giles Street and Ali Baba Lane, near gate 5. Officer Tennant heard a couple of popping sounds and wasn't sure what it was. He then realized it was gunfire and got his rifle and gear from his patrol vehicle. Officer Tennant assisted with moving people from the venue to the church parking lot. After the gunfire appeared to end he went and assisted with clearing the venue with other officers.

Officer Tennant explained the event was working off the Event 5 channel with a dispatcher. He was concerned that he was told to switch to CCAC channel during the gunfire because it was unsafe to do so under the circumstances. Officer Tennant also had concerns he was unable to render aid due to the amount of injured people around him and he was unable to get medical staged for them.

Officer Anthony Raymond PN9339

Detective Mauch conducted an audio recorded interview with LVMPD Officer Anthony Raymond regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Officer Raymond refused representation from the LVPPA. During the interview, Officer Raymond relayed the following information:

Officer Raymond was partnered with Officer Mark Baumann. Officers Raymond and Baumann were assigned near gate 5 on Giles Street. Officer Raymond was at the command post on lunch when he first heard a noise he believed to be some sort of electronics interference. He then realized it was gunfire and went towards his post. Raymond assisted with getting people out of the venue and was part of a force protection team that cleared the venue.

Officer Raymond had concerns of too much radio traffic and being told to switch radio channels during the gunfire. He believes more medical related training would be beneficial in the future and thinks training days should be utilized for officer's training. The traffic vests made them bigger targets and patrol shields and/or a staging area for them would assist officers in the future.

Sergeant Justin Van Nest PN14198

Detective Mauch conducted an audio recorded interview with LVMPD Sergeant Justin Van Nest regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPMSA Representative Jay Roberts. During the interview, Officer Tennant relayed the following information:

Sergeant Van Nest was in charge of 6 Special Event Officers and was responsible for entrance gates and the interior of the venue. Sergeant Van Nest was on the Las Vegas Boulevard outside of the venue dealing with a female causing a disturbance. Sergeant Van Nest heard a couple of popping sounds and then realized it was automatic gunfire that was coming from across the street. As the gunfire continued, Sergeant Van Nest and other officers took cover behind a brick wall. Sergeant Van Nest coordinated moving people east bound from the boulevard, since the gunfire sounded like it was between the Luxor and Mandalay Bay. Sergeant Van Nest was close to Las Vegas Boulevard and Mandalay Bay Road when the arriving patrol units started to take on gunfire. Sergeant Van Nest joined a response team that later formed up with officers inside the venue.

Sergeant Van Nest had concerns about the yellow traffic vests. He removed his during the gunfire. Sergeant Van Nest believed additional scenario based training, specifically large scale incident training, would be beneficial in the future. Sergeant Van Nest also had concerns that all the patrol vehicles were parked at the church on the other side of the venue, which he believed to be too far away.

Special Events Coordinator Cecilia Rodriguez PN7281

Detective Mauch conducted an audio recorded interview with LVMPD Special Events Coordinator Rodriguez regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Special Events Coordinator Rodriguez refused representation from the Las Vegas Police Protective Association Civilian Employee (LVPPACE). During the interview, Special Events Coordinator Rodriguez relayed the following information:

Coordinator Rodriguez was working in the command post trailer, which was on the north side of the venue near Reno Avenue. Coordinator Rodriguez worked with a couple officers and handled the dispatch assignment and coordinated with the event personnel that were utilizing the security cameras.

During the gunfire, Coordinator Rodriguez assisted the security personnel with the surveillance cameras. She also directed the officers to switch from the Event channel they were using to the CCAC channel. A few officers still remained on the Event channel and continued to make requests over the radio. Rodriguez had one radio on the Event channel

and a second radio on CCAC channel. When officers made requests on the Event channel, Coordinator Rodriguez or another officer in the command trailer would relay the request to the area command channel.

Coordinator Rodriguez had a concern with the command post being situated on the venue property and believed in the future for larger scale events, the command post should be away from the actual event.

Detective Ochsenhirt conducted an audio recorded interview with LVMPD Detective Glenn Brook regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Myron Hamm, PN6675. During the interview, Detective Brook relayed the following information:

Detective Brook was assigned to work the Route 91 Harvest Festival in a uniformed capacity. Detective Brook's call sign was 172SE and he and his partner, Detective Steve Balonek were assigned the responsibility of traffic / pedestrian control at the intersection of Giles Street and Mandalay Bay Road, near Gate 7. Detective Brook said the hours of the overtime assignment were to be from 1300-0100. At approximately 1700 hours, Detectives Brook and Balonek observed a flashing light in a room, located near the center of the hotel, on the 5th or 6th floor of the Mandalay Bay Hotel and Casino. Detective Brook said a Security Guard for the venue told him he had been there for three (3) days and had noticed the light the entire time. At approximately 2200 hours, Detective Brook said they heard a four (4) sound "burst," coming from the southwest portion of the main stage. Detective Brook said he was unsure if the sound was pyrotechnics, as some outdoor events have them, but they had not been briefed about pyrotechnics. Approximately thirty (30) seconds later, they heard the same sound and were certain they were gunshots. Detective Brook said Detective Balonek, utilizing binoculars, was able to locate the gunfire coming from Mandalay Bay, eventually determining it was the 32nd floor. Detective Brook said he had parked his department vehicle, facing east on Mandalay Bay. Detectives Brook and Balonek moved further east and took a position of cover. Detectives Brook and Balonek assisted getting patrons out of the venue and getting medical attention if needed.

Detective Brook felt they were adequately trained and equipped to handle the events that took place on October 1, 2017.

When asked about equipment the department might consider, Detective Brook suggested tactical load bearing vests. Detective Brook also suggested more trauma equipment could be placed in patrol cars to care for the wounded. As it related to the Route 91 Harvest Festival, Detective Brook thought the use of reflective, traffic style vests was not the best choice. These vests made the identification of law enforcement at or near the venue easier to the suspect.

Daniel Swanson

Detective Ochsenhirt conducted an audio recorded interview with LVMPD Detective Daniel Swanson regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Myron Hamm, PN6675. During the interview, Detective Swanson relayed the following information:

Detective Swanson was assigned to work the Route 91 Harvest Festival in a uniformed capacity. Detective Swanson's call sign was 175SE and he was assigned the responsibility of roving traffic relief. Detective Swanson said that his shift was supposed to end at 2200 hours and that he was waiting to meet the supervisor to collect his statistics. Detective Swanson said he was supposed to meet the supervisor near the church, which was located at Giles Street and East Reno Avenue. After meeting with the supervisor, Detective Swanson said he drove southbound Giles Street, then westbound on Mandalay Bay Road and met with another uniformed officer near the intersection of Mandalay Bay Road and Las Vegas Boulevard South. Detective Swanson said that as he began to drive out of the area, he heard what sounded like firecrackers. Detective Swanson then began to hear radio traffic indicating people had been shot inside the venue. Detective Swanson parked his vehicle and deployed his rifle and could see people coming out of the venue, hiding behind the block wall that was on the west side of the venue. Detective Swanson said he could see people climbing over the fence, near the southeast corner of the venue. Detective Swanson said that he provided medical care to individuals who were injured during the shooting. Detective Swanson said he helped move people south of the venue, near the McDonalds.

Detective Swanson said that he could have used more tourniquets, had they been available. Detective Swanson said he thought more medical supplies in general would have been helpful. Detective Swanson said that the Gunfight Medicine class, that is available through In-Service Training, was extremely helpful when assessing and helping to treat the injured.

Detective Christopher Rivera PN8866

Detective Ochsenhirt conducted an audio recorded interview with LVMPD Detective Rivera regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Scott Nicholas, PN6676. During the interview, Detective Rivera relayed the following information:

Detective Rivera was assigned to work the Route 91 Harvest Festival in a uniformed overtime capacity. Detective Swanson's call sign was 176SE and he was assigned the responsibility of the area around Gate 2B, which is on the west side of the venue, near Las Vegas Boulevard. Detective Rivera said during the event he and his partner, Officer A. Loos, PN14797, took fire from the Mandalay Bay. After hearing the first volley of gunshots and not being certain if they were gunshots or fireworks, Detective Rivera heard a second volley of gunshots. Detective Rivera said the lights went dark, in the venue, and the concertgoers began to flee the venue. Detective Rivera said private security personnel, working for the venue, began to motion to the Mandalay Bay. Detective Rivera and Officer Loos ran along the interior wall southbound towards the Mandalay Bay. Detective Rivera said he and Officer Loos went back to their vehicles and retrieved their rifles, tactical equipment and took off their reflective vests. Detective Rivera and Officer Loos met up with two (2) additional uniformed officers and made their way towards Mandalay Bay, while advising citizens to get to safety.

Detective Rivera said a patrol sergeant took charge of Fire Team and they climbed a chain link fence onto the Luxor property. Detective Rivera said they made their way to the Mandalay Bay and met with another Fire Team. Detective Rivera said the Fire Team that he was a part of made their way into the casino and they checked the Michael Jackson theater and discovered 1,200-1,400 people who were sheltering in place. Detective Rivera said none of the doors to the theater locked and there were four (4) unarmed hotel security officers in the theater so the decision was made to stay there.

Detective Rivera said he thinks his military training and experience helped prepare him for the event. Detective Rivera said more MACTAC type training would benefit those officers working on or near the resort corridor.

Detective Rivera said heavy body armor should be considered, as well as Velcro name plats to be worn on heavy / tactical armor. These would help to identify officers who are not known to each other and aid in communication.

Officer Michael Maloney PN5541

Detective Ochsenhirt conducted an audio recorded interview with LVMPD Officer Maloney regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Scott Nicholas, PN6676. During the interview, Officer Maloney relayed the following information:

Officer Maloney was working with Officer Bianco, their call sign was 186SE and they were assigned to the east grass infield area, near the main stage. Officer Maloney said they were standing near the House of Blues Bar when the first shots were fired. Officer Maloney thought the first shots were nothing more than fireworks, but the second volley of shots were recognized. Officer Maloney said he and Officer Bianco, along with two (2) unidentified uniformed patrol officers made their way towards the main stage, in a southwestwardly direction. While moving towards the main stage, Officers Maloney, Bianco and the unidentified patrol officers heard another volley of shots and realized they were in the line of fire. Officer Maloney said they all split up and took cover wherever they could find it. Officer Maloney began to tell the crowd to exit the venue to the east, out of Gate 5. Officer Maloney rendered aid to a woman who had been shot in the leg and then Officer Maloney made his way out of Gate 5 and over to the Mobile Command Post (MCP). Officers Maloney and Bianco helped carry a woman to the ambulances near the church, located at Giles and Reno. Officer Maloney used his patrol car to shield citizens in the church parking lot, which had become a makeshift triage area. Officer Maloney and Bianco loaded an injured woman and two (2) other citizens in the back of Officer Maloney's marked patrol unit and drove to Sunrise Hospital.

After leaving Sunrise Hospital, Officers Maloney and Bianco made their way back to the venue, stopping in the area of East Tropicana and Koval due a report of a suspicious male, wearing all black at the Motel 6. While at the Motel 6, Officer Maloney became aware there were additional injured citizens in the office and Officers Maloney and Bianco waved down ambulances to transport the injured.

Officer Maloney feels he was adequately prepared for this situation, but thinks more combat medicine training would be beneficial. Officer Maloney thought having additional equipment in the MCP would be beneficial, such as shields or extra ammunition. Access to the MCP would be helpful as well, as the MCP was locked.

Sergeant Monique Bulmer PN8402

Detective Ochsenhirt conducted an audio recorded interview with LVMPD Sergeant Bulmer regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPMSA Representative Sergeant Michelle Jotz, PN4964. During the interview, Sergeant Bulmer relayed the following information:

Sergeant Bulmer was working an overtime assignment at the Route 91 Harvest Festival and her call sign was 748SE. Sergeant Bulmer had eight (8) officers assigned to her and she spent the majority of in the area north of the grass seating area and south of grass / lawn chair area. Sergeant Bulmer said she was with Sergeant Van Nest and Sergeant Richmond. Sergeant Bulmer was called to the Medical Tent and while there she heard over her radio there was an Active Shooter at the venue. Sergeant Bulmer began to search the venue to look for a possible Active Shooter. As Sergeant Bulmer is searching for the Active Shooter, she began to encounter concert goers and began to usher them towards the exits on the eastside of the venue. Sergeant Bulmer met with two (2) uniformed officers and continued to hear gunshots. Sergeant Bulmer came across a woman who had been shot in the head and attempted to broadcast the information over the radio, while on a Special Events (SE) channel, and was told to change to Convention Center channel. Sergeant Bulmer was able to make it all the way to the west and could still hear gunshots. Sergeant Bulmer told the other uniformed officers they needed to start getting people out of the venue, both injured and non-injured. Sergeant Bulmer said there was an overwhelming smell of gunpowder as they made their way to the main stage.

Sergeant Bulmer said multiple buses had been parked behind the main stage and some of the buses were evacuated. It was determined to shelter in place when it came to Jason Aldean. Sergeant Bulmer and her team made their way to the initial Command Post (CP), near Giles and Reno and then began walking the exterior of the venue in order to set up a perimeter, ensuring the safety of those in the area. Sergeant Bulmer then began to have patrons fill out voluntary statements.

During the incident, Sergeant Bulmer removed her traffic vest and left it near one of the barrel tents. Sergeant Bulmer did not feel she was adequately trained to handle this incident and once she ensured there was not an active shooter, she wasn't sure what to do next. Sergeant Bulmer suggested the department policy on rifle deployment needs to be addressed. Rifles are very important and Sergeant Bulmer feels the department has taken an "anti-rifle" stance. Sergeant Bulmer thought placing rifles in a centrally located vehicle would be a good idea. That way they can be accessed quickly should the need arise. Sergeant Bulmer suggested an easier way to change radio channels than what is currently in place.

Detective Ochsenhirt contacted Officer Contreras, who said he had secured from his overtime assignment as 174SE prior to the first shots being fired. Officer Contreras had been assigned the responsibility of Roving Traffic Relief. Officer Contreras was not interviewed surrounding the events of 1 October.

Officer Steve Hutchason **PN7088**

Detective DePalma conducted an audio recorded interview with LVMPD Officer Hutchason regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Myron Hamm, PN6675. During the interview, Officer Hutchason relayed the following information:

Officer Hutchason was assigned to the Command Post the day of the event. He was in a "semi plain clothes" operation which reflected him wearing a black polo shirt with the metro star and beige 911 pants. His duties were to utilize the radio in order to broadcast any incidents that may occur during the venue. Officer Hutchason was assigned to work

from 1300-0100 and was working along LVMPD Special Events Coordinator Rodriguez. Officer Hutchason said he also worked the previous night where he had a briefing beforehand. He was informed that his job duties were to include reporting any fights, communicate with security, medical needs and anything else that Law Enforcement may need to act upon. He did not observe anything out of the ordinary.

At approximately 2205 hours, Officer Hutchason heard what appeared to be fireworks from a distance however, did not expect them. Very shortly after hearing that noise he observed people running. His first instinct was to run out of the CP along with other Officers to help assist however, he stayed with Rodriguez as she needed help working the radio. Officer Hutchason realized what he initially believed to be fireworks were rapid gunfire instead. He was trying to scan the area for a potential shooter in the crowd however, he could not locate anyone. He observed citizens injured and running out of the venue. It appeared to be approximately 10 minutes when he was able to get on CCAC radio and called for traffic to be stopped at Las Vegas Blvd and Tropicana and any traffic moving southbound. This was when Officer Hutchason stated he believed the shooting had already stopped. Approximately an hour went by when he was advised of small fires developing along the food vendor tents. He immediately began to shut down the propane tanks. While doing so, he observed many injured people still walking inside the venue as well as a man carrying a lady who appeared to be deceased. Officer Hutchason did what he could to direct the individuals to medical personnel on Giles Street however, he seemed to believe there were not enough of them present at that time.

Officer Hutchason did not feel he was adequately prepared and trained to handle this type of situation. He felt the Department should do more MACTAC, ICS training and better communication with the area command Captain for any future events. Furthermore, he should have had immediate access to his rifle and some more protective gear like his plates. Lastly, he believes medical personnel were inadequately prepared and felt they should have had a more substantial trauma pack to assist in a mass casualty event.

Representative Officer Myron Hamm, PN6675. During the interview, Officer Smith relayed the following information:

Officer Smith stated he was working overtime at the Route 91 event and initially assigned at the main gate checking wrist bands bag checks. When the initial rounds went off, it sounded like fireworks and he and his partner looked around for them. They then heard event security yell "people are shot", "people are shot", "people are shooting". He then ran towards Las Vegas Blvd by jumping a block wall and then southbound on the Blvd. He heard another volley of shots being fired and yelled for people out on the street to take cover behind walls. Officer Smith made it in front of the Luxor Hotel near the Mandalay bay Rd where he met up with other Officers. Officer Smith said he was initially pinned down at the street however, when the shots stopped, he and other Officers made it a point to direct whatever citizens they could find to move north behind a wall away from the area. Two Sergeants then created two strike teams which he was part of. He entered the Mandalay bay and began clearing out restrooms and bars where he observed people hiding. Officer Smith was told to start directing them to the Michael Jackson theatre which he did. Approximately 45-60 minutes later, he was directed to SCAC and then back out to the Church at Giles Street and Reno Avenue where the events planning CP was. It was at the church where he was released from.

Officer Smith felt he was adequately prepared and trained to handle this situation. He felt the Department needs to do more training for this type of incident due to the type of city we live in. He felt the Officers should be better prepared with plate carriers and plates in order to stop high caliber rounds. Officer Smith felt medical personnel should be better prepared with a larger number of tourniquets available as they ran out and had to use bed sheets to stop the bleeding.

During the interview, Detective Bordoni relayed the following information:

Detective Bordoni stated he was working overtime at the event and ultimately did not see any rounds impacting around him and his overtime partner. Detective Bordoni was working inside the concert and attending to a citizen that had a bad reaction to her medication when he heard what appeared to be fireworks. He stated most concert goers must have thought the same thing as no one he noticed reacted to the noise. Once the second volley of shots rang out he and his partner realized it was gunfire. He ran south through the venue and made it to Las Vegas Boulevard where he directed people to take cover not knowing where the gunfire was exactly coming from. He observed an Off Duty Firefighter attending to a female with a gunshot wound to the head. However, made it a point to get people running from the concert to safety. He did not have any interaction with the suspect. Detective Bordoni felt he was adequately trained but felt he could have had his riot gear and rifle closer to him while working in this capacity.

Detective Keith Bryant PN7773

Detective DePalma conducted an audio recorded interview with LVMPD Detective Bryant regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Michael Ramirez, PN9057. During the interview, Detective Bryant relayed the following information:

Detective Bryant was working overtime at the concert as 184SE and assigned to the grass area inside the venue. He stated he was in fact taking fire. He was inside the venue when hailed down by a concert goer who was having an unrelated medical episode prior to the shooting. Detective Bryant initially heard a few gunshots which he thought to be fireworks. He believed them to be fireworks because the crowd was still cheering. He then heard a longer volley of shots that were louder which he realized was in fact gun fire. Detective Bryant observed the stage to go dark and people to start running. He then heard another long volley of gun fire and observed people shot in the back and head. He attempted to get on the radio to advise of multiple injuries however, it was difficult to do so. Bryant stated after the third volley of shots, he realized the gunfire was coming from the Mandalay bay. He stated at one point during the incident, someone told him to take off his reflective vest. Detective Bryant felt he was adequately trained however, a suspect with higher ground would have an advantage point and he is not trained for that particular incident. Bryant felt having had better training regarding large events and dealing with

mass casualties would help. Lastly, A venue with a large amount of people in an open area he felt there should be Officer(s) working in a spotter/sniper capacity.

Detective DePalma conducted an audio recorded interview with LVMPD Officer Miller regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Bryan Yant, PN6956. During the interview, Officer Miller relayed the following information:

Officer Miller stated he was working overtime at the concert as unit SE167 and assigned in front of the church located on Giles St. He was scheduled from 1300-0100 hrs. He stated Aldean was playing and he heard what appeared to be fireworks. He looked up and did not see any. The next thing he noticed was people running out of the exits onto Giles Street yelling to him that they were shot. Miller stated he heard rounds hitting the ground and then noticed citizens jumping in his patrol vehicle in order to take cover. At one point he noticed a lady pull up in a patrol car with a wounded person in the passenger side. He directed her to get out of the car in which point he took control of the patrol car and drove the wounded person to the corner of Koval and Tropicana where a medical triage area was established.

Officer Miller felt the LVMPD could do more medical training dealing with people in a critical stage and could use more medical supplies like tourniquets as they ran out fast. Furthermore, he used up his trauma kit he had in his patrol car fairly quick. Officer Miller felt inadequate with only a shotgun and duty handgun.

Detective DePalma conducted an audio recorded interview with LVMPD Officer Loos regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. During the interview, Officer Loos relayed the following information:

Officer Loos stated he was working overtime for the Route 91 event and assigned at gate 2B as well as roving. He said at the time of the shooting he was behind the crowd near gate 2. When he heard the gunshots for the first time he was hoping it was fireworks but realized quickly that it wasn't. He immediately scanned the crowd for a shooter and observed people falling down. Officer Loos made his way down to Las Vegas Blvd where he began moving southbound along the block wall right outside the venue. Officer Loos realized the shooting was coming from the Mandalay bay area so he went back northbound along Las Vegas Blvd where he made it to his parked patrol vehicle. There he retrieved his rifle and additional gear. He then moved swiftly back towards the Mandalay bay where he directed people to get behind cover. Eventually he was part of a strike team put together by a Sergeant. For the remainder of his shift, Loos made it to the Mandalay Bay where he assisted clearing out the House of Blues and protecting citizens who were locked down inside the Michael Jackson Theatre.

Officer Anthony Gilbert PN13624

Detective DePalma conducted an audio recorded interview with LVMPD Officer Gilbert regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Bryan Yant, PN6956. During the interview, Officer Gilbert relayed the following information:

Officer Gilbert stated he was working overtime at gate 3 next to the AM/PM at Reno and Las Vega Boulevard. He advised he heard "pops" like the sounds of fireworks and when he looked up he did not see any. He said the noise sounded like it was coming from the Mandalay Bay area. Officer Gilbert said he made it down towards the Mandalay Bay and during one of the volleys of gunfire he was pinned down behind cover. He stated this lasted for what he figured to be almost 10 minutes. He and other Officers present devised a plan to keep citizens behind cover and once the shooting stopped they directed citizens out of the area. A strike team was created by a Sergeant who directed them to make it inside the Mandalay Bay casino where he assisted in clearing out the House Of Blues and met with security to help protect people inside the Michael Jackson theatre.

Officer Gilbert felt Officers could use more MACTAC training, more Officers that are rifle certified and having immediate access to their equipment when on an event like that. He

stated their vehicles they were directed to have at the event were parked too far away from where they were assigned.

Detective DePalma conducted an audio recorded interview with LVMPD Detective De Villar regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Bryan Yant, PN6956. During the interview, Detective Del Villar relayed the following information:

Detective Del Villar said he was working overtime at the Route 91 concert and assigned to Gate 3 near the corner of Reno & Las Vegas Blvd. He heard a volley of shots coming from a distance and began to run south down Las Vegas Blvd with his overtime partner. He stated at one point he jumped over a wall to gain entry into the venue however, when they realized the shots were coming from the Mandalay Bay, they went back onto Las Vegas Blvd. Detective Del Villar said once they made it down to the corner of Las Vegas Blvd and Mandalay Bay (NE Corner) they began taking rounds. He took cover behind a patrol vehicle that was taking rounds. When a volley of shots stopped, he noticed a generator that was powering up lights in the immediate area. He immediately shut down the generator in order to assist them with utilizing a cover of darkness from the shooter. Detective Del Villar said while the shooting continued, he did what he could to direct citizens to proper cover. Once the gun fire stopped, he attempted to evacuate citizens from the immediate area by telling them to head north. He was eventually assigned to a strike team that was created and went into the Mandalay Bay casino where he assisted other citizens.

Detective Del Villar stated he felt he was adequately prepared and trained to handle this type of situation. He felt that the department should offer more rifle classes as they are typically difficult to get into at the present time. Lastly, he felt that the department should offer rifle plates and possibly lookout equipment such as binoculars for those that are in a spotter assignment.

Officer Carlos Zamora PN917

Detective DePalma conducted an audio recorded interview with LVMPD Officer Zamora regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Tyler Todd, PN8411. During the interview, Officer Zamora relayed the following information:

Officer Zamora stated he was working overtime at the event and assigned traffic control at the Mandalay Bay and Las Vegas Blvd intersection with a call sign of 161SE. He had just rotated off his feet inside his marked patrol vehicle which was parked just east of Las Vegas Blvd on Mandalay Bay Drive when he heard the first volley of gunfire. He stated it sounded like fireworks and after hearing the second volley of shots he still wasn't sure exactly what they were. Officer Zamora said the sound came from the Mandalay Bay casino area and realized it was gunfire when he was advised over the radio people suffered gunshot wounds. Officer Zamora left his vehicle and began running north towards a block wall where he was under fire. He and other Officers did what they could to provide cover for citizens in the immediate area. He stated there was a generator that powered up lights which illuminated the area he and other Officers were at. He and other Officers ran to the generator and powered it down in order to provide some darkness. Officer Zamora did not feel he was adequately prepared and trained for a situation like this. He stated there is nothing you can really do to train for that type of incident. Officer Zamora did not feel there was any equipment to better assist him during this incident.

Officer Meghan Kraut, PN9313

Detective Boucher conducted an audio recorded interview with LVMPD Officer Kraut regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Bryan Yant, PN6956. During the interview, Officer Kraut relayed the following information:

Officer Kraut currently works out of the Officer of Community Engagement. On October 1, 2017 she was working special event overtime at the Route 91 concert. Officer Kraut was partnered up with Officer Andrew Krnjeu, PN9336 for the event. The Officers parked their vehicles at the Catholic Church some distance east of the venue, and were brought over to the venue as were other officers. Officer Kraut was stationed near the VIP lounge.

They were positioned on the northwest corner of the grass area next to the VIP lounge and suites.

Jason Aldean had begun performing. Officer Kraut heard what she believed to be approximately 3 gunshots. She conferred with Officer Krnjeu and they were unsure if it was gunfire or fireworks. It sounded like it was at a distance, somewhere to the south of where they were so they began to walk towards the stage.

Gunfire erupted and both officers drew their firearms and began running towards the south. Officer Kraut believed the gunfire was possibly coming from the street outside of the venue, closer to Mandalay Bay. Both officers reached the area west of the stage where the performer's busses were located. Officer Kraut took cover behind the busses and changed her radio to CCAC, as she was unsure if they were aware what was happening. She heard someone on the channel broadcast, "It's coming high." She decided to remain behind the cover of the busses because the shooter was elevated and they were uncertain where he was at. The officers began knocking out all the light around them which they felt were illuminating their position.

Security from the venue contact the two officers and asked if they could help, and also advised that there were a large number of people pinned down, near and around the stage. So Officer Kraut had security direct the people to their location, and they began having the people take cover in between the busses. Eventually there were too many people to fit between the busses. Officer Kraut located a large conex box next to the stage and began having more people go in there.

There were a number of injured people present. In the people around her were ex-military, nurses, firemen. She asked them to assess and aid the injured. They made make shift tourniquets out of whatever they could find. At one point a man arrived with a bunch of seatbelt looking items and they were able to use those for tourniquets.

Once the gunfire had ceased for a period of time, Officer Kraut got on the radio and advised he had approximately 100 people with her that they needed help evacuating. Officers eventually made their way to them and began evacuating victims. Officer Tim Frederick commandeered a van from the venue and drove victims in groups from the venue to the church. Once everyone surrounding the busses had been evacuated they began working on the people within the busses.

They determined there were about another 40-50 people on the busses still. They evacuate the first bus closest to the stage, and then they began hearing radio traffic about possible active shooters at other hotels north of their location. The officers collectively decided they were going to have the remaining people stay on the busses and the officers were going to take up security positions around the busses until they knew it was safe to move them. Eventually they evacuated the busses as well bringing everyone to the church.

Patrol Detectives arrived at the church and gave out voluntary statements for everyone to complete. Officer Kraut believed she was adequately prepared mentally to deal with this situation as she instructs active shooter training, and she was on the SAT team for several years, so she believed her training in these areas prepared her for this event.

In regard to training the department might need to institute, she believed there could be more training. She felt all the training she had done personally had prepared her, but felt most of the officers at the venue did not have the same training, and were not prepared for an incident like this. She noted that training days have been taken away from squads, range time has been decreased, and that most officers haven't had live sounding training which prepared them for this. She further noted that in her opinion most officers did not stay current on mass casualty attacks, or ISIS type attacks. Officer Kraut suggested that there should be combat medical training provided as well, as they were ill prepared to handle and aid all of the casualties.

Officer Kraut also brought up the concern about not being able to access her rifle, medical kit or extra ammunition. Overtime assignment often have you park your vehicles away from your area of assignment, as a result all of her equipment was too far away to assist her. She suggested having cars parked in the venue or strategically placed lock boxes throughout the venue with medical supplies, shields, ammunition and rifles in them. Lastly there was a concern regarding the yellow police vests the officers are required to wear. She felt like they provided the shooter with a target as the vest make the officers stand out in the crowd.

Detective Boucher conducted an audio recorded interview with LVMPD Lieutenant Spencer regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPMSA Representative Tara Roberts. During the interview, Lieutenant Spencer relayed the following information:

On October 1, 2017, Lieutenant Spencer was in charge of the Route 91 concert event. He had 50 people assigned to him for the incident. There was an initial briefing at 1300 hours, at the Catholic Church parking lot, which was east of the venue. Most of the officers worked inside the venue, but there were also some stationed outside for traffic control.

Around 2200 hours Lieutenant Spencer was in the command post with Officers Rodriguez, Hutchings and Fredrick. Jason Aldean had requested an escort to the airport, which Lieutenant Spencer had denied, and Aldean was upset about it, so they were trying to deal with that situation when they heard gunfire. Initially they were unsure if it was fireworks or gunfire, so they looked at the monitors and it didn't appear anything was happening. A few moments later, there was more gunfire, except this time they could see people in the crowd running away.

Lieutenant Spencer and Officer Frederick ran from the command post, through the crowd, towards LVBLVD. Lieutenant Spencer got onto the radio and advised they had a confirmed active shooter, and he called for a surge. When they reached Las Vegas Boulevard there was a sea of people running north from the concert. Lieutenant Spencer told the officers to keep moving south towards the sound of gunfire. At that point in time he expected to encounter the shooter on the street. As he moved closer to Mandalay Bay he could tell the gunfire was coming from an elevated position, and then officers were on the radio broadcasting that the shooter was elevated. Lieutenant Spencer took cover behind a Palm Tree while trying to discern where the shooter was. He directed the civilians to take cover behind the trees and a pony wall nearby.

He observed cars still driving down the Boulevard, so he attempted to get on the radio to have units to the south stop traffic, but he was unable to get on the radio. There was now broadcast of possible shooters at other hotels as well now.

Lieutenant Spencer attempted to get a staging area at Tropicana / Las Vegas Boulevard, however someone came on the radio and set the staging area at South Central Area Command.

When the gunfire stopped, he directed all the civilians to flee to the east, back towards the church where the briefing had taken place. The civilians took off running, and Lieutenant Spencer began checking along the wall to send civilians to safety. He encounter some other officers as well. There were five officers and a paramedic. One of the officers had a shield with him so they followed behind him. They worked their way through the venue checking on all the people who were down. Everyone they encountered was dead.

They continued through the venue and encountered officers at the tour busses. There were still about 40 people on the busses, which needed to be evacuated. However there was radio traffic that there may still be active shooters at different hotels. So it was decided that they would shelter in place. Lieutenant Spencer put officers on each corner of each bus and kept all the victims in their busses.

A Fire Captain approached Lieutenant Spencer and advised him someone had dropped off a suspicious package in front of their medical area. Lieutenant Spencer went with him and the package was a backpack. He opened it up and determined it was just a backpack.

Lieutenant Spencer then encountered Deputy Chief Brett Zimmerman and asked him about the other shooters. Deputy Chief Zimmerman advised there were no other shooters anywhere else. Lieutenant Spencer realized the shooting was over and began handling his responsibilities as the Lieutenant of the incident.

Lieutenant Spencer felt that he and the other officers were prepared as best as they could have been for this incident. He did not feel there was really any way to implement training for a potential incident like this.

Lieutenant Spencer felt that tactical rifles are equipment the department should consider providing to assist our officers in the eventuality of another incident like this. Lieutenant Spencer commented that there was a great deal of radio traffic, which made it difficult for him to relay information.

Detective Boucher conducted an audio recorded interview with LVMPD Officer Muis regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Michael Ramirez, PN9057. During the interview, Officer Muis relayed the following information:

Officer Muis was working an overtime assignment at the Route 91 Harvest Festival starting at 1300 hours. Officer Muis was assigned the responsibility of pedestrian traffic control at the intersection of East Reno Avenue and Las Vegas Boulevard South and his vehicle was parked at the AM – PM. Officer Muis was at the north end of the concert venue. Officer Muis was standing in the median on Las Vegas Boulevard, waiting for the signal to change, talking with another officer when he heard what sounded like fireworks. Officer Muis heard the second volley and thought it couldn't be fireworks. After the third volley, Officer Muis heard radio traffic indicating there were shooting victims in the area and he ran back to his marked patrol vehicle to retrieve his rifle and plate carrier. Officer Muis and Sergeant Riddle made their way to the Luxor, while continuing to tell people to leave the area to the north. Officer Muis evacuated some pedestrians from the area and then rejoined the group at the Luxor. Officer Muis and the group of officers he was with made their way to the north end of Mandalay Bay and met up with another group of officers. The group made their way into the Mandalay Bay through an employee entrance.

Once inside, Officer Muis led a group of officers through the casino floor, clearing it as they went. Officer Muis told individuals they encountered to continue moving out of the hotel. They encountered a homeless man and detained him until they were certain he wasn't involved. After hearing the shooting was over and the suspect was in custody, Officer Muis was assigned containment responsibilities outside the hotel. Officer Muis eventually was told to go check in with Special Events and made his way back to the area of his patrol vehicle. Officer Muis attended a debriefing at approximately 0500 hours. Officer Muis did not think they had been targeted by the suspect and doesn't think any rounds were fired in his direction. Officer Muis thinks he was adequately prepared and trained to handle the situation, but suggested that more rifle classes would be beneficial. Officer Muis felt a rifle rated shield would be a good piece of equipment for the department to consider.

Officer Jonathan Adkisson PN14314

Detective Boucher conducted an audio recorded interview with LVMPD Officer Adkisson regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Myron Hamm, PN6675. During the interview, Officer Adkisson relayed the following information:

Officer Adkisson was working an overtime assignment at the Route 91 Harvest Festival and his shift began at 1700 hours and he was scheduled to work until midnight. Officer Adkisson attended briefing at the church and then was assigned to Gate 5, which is on the northwest corner of the venue. Officer Adkisson said bags and purses were being searched at Gate 5. Officer Adkisson heard the first three to four shots, which he thought might be fireworks, but he hadn't seen anything. After the first shots a security guard ran towards him and said shots had been fired near the southwest corner of the venue. Officer Adkisson and his partner ran towards the interior of the venue and took cover near a block wall. Officer Adkisson began to encounter individuals who had been shot and they began to create tourniquets from the clothing of others. Officer Adkisson helped treat others and gave victims directions to exit the venue.

Officer Adkisson ran to his patrol car and got his rifle and plate carrier and ran back towards the venue, telling people to run out of the area. Officer Adkisson met up with other uniformed personnel and they entered the venue from the southwest gate, after the shooting had stopped, and began to search and clear all the structures. Officer Adkisson provided force protection to medical personnel while they treated the wounded on the east side of the venue. Officer Adkisson was later tasked with providing perimeter security at the venue.

Officer Adkisson attended a debriefing at the House of Blues Bar, inside the venue, at approximately 0500 hours. Officer Adkisson felt he could have used more medical training and the department may want to institute more medical training moving forward. Officer Adkisson believed binoculars would have been helpful during the incident and the department may want to consider them.

Detective Boucher conducted an audio recorded interview with LVMPD Officer Fetherston regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Tyler Todd, PN8411. During the interview, Officer Fetherston relayed the following information:

On October 1, 2017, Officer Fetherston was working special events overtime at the Route 91 concert. He began his shift at 1300 hours, and was assigned to traffic control at Las Vegas Boulevard and Reno.

Officer Fetherston was on the west side of Las Vegas Boulevard conducting traffic control when he hears a short burst of gunfire or fireworks, he was unsure which it was. He heard it again and still was unsure if it was gunfire. There was a broadcast over the radio about that people were shot inside the concert so they now knew it was gunfire.

Officer Beason, who was working with Officer Fetherston advised he had a rifle in his car. So both officers ran to Officer Beason's car. Officer Fetherston drove as Officer Beason had retrieved his rifle. They drove to the northeast corner of the Mandalay Bay property and exited the car. In the north tower in an upper window they observed smoke coming from one of the windows. They attempted to get on the radio, but there was too much radio traffic.

They entered a tunnel which brought them into the casino. A security officer located the officers and told them that the shooting was taking place on the 32 floor. The security officer brought them up to the 32 floor.

When they got off the elevator there were several security officers there. They advised that the shooter was in the suite at the very end of the hallway, and that the suspect had fired rounds down the hallway, having shot one of the security officers in the leg. The security officer who had been shot was still present, but was put on the elevator a short time later. Security officers also advised that the stairwell door had somehow been secured.

As the officers looked down the hallway, they observed a food cart by the door, and did not know why they were there. Officers Fetherston and Beason decided that they should advance towards the room, when a group of officers came out of the stairwell and joined

them. They made a plan to clear the rooms down the hallway, to evacuate anyone in the rooms. They worked their way about halfway down the hallway and then held for SWAT. Once they knew there was a team in the stairwell they advanced one more set of rooms, and located a baby in one room and a nanny for the baby in another across the hall. They evacuated them.

The team on the stairwell had made it to the hallway and set a breach for the door. Everyone took cover and watched them make entry into the room. They were advised there would be a second breach on another door in the room, which they heard.

Officer Fetherston and the team then cleared the rest of the rooms up to the suite. SWAT posted up on the suite and directed the officers to recheck every room on the 32 floor, and to evacuate anyone they discovered. They had a master key for the rooms from security and rechecked every room on the floor. They located a small number of people and directed them to the elevators where security was standing by.

Officer Fetherston did not hear any gunfire the entire time he was on the 32nd floor. After clearing all of the rooms, Officer Fetherston, Officer Beason and another unknown officer stayed by the elevators to keep the floor secure until 0430 hours, when they went to a debrief. Officers Featherstone never made entry into the suspect's room.

Officer Fetherston believed he had been adequately trained to handle this incident. In regard to better train and prepare for future incidents, Officer Fetherston wanted to be able to carry a rifle. He has been unable however to get into the rifle class as it is always full. He has tried several times to get in the class.

Detective Boucher conducted an audio recorded interview with LVMPD Officer Tran regarding the October 1st shooting at 3901 S. Las Vegas Boulevard. The interview took place at LVMPD Headquarters, Building A, 2nd floor. Present in the interview was LVPPA Representative Officer Bryan Yant, PN6956. During the interview, Officer Tran relayed the following information:

Officer Tran was assigned an interior position, on the west side of the stage, closest to Las Vegas Boulevard, in a uniformed capacity. Officer Tran was working with Officer

Stutzman and they were working a twelve (12) hour shift. Officer Tran and Officer Stutzman were positioned near the VIP lounge. Officer Tran heard firecracker type noises, from the south end of the VIP lounge, while Jason Aldean was performing. Officer Tran asked Officer Stuzman if there were supposed to be any fireworks and Officer Stuzman said no. Officer Tran and Stuzman walked towards the main stage and observed a female laying on the ground with apparent gunshot wounds. Officer Tran broadcast the incident, attempted to render aid and began looking around the crowd. Officer Tran heard another volley of gunshots and he told people in the area to get down and take cover. Officer Tran then headed west towards the VIP lounge and took a position of cover and shielded a woman from gunfire. Officer Stuzman jumped the fence and ran into the VIP lounge and that was the last he saw him until later in the evening. Officer Tran heard another volley of gunshots and was told by a concert goer the shots were coming from the Mandalay Bay.

Officer Tran broadcast the information about the shooting coming from Mandalay Bay and was advised by another concert goer there were additional people shot on the south end of the VIP lounge. Officer Tran heard a least one (1) additional volley of gunshots and met up with Officer Frederick. Officer Tran and Frederick exited through the west side of the venue and began evacuating people who were hiding by the concrete wall. Officer Tran remembered seeing Officer Clarkson, who had been shot, and they evacuated him. Officer Tran went back into the venue and continued to assist those who had been injured. Officer Tran helped evacuate people who were stuck in a tour bus, some of whom sheltered in place. Officer Tran eventually provided security outside of the east gate, near the medical tent.

Officer Tran took his traffic vest off near the VIP bathroom, so as not to be a visible target.

The briefing Officer Tran attended covered what not to do instead of what to do if a major incident took place; where to send people. Officer Tran believes from a training standpoint he was prepared. Having their equipment closer to the incident would have been beneficial.
