The following is the transcription of a tape-recorded interview conducted by DETECTIVE C. JEX (CJ), P# 5597, LVMPD FORCE INVESTIGATION TEAM, on 10-03-17 at 1805 hours. Also present is Las Vegas Police Protective Association representative S. Nicholas (SN), P# 6676.

CJ: Operator this is Detective C. Jex, P# 5597, with the Force Investigation Team conducting a recorded witness officer statement reference Event # 171001-3519. The officer being interviewed is Officer Theron, T-H-E-R-O-N, Young, Y-O-U-N-G, his P# 15103. His call sign for this incident was 8Mary61. He's part of the Flex Team in the Convention Center Area Command. His date of hire is [REDACTED] He is assigned to Convention Cer- Center Area Command, Squad CC16. And his RDOs are Wednesday, Thursday, Friday. This interview is reference an active shooter that

occurred on 10-1-17, at approximately 2208 hours at the Mandalay Bay Resort at 3950 Las Vegas Boulevard South. Today's date is 10-3-17, and starting time is 0605 hours. This statement is being conducted at LVMPD Headquarters, uh, Building C, uh, 3rd Floor in the, uh, CIRT Conference Room. Uh, also present is PPA Representative Scott Nicholas, P# 6676. All right is it okay if I call you Theron?

TH: That's fine.

CJ: Theron, uh, you're aware that this interview is being recorded?

TH: I am.

CJ: All right. Uh, before we get started what I would like for you to do is, uh, describe to me what you were wearing the - the night of the incident...

TH: Okay.

CJ: ..and, uh, and then any gear that you may have put on, uh, and describe that gear, okay?

TH: Okay.

CJ: Go ahead.

TH: Uh, our squad was conducting a plain-clothes plain operation so I was in street clothes, I had a - a black button up shirt with blue jeans and tennis shoes on. Um, we got the call, we were driving actually back, uh, to meet one of the detective sergeants to, um, maybe coordinate a CI. And that's when the call came out, we immediately pulled over and we had a tactical vest in the vehicle, the tactical vest was green in

color, it had, um, a Metro Velcro badge on the front and I had the - the bright yellow and black Police on the back. I also was wearing my hang badge at the time on my shirt as well. I had donned that that equipment on which is a full plate carrier with - with armored plates and magazines. Um, I am a rifle carrier, I also slung my rifle as well as I had a, uh, a sidearm in a sidearm holster on a normal belt on my persons.

CJ: Okay. And the rifle, is that personally owned or Department?

TH: It's personally owned.

CJ: Okay and what - what kind of rifle was it?

TH: It's - it's a No- Noveske AR-15.

CJ: Okay.

TH: Yeah.

CJ: All right. Um, okay, uh, now what I'd like for you to do is just narrate me through, uh, how you responded...

TH: Okay.

CJ: ...or how you heard about it and how you responded and then just walk me through, tell the whole story all the way through...

TH: Okay.

CJ: ...'til you were re- essentially relieved from wherever you were.

TH: All right so again I said before we were on our way to meet a detective sergeant, uh, we were trying to maybe possibly get a CI in our area command to work with us. Um, that's when the call came out, we were I believe just on Sierra Vista at the moment. Um, call came out, my partner and I, uh, we pulled over real fast and we just threw on the equipment very quickly, started heading towards, uh, the Mandalay Bay, Route 91 area. 'Cause we heard that's what the - the call was coming out as. Uh, as you know there was a lot of radio traffic, the first details was it was at the Route 91 and as we're on our way there then we started hearing guys saying it was coming from - from the Mandalay Bay. Um, we were traveling down - down, uh, Paradise, we made it over to, uh, Tropicana and then we started hearing that officers were taking fire at the intersection of Mandalay Bay and Las Vegas Boulevard and that we pretty much had confirmation that it was coming from the actual Mandalay Bay. We changed route, we went through the Excalibur, we wanted to go around, we did not want to take direct fire, we made the decision that we're gonna go inside and try to find this guy. So we changed direction, went around the Excalibur which there's a - a back street, Frank Sinatra which leads into a back valet of Mandalay Bay which is they - they call that area the Delano. Uh, we pulled right in there, we parked. My partner and I, we got out, um, we started trying to find a security guard so we could find which elevator bay we needed to go to. Um, during that we actually found a couple other officers that were already in there and they were wearing, uh, their tan Metro uniforms. Um, we grabbed a security guard and we said, "We need to get in an elevator right now, what floor are we going to?" We had multiple reports, at the time

we had 29th Floor, possibly a 32nd Floor so we had multiple floors that maybe we were gonna go to. One security guard actually took us in improper direction and we found a right guy to take us the correct direction, we finally got in the elevator. Um, we decided that we were gonna go to the 32nd Floor 'cause like I said guys were getting information that it was multiple floors and we just made a decision that hey we're just gonna go to the 32nd, that's where we have our best information. We'll go there, we'll sweep the floor, if we don't find anything we'll go start working our way down to the next floor and so on and so forth. We made it up to the 32nd Floor, my partner and I along with I don't know those other officer's names. My partner is Officer Kravetz. Uh, I think we had like four guys in tans with us, don't quote me on that number. We went up the elevator, got to 32nd - the 31st Floor, we decided to use the stairs to go up, we didn't want to be ambushed or anything like that on that floor. Um, there was another officer who was waiting in the elevator bay and we got off the stairs at 32 he was right there and then that's when he told us that a security guard had been engaged on that floor. Um, we had an idea of where the room was, we knew it was the north area tower so we knew which direction to face. Uh, we got the information again from the officer there who was talking to that security guard. Um, we didn't know exactly where the room was at that moment, we just knew that it was possibly that - the # 135 room up there. Uh, we also were told there was multiple shooters. Uh, by the time that we had got up there we had heard no more shots. I was not hearing shots when were in the - when we were, um, on the casino floor going in the elevator, I did not hear shots when we were in the stairwell, and we

did not hear shots when we were actually on the 32nd at the end of the hallway facing that north - that north room. So we got a master key from the security guards and we decided that okay well we possibly have multiple shooters, that means it could be multiple rooms. We started going through doors and clearing rooms, working' our way down. Um, again maybe there's five to seven of us at this time, I don't know exactly. I just remember my partner and I, we - we stayed together the whole time. Um, and as we - as we are, uh, clearing, we're just kind of moving. Uh, we're - we're covering each other down the hallway so we- we're - we're doing it tactically, we have a guy covering down the hallway, a couple guys covering the hallway, we have a breacher up on the door, we're - we're pushing the doors in, we're goin' on and we're - we're clearing out rooms like we are trained to do. Uh, we're working our way up and then one of the guys noticed is there some impacts in the ceiling above us, we were probably about halfway down the hallway at this point. And again we're not hearing anything at all. Um, I lay in the prone because we see those and I start covering down the hallway and there's - you can see actually bullet fragments, shrapnel on the ground. So now we know that we're pretty sure we are in the right place where we need to be. Uh, we talked to a security guard and - and we're asking him again, "Does your guy know exactly where he took fire from?" I'm like looking at two doors down the hall, I said, "What are those two doors that I'm looking at? Is that - is that possibly the room?" And he said, "That is the room, # 32135 that we believe it came out." So now we're pretty sure that is the room now and maybe if there are multiple shooters, maybe they are all in that room. We decide

to work forward a few more bays, uh, bays meaning the hotel rooms. We clear a couple more rooms on each the left and the right side. Uh, we were probably about three bays down and the last door that we go into there was actually sadly a toddler in there all by itself. We were able to get that out of there thankfully, pass it off to another officer who I think passed it off to a neighboring female. Um, so then we decided to decision that okay we believe this is the room and we know that there's been already fire taken down this hallway and we know SWAT is coming. Uh, Security was telling us they believe the stairwell and those doors might be barricaded and we decided to hold. 'Cause again we didn't hear anything. So we held, SWAT shows up, um, they start coordinating their attack, they got their snipers and everything like that. Um, they go ahead and make their move forward, they start setting up their breaching charge, they let us know that, "We're gonna breach, we're gonna breach," that's being communicated back. I guess I got a little ahead of myself, before all that I hear- I guess there was another team coming up the stairwell as well and the SWAT guy was communicating with them too. I - I got ahead of myself there.

CJ: Okay.

TH: Um, I believe my partner was helping him with that radio traffic. And at that time I am still in the prone and I am holding on that door as well as other officers are in the hallways holding on the door as well. Um, they do their coordination with that other team down the hallway 'cause there's some flashlights coming' out and we obviously don't want a - a crossfire or anything like that. I remember the guy calling, "Hey

SWAT, SWAT, SWAT, identify yourself. Identify yourself." That's when they got on the radio and they started communicating, they knew that was a friendly, not - not our suspect and we had friendlies down the hallway. Uh, so SWAT made - made their plan. Um, they set up the breach, they told us, "Okay back up, get in the room and get ready to cover your ears and close your mouth 'cause it's gonna be loud." So one charge went off and then you had smoke coming' out and you could hear the smoke alarms coming off, things like that. Um, they said, "Hey we're gonna place another charge," um, so they placed another charge and they told us that breach is gonna be up again. Um, they said, "It's gonna be loud again, please cover your ears." So once they were ready and they told us to cover our ears we covered our ears again and they blew the door again. And at that - the second breach is when I believe that they did enter. Um, I didn't hear any loud gunfire, it sounded like maybe there might've been some suppressor fired 'cause it was not very loud or maybe because the room was so big we couldn't hear all the way down the hallway so I don't know if gunfire was exchanged between suspect and SWAT, or suspect 405 or what. Um, after that we walked up to the door, uh, as the SWAT guys came out and we said, "Okay well what else do you need now?" And they said, "Okay rooms gonna be - gonna be locked. What we need you guys to do is we need you to re-sweep the whole 32nd Floor. So myself, Officer Kravetz and another officer -- which he was in plain-clothes but he also had a full-identifiable Tac on, I don't know who that officer was -- we went back and cleared the entire 32nd Floor with other officers. So we had a four-man team on the left and a four-man team on the right. They took

the right side, we took the left side, or vice versa. Again with the security guard with the master key and we re-cleared every tower on the whole floor. And there was actually some people, um, in a few rooms that were in the, uh, wing that we hadn't cleared previous and we got those people out as well. So after we, um, cleared that we went back over to the room to check in, um, there was a couple guys there, I believe there was a Sarge there and we just said, "We cleared like everything you told us to do," and they said, "Okay well SWAT wants you to stop clearing," I was like, "That's fine, we had already cleared everything." And they said, "Okay well you guys are good then," so then we - we, um, we called our sergeant and let 'em know where we were. Um, in our squads we already have strike teams set in incidents like that so what myself and Officer Kravetz did per our sergeant's instructions, we found those - the other group of guys that we're supposed to be with and we met up with them on the casino floor in Mandalay Bay and we held a position in the lobby.

CJ: On which floor?

TH: On the - the lobby level.

CJ: Oh the lobby level.

TH: We met up with our - two other guys from our squad that we're supposed to be with and we held there until further notice. And then, um, after that we were told okay we could - it was okay to leave Mandalay Bay now, then we went and found our supervisor which was at Mandalay Bay and Las Vegas Boulevard.

TH: And then we just kind of stayed there. Um, kind of just at the intersection one of our guys locked the keys in the car so we were waiting with him to - to get a tow to - to get it out. And that - and then we got relieved. So...

CJ: Okay.

TH: ...I know that was kind of a lot quickly but...

CJ: No that - no that was good.

SN: Awesome.

TH: So...

CJ: So, uh, you mentioned that you never did hear shots except for when they - after they had breached and entered...

TH: Yeah. So like I said as we were going up the elevator I didn't hear any shots, I don't - I don't think anybody else heard any shots. We got off on the 31st, didn't hear shots. We went up the stairs, we made it through that main - the main elevator bay and 32 now, we were not hearing anything.

CJ: So this - this stairwell that you went up from 31 to 32...

TH: Mm-hm.

CJ: ...where in - in relation - I've been up there so in - in relation to where you come off of the elevators in that - there's kind of a round area where the wings go off of to the room...

TH: Mm-hm.

CJ: ...where are the stairs in relation to that if you can remember?

TH: I bel- you know what, we got a little turned around on our north, south, east and west up there so I can't give you...

CJ: That's okay.

TH: ...a great direction. Um, I know they were not the stairs that we came off, were not - was not the wing near the target room.

CJ: Okay.

TH: 'Cause I remember we had to come out - 'cause again - so you know how the Mandalay Bay (unintelligible) where it's got the big area and then you have the elevator base well then it splits off the three wings, we came down the one wing that one officer again was standing who had made contact with the security guard who was shot, and he was holding on that corner which was - now we know was facing - was facing north. And so we must've co- yeah we came out here, he was in a big area and then he was facing north and that's when we conducted our plan to start moving down the hallway.

CJ: When you were cl- you mentioned that you cleared the rooms down towards where the target...

TH: Yes.

CJ: ...room was, uh, were there people in any of those rooms?

TH: Yeah there - like I said we talked about the - the baby in the one room...

TH: Mm-hm.

CJ: ...um, I'm just a little confused on that. You made - you made - you kind of made it sound like the two charges happened very quickly with each other.

TH: Yeah, uh, again (unintelligible) I know I said a lot quickly. They were not back to back.

CJ: Okay.

TH: Um, they set a charge, they - they detonated it, they waited, I couldn't tell you the time lapse, and they set another one and detonated it.

CJ: So when you heard the first one...

TH: So, um, wh- when I relieved my prone - when they told me to leave my prone position is when the SWAT [REDACTED] got there. Then they said, "Back up in the room," 'cause they're gonna...

At that time we were under the impression that it was possible he was on the 29th floor. Uh, the elevators were - I wanna say they were locked out but we had somebody with us that unlocked the elevator for us. So we went up in the elevator, uh, got off on 28, um, made our way through the stairwell up to 29. Uh,

He also gave us information that the stairwell was barricaded which is located next to the suspect room. Um, at that time there was more officers arriving. There was a S.W.A.T. officer who arrived. I'm not sure what his name was. Um, he arrived and the plan was determined that we were gonna go one level below and then we're gonna go down the hallway and take the stairway to, um, that stairwell up to where the suspect room was located. So myself - it was probably ten officers - nine or ten officers, um, went the floor below. We went down the hallway into the stairwell. Um, we stood by momentarily - we - we try - we broke a couple of lamps tryin' to give us more cover. Um, the, uh, S.W.A.T. officer, um, breached the first door that was, uh, I guess had an L-bracket on it. Um, he opened the second door and he had a breaching charge, which he, uh, placed on the door. Um, plan was we were gonna blow the door. Um, I was behind them and the officers behind them I was only armed with my shotgun at that time. That if - due to the number of officers

we did not want to be too close together at that time. We kinda wanted to be far apart in case the suspect decided to shoot once the breach was done. And that if any officers were hit we were goin' to evac - evac - and we'd go up there and grab them and get them outta there. Because we were - half our - half the officers there were not - did not have ample fire power to engage a suspect with automatic weapons. So, um, the S.W.A.T. officer blew the door, um, assessed and I believe the first - I'm not sure how many - there was a canine officer there that was - had a rifle. And I'm not sure if another S.W.A.T. officer - I'm not sure. There was three of them that went in there. And, uh, went in to clear the room. We moved up into the - the stairwell. A few of us holding the doors open and we believe that the suspect also had access to one of the side rooms. So the room across the hallway we covered while they cleared the room. Um, we held that for a few moments. We did hear that they said that there was a suspect down. And that they needed another breaching charge. So at that time they went back into the hallway. I grabbed a breaching charge got it up. They, uh, applied it - I'm not sure where they applied it in the room, uh, they detonated that breaching charge. And cleared I guess the rest, uh, the, uh, secondary room of the - the other room. Um, during that time I'm not sure exactly when they were clearing or at the end or when the breaching charged, but I did hear three gun shots. Um, I did not know who fired. I never got that information. I had no idea if they shot the suspect or I - I'm not sure what happened when I heard those gunshots. Um, at that time once they said that those rooms were cleared. The rest - we met up with the rest of the officers that were coming down the

hallway. Um, I briefly stepped into the sus- suspect's, um, suite - for momentarily I stu- I think I took a step in. I took a look around. Um, there were several officers there at that time. And we were listening to the radio. We also heard that there was possibly, uh, another active shooter at the Paris. Today's date is October 3, 2017 and the time is 1755 hours. This statement is being conducted at LVMPD Headquarters, Building C, third floor. Also present is Officer M. Hamm, that's Henry, Adam, Mary, Mary, P# 6775, which is with the PPA, and Detective A. Ubbens, that's Union, Baker, Baker, Easy, Nora, Sam, P# 13119 with FIT. All right, um, before we get started, um, let's start off with what you were wearing that day of the incident.

ST: Uh, I was in essentially what I have on now. I had a black, uh, 5-11 shirt and blue jeans. Um, when I responded to the scene I had my tactical vest, it's a black tactical vest. It has a large, uh, velcroed on Police badge on the front that says, "Police," and it is also the Metro logo sewn into it, and then large Police patch on the back. Had my, uh, riot helmet on. Uh, that was it for clothing.

PQ: And as far as, uh, weapons?

ST: I had my, uh, Glock 17 with a weapons mounted light that's attached to the vest. I also had my Glock 26 on my hip.

PQ: Okay, and any other, um, equipment, like, uh, handcuffs or anything like that?

ST: Uh, the tact vest has, um, extra magazines, um, I - I didn't have the Taser in with it, uh, which is a pouch, but, um, tryin' to think any other weapons. Uh, I think that's it. Flashlights, things like that, accessories but no - no other weapons.

Um, so he wants the lights out so we're workin' on takin' the lights out so we don't - 'cause we know, at this point, the door we're gonna come through is gonna be the hallway and the suspect's door's gonna be immediately to our left and we know, at least through radio traffic, that there's already a team on that hallway coverin' down the long end of the hallway. So, we're tryin' to communicate. We got, uh, oh, it was, uh, Officer Burns was also in the hall - in the stairwell. So, Officer Jacoby Burns, he's gettin' on the phone with Matchko, tellin' Matchko, "Hey, we're in the stairwell, just so you know we're gonna poke our head out and see what's goin' on." So, uh, Levi pops open the door, takes a peek. Matchko acknowledges that we're in the hallway. Um, at this point, uh, we can see the - you can see the holes that come out of the suspect's doors. You can see that he's already fired out. Um, Levi decides that he's gonna use an explosive charge on the door. So, he calls - we get, um, Huddler on the phone and he lets Lieutenant Huddler know, "Hey, I wanna put a charge on the door, I wanna see what the response is from the suspect." Huddler, you can hear him over the phone, you couldn't hear all of it, but he says, "Hey, you know, do you need more SWAT guys," whatnot. He says, "No, I got six guys here, we're good." So, he sets up this charge, um, I think it was Bitsko goes with him. It might've been Newton, but they pop out in the hall and it's - it's only, like, a foot or two to the door - of the suspect, from our door. So, he pops out into the hall, places the charge, go back in, he blows the door.

He lets us know, before he blows the door, he says, "Hey, once we blow this door," excuse me. "If there's no response, we're gonna open this up, we're just gonna roll in." So, blows the door, we get no gunfire out, anything like that. Now, where we are, there's the stairwell door, probably a - maybe a four foot room, like a - like a - I don't even know what to call it, it's just an access room to the second door that leads into the hallway, so we have two doors between us and the hallway, and then the suspect's door's on the left. So, we close both those. Levi blows the door and we - we get no response, so we let Matchko know, "Hey, we're rollin' in," 'cause we're gonna be comin' out quick and we don't want any - any friendly fire. Um, so when we went in our - because the gunfire had stopped what we - what the plan was was to try to contain him from leaving the building. So, um, we started moving through the casino in a group. Um, started clearing everybody out. Um, patting everybody down we could. Um, made contact with a couple security officers who, you know, said that he was on the 32nd floor that when - that he had a camera set up, um, and that he had

But, um, we tried to relay some of that traffic. I think we ended up having to do some of it over the phone, um, 'cause we couldn't get over the air. Um, we took positions all around the elevator areas and just kept trying to clear people out. So if he came down we could try to neutralize it. Um, and then I wanna say maybe 10 to 15 minutes after, uh, we - we were - we entered the building the first, uh, SWAT officer arrived. I think it was a SWAT sergeant, but I can't remember to be honest with you. Um, and briefed him very quickly, um, that the shooter was on the 32nd floor. Um, that, you know, all the information I just gave you guys and then, um, a security guard that had access to, um, the service elevators, um, took that - took him to, uh, move up. And he instructed us to - to try to hold and contain downstairs in case he had left the room and in case he came down and, um, so that's what we - we did. We just kind of held everything until we heard, uh, the breach over the radio. Um, and then, um, we just kept clearing and clearing and clearing, getting people out of there. And then after that, um, we pretty much went through every - every room in the entire hotel, um, with SWAT. Um, and pretty much did that until about 6:00 a.m.

This interview is being conducted at LVMPD Headquarters, Building A, Third Floor Conference Room. Uh, the date is 10-6-2017. The time is 1311 hours. Uh, person being interviewed is Erik Perkett. First name, E-R-I-K. Last name is P-E-R-K-E-T-T. P# is 14152. His call sign for that night was R15. His date of hire is [REDACTED]. He is currently assigned to the Robbery Detail. His RDOs are Thursday, Friday, Saturday. His hours at 1500 to 0100. His vehicle number he was operating

on the night of the incident was 3796. Uh, no one is present - no one else is present.

Uh, are you aware this is being recorded?

EP: Yes.

SK: Okay. Um, what - what were you wearing that night?

EP: I was wearing, uh, my tactical vest that said police on the front and back with a Metro badge that had all my, uh, normal, uh, duty belt gear on it. Underneath that, I had a grey polo shirt with blue jeans and brown, uh, cowboy boots.

SK: Okay. Did you have a firearm?

EP: Yes. I did.

SK: Okay.

EP: I had two firearms.

SK: Okay. All right. So basically just tell me how you learned about the call and what your response was.

Uh, Joe Parra called and said, "Hey, there's an active shooter going on in Convention Center Area Command." Uh, we looked at CAD. We saw that there was a 415A in call that had been generated at Mandalay Bay. Sergeant Jungy then turned on, uh, his portable radio to the Convention Center Area Command and we could hear officers, uh, advising that

I played, uh, I put my tactical vest on prior to leaving and left the parking lot Code 3, Mandalay Bay, uh, based upon the active shooter. Uh, from there, I exited on Russell Road from the I-15 to the back of the, uh, Convention Center Parking Garage off of Russell. Uh, listening to the, uh, that's where I assigned myself and told, uh, dispatch on admin channel that I was arrived, uh, using my call sign R15 for the day. Uh, listening to the radio traffic on Convention Center, I proceeded to, uh, Hacienda and went to the east valet off of Hacienda. Um, parking in the east valet, uh, parking area underneath the awning. Um, I got out of my car. Locked it. Um, I didn't hear any shooting or see any shooting at the time so I proceeded into Mandalay Bay advising people that there was an active shooter, to take cover. Um, proceeding into Mandalay Bay, I met up with, uh, Scott Murray in the lobby by registration and Scott Murray and I discussed that the -- we were given reports of an active shooter on floor 29 and floor 32. Uh, Scott Murray and I decided that we needed to go to floor 29 because there were already officers on floor 32 and take out that threat if necessary. Scott Murray and I then walked to the elevator bays right by registration where we met up with, uh, Sergeant BiTsko, Stephen Trzpis, uh, Sergeant Matchko, uh, I believe, uh, Verl Conover and, uh, Dave Newton from K-9

along with a couple other officers who are also in tactical gear. And, uh, we decided to split up into two four man teams. Uh, Sergeant Matchko would take his team up to the 32nd floor to aide patrol that was on that floor. And I went with Sergeant Bitsko's team which was, uh, Sergeant Bitsko, myself, Stephen Trzpis and Dave Newton to the 28th floor in order to work up to the 29th floor to take out that threat. Uh, we exited the 28th floor with, uh, Sergeant Bitsko being on with the rifle and our team having a ballistic shield. We then, uh, began clearing the hallways on the 28th all the way through the 31st floor because we didn't find an active shooter on the 29th floor. Um, going through the hallways, we could smell the gun powder heavily in the air. Uh, we didn't see anybody, uh, in the rooms. We didn't see any, uh, bullet holes or any ballistic markings on the walls that would indicate that there was an active shooter on the 29th. When we got to the 31st floor, we cleared the floor and we ended up meeting up with Levi Hancock who had a couple of officers with him. Uh, we made a quick decision to proceed to the stairwell next to the, uh, the suite for, uh, 130- the 135 area. And, uh, the minute we walked into the stairwell, we met with, uh, or we encountered a couple security guards and two patrol officers. They were stationed on the 31st floor and they advised us that, uh, they had heard automatic gun fire on the 32nd floor. Um, due to that, we walked by them and proceeded up the stairwell to the 32nd floor. Once we got to the 32nd floor, we found out that the door had been, uh, barricaded or locked and it would not open, uh, from the stairwell. We then used a, uh, small pry tool that Levi Hancock had with his tool bag and broke open that door. Also doing that we, uh, we decided that we wanted to break out the

Uh, we then used the ballistic shield to prop open the door and, uh, gain a little bit of, um, eyes on the door to see what we were working with. Uh, at that time, Sergeant Matchko's team, we realized was also working their way down the hallway at the same time that we were opening up the door and there was almost a blue on blue incident because, uh, we hadn't accurately, uh, notified each other of our whereabouts. So we advised Sergeant Matchko and his team to stay where they were at halfway down the hall and, uh, that's when Levi asked for, uh - uh, his - or went to go get his bag and got the, uh, explosive breach out of his bag. So Levi, we backed up into the stairwell while Levi, uh, set up the explosive breach and we set up a, uh, entry team. So the entry team, uh, as far as I know was made up of Levi, Sergeant Bitsko, Dave Newton, uh, Stephen Trzpis, uh, Officer Magsaysay, Matt Donaldson and, uh, Walford. I don't remember his first name. Um, they were - they were designated as the entry team 'cause they had rifles, uh, and that way it was an equal rifle on rifle, uh, entry. I designated myself as a rear guard and downed officer rescue with another officer that

I can't remember his name. Uh, we worked out a plan that hey, once we get up there and do rear guard, if one of them goes down, we're going to immediately evacuate them out of the room and bring them down and evacuate 'em out of the hotel for triage. Uh, once, uh, oh, we also had informa- we also began to get information that he possibly had the room next to him that that room was involved. Uh, I can't remember the room number. Uh, but that was the room where the, uh, room service cart was sitting outside of.

SK: Mm-hm.

EP: So we saw the room service cart and we saw wires going underneath the door. Uh, so that's also why we believed that it could be involved. Uh, we didn't know if he had maybe put explosives on the door. Um, but, uh, the idea was, Levi would, uh, blow the door and see if he responds with gunfire to the explosive breach. Um, if he didn't, then they would enter and we'd proceed with the entry plan. So this was communicated to Sergeant Matchko to advise him that there would be an explosive breach, that we would be entering into the suite upon the explosive breach and for his team to hold. So that way there was no blue, you know, any blue on blue incident, no one got shot. Um, once the explosive breach went off, we waited maybe a second or two where there was no gun fire and they proceeded with the entry plan. So all the officers that were, uh, deemed for entry, they went inside the entry way. Me and another officer moved up and placed ourselves, uh, in front of the second door where the room service cart was in case he decided to double back, uh, and try to take out the team that way. So once they cleared the - once they cleared that

room, they advised that there was a second door leading to the second room and that's where they're going to make entry. EP: So they placed the explosive breach on the, uh, the door inside the Suite 135 going into the other room. Um, when that went off, um, it sounded like there was some gunfire inside the room. SK: Mm-hm.

EP: So I decided to do Russell Road and take the back way into Mandalay Bay.

SK: Okay. And then as you were clearing those - the rooms prior to getting up to the 32nd floor, were you guys -- did you have a master key? Were you kicking doors or in, opening doors or what -- how were you guys doing that?

EP: We didn't - we didn't clear any of the rooms from 28 to 31 unless they were opened and unlocked.

And stayed behind Sean cleared the bathroom. Um, came back out cleared that room. And at that time they were having trouble on the other side of the, ah - on the right side there's another bedroom and the door couldn't be breached and they were trying to kick it but then, ah, he couldn't get through so Levi put another charge on that door and, ah, breached that door. And I remember Sean saying - 'cause none of us had rifle pla- well some of us had rifle plates but he was one of the few officers that had, ah, rifle plates so he and Levi set up on the door. Um, on that bicycle shirt is, um, our LVMPD patches on the shoulders as well, ah, sergeant chevrons on the shoulders. It's a yellow shirt that says 'Metro Police' on the back and it has a cloth badge on the front. Ah, over that shirt I put on my, ah, hard plate carrier. The hard plate carrier, ah, says 'Police' across the front and it also says 'Police' across the back. I also put on a, ah - ah - um, ballistic helmet. The helmet says 'Police' on patches as well as my name on the helmet as well. I also, ah, deployed my AR15 rifle which is a, um, Rock River AR15. With a - an aim point red dot sight and a flashlight on it.

WM: Oh, I also, ah, put my duty belt on my, ah, waist which had all my required gear.

CJ: Okay and on that duty belt, ah, is there a handgun?

WM: Yes, a Glock 17. The Glock 17 has a, ah - a light on it and an extended magazine.

CJ: And then the rest of the equipment is just related to what you would use as a police officer, ah, the rest of the gear that's on your belt?

WM: Correct.

CJ: Okay. All right, um, now what I'd like for you to do is, ah - ah, let's go into this incident and have you start with where - ah, where you were when you got the call what - whether it was dispatched or you self-initiated. And then just walk me through all the way through the incident.

WM: Okay. Um, on that day I was - it was my regular day off. I had got called - I'm on call for vice investigations. I was with my detectives we were getting ready to serve a search warrant over near the Gold Coast Hotel on Gannet Circle. Ah, we were getting ready to make entry. As we were getting ready to make entry I heard - there was a patrol car out there and I heard the, ah - the radio traffic about the active shooter and I could hear the gunfire in the background. There was another sergeant that was on-scene with me, Sergeant, ah, Benjamins was at the search warrant. And based on that I, ah, made the decision that I was gonna go assist with the active shooter. Because I have experience in the military with these situations. So, ah, in that - in my work pickup truck which is vehicle 4903, a plain blue Chevy Silverado I had my gear. I put all my gear on when I was at, ah, the scene of the search warrant.

And then I turned the radio channel over to Convention Center and drove Code 3 to the Mandalay Bay. The reason I could hear the- I could hear that the, um - I could hear that the, ah, people were getting shot at the Route 91 Harvest Festival. Um, and I can hear the chaos going on over there but then I also heard that, um, there were reports of an active shooter on the 29th floor and the 32nd floor of the Mandalay Bay. And that there were also other possible multiple active shooters. So I drove down Flamingo, got on the 15 and headed to Mandalay Bay. I got off on Russell. As I was getting off on Russell I could hear and as I'm pulling into the west valet of Mandalay Bay I could hear, um, reports that a security guard had been shot inside, um, and it was conflicting stories whether it was on the 29th or the 32nd floor. So I had all my gear on. And I saw a patrol car or two in the west valet. I didn't know how ma- if there were any officers or how many officers were there. I saw those two vehicles. So I entered the west valet, um, side of the casino. And, ah, I'm familiar with the Mandalay Bay 'cause I used to work security there. So I proceeded across the casino floor with my AR. Ah, I stopped at the gift shop retained a water 'cause I was thirsty. And then, ah, when I turned the corner into the elevator core I saw a gr- I saw a security guard go by the elevator core. I told him to take me over to the elevator core 'cause I fig- I figured they were pinned out, um, to pre- to prevent anybody from going up. So when I turned the corner there was a group of, um, officers on the elevator getting ready to go up. So I jumped on the, ah - on the elevator with them. It was probably like five or six officers. I just remember, ah, Jacoby Burns was on there. Um, I think Farrah Edge was on there. I think Conover

was on there and a couple other people that I don't know who they are were on there with, ah, a couple of the security guards. Based on the fact that they said it was either the 28th or 29th floor that's where the guy - the security officer been shot I sa- I told him to take us to where the security officer got shot. I believe that we got off on the 28th floor 'cause that's where the initial reports and it was the closer location. So we got off on that floor and we began clearing the floor and we're looking - we're listening for the gunfire. And we didn't hear anything and by the time we got down a couple of the hallways there was no indication of a shooting happening. There was nothing in the hallway, there was no people screaming there was nothing going on. So I figured we were probably on the wrong floor. And then I ask- I think I - I believe I asked another security guard what - I said, "What floor did the security guard get shot? Where is he at?" And they said he - they had already taken him off the property or they already got him out. But it was on the 32nd floor. Sometime in that time I heard another team was in the vicinity, like they were on the 31st or 32nd floor and they were making their way up. So I took the team that I had on the 28th floor. We got in the stairwell and we went up the stairwell to the 32nd floor. So when we got the 32nd floor we did not arrive on the wing - ah, the wing of the hotel where the, ah - the shooting had occurred. We arrived on a different wing, I don't know which one it was. So when we got off we started making our way down one of the wings looking for the gunfire, again, and when we got to the elevator core I could see another group of officers in the suspect's wing. Um, probably about a 1/4 of the way down. And when I got to that point I could see a security guard. Ah, manager was

standing about 20 yards down the hallway and I actually used to work with him. And I saw him and I asked - and he had his gun out and I asked him, you know, "What's - what's going on down there?" So, I gave somebody my rifle because I knew I was gonna have to low crawl down there because they said that the guy had fired a bunch of rounds. Um, through the door down the hallway. And when you looked down hallway you could see the just debris from gunfire what - what apparent gunfire down the hallway. So after I passed off my rifle 'cause I had too much gear. Ah, I also - I was also carrying a green bag that said 'Police'. With all my ammo, I forgot about that. So I low crawled down the hallway to the security guard and asked him, you know that was going on. He said the team is up there and they wasn't a sergeant up there. So I made it up to where the team was at and they were probably about 1/4 of the way down the hall. And I asked 'em what was going on. And that team was comprised of, ah - I think Trzpis - no, no, Trzpis wasn't there. There was a lot of random people there I don't remember exactly who was there at that time.

CJ: That's all right, don't worry about it.

WM: So there's probably - probably about five or six of 'em there and they were on both sides of the hallway. One guy was proned out in the middle of the hallway. I told that guy, "Get the fuck - get to the side because if the guy starts shooting again, um, we don't want to be getting hit." Um, so I pushed them to the sides of the hallway, all of 'em and I told 'em to get into the hotel rooms if they could. One of 'em had already

retrieved the key from the - from the security officer so we had a master key to open the doors. And at that time I could look down the hallway and I could see the food ser- or the, ah, room service cart. And the room service cart was completely out of place. There was just something weird about it and the closer you got you could see that there's wires hanging off the food service cart and it was just arranged in a manner that made me think that it was probably a booby-trap bomb or something. Like that there was gonna be trip wire down there. So I - I guess at that point I was more concerned about the cart than the door. And making sure that no officers crossed over that cart. So since we were 1-4 of the way into the way I had the guys keep proceeding down the hallway so we're bounding down the hallway. Um, and providing cover as we went down the hallway. And as we're doing that, um, we kicked a few doors in and we used the key card to open a few door doors. Um, so we start - we started evacuating rooms. A lot of the rooms had already been empty but some of 'em still had onesies and twosies, civilians just, ah, sheltering in place. So when we found them we were able to, ah, to get them down. Or get them to the elevator core and pass them off to the other officers in the elevator core and send them away. So by the time we got up to about the halfway point of the hallway that's when, um, Levi Hancock and Sean O'Donnell showed up from SWAT. And as I'm listening on the radio there's - there's a million other things going on. There's all the carnage but then there's also reports of other active shooters. And I hadn't heard any gunfire but the security supervisor told me that the security guard just got pulled away so the gunfire here had just happened before I got up there. So now the

concern is is this gonna be a barricade or are we gonna treat this as a - as an active shooter and go in there right now? Third concern is this a bomb on this cart? When we walk by this are we gonna trip wi- trip wire and is everybody gonna die. So Sergeant Bitsko at about that same time came up on the radio and he I think was on the 31st floor and he was making way his down the 31st floor to head toward the stairwell. So him and I are kind of trying to - to coordinate back and forth. Um, what we're gonna do. I knew he was moved down and they had a shield. We didn't have a shield in our group. We had multiple rifles. We're going down the hallway, we're clearing rooms. At about one point, um, that's when Levi and Sean showed up. When they showed up I knew Sergeant Bitsko was th- was down there and I told Levi, I said, "Hey, look, go back to the elevators, go downstairs, meet up with Sergeant Bitsko," - I was like, "I don't want you guys going past the cart, I don't want past the cart. Go back down, walk the floor under and come up the stairwell by the suite so you're past the cart." So Levi took off and Sean O'Donnell stayed with us and covered down on the, ah - on the hallway. At - a couple seconds later two of the SWAT sniper guys showed up. And they proned out in the hallway and were trained on the door. As we kept trying to move up the hallway. And you know, we're - we're - it's - we had to go slow down the hallway because we couldn't expose ourselves for a long time. So we're not getting struck by gunfire coming down the hallway. So they're - they're proned out in the hallway. O'Donnell's got the side and then me and the, ah, other guys are moving forward and we're opening doors and we're getting people out. We get to one room and there's a baby in there and it's by itself. And

the kid is screaming - the - one of the officers picks the baby up, I go in, I grab the baby. I start, I run down the hall with the kid. Um, the mom came out of somewhere, I don't even know where she came from, out of a different room ac- down, she came down the corridor somehow. But what I'm assuming is is when the gunfire originally happened she ducked into a different room, um, to get - to get away from the gunfire and she couldn't get back to her room. So, I ran down the hallway with her. Gave her the baby and had sent her down the elevator with the other officers. A couple of onesies and twosies were still coming out of the rooms and that's causing a lot of confusion trying to get them down. So we're slowly making our progress up towards the, ah - the food service cart. At the same time Sergeant Bitsko was already ma- had already gotten to the, ah - the stairwell with his team. And he was on the radio and you could hear the radio traffic between him and I and he's like, "We're gonna - we're gonna move for- we're at the stairwell," - and I got on the radio, I told him, "Don't go along the stairwell." There was one point in the whole time that I switched channels and I think it went over to Northeast. And I was relaying all the information 'cause I couldn't get across the radio. Um, I was relaying all my information to the Northeast dis- dispatcher. And I told her she needed to go over to the Convention Center and let them know what was going on. Because Lieutenant Huddler was coming on the radio and asking if we had the floor contained. And he wanted to know who was up on the floors 'cause we were trying to come up with a plan as to what we were gonna do as far as making entry. So I told the girl that on the Northeast channel and then I went back to Convention Center and still people talking

And then once Levi got there, ah, we would come up with a plan once they got in place to get him down 'cause now a main concern is is those guys - those - the guys that I'm with don't all have their radios on or can't hear their radios. And they want to come where all of our guns are trained on that doorway. So there's a serious blue on blue issue right there. So I'm trying to prevent these guys from shooting each other the best I can. Um, so Levi gets down there and him and Sergeant Bitsko are talking and they - I don't know if they came across the radio or what we did but we - we - we decided we're gonna make entry. We're gonna put the charge on the door. Once the charge went off on the door we're gonna wait to see if the guy starts shooting at us and we're gonna see what happened. So, I told the guys that I was with I said, "Look, when he blows this door off the fire alarm's gonna go off and maybe the sprinklers. And people are gonna come out of their room," that's - that's like my biggest - I - I didn't know if the guy was gonna start shooting at us but I was like, "Just be prepared for people to come out of the sides," and I don't know if this guy has accomplices in the other rooms that'll come out and shoot us anyway 'cause there's 12 doors probably between us. So I was like, "Look, civilians are gonna come out when this charge goes off. If it looks like an innocent and they're not involved just - you know, we got to grab 'em, we gotta run 'em back to the elevator." So the charge goes off, the fire alarm goes off, everything turns into fuck-pandemonium. People start coming out and we're running 'em out and we get all the

So we waited and, you know, this is a high stress situation so I don't know maybe a minute ballpark. Um, and then they had the shield down there. And Levi and Sergeant Bitsko, ah, we - we decided, okay, they're gonna make entry, we're gonna cover the hallway, we're gonna watch the hallway. Um, so they came up, Levi came up, made entry into the room. O'Donnell left from our position ran down the hallway with Levi. And joined him and then the rest of Sergeant Bitsko's team started to make entry into the room. Our team in the hallway moved - well, moved forward because now we know that the food service cart didn't blow up so that was a plus. So we were to move forward and get down the hallway. And once they got into the room a bottleneck happened because it was probably like six guys trying to get into this room. And I guess when Levi - what - what I surmise is that when Levi made entry into the room with O'Donnell, um, they saw the suspect laying there. They called out that, "Suspect's down," and I had not heard any gunfire at this time. They said, "We have one down, there's a second door." The bottleneck happened at the door so it kind of prevented the rest of us from moving forward so we're - but we're still watching the back of the hall. They go in, they say, "We're gonna blow this other door." Um, as they walk into the room, mind you on the radio there's a million other

If we have to go in there and - and he fires off a couple of rounds at us at least he can't rain down hellfire from that room anymore." So we had to make entry, I mean it really wasn't a question or not. Ah, if we could wait or not. It was exigent. Um, they go in, they put the charge on the second door and that - that probably was about, if I had to guess, 15, 20 seconds after the initial entry. So they put the second charge on the door. Um, they blow the door. As soon as that I hear the second explosion now the fire alarm goes off again and I hear the (unintelligible). I hear the what sound like a burst fire but it was very muffled. So it sounded like two or three rounds went off. And I'm - I'm down there I'm trying to make my way through the room I'm like, okay, I was like, "Did the suspect shoot at us? Did we shoot the suspect, are we in a gunfight, what's going on," and they were all pretty calm. So they all seemed a little bit like embarrassed. And I guess one of - O'Donnell or one of them had a negligent or accidental discharge I don't know what the proper term would be. So they fired off a couple of rounds I don't even know where they went but they're like - the guy 405 and I was - and I was like, "Okay." So, and then they said, "The room's clear." So I said, "Okay, no problem." When they came out of the room I was like, all right, there's a million other active shooters being called out right now. So I grabbed Trzpis, Conover and one guy from Robbery, I don't remember his name. The three of those guys, I said, "Look, you guys are gonna stay here with me. We're gonna

Um, at that point, I don't know if it was right there or a second later, ah - I don't know if I answered the phone first or what happened but - so I go in there. Um, and I could see the suspect laying on the ground and the blood had started to, ah - started to coagulate by his head. So it appears that based on the time I didn't - there - I didn't think it - it - it looked like there's no way that the gunshots that we did from the time frame based on the blood coagulating like they shot him. You know, like when I looked at him I immediately thought to myself this guy has been dead for more than the time we've been in this room. Not a long time but it looked like he killed himself. We need to figure out the rest of these shooters are because we're gonna try to go up on wiretaps on the phones." So he's like, "Go in there, get any phones that you can. Get the phone numbers off of 'em and start figuring it out." So, I'm like, "Look," - I go,

"I get it's - it's exigent circumstances and I'm trying to preserve the crime scene at the same time." And, "You need to start sending it down to us so we can get wiretap - so we can start doing the, ah, PEN's, emergency PEN's on the phone numbers that you re- retrieve." So I found a couple of dropped phones on the counter but they were obviously, you know, throw down phones and not the - the suspect's real phone. And I said, "Look, well I don't know if he has his phone on him, I'm gonna have to move him," and they're like, "Well you gotta move him, you gotta look for the phone, you gotta find it." The blood came out of his mouth when out next to his face. Trzpis checked him for phones. He still had a gun underneath him. I rolled him back he was obviously dead 'cause he had a bullet in his head. So I put him back down, he went back in the same position but now the blood on the side of his face is from me rolling him. Um, he had nothing on him. We later found his real phone and a bunch of the

CJ: Okay.

WM: I mean it's kind of weird to describe but we're moving down the hallway as Sergeant Bitsko is moving underneath us. We're all moving together trying to converge on this room and figure out what we're gonna do, hopefully not to get blown up.

CJ: So just so I'm clear when you - the only time that you hear gunshots is when you're still over at where you were gonna serve the search warrant?

WM: Correct.

CJ: Is that correct.

WM: Yes.

CJ: So once you arrived at the Mandalay Bay you did not hear any other gunshots other than the three or two or three that you heard muffled once you were up on the floor after they'd made entry into the room, is that correct?

Um, I don't necessarily always hear what's going on on every channel but I look for - look for Code Red tones. Um, screaming on the radio. And that's when I heard - I heard an officer screaming, I looked down, I saw that it was on Convention Center. I turned it to, ah, Convention Center so I get all the traffic on it 'cause how scan functions it's just the channel you're on you'll get all traffic and the sporadic other channels. So when I switched over I heard somebody, ah - an officer yelling on the radio something about casualties, something about, ah, shots being fired. Ah, the rest of my - my team was dressed down in their black tee-shirts and - and cargo pa- or BDU pants for dog training. But Dave Newton, ah, who is one of my handlers, officers, ah, was with me

No, I'm sorry, so we got on I- we got on 215 went 215 to I-15, I-15 to Russell. Ah, eastbound on Russell, northbound on Las Vegas Boulevard. As we were going northbound I, ah, was advised that the suspect was firing from an elevated position Mandalay Bay. So that's about the time limit from when it first started where I'm guessing for a start from what I heard, driving time to when they started to figure out the shots weren't coming from the interior of Route 91 but they were coming from, ah, Mandalay Bay at a elevated position. We still didn't know where, what floor. Um, I get - we have K-9 Simplex radios in our car so I can communicate to coordinate searches upon our arrival. I get on the K-9 Simplex radio and I tell Newton, "Don't drive down," because we were gonna drive right underneath it. There was a conglomeration of patrol cars on Las Vegas Boulevard. Initially I did have a concern that there were officers taking a lot of fire there 'cause they were right in the line of fire. Um, we did a U-turn, Officer Newton said, "I'm gonna go in on the Four Seasons," it should all be captured on my body cam. That radio channel is Simplex line of sight so it's not recorded. Um, we enter through, ah, Four Seasons, we go over to the Shark Reef. When I can get on the radio - I start to crisis dress, I throw on my heavy gear, I throw on my helmet. Um, when we - I get on the radio and I say - first thing I said, "I need a couple of officers at

Um, but I have been through SWAT school, operated with the shield numerous occasions. Um, so I - I also deploy the shield which I - I give off to the PD detective. Um, it's better to have it than not. So at that point, yeah, I knew we were going into rifle fire but at the same I - I'd rather carry it and have it. Um, right before we're getting ready to go in two more PD detectives shows up, I don't know who. A female officer, she had a rifle. I'll tell you through my training and experience she appeared to be very overwhelmed. Um, which is why I still even though I had somebody with a rifle on my team kept my rifle. Um, and then another PD detective with me so then at

Um, later in the event and I'll explain that it would have been nice to have a patrol dog with me, however, running through a crowded casino with people running and screaming were gonna elicit bite. Um, also I operated with, ah - with Officer Newton on numerous different occasions so I - I knew his capabilities and I'd rather it be unencumbered by his patrol, ah, K-9. Ah, 'cause I did know actually I was at the Shark Re- Reef that weekend with my family before so I knew how long of a walk it was. Ah, through the casino. So we, ah, you know, pace ourselves. I'm telling citizens to go towards us 'cause I knew there were no gunfire coming from where we were coming from so as we come across citizens we'd tell 'em to go towards us. Um, one of the PD detectives with the shield, and you have to forgive me, I don't know his name. Um, asked an employee where the - the elevators to the, um - the elevators to the hotel, the tower is and he - they told him just straight and to the right. Obviously it was a possibility to - and it was, you know, not the best situation to have him by himself going up. I made that decision. I knew - I knew the decision I was making when I made it. Um, I took my team to the elevators, Officer Murray, ah, a K-9 handler with me had gotten on the radio and advised, ah, Mandalay Bay or to kill the - kill the elevators. So you had to have someone with a card. Ah, tactically was an outstanding decision 'cause if the suspect did get mobile it would be able to inhibit - we can own, I can own the stairways, I - we don't have the resources to own every floor of the elevators. So, um, that decision - if the suspect were to go mobile prevented him from moving. It did create some, ah, you know, difficulties in moving at times. Um, but in my opinion it was worth that to stop the suspect if he was mobile. The information that I was receiving at that time was there was security and a gunfight on the 29th floor with the suspect. And then also there was patrol officers stating that the suspect was possibly on the 32nd floor. As I get on the elevator, um, Sergeant Matchko and his team also get on the elevator. So we're all in - in the elevator. We - we make the decision to go up to the 28th floor. And then take the stairs up. So I don't want to open the

We'll do the next level and then we'll meet you." Um, so we did that. They went up to 32. Ah, we cleared 31, nothing of info on any of those. Other at one point because I'm on the SWAT communicator for the all-call my phone kept fricking ringing. Um, giving up my position. So I did take one of my - one of my people I put him in the leader position, I falled back or fell back

Ah, we tried to pin the doors open at one point we - I tried to use a tactical muzzle that I keep in my pocket. Um, that didn't work. Um, but - so we used a, ah, pry bar to pop open the door. Ah, patrol officer, I think it might be a gang officer that was with - him and Levi popped the door open as I - if I provide cover, um, with my rifle. Once we get the door open directly across from us there's a second, there's a door directly fro- across from us the door faced. Well if that way is north then the door would face west. Um, there's a door and in front of that door is what appears to be a room service cart. On the room service cart on top there's a plate with, I didn't know what it was at the time. Ah, a black - ah, what it turned out to be a camera taped on top of it and that camera was on top of the plate facing back towards the suspect door. Um, I couldn't see at this point underneath the, um, cart but there were wires go- leading to the cart. Um, so I covered on that door 'cause that's obviously suspicious. Um, we start talking and it - and - I can't say how long we were there. I can't say everything we discussed at this point. We're discussing tactics, discussing what's

that cart. Um, there were - there was a lot of debris on the ground outside consistent with rounds flying through the door. Um, down the hallway. Um, and I believe I - I might have peeked the door and actually saw the bullet holes for myself. That lent to me that the suspect was most likely still inside the room. But at this point on the radio I'm getting a, another active shooter at New York New York and an active shooter at Tropicana. Officers yelling on the radio that there's multiple casualties at these locations. You know, I expect phone calls to come in from citizens here. 'Cause you have people walking in injured. But when I heard officers yelling, "There's multiple casualties, multiple casualties," to me that upped my clock of how long we have here. First off it took a while to get up here. This wasn't a normal active shooter where someone's going through a crowd and you go and neutralize 'em. This is a subject in a hardened heightened position. So I knew how long. I was very aware that he was actively killing people. Um, so Levi when with all these others going on he says, "I have a couple charges," um, which to me - you know, charges meaning you can do an explosive breach on a door to make entry. Um, and I - I can't remember the exact wording but he's like, "I'm thinking we hang a charge," um, and see if we can't get a response from the guy. So I'm like, "I'm good with it." Um, I step out. Officer Newton covers the door as Levi hangs the charge. I step out, I cover that secondary door, ah, with my rifle. And I believe it was at this time, I can't be 100% certain if it was at this time or another time. That I reached over and I flipped that plate that had the camera on it so it wasn't aimed at us. 'Cause I knew we're gonna - I felt we were probably gonna make entry and I wanted to give us

every chance. Um, so we - we tuck back in. He then calls Lieutenant Huddler on the phone to get approval for the [REDACTED] which is a entry. Um, and, you know, I think he got approval for tagging the charges prior but I can't - I can't remember. And I'm like, "Hey, we need to let the officers down the hall know. We need to get on the radio and make sure they know. They don't hear an explosion and think we're all dead and start rushing down the hallway." Um, so - so we get on, we let them know that, "Hey, we're gonna - we're gonna breach the door." Um, so we tuck back in, we use the shield to prop the door open. 'Cause if I shut the door the explosion may damage it, it may, whatever, so we use the shield to prop the door open. We step back, um, he calls for the breach. We breach the door, we get a successful breach. Ah, we move forward. Now Levi is low and I'm high. And Levi's seeing how much he can clear we're still behind somewhat cover. Um, we weren't definitely not in a fatal funnel at this point 'cause we weren't out in the hallway. We were - still had the wall as cover. I could see a, ah - ah, what appeared to be an AR platform rifle with a Scope and bipod, ah, directly behind the door. I called that out to Levi, um, as he's clearing what he can clear just form his location. Ah, we move out into the hallway. We get Officer O'Donnell and another SWAT officer I believe and we make entry. Once again my perception is if we didn't make entry we wouldn't know, 'A', if he's still inside. Um, or if he's still gonna kill people. I mean he's be- at this point I'm starting to hear the gravity of this, so. Um, I'm not blind to the fact that there was a chance that there was explosives on that cart. That was one of my main concerns. We make entry. Um, and initially when we made entry or we started I could see that this

wasn't a secondary room that that was a hallway that would lead to that door. So I held on that door 'cause I didn't want a suspect to come behind us. I hear Levi calling for one, meaning, you know, he's - with me, "I need one, I need one." For me that means he needs help in there so I grab somebody I said, "You cover this door." And I fold into the - or move into the room. Um, I end up going left clearing a bedroom and a closet. Um, stepping over numerous weapons, brass, debris both from him shooting a lot of guns, debris from us blowing the door. Um, I could see what appeared to be a blue ventilation system. Um, when I could feel airflow which wasn't natural for that room. I been in the - I've been in that specific - not that specific suite but that type of suite for dignitary protection as a bomb dog handler at Mandalay Bay. So I was - but, one, I didn't think about it before. If I did I probably would have (unintelligible) layout. Um, I was a little stressed at the time before we made entry. Once we went in I remember, "Oh, I been in - I've been in these places." Um, so there was the, ah - um, ventilation system. Which we stepped over, I might have stepped on to be honest with you. I tried to be as careful as at that point though it's still tactical. Um, we clear the bedroom. Ah, O'Donnell opens a door, I clear a closet. We then move out and there's a closed bedroom door, ah; on the east side of the room. And that - the door faces, ah, like the room when you turn the south. And it was closed. I wasn't in a position necessarily where I could see it. I - I'm know- I've learned not to rush in, you know. He'll call me if he needs me at this point. But he ha- if he needed more bodies at that point he'd call more - call for more. Um, he says that he's gonna do secondary breach on that door rather than open and go in.

So good tactical call. Um, I also at this point see the suspect laying supine, his face fa- his feet facing north, um, he's on his back. Um, he has a, what appears to be a devastating gunshot wound to the head. Ah, there's a small silver revolver above his head with blood on it. Everything was consistent to a self-inflicted gunshot wound. Ah, it appeared as though like I said he had taken his own life. Ah, there was not blood rushing out. It - there was - it was a pool of blood which led me to believe it wasn't like he did it as we made entry. I'm guessing it would, you know - I mean I can't - I'm not even gonna say a time. Ah, 'cause I don't have the body experience to say a time but there was not blood rushing out that I saw. Ah, Levi called for a secondary breach or ca- called that he was breaching. He breached that door again, he said it on the radio so we didn't have people rushing in thinking that, you know, we had just got blown up which was still a concern of mine that we were gonna get blown up because I knew through my training and experience that these types of tactics he booby-traps it as well. Um, went in cleared the bedroom and at that point we're done. We, ah - there was - you know, there was no other suspects inside. There - I believe the SWAT commander asked, "Hey, can you get the guy's wallet and identify him," which we needed to identify if this was our guy, if that's who the room's registered to, and all that. So we did. Ah, we also, in the bedroom there was a folder we opened and found checks, that's how we got the female's name and the address. Um, minimal, we just were going for Intel. That could save people's lives. Once we had it, okay, we backed out. Um, I - other things I saw in the room there was - there was cards. I don't think the wallet was on the suspect. I think the wallet

JB: No, so - well first off, so when we are there I take Officer Donaldson, um, and I put him behind us to cover high. 'Cause once again I didn't want someone coming down from higher back on our back. Um, same thing I'm just trying to - as much command and control of it as I can keep in such a dynamic and rapidly evolving situation, um, I - once Levi was there I knew that he could handle more tactical and I could back off a little bit from tactical 'cause I have tactical experience but - and when - when it was just me and the PD guys and my guy I had to dictate tactics. Once Levi was there and I've worked with Levi for years and years. I been to SWAT school with Levi so I knew he can manage tactics while I can now kind of back off and - and start being a little more, "Hey, I need a patrol guy here. We don't need so many people at the stairwell with us. We need the," and work that. Um, as far as the door somebody said - oh, it was - it was screwed shut by security. I don't remember seeing. I remember why won't this open? It's the only one I came across that wouldn't open when we were going. So that's - I made the - I jumped to the conclusion that the suspect did that to maybe slow our, ah, approach. Um, so someone had a handheld and they just they pried it and pulled it open. But I can't speak to - I - I think I remember something up high with two screws but I - I can't speak to it.

JB: Hundred- I saw the wires. I will tell you when we made that decision to move forward it was one of those we had to. Um, I worked a bomb dog for years. I - I like to think I know a det cord and other things look and these were extension cords. Um, I made

JB: Yes, in fact at one point when we, ah - before we move I tell Levi, "Hey, we need to get on the radio and let the officers at the end of the hall know to move back." Because I didn't want a crossfire situation. I didn't want guns aimed at us when we moved and then when I did move out to cover that, ah - the - the door and move the camera I could see the officers at the end of the hall. But we were in communication with them. At one point comms were so bad another officer said, "I'll call Matchko and let him know," and that officer called Sergeant Matchko on the phone and advised him what the plan was so he knew. Because, ah, we just it - I was getting either a double beep from my radio, meaning it wasn't transmitting. Or I was, ah - couldn't co- I couldn't get on because people were talking about, you know, people shot and down and hurt and moving people. You know, to me and this is just more of a - I know people are out there dying but, you know, we need to stop it. Can't stop plugging the - plugging the dam without stopping the - you know, stopping the water first so.

TR: I do, I just had a point of clarification. You said that Levi told you that he had a couple of charges. And he made a call to the lieutenant. Did the lieutenant actually make the call to use the charges or did you make that call?

JB: Well, it wasn't like he - he gave the plan, I said, "Okay." But we can't use explosive breaching without the SWAT commander's approval.

TR: Okay.

But I didn't know that which is part of my mindset as to why we had to go in when we did.
