The following is the transcription of a tape-recorded interview conducted by Detective JT Rhoden, P# 2958, LVMPD Fort Worth Police Department on 10/03/17 at 1422 hours.

Det. Rhoden: This is Detective JT Rhoden, R-H-O-D-E-N, ID#2958, with Fort Worth Police Department. It's the third day of October 2017. It's approximately 2:22 pm. I am with Detective John W. Galloway, ID#3298 and we are at [REDACTED] and it's Avenue, correct?

C. Betzler: Yes.

Det. Rhoden: [REDACTED] and I'm speaking with Carly. Now Carly, you're, is it C-A-R-L-Y?

C. Betzler: R-L-Y. Yes.

Det. Rhoden: Okay. So C-A-R-L-Y. And your last name, Carly?

Det. Rhoden: Okay. And Emma is uh, uh, the Officers at TCU had a idea who Emma was, but they weren't, is last name Simon?

C. Betzler: Yeah.

Det. Rhoden: Okay. So they had kinda figured out who Emma was. Um, so did you actually go, you said you met your mom in Las Vegas. You didn't go to California and then come?

C. Betzler: Well, it was all 3 days. So Friday, Saturday, Sunday.

Det. Rhoden: Oh, was it a 3 day? I'm sorry. I've never been so I don't-

C. Betzler: Yeah.

Det. Rhoden: Know. Okay.

C. Betzler: Um, so we flew in um, Thursday night. I flew in and she flew in like a few hours after me.

Det. Rhoden: She? You mean Emma?

C. Betzler: Emma. Yeah.

C. Betzler: Uh huh. And then so we, my mom and I and Emma, we went to the concert Friday and Saturday and then Sunday.

C. Betzler: Towards the hm, I would say towards the airport. I'm not like positive. I don't know like the geography, but um, it's like the stage is facing perpendicular to Las Vegas Blvd. So like if you're facing-

C. Betzler: The stage and you look to the right you see Mandalay Bay and um, the Luxor.

Det. Rhoden: Okay. Okay.

C. Betzler: To the side. Yeah.

Det. Rhoden: That makes perfect sense to me. Okay. So the stage is perpendicular to the Las Vegas Blvd.

C. Betzler: Mhm.

Det. Rhoden: And if you're looking at it to your right is Luxor and-

C. Betzler: The hotels.

Det. Rhoden: Mandalay Bay and such is that.

C. Betzler: Yes.

Det. Rhoden: So where are you at when everything starts to kinda happen?

C. Betzler: So we, Emma and I were standing like middle of the stage, about like 20 people back during the concert.

C. Betzler: And so she, we had been there for the previous set and during the break and we're standing there. And like I don't know how many songs into Jason Aldean it was that like, the person who was singing when it happened, but she turns to me and she's like, "I, I need to go to the bathroom." And I was like, "Really?" Like, "Right in the middle of a concert you're gonna make us walk to the bathroom?" Like, "Come on. Can't you wait?" And she's like, "No, I can't wait." And so we turn and we start walking like so back to the stage and then to the right. So away from-

Det. Rhoden: So kind of you're walking away from the stage and to your right which is-

Det. Rhoden: Moving you away from, kinda towards the airport and away from the boulevard?

C. Betzler: The, yes. Yes.

Det. Rhoden: Okay.

C. Betzler: And so we're and then we randomly pass my mom. And we're like, "Oh, hey." And I was like, "Oh, Emma has to go to the bathroom." Like so annoying. And then literally 5 steps after we pass her, like we hear the gunshots start. And I literally just grabbed Emma and we just ran and like right there towards the right side there by where the bathrooms were, there was an exit. And so we just like ran out of there and as we were running like I felt something hit my foot and I was like, "Emma. My foot! My foot! I can't run." And then she was like, "I know. My leg. Like just keep running." And so we ran out that exit and like I don't even know how far. Like we were just in a crowd going wherever we could and like we couldn't like know which way the gunfire was coming from or like if they were in the concert or like if we were running towards them. And so we just like ran perpendicular to the Las Vegas Blvd. Like just away. Like down past like a Motel 6. We were in the Motel 6 for a little bit and then ran across the street and then made our way like back to MGM. Like through the parking garage between like the cement wall and cars. Like running through there.

C. Betzler: And then like into the, but at that point like MGM had been like nobody in, nobody out.

Det. Rhoden: Mhm.

C. Betzler: But like I think the way we went in like through the parking garage, we had to go underground and then come back in so like we got in. And then just ran back to our hotel room.

Det. Rhoden: Okay. So and you gave me a lot of information right there and I just wanna walk back through it real slow and make sure I-

C. Betzler: I would say like the houses across the street.

Det. Rhoden: Okay. So you were probably, you know, 50-60 feet from 'em?

C. Betzler: Mhm.

Det. Rhoden: Something like that?

C. Betzler: Yeah.

Det. Rhoden: Okay. So you're headed towards the bathrooms and the bathrooms, I guess, the back, what were they? Like porta-potties?

C. Betzler: Yeah.

C. Betzler: Mhm.

Det. Rhoden: Were the backs of the porta-potties facing the boulevard?

C. Betzler: Yes.

Det. Rhoden: And the doors were facing inside the, the area?

C. Betzler: Yeah, but it's like 2 rows. So like the doors of the porta-potties face each other, but like this row, the backs face the boulevard.

Det. Rhoden: Okay. Well, now. Well, now hold on. Let me back up just a second. That's why I asked this question. When you say you turned, you were watching the concert. Emma says she's gotta go to the bathroom. You turn your back to the stage and you're walking-

C. Betzler: Away from Las Vegas Blvd.

Det. Rhoden: Right.

C. Betzler: Yeah.

Det. Rhoden: So the, so the, but so the bathrooms were on the opposite side-

C. Betzler: Yeah.

Det. Rhoden: From the boulevard? Okay. So the exit that you went out didn't go back to the boulevard-

C. Betzler: No.

Det. Rhoden: It went out behind the-

C. Betzler: A different, I'm, a different boulevard I guess is what I'm saying.

C. Betzler: Yeah.

Det. Rhoden: Okay. That-

Det. Rhoden: You just hear gunfire?

C. Betzler: We all thought it was like someone in the venue just like spinning in circles just like shooting.

Det. Rhoden: Okay.

C. Betzler: So-

Det. Rhoden: Well, let me ask you this question. Um, have you ever fired a gun?

C. Betzler: Yeah.

Det. Rhoden: Shot a gun? Anything like that?

C. Betzler: Mhm.

Det. Rhoden: Okay. So you kinda know what a, how loud a gun is and things-

C. Betzler: Yeah.

Det. Rhoden: Of that nature. So it sounded pretty loud? You thought it was pretty close by?

C. Betzler: Yeah. I mean-

C. Betzler: Like my dad's retired from the Sheriff's Department and so like we like when, 'cause a lot of people thought like it was um, like fireworks or like part of the show-

C. Betzler: Yes.

Det. Rhoden: So it was real rapid fire?

C. Betzler: Rapid.

Det. Rhoden: Rapid succession?

C. Betzler: Yeah.

Det. Rhoden: Just a guess. How long do you think from the time you realized that shots were going off until the last one?

C. Betzler: I mean, like-

Det. Rhoden: And I know that time it's like 30 minutes seems like 10 seconds-

C. Betzler: Right.

Det. Rhoden: Or 10 seconds seems like 30 minutes-

C. Betzler: Right.

Det. Rhoden: So I know it's hard to say-

Det. Rhoden: But was-

C. Betzler: We had-

Det. Rhoden: Was he still shooting when you made it back to the MGM? Were you-

C. Betzler: Not to the MGM.

Det. Rhoden: Okay.

C. Betzler: But he was still shooting like we had gone two blocks away from the strip and then one block towards MGM. So like that amount of time, I mean, I would guess like I have no idea.

Det. Rhoden: It, the, that you said you made it about two blocks away and that's moving with a big crowd of people-

C. Betzler: Right.

Det. Rhoden: So you're not running full speed flat out.

C. Betzler: No.

Det. Rhoden: You're having to fight your way through the crowd.

C. Betzler: Yeah.

Det. Rhoden: So you got two blocks-

C. Betzler: And that's like us getting through fences 'cause that whole venue was like-

Det. Rhoden: Sure.

C. Betzler: Blocked off so people pushing through fences, push, people pushing through like that Motel there 'cause it was like where it's like a two-story motel, but it's outside. You know? Like it's not a closed hotel where you go in through a door. Like-

Det. Rhoden: Mhm.

C. Betzler: The doors are outside and so everyone's running through there to try to like make sure they're covered and so it's like stopped in there. And then like getting across the street too, cars are just like everyone's honking. Everyone's just trying to get away. So if I had to guess though, I would say like between 5 and 10 minutes.

Det. Rhoden: So and I'm not even gonna ask you how many shots you think might've been fired-

- Det. Rhoden: Boom, boom, boom, boom, boom for the most part?
- C. Betzler: Yeah, for the, and constantly.
- Det. Rhoden: Okay.
- C. Betzler: Like the whole time we were running like that I, if there were breaks like it was maybe a few seconds.
- Det. Rhoden: Okay.
- C. Betzler: Like it was, it was never like, like a period of time where like there was a break and then like you heard it again. Like we just-
- Det. Rhoden: Okay. So now I know that you and Emma went together to the concert and your mom was there. Any other friends or anybody?
- C. Betzler: My mom was with her fiancé.
- Det. Rhoden: Okay. So now are they running with y'all?
- C. Betzler: No.
- Det. Rhoden: Headed back to the-
- C. Betzler: No.
- Det. Rhoden: Okay. So you and Emma make it two blocks away from, going away from Las Vegas Blvd-

Det. Rhoden: Okay. And then you made your way back to the MGM. You were able to get into the parking garage.

C. Betzler: Mhm.

Det. Rhoden: And then go in and back up to your room.

C. Betzler: We went up, we went, we saw the parking garage and went up and floor and then like from there ran towards the hotel and then like the way MGM's set up like we had to go through the MGM Hotel-

C. Betzler: To get to like the Signature like-

Det. Rhoden: Right.

C. Betzler: Condos.

Det. Rhoden: Okay. Now you'd, the way you described it earlier, you were running and you felt the pain in your foot.

Det. Rhoden: Okay. So you were still inside where the actual concert was taking place?

Det. Rhoden: Okay. And that's perfectly normally. Alright. Um, so when you got back to the hotel room, it's you and Emma in, in your room?

C. Betzler: Mhm.

Det. Rhoden: Okay. Um, what was the first thing that you did once you got back to the room?

C. Betzler: Well, we got back and my mom and her fiancé were there so were there, 'cause they were behind us.

C. Betzler: And so like we, I, I couldn't get ahold of them while we were running and so like first we saw them and we were like, "Oh my gosh. Like what happened?" And then they had brought back another girl who like got separated from her group. So they just grabbed her while we were running and like brought her back to our hotel room and then I took off my boot and like I, at that point I was like so much adrenaline. I was like, "Oh my gosh." And so I took off my boot and like my whole sock was like soaked in blood and so then we just sat down and like my mom's fiancé like gave us ice and water and like we all just like sat there and cried. Like-

Det. Rhoden: Okay. Um, what, let's talk about your boot for a second. Did you see a hole in it when you first started looking-

Det. Rhoden: Where was the hole at in your boot? Was it in the top? Was it in the side?

C. Betzler: In the sole.

Det. Rhoden: Okay. Um, what did you do with that boot? Do you still have it or is-

C. Betzler: Yeah.

Det. Rhoden: Okay. Um, now I know you didn't seek medical treatment there.

Det. Rhoden: But could you see what kind of injury, what, describe the injury on your foot for me?

C. Betzler: Um, it's like the bottom of my toe is like a gash like-

C. Betzler: And so it's like, it was like split open and then like 'cause when I took off my sock, all my toes were bloody, but it, and then I like rinsed it off and it was just that. And it was just like that toe had split open.

Det. Rhoden: Shrapnel, basically, that you had found. Was that actually removed from your foot or was it something that you found in your boot or in your sock?

C. Betzler: In my boot. Like, like in my boot under my s-, like between my sock and my boot.

Det. Rhoden: Okay. So it was, so they didn't actually, that's not something that they actually removed out of your body?

C. Betzler: No.

Det. Rhoden: That's something that you found in your boot?

C. Betzler: Yes.

Det. Rhoden: Okay. So you're there in the room, take a breath, realize I have to check on my foot.

C. Betzler: Mhm.

Det. Rhoden: Because I have this pain. You pull your boot off. You see all the blood.

C. Betzler: Mhm.

Det. Rhoden: At what point did you find that little piece of metal?

C. Betzler: Um, I didn't. Just like I just sat on the couch and then my mom's fiancé, Justin, grabbed my boot and he like was looking at it and looking at the hole in the bottom and then like-

On Oct 1st I attended the Route 91 Harvest Festival we arrived at 3pm. My boyfriend, my aunt, uncle and I. We were standing on the left side at the end of the stage that went into the crowd. At 6:40 my boyfriend and uncle went to the Nashville stage for another concert and they stayed back on the left by the budweiser truck. At 10:07, I took a video for 15 seconds. 3 minutes later I heard pop pop pop - I turned to my aunt and said it sounded like gunshots. People around us said it was confetti popping so I went back to watching. He started the next song and that's when the pops sounded like a machine gun. We immediately dropped to the ground. We heard the music stop. It seemed to last forever. When the first round stopped we decided to run. We thought the shooter was in the festival. We huddled for a few seconds with another group off to our left then ran for the malibu rum house. At this point I lost a flip flop. We ran through there and filtered into a large crowd making their way an exit. I think now it was Exit 6. We got out and ran behind an open rear door with two men.

we hid there till this round stopped. We ran through a parking lot (gravel) I lost my shoe, and my cell phone. Somewhere around there, we asked for rides but no one would take us. We reached a cement fence and a wire fence. Where we were trapped. My aunt started to climb, but was having trouble. A man pulled her down and told her not to climb. The shooting started again. We dove down into the dirt/gravel by the fence. She then yelled I have been hit. I could see her face bleeding down one side. When the round stopped we found a hole in the fence and climbed through.

We then saw a door open and people going in - I believe it was ~~Buckyard~~ offices and Route 91 office. We hid there for 5 hrs. Getting reports of multiple shooters and other hotels. We went into lock down again maybe an hour into it because of reports of a shooter at Hooker hotel. There were Emt and off Duty cops that were able to have contact with LVPD. We left around 4am and walked back to our hotel. We flew home the next morning.

I am horribly traumatized. Can't leave the house, hear loud sounds, be in crowds. And haven't been able to return to work.

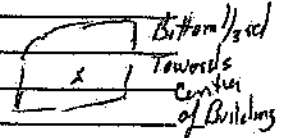

As the sound of the firecrackers continued to go off, I looked to my right and observed a group of people looking towards the floor and at an individual who I believed to have fallen. I continued to watch the performance when the sound of firecrackers continued to get faster. At that point, I observed Jason Aldean run off the stage and out of view. Once the music had stopped, I determined the sound of the firecrackers to be actual gunshots. Since I heard the gun shots coming from my right, I believed the shooter was on the west side of the venue. In order to take some course of action, I ran in a south westerly direction in an attempt to get to the west side of the venue. Once I reached the west side of the venue and hid behind cover, I contacted an on duty Las Vegas Metro police officer, Officer Tran. I advised Officer Tran who I was and advised him that I would assist in any way. While on the west side, the sounds of gun shots were louder and were not stopping. Since I did not see a shooter in the immediate location, I looked up towards the Mandalay Bay Hotel and I observed what I believed to be muzzle flashes coming from an elevated location. I advised Officer Tran of what I observed as he began to put information out on the radio. Once the shooting had stopped, I attempted to help as many people as I could. I was able to assist few individuals who were injured but most parties that I came into contact had succumbed to their injuries. I assisted with carrying bodies out of the venue and with looking for anybody who might still be inside the venue hurt. I remained at the venue until all personnel were gone.

[REDACTED] and I ran to E. Reno Ave. and Duke Ellington Way, where I was able to get supplies from ambulances to better wrap [REDACTED] wound and assist others around me. Hours after the incident, we were finally transported by an empty Metro Bus to Sunrise Hospital. Sunrise Hospital was quickly filled with critically injured patients. 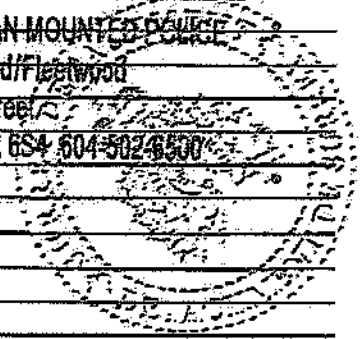

We heard rapid fire with no idea of how many shooters there were, unable to determine where the shots were coming from, seeing people running to exit. Hearing people yell for medics. We stayed down covering our selfs with our chairs so that we would not get stepped on. More shots fired the person behind us had been hit. I heard them needing something to stop the bleeding and giving out vitals.. There was a lady in front of us the said she had gotten shot. We asked her to lay down come closer so we could check her. Jennifer couldn't see that she was badly injured and the shots started again. The shots this time sounded different and we thought they were getting closer. Putting our heads down and lying still and quite we waited until the shots stopped. The lady we had checked was no longer next to us and the person they were treating behind me was gone as well. During the shootings we had people ask if we needed medical and if we were ok. We had checked our selfs preidically to make sure we had not been shot and had made the decision to stay put until we felt it was safe to flee. After the shots had subsided for abot 3-5 mintues the 3 of us felt it was time to try and exit. Keeping low and together we made our way through debri, chairs through the open area. Passing people who were being attended to by the Budlight cooler, stepping over broken glass from the bar area, money all over the ground and more injured people with security telling us to exit this why and to head to the Tropicana Hotel.

morning after taking a cab to Circus Circus. and much confusion on were to go and how to get off the strip.

At this point the crowd was are this was not fireworks and people were starting to take cover anywhere possible as well as run for any exits Michael Vestuto pushed me to the ground to my stomach and told me to get down and cover my head. Michael Vestuto then said when I say run, you run. He said we will wait for the Police to return fire then we run. All the while we were thinking someone was in the festival shooting not realizing the bullets were being rained down on us. I could hear the bullets hitting the ground all around us people screaming and watching people drop to the ground like flies. We could hear the spray of bullets getting closer to us. At this time it was a constant spray of bullets for approximately 2-3 minutes. Michael then stated it was time to run.

My uncle and aunt told us not to run and play "possum" Michael Vestuto stated this was not the movies and we are not going to lay here being picked off one by one. Michael Vestuto grabbed my arm and said when I say run you run and don't let go. We thought my family would follow, when we didn't hear the bullets that close to us Michael said "run now " At this point I was hysterical and was merely a rag doll being drug behind. I do not recall where we ran to for an exit as I was looking all around people running for their lives, at one point I saw a gentlemen shot on the abdomen hunched over trying to run. Michael and I ran to a fence we noticed a gentleman struggling to push over a freezer to hop over the fence. Michael pushed the freezer over and threw me over and I landed on my back landing on another patron. Michael Vestuto helpped a few other women over the fence while, and then he emerged over the fence. At this point my asthma was full blown and I could barely breathe and did not know where we were, we saw Hooters and tried to run in, however people were running out of the building at the same time so we did not feel safe in there either. I then saw Michael run into the road until a white pickup truck stopped. Michael informed them of what had transpired and they offered to take us to safety. About 15 other patrons hopped in the bed of the truck and we all drove off. The driver took us to a Del Taco located at Tropicana and Maryland, I went into the bathroom and there were other patrons there too crying and praying. We held hand and prayed. Michael Vestuto was finally able to reach my family and confirm they were all safe. My asthma was so bad I recall passing out not being able to breathe. I do not know how long I passed out for, but when I woke I was informed my uncle John was on his way to get us all. My unice John Ortiz lives in Summerlin and heard about it on Twitter before any news station on TV was picking it up. We all finally arrived back him about 1:30am.

My husband and 2 friend an I were staying on the 32nd floor of the Mandalay Bay 9/29-10/1. Our room number was 32-335. I did see a suspicious man on Saturday night and reported that to the FBI. The man was not Stephen Paddock. We were on stage front, right side (closest to Mandalay Bay) when the shooting started. We initially heard about 6 gunshots but dismissed them as fire works. Less than a minute later, rapid fire erupted and people all around us were getting shot and falling to the ground. We couldn't tell where it was coming from as it felt and sounded like it was coming from all directions. We dropped to the ground. We decided we needed to run but didn't know where we should go. We headed left toward center stage. Shots kept firing. We dropped down everytime. People were falling on top of us. We kept running, tripping over bodies and made it to the bar behind the sound booth. We flipped tables to try to protect ourselves from the bullets and shrapnel. A bullet grazed my left leg. My friend was hit in his legs and feet with shrapnel. We stood up to run again and a woman in a black shirt right behind me was shot and fell into me - both of us falling to the ground. Someone rolled her off me and we ran to the dumpsters left of the stage and near the back. When the gunfire finally stopped, we ran to an airport hangar and were eventually transported to a cell phone lot.

The people working at Xterious Escape locked the doors. We stayed in there for hours with about 15 other people. Some people who were at the concert and some who were doing the escape room. Around 1am the police gave us the okay to walk to the MGM. We stayed with a stranger named Alex on the 7th floor of the MGM until I found my parents and sister.

I began banging on Ashley's door to get out someone is shooting. The sound of a few shots quickly became like a machine gun as Ashley ran out of the bathroom. Heather was holding Ashley's hand and Ashley was holding mine. We ran to the nearest exit but only they made it out before I got caught by the hundreds of people running out of the same gate. I was getting squashed against the gate by many people trying to get out. Ash still had a hold of my hand and her and Heather pulled on it until they got me out. We then continued to run towards the back of Tropicana Hotel. As we ran a guy running next to us got shot on his leg. People were dropping from the gates to our left and some were getting trampled when they fell on the floor. We continued to run past a church and then into an open door at the Tropicana. We pushed our way into an elevator / service elevator I believe and began climbing the ladders on the side of the building for the roof. I think we went up

We got together with them and decided to walk down into the kitchen and find a better hiding place. We then hid in a food storage hallway using a large metal freezer to block us in. We remained there until a Security Guard came looking for people to bring us to a big room where sweat was. They had cleared our building and brought everyone to the pavilion with about 2000 people and provided us with water and towels. My left arm was bleeding from cuts and I had a large bump on my arm from being pinned on the gate.

On Sunday, October 1, 2017 at approximately 10:05 PM I was at the Route 91 Harvest Festival with my Fiance Courtney Anne Ortiz, her Uncle Daniel Mitchell, Aunt Melinda Ortiz, and Cousin Kate Chamberlian. We were located center stage near the center bar area which was approximately 40 yards from the main stage. Within approximately 15-30 seconds of Jason Aldeans second or third song played there was a repeated continued sound in the distance which sounded like fireworks cracking from a far. The crowd seemed hesitant but there was not any panic within the area I was located. Jason Aldean continued to play his song for about 30 seconds when all of a sudden he left the stage to the far right as I was facing the stage. The apparent firework sounds stopped and the all the lights at and around the stage went dark making visibility difficult. There were no "firework" sounds at this time when the lights were out. At this point the crowd near me were hesitant and appeared confused to why the performance ceased and the lights went out. Within 30 seconds of the lights going out there large bright lights above the stage which came on and faced the crowd. It was my opinion these came on as a sign the show was over and for people to find the exits. Within 15-30 seconds of the bright lights coming on the "firework" sound came back louder and in a heavier continued fashion. At this point the crowd was aware this was not fireworks and many people took cover to the ground while others ran to the exit areas all around the venue. At this point I was in a kneeling position while everyone around me was down on their stomachs on the ground. I was surveying the crowd and trying to assess where the sound was coming from so I can determine how to proceed. I told the people around me to listen for single shot gunfire as that will more than likely be Police officers engaging with whomever was shooting. There was no return single shot gunfire and the bullets were getting closer to my location. It sounded as if someone was inside the venue and was on the other side of the bar area we were at and shooting.

The gunfire was getting closer to us at the center bar area as I could hear bottles breaking and sounds of metal pinging debris from the bar. It was in my opinion a person was inside the venue with a gun and walking from the West side of the venue to the right and getting closer to the center area I was located. At no time did I feel the gunfire was coming from any other area besides inside the venue. As the bullets were getting closer and continuing non-stop which seemed to be like 2-3 minutes at this point I told my Fiance and her family we have to get out of here. The people surrounding my area said we need to stay put and play dead. I told my Fiance and her family this is not the movies and we can not lay here in the hopes someone is not going to come by and shoot us one by one. At his time I grabbed my Fiance arm and said when I say run you follow me and dont let go. I thought her family would also follow us. When I no longer felt the bullets were coming directly at us I said lets go and ran for the East side fence behind the food vendors area. My Fiance Courtney Ortiz fell a couple times and I had to stop to pick her up and make sure she could keep running. It was at this time while picking up Courtney that I noticed her family was not behind us. I had to keep running and get Courtney out of this situation. She was having difficulties breathing and was in a panic. I ran pulling her arm with me toward the East Fence line. I noticed a guy struggling to push a Refrigerator/Freezer against the East fence in order to use as a step stool to get over the fence. I told the gentleman to let me get it and I was able to flip it over and slide it against the fence line. At that point the gentleman jumped on top and went over the fence. I helped my Fiance onto the Freezer and tossed her over the fence so she would not get caught in the top exposed pieces. She landed on a gentleman with her back who broke her fall and kept her from having a more serious fall had she hit the pavement directly with her back first. I helped a few other women over the fence by lifting them up by their waste to get over. I then pulled myself over the fence and noticed I was in a side road unfamiliar to me but was near large parking lots. Courtney Ortiz and I ran through the parking lots and on the West Side of the Hooters Hotel and Casino. I told Courtney lets go inside Hooters as we will be safer indoors. When we headed in the front entrance of Hooters I noticed a large amount of people vacating the entry of Hooters as if they were evacuating the building. At the time I ran with my Fiance to Tropicana in front of Hooters with the intent of stopping a cab for a ride. I stood in the road until a White pickup truck stopped in front of me to avoid hitting me. I went to the Driver side window and told the Driver what was going on at the Festival and asked him to bring us down the road a few miles to safety in which he said yes. There were approximately 6 people inside the truck and about 15 people who jumped into the bed of the truck also looking for help. At this point the Driver took us to Maryland and Tropicana and I said he can drop us off here as this was plenty far. Once we go to the parking lot we went inside Del Taco which was on the corner so Courtney Ortiz could use the bathroom and try to pull herself together. I was making every attempt to get ahold of Courtney aunt, uncle and cousin to see they were safe. The cell service was terrible and it took approximatley 10 minutes before I ended up making contact with Daniel Mitchell to ensure they were safe. Daniel Mitchell took a ride to our location on the corner of Maryland and Tropicana the same way I did with someone else giving him a ride. Once they arrived we were picked up by Courtney Ortiz uncle John Ortiz who lives in Summerlin and heard about the shooting event on Twitter. We ended up making it back home at about 1:30 am

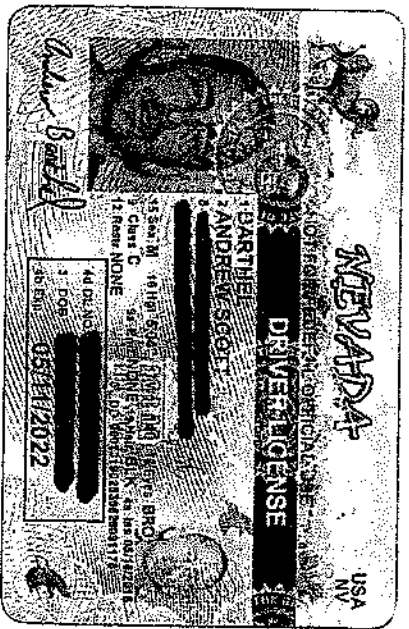
