## 5. Risks

Alert and its partners will regularly identify and assess context, programmatic and institutional risks. Risk management strategies will be agreed at the programme inception and regularly reviewed include with programme and context developments. Here, we explain the risk management process. As part of the Inception process, Alert and partners will assess risks at country (national, subnational and in project locations) and regional levels, and evaluation their livelihood and the severity of impact. This framework will be reviewed as part of bi-monthly refection workshops and as part of the formal quarterly reporting process. The programme's M&E framework will also track development in risk.

## Risk assessment process:

- 1. Identify all the potential risks to the project
- 2. Assess the likelihood of the risk occurring on a scale of 1-5 (1 being unlikely, 5 being almost certain)
- 3. Assess the impact that the risk would have to the project, personnel, reputation or other assets if it occurred on a scale of 1-5 (1 being negligible impact, 5 being catastrophic)
- 4. Multiply the risk likelihood score by the risk impact score to get an overall numerical value between 5 and 25.
- 5. The highest scoring risks should be prioritized in the risk mitigation strategy
- 6. Develop a risk treatment strategy for each of the identified risks based on the following options: avoid, reduce, accept, transfer,
- 7. Reassess the likelihood and impact following the risk treatment strategy and decide on whether to reduce or accept the residual risk. Risk owner should be identified for each risk
- 8. The level of risk on a project will be tracked, monitored and reported throughout the project lifecycle.
