

The US Administration’s Biowarfare programs are illegal. They are also dangerous to the survival of the human species Skull and Bones and the Rockefellers have controlled those programs and staffed them, like they did the CIA. In my review of the lab in about 1990, I took a hundred research papers produced by the US Army’s Biowarfare Lab at Fort Detrick and analyzed them for;

- 1) Did the research make the US citizens safer or more at risk from BioWarfare?
- 2) Was the research conducted in such a way that its results were scientifically valid?
- 3) Was the research ethical, i.e. did the risks of not doing it outweigh the risks of doing it?
- 4) Did the results of the research, where scientifically valid, affect US policies correctly to preserve the security of the US and world’s populations?
- 5) Was the research cost effective in protecting the US population from BioWarfare?




So, I was in a position to judge whether the research made sense in terms of protecting the public and whether the results were analyzed incorrectly and thus

could not reach scientifically valid conclusions. In about 40% of the studies, it was clear from simple mathematical tests that the data in the studies was falsified. Let me explain that by way of a story example so that you understand how I could conclude that with certainty.


During WWII in Europe there was rationing of scarce food. A man felt that his baker was cheating by making loaves of bread which were sold as 1 kilo loaves. He wanted to catch the baker at it so he weighed each loaf he bought when he got it home. Each loaf the baker sold him was indeed over 1 kilo in weight. But he still reported the baker to the police and had him arrested because he knew the baker



was cheating. He knew that because the graph of the weights. If the baker had sold loaves which averaged 1 kilo, there would be a distribution of weights which looked about like a bell shaped curve.



If the baker suspected that the buyer was checking the weights he could just hand him one of the loaves over 1 kilo that he set aside for him in advance. The distributions of weights that the man bought would then look like half of a bell curve.



But if the baker's average weight of loaves was significantly less than one kilo, say 900 grams on average, than that critical buyer's weighed loaves distribution looks like a tail of a bell curve, not half of one with a rounded curve at the top.

When researchers make data up, they like the baker do not think about it needing to fit into a natural mathematical distribution. So, it was very easy for me to quickly prove based on mathematics that at least 40% of the studies were so flawed by the researchers making up data as to be worthless science. Since there was no peer review of their work by outside scientist they were used to getting away with making up their results.

That meant that critical studies to show the lab was doing the research safely were mostly nothing more than wishful thinking. Because I had researched the number of times that the lab had had a dangerous germ escape from their control, I was not at all pleased. There was no question in my mind that the research was being done in an unsafe fashion. That risked infection of the US population with deadly diseases.

That was not just a theoretical problem; there had been dozens of incidents in which dangerous weaponized germs had escaped from US Biowarfare Labs. Although Fort Detrick is the best known of them, there are several others as well. In one such incident in about 1994, a weaponized influenza virus escaped from a Biowarfare lab in the South and spread across 3 States before it was contained and controlled using a vaccine. In another case, the US govt. was about to firebomb a Biowarfare Lab and the town of 20,000 people that its workers lived in because of an escaped germ. Then it found another way to control the germ. But it was an exceedingly close call. In my report to Tenet I listed over 2 dozen such serious incidents in which US citizens had lost their lives due to US created BioWarfare germs. The total number of US citizens who had lost their lives in those US caused Biowarfare accidents exceeded 30,000.

They were hidden from the public by labeling them as deaths from non-weaponized regular germs and other ruses like "drug interactions" or "chemical spills". In some incidents, bodies were promptly incinerated, and families notified of "accidents". In one case, a US concentration camp was used to "quarantine" people and then incinerate over a thousand people over a 2 day period. It reminded me of the death camps in Nazi Germany. This incident saddened me greatly because of the many innocent lives lost when there was a 50% chance that those who were infected would have recovered. But the Shadow Govt. was so anxious to cover up the Biowarfare germ leak so that the public would not stop their new germ creation programs that they sacrificed all of those who were suspected of being infected. That is, they massacred the people, including the women and children without waiting to see if they would die of the infection. Biowarfare germs do not kill even 90% of infected people. They do however kill about 50% of infected people if they are very deadly weaponized versions of germs. But this group of about 1,200 people were only suspected of being infected. I estimated that only about 10% were actually infected at the time they were quarantined. Had they been separated into small family units of a parent and a child for quarantine, most of those family units would have been later shown to be free of infection and could have safely been released a week or two later. The way this disaster was handled proved that those behind the Biowarfare programs were more interested in killing innocent Americans than saving their lives. And these were even white middle class

Americans who had been exposed to the germ in the course of their shopping at a particular store where the clerk's husband worked for a Biowarfare lab. In retrospect, it appeared that the Shadow govt. rounded up the inhabitants of this small town and liquidated them in order to suppress the news of the hemorrhagic illness with a high fever near their Biowarfare Lab. If I remember correctly, the Lab was in New Mexico and the year was about 1987.

There were no incidents in which a US citizen had lost their life in that same interval of time to a foreign govt. releasing a germ on US soil. The number of serious incidents in which a germ was accidentally released but was stopped in time to prevent a death was over a hundred. Such programs are inherently too dangerous to ever justify the creation of new biowarfare germs.

I looked into whether the research was directed to improve the safety of the US public or to endanger it. About 80% of the research and development was geared to making ever more dangerous and deadly germs. Why?

In CIA researcher Robert Morrow's book [First Hand Knowledge](#) he says that he was asked by the CIA to find a way to disable or kill all Americans excepts those that were able to get a life-saving drug that the Shadow Government could control. He decided that the best way to do that would be to cause hypothyroidism and control the supply of thyroid replacement medication. In fact, there has been a growing epidemic of hypothyroidism in the US. Some scientists attribute that to the above ground nuclear explosions at the Nevada Test site. It has been estimated that 60,000 new cases of thyroid cancer resulted from those tests. Meanwhile, people's ability to buy desiccated animal thyroid supplements over the counter has disappeared. While such events could be coincidences, the research that I read led me to conclude that the Shadow Govt. sincerely wanted to have that kind of control over people's health and lives and were working slowly and steadily towards that goal. When they are vigorously opposed by consumer groups they suffer setbacks in their agenda. Such setbacks have been many. If people only understood how dependent they are on the ignorance and apathy of the public, they would tell all their friends and neighbors and stop the Shadow Government's control over the population.

Although it is difficult to believe that the Robber Barons would target Americans, and not just foreigners, it is true. I have supplied you with a bit of the evidence of that in other cases, such as the Ludlow Massacre of American women and children in Case 22A, and the unsafe addition of benzoate/benzoic acid, aspartame/ Nutrasweet/Equal to sodas. If you read former US intelligence insider Al Martin's [The Conspirators](#), the US Shadow Govt. under Bush, Sr. as Vice President had a contingency plan to cause a limited nuclear war in order to have an excuse to impose martial law. Al Martin was briefed on that plan, Operation Orpheus, by Col. Ollie North of Iran Contra Scandal infamy. Al Martin asked Ollie North how many American lives the US Administration planned to expend in that limited nuclear war. Ollie North said, "It is just a number." When Al Martin pressed him on what the number was he said, "50 to 70 million Americans." If that is how many would die, how many would be left sick afterwards? Those who survived would be at high risk of cancer. And essentially all of those downwind from it would become hypothyroid and would only be able to function if they were able to obtain thyroid supplements from the drug companies. Those supplements could be rationed or made so expensive that only those who were loyal to the Robber Barons could get them.

The US Administration has been making many new germs and using the vaccines only for their own use. The HIV virus is a BioWarfare germ which was developed at Fort Detrick.

It was tested under the supervision of CIA officer Jim Jones on US blacks, hispanics, and Native Americans at Jonestown British Guiana. I met Jim Jones in the halls of the CIA after that. He did not die in that CIA mass murder atrocity that killed over 900 people. Most were not so well mind controlled as to 'voluntarily commit suicide on cue'. Please read the book "Was Jonestown a CIA Medical Experiment?" by Robert Meier for more information. HIV did not accidentally escape from Fort Detrick; it was intentionally used to target populations, mainly blacks and Third World people. For example, HIV infected units of blood were sent to sickle cell clinics in Africa, put in vaccines used in Africa, India, Thailand, etc. But, infected blood was also wittingly sent by the Shadow govt. to Canada with the intention of infecting that population as well. The Robber Barons only consider the top 500 wealthiest families in the world to be "their own". In their agenda, they want to allow each of those families to have a million relatives on the face of the earth and wipe out all the other people. That can be done by creating new germs and taking safe vaccines to them, while withholding those vaccines from everyone else. Thus, they have developed a vaccine against HIV which they have taken but hidden from the rest of the world. In my report to Tenet, I stated that this was a crime against humanity which was being perpetuated on a daily basis. After he read my report, I asked him what he was going to do about all those crimes against humanity, as each new germ represented one. He hemmed and hawed and then offered lamely that he was not the one making the decision. I asked him who was. He did not answer that question directly. He said, "Well, you can come with me to the next Presidential briefing in the morning and discuss it with Bush, if you think that it will do any good."

I doubted it would do any good, but in the interests of thoroughness I did it anyway. I took with me a large stack of my report. My report was over 225 pages with a couple hundred pages of supporting documents. So, each report was almost a ream with of paper. I put 10 of them in a box to take with me. Both Cheney and Bush were at that Presidential briefing that morning. And Rice was called into it when I started giving my briefing on the poor quality of the research done at the BioWarfare Labs. At the end of my almost 12 minutes, I concluded with my recommendation that all the labs be closed down.

Bush, Jr. said to me, "We wanted to know how to make the research more effective. What are your recommendations to do that?"

I asked him, "More effective in what way?" That was a loaded question because they did not want to come out and say in front of the many foreign bugs likely to be in the Oval Office, "At killing off most of the people in the world so we can have all the resources of the planet for just our own children." So, there was a brief uncomfortable silence.

Then Cheney said, "You know what we want. What do we have to do to get the level of science up to be able to accomplish it?"

I started off on the tangent of how to make the research safe enough to even do and recommended tongue in cheek that it at least be moved off shore to join their

investments. Rice laughed at that. The others did not. They wanted the BioWarfare Labs on US soil to be able to claim an accidental release when one was intentional. That suggested to me that Rice was not as close into the loop on the actual agenda as the others.

Cheney then said to me “Just get to the point and tell us what needs to be done to get the kill ratios up to usable to immobilize a whole population.”

I said, “Of healthy well fed soldiers or starving villagers?”

He said, “Assume a healthy population’.

Then Bush, Jr. added in “What does it take to kill everyone who isn’t vaccinated? Can’t we just use several germs at the same time?”

Cheney frowned at that because Bush had said more than was wise for plausible deniability. He tried to cover for Bush and added, “In the event of war.”

I said, “We are in a war now. It is likely that MiddleEasterners have different susceptibility rates than Westerners.”

Bush, Jr. said, “Well, we want to be able to cover all bases.”

Tenet rolled his eyes up to the ceiling at Bush’s continued faux paxs.

Rice tried to rescue him this time and said, “This is just theoretical so that we understand all facets of the problem.”

Bush leapt back in and said, “No, I really need to know in case I decide to launch this globally.”

Cheney got up and left the room, apparently because Bush had said too much and he didn’t want to be implicated by what else Bush said. But that did not help Cheney because the next thing that Bush, Jr. said was ‘Cheney and I already discussed this before you came this morning and we are of the same mind on it. We want the capacity to wipe out all of the “lesser beings” on the planet.’

I played dumb and asked him how he defined that.

He said, “You know, all those who are not members of the CFR already”

“And their families?” I offered.

“Well, not all of them,” he said. “You know The List.”

I handed him a copy of it to make sure that we were talking about the same list. He nodded yes, and repeated “What do we have to do to get down to just those people?”

I told him that their current plans were not good because the science was so faulty that even if you used multiple germs that those people had already received the vaccines on, that the number of people left alive were likely to overwhelm all defenses and overrun and kill the perpetrators.

“That means us, doesn’t it?” he asked.

Rice was shifting uncomfortably in her chair--apparently she knew that that her family was not on that list.

I said, “Yes. And I don’t think that you can improve the research quality at the Labs without inspiring a culture of honesty in them first.”

“How do we do that?” he asked.

“Leadership” I replied. “Model the behavior that you want them to have by being honest.”

“What about incentives? Cash incentives?”, he asked.

“You already have such a system in place. The researchers know that they can get an extra \$100,000 by creating a new germ. It is not improving the quality of the research, it is only making more germs.”

“But then we will succeed by having lots of them!” he asserted.

“No, lots of them are “me too” germs and they can cause the body to develop immunity to many of the other germs in the program.”

“Then we can imprison all those who don’t do good research, to improve the quality. How long should they be imprisoned for?”

“I really don’t think that will work either”, I said. “They will get more devious, but not more honest.”

We went around in circles like this for a while. Finally, Tenet said it was getting late.

Bush ended by saying, “I don’t think my being more honest is a good idea. People would find out the truth. I think that you better explain this to Rockefeller as I sure don’t want to have to. He is going to be very disappointed in you. You are failing to make this work the way we want it to. I don’t think that will be good for your health, if you keep on resisting us in this.”

Cheney came back in as Tenet and I were about to leave. I gave him, Bush, and Rice copies of my report. I also left a copy for Rumsfeld, the Head of the JCS, and others until I had none left.

Cheney said, "You expect us to read this?" I said, "The first 5 pages are the executive summary. The rest is to prove what I said in those 5 pages."

Bush said, "Oh, I can read that much" and picked his copy back up off the side table he had set it on. Then he said to me vehemently, "This better deliver what I want or you will be sorry when Rockefeller hears of it."


Cheney said to Bush, "Don't worry. We have others to replace her."

The next month they had 3 other people review the BioWarfare Lab's research without first giving them my report. Those 3 people said much the same that I did--the science at the BioWarfare Labs was seriously flawed and untrustworthy.

I asked about 10 people in that dept. who the person represented in the statue was. The statue was textured on the face making it unclear whether the figure was bearded or not. Three of them said Rockefeller, though one of those said Nelson, not David. Most said a saint and two of them said, "Jesus". That is how well the sculptor accomplished David Rockefeller's wish to be immortalized as a Christ like figure while planning genocide to kill off 5.5 billion people!

But apparently he was not alone in that wish because Prince Phillip, husband of Queen Elizabeth II said, "*If I were reincarnated, I would wish to be returned to Earth as a killer virus to lower human population levels.*"

# Articles Which Explain the History of the Drug Cartels

## 'The power behind your doctor' by Anne Casey:

*'A February report by the US Office of Technology Assessment concluded that drug companies have been making profits in excess of \$2 billion a year. Between 1976 and 1987 the drug companies earned returns on investment that (after allowing for risk) were two to three percentage points higher than other companies. US drug firms dominate international markets. The result is a trade surplus of more than \$1 billion a year in medical and pharmaceutical products.*

*At the helm of this national and international domination is the Rockefeller family fortune. In 1949 US investigative reporter Morris A. Bealle documented the beginnings of this huge industrial combine.*

*According to Bealle, the Rockefeller empire (which was built on Standard Oil Company) in the early part of this century became interested in the drug trade after making breath-taking profits from palming off bottled petroleum, called Nujol, as a supposed cure for cancer and later for constipation.*

*In 1939 the Drug Trust was formed by an alliance of the two greatest cartels in world history -- the Rockefeller empire and the German chemical company, I.G. Farbenindustrie (I.G. Farben). Drug profits from that time onwards curved up into gigantic proportions and by 1948 it became a \$10 billion a year industry.*

*I.G. Farben's past is highlighted by the fact that during the Second World War it built and operated a massive chemical plant at Auschwitz using slave labour. Approximately 300,000 concentration camp workers passed through I. G. Farben's facilities at Auschwitz and at least 25,000 of them were worked to death. Twelve of I. G. Farben's top executives were sentenced to terms of imprisonment for slavery and mistreatment offences at the Nuremberg war crime trials.*

*Hoechst and Bayer, the largest and third largest companies in world pharmaceutical sales respectively, are descended from I.G. Farben.*

*The Rockefellers gave billions of dollars worth of gifts to colleges and public agencies within the United States who taught Rockefeller drug lore. In 1927 they formed the International Education Board, which similarly "donated" millions of dollars to foreign universities and politicians.*

*As these huge amounts of money were being “donated” to drug- propagandising colleges, the Rockefeller interests were expanding worldwide. Already 40 years ago Bealle wrote:*

*“It has long been demonstrated that the Rockefeller interests have created, built up and developed the most far reaching industrial empire ever conceived in the mind of man (sic). Standard Oil is of course the foundation industry upon which all the other industries have been built ...*

*“The keystone of this mammoth industrial empire is the Chase National Bank with 27 branches in New York City and 21 in foreign countries [now renamed the Chase Manhattan Bank with over 200 branches in the US and abroad]. Not the least of its holdings are in the drug business. The Rockefellers own the largest drug manufacturing combine in the world and use all their other interests to bring pressure to increase the sale of drugs.”*

*In 1979 President Carter was moved to proclaim, “The oil lobby, perhaps the most powerful lobby on earth, is almost matched by hospital owners and doctors”.*

*In 1980 Exxon became America's largest corporation. Exxon is the new name for the old Rockefeller Standard Oil Trust.*

*What effect has this domination of the industry by the companies had on our health?*

*According to the US Food and Drug Administration, 1.5 million people in the US were hospitalised in 1978 as a consequence of taking drugs, and some 30% of all hospitalised people are further damaged by their treatments. Every year an estimated 140,000 North Americans are killed because of drug taking; one in seven hospital beds is taken up by patients suffering from adverse drug reactions.*

*In Australia, Dr Julian Gold, head of the National Health Surveillance Unit of the Commonwealth Institute of Health, estimates that up to 40% of all patients in Australia may actually be victims of doctor-induced (iatrogenic) illnesses. Of this amount, generally half are from drug reactions.*

*Today drugs are highly toxic substances because they are generally composed of artificial chemical compounds synthesised in the laboratory. In the past, before drugs became big business, nearly all medicines were composed of natural, plant-derived ingredients that were far safer.*

*Drug companies choose to synthesise the ingredients because they are cheaper to produce and can be patented, giving the companies monopoly rights on their sales.*

*Every doctor knows the dangers of the drugs they administer. Each has a copy of the MIMS Annual, containing information on the effects of the drugs. Even then this is unlikely to reveal the full extent of possible side effects because it is the information which the drug companies themselves provide...*

*Alternatives to the drug company monopolies are ruthlessly suppressed by bodies such as the American Medical Association, the US Food and Drug Administration and the Australian Medical Association.*

*Jenny Burke of Australian Biologics told Green Left, "Until conventional medicine gets perfect results, they can't afford to ignore anything, and they're certainly not getting perfect results.*

*"People must have the right to access a wide range of possible health options and to determine their efficacy for themselves. Instead they are faced with doctors who will readily hand over scripts but who do not even know of important developments in health which are taking place outside the narrow sphere of the drug companies.*

*"We're told that natural and alternative therapies are hurting people, but the real damage is being inflicted by the monopoly drug companies and the doctors who refuse to inform themselves. This is the real crime."*

*A US publication, the Civil Abolitionist last year reported that on May 6, 1992, the clinic of Jonathan Wright MD, a highly regarded nutrition specialist, was assailed by 22 armed men because the doctor had been treating his patients with natural substances that didn't meet the FDA's approval.*

*During the SWAT-type attack, the front door was kicked open, guns were pointed directly at staff, and the shocked patients were herded into a room. Patient records, equipment, business records and vitamin supplies were confiscated. At the time of the article, the FDA had not filed charges against Dr Wright.*

*Last year similar actions took place against three manufacturers of vitamin supplements (Allergy Research, Thorne Research and Highland Laboratories).*

*A bill pending in the US House of Representatives would make vitamins, minerals and herbs unavailable except through prescription from medical doctors, prevent food supplements from entering the country and make it illegal for anyone to sell vitamins, minerals and herbs with a fine of up to US\$1 million*

*for each violation plus a \$250,000 fine against the store. A bill identical in nature has been passed in the UK and a similar one is on the table in several European countries and Canada.*

*In Australia, a repeal of Schedule 1, Exemptions of the Therapeutic Goods Act, scheduled for January 1994, would minimise access to natural therapy and threaten the existence of the natural therapy profession and manufacturers of natural remedies.*

*The domination of health care by powerful monopolies extracting billions of dollars in profit means that people's health is deteriorating while government health care bills soar...*

*“Even within Western cities such as New York, some people are able to access preventive drugs and treatments early in their HIV illness, and other people only access any health care a day or two before they die. This is dictated by class, race and gender.*

*“The global struggle for health requires not simply the defence of access to health programs and drugs but also a struggle against poverty and sexism and for basic human rights.”*

## **How the Chemical Companies came to control the media and people**

### **The Drug Story**

*“How the pharmaceutical industry took control of the hospitals, universities, research and other institutions in the early part of this century is amply demonstrated by world-famous medical historian and author, Hans Ruesch, in his devastating expose: *Naked Empress or The Great Medical Fraud*(55) (1992). *I.G. Farben's unsavoury past is highlighted by the fact that during the Second World War it built and operated a massive chemical plant at Auschwitz using slave labour. Approximately 300,000 concentration-camp workers passed through I.G. Farben's facilities at Auschwitz and at least 25,000 of them were worked to death.(58) Also, others were brutally killed in I.G. Farben's drug testing programs(59). Twelve of I.G. Farben's top executives were sentenced to terms of imprisonment for slavery and mistreatment offences at the Nuremberg war crime trials.(60)*

*Hoechst and Bayer, the largest and third largest companies in world pharmaceutical sales respectively, are descended from I.G. Farben. In September 1955, Hoechst appointed Friedrich Jaehne, a convicted war criminal from the Nuremberg trials, as chairman of its supervisory board. Also, a year later, Bayer*

*appointed Fitz ter Meer, another convicted war criminal, as chairman of its board.(61)*

*On the Rockefellers' moves towards "influencing" medical colleges and public agencies in the United States, Bealle writes:*

*"The last annual report of the Rockefeller Foundation itemises the gifts it has made to colleges and public agencies in the past 44 years (from 1948), and they total somewhat over half a billion dollars. These colleges, of course, teach their students all the drug lore the Rockefeller pharmaceutical houses want taught. Otherwise there would be no more gifts, just as there are no gifts to any of the 30 odd drugless colleges in the United States."(62)*

*The Rockefellers did not restrict their "educational" activities to the US alone. In 1927 they formed the International Education Board which "donated" millions of dollars to foreign universities and politicians, with all the usual strings attached.(63)*

*As these huge amounts of money were being "donated" to drug-propagandising colleges, the Rockefeller interests were expanding world-wide. It was large enough 40 years ago for Bealle to state:*

*"It has long been demonstrated that the Rockefeller interests have created, built up and developed the most far reaching industrial empire ever conceived in the mind of man. Standard Oil is of course the foundation industry upon which all of the other industries have been built.*

*The keystone of this mammoth industrial empire is the Chase National Bank with 27 branches in New York City and 21 in foreign countries (now renamed the Chase Manhattan Bank with over 200 branches in the US and abroad). Not the least of its holdings are in the drug business. The Rockefellers own the largest drug manufacturing combine in the world, and use all of their other interests to bring pressure to increase the sale of drugs."(64)*

### *The Not-So-Independent Media*

*Instrumental in Rockefellers' moves towards making the world drug-dependent is their enormous influence on the media. Commenting on this, Ruesch explains:*

*"So the stage was set for the 'education' of the American public, with a view to turning them into a population of drug dependants with early help of the schools, then with the direct advertising and, last but not least, the influence the advertising revenues had on the media."*

*A compilation of the magazine Advertising Age showed that as far back as 1948 the larger companies spent for newspapers, radio and magazine advertising the sum total of \$1,104,224,374, when the dollar was still worth a dollar. Of this staggering sum the interlocking Rockefeller-Morgan interests (gone over entirely to Rockefeller after Morgan's death) controlled about 80%, and utilised it to manipulate public information on health and drug matters - then as now.*

*Anybody who tries to get into the mass media independent news, contrary to the interests of the Drug Trust, will sooner or later run into an unbreakable wall.*

*For big advertisers it is easy not only to plant into the media any news they wish to disseminate, but also to keep out the news they don't want to get around. A survey in 1978 by the Columbia Journalism Review failed to find a single comprehensive article about the dangers of smoking in the previous seven years in any major magazine accepting cigarette advertising.*

*Even the most independent newspapers are dependent on their press associations for their national news. And there is no reason for a news editor to suspect that a story coming over the wires of Associated Press, united Press International or the International News Service is censored when it concerns health matters.*

*Yet this is what happens constantly. [Emphasis added](65)*

*Ruesch showed how the above-mentioned international media were taken over by the Drug Trust and he further explains:*

*"So this sews up the press associations of the Rockefeller Drug Trust, and accounts for the many fake stories of serums and medical cures and just-around-the -corner-breakthrough-to-cancer; which go out brazenly over its wires to all daily newspapers in America and abroad.."*

*Thus newspapers continue to be fed constantly with propaganda about drugs and their alleged value, although 1.5 million people landed in hospitals in 1978 because of medication side-effects in the US alone, and despite recurrent statements by intelligent and courageous medical men that most pharmaceutical items on sale are useless and/or harmful.(66)*

*Among the many publications owned by the Rockefeller Drug Trust, are: Fortune, Life, Time, Readers Digest and Newsweek magazines, and the Encyclopedia Britannica. These publications are constantly pushing drugs."*

*Chairman. Of the Supervisory Board. Of Bayer....*

*As of 1993, 300 transnationals controlled 25% of the world's productive capacity. (See The Economist, Mar.27, 1993, "A Survey of Multinationals").*

*This is reality.*

*Monsanto, Dow, Du Pont, Bayer, Hoechst, Rhone Poulenc, Imperial Chemical Industries, and Novartis are all researching and growing genetically engineered crops which the supreme quality of being able to absorb and tolerate more of the parent company's (specific) pesticides without curling up and dying in the fields.*

*Pesticide drenched fields.*

*And drenched bodies of those who eat the foods.*

*No word from this administration about this. The Clinton White House is, in fact, enthusiastic about genetically engineered (GE) food. Or, as the government calls it, GMOs, genetically modified organisms.*

He decided that the books were being cooked, that data were being falsified. He went to Congress and told them this, and he also said that his bosses at the FDA were covering up these lies. In 1989 he was fired.*

*In the revealing book, Toxic Sludge Is Good For You, John Stauber writes, "Monsanto was the manufacturer of most of the world's PCBs -- persistent chemicals used in electrical equipment which have been shown to cause cancer and birth defects. It is also the world's largest producer of herbicides, including products contaminated with dioxin (thought to be the world's most toxic small molecule)." ## The Responsibility of IG Farben

*“IG Farben was the union of Agfa, BASF, Bayer, Hoechst, and a few other smaller German chemical companies. At that time, they had a leading role as the world's biggest chemical company. With amounts of 81 million Reich Marks, they were the biggest single financier of the Nazi party from 1933 to 1944. They explicitly conducted their own plans for the war. They had Hitler's personal assurance guaranteeing delivery of fuel, ammunition, etc., which gave the Nazis the possibility to start the war. ... The cartel earned their money from deadly weapons, the industrialisation of the mass murders in concentration camps, the massive enslavement of prisoners and 'enemies of the people' as well as from "the transfer of enemy assets out of conquered areas".*

*...Prisoners were than subjected to brutal torture sometimes while conscious and sometimes they were already dead. This was done under the pretext of "medical and scientific experiments in the service of science". The mass murders of Jewish people were "perfected" with the poisonous gas Zyklon B. ...Two million dollars was provided [by IG Farben-Standard Oil of New Jersey] for the construction of the concentration camp. At IG Farben's own Auschwitz, IG Monowitz, and the adjacent factory, approximately 370,000 prisoners died as a result of the working conditions and malnutrition. IG Farben Board Member, Schneider, displayed the following principle in 1943, "...get out as much work out of the prisoners of war as possible. All these people should be fed, housed and treated, so as to get the most work done with the least possible costs." Due to this sort of treatment, the average life expectancy at the IG Monowitz factory was only 9 months.*

### *The BAYER control centre*

*The control centre for IG Farben conducted human experiments came from BAYER. The notorious scientific department was directed by Wilhelm Mann. He was also manager and a member of governing board of the Cyclone B monopoly, Degesch. He carried out the annihilation of Jews with indifference and recognised human experimentation as an example of progress. The BAYER researcher, Prof. Gerhard Domagk, conducted human experiments for germ warfare under contracts from the SS. He was later awarded the Nobel prize for medicine for his discovery of sulphonamide. Sulphonamide was first tested on humans who were infested with gangrene and finally treated with antibiotics from BAYER. Death was inclusive.*

*It appears that all at the IG Farben company had an interest in human experimentation. IG Farben top managers, Bütefisch, von Schnitzler, Ambros, ter Meer and Dürrfeld met with Auschwitz's factory head, Rudolf Höß and SS leader Heinrich Himmler on friendly terms at Auschwitz. The correspondence between BAYER and the Auschwitz concentration camp gruesomely documented experiments on humans. BAYER put an order for 150 women, necessary for new experiments. They were deemed as "sufficient" despite "their miserable state of health" after "delivery". There it meant, "the experiment have been carried out. All test objects are dead. We would like to inform you that we will be needing a new delivery shortly."*

*Continuity until today*

*IG Farben lost only 13% percent of their capacity in air strikes during the Second World War. Industrial plants were hardly bombed because the Americans knew that IG Farben delivered aeroplane fuel via the Rockefeller group. After the war who was chosen to be the judge of the lawsuit against IG Farben management during the Nuremberg trials but Howard C. Peterson. Peterson was a former partner of the New York law firm, Cravath, Gersdorff, Swain & Wood. They represented the interests of IG Farben after the war in the USA.*



*IG Farben board member, Fritz ter Meer became the chairman of the board for BAYER in 1956. He said during the Nuremberg trials on the topic of human experiments that "concentration camp prisoners were not subjected to exceptional suffering, because they would have been killed anyway". Eleven of the IG Farben managers were set free. Six received prison sentences from 18 months to 3 years. Ter Meer received a 7 year sentence, while Ambros and Dürrfeld received eight years. All those convicted were released from prison early. Some were included in the succeeding management team of the IG Farben Cartel.*

*90% of IG Farben ownership was divided up among BAYER, HOECHST, and BASF. Every one of the former of the IG Farben companies, BASF, BAYER, and Hoechst are bigger and more powerful now than ever before. Despite the formal disintegration of the IG Farben company, BASF, BAYER and Hoechst act homogeneously due to common profit interests.*

*BASF proved their lack of a sense of guilt only in 1991 when they levelled the last remains, shacks, gas chambers and crematoriums of the former IG Farben Schwarzhede concentration camp, "by mistake". BAYER reacts to accusations in their own way. Critical stockholders from the Co-ordination against the BAYER-Gefahren (CBG) used their right to speak at a shareholders meeting in Cologne in 1995. They referred to the past of the BAYER company and called for the erection of a fund to compensate former forced labour workers at the Auschwitz Monowitz concentration camp. The plan was to put a mere DM from every stock into this fund. The microphone was turned off after many interruptions. The three CBG members were forcibly thrown out of the hall by security guards when they tried to continue speaking. This took place under the direct orders of the Chairman of the Board, Hermann-Josef Stenger. He also ordered them to stay away.*

*The survivors of the IG Farben factory have still not received one Pfennig in compensation. The official reason: BAYER is not the legal successor of IG Farben." <http://www.mega.nu:8080/ampp/bayer.html>*

*“As Bealle pointed out, a business which makes 6% on its invested capital is considered a sound money maker. Sterling Drug, Inc., the main cog and largest holding company in [the Rockefeller Drug Empire and its 68 subsidiaries](#), showed operating profits in 1961 of \$23,463,719 after taxes, on net assets of \$43,108,106 - a **54% profit**. Squibb, another Rockefeller controlled company, in 1945 made not 6% but **576%** on the actual value of its property.*

*That was during the luscious war years when the Army Surgeon General's Office and the Navy Bureau of Medicine and Surgery were not only acting as promoters for the Drug Trust, but were actually forcing drug trust poisons into the blood streams of American soldiers, sailors and marines, to the tune of over 200 million 'shots'. The agency had issued no public announcement of the session -- only private invitations to fifty-two attendees. There were high-level officials from the CDC and the Food and Drug Administration, the top vaccine specialist from the World Health Organization in Geneva and representatives of every major vaccine manufacturer, including GlaxoSmithKline, Merck, Wyeth and Aventis Pasteur. All of the scientific data under discussion, CDC officials repeatedly reminded the participants, was strictly "embargoed." There would be no making photocopies of documents, no taking papers with them when they left. The federal officials and industry representatives had assembled to discuss a disturbing new study that raised alarming questions about the safety of a host of common childhood vaccines administered to infants and young children. According to a CDC epidemiologist named Tom Verstraeten, who had analyzed the agency's massive database containing the medical records of 100,000 children, a mercury-based preservative in the vaccines -- thimerosal -- appeared to be responsible for a dramatic increase in autism and a host of other neurological disorders among children. "I was actually stunned by what I saw," Verstraeten told those assembled at Simpsonwood, citing the staggering number of earlier studies that indicate a link between thimerosal and speech delays, attention-deficit disorder, hyperactivity and autism. Since 1991, when the CDC and the FDA had recommended that three additional vaccines laced with the preservative be given to extremely young infants -- in one case, within hours of birth -- the estimated number of cases of autism had increased fifteenfold, from one in every 2,500 children to one in 166 children. 



### How Heavy Metal Detoxification May Help Your Child

Autism is a complex neurobiological disorder. It is part of a group of disorders known as autism spectrum disorders (ASD). Today, 1 in 150 individuals is diagnosed with autism, making it more common than pediatric cancer, diabetes, and AIDS combined. It occurs in all racial, ethnic, and social groups and is four times more likely to strike boys than girls. Autism impairs a person's ability to communicate and relate to others. It is also associated with rigid routines and repetitive behaviors, such as obsessively arranging objects or following very specific routines. Symptoms can range from very mild to quite severe.

- 1 in 150 children is diagnosed with autism
- 1 in 94 boys is on the autism spectrum

- 67 children are diagnosed per day
- A new case is diagnosed almost every 20 minutes
- More children will be diagnosed with autism this year than with AIDS, diabetes & cancer combined
- Autism is the fastest-growing serious developmental disability in the U.S.
- Autism costs the nation over \$90 billion per year, a figure expected to double in the next decade
- Autism receives less than 5% of the research funding of many less prevalent childhood diseases
- Boys are four times more likely than girls to have autism
- There is no medical detection or cure for autism

Autism was first identified in 1943 by Dr. Leo Kanner of Johns Hopkins Hospital. At the same time, a German scientist, Dr. Hans Asperger, described a milder form of the disorder that is now known as Asperger Syndrome. These two disorders are listed in the DSM IV (Diagnostic and Statistical Manual of Mental Disorders) as two of the five developmental disorders that fall under the autism spectrum disorders. The others are Rett Syndrome, PDD NOS (Pervasive Developmental Disorder), and Childhood Disintegrative Disorder. All of these disorders are characterized by varying degrees of impairment in communication skills and social abilities, and also by repetitive behaviors.

Autism spectrum disorders can usually be reliably diagnosed by age 3, although new research is pushing back the age of diagnosis to as early as 6 months. Parents are usually the first to notice unusual behaviors in their child or their child's failure to reach appropriate developmental milestones. Some parents describe a child that seemed different from birth, while others describe a child who was developing normally and then lost skills. Pediatricians may initially dismiss signs of autism, thinking a child will “catch up,” and may advise parents to “wait and see.” New research shows that when parents suspect something is wrong with their child, they are usually correct. If you have concerns about your child's development, don't wait: speak to your pediatrician about getting your child screened for autism.

## **Infant Vaccines Produce Autism Symptoms in New Primate Study by University of Pittsburgh Scientists**

ATLANTA, May 19 – Findings released Friday showed that infant monkeys given vaccines officially recommended by the CDC and the American Academy of Pediatrics (AAP) exhibited autism-like symptoms.

Lead investigator Laura Hewitson of the University of Pittsburgh and colleagues presented study results at the International Meeting for Autism Research (IMFAR) in London.

Safety studies of medicines are typically conducted in monkeys prior to use in humans, yet such basic research on the current childhood vaccination regimen has never before been done.

The abstracts presented at IMFAR, the world's top autism science conference, describe biological changes and altered behavior in vaccinated macaques that are similar to those observed in children with autism.

Unvaccinated animals showed no such adverse outcomes. The vaccines given were those recommended for U.S. infants in the 1990s, including several with the mercury preservative thimerosal and the Measles-Mumps-Rubella vaccine.

Rates of autism spectrum disorder among children born in the 1990s surged dramatically, from about 1 in 5,000 to 1 in 150 children.

"This research underscores the critical need for more investigation into immunizations, mercury, and the alterations seen in autistic children," stated Lyn Redwood, director of SafeMinds.



Only a retrospective study which would be very difficult to do under the circumstances could be mounted with regard to the thimerosal question.

## **Never seen an Amish person with autism**

However, Dan Olmsted, investigative reporter for United Press International, and author of the Age of Autism series of reports, appears to have solved this problem when he came up with the idea of checking out the nation's Amish population where parents do not ordinarily vaccinate children.

First he looked to the Amish community in Pennsylvania and found a family doctor in Lancaster who had treated thousands of Amish patients over a quarter-century who said he has never seen an Amish person with autism, according to *Age of Autism: A glimpse of the Amish* on June 2, 2005.

Olmsted also interviewed Dick Warner, who has a water purification and natural health business and has been in Amish households all over the country. "I've been working with Amish people since 1980," Warner said.

"I have never seen an autistic Amish child – not one," he told Olmsted. "I would know it. I have a strong medical background. I know what autistic people are like. I have friends who have autistic children," he added.

Olmsted did find one Amish woman in Lancaster County with an autistic child but as it turns out, the child was adopted from China and had been vaccinated.

The woman knew of two other autistic children but here again, one of those had been vaccinated.

## I don't think we have a single case of autism in children delivered by us who never received vaccines



In addition to the Amish, Olmsted recently discovered another large unvaccinated group.

On December 7, 2005, Age of Autism reported that thousands of children cared for by Homefirst Health Services in metropolitan Chicago have at least two things in common with Amish children, they have never been vaccinated and they don't have autism.

Homefirst has five offices in the Chicago area and a total of six doctors.

"We have about 30,000 or 35,000 children that we've taken care of over the years, and I don't think we have a single case of autism in children delivered by us who never received vaccines," said Dr Mayer Eisenstein, Homefirst's medical director who founded


the practice in 1973.

Olmsted reports that the autism rate in Illinois public schools is 38 per 10,000, according to state Education Department data.

In treating a population of 30,000 to 35,000 children, this would logically mean that Homefirst should have seen at least 120 autistic children over the years but the clinic has seen none.

# Forced Vaccination of the Soldiers

## In the Gulf War: Intentional Violation of the Nuremberg Code

During the last 50 years, hundreds of thousands of military personnel have been involved in human experimentation and other intentional exposures conducted by the Department of Defense (DOD), often without a service member's knowledge or consent. In some cases, soldiers who consented to serve as human subjects found themselves participating in experiments quite different from those described at the time they volunteered. For example, thousands of World War II veterans who originally volunteered to "test summer clothing" in exchange for extra leave time, found themselves in gas chambers testing the effects of mustard gas and lewisite. (Note 1) Additionally, soldiers were sometimes ordered by commanding officers to "volunteer" to participate in research or face dire consequences. For example, several Persian Gulf War veterans interviewed by Committee staff reported that they were ordered to take experimental vaccines during Operation Desert Shield or face prison. (Note 2)

...the Department of Defense (DOD) conducted numerous "man-break" tests, exposing soldiers to chemical weapons in order to determine the exposure level that would cause a casualty, i.e., "break a man."... Similarly, hundreds of soldiers were subjected to hallucinogens in experimental programs conducted by the DOD in participation with, or sponsored by, the CIA. ... These service members often unwittingly participated as human subjects in tests for drugs intended for mind-control or behavior modification, often without their knowledge or consent...

The Nuremberg Code is a 10-point declaration governing human experimentation, developed by the Allies after World War II in response to inhumane experiments conducted by Nazi scientists and physicians. The Code states that voluntary and informed consent is absolutely essential from all human subjects who participate in research, whether during war or peace. The Code states:

The person involved should have the legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This latter element requires that before the acceptance of an affirmative decision by the experimental subject, there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonable

to be expected; and the effects upon his health and person which may possibly come from his participation in the experiments. (Note 6)

There is no provision in the Nuremberg Code that allows a country to waive informed consent for military personnel or veterans who serve as human subjects in experiments during wartime or in experiments that are conducted because of threat of war...

In summary, DOD informed FDA that they did not want to abide by informed consent regulations, and FDA officials pointed out that pyridostigmine and botulinum toxoid were investigational [for both safety and effectiveness] and that there are laws regulating how they can be used. DOD claimed that "under the DOD directive the Secretary of Military Departments [could] dictate the use of unapproved FDA regulated products" in the Persian Gulf, but "DOD's current position is that this not their primary choice at this time." (Note 80)

The issue was debated by the two agencies for several months. Finally, at a meeting on December 31, 1990, an agreement was reached. According to minutes of that meeting, DOD officials agreed that the botulism vaccine would be administered by trained individuals with a health care background, and that information would be provided orally "at minimum, and in written form if feasible, to all personnel receiving the vaccine." In her review of the DOD's application for use of the botulism vaccine in the Persian Gulf, an FDA reviewer pointed out that in 1973, the Centers for Disease Control had considered terminating its distribution because of adverse reactions... Since no records were kept for most of the Gulf War soldiers who received the vaccine, there is no new information about the safety of the botulism vaccine resulting from its use by U.S. troops. Therefore, its safety remains unknown...

Approximately 8,000 individuals received botulinum toxoid in the Persian Gulf. Given the high proportion who have reported that they had no choice, it appears that hundreds of thousands of U.S. troops were ordered to take an investigational drug or vaccine without having the opportunity to refuse.

BOTULINUM TOXOID [Survey]--

Of those receiving botulinum toxoid, those who:

received no oral/written information on the vaccine: 13 [76%]

were told they could not refuse it: 15 [88%]

described immediate side effects: 6 [35%]

Of the women receiving botulinum toxoid, those who received no warning on risk if pregnant:

4/4 [100%]

In 1990, DOD applied to FDA for a waiver of informed consent, claiming they would provide warnings orally and in writing regarding the risks of pyridostigmine, even though they would not give soldiers the choice of whether or not to take it. According to reports from various sources, including DOD's own study, DOD did not fulfill its promise. In addition, DOD personnel apparently distributed these drugs to civilians without any warnings. ...

The repeated claims by DOD and FDA at the Committee's May 6, 1994, hearing and at other times since the war that they were sure pyridostigmine was perfectly safe as used is not consistent with the concerns of DOD scientists regarding the potential serious adverse reactions and drug interactions while conducting research. It does not make sense that the researchers would establish such

elaborate safeguards when giving the drug to four men, and then have none of those safeguards when giving the drug to more than 400,000 U.S. troops, none of whom had been tested for sensitivity to pyridostigmine, and most of whom were not screened for medical problems or medication use that could preclude the safe use of pyridostigmine. DOD researchers were aware of the shortcomings of their research.

Additionally, approximately 28,000 of the 400,000 receiving the pyridostigmine were women, who were required to take an investigational drug that DOD had never tested on healthy women. (Note 122)

Anthrax vaccine was given to approximately 150,000 military personnel in the Persian Gulf. Anthrax vaccine is considered effective for protecting against anthrax exposure of the skin; however it is unclear whether it provides protection against inhaling aerosolized anthrax.

## Dirty Methods are Not Needed for Population Control

Because the Cabal's rationale for war, famine, and destruction has been population control, I had the CIA study my clean methods for population control. Those studies proved that the Cabal's methods were effective by comparison; wars and even famines did not result in long term decreases in population. They were short term measures that worsened population growth rates right afterwards. It was like cutting up starfish to get rid of them, the process of cutting them stimulated their re-growth. Fear, anxiety, insecurity, and poverty, cause people to want more children and produce them. Wars and trauma, and food scarcities, are like pruning rose bushes--one gets more flowers and more seeds. The CIA's own internal studies make that quite clear. In the 1900's there were two world wars and many lesser wars. The result of all that war, famine, and suffering was that there were more people in 2000 on the planet than in 1900. That is a failed strategy, even if we believed the goal to be a valid one.

The so-called clean development methods discussed in the above article about the Kissinger-Haig plan, were neither clean, nor intended to cause the Third World to become developed into First World nations. The leaders like Kissinger did not want Third World producers of raw materials to be First World like consumers of resources. They believed in a world of limitation and want, in which in order to have as much as they wanted, others would have to go without. They have a zero-sum idea of the world in which they believe that causing the people in the Third World to go

without will result in their happiness. Nothing could be further from the truth. Their analysis was wrong, completely wrong. The easiest way to understand that is to look at a marriage, because that is something that we have an understanding of from our personal observations over time. Beating up the wife, withholding love and refusing to share with her equitably, causes the relationship to deteriorate. It still produces many children. On the other hand, treating her as an equal and assisting her out love to achieve the goals that she freely sets, leads to a happier home in which there are naturally fewer children. In many cases, well-satisfied women busy doing what they love, produce no children at all. People with high education and career productivity have low birthrates. One doesn't have to force women to work, doing so doesn't lead to a decrease in population. It is love, care, and opportunities that give women the satisfaction needed to produce well without over-multiplying. The so-called development programs that the US tried to foist upon the Third World were like a husband holding his hand over a wife's head about to beat her, but not doing so at the moment. The underlying goal of those development programs was to force Third World countries to give up their resources at slave labor prices. There was no respect, care, or love involved, and the result was like a tyrannical marriage with an overproliferation of children, bickering, and problems.

During the course of several decades from about 1985 to 2004, the CIA did three major studies on my clean methods to control population, and about a dozen minor ones. They did so many studies because they could not figure out how I managed to get such good results. Also, they hoped to prove me wrong in the end, as they had an addiction to using dirty methods and wanted justification to continue using them. They had a commitment to violence, hoarding, and selfishness that they were not willing to allow reason, truth, and data to bring it into question. As a result they kept on banning my research results within the CIA and forcing me to reproduce them in further studies. Thus I ended up doing such studies long after analysts in the CIA's Intelligence Dept. conceded that I was right and that my methods did work well. Of course, you should not take my word for it but obtain copies of those studies and the full complement of their reviews.

Although the studies are complex and I don't have the data in front of me, I want to mention them because it is relevant to whether it was right for Bush, Sr. to sell the bio-warfare agents to Hussein. I had finished the first major study prior to that sale and it angered me that the old view that depopulation by killing still appeared to be standard operating proceeds at the White House. It is not that Bush, Sr. was ignorant of that study of mine. When I spoke to him on the phone about wanting to come over to inform him and others of the dangers of the Bio-warfare agents, he said something like "Is this about your wanting to do depopulation your way?" When I said, in effect, "Yes." He specifically forbid me from speaking about that study when I came to the White House the next day. He appeared, in my opinion, to want to keep the results of that study secret from his cabinet ministers and advisors. My methods would not have made kickbacks for anyone, nor ranked up any body count. The first major study done on my methods was a retrospective one. It was noticed by a CIA analyst that a village I had helped survive in Vietnam during that war, had a very low birth rate. It was an anomaly noticed on a study of Agent Orange birth defects. There were almost none to no birth defects in that village, and it was then asked, "Was that because there were not births at all in the next 10 years or so?" The answer was that there were births per the Vietnamese authorities that CIA analyst was working with, but not many. The Vietnamese authorities had tried to determine why and attributed it to the strange actions that I had taken in that village during the war. I had been sent in to do reconnaissance with a small team of men because the US Army hoped that my skills as a remote viewer would help us locate Stinger type missiles.

The VC had been shooting down US choppers. We did find and destroy missiles to the extent that the chopper problem in that area was greatly alleviated for awhile.

I had spent about half a day in that village as I tried to locate the missiles. I did not conduct a search and destroy mission of that village. Instead of destruction and intimidation, I did careful listening and tried to solve some of the village's many problems. One of the problems that they complained to me about was that the US military was frequently coming through their village and terrifying them. As I listened to their many complaints on that score, it occurred to me that there might be a way to help them. Their strategy up to that point had been to wait for it to happen and then scatter and hide in the surrounding mountains for weeks at a time until the US moved on. That strategy was not very successful. Their crops did not get the care they needed. Their livestock were unable to be moved quickly and got killed by the US troops and left to rot. Their rice and food stores were scattered all over the village trampled underfoot and moldy by the time they returned. Life was Hell for them, as a result of the American soldiers, not unlike Iraq these days. It seemed to them that nothing could ever change that. But it did not appear to me to be a hopeless problem because I had faith that the Lord could solve any problem fairly quickly and well. Thus, it did not surprise me when an answer occurred to me about an hour later. That answer was for them to post a watch on all the trails that lead into the village (something they had already done.) But to do so with a different intention. They were doing so then to alert the village to "run". I suggested that they alert the village to host a party for whoever came. That is, they should not favor nor run from any group, but entertain and feed whoever came through. At first, they objected saying that they were poor people and could not afford to. I pointed out that they were losing all their food and livestock each time, and it would be better to serve even half of it, and keep the other half. They discussed it and decided to give it a try. I made some suggestions as to how to entertain soldiers without giving their young girls to them. They brainstormed came up with many creative ideas. That village became known for its great hospitality and talent. Neither side demolished it after that because they wanted to be able to have some rest there. It was a "fire free" zone in the midst of a war zone. I think the God blessed them with peace because of their generous hearts and actions. If they had worried about having enough, it never would have worked. Since they gave so freely, both sides left behind much food that was uncooked to reciprocate. It was a miracle that God kept going for years during the war. I had been there in about 1969. The CIA analysts confirmed by satellite images that the village had not been destroyed after that, even though the war raged all around them. The war did not end until 1975.

By the time the CIA studied it as anomaly in population growth, almost 15 years had passed. The population of the village had modestly decreased, while the villages nearby had very large numbers of children, were requiring cutting down of more jungle, and were very poor. It was not just that the village had had peace. That is not actually enough to reverse the overgrowth of population. It has to have spiritual contentment. Later studies elucidated that more clearly.

That first major study went beyond that one village to look at other places in the world that I had been on assignment. I got sent to war zones periodically, and CIA analysts had noticed that difficult to account for results followed. I was not responsible for those effects; I was just desperate enough to call on God with faith. The CIA analysts thus went back over the record of which villages I had been on assignment to and looked at birth rates before and after and in comparison to neighboring villages. I had not gone to those places with any intention to control population; I had in the course of my other duties for the CIA, tried to help them in whatever way seemed appropriate at the time. So, it was kind of a double blind study in that neither I nor the villages had any idea that the CIA

would later study the result of going to sincerely and selflessly help. I was not leaving behind bags of Aid money, financial grants, or contracts with the CIA to help them later. I was enquiring after their needs as a concerned visitor and dispensing some practical advice grounded on good spiritual principles. The CIA analyst in question found a decrease in population and crowding where I had given such advice, and not when I was in too much of a hurry to give it. It was not that I was contaminated with poison or spreading poisons. The children were fewer but healthy overall. Frankly, the CIA was unable to account for the results, even after they carefully substantiated them. It especially troubled them, given how short I was in any village, that the effect seemed to be long lasting. That was not surprising to me, I had intended to give advice that would benefit them long term by changing their culture for the better. Careful application of almost any kind spiritual principle will do that. I looked to see the spiritual basis of their most pressing difficulty and tried to correct it with the simple advice I gave.

Perhaps more examples will make that clearer. This example came from a village in Europe where people were poor and oppressed by their government at the time. I was there to rescue some dissidents and bring them back to the CIA. In the normal course of doing that I learned that their village had a problem with its water supply. The simple way to address it would have been to replace the pump. That was not the solution that I thought was most beneficial in the long run because it would be temporary and not correct a problem in social justice. One family, the one who had the pump house was using almost all the water to irrigate their fields, while other families got none for their fields. I suggested a different way for them to use the land so that a short trough from a local stream would irrigate all of their fields. It meant two things; the land would have to be swapped around and people would have to cooperate in building and maintaining the trough. Everyone would benefit each time anyone irrigated one field, all would get irrigated. That project created an enormous amount of good-will in the village because it was designed properly. The result was an increase yield per acre and a more forest was allowed to grow over unneeded farmland. The population shrank about 10%, not due to migration to cities, but due to contentment and fewer children.

Here is another example. In this village the primary problem was bickering and power struggles. The mayor had alienated many people by insisting that he alone made the rules. He was a mini dictator and thought that served his interests. But almost no one liked him as a result. People kow-towed to him and flattered him but he was lonely and unloved. My presence in his village had nothing to do with him from the CIA's point of view. I was there to make contact with a man from another area and I had to wait for him to show up. So, I had listened to people's stories intending to solve their most pressing problem. What I recommended was that the villagers shower the mayor with many small kindnesses, not false words, but treating him like a true friend. I made it into a game called, "If I was the lonely mayor, I would want \_\_\_\_\_", and I asked the villagers to fill in the blank. They had a lot of fun with the game. They had never thought of him as a lonely man needing help. They had thought of him as a terrifying petty tyrant who had to be obeyed or else. They were unable to vote him out of office, they were in a one-party system and he had been appointed. As a result of this simple intervention, people started inviting him home to family dinners. He started to thaw and become a real person. As that happened the policies he created were more humane and fair and the village prospered. Surprisingly, this village, by the sheer grace of God, went from being one of the worst in the region to one of the best to live in. I do not mean materially, I mean spiritually. What I mean by that is that people were willing to listen to each other's problems and help each other out. This was in a communist country. People were sharing material possessions, but frankly that did not help them so very much. Sharing of their hearts and

helping from their hearts was what made the difference in terms to their contentment. The population of the village also went down, about 5% judged by births, not migration. Nearby villages had an increase in births consistent with their national average.

The long term effect of even short term love has been noticed before in sociology. In one of the Chicken Soup for the Soul books, there is a true story about disadvantaged minority students in Washington, DC schools. A sociology professor sent his graduate students in to assess elementary student's chances of succeeding in life. The graduate students said things like "The kids haven't got a chance, their parents are drug addicted, unemployed, illiterate, etc.". Twenty or more years later another sociologist sent his grad students out to find out what actually happened to those kids. Much to their surprise, the kids turned out to be overachievers with many physicians, engineers, etc. among them. They were baffled. They studied the issue until they figured it out. The kids that succeeded so well had all gone through one particular teacher's class. They tracked that teacher down in a nursing home where she was still alert. They asked her what she had done that made the difference. She said, "That's easy. I loved those boys!".

Studies of foster children have shown the same thing. If there was one person that believed in them, believed that they could grow up to be a good person contributing to the society, that was enough. Just one person, out of all the people that abused them and put them down. Just one person that loved, cared, and respected them—that was all that it took.

Now, that I have told you that, I will I can tell you another hard to believe story about those studies on population control. This was part of a population control study that was prospective in which the task was to decrease population growth. In this study, my methods were pitted against the usual CIA methods of war, famine, and destruction of the culture. I was told to "do my magic" on a village on the outskirts of the CIA's war zone. I never traveled to that village. I merely called them up and asked for a toll-free number to be passed out along with a couple hours a week that I could be reached by phone. I said that I was a problem-solving consultant and would try to help them realize whatever dreams they had. For the next two months or so, I manned the phone during those hours. That was all the time I had for that project. I listened and helped people find the dream in their heart that could move them to take the risks to succeed. I wasn't passing out money, or grants. All I was doing was listening, and giving simple heartfelt advice. By the end of the two months, the villagers decided to "host a university". They did not even have a high school graduate among them, but they wanted to get an education. I asked them to figure out what a university should teach that would really help them. They designed the curriculum. It was not like any university that I had ever heard of, and that was a big plus for them. They hosted the university that they needed not the one that others wanted them to have. They invited "speakers" and kept control of the curriculum and its relevance to their lives. Neighboring villagers flocked to their village to take one and two day courses. They had many teachers that then went out to teach from village to village. There were courses on how to be a mid-wife, on how to raise livestock, on how to write down their life stories, on how to raise children, and on how to set up small businesses. That village became prosperous. It also had a decrease in population naturally. That moderation of population, like in First World educated cultures was long lasting.

My intervention cost next to nothing—not even a single plane ticket. The war dragged on for years, cost the US taxpayers a lot, and did not decrease the population growth rate, only decreased the numbers in the population. It just trimmed the rose bush and made it grow. Actually, it left an ugly landscape, despair, and suffering. When one trims a rose bush you get lovely roses. After a war,

you get a bumper crop of children, but not happy healthy ones usually. One get children missing limbs due to landmines, and birth defects from defoliants and depleted uranium. War is not good for growing children. It is not like pruning is to rose bushes, I was wrong.

In one of the last population growth studies I did at the CIA, the question being studied was “Could others get results like mine?” That study used intelligence officers, trained murderers and assassins. We all have that “soldier” inside of us waiting to come out if we get put in bootcamp. I gave them a different kind of bootcamp. It was only a week long and it was mainly changing their hearts and minds; I don’t like physical exercise much. After that week was over, they manned a phone line to a village a couple hours a week like I had years before. The birth rates were studied for several years after that. Their listening and helping people problem solve also made a difference, depending on how they did it. If they were authoritarian, the villagers felt threatened even at a distance and the population growth rate went up. If they were loving and helped by supporting the goals of the villager, the birth rates went down. One man got better results than I had. Overall, about 25% of those trained killers managed to change enough to get an excellent result, the population decreased by contentment flourishing. About 40% got the result of the population staying the same. And about 20% got no change in population growth, and about 15% made the population growth rate worse. It was still not as bad as after a war or a famine.

The Cabal causes the very problem that they say is so serious that it requires the drastic measure of killing—their harsh authoritarian stance is a major cause of population overgrowth. Note, I did not help people solve their problems by making them lazy. Passing out money in welfare programs is not love. That is not to say that passing out money it never appropriate. When one loves someone one can see, by the grace of God how to help them. A social program without love it not much different than being given a number at Auschwitz, it dehumanizes the person. It is no wonder that government social programs often fail to give real and lasting benefits. Yet when the people running them do have love in their hearts and are allowed to give it in that setting, much good can come of it. All too often programs are rule based prisons of the mind that destroy love and prevent creative thinking. It doesn’t have to be that way.

One of the reasons that I think we didn’t get as good a result on that population control study of my students, is that the framework was static. It did not allow my students to figure out creatively how they could best help a village. I am sure that some of them would have been best going out to a village and listening to the people while playing sports or hiking with them. They could have listened while doing outdoor work with them that helped the village. Frankly, I think that in many cases the villagers never told them their most pressing problems, and that was one of the biggest difficulty in the study. Gaining the trust of others can be a big problem, if the CIA officer has spent decades lying, conning and killing. A week of empathy training may not be enough to change a hardened criminal into the saint that they were meant to be. Since the CIA would not let me solve the biggest problem that they have at the CIA, it is not surprising that the CIA officers had trouble solving the biggest problem of those villages.

The sheer number of non-elite means that they could in fact easily defeat the wealth by non-violent organization. So, the major tool of the elite is to convince the public that they are powerless so that they do not try. Gandhi, Nelson Mandela, Cindy Sheehan, Martin Luther King, and many others have shown that people without money or govt. titles are indeed very powerful when dedicated.

ROCKFELLER AND MASS MURDER

The ROCKEFELLER Foundation is the PRIME SPONSOR of public relations for the UNITED NATION'S drastic depopulation program, which the world is invited to accept at the UN's scheduled September conference in Cairo, Egypt. Evidence in the possession of a growing number of researchers in America, England, and Germany demonstrates that the Foundation and its CORPORATE, MEDICAL, and POLITICAL associates organized the racial MASS MURDER program of NAZI GERMANY. These globalists, who function as a conduit for British Empire geopolitics, were NOT stopped after World War II. The UNITED NATIONS alliance of the old NAZI rightwing with the NEW AGE leftwing poses an even graver danger to the world today than the same grouping did in 1941. Oil monopolist John D. Rockefeller created the family-run Rockefeller Foundation in 1909. By 1929 he had placed \$300 million worth of the family's controlling interest in the Standard Oil Company of NEW JERSEY [later called 'EXXON'] to the account of the Foundation. The Foundation's money created the medical specialty known as PSYCHIATRIC GENETICS. For the new experimental field, the Foundation reorganized medical teaching in Germany, creating and thenceforth continuously directing the "Kaiser Wilhelm Institute for Psychiatry" and the "Kaiser

Wilhelm Institute for Anthropology, Eugenics and Human Heredity." The Rockefellers' chief executive of these institutions was the fascist Swiss psychiatrist Ernst Rudin, assisted by his proteges Otmar Verschuer and Franz J. Kallmann. In 1932, the British-led "Eugenics" movement designated the Rockefellers' Dr. Rudin as the president of the worldwide Eugenics Federation. The movement called for the killing or sterilization of people whose HEREDITY made them a public burden. THE RACIAL LAWS... A few months later, Hitler took over Germany and the Rockefeller-Rudin apparatus became a section of the Nazi state. The regime appointed Rudin head of the Racial Hygiene Society. Rudin and his staff, as part of the Task Force of Heredity Experts chaired by SS chief Heinrich Himmler, drew up the sterilization law. Described as an American Model law, it was adopted in July 1933 and proudly printed in the September 1933 Eugenic News [USA] with Hitler's signature. The Rockefeller group drew up other race laws, also based on existing Virginia statutes. The "T4" unit of the Hitler Chancery, based on psychiatrists led by Rudin and his staff, cooperated in creating propaganda films to sell mercy killing [euthanasia] to German citizens. The public reacted antagonistically: Hitler had to withdraw a tear-jerker right-to-die film from the movie theaters. The proper groundwork had not yet been laid. Under the Nazis, the German chemical company I.G. FARBEN and Rockefeller's STANDARD [EXXON] OIL of New Jersey were effectively a SINGLE FIRM, merged in hundreds of cartel arrangements. I.G. FARBEN was led up until 1937 by the Warburg family, Rockefeller's partner in banking and in the design of Nazi German eugenics. Following the German invasion of Poland in 1939, Standard Oil pledged to keep the merger with I.G. Farben going even if the U.S. entered the war. This was exposed in 1942 by Sen. Harry Truman's investigating committee, and President Roosevelt took hundreds of legal measures during the war to stop the Standard - I.G. Farben cartel from supplying the enemy war machine. In 1940-41, I.G. Farben built a gigantic factory at Auschwitz in Poland, to utilize the Standard Oil / I.G. Farben patents with concentration camp slave labor to make gasoline from coal. The SS was assigned to guard the Jewish and other inmates and select for killing those who were unfit for I.G. Farben slave labor. Standard-Germany president Emil Helfferich testified after the war that Standard Oil funds helped pay for SS guards at Auschwitz. In 1940, six months after the notorious Standard-I.G. meeting, European Rockefeller Foundation official Daniel O'Brian wrote to the Foundation's chief medical officer Alan Gregg that "it would be unfortunate if it was chosen to stop research which has no relation to war issues" -- so the Foundation continued financing Nazi "psychiatric research" (which translates into "mind control" research. - Branton) during the war. In 1936, Rockefeller's Dr. Franz Kallmann interrupted his study of hereditary degeneracy and emigrated to America because he was half-Jewish. Kallmann went to New York and established the Medical Genetics Department of the New York State Psychiatric Institute. The SCOTTISH RITE of Freemasonry published Kallman's study of over 1,000 cases of schizophrenia, which tried to prove its hereditary basis. In the book, Kallmann thanked his long-time boss and mentor Rudin. Kallmann's book, published in 1938 in the USA and Nazi Germany, was used by the T4 unit as a rationalization to begin in 1939 the murder of mental patients and various "defective" people, perhaps most of them CHILDREN. Gas and lethal injections were used to kill 250,000 under this program, in which the staffs for a BROADER murder program were de-sensitized and trained. DR. MENGELE... In 1943, Otmar Verschuer's assistant Josef Mengele was made medical commandant of Auschwitz. As wartime director of Rockefeller's Kaiser Wilhelm Institute for Anthropology, Eugenics and Human Heredity in Berlin, Verschuer secured funds for Mengele's experiments at Auschwitz from the German Research Council. Verschuer wrote a progress report to the Council: "My co-researcher in this research is my assistant the anthropologist and physician Mengele. He is serving as Hauptsturmfuehrer and camp doctor in the concentration camp Auschwitz.... With the permission of the Reichsfuehrer SS Himmler, anthropological research is being undertaken on the various racial groups in the concentration camps and blood samples will be sent to my laboratory for investigation." Mengele prowled the railroad lines leading into Auschwitz, looking for twins -- a favorite subject of psychiatric geneticists. On arrival at Mengele's experimental station, twins filled out "a detailed questionnaire from the Kaiser Wilhelm Institute." There were daily drawings of blood for Verschuer's "specific protein" research. Needles were injected into eyes for work on eye color. There were experimental blood transfusions and infections. Organs and limbs were removed, sometimes without anesthetics. Sex changes were attempted. Females were sterilized, males were castrated. Thousands were murdered and their organs, eyeballs, heads, and limbs were sent to Verschuer and the Rockefeller group at the Kaiser Wilhelm Institute. (Remember, the Rockefellers were originally German immigrants to America. - Branton) In 1946, Verschuer wrote to the Bureau of Human Heredity in London, asking for help in continuing his "scientific research." FACELIFT... In 1947, the Bureau of Human Heredity moved from London to Copenhagen. The new Danish building for this was built with Rockefeller money. The first International Congress in Human Genetics following World War II was held at this Danish institute in 1956. By that time, Verschuer was a member of the American Eugenics Society, then indistinguishable from Rockefeller's Population Council. Dr. Kallmann helped save Verschuer by testifying in his de-nazification proceedings. Dr. Kallmann created the American Society of Human Genetics, which organized the "Human Genome Project" -- (based at Los Alamos Labs and in turn the more covert research-and-development projects within the Dulce, New Mexico base -- which is also involved in researching any and every

form of sophisticated occult-technology imaginable. - Branton) a current \$3 billion physical multiculturalism effort. Kallmann was a director of the American Eugenics Society in 1952 and from 1954 to 1965. In the 1950s, the Rockefellers reorganized the U.S. eugenics movement in their own family offices, with spinoff population-control AND abortion groups The Eugenics Society changed its name to the "Society for the Study of Social Biology", its current name. The Rockefeller Foundation had long financed the eugenics movement in England, apparently repaying Britain for the fact that British capital and an Englishman-partner had started old John D. Rockefeller out in his Oil Trust. In the 1960s, the Eugenics Society of England adopted what they called Crypto-eugenics, stating in their official reports that they would do eugenics through means and instruments not labeled as eugenics. With support from the Rockefellers, the Eugenics Society [England] set up a sub-committee called the INTERNATIONAL PLANNED PARENTHOOD FEDERATION, which for 12 years had no other address than the Eugenics Society. (Note: Margaret Sanger plays a central role in this PLANNED PARENTHOOD network. And people blast Rush Limbaugh for calling Sanger a "Femi-Nazi" when in fact that's exactly and literally what it comes down to, when one considers her full support of the Nazi's 'Aryan' racial supremacy philosophies. In the 1980's there were an estimated 50 MILLION or more abortions worldwide, many of which can be attributed to the genocidal agendas of PLANNED PARENTHOOD. In her book 'PIVOT OF CIVILIZATION', in reference to free MATERNITY care for the poor, Sanger states: "Instead of DECREASING and aiming to ELIMINATE THE STOCKS that are most detrimental to the future of the race and the world it tends to render them to a menacing degree dominant." And in reference to her 'Negro Project' of the late 1930's, which aimed at recruiting black ministers, physicians and political leaders for the purpose of encouraging birth control and sterilization in the black community, Sanger wrote: "...We do not want word to go out that WE WANT TO EXTERMINATE THE NEGRO POPULATION, and the minister is the man who can straighten out that idea if it ever occurs to any of their more rebellious members." Since Sanger is part of the 'ARYAN' SUPREMACY agenda, it is remarkable that she would allow information about Planned Parenthood's REAL genocidal agenda to slip out through her writings. The core issue of most of the incendiary pro-abortion / anti-abortion arguments should not be whether a Mother's right to KILL a human being with a beating heart supersedes a child's right to LIVE. That's merely a means that Planned Parenthood has used to conceal their Fascist genocidal agendas -- that is to hide them behind divisive arguments about 'Constitutional Rights' of Mothers vs. those of children. The CORE issue should be whether or not fascist white supremacists should commit genocide against targeted 'non-Aryan' races through abortion, sterilization, infanticide, and other methods. - Branton), This, then, is the private, international apparatus which has set the world up for a global holocaust, UNDER THE 'U.N.' FLAG.
