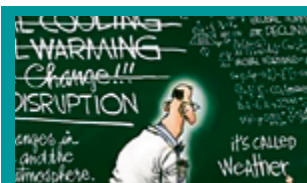

UK doctors call for end to covid vaccines

"WHEN we became doctors, we took an oath to do no harm, and that oath needs to be honoured."

"Harms being caused by these vaccines are quite apparent, and the media are silent about this."

"The data is alarming and the vaccines need to be stopped."

"Unsafe, not effective; the rollout is unethical and unnecessary."

"Stop all the boosters immediately."

The above are all quotes from a press release by Doctors for Patients UK (DFPUK), which was launched in September 2022, and is a fast-growing group of UK doctors who are dedicated to practising ethical, evidence-based, patient-centred medicine.

The group was borne out of increasing concerns that core principles of medical ethics are being disregarded, such as the oath to 'first do no harm', respect for individual bodily autonomy, and the need to obtain full and informed consent for all medical interventions.

Many doctors, in the UK and internationally, have become increasingly concerned about the safety profile of covid-19 vaccines, and the continued rollout of these products to the public, including to pregnant women and children. Several doctors in DFPUK have submitted multiple Yellow Card reports of adverse events to the MHRA, and have signed letters to the JCVI, MHRA, the RCOG, the Prime Minister and others to express their concerns, but have seen little or no response, nor action taken.

They have, therefore, now compiled a video in which they share their individual perspectives, clinical experiences and serious ethical concerns, in the hope that more doctors will join them, and urgent action will finally be taken by the authorities.

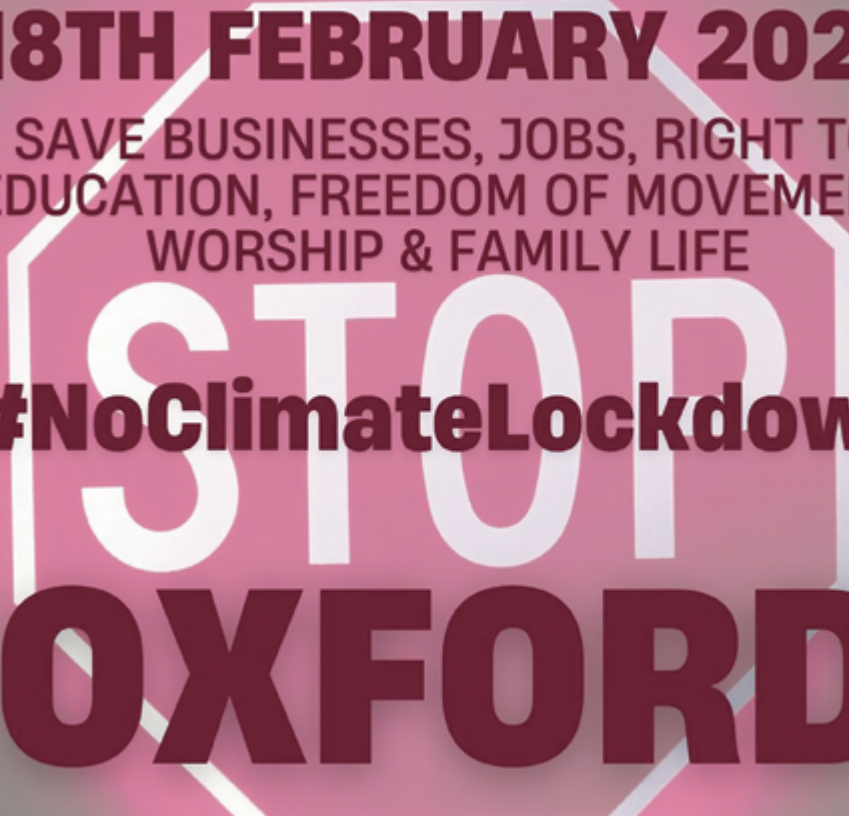

Just who are the ‘experts’ of the UK’s health regulator?

Court rules politicians are above the law

IN the Belfast High Court case against Robin Swann, Naomi Long, Jim Shannon and Mike Nesbitt, the judge stated that politicians do NOT owe us a duty of care.

A private lawsuit against the four high profile politicians over the implementation of coronavirus regulations in Northern Ireland is to be struck out, the High Court has ruled.

The barrister for Crown solicitors, Mr Fee, stated on behalf of two of the four defendants: "Any case against us is hopelessly weak and has no prospect of success."

Let that sink in. ANY case. Our elected representatives, whose only job and purpose is to act on our behalf and with our best interest in mind - those whose votes and decisions impact millions of lives and livelihoods - do NOT owe us a duty.

And they feel that they are above the law and immune from prosecution. That begs the question: what are we paying their big wages for? Why are we funding their staff and constituency offices and all their other expenses?

These, and many other questions, were put to the Belfast High Court by Jody Nesbitt and his wife Diana, after fruitlessly trying to engage with the above-mentioned politicians since March 2020.

Before March 2020, the plaintiffs, Jody and Diana, were involved in hospitality and show business. Jody owned a guest house, Legacurry Mill, near Lisburn, was renovating Gosford Castle, Armagh and building a hotel complex in Newry. Diana was a wedding photographer as well as performer for a successful Abba tribute band. In March 2020, their livelihoods were taken away without any meaningful support.

No furlough, no grants, no words of explanation as to how to feed their two children. Jody and Diana started contacting their local politicians, asking them what rationale and science they had to support their decision to shut down society, while picking and choosing who can work and who

can't, who is worthy of financial help and who is not.

Jody and Diana were doing a lot of research into the science behind covid, all the measures being put in place, and their lawfulness. They sent multiple Freedom of Information requests to health and social care trusts, surgeries, constituency offices, the education sector and other public sector departments.

They united their efforts with local and international rationally-thinking laymen, health, science, and law professionals, and discovered that not only was the 'pandemic' a global lie based on a PCR fraud, but that none of the politicians or public servants had any scientific information available to them to vote for the Coronavirus Act and all its subsequent implications.

'The department does not hold that information' was a standard response. Everyone blindly followed orders from above.

For over a year, the plaintiffs were trying to engage with the defendants, calling for public debates, asking questions, seeking clarifications, and supplying in-depth research and evidence of covid fraud. The defendants would not read or listen. Had they listened, the health and economic disasters we are seeing now would have been averted. 'How am I expected to understand this? I am not a scientist' was another oft-heard response.

None of the defendants were willing to even consider the evidence. None did the due diligence to inform themselves about something they voted for. None cared. Public servants who did not care about the public.

The plaintiffs had no other option but to go to court to seek justice as litigants in person, as no lawyer would agree to help, or couldn't due to conflicts of interest (because they had represented the government before).

The plaintiffs' statement of claim contained 22 causes of action including, but not limited, to misfeasance, breach of fiduciary duty, fraud by misrepresentation,

negligence and wilful neglect.

Shortly after launching papers in court, the plaintiffs had a visit from police, investigating them for a harassment case, initiated by Jim Shannon and Mike Nesbitt. Diana and Jody were interrogated separately in locked rooms, under caution, by Bangor CID in August 2021.

On August 9 2021, they paid a peaceful visit to Jim Shannon's constituency office in Newtownards, to serve some lawful notices, and to enquire why the face-covering signage on the door did not mention anything about exemptions. Jim Shannon's staff aggressively confronted Diana. She caught the whole incident on camera.

Master Bell, sitting at the High Court, ruled that if there is no case law in the past to prove that politicians were ever held accountable for their actions under personal liability, then it was not going to be possible now or in the future.

The plaintiffs, however, upon carrying out comprehensive research into a huge amount of case law, were able to find it and presented it to the judge during the two-hour hearing. They also presented in great detail that they passed the Caparo test used for determining duty of care.

Master Bell ignored that case law, and applied personal discretion to dismiss all causes of actions.

All of us are equal and no one is above the law

The cornerstone of justice: Do no harm

IN 2019, 11 Supreme Court Justices reaffirmed the Rule of Law across the United Kingdom, though this may come as a surprise to many of us who have borne witness to events since.

In what was essentially an argument between government and Parliament about who the boss is, the Supreme Court confirmed the constitutional position established by the Bill of Rights (1688) that Parliament is sovereign, but sovereign only over the government. Parliament as legislature has no authority over anyone other than the government (the executive).

Importantly, the Supreme Court did not stop there, as that would allow for a corrupted Parliament to approve governmental interference in our lives beyond the constitutional constraint to do no harm.

The court reaffirmed the correct constitutional position as evidenced by both the Bill of Rights and the Coronation Oath Act 1688, that it is the court and the court alone that determines the lawfulness of what they, Parliament, approve.

This is law; it is fundamental to recognise that legislation is not law, a common error which disrupts our ability to go peaceably about our business.

The judiciary then went further still, and said that it is the people who create the law of the land through the independent judiciary, after all, as the Act of Settlement (1700) clearly states: “...the Laws of England are the Birthright of the People thereof.”

Hence, from an argument between the government and Parliament

as to who is the boss, it transpires that the court has restored the position that it is we, the people, who are the boss, in keeping with our founding constitutional documents.

Indeed, when viewed from on high, our forebears bequeathed an incredibly elegant system of lawful governance whose beating heart is to do no harm. However, before we explore this any further, it is necessary to bring God into the courtroom.

Simply put, until such a time as we can bring the Creator (howsoever you may see it,) into the court, to provide first-hand, cross-examinable witness testimony that any individual, or group of individuals, can impose their will upon another, then it is self-evident that all are equal under the law, and that no one is above the law.

To understand what it means to be equal under the law, you need to apply one simple question: can I also do that? If the answer is no, then the action to which you are applying the question is unlawful. That no one is above the law simply means that we are all accountable for any harm we cause.

In 2019, when those 11 Supreme Court justices, flanked by an expensive retinue of silks, delivered a verdict that Boris Johnson was not able to prorogue Parliament, they would no doubt have arrived more promptly at the same verdict had they simply asked whether they themselves - or indeed, you or I - are able to do similarly. Clearly, I cannot prorogue Parliament, and consequently, neither could Boris Johnson.

‘What one can do, all can do’ is the simplest and most efficient test of whether something is lawful or not.

Turning back to our lawful governance arrangements, with a fuller understanding of its central tenets in hand, we can now sketch out how the monarch swears to govern us according to our laws

and customs, by instituting a government controlled by an independent Parliament.

And it is a Parliament constrained to do no harm to the people, and whose every act is subject to the independent judiciary to determine whether they are acting lawfully or not.

Following this, and understanding that we are all equal under the law and nobody is above the law, it is illegal for any individual or group of people (for instance, Parliament) to knowingly impose their will upon any other person without first obtaining their consent, freely given.

In this way, and only in this way, are our duties, rights, and obligations created, i.e., by

contract. Clearly, if I cannot tell you what to do without first having reached an agreement, then neither can anybody else.

Not one item of parliamentary legislation has the people as a contracting party, due to the impossibility of obtaining the consent of all the people.

Similarly, the judiciary, the police, and all officers of the state are bound under contract of their oaths, attestations or affirmations, through which their respective duties, rights and obligations are created. These contracts are the social contract, and unless you are in possession of one, then you have none of those duties, rights, or obligations bar one, to do no harm.

Our constitutional arrangements are an elegantly designed contractual set of arrangements such that the parties to the agreements are bound over to keep the peace (do no harm), corralled by an independent judiciary in which the people create the law.

It is precisely here where our collective obligation arises. Should we wish to properly restore the one right that is foundational to us all, the right to do whatever we wish, save that which causes another harm, then we are obligated to act, in the face of harm, to see that the peace is kept.

Unravelling the covid-climate narratives

Behavioural science emerging as underhand political tool

THE extraordinary range of events that have occurred across the world since 2020 seems to be unprecedented historically.

But most of these seemingly disparate events are all part of the same programme, an agenda to delete human freedoms under the guise of permanent crises.

Klaus Schwab has made the point repeatedly: the pivotal event of recent times, covid-19, provided a 'window of opportunity' for a societal, economic and political transition that will supposedly save us all.

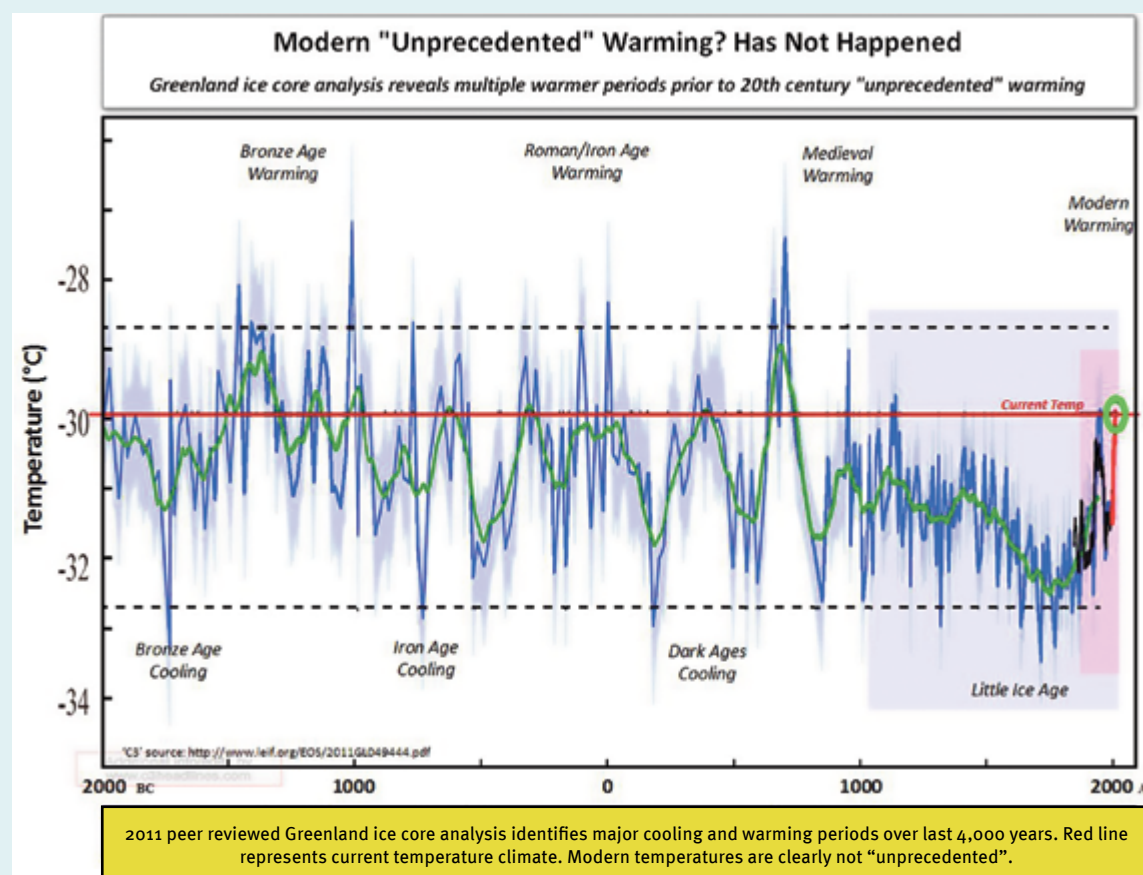
Therefore, the proposed 'Great Reset' is often discussed in reverential tones, implying that 'God's Great Plan' is both inevitable, unchallengeable, and is being undertaken in our best interests.

With extraordinary timing, Schwab's book detailing *The Great Reset* appeared in the summer of 2020, outlining the case for urgent change if we were to survive as a human species.

Embellishing the rhetoric from a long line of left-leaning politicians, academics and social commentators, the argument goes something like this: whilst globalisation itself is a good thing, the downside of more open borders, global trading arrangements, and cross-fertilisation of cultures, means that there must be much more stringent regulation, monitoring and control.

Therefore, covid-19 dovetailed neatly with the climate crisis, crime and terrorism, as issues which can transcend domestic policy initiatives, evade national security measures, and demand some kind of response at a supranational political level.

The acceleration of climate change as a greater political priority in the late 1990s/2000s introduced a raft of measures that were aimed specifically at changing behaviour at an individual (as opposed to institutional) level, as a way of directly engaging the public in reducing their 'carbon footprint'.



The public apathy which characterised previous attempts to persuade most of the population that there is a climate crisis has been turned on its head by the enforced behavioural change of the two lockdowns of 2020/21.

The focal point for this was the Climate Change Act in 2008, where the then Labour Government pledged to reduce the UK's carbon emissions by 60% (later revised to 80%,) by the year 2020.

The aftermath of what some argued was evidence that the government was beginning to take climate change seriously, witnessed the beginning of a much more direct interface between academia and policy, as government officials sought to harvest the most influential academic findings on human behaviour.

From the late 1990s, the government developed a suite of policies designed to reduce energy demand at a consumer level – primarily by changing or nudging attitudes, values and behaviours.

Reducing or curtailing car

journeys, switching to renewable fuels and sustainable ways of generating energy, turning off lights, and purchasing more energy efficient appliances have become mainstream policy objectives in the UK's carbon governance agenda since the turn of the century.

It was the environmental debate which made changing behaviour a more central feature of government policy, although issues such as health also targeted individuals for their lifestyle choices. This emerging agenda also highlighted the closer political ties between policy and social scientific research into human behaviour.

Directly encouraging widespread behavioural shifts also signposted some of the challenges for policy makers when attempting to engage more directly with citizens on specific

policy outcomes. Perhaps the biggest obstacle revealed itself as the latent widespread public apathy and scepticism over climate change itself.

This could be observed, for example, in the disastrous uptake of the UK green deal and other incentive-based approaches to reducing household energy use. The widespread opposition to wind farms was also indicative that many of the general public were not going to be so easily persuaded by the more visible effects of a 'green' transition on their immediate landscapes.

It is interesting to compare the different levels of public buy-in to the climate crisis and to the advent of covid-19. The general levels of scepticism over the degree of threat posed by the climate crisis, for example, contrasted sharply with the

perceived immediate threat of an infectious and unknown disease. The UK Government was able to leverage the perception of this threat to far greater effect than they had in delivering the climate crisis message.

The lockdown measures, keeping people in their homes, social distancing, mask-wearing, and then eventually large-scale vaccination programmes, all culminated in a radical transformation in attitudes, behaviours and social norms, and an unprecedented level of change in public behaviour, wartime excepted.

Clearly, it was a more difficult undertaking to deploy the climate change message as a direct behaviour modification tool, as the concept itself is noticeably more abstract, less linear in its implications, and, for most, constitutes a non-immediate issue.

The climate crisis has now been carefully reintroduced and woven onto the back of the covid narrative, and builds on the more top-down approach to changing behaviour that was introduced by the pandemic. For example, the International Energy Agency declared in 2021 that the lockdowns since 2020 had seen 'an unprecedented 6% reduction in carbon emissions, as global energy demand was slashed during this period'. The media highlighted the clear blue skies resulting from ten weeks of lockdown, hinting at the implications of a society of this kind over the longer term.

A tweet released by the World Economic Forum (and then hastily withdrawn) proposing that 'lockdowns are quietly improving cities around the world', suggests that these may have been a testing ground for what is to come.

It is clear to most people who have been following the main narrative that the climate crisis has long served the cause of those who are part of the higher echelons of politics, business and banking, who have advocated for greater control and regulation of the Earth's resources.

‘Footballers are no longer being asked to have vaccines’

Are you getting private support from others in football who agree but don't want to speak out?

Yes absolutely. I got a letter together to get a meeting with the FA and PFA regarding vaccines for footballers and the amount of players that were collapsing on the field last year. When I rang around my contacts, I spoke to about 90 ex-players, and I think only two didn't want to put their names to a letter calling for an investigation. So people are aware of it, they will sign letters, but whether they are prepared to speak out in public is a different thing.

It seems to have calmed down – we've just had the World Cup and there were no collapses?

I sent stuff to the FA doctor whenever people collapsed on the pitch, investigations were taking place, or scientific papers regarding myocarditis in young men were released – and the last time I sent one, I was told that the footballers are no longer being asked to have vaccines.

That may be one of the reasons why it's calmed down a bit – they've stopped taking them. Although I had lunch with a former team-mate of mine, who confided in me that he'd had the booster and has since been suffering with heart problems.

So it's hard because there are still people taking them and they obviously don't realise the risks involved, and it's sad.

But there was no big announcement from the Premier League clubs, because that would end it, wouldn't it?

Yes, it was all done very quietly. I didn't know until the FA doctor told me about it two weeks ago; it came as a surprise to me. I don't know how long that's been in place for. I played golf with a couple of Premier League players last summer, and they said it was probably about 50/50 in their squad who were vaccinated or not.

You could see when the clubs went on pre-season tours, the ones that had 'niggling injuries' were the ones who couldn't get into the country because they hadn't had it, so they had to stay at home.

Couldn't people say you're in a position to speak out because you've retired, you've got your life set, not relying on pundit income etc...?

To be honest, I'm not set for life – I have to work. I still have a mortgage and a lot of outgoings every month, so I still have to have work.

But I knew the risks of speaking out, and I lost my job at Sky. That was a scary time, because I didn't know where the money was going to come from. I wasn't in a position where I could say 'I'm rich enough and I can say what I want'. I still had sacrifices to make, and I knew what could happen by speaking out, and I still chose to anyway because I believe it's right, and things have worked out.

I have picked up other work, and managed to keep going and pay all my bills, and I believe that's a bit of karma. I did the right thing, and got rewarded for good actions and good deeds – that's something I'm quite at peace with.

Was it the covid scam that woke you up?

I've always tried to have my own thoughts on things, and not be manipulated into thinking in a certain way.

The first thing I can think of is probably 9/11, where nothing made sense. Just little

things that happened that made you go 'hang on a minute!' One of the things was the conveniently found passport of one of the terrorists. I went 'that whole building's collapsed and they found a passport in the debris that just happens to be from the bloke on the plane!' Then you have architects and engineers' testimonies who say 'that can't happen', and all of it is being suppressed.

Then covid came along and I started looking into it, and saw some credible people who said 'this has been planned for a long time, and this is what's coming next – we're going to have mandatory vaccinations and digital passports'. You watch it all play out and that should make you very suspicious.

Terrain theory or germ theory?

Something I hadn't heard of until about a year ago, but I've asked that question to a couple of doctors who I've had on the podcast. There are more and more doctors now who are questioning the germ theory, and thinking what they've been taught isn't quite right. Dr Tess Lawrie was very open, and said she was going to look into this more because of what's gone on in the last two years.

You have to question everything you've been taught, and re-evaluate it with a different set of eyes.

Are any vaccines safe or effective?

Last time I had a flu vaccine was about 25 years ago. It made me quite ill for a couple of weeks and so I haven't had another one, or the flu, ever since.

I've seen some interesting graphs which pointed out that a lot of the diseases that vaccines are claimed to have successfully cured were actually reducing anyway, because of clean water and better sanitation etc., and the vaccines were only brought in late on and didn't change any trajectory.

I'm not qualified to say whether any are safe or effective, but I would need more evidence now to believe they were.

Then you start looking into scientific research and who funds it - the

pharmaceutical industries who are some of the most corrupt organisations in the world. If you look at how many times they've been fined criminally, and the amount they've been fined for the unethical things they've done - I no longer trust the pharma industry and scientists who are funded by them.

I'm completely confident that they won't get their chip implants, and I don't think they're even going to get to cashless, because we're going to fight so hard against it.

I think they'll definitely try to implement a cashless society, hoping people won't see what that is and what that leads to.

It's not difficult to imagine what goes on after you don't have any cash. When you have CBDC, they can turn your money off. So it's far more dangerous, and when they take away cash as an option, that's when you're in serious trouble.

I've learned that everything that happens, they need your consent to do it, so they're very sneaky about it. That's why mass noncompliance is the way forward, because if you don't comply, they then have to resort to illegal measures, and that's when we win, because that wakes everyone up.

What do you think our best hope is?

Keep pounding away and keep making people aware of what governments are trying to do to us – when people realise just how bad these things are they're trying to implement, and how much control they will have over us, then I think it only stops when enough people realise. I don't think there's anything legally that can happen, they seem to have got all that stitched up.

But if enough people just don't comply, mass peaceful noncompliance, that would make the biggest difference. Once you don't allow these people to implement their laws on you, you take their power away from them.

The Swansea witch hunt

Authorities are trying to crush those who defy them

IT was the mid-1700s in the UK when ordinary and often once well-respected women were turned upon by members of their own community.

Accused of witchcraft and making a pact with the devil, these women often lost everything.

So when Anna Redfern took a stand against the bewildering and nonsensical covid passport scheme in 2020, she soon found herself in a similar situation when Swansea Council fined her £5,000 and closed her premises.

Despite this action, and believing strongly in freedom of choice, Anna reopened the next day, and was overwhelmed by supporters who flooded her premises. Amongst these were Richard Taylor (who set up her Crowdfunder page) and other members from the Voice of Wales group, whom Anna mistook for a choir. Anna did not know who they were, and was unaware of their far-right label.

“There were three helping – a gay ex-safety officer, a mixed-race cameraman, and a family man with his wife and their three-year-old daughter. They seemed like good people.

“All I saw was kind human beings helping me in my time of need. If seeing the good in people is a crime, I’m guilty of that.”

The Crowdfunder raised £61,000 in three weeks. As this was more money than was needed, Anna attempted to donate it to the Town Hill Community Primary School Fund. Swansea Council, however, said that they, “cannot be seen to accept either 50p nor £50k from you, due to where the money has come from.”

With the business running at a loss since the lockdown, together with legal fees (£20,000) and fines (£15,000), the donated money was soon used up anyway, and Anna’s financial documents were dissected in court before being made available for the general public to also scrutinise.

Cinema & Co reopened in March 2022, but accusations of a far-right association - that she had made a pact with the devil - have damaged Anna’s reputation.

“The irony is, I’m being accused of the very thing I’m standing up against. There’s a running theme of hypocrisy.”

Swansea Council excluded Anna from the Swansea Fringe Festival, while the cultural community is also boycotting her, declaring that she “alienated the political left and the anti-racist forums in Swansea”. Anna

has also been excluded from the City Centre Conference, and she is no longer eligible for the Swansea Co-Working grant of £5,000.

“They’re never going to stop,” she said. “I bruised their ego by not doing what I was told – by not complying. I had a visit from licensing this week; they’ve got control over everything. Pollution threatened to put an abatement notice on me. They won’t stop until my business goes down the pan.”

Anna now cannot afford to pay herself or staff, as the business is £40,000 in the red, and people she considered friends will also no longer supply her.

The cultural community that she has loved and supported for years has turned its back on her. Voice.wales published an online article stating: ‘Hundreds in Swansea sign open letter to Cinema & Co – don’t let racists divide us!’ 200 signatures claimed that Anna enabled the far-right to further their message of bigotry and hatred, which Anna has always denied.

A shadow ban on social media means that Anna can’t advertise, so she has no way of promoting her cinema listings or events. It is a dire situation for Anna. She was naïve to trust people who said they wanted to help, but she was also brave to stand up for our rights and privacy during the chaos of the lockdown. We hear so often the mantras ‘support small businesses’, ‘buy local’, and ‘support the arts or lose them’, but are we really doing everything we can for independent business

owners in our communities?

Cinema & Co was once a lively, vibrant hub and place to meet – now it is mostly empty and running at a loss, and Anna, like the women accused of witchcraft, has found herself in ruins.

Whatever happened to the future?

IN the nineteenth century, Queen Victoria reigned in half of the world. It was said that the sun never sets on the British Empire, ubiquitously coloured pink on Mercator's projection.

After the carnage of the First World War in Europe, the American century was established. But as blatantly shown by the administration of Joe Biden, the Washington establishment is abandoning American exceptionalism for a new world order in which no single nation shall dominate. We are well into the third century of globalism: a post-democratic, post-liberal, post-traditional technocracy.

The British Empire was fired by coal, the Pax Americana by oil, and the global technocracy by silicon. For all their faults, the British imperialists propagated their civic systems and institutions. The neo-colonial Americans elevated popular culture above religion and ritual; although the USA was never really 'the land of the free', it was widely regarded as a land of opportunity. It seemed, particularly after the emancipatory movements of the 1960s, and later by the collapse of Soviet communism, that we were heading inexorably towards the sunlit uplands of liberating modernity.

The internet initially appeared to hasten this process. But it soon became a double-edged sword, as authoritarians used it for surveillance. Now the early dreams have been dashed by an unholy alliance between governments and Big Tech to control the narrative by systematic censorship. The information superhighway is becoming a control grid.

Drawing patterns across the complexity of history is, unavoidably, a simplification. As well as the British ruling class and American 'deep state', globalisation has involved other important actors: industrial Germany (whose leading scientists under the Third Reich were brought to the USA by Operation Paperclip), the Jewish intelligentsia (mostly a force for good, but also including the cultural Marxists of the Frankfurt School and Hollywood moguls pushing propaganda), global bankers and corporations, wealthy dynasties such as the Rockefellers (who monetised philanthropy), and of course transnational organisations such as the Bilderberg Group, Trilateral Commission and World Economic Forum that pursue one world government.

Since its revolution in 1949, China has been perceived by outsiders as an oppressive regime. Yet behind the scenes, globalists have seen the Chinese



way as the future: a collectivist society brought under technocratic tutelage. Its electronic monitoring of citizens, known as the social credit system, may seem dystopian to ordinary people acclimatised to liberal democracy. However, as shown by covid-19, our leaders have relinquished national autonomy to sign up to dictatorial globalism. The purported pandemic was one of a pair of Trojan Horses alongside the preposterous climate change crisis.

China demonstrated not only a radical lockdown to the world, but also brutal policing methods (allegedly the violent Victoria state police under the authority of covid-19 zealot Dan Andrews were trained

by the Chinese). After the tyrannical rule of Mao Zedong, China was helped by the West to become an economic powerhouse. While facing outwards with rapacious capitalism, its communist system maintains internal discipline, exploiting technological advances to record every person's movements. Under these conditions, China has been a testing ground for technocracy.

Western figures such as Justin Trudeau laud China because its totalitarianism allows society to be transformed to an extent that European and American globalists would like, but cannot readily impose due to lingering traditions of faith, flag and family. But they have made great strides with covid-19. Yuval Noah Harari, expert advisor to the World Economic Forum, pronounced the replacement of God, the soul and free will by genetic and biochemical engineering. The fourth industrial revolution has a transhumanist agenda, creating the internet of bodies.

How will the third act in this play end? World Economic Forum leader Klaus Schwab warns of civil unrest, as people realise that a technocratic elite will control every aspect of their lives. Humanity has a choice: either take a passive role, like the non-playing characters in video games, or rise in revelatory unison against these diabolical forces of darkness.

Earlier in his long and illustrious career, Ray wrote the classic album, *Preservation Act 2*. This album brought to life the career politician - those who would do anything to keep their careers, amass untold wealth and physical assets to the complete detriment of their fellow man.

Let’s take the above quote apart by looking at the way in which we, people of the world, have been manipulated.

- 1. Money: unelected organisations such as the World Economic Forum, International Monetary Fund and Bank for International Settlements have for decades been dictating to the general public how they can gain access to, and how they can spend, their hard-earned money.**

Open source is key to freedom

OUR world is highly complex and continuously evolving.

Think about how many decisions each of us makes in a day, such as what to eat, where to go, what to buy and so on. Everyone is making similar decisions each day, in our country and across the world.

It is little-known that a well-shuffled pack of 52 playing cards has almost no chance of appearing in the same order, anywhere else in the world. Why? Because the number of possibilities expands exponentially.

In 2022, we witnessed and experienced an explosion of activity to create expanding families of soulmates working together to help each other to survive and flourish, while reducing their reliance on the establishment. They aren't relying on governments, councils, corporations or established non-governmental organisations, but creating their own solutions, meeting locally in groups.

Opensource unleashed the power of the internet that gave rise to the sophisticated and complex information and communication technology we use everywhere today. The internet was started by DARPA (U.S. Defense Advanced Research Projects Agency), but it flourished as an opensource platform for collaboration, leading to the ubiquitous technology we use today to access information, communicate, conduct transactions and for numerous other applications.

Unlike proprietary organisations such as Apple, Google, Microsoft and

Amazon that appropriated opensource technology (because they couldn't create anything comparable for themselves), the opensource or free software movement has no 'command and control' mechanism, but is the product of distributed, autonomous but interdependent self-organisation. With opensource or free software, there are no licence fees required, nor restrictions on using, copying, adapting and sharing the applications for anything you want to do with computers and phones, on or offline. Developers and users have openly shared code, information and ideas over the last 40 years, to create and constantly improve most of what runs the internet and associated technologies, such as smartphones and the applications that run on them.

There was no blueprint or overarching plan for how the internet should evolve. It is the product of people solving their own and each others' technical and usability issues, through the constant sharing of code and ideas while collaborating to solve issues. This is the opensource methodology that can solve many of the major problems in the world we face today.

We cannot abdicate responsibility for ourselves and each other to so-called representatives, whoever they are or



however they are chosen or elected. Self-interest and corruption inevitably permeates all governments. Neither should we ever abdicate making moral judgements as to how we should live.

We can, however, self-organise through distributed but interdependent activity and groups to thrive.

The main challenge to overcome is how we mediate transactions and relationships with people beyond the boundaries of trust that exist within our families of soulmates. That is the subject for another article - on how we deal with value to overcome the shortcomings and disadvantages of current and historic monetary systems.

Those shortcomings and disadvantages too are being explored, and solutions are beginning to emerge from opensource collaboration.

Volunteer arrested for silent prayer near abortion facility

A CHARITY volunteer has been arrested and charged on four counts after she told the police she ‘might’ be praying silently, when questioned as to why she was standing on a public street near an abortion facility.

Police approached Isabel Vaughan-Spruce (pictured) standing near the BPAS Robert Clinic in Kings Norton, Birmingham. She was carrying no sign and remained completely silent until approached by officers. Police had received complaints from an onlooker who suspected that Vaughan-Spruce was praying silently in her mind.

“It’s abhorrently wrong that I was searched, arrested, interrogated by police and charged, simply for praying in the privacy of my own mind. Censorship zones purport to ban harassment, which is already illegal. Nobody should ever be subject to harassment. But what I did was the furthest thing from harmful – I was exercising my freedom of thought, my freedom of religion, inside the privacy of my own mind. Nobody should be criminalised for thinking and for praying, in a public space in the UK,” said Vaughan-Spruce following her arrest.

The censorship zone measure introduced by Birmingham authorities criminalises individuals perceived to be “engaging in any act of approval or disapproval or attempted act of approval or disapproval” in relation to abortion, including through “verbal or written means, prayer or counselling...”.

A thoughtcrime in UK law?

Vaughan-Spruce had stood near the abortion facility (while it was closed) on three occasions, in which she says she might have been praying.

Whilst in the police station, Vaughan-Spruce was shown pictures of herself outside the abortion facility. She said she could not recall from the pictures whether she was praying at these specific moments, or whether these had been taken at times that she was distracted and thought about other things, such as her lunch. She maintains that all her thoughts were equally peaceful and imperceptible, and that none should be criminalised.

“Isabel’s experience should be deeply concerning to all those who believe that our hard-fought fundamental rights are worth protecting. It is truly astonishing that the law has granted local authorities such wide and unaccountable discretion, that now even thoughts deemed ‘wrong’ can lead to a humiliating arrest and a criminal charge,” said Jeremiah Igunnubole, Legal Counsel for ADF UK, the legal organisation supporting Vaughan-Spruce.

“A mature democracy should be able to differentiate between criminal conduct and the peaceful exercise of constitutionally protected rights. Isabel, a woman of good character, and who has tirelessly served her community by providing charitable assistance to vulnerable women and children, has been treated no better than a violent criminal. The recent increase in buffer zone legislation and orders is a watershed moment in our country. We must ask ourselves whether we are a genuinely democratic country committed to protecting the peaceful

exercise of the right to freedom of speech. We are at serious risk of mindlessly sleepwalking into a society that accepts, normalises, and even promotes the tyranny of the majority,” he added.

As part of her conditions for bail, Vaughan-Spruce was told that she could not contact a local Catholic priest who was involved in pro-life work – a condition that was later dropped.

Police also imposed restrictions, as part of her bail, on Vaughan-Spruce engaging in public prayer beyond the PSPO area, stating that this was necessary ‘to prevent further offences’.

Vaughan-Spruce is the Director of the UK March for Life, and has volunteered for many years in support of women in crisis pregnancies.

“I have devoted much of my life to supporting women in crisis pregnancies, with everything that they need to make an empowered choice for motherhood. I am also involved in supporting women who have had abortions

and are struggling with the consequences of it. I’ve grown close to many of the women I’ve been able to support over the years, and it breaks my heart to know that so many more go through this every day,” explains Vaughan-Spruce.

“My faith is a central part of who I am, so sometimes I’ll stand or walk near an abortion facility and pray about this issue. This is something I’ve done pretty much every week for the last 20 years of my life. I pray for my friends who have experienced abortion, and for the women who are thinking about going through it themselves,” she continued.

Her arrest follows another recent incident in Bournemouth where a woman was told to leave by local authorities for praying, even outside of the local censorship zone.

Last year, a grandmother from Liverpool successfully overturned her charge on human rights grounds, after she was arrested and fined for praying silently near an abortion facility on a walk during lockdown.

In Westminster, parliamentarians are considering legislation to introduce censorship zones in England and Wales. Clause 9 of the Public Order Bill, currently under parliamentary debate, would prohibit pro-life volunteers from “influencing”, “advising”, “persuading”, “informing”, “occupying space” or even “expressing opinion” within the vicinity of an abortion facility. Those who breach the rules could face up to two years in prison.

A 2018 government review into the work of pro-life volunteers outside of abortion facilities found that instances of harassment were rare, and police already have powers to prosecute individuals engaging in unlawful activities. The most common activities of pro-life groups were found to be quiet or silent prayer, or offering leaflets about charitable support available to women who would like to consider alternative options to abortion.

The censorial provisions of the parliamentary bill drew substantive criticism from members of the House of Lords, including Liberal Democrat Peer Lord Beith, who deemed the clause “the most profound restriction on free speech I have ever seen in any UK legislation.” Lord Farmer called the clause “fundamentally flawed”, and asked: “When one walks past, one sees that vigils are often small groups of harmless, mainly female, pensioners. Why should they be banned and silenced?”

Clause 9 has caused great controversy following a statement released from the Parliamentary Under-Secretary of State shortly after MPs voted to include it, admitting that the clause “could not be said to be compliant” with Convention rights as protected in the European Court of Human Rights.

Baroness Claire Fox, who advocates for abortion, pointed out that “creating prohibitions on protest on an issue-by-issue basis is not an appropriate way to make law. It sets a precedent that will inevitably lead to attempts to prevent speech, expression, information sharing, assembly or the holding of protected beliefs around other sites or in relation to other controversial or unpopular causes.”

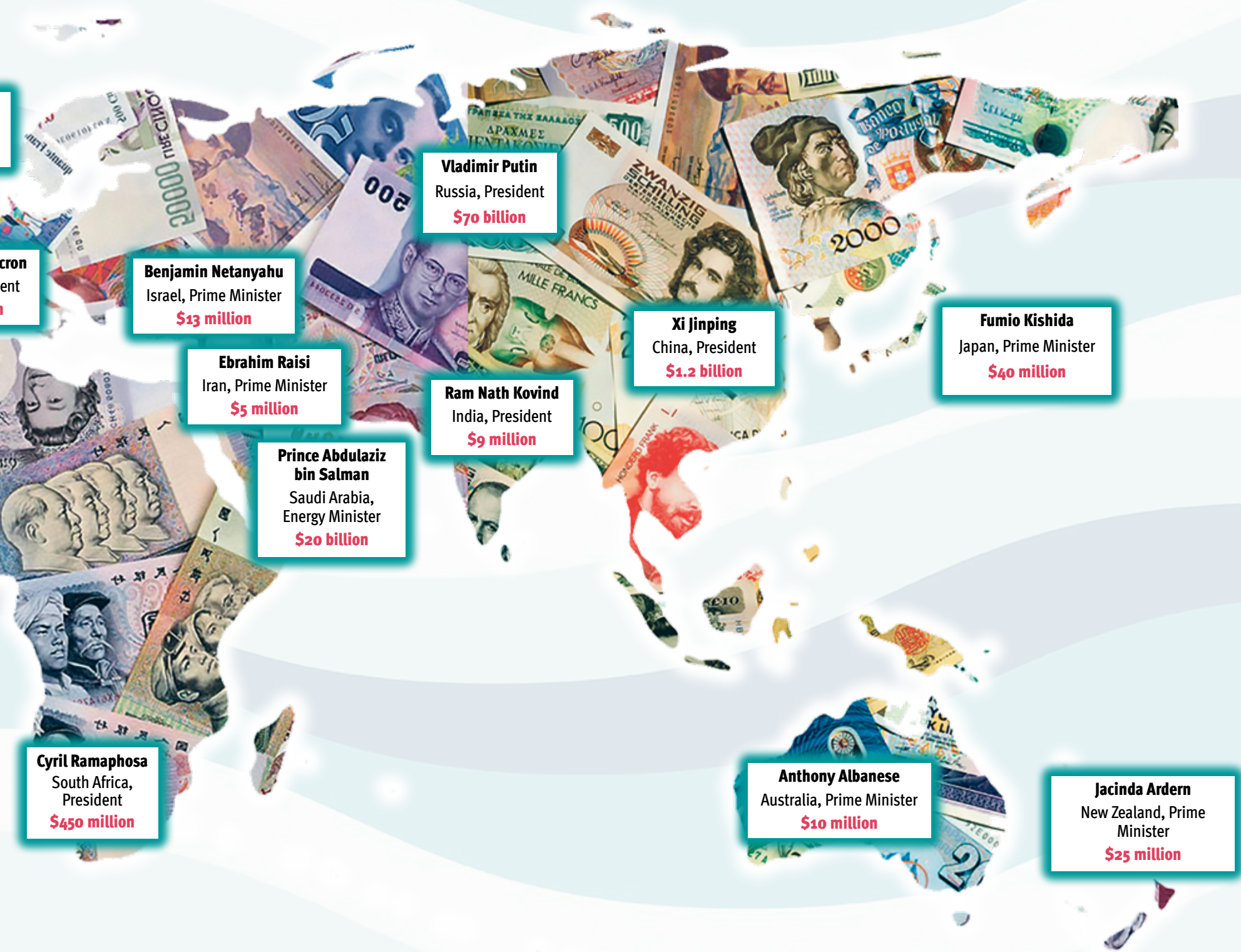

China's alliance with Saudis a complete disaster for Biden

NOTHING better illustrates the utter ineptitude of the Biden administration's dealings with the Middle East than Saudi Arabia's decision to forge a strategic alliance with China.

This is a time when Washington should be working overtime to strengthen its ties with long-standing allies like the Saudis, to combat the mounting threat Iran poses to the region's security.

Thanks to the Biden administration's wilful neglect of its relations with the Saudis, Riyadh is instead looking to build a partnership with Beijing, as was evident from the lavish reception given to Chinese President Xi Jinping during his state visit to the kingdom this month.

Rarely has a visiting leader been the recipient of such lavish state pageantry as Xi, after Saudi Crown Prince, Mohammed bin Salman, spared no effort to afford the Chinese leader a warm welcome, which included a jet escort on his arrival.

During his three-day visit, Xi held extensive talks with the Crown Prince, Saudi Arabia's de facto ruler, as well as other senior Saudi officials, and signed a strategic partnership agreement that will deepen ties between Riyadh and Beijing on a range of issues, from defence to technology.

One particularly eye-catching aspect of the agreement was a deal with the Chinese tech giant, Huawei, to supply the Saudis with cloud computing services and allow high-tech complexes to be built in Saudi cities, according to Saudi officials.

Huawei has been designated a potential security threat by the U.S., with intelligence officials claiming that the company has close links to China's ruling Communist Party, and could be used to conduct spying operations.

That Riyadh is now moving away from its traditional alliance with the U.S. and strengthening its ties with Beijing is a strategic disaster of epic proportions, and serves as a damning indictment of the Biden administration's careless

treatment of the Saudis, for which the president is personally to blame.

Biden set the tone for his strained relationship with the Saudi royal family during the 2020 presidential election, when he denounced the kingdom as a 'pariah' state over its involvement in the murder of Saudi dissident Jamal Khashoggi in Istanbul in 2018, although there has never been any audible distress from the Biden administration over Iran's 2007 abduction and presumed murder of ex-FBI agent,

Robert Levinson.

Russia's invasion of Ukraine, though, forced Biden to rethink his attitude towards the Saudis, when it suddenly dawned on him that he needed them to increase oil supplies to ease the pressure on world prices.

His efforts achieved little; the Saudis were apparently unimpressed with Biden greeting the Crown Prince with a fist-bump when he visited the kingdom in the summer, and he came away empty-handed, with the Saudis

and other Gulf states ignoring his pleas to increase oil production.

Now, thanks to Biden's incompetent management of the U.S.-Saudi relationship, Riyadh is looking to China to protect its interests, a move that confirms the alarming decline in U.S. influence in the region that has taken place in the vacuum created by Biden's leadership.

New Zealand demands citizens report 'conspiracy theorists'

Those who oppose government policies being branded 'terrorists'

THE authoritarian left-wing New Zealand government has ordered citizens to report their friends and family to the police if they suspect them of opposing government policies, including covid measures.

According to literature released by Jacinda Ardern's WEF-infiltrated government, New Zealand citizens who are suspected of being 'conspiracy theorists' will be investigated as terrorists.

Rebecca Kitteridge, director of the New Zealand Security Intelligence Service, explained that there are 'dozens of indicators' that suggest a family member or friend

U.S. gun shops claiming purchases being restricted

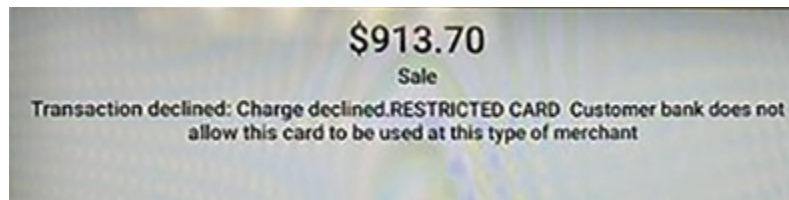

GUN rights advocates in the U.S. warned that a new requirement for the credit card industry, to add a firearm and ammunition-specific Merchant Category Code (MCC) for gun stores, could lead to the denial of lawful firearms purchases.

In September 2022, Visa, Mastercard and American Express all said they would adopt the MCC code to categorise sales at gun shops. Since then, both gun store owners and customers have complained online that they experienced card issues.

Twitter account, Battlecock Tactical, tweeted: 'Federal Firearms License [gun shop] in a Facebook group shared this. Looks like the doomers accurately called how that new firearms merchant code would go down.'

Battlecock Tactical posted an image of a retail POS (point of sale) system at an FFL (Federal Firearms License) that shows a \$913.70 transaction was declined. The error code on the merchant's computer reads: 'Transaction



declined: Charge declined. RESTRICTED CARD Customer bank does not allow this card to be used at this type of merchant.'

Someone with the handle AnarchyCoiner tweeted: 'I had this happen with my PayPal credit card. I tried to use it to buy ammo at my local FFL and it was denied.'

Another person wrote: 'Tried to buy a PSA (Palmetto State Armory) dagger slide a bit ago and had the same issue ordering from their website with my debit card - credit card let me order though.'

So perhaps the gun advocates were right from the get-go. As credit card companies were rolling out the new code in mid-September, National Shooting Sports Foundation lawyer, Lawrence Keane, said: "It was never about gathering data to aid law enforcement. It is, and always

has been, a concerted effort to pressure credit card companies to deny lawful purchases of firearms and put every single gun purchaser on a watchlist."

Could these be some of the first examples of backdoor anti-gun policies enforced through big corporations?

Ghana starts buying oil with gold

THE Government of Ghana has finally reached an agreement with petroleum refiners in the United Arab Emirates to supply the West African nation with petroleum products beginning this month under the Gold for Oil initiative.

Under this initiative, the Government of Ghana will be using gold in exchange for refined petroleum products instead of using U.S. dollars.

The move is part of the Akufo-Addo administration's effort to address the situation where oil importers chase dollars for oil import, thereby, putting pressure on the local currency, the cedi.

Vice President, Dr. Bawumia, broke the news in November 2022 when he said the government was



engaging oil firms to use gold to pay for oil.

Giving an update on the new initiative, Vice President, Dr Mahamudu Bawumia, wrote on his Facebook wall: 'I am happy to announce that the Government of Ghana has concluded the arrangements for the operationalisation of the Gold for Oil policy.'

'Consequently, the first oil products under the policy will be delivered next month (January 2023). My thanks to the Minister for Energy, Minister for Lands and Natural Resources, Governor of the Bank of Ghana, the Chamber of Mines, PMMC, NPA and BOST for their leadership in the operationalisation of the Government's Gold for Oil Policy.'

Wars are never in the people's interest

THE Ukrainian conflict is becoming a slaughter with no end in sight, and the risk of escalation is growing and can no longer be ignored.

Putin has blood aplenty on his hands, yet the simplistic propaganda narrative - that he randomly went mad one day and invaded Ukraine in a fit of expansionism - is absurd, and fails to acknowledge the well-documented role of the U.S. and NATO in fomenting this conflict.

As a thought-experiment, would those who claim it's none of Russia's business whether Ukraine joins NATO care to imagine London's response if a future independent Scotland were on the cusp of being lured into military alliance with Russia?

For months now, we have been hearing that Putin's troops are demoralised, ill-equipped and close to defeat, yet we are simultaneously fed that Russia poses an imminent expansionist threat to her neighbours such as Finland, Poland or Sweden. These propaganda narratives are mutually exclusive, therefore at least one of them must be false.

The bitterly suffering Ukrainians whom the politicians claim to champion won't benefit much from a pyrrhic victory at the price of reducing their country to rubble, and a pyrrhic or otherwise victory is never certain. General Smedley Butler famously declared that 'war is a racket'.

As always, the vested interests of the Military Industrial Complex and shadowy elites are set to be the only winners. Many of our vulnerable are already huddling hungry this winter. This is in neither our national interest nor our class interest. U.S./NATO victory via Ukrainian proxy forces will win us no spoils, yet defeat or mischance may conceivably result in escalation and greater harm.

This must be ended now by a negotiated peace, but where is the Peace Movement to demand it? Could it be that none now dare dream of peace? We must rise to the challenge.

Just over 100 years ago, journalist, H.L. Mencken, wrote: 'The whole aim of practical politics is to keep the populace alarmed (and hence clamorous to be led to safety) by an endless series of hobgoblins, most of them imaginary.'

Even when such a media-conjured hobgoblin has some basis in reality, responding with the fear and alarm the conjurers wish to instil to control us is never helpful.

Nature gifted us an adrenal fear response to shut down thought and prepare our bodies for 'fight or flight' from predators, falling rocks or other physical threats. Where there is no immediate physical danger, this fear response serves only to shut down our conscious minds, and open us to manipulation. The adrenal fear response is entirely maladaptive in withstanding a spiritual, psychological or political danger, and it sickens our bodies as well as our minds.

Is the supposed threat of nuclear war merely another such hobgoblin or fear-phantom? Maybe. Yet even if this danger is in some sense real, an adrenal fear response will not help us to mitigate it. Better dwell upon the profound wisdom contained in the 'Litany Against Fear' from Frank Herbert's 1965 novel, *Dune*.

Bertrand Russell once said: 'war does not determine who is right - only who is left'. It matters little which monger is right; all are wrong for choosing war over the 'jaw-jaw' of negotiation.

There are two paths now: one towards escalation and destruction, and another towards negotiation and peace. In negotiation, both sides must set aside strident nationalism and make compromises for the holistic good of all.

Are elections being stolen worldwide?

Fears raised over ‘fraudulent’ voting machines

TO suggest there was election fraud in the 2020 U.S. Presidential Election, according to the mainstream media, is an affront to democracy itself.

But many sceptics pondered how the mainstream media were so sure, without properly investigating the claims made.

State and federal courts dismissed the fraud claims almost unanimously. Because nothing says transparency more than a complete refusal to investigate, audit a vote or allow inspections of voting machines.

It has also crossed the minds of the sceptical as to how Joe Biden, a relatively unpopular former Vice-President, with a lacklustre governmental track record and corruption allegations hanging over him, accrued a record number of votes (81 million), while barely registering on the campaign trail.

Adding to the suspicion, the *2000 Mules* documentary by Dinesh D’Souza produced convincing evidence of coordinated voter fraud by mail-in ballot, analysing mobile phone satellite tracking data.

However, voting machines and voting software were claimed to be at the heart of the alleged fraud.

Fingers were pointed at the iconic hedge fund billionaire and notorious globalist, George Soros. But where does he feature in the elections controversy? Soros is a long-time associate and business partner of gold standard globalist, Mark Malloch-Brown (now Lord Malloch-Brown), who chaired the board of directors of election technology manufacturer Smartmatic’s holding company, London based, SGO Corporation Ltd. Smartmatic along with Dominion provide election systems in the U.S.

In 2005, *Time Magazine* listed Malloch-Brown, a paid-up member of the World Economic Forum (WEF) and climate change zealot, as one of the 100 most influential people in the world.

Formerly vice chairman of George Soros’s Quantum Investment Fund, he was duly promoted to president of Soros’s grant-making, leftist Open Society Foundation, shortly after the disputed November 2020 U.S. election.

Suspensions grew further directly after the election, when Smartmatic’s chairman, Peter Neffenger, was handed a position on the new President Biden’s transition team at the Department of Homeland Security. Mainstream media, including CNN, claimed during the election fraud controversy of

2020 that Smartmatic had played no part in the swing states. However in 2016, Smartmatic’s own website confirmed that it was offering election technology to 312 counties in 16 states, including swing states Nevada, Wisconsin, Florida, Michigan, Pennsylvania and Arizona. These are the battleground states that decided the election.

Also sitting on the SGO Board is Roger Pinate, the original co-founder of Bizta Corp, Venezuela - the predecessor of Smartmatic. Bizta was granted contracts worth \$131 million to provide election systems in the highly disputed recall

received feedback, and only then issued a tally sheet for the officials at the voting centres.’

Does this suggest that the machines are communicating with a totalising centre on a private server, and establishing the ‘required’ votes to switch from one candidate to another, before issuing final vote tallies?

Now it gets weirder: Jose Alfredo Anzola, also co-founder of Smartmatic, died aged 34 in 2008, in a plane crash deemed suspicious by aviation experts.

According to the *Boston Globe*, the pilot, Jose Mario Donadi Gafaro, a twice-

refused to accept the defeat, calling on the military to intervene. Millions have taken to the streets every day and night and the cry is the same as on January 6 in Washington... the machines have stolen the election. An independent analysis of the vote, using official data gleamed from Brazil’s Superior Electoral Court (TSE), showed the same inexplicable mathematical anomalies from voting machines that were witnessed in the U.S. 2020 election.

And in one win-margin category, Lula outperformed the polls by 72 times, picking up more than 80% of the vote, not in 0.3% of winning margins as polls might indicate, but in 22.1% of the results! There remains no explanation for why the machines could show such discrepancies from across Brazil, with the same demographics.

Now, in an unprecedented move, the Brazilian judiciary has declared it illegal to make election fraud claims, and threatened to make arrests.

Marco Antonia Costa, journalist and constitutional attorney, commented: “The electronic system is very doubtful, we have no transparency. When you question the authorities, they go after you, put you in a spiral of fear.”

There are also question marks over elections in Canada and France, where Trudeau and Macron succeeded despite having poor approval ratings. And the recent U.S. midterms saw voting swing wildly away from poll data that had indicated a red wave for Republicans, but did not materialise amidst a climate of dissatisfaction with government policies, inflation, war and corruption.

Is this absolute proof of election fraud? No. But an incontrovertible pattern is emerging: each time, we see unpopular, authoritarian, globalist candidates winning elections, followed by widespread claims of fraud, followed by authoritarian censorship and blanket refusals to audit votes.

George Soros once claimed he felt like God, such was his wealth, power and status. Which begs the question; if there was to be an election for the Almighty, would God use voting machines to cheat?

referendum success of Venezuelan dictator Hugo Chavez in 2004.

Now it is hardly a stretch of the imagination to believe that the socialist, totalitarian-minded Chavez invested in a brand new, unheard-of, fledgling election system, with the party’s popularity slipping, to secure his tenure by nefarious means.

An independent statistical analysis of the election showed clear signs of election fraud, and anomalies in the electoral register. The study, *Forensic Analysis of Venezuelan Elections during the Chávez Presidency*, by Raúl Jiménez and Manuel Hidalgo, noted, ‘anomalous statistical patterns, which are consistent with election fraud.’

This was corroborated by Harvard Professor Ricardo Hausmann and MIT Professor Roberto Rigobon. They argued that the voting results were manipulated, ‘at level of the voting centre, not at each voting machine.’ The same claims were made in the 2020 U.S. Presidential Election.

A leaked memo by Vladimir Chelminski, former Executive Director of the Caracas (Venezuela) Chamber of Commerce, claimed that the machines ‘first communicated with the Totalising Centre,

convicted drug trafficker, was supposed to be serving an eight-year prison sentence in Venezuela, but was flying to the Dutch Antilles in a plane laden with cash.

After investigation, the downed plane’s registration number was tracked to a company that provides shrouding for aircraft use, allegedly for the criminal fraternity and the CIA. Who would have the power to break a drug smuggler out of jail to make anonymous flights?

The cause of the crash was not clear, but it was alleged that Anzola was in dispute with powerful figures in the Venezuelan government, and had threatened to expose election corruption with detailed documentary evidence.

Smartmatic provides election technology to Brazil, although it does not provide voting machines. On October 30 2022, populist president, Jair Bolsonaro, was inexplicably defeated, despite overwhelming visual support compared to his opponent, similar to Trump in 2020.

The Club of Rome at 50

I USED to believe the tenets of the Club of Rome. I did so for about four years (from the age of 22 to 26), until I woke up from ecodoomism.

It is apparent that millions have been sucked into this cult and have never found a way out. Yet.

Indeed, eco-doomism is one of the world's leading causes of depression, suicide, sexual ambiguity, non-replacement and cultural anomie.

It is immediately the cause of irrational policies designed to immiserate the population (viz., Dutch government putting farms out of business to control atmospheric nitrogen levels). Here are the doctrines of the Club of Rome, circa 1972. *The Limits to Growth* contains six main messages, look familiar?

- 1. The environmental impact** of human society had become heavier between 1900 and 1972, due to both an increase in the number of humans, the amount of resources consumed, and pollution generated per person, per year.
- 2. That the Earth is physically** limited, and that humanity cannot continue to use more physical resources and generate more emissions than nature is capable of supplying in a sustainable manner. In addition, it will not be possible to rely on technology alone to solve the problem, as this would only delay reaching the carrying capacity of the Earth by a few years.
- 3. The authors warned that it** is possible, and even likely, that the human ecological footprint will overshoot the carrying capacity of the Earth, further explaining that this would likely occur due to significant delays in decision-making while growth continued, bringing the human footprint into unsustainable territory.
- 4. Once humanity has entered** this unsustainable territory, we will have to move back into sustainable territory, either through 'managed



decline' of activity, or we will be forced to move back through 'collapse' caused by the brutal inherent processes of nature or the market.

- 5. The fifth message is one of** hope. The authors state that: 'The challenge of overshoot from decision delay is real, but easily solvable if human society decided to act, meaning that forward looking policy could prevent humanity from overshooting the aforementioned limits.'
- 6. The authors advocated for** an early start – in 1972, that was 1975 – to achieve a smooth transition to a 'sustainable' world, without needing to pass through the overshoot and contraction phases.

The World Economic Forum and Klaus Schwab have followed these doctrines as night follows day. The key assumptions are that the current population/resource consumption mix is unsustainable, and that a process of managed decline can smooth the transition to sustainability.

I am about to say something at once paradoxical and true:

Humans have more to fear from the managers of population reduction than we do from spontaneous civilisational collapse.

In regard to those who advocate population reduction, the old adage of C. S. Lewis applies: the robber barons might have their greed satiated and stop, but the person who tortures you for your own good does so with a clean conscience, and will not stop. Hence Stalin. Hence Klaus Schwab, and his minions and acolytes.

Collapses are random and bring their own correctives. They are chaotic. If the Roman Empire has to fall, it is better that it occurs without central planning, administered by mad tyrants. I realise that this is offensive to those who believe that civilisational change can be planned, but it cannot.

The assumption that needs to be challenged the most is that collapse is somehow inevitable, because we have gone beyond limits set by nature, that this unsustainability is somehow new, and that we can plan our way out of it.

We went beyond the limits when we domesticated animals, invented agriculture and mined metals. I would not wish to say there are no limits, but I would say that the collective intelligence of mankind has continually found solutions to the problems we have ourselves created. We went into the realm of the 'unsustainable' thousands of years ago. We are still in 'unsustainability'. There is no stable state.

The Club of Rome published its manifesto in 1972. It has had a tremendously negative impact since then. It resuscitated the idea of a centrally-planned economy, when the central conceit of Marxism had collapsed: that a planned economy could prevail over the chaotic forces of the market, or of nature.

The close relationship between the idea of sustainability and the tyranny of 'all-wise' central planners needs to be made clear.

EU to restrict cash purchases to 10,000 euros

UNDER the guise of anti-money laundering (AML) regulations, the Council of the EU announced on December 7, 2022 that large cash payments of €10,000 or more will become impossible.

According to the official press release, the new rules will be extended to the entire crypto sector, obliging all crypto-asset service providers (CASPs) to conduct due diligence on their customers, ending any notion of anonymity using cryptocurrency.

"This means that they will have to verify information about their customers. CASPs must apply due diligence measures when carrying out transactions of €1000 or more, and add measures to mitigate risks in relation to transactions with self-hosted wallets."

The Council also introduced specific enhanced due diligence measures for cross-border correspondent relationships for crypto-asset service providers.

"Trying to stay anonymous when buying or selling crypto assets will become much more difficult. It will even become difficult to launder dirty money via jewellers or goldsmiths," said Czechia's Minister for Finance, Zbynek Stanjura.

Despite HSBC's being caught and fined over laundering huge sums of money for drug cartels among many other criminal activities, now the ordinary, law-abiding European citizen is having his right to privacy removed again.

Australia demands company directors have digital ID

THE Government of Australia's requirement that all company directors have an online digital ID to be able to operate, pay taxes and use other government services passed its deadline on December 1 last year.

Strep A stories just more fear-mongering

‘Dangerous pathogens’ narrative lacks compelling evidence

IN early December, there were many media reports about a new potentially dangerous disease in the UK.

A BBC article entitled, *Six children die with Strep A bacterial infection*, stated: ‘Six children have died... including five under-10-year-olds in England since September - the UK Health Security Agency has said.’

It would seem that the fearmongering narrative about ‘pathogenic viruses’ has now been expanded to include ‘pathogenic bacteria’. But bacteria are no more to blame for disease than ‘viruses’, even though, unlike the particles called ‘viruses’, bacteria definitely exist and can be observed.

These new media reports raise an important question: Have the ‘would-be controllers’ just moved the goalposts for those of us who have been calling out the ‘virus’ lie for almost three years?

More details were reported by the BBC in an article entitled, *Parents urged to be aware of Strep A symptoms after death of six children*. It read: ‘Strep A infections are usually mild, causing illness ranging from a sore throat to scarlet fever, but can develop into a more serious invasive Group A Strep (iGAS) infection.’

Further explanations about this so-called ‘infection’ are provided in the same article under the heading, *What Is Strep A?*

- Group A Streptococcal (GAS) infection is caused by strains of the streptococcus pyogenes bacterium
- The bacteria can live on hands or in the throat for long enough to allow easy spread between people through sneezing, kissing and skin contact
- Most infections cause mild illnesses such as ‘strep throat’ or skin infections
- It can also cause scarlet fever and in the majority of cases this clears up with antibiotics
- On rare occasions the bacteria can get deeper into the body - including infecting the lungs and bloodstream

But there are so many problems with these claims.

First of all, it is admitted that streptococcus bacteria can be found in healthy people, as indicated by an article entitled, *What is Strep A and what are the symptoms to look out for?* The article reads: ‘It’s a bacteria

sometimes found in the throat or on the skin. Many people carry it harmlessly without even knowing, but they can spread it to others who might become ill.’

Note the admission that this bacterium can be harmless and may not always cause disease. This completely undermines the claim that the streptococcus bacterium is pathogenic, because it fails to meet the first of Koch’s Postulates, which states that the ‘microbe’ alleged to be the causal agent should *always* be found in people suffering from the disease that it is claimed to cause, and should never be found in people who do not have the disease that it

is discovered to not be supported by evidence, it needs to be abandoned and replaced with a rule that is supported by evidence.

Unfortunately, the medical establishment refuses to re-examine its rules about the germ theory. Instead, it makes excuses for any exceptions to its ideas about ‘infectious diseases’ and says that people who are ‘asymptomatic carriers’ have strong immune systems. This is an unproven assumption, mainly because the concept of the ‘immune system’ is totally dependent on the ‘germ theory’, which itself remains unproven.

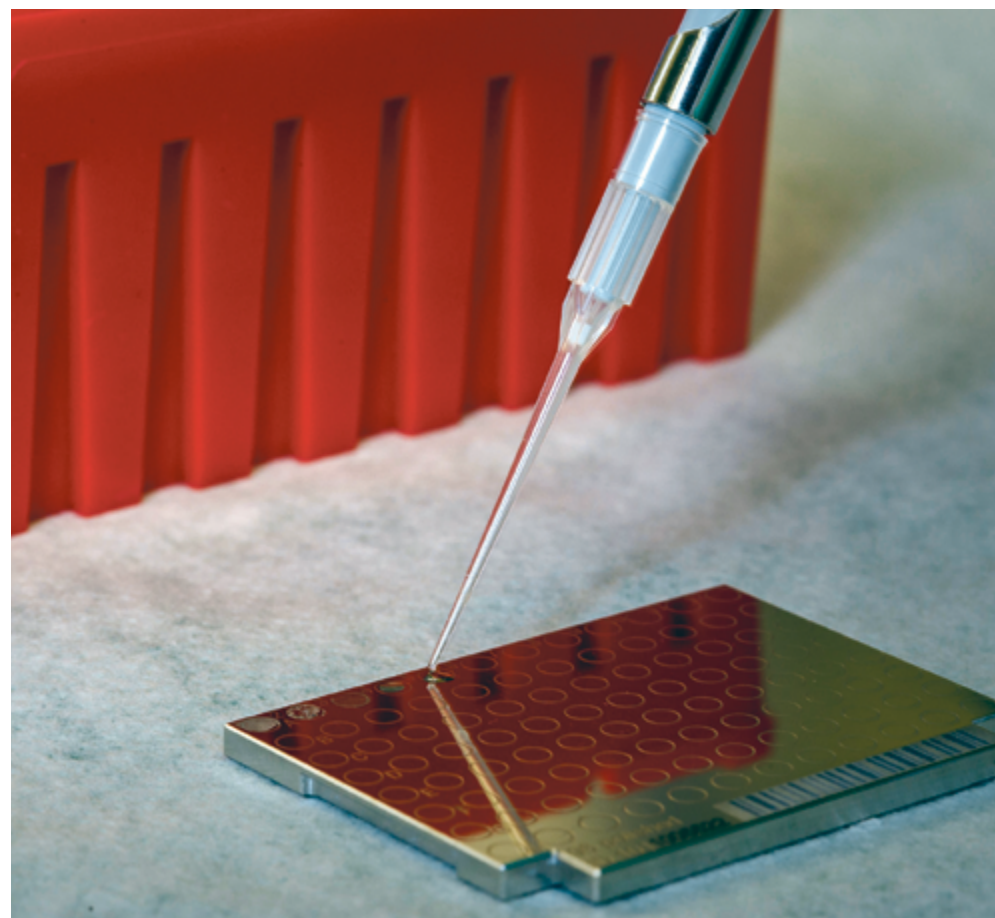

is claimed to cause.

The logic of this postulate is undeniable. Yet it is admitted that ‘strep’, and many other bacteria, are found in asymptomatic people, which means they do not have a ‘disease’.

A single exception to any rule refutes the notion that it is a rule.

Furthermore, the existence of a single exception to a rule means that the rule needs to be re-examined and re-assessed, especially in science.

But more importantly, when the rule

One of the main consequences of the idea that bacteria cause health problems is that the recommended solution involves antibiotics, which, by their very nature, are toxic - their intended purpose is to kill bacteria.

The commonly-used antibiotic for Strep A is penicillin, on the basis that it is said to not be affected by anti-microbial resistance. This is yet another mistaken notion, but one that distracts from the fundamental issue, which is that bacteria have not been proven to be pathogenic.

More worrying is the serious condition

called ‘invasive GAS’ as described on the Minnesota Department of Health web page entitled, *About Group A Streptococcus: Commonly Asked Questions*, under the heading, *What Kind of Illness are Caused by Group A Streptococcal Infection?*

It reads: ‘Two of the most severe, but least common, forms of invasive GAS disease are called “necrotising fasciitis” and “streptococcal toxic shock syndrome” (STSS).’

Necrotising fasciitis is described as ‘a destructive infection of muscle and fat tissue, and occasionally described by the media as the “flesh-eating” bacteria’.

STSS is described as ‘a rapidly progressing infection that causes shock and injury to internal organs such as the liver, kidneys and lungs’.

These are clearly very serious conditions, but they cannot be properly investigated and understood while the medical establishment continues to declare them to result from bacterial infections.

Unfortunately, without a serious and in-depth investigation into each individual case, it is impossible to know exactly what the causes could be, because there are always multiple factors involved in the causation of health problems. However, it is highly likely that toxins of some description are involved, especially in the case of STSS, which involves damage to the liver and kidneys, two of the body’s most important elimination organs.

There are a number of toxins to which children have been recently exposed. These include vaccines, whether the covid vaccine or the nasal flu vaccine given to many UK schoolchildren during the autumn term.

There is clearly an agenda to keep people in fear of ‘dangerous diseases’.

Also important is the reference to the rise of cases being due to ‘increased social mixing’. So the question is: are they preparing for the implementation of further lockdowns to ‘stop the spread’ of this new alleged ‘bacterial’ disease?

No matter how often the medical establishment attempts to propagandise us with fear-based stories about ‘dangerous pathogens’ that cause ‘deadly diseases’, it is important for people to know there has never been any genuine scientific evidence that bacteria and ‘viruses’ are the causes of any disease.

The actions began in autumn 2022, in

Dunfermline, at the end of a small freedom rally. A tireless activist, 'Moira from Dundee' as we all know her, had set up a display of laminated A4 pictures with stories of vaccine dead and injured.

Placed on park railings, the profiles had real impact. Here were real people, not just statistics.

Some of us quickly recognised that Moira's 'Real not Rare' campaign was the way forward.

We agreed we would back her in taking it on tour to a different town centre every Saturday.

Stirling followed Dunfermline, Falkirk followed Stirling, and then it was on to Glasgow, Dundee, St Andrews, Aberdeen, Glasgow again, Clydebank, Paisley, Forfar and Perth.

We now have three sets of materials, allowing separate memorials simultaneously in different locations. It is an idea which is beginning to catch on throughout the UK.

Each memorial only takes a few people to set up, and we usually have a few others nearby handing out relevant leaflets and copies of the *The Light* paper.

The A4 laminated cards have been replaced by A3 size for greater impact. All the stories and pictures feature people whose deaths their families have already publicly attributed to covid injections.

We have learned to set up the cards and then stand well back to allow passers-by to

stop and look without feeling intimidated. Solemn classical music (played not too loudly) can create a suitable atmosphere.

We have vowed to keep going from town to town, week after week.

Our aim is to counter the 'vaccines are safe and necessary' narrative, and also push back against the media and tech censorship of dissenters who simply pose reasonable questions such as 'can we investigate why so many previously healthy people are dying?'

People are becoming increasingly aware that they and others keep catching 'covid', despite being double and triple jabbed. Many are also hearing stories of friends, relatives or colleagues who have been seriously unwell or worse after the shots. If the Real not Rare campaign makes just some of them stop and think about the necessity of further injections, or why they were never fully informed of the risks, then it is worthwhile.

The campaign highlights those who have been harmed, but feel abandoned by governments and the medical system. So many people want to stop and share their stories about serious injuries they or someone they knew had suffered. They go away lighter in spirit after being able to talk to someone who listened and understood. More people than ever are thanking us for what we are doing.

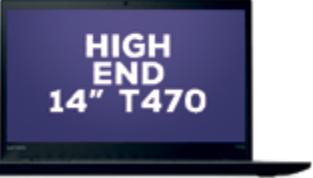

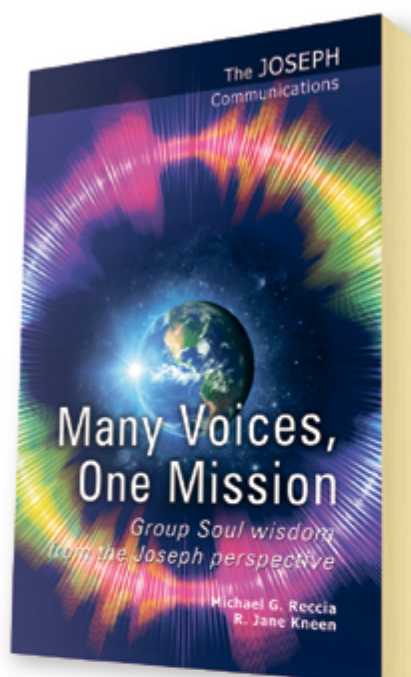
