Is your money safe?

OUR hard-earned savings are at huge risk from those purporting to be our financial masters.

Think bank failures, stock market crashes, cyberattacks and the plan to introduce programmable all-digital currencies.

Whether you have savings, pensions or investments, few tell us about the risks involved with paper assets - wealth that we don't hold in our hands.

All trade and the economy is exchange: whether you are exchanging your labour for bank account credits or credit notes for barrels of oil, we are all exchanging what we have for what we need.

When you go to the shop, you exchange what you have (paper currency or account credits) for what you need (bread, milk, meat, etc.) Nearly every single part of the economy works like this – except for where one side of the exchange is 'free', e.g., voluntary work or gifts.

The medium of exchange, what we call money, therefore becomes the most highly prized commodity because of its ability to be exchanged into anything else. Money used to be an actual commodity - after tally sticks,



pebbles, salt and many other variations, people settled on gold and silver as the best form of money because of qualities like their rarity and durability.

Then we had the big shift, or grift, from real, physical money to paper or fictional representations of it. In the interests of safety and security, the bankers introduced a way of moving your gold from one city or country to the next, by issuing paper certificates proving you had the gold in your bank.

A great idea, if you trust the bankers not to issue more paper certificates than what gold they have, or the value of those paper certificates decreases.

In 1971, U.S. President Richard Nixon de-coupled the dollar permanently from gold, allowing the U.S. Treasury to issue as many paper certificates (dollars) as it wanted, thus devaluing the dollar and every other currency that floated with it.

Cut to today, and the U.S. is having to print one trillion dollars of new debt every one hundred days to keep up the payments on the debt already created. Read that again.

The entire financial system is now essentially the biggest Ponzi scheme in history, and it will

affect every single one of us when it inevitably collapses.

If you have a pension, you are liable for this debt. If you are invested in stock market companies, directly or via investment funds or exchangetraded funds (ETFs), you are liable for this debt. If you have cash in the bank or under your mattress, you are liable for this debt, once the currency collapses to its intrinsic value - zero.

By the way, a pound is called that because it used to represent a pound of silver. Today, a pound of silver costs around £400, so when we say that they have

devalued the currency to enrich themselves at everyone else's expense, we really mean it.

They try to blame inflation on greedy companies (or supply chain problems) when in fact it is the devaluing currency which impoverishes the majority of us while they cream off the Earth's bounty and everyone's valuable time, skills and creativity.

The solution for individuals who recognise this huge danger to their family's future is to not have very much paper wealth. Convert it to real wealth - land, buildings, businesses, tools, seeds, livestock, and if you have any left over for savings, precious metals - anything real and tangible that is widely seen as useful and therefore valuable; a hardware store is a goldmine in a depression/hyperinflation.

The number one asset to invest in, though, is always yourself and those around you. Develop skills and networks and businesses and economies that make you truly resilient and sustainable.

The Earth gives continuously, abundantly, for free: fuel, lumber, food, water, animals, plants, and so on. It should all cost very little, but the debt-based money we use is dwindling in real purchasing power every day, and one day soon it will vanish completely.

Police up ante on 'hate speech'

'Offensive' shows could be classed as illegal by the courts

POLICE in Scotland are being trained to target actors and comedians under new hate crime laws set to be activated next month.

The news was revealed by *The Herald* daily newspaper, citing leaked police documents.

Training material obtained by the outlet states that content deemed to be 'threatening and abusive' under the Hate Crime and Public Order Act can be communicated 'through public performance of a play.'

A slide from the leaked training material, titled 'Stirring up hatred', also lists 'protected' characteristics including age, disability, religion, sexual orientation and transgender identity.

In other words, under First Minister Humza Yousaf's new law, any performer who for example 'misgenders' trans people, jokes about race or religion, or even criticises migrants can potentially be prosecuted.

The training material further states that even those forwarding or sharing material deemed to be 'hateful' can also be targeted under the law.

It states: 'The different ways in which a person may communicate material to another person are by: displaying, publishing or distributing the material, for example on a sign, on the internet through websites, blogs, podcasts, social media etc., either directly, or by forwarding or repeating material that originates from a third party, through printed media such as magazine publications or leaflets.'

So, essentially retweeting a Dave Chappelle or Ricky Gervais skit could land you with a hate crime charge in Scotland.

Commenting on the training material, Shadow Justice Secretary, Russell Findlay,

said: "If this is genuine Police Scotland training material, it appears to be at odds with the legislation which excludes plays from its scope. This revelation adds to widespread concerns about Humza Yousaf's hate crime law and needs to be explained."

The Association of Scottish Police Superintendents raised concerns about the new legislation being weaponised for political purposes. They warned that vexatious complaints could be made against innocent people by their political opponents.

The Scottish Daily Express previously reported that police had been given mandatory training in how to deal with alleged hate crimes, including a question asking: 'A high-profile, male politician who is a strong supporter of the LGBT community is abused in the street during campaigning and called a 'deviant'. What aggravators would be recorded for this crime?"

The multiple choice answers provided were 'Disability – physical impairment; Racial – white Scottish; Transgender Identity – female to male; or Sexual orientation – Gay man.'

The Scottish government, led by Yousaf, has also floated proposals to punish parents who refuse to accept their children identifying as transgender with up to seven years in jail under a separate new law.

Yousaf was previously labelled 'a blatant racist' by X owner Elon Musk, who was commenting on a video posted to the platform of Yousaf, complaining that the "most senior positions in Scotland are filled almost exclusively by people who are white" and stating it is "not good enough," and that that Scotland has a problem of structural racism," despite being demographically 96 per cent white.

Censorship, destruction of artistic freedom, and thought control are not what I voted for when I voted for devolution.'

'Hospital killed my dad'

Family witnessed distressing treatment of pensioner

THE following account is from the latest person to join my support group for those allegedly killed in hospital.

The woman gives details of her dad's death in hospital and how it was allegedly covered up by NHS staff. She has to remain anonymous for now as she is involved in legal action.

She says: 'Saturday December 16: I went for a meal with my dad. He felt ill all day and thought it was due to his asthma


Sunday December 17: in the early hours of the morning, Dad called an ambulance as he had chest pain. He'd had a heart attack and had three stents put in. The doctor said they couldn't do the last ventricle and that it would have to be done at a later date as it was too risky after such a major shock to the heart.

When I visited that day, Dad (pictured) was in a side room on oxygen. He spoke to me. He was coherent and knew who I was. My dad was totally sound of mind.

Monday December 18: I visited him again. Dad was thinking clearly - he even told a joke - but said he needed to rest so he'd be ready to go home. A nurse said he was improving and that they planned to move him to another ward.

Tuesday December 19: dad's brother visited. They spent hours talking and reminiscing. Dad got upset and was reassured by his brother. By the evening, Dad was heavily sedated.

Wednesday December 20: I visited again. Dad couldn't open his eyes at all. We thought that perhaps the medication he'd been given was having an adverse effect. We were told the syringe driver in his arm was giving him insulin. My dad was not diabetic. That night, Dad

started struggling to breathe and was put on a ventilator.

Thursday December 21: I was told there was no change in Dad's condition.

Friday December 22: I was told in the morning update by the nurse there was still no change and to stop calling as there was no change expected.

I went in at 4pm and was told that they had taken my dad to the cath lab to have his last ventricle opened. They hadn't informed us in advance and hadn't asked for consent. Had they asked, we would have refused as he wasn't strong enough for such an operation. My uncle informed me he'd visited earlier that day and

onto his stomach. He was on

a ventilator which kept cutting

out. When my uncle asked why Dad had been moved into that position, the nurse looked guilty and couldn't give a reason. I have since researched this and found out that the technique is often used to speed up deaths of patients on ventilators in ICU.

The nurses and doctors called us all in to witness my dad being jumped on and shocked: that image will never leave my mind. I do not know why they wanted us to see that.

Dad's heart stopped. He wasn't strong enough for that heart procedure; he had a high temperature from the reaction to the sedative, was on fentanyl and was on a ventilator.

My uncle begged them not to carry out the procedure, saying he was not strong enough for it,

but the doctor assured him my dad would make it. After Dad died, the doctor apologised for getting it wrong in front of eight of my family members.

I asked what sedative my dad was given. They said they couldn't remember.

Thursday 28th December: I had a phone call recommending cremation from the hospital bereavement team, saying it'd be less paperwork for us. I said we had yet to decide.

Dad's death certificate says 'cause of death: heart attack and type 2 diabetes'. Dad was not diabetic .

I believe the cause of death was the over-sedation and the fentanyl. I also believe they took him for the heart surgery to cover up what they'd done. They knew his heart couldn't tolerate any more work on it and that the operation would kill him, but they'd messed up with the medication and needed to hide it. So they operated on him so he'd suffer a heart attack.

I went to the police to report what had happened. The police took my statement, then I had a call accusing me of using 999 unnecessarily and threatening to arrest me. I didn't call 999; I called 101. I am shocked and traumatised by the way the police have treated me.

At the inquest, the coroner and pathologist refused point blank to agree to a toxicology test and tried to bully me into getting my dad cremated as quickly as possible. I stood up to them and said I was going to get a private toxicology report. I set up a Crowdfunder to finance that, which has now completed.

I've now had the tests done and I'm waiting for the results. My dad was 69. He was my full-time carer. He deserved to live, not to be killed. It haunts me every night what they put him through. I miss him so much.'

Surveillance prison taking shape

Facial recognition is turning us into walking ID cards

WHEN Harvey Eugene Murphy Jr visited his home state of Texas to get his driving licence renewed, he never imagined the trip would result in him being wrongfully arrested and assaulted in jail.

Yet that is precisely what happened to the 61-year-old grandfather thanks to Houston Police's reliance on facial recognition technology.

Murphy was arrested in relation to the armed robbery of a Sunglass Hut store in Houston. But while the real thieves were making off with thousands of dollars in cash and merchandise, Murphy was back home in California, nowhere near the scene. By the time the Harris County District Attorney's office in Texas figured that out, it was already too late - three men had sexually assaulted Murphy in a bathroom in jail, leaving him with permanent injuries.

"Mr Murphy's story is troubling for every citizen in this country," said Daniel Dutko, a lawyer representing Murphy. "Any person could be improperly charged with a crime based on error-prone facial recognition software, just as he was."

If you think that such things could never happen in the UK, think again. Some British police forces already use facial recognition tech. London's Met Police use it on the streets routinely. It was also used last year to watch crowds at the King's Coronation,

at an Arsenal v Tottenham match, at a Beyonce gig, and even on F1 Grand Prix day at Silverstone.

According to civil liberties group Big Brother Watch, since the Met Police started using facial recognition tech, 85% of all matches identified by the system were wrong. The figure for South Wales police is even worse: 90% of matches were incorrect. 'We've [personally] witnessed people being wrongly stopped by the police because facial recognition misidentified them,' the group said in a report.

Despite these disastrous figures, policing minister Chris Phelps wrote to police chiefs last October urging them to 'double the number of [facial recognition] searches by May 2024, so they exceed 200,000 across England and Wales.'

"This dangerously authoritarian technology has the potential to turn populations into walking ID cards in a constant police line-up," said Silkie Carlo, director of Big Brother Watch.

Her comment highlights the real problem here. When people think 'Digital ID', they

think of a card or passport, something with a reference number. But biometric data – facial recognition, fingerprint recognition, even gait recognition to identify those who wear masks – renders ID cards obsolete.

Consequently, when Tony Blair and William Hague jointly released a report in February last year calling for 'a secure, private, decentralised digital-ID system,' the Prime Minister's spokesman was able to say with a straight face: "There are no plans to introduce Digital ID. Our position on physical ID cards remains unchanged. We are already carrying out work to enhance the digitalisation of public services."

But the government doesn't have to let citizens know that they are in a surveillance system by issuing something as obvious as a physical card. Instead, citizens are coerced into handing over their biometric data unwittingly; using face recognition software to unlock their phone, or to check into a hotel, or to open a bank account, or even by simply walking into their local Tesco.

Meanwhile, the government is forging ahead with a vast range of digital ID schemes, such as the Data Protection and Digital Information Bill, currently passing through the House of Lords. That bill gives the government widespread powers to tap into data collected by a range of public and private enterprises, including banks.

A timeline of ID cards in Britain

1939: The government introduces ID cards for the first time as a war-

time measure, citing evacuations, rationing and population measurements as justification. 45 million cards are issued under the National Registration Act.

1950: Harry Willcock, a 54-yr-old dry cleaner from London, is stopped by a policeman who demands to see his ID card. Willcock refuses, saying simply: "I'm against this sort of thing."

1951: The British Housewives League is inspired by Mr Willcock's defiance, setting fire to their own ID cards in frying pans outside Downing Street. The High Court rejects an argument by Willcock's lawyers that the Act

lapsed when the war ended, but give him an absolute discharge.

1952: Churchill's government scraps ID cards in order to 'set the people free'

2001: Following 9/11, Tony Blair calls for ID cards, claiming it would be impossible to fight terrorism without them.

2002: Home Secretary David Blunkett introduces plans for ID cards. He claims the cards would be used to ensure that people could not "draw on services which are free in this country, unless they are entitled to."

2004: Boris Johnson rails against the idea, insisting that if ID cards were introduced, he would eat his.

2006: After several defeats in the House of Lords, the Identity Cards Act is passed into law.

2008: Compulsory ID cards for *foreign* nationals are rolled out nationwide.

2009: Pilot schemes are introduced for ID cards for British citizens. People in Greater Manchester are able to buy biometric ID cards for £30. Some 15,000 are issued.

2011: Following Labour's defeat by the coalition government a year earlier, the scheme is scrapped. The cards are rendered invalid and the database behind it is deleted.

2021: Boris Johnson's government introduces legislation for a Covid

Pass to prove vaccine status. The scheme is denounced as a 'medical digital ID card'. Over 100 Tory MPs rebel against the government and vote against the scheme, but are unable to defeat it.

2023: Tony Blair and William Hague join forces to issue a new call for

Digital IDs. Though the government rejects the call, they forge ahead with a variety of measures including One Login, required to access a range of government services including applying for vehicle licences, signing mortgage deeds, and connecting families in need to support services in their area.

2024: The fight for freedom continues.

Justice must be seen to be done

Court defines parameters of truth battleground

RICHARD D Hall... for those who don't know, he is a journalist, an investigative one, who delves into subjects that have put him at personal risk many times.

Without offering any views on one of his latest investigations – the Manchester Arena incident – it is important to reflect on the legal case he is facing.

Justice must be done in a fair society, and it must be seen to be done. The problem lies in the fact that defining justice is not easy, nor is it easy to apply it.

So for those not attending court and who are not privy to all the evidence, how do we form our own opinions on his case?

There are numerous sources we can go to and – as it often is with counter-narrative issues – the media and alternative news have different takes.

In Mr Hall's case, the legacy media en masse has taken a fairly unforgiving line against him (not least by describing him as a 'self-styled journalist' in story intros) and this has been enabled by the courts and a public inquiry into the incident in Manchester.

In the High Court in London on February 8, it was ruled that Mr Hall's own evidence around the Manchester arena incident was 'fanciful' and it was rejected by Judge Richard Davison.

The ruling was made in light of the public inquiry that established Salman Abedi was a suicide bomber at the Manchester venue

on May 22, 2017.

An open-and-shut case then, perhaps. But is there another side to the story?

Much of the alternative news arena thinks so.

But what counts in terms of evidence is what can be heard in open court in a trial. In an attempt to have his evidence heard, Mr Hall appealed against the High Court decision during a remote hearing on March 13.

Representing himself, he said: "There seems to be a lack of knowledge within the judiciary about false flag terrorism."

Mr Hall claimed that NATO countries had

carried out hoax events "to fool the public into thinking they are under attack", adding: "It is very concerning that the judiciary does not seem to be aware of it."

He subsequently claimed the inquiry into the Manchester Arena incident was "corrupt" and that the legal claim against him "is being used for an ulterior political purpose."

"It is the real bomb attack hypothesis that is implausible because the evidence does not point to it," Mr Hall continued in the hearing attended by more than 120 people. Judge Davison denied Mr Hall permission to bring an appeal against his previous judgement.

He said: "Nothing that you have said amounts to, in my view, an argument that would have a real prospect of success in an appeal."

Mr Hall was given 21 days to file a second bid to bring an appeal which would be considered by a different judge.

The full trial in the claim against Mr Hall is expected in July.

So, until then – whatever our views are on what happened in Manchester – we can only wait and debate amongst ourselves, and ask the question, is justice being seen to be done?

Virology built on pseudoscience

Inversion of natural health enabled by dogma within medical world

'ISOLATION' means the separation of one thing from everything else. This is the only way to scientifically identify a thing.

This is done with everything from large organic material to the smallest nanoparticles. It is done with gold and silver. And it is done in basic chemistry, but it has never been done with a virus.

Several have claimed to have done so, but have since been exposed as frauds. Today, virologists claim that isolation is not possible because of the obligate intracellular nature of a virus. This means that they cannot exist outside of a living cell.

But if this were true, then it would also be true that they can not spread from one person to another. The pseudoscience of virology is full of logical fallacies that any inquisitive person can recognise.


Scientific studies require a control group. Meaning that two samples are needed where every factor is the same except for the presence of the thing being studied. But this cannot be done in virology because a virus has never been isolated.

When virologists claim they are isolating it, they are lying. This is evident today with the latest so-called proofs that SARS-CoV-2 has been isolated.

In both the isolation and rapid sharing of the 2019 novel coronavirus, published by the *Medical Journal of Australia*, and in the viral isolation analysis of SARS-CoV-2 from Japan's *Journal of Infection and Chemotherapy*, the titles suggest that they isolated a virus, but they clearly did not. They took material from the most contaminated source possible, the nose, which acts as a filter by capturing particulates inhaled from the environment.

At no point did they isolate a virus from this sample. What they did was run the entire mix of unknown material through a PCR test, and claimed that it tested positive for SARS-CoV-2.

But we know that the PCR test is not

capable of isolating a virus, and we know it's been deliberately adjusted to give false positive results. So this is not science, it is fraud.

They then inoculated a culture of cells with the entire mix of nose material, added in unspecified material, and the cells died. At no point in these experiments was a virus ever isolated. They in fact did the opposite of isolation by adding foreign material to a mix of unknown material from a person's nose.

So even if the cells died as a result, there is no way of knowing what killed them.

There is an alternative theory that does not have massive funding from spurious foundations and Nobel Peace prizes to convince the public of its validity.

Terrain theory tells us that most diseases are nothing more than the symptoms of natural bodily processes of healing, and the repairing tissues damaged by stress and external toxins.

Cells naturally die and break down in a

way that is identical to how virologists claim a virus behaves. The very same foundations pushing the theory of the virus have been simultaneously creating a more toxic world with petrochemical drugs that earn billions in profits.

There are far more so-called diseases today than existed before this pseudoscience was unleashed on society.

She is saying that what we are told today are symptoms of a disease, are actually natural processes of the body healing itself from damage.

Manly P. Hall, known best for his 1928 publication, *The Secret Teachings of All Ages*, gave a lecture in 1989 called: *Magnetic Fields of the Human Body*. In this lecture he described this same sentiment.

He said that each human body is surrounded by its own magnetic field which provides tremendous protection. As long as the individual takes proper care of this magnetic field, it will heal all wounds and recover all bodily functions and organs.

My anguish at being vaxxed

We trusted our doctors – I'd had mine for over 25 years, and we knew our government lied at election times, but we voted the best we could based on the B.S. presented to us.

We went about our lives innocently – working, raising kids and babysitting grandkids – and many of us had not one person in our circles to warn us of the dangers.

We didn't even know that we had to do 'research'. Unbelievable as that may seem, it's absolutely true.

are part of the B.S., because how would we ever know when there is no long-term proof? It's endless medical tests that come back 'normal', but you just know and feel the changes in your body.

It's seeing the videos of the 'calamari' clots and reading about graphene microblades slicing up veins, and spikes adhering like velcro to tissues and organs.

It's the breathlessness and palpitations on the slightest exertion that doctors can't explain.


It's the knowing that it was all for nothing, though we believed it was for the best of intentions.

It's this tattoo on my arm of the vax batch numbers that I use to open conversations and share my adverse reactions with every doctor, specialist and pathologist, radiologist and ambulance paramedic I meet.

It's grief – deep, empty, gut-wrenching grief for all my family and friends, all those I love and care for.

It's loss — the loss of my future dreams and plans, the loss of my husband and family, it's the pain felt by the name-calling and

Education or indoctrination?

Alex Newman, U.S. investigative journalist and author, is interviewed by Richard House

Richard House [RH]: Your new book, Indoctrinating Our Children to Death is a gripping tour de force, Alex. Tell us about the main inspirations underpinning your work on America's schooling system.


Alex Newman [AN]: Great to chat, Richard. Frankly, I had no idea what a disaster the American education system was, because I grew up outside of the USA in elite private schools, mostly in Latin America and, later, in Europe. My first taste of American education was taking a high-school equivalency test instead of getting a degree, since I'd been expelled and never graduated. It was so easy I couldn't believe it... these were subjects I mastered in elementary school! College in the US was a wake-up call, too.

As I was getting started in my journalism career. I read in a local newspaper that US national education standards were being developed. I wasn't a constitutional scholar, but I understood even then that education was not a constitutional responsibility of the federal government - so I began digging. What I found was shocking: the Common Core State Standards Initiative, also known as Common Core. As I researched this and spoke with many of the key players, it quickly became apparent that these national standards weren't just bad, they were designed to be bad. That's what the experts on the Common Core Validation Committee were telling me.

That eventually led me to Dr Samuel Blumenfeld, the great educator and author who dedicated 60 years to researching this atrocity foisted on Americans. We teamed up to write *Crimes of the Educators*, and that experience led me to the conclusion that education was the most important issue – by far – facing families, and even the nation.

In short, I realised we were going to lose all of the other battles important to me if we didn't focus on the root cause: the deliberate dumbing-down, indoctrination and sexualisation of children by this diabolical system. So today, rescuing children from this evil system is one of my most important priorities in life.

RH: The word 'deliberate' seems key here – could you say more about the deliberative nature of these assaults, Alex? And is this a global issue, or

US-specific?

AN: There should be no question in anybody's mind about whether the horrors we're seeing in public education are deliberate. They absolutely are. The system isn't broken – contrary to popular belief. In fact, it was dreamed up, created and weaponised very strategically for the purpose of turning children against God, their parents, their countries and their freedoms. This can be proven using primary-source documents and writings from the architects of this system: Robert Owen, Horace Mann and John Dewey.

The dumbing-down of the children is deliberate too. As far back as 1898, Dewey – widely viewed as the founding father of the system existing today – was scheming on how to de-emphasise reading, writing and thinking. Instead, he wanted to focus on socialising children and turning them into little collectivists. But he knew parents, teachers and taxpayers would revolt if they knew. 'Change must come gradually,' he said. 'To force it unduly would compromise its success by favouring a violent reaction.' This is the language of a conspirator.

Today, socialists, communists, revolutionaries, LGBT activists, feminists and countless others passionate about their ideology, brag openly and celebrate their efforts to recruit captive schoolchildren. Whether one agrees with their ideologies or not, a tax-funded compulsory system is no place for zealots to be indoctrinating and weaponising other people's

While this largely began as an American and European problem, today the systematic indoctrination of children is a global phenomenon. Tyrants everywhere have realised the power inherent in moulding young minds. UNESCO, the UN's education agency, plays an enormous, deeply problematic role in education, as do many other international institutions. Between the Common Core, the World Core Curriculum, and the various efforts to standardise education globally, this is a truly global threat that the world has never before faced.

RH: 'Inaccurate diagnosis results in improper treatments' – that's brilliantly summarised! Is U.S. home-schooling taking off, as in Britain? And how is your new book that outlines all this being received?

AN: Thankfully, homeschooling and private education are exploding in the United States, and this ongoing growth is perhaps the single brightest development on the horizon. Top leaders have endorsed it. While we don't have perfect data because many states don't track homeschoolers, estimates suggest there are several million children being educated at home. And the exodus is

growing rapidly.

We do have a lot of data showing these children will do drastically better than the victims of government schools. Hopefully, the home-schoolers can become the leaders of the future, and potentially even rebuild from the ashes. The trillion-dollar-per-year government education monster is gearing up for war against home education, but this will be a hard battle for the evil-doers to win – especially with home-schoolers doing so well on every metric.

My book, Indoctrinating Our Children to Death is doing extremely well.

We've already received endorsements from many of America's top leaders in education, ministry, media, military, politics and business. Millions have heard about it via radio, TV and print media – and we're just getting started! Sales are surpassing our wildest expectations as the word continues to spread. We hope this will continue, because the battle over education is the most important fight of all.

We live in a barely fathomable complex of corporate/private interests and a labyrinthine state infrastructure. Plausible deniability allows government corruption, corporate crime, financial domination, medical malfeasance, unlawful prohibition, propaganda, racketeering and illegal wars to all go

Vaccine trial kills nurse

However, like countless others in the sporting world, Fordyce had trusted the hype surrounding covid and he had been vaccinated. In a race to bring them to market, they have neither looked carefully nor cared to pay due attention to the warning signs and it is the trusting public, people like Gareth's sister Elsie, who are paying the ultimate price now. Spring's conspiracy journey

THE central narrative of
Marianna Spring's Among the
trolls: My Journey Through
Conspiracyland focuses on the
author's claims of bullying,
trolling, and even murder
threats.

Spring was appointed as the BBC's first disinformation and social media correspondent in March 2020 – mirroring similarly appointed roles in the U.S. media at CNN and NBC.

She claims it was her role of 'upholding the integrity of contemporary journalism' that sparked most of the abuse.

The cover offers a good indication of what the contents will be. Spring is depicted as an artistic representation, in the middle of a group of people (diversely represented, of course), with the individuals in the scene looking as if they are a) about to kick off, b) are in the middle of hurling vitriolic abuse to all and sundry, or c) are caught somewhere in between the two and about to suffer a nervous breakdown as a result.

She says her journey into 'conspiracyland' began during 9/11. Aged five, her innate journalistic qualities prompted her to question an event so self-explanatory that she now reasons: 'I couldn't get my head around how people might think that something like that could happen deliberately. It was terrifying.'

From this unsettling experience, it seemed as if Spring's future destiny was signposted to greatness – to lead the fight against challenges to mainstream news and their 'self-evident truths'

Whilst she does acknowledge that politicians and the media can both mislead or lie, this does not extend to 9/11, or any other event in which the role of the establishment might come under scrutiny.

The book itself is principally organised around pandemic-era counter-narratives; the origin of most of the hatred and vitriol to which she has been subjected.

This is not entirely surprising, given that her BBC role 'coincidentally' materialised in March 2020 – the very moment

when those who chose to think critically surmised that it was actually a great reset that was being foisted on the world and not a public health crisis.

This was the very moment that the conspiracy theorist label reemerged into a world where the establishment was again under scrutiny and was in need of a political safety valve. The term was rolled out to both crystalise dissent and to isolate people with brains who were willing to stand against a remarkably docile society.

Spring's book rides this wave and highlights the real intention of her role at the BBC – to belittle and ridicule challenges to the authoritarian crimes of covid era politics, and to stoke up modernday witch-hunts of those who choose to stand in truth.


She claims to be targeting lies, disinformation, and misinformation in our society, but her employer, the BBC, mirrors those very same qualities.

I mean, where do we begin? Should we challenge her on the global rise in excess deaths (and recent political massaging of these figures), adverse reactions from the vaccination roll-out (all in the public domain in the Yellow Card Scheme)? Or what about the outright lies being peddled by the pharmaceutical companies and their government allies on respectively, 'effectiveness', 'efficacy', and 'safety'?

All these claims are unravelling. Perhaps we could raise the issue of the 'liberal labelling' of covid deaths. We could broaden the discussion further to highlight clear conflicts of interests around PPE contract handouts, or dubious investments in pharmaceutical companies by people involved in designing the very policies which would guide the customer base.

We might even consider that the establishment itself paid no heed to its own public health policies. But perhaps Spring does not care to consider any of the above, or

to consider any of the above, or any of the other discrepancies in the official version of what is being experienced in our world right now. After all, when your newly established role at the BBC demands that you prioritise their particular 'confirmation biases',



you can neatly side-step the lies, disinformation and misinformation that are your employer's stock-intrade and claim these as truths. When this version of reality is challenged, you can then claim victimhood. As an overview of the dark arts of 'the new normal', this book provides a unique understanding of how victimhood, lack of self-awareness and absence of personal responsibility now provide the reference points for legacy media journalism.

Warning of future we may inherit

Book review of The Mirror by Tim Bragg

THE Mirror is a dystopian novel set in a not-too-distant future – 2073 – where humanity is held captive within its society.

It is a society completely run by a system of artificial intelligence and technocracy similar to that envisaged by both one-time Fabian socialists, Aldous Huxley (*Brave New World*) and George Orwell (*Nineteen Eighty-Four*).

Both of these authors portrayed 'one world' collectivist states run by a cabal of central planners where life, language, media and entertainment are completely

regulated and controlled.

Bragg here offers a very compelling and highly relevant take on this theme for contemporary times, but with perhaps a story more reminiscent of the film, *Blade Runner*, (itself based on the novel *Do Androids Dream of Electric Sheep?* by the gnostic Philip K Dick) and Mary Shelley's classic, *Frankenstein*.

But *The Mirror* has a much more uplifting and positive affirmation of the human capacity for self-transcendence through the essence of creativity and art.

The nature of art is one of the central themes of the book, but also how art can be captured and simulated by technology (witness now how AI can itself write poetry and paint images, etc.).

There is a cryptic reference in the story to how the world changed in 2030. Some of the characters in the book who hold positions



of power have names that appear rather 'hipster' or eco-themed, although the world they inhabit is anything but natural.

There is cloning, eugenics, genetic engineering and mass surveillance. Even reproduction, itself reduced to life inside something resembling a panopticon, is closely screened

in the name of 'mother earth'.

Space is given in the book to themes of human immortality in the face of individual extinction, particularly as one central character has a near-death experience.

This theme becomes central to the novel's central premise – do humans and nature have a soul or spirit?

Are we soul and spirit, or merely biological machines with neither? Does consciousness actually exist independently of the mind? Do we think thoughts, or are thoughts thinking for us? What does it mean to be human?

Another work worthy of mention in this context here would be C.S. Lewis's *That Hideous Strength*, an anti-transhumanist classic.

Bragg has succeeded in writing a highly readable novel depicting what the world would look like should Klaus Schwab's vision of the Great Reset and Agenda 2030 actually come to fruition and succeed in reducing all of humanity to automatons.

Given the indefatigable spirit of humanity, though, Bragg gives us much inspiration to suggest that a single blade of grass could cut through concrete given time.

Genuine human values like compassion, friendship and love, and the redeeming capacity of art, win through in the end somehow.

This is a multi-layered work with good characterisation and many textures and tones, which slowly draws the reader in, with twists and turns in the tale amidst a mounting fear that builds to its shocking conclusion.

It is a critical attack against transhumanism, which succeeds without either preaching or condemning, and clearly displays the author's obvious empathy and sensitivity to the human condition.

The pyramid of power

WHO'S really running this dystopian reality show? That's a question that I often face from the audience at speaking events, and I always respond by admitting that I don't know the answer.

None of us do, if we're honest. Recently, at the Brighton Free Speech Society. I asked the gathering whether they could identify the people pulling the strings. Several answers were given, each stated with certainty, but no conclusive evidence: Big Pharma, bankers, dynasties, Freemasons and Satanists were all named as the architects of a totalitarian new world order.

Whoever the master planners are, clearly there is a global agenda that all countries are expected to follow. Democracy and national sovereignty, as shown during the pseudo-pandemic, and with the preposterous climate emergency, have become a sham. In my book, Green in Tooth and Claw, I present this pyramid of power.

On the lower stratum are the ordinary people, who are often apathetic or gullible in regard to the official narrative (for example, believing that covid-19 vaccines are safe and effective). However, such 'commoners' are also associated with common sense.

Around the time of the EU referendum, sociologist, David Goodhart, described a new political fault line between the progressive morality of the cosmopolitan middle class (Anywheres) and the faith, flag and family bonds of the lower social classes (Somewheres).

Brexit showed how the former deride the latter for their attraction to 'populism'. Psychological research consistently shows that no more than about 10 per cent of the population are critical thinkers, but they are disproportionately found in the lower levels of the social

hierarchy (despite – or rather because of – their lower educational attainments).

Moving up to the professional managerial bureaucracy, critical thinking is less prevalent here. Conformity is rewarded, while dissidents do not fare well on the promotion ladder and are prone to disciplinary action (as I regularly observe as a trade union rep). This stratum includes lawyers, accountants, doctors, teachers and lecturers, civil servants, councillors and backbench MPs. These are Goodhart's 'Anywheres', who dominate our culture, institutions and professions. They consider themselves sophisticated, which the dictionary defines as 'deprived of native or original simplicity'.

This is the officer class of the societal hierarchy, and compliance is most strictly maintained within their own ranks. To get ahead in the bureaucracy, one must display the values of purported progressivism (a nexus of green and woke). Judges are only appointed if they have shown commitment to diversity, equality and inclusion. Labour and Conservative parties carefully vet candidates for each parliamentary seat, ensuring that they are in tune with the agenda. Below this level, as the clerical officer Winston Smith found when he went walkabout in Nineteen Eighty-Four, there is relative freedom from the ideological regime. Ascending to the next level are global leaders. The likes of Justin Trudeau, Jacinda Ardern and Nicola Sturgeon took to the contrived covid-19 crisis like ducks to water. The difference between them and the majority of politicians is that they knew that the contagion was a scam (this was apparent when they removed their masks as soon as the cameras were off, and when Boris Johnson held parties at 10, Downing Street soon after imposing lockdown). At the upper reaches of this level are the most prominent exponents of globalism: Tony Blair, George Soros, Barack Obama, Klaus Schwab and Bill Gates. These are frontmen; although tremendously influential, they are not at the

commanding heights.

Ultimately, though, the pyramid of power is not merely for material gain. The motives may be perceived as megalomania, but I suggest a spiritual driving force. U.S. military emails leaked online



UNCLASSIFIED sensitive emails containing personal information dating back years were spilled on the internet in an embarrassing and dangerous development for the U.S. Military.

In February, a senior U.S. Defense official confirmed with Fox News that a U.S. Department of Defense server was left exposed online for two weeks, allowing internal emails to be accessed.

Fox News reported: 'A misconfiguration with a Department of Defense server hosted on Microsoft Azure's government cloud allowed the server to be accessed with a password, according to Tech Crunch, which reported that anyone with internet access could access mailbox data if they knew the server's IP address and were using a web browser.'

The leaked server contained an internal

mailbox of three terabytes of military emails, with many related to the U.S. Special Operations Command, which is a military unit that conducts special operations.

One of the files exposed contained a completed SF-86 questionnaire. According to *Tech Crunch*, a leading technology media property: 'The server was packed with internal military email messages, dating back years, some of which contained sensitive personnel information.

'One of the exposed files included a completed SF-86 questionnaire, which are filled out by federal employees seeking a security clearance and contain highly sensitive personal and health information for vetting individuals before they are cleared to handle classified information. These personnel questionnaires contain a significant amount of background information on security clearance holders valuable to foreign adversaries.'

In a statement to Tech Crunch, U.S. Special Operations Command (USSOCOM) spokesman Ken McGraw said: "We can confirm at this point that no one hacked U.S. Special Operations Command's information systems.'

The U.S. government was contacted initially by *Tech Crunch*, after an accomplished security researcher called Anurag Sen, known for discovering sensitive data that has been inadvertently published online, found the exposed server on the open web.

Shodan, a search engine that scans the entirety of the internet for exposed systems and databases, discovered the mailbox server was first spilling data on February 8.

It remains unknown how the military mailbox was leaked to the open internet, but their excuse is a 'misconfiguration caused by human error.' Investigations are under way at the USSOCOM.

If the Biden administration focused less on the bogus climate crisis and wokeology and more on tightening cyber security, serious errors like this might not occur.

Failed asylum seekers being frozen out

THE Icelandic government has recently voted in favour of cracking down on illegal immigration and will impose stricter laws for anyone seeking asylum in the country.

According to REMIX News: 'Iceland's parliament is cracking down on immigration, with new legislation that strips asylum seekers of housing and healthcare, along with other rights, 30 days after their application is rejected. The country's parliament passed the legislation despite protests from human rights organisations, including Amnesty International, which is funded by billionaire oligarch George Soros, and other organisations like the Red Cross and UNICEF, according to Icelandic news site

Members of the Icelandic Parliament voted 38 to 15 in favour of taking state health and social security benefits away from failed asylum seekers. The Bill had the support of the three ruling government parties in Iceland

SchengenVisaInfo reported that Iceland has recently been subject to a large number of refugees, with more than 2,500 asylum applications filed last year.

Justice Minister Jón Gunnarsson justified the Bill by stating: "There have been repeated attempts here for several years

to make changes to the immigration law. The situation has changed a lot during this time, and today we are faced with an unprecedented problem when it comes

to receiving everyone who comes to us as refugees and seeking protection. Therefore, in my mind, it is quite clear that we need to consider further steps to bring us closer to the regulations that apply in our neighbouring countries so that we are not getting a number that far exceeds what is in these countries."

Gunnarsson added that the new law was in response to an 'out of control' asylum system.

REMIX News stated: 'The reality shows that the crime trend in Iceland is worsening. Gangland killings have become a new phenomenon, including a recent case involving Albanian gang members, which may be fuelling anti-immigration sentiment.' Global Initiative reported on the case by saying: 'An execution-style murder such as this is practically unheardof in Iceland and has prompted renewed discussion on the changing criminal landscape in the country and the rise of organised crime and its associated violence. Investigators are confident they have uncovered the motive for the murder, but when pressed by media they declined to offer further details.'

Iceland is leading the way in tackling uncontrolled and illegal immigration.

Why the West supports Israel

Powerful Zionist lobby groups are influencing politics

THE narrative runs that Israel is key to U.S. interests in the Middle East and, by extension, to those of Britain and Europe.

Prof. Jean Bricmont and Diana Johnstone write on *Global Research* that Israel is of no strategic, military or economic value to the U.S. because there are enough American military bases and fleets in the area to handle any kind of military needs without using Israel, and money only flows in one direction: towards Israel.

Retired U.S. Colonel Douglas MacGregor is also of the view that Israel is nothing but a chronic liability for his country, which only serves to antagonise America's relations with the Arab states, Iran and Turkey. So what motivates the West to sink ever deeper into pariah status in its defence of the indefensible?

Referring to Israel's ongoing slaughter of Palestinians in Gaza and the West Bank, British journalist and author Owen Jones said: "Western governments have openly facilitated some of the worst crimes of our age. I don't think the West is ever going to recover from this."

American journalist Alison Weir, author of *Against Our Better Judgement: How the U.S. was used to create Israel*, explains how important it is to examine why the West is taking such irrational, immoral, and self-destructive actions.

The answer is that the U.S., Canada, the UK, France, Germany, and Europe in general, are under the pervasive and extremely powerful influence of the pro-Israel Lobby.

The Israel Lobby groups are ubiquitous, very well organised, and have access to unlimited funding through their alliance with powerful bankers. The extent and scope of capture of the major institutions by Zionist lobbying organisations in the UK is probable, but unknown.

David Miller, the social science

professor of Bristol University who was forced out of his post by some of these organisations, in February won his case in an employment tribunal for discrimination and unfair dismissal.

This was after three years of battling against these forces. He estimates that over 2,000 of these Zionist lobby groups operate in the UK, whilst in the U.S. their number is a multiple of this figure. In 2012, the journalist and broadcaster Peter Oborne wrote that 'some 80% of all Tory MPs are members of Conservative Friends of Israel, including most Cabinet ministers.' But the same applies to the Labour Party who have their own Labour Friends of Israel.

The Zionist political project began in the 19th century on both sides of the Atlantic with the financial support of wealthy industrialists and bankers such as the Rockefellers in the U.S. and the Rothschilds in the UK. The project was also aided by

influential figures such as U.S. Supreme Court Judge Justice Louis Brandeis who wielded considerable political power through the secret society 'The Parushim', and former British PM and Foreign Secretary Lord Balfour

During the First World War, Zionist membership expanded dramatically, despite the best efforts of some Jewish anti-Zionists – for it is important to note that not all Jews are Zionists, nor are all Zionists Jews.

Many thoughtful, intellectual Jewish voices opposed Zionist ideology then, and oppose it now, but these voices are censored and punished by the same methods the Zionist networks deploy to silence all opposing voices.

The enormous power and reach the Israel Lobby network has across Western governments and institutions is a function of an alliance between Jewish Zionists and Christian Zionists in their support of the State of Israel.

During World War 2, Jewish Zionists in the U.S. devised a strategy to 'crystallise the sympathy of Christian America for our [Zionist] cause.'

Christian support was largely gained by exploiting their wish to help people in need. However, Christian Zionism grew into a huge movement and an omnipotent lobby group, the militant extreme right-wing of which is increasingly directing American foreign policy, and by extension, that of NATO countries, having infiltrated not only the Republican Party, but Washington and most of Congress.

Clifford Keracofe served in the U.S. Senate from 1981-1992 and witnessed first-hand how these various Zionist pressure groups operated: AIPAC – American Israel Political Action Committee, ZOA – Zionist Organisation of America, CUFI – Christians United for Israel, to mention a few. He explained how they ruthlessly saw to it that the State Department (the

U.S. Foreign Office) was purged of experienced ambassadors and diplomats to the Middle East, whose foreign policy attitudes since World War Two had been balanced. The Department became 'zionised' as the objective staffers were weeded out.

Jimmy Carter (U.S. president from 1977-1981) was highly knowledgeable of the history of the Middle East and was dedicated to achieving a just peace agreement in Palestine. But this ran counter to the Zionist goal. Carter did not win a second term. It is no secret that the Israel Lobby hold the keys to the White House.

In 2006 Jimmy Carter published his book *Palestine: Peace Not Apartheid*.

In 2009 Keracofe published his book *Dark Crusade: Christian Zionism and U.S. Foreign Policy* described as 'the most nuanced analysis yet written of the dangerous and complex phenomenon of Christian Zionism's influence on American foreign policy.'

In an interview on UK Column, Keracofe explained that Protestant fundamentalists anticipating the end of the world have made common cause with the most extreme political elements in the State of Israel, who believe all non-Jews must be expelled from the Holy Land.

He further claimed that Congress' support for Israel and its genocidal policies began in 1948. In his opinion, the Neo-Conservatives want to break the ability of the U.S. to have a decent relationship with Russia and China because, if the major powers, including Europe, cooperate on Middle East policy, they would impose a peace deal on Israel. Instead, just as the Christian Zionists pushed for the Iraq War, they now push for war with Iran.

It is essential to understand how the West has become hostage to what Keracofe describes as 'an apocalyptic death cult ideology' if we are to expose and dismantle it.

How the CIA destabilises the world

Secret agency with no accountability has caused death of millions

THERE are three basic problems with the CIA (Central Intelligence Agency): its objectives, methods, and unaccountability.

Its operational objectives are whatever the CIA or the President of the United States defines to be in the U.S. interest at a given time, irrespective of international or U.S. law.

Its methods are secretive and duplicitous. Its unaccountability means that the CIA and president run foreign policy without any public scrutiny. Congress is a doormat, a sideshow.

As a recent CIA Director, Mike Pompeo, said of his time at the CIA: "I was the CIA director. We lied, we cheated, we stole. We had entire training courses. It reminds you of the glory of the American experiment."

The CIA was established in 1947 as the successor to the Office of Strategic Services (OSS). The OSS had performed two distinct roles in World War II, intelligence and subversion.

The CIA took over both roles. On the one hand, the CIA was to provide intelligence to the U.S. government. On the other, the CIA was to subvert the 'enemy', that is, whomever the president or CIA defined as the enemy, using a wide range of measures: assassinations, coups, staged unrest, arming of insurgents, and other means.

It is the latter role that has proved devastating to global stability and the U.S. rule of law. It is a role that the CIA continues to pursue today. In effect, the CIA is a secret army of the U.S., capable of creating mayhem across the world with no accountability whatsoever.

When President Dwight
Eisenhower decided that Africa's
rising political star, democratically
elected Patrice Lumumba of Zaire
(now the Democratic Republic
of Congo), was the enemy,
the CIA conspired in his 1961
assassination, thus undermining
the democratic hopes for Africa.
He would hardly be the last
African president brought down
by the CIA.

In its 77-year history, the CIA has been held to serious public account just once, in 1975. In that year, Idaho senator Frank Church led a Senate investigation that exposed the CIA's shocking rampage of assassinations, coups, destabilization, surveillance, and Mengele-style torture and medical 'experiments'.

oppose the oversight prerogatives of the Congress.

The Watergate scandal, investigated by the Senate Ervin Committee, had also empowered the Senate and demonstrated the value of Senate oversight of Executive Branch abuses of power. Crucially, the CIA was newly led by Director William

characteristics chronically in short supply in U.S. politics.

Since 1975, the CIA has run secretive operations backing Islamic jihadists in Afghanistan that utterly wrecked Afghanistan while giving rise to al-Qaeda. The CIA has likely run secretive operations in the Balkans against Serbia, in the Caucuses against

destabilise the government of Afghanistan, with the aim of inducing the Soviet Union to invade that country.

In the case of Ukraine, we know that the U.S. played a major covert role in the violent coup that brought down Yanukovych and that swept Ukraine into a decade of bloodshed, but to this day we don't know the details. Russia offered the world a window into the coup by intercepting and then posting a call between Victoria Nuland, then U.S. Assistant Secretary of State (now Under-Secretary of State) and U.S. Ambassador to Ukraine Geoffrey Pvatt (now Assistant Secretary of State), in which they plot the post-coup government. Following the coup, the CIA covertly trained special operations forces of the post-coup regime the U.S. had helped bring to power.

We have good reason to believe that CIA operatives carried out the destruction of the Nord Stream pipeline, as per Seymour Hersh, who is now an independent reporter. Unlike in 1975, when Hersh was with the New York Times at a time when the paper still tried to hold the government to account, the Times does not even deign to look into Hersh's account.

Holding the CIA to public account is of course a steep uphill struggle. Presidents and the Congress don't even try. The mainstream media doesn't investigate the CIA, preferring instead to quote 'senior unnamed officials' and the official coverup. Are the mainstream media outlets lazy, suborned, afraid of losing advertising revenues from the military-industrial complex, threatened, ignorant, or all of the above? Who knows?

Next year is the 50th anniversary of the Church Committee hearings. Fifty years on, with the precedent, inspiration, and guidance of the Church Committee itself, it's urgently time to open the blinds and expose the truth about the CIA.

The exposé by the Church Committee of the CIA's shocking malfeasance has recently been chronicled in a superb book by the investigative reporter James Risen titled, The Last Honest Man: The CIA, the FBI, the Mafia, and the Kennedys—and One Senator's Fight to Save Democracy.

That single episode of oversight occurred because of a rare confluence of events.

In the year before the Church Committee, the Watergate scandal had toppled Richard Nixon and weakened the White House. As successor to Nixon, Gerald Ford was unelected, a former Congressman, and reluctant to Colby, who wanted to clean up the CIA operations. Also, FBI Director J Edgar Hoover, author of pervasive illegalities also exposed by the Church committee, had died in 1972.

In December 1974, investigative reporter Seymour Hersh, then as now a great reporter with sources inside the CIA, published an account of illegal CIA intelligence operations against the U.S. antiwar movement. The Senate Majority Leader at the time, Mike Mansfield, a leader of character, then appointed Church to investigate the CIA. Senator Church himself was a brave, honest, intelligent, independentminded, and intrepid politician,

Russia, and in Central Asia targeting China, all deploying CIA-backed jihadists. In the last decade, the CIA ran deadly operations to topple Syria's Bashir al-Assad, again with Islamic jihadists. Neuralink animal testing horror exposed

Statement from the Physicians Committee on Musk's purported Patient Implant

ON January 29, 2024, Elon Musk claimed on his social media platform X that a patient had received an implant from Musk's brain-computer interface company Neuralink 'and is recovering well'.

The statement has not been independently verified. It is important to remember that Musk has a long track record of misleading the public about Neuralink's supposed developments.

In addition, Neuralink has a well-documented history of conducting unnecessary, sloppy experiments on monkeys, pigs, sheep, and other animals that raise serious concerns about the safety of its device. Past experiments revealed serious safety concerns stemming from the device's invasiveness and rushed actions by company employees.

In addition, a significant number of medical devices approved for clinical trials fail to ever make it to the market. As such, the public should continue to be sceptical of the safety and functionality of any device produced by Neuralink.

According to a March 2023 news report, which cited Neuralink employees, the U.S. Food and Drug Administration (FDA) itself 'raised safety concerns' related to 'device's lithium battery; the potential for the implant's tiny wires to migrate to other areas of the brain; and questions over whether and how the device can be removed without damaging brain tissue.'

In addition, Musk's true intentions for Neuralink are disturbingly clear. He has repeatedly said the goal of the company is 'to achieve a symbiosis with artificial intelligence' which is not necessarily in line with developing treatments for patients.

The Physicians Committee continues to urge Elon Musk and Neuralink to shift to developing a noninvasive brain-computer interface. Researchers elsewhere have already made progress to improve patient health using such noninvasive methods, which do not come with the risk of surgical complications, infections, or additional operations to repair malfunctioning implants. Noninvasive devices are already demonstrating the ability to improve quality of life for older adults and elderly patients, translate brain activity into intelligible speech, and assist paralysed patients.

The Physicians Committee was the first group to obtain internal records from the University of California, Davis (UC Davis), where Neuralink conducted painful, deadly experiments on monkeys between 2017 and 2020. Many of those records were released to the public by the Physicians Committee in February 2022.

Here is a timeline of events since then:

March 2022

In response to the Physicians Committee's complaint alleging violations of the federal Animal Welfare Act by Neuralink and UC Davis, the U.S. Department of Agriculture (USDA) inspected both facilities. The agency has a well-documented history of failing to hold violators accountable, and its inspections of Neuralink and UC Davis continued that trend. However, USDA Secretary Tom Vilsack later confirmed to Congress that a violation of the law did occur—except it was wiped away due to a now-forbidden agency policy designed to remove such incidents from public records.

The August 2019 incident involved a male rhesus macaque identified only as 'Animal 8' by UC Davis. According to records obtained by the Physicians Committee for Responsible Medicine through a public records lawsuit against UC Davis, a company neurosurgeon drilled two holes in Animal 8's skull. implanted electrodes in his brain, and used bone screws to attach electronics to his head. The holes were then filled with a surgical adhesive called BioGlue. Soon thereafter, Neuralink and UC Davis staff killed Animal 8. BioGlue had never been approved for use in the experiment, which is a serious violation or 'noncompliance' in USDA's language—of the Animal Welfare Act.

Vilsack did not address an earlier, even more troubling incident involving BioGlue. In September 2018, a Neuralink neurosurgeon drilled into the skull of a female rhesus macaque known only as 'Animal 21' and filled holes with the adhesive.

The next day, she lost coordination and balance, experienced paralysis in both legs and was suffering from 'depression'. The day after that, she was seen 'gasping/retching' and 'collapse[d] from exhaustion/fatigue.' When staff finally euthanised her and conducted a necropsy, they discovered BioGlue was 'covering and compressing a

large area of the left cerebrum' and blood had

built up on the surface of her brain. They also

due to vomiting' and blood in her stomach. BioGlue had never been approved for use in the study, and it remains unclear why USDA did not cite Neuralink and UC Davis for this serious violation. It is also unclear why USDA found the September 2018 use of BioGlue to be a violation but not the August 2019 use.

September 2022

Filings related to a public records lawsuit by the Physicians Committee against UC Davis revealed the university possesses 371 photographs related to monkey experiments conducted by Neuralink. Yet the university's attorneys argued that the images should not be released because the public would misunderstand them. As of the date of this statement, the public records lawsuit is ongoing.

December 2022

Reuters reported that Neuralink was under investigation USDA and the U.S. Department of Justice (DOJ) for animal welfare violations.

The investigation also revealed that Neuralink had killed more than 1,500 animals in experiments and employees were concerned that many experiments had been rushed. According to Reuters, an employee 'wrote an angry missive earlier this year to colleagues about the need to overhaul how the company organises animal surgeries to prevent hack jobs.'

'The rushed schedule,' the employee wrote, 'resulted in under-prepared and over-stressed staffers scrambling to meet deadlines and making last-minute changes before surgeries, raising risks to the animals.' As of July 2023 and November 2023, neither USDA nor DOJ, respectively, would confirm or deny the existence of investigations.

December 2022

Members of Congress wrote to USDA to raise animal welfare concerns about Neuralink and urge greater oversight of the company.

February 2023

New records obtained by the Physicians

Committee from UC Davis revealed that Neuralink may have violated federal hazardous materials laws by transporting infectious pathogens from 'infected' monkeys without safely packaging them. In one email, from 2019, a UC Davis employee wrote to Neuralink: 'Since the hardware components of the explanted neural device are not sealed and it was not disinfected prior to leaving the [university], this presents a hazard for anyone potentially coming in contact with the device. Simply labeling it "hazardous" doesn't account for the risk of potentially contracting Herpes B.' Later, a UC Davis employee wrote that "devices had made their way back [to the university] in an open box," emphasizing: 'we are making a big deal about this because we are concerned for human safety.' The Physicians Committee provided the records to the U.S. Department of Transportation (DOT), which launched an investigation. (See January 2024 below for further updates on this.)

May 2023

Reuters reported that Neuralink's internal panel which oversees animal experiments was 'rife with potential conflicts,' raising 'questions about potential violations of conflict-of-interest regulations,' according to bioethicists.

September 2023

Following false claims by Elon Musk about the deaths of monkeys, the Physicians Committee asked the U.S. Securities and Exchange Commission (SEC) to investigate Musk and Neuralink for possible securities fraud, pointing out that he may be deliberately misleading investors.

October 2023

WIRED reported disturbing details about Neuralink's monkey experiments and how the company works to keep photos of those experiments secret.

November 2023

U.S. lawmakers also asked SEC to investigate Musk and Neuralink for securities fraud.

January 2024

Public records reveal that DOT fined Neuralink for violations of federal hazardous materials laws. The fines stemmed from the investigation launched after the Physicians Committee's February 2023 complaint.

Calibrating and nudging citizens

The abuse of behavioural science during covid:

Psychologist Dr Gary Sidley interviewed by Richard House

Richard House [RH]: Gary, tell us how you, a professional psychologist, came to initiate a major research project into the state abuse of behavioural science.

Gary Sidley [GS]: At the start of the covid event in early 2020, my attention was drawn to the daily fear-porn - comprising scary images and non-contextualised death counts - on our TV screens. My initial suspicion, that I was witnessing an overreaction to a 'novel coronavirus', grew in conviction, so I did my own research. I soon found like-minded people, and joined campaign groups actively challenging the dominant covid narrative, developing a specific interest in the state's deployment of behavioural-science strategies - or 'nudges' - and the ethically dubious way these psychological methods of persuasion were being used to influence people.

Having trained as an NHS clinical psychologist, I've long been familiar with the 'behaviourism' paradigm and its associated therapies, so I was able to quickly get up-to-speed with the way behavioural science was being infused into public-health messaging, and I didn't like what I found – namely, a government strategically inflicting fear and shame to lever compliance with contentious, nonevidenced goals. I was keen to dig deeper, and identify the personnel responsible for these harrowing advertisements; when the Panda organisation offered to support me, the research project began.

RH: My response in March 2020 was identical to yours, Gary. So tell us about the 'headline' joys and tribulations of your research project, and its key findings.

GS: The major frustrations have been the evasiveness of the Cabinet Office when responding to Freedom of Information requests, often refusing to answer our questions, claiming the requested information was 'not centrally held' and would, therefore, take too long to retrieve. So we had to keep re-submitting our questions in a more specific form to prise something useful from them. The joys were in revealing the little-known and previously unknown details about the state's deployment of behavioural-science strategies during the production of the 'Look Them in the Eyes' (LTITE) messaging campaign. Many of our discoveries will be of interest to UK citizens, and a few they may find quite shocking.

Key findings? First, we confirmed that

state-funded behavioural scientists are ubiquitous in the UK. During covid, these nudgers not only resided in advisory groups (like the SAGE sub-group, SPI-B), but could also be found in the 'Government Communication Service' – that employs over 7,000 'professional communicators'

as Susan Michie, David Halpern and Stephen Reicher – we demonstrated that during covid, the published outputs of both the SPI-B and the Behavioural Insight Team endorsed fear-inflating and shaming nudges, as well as encouraging strategies harnessing peer pressure and

and as in-house staff within most government departments. For example, the UK Health Security Agency currently hosts
 behavioural scientists. The Government also entered into lucrative contracts with the Behavioural Insight Team (aka the 'Nudge Unit') so as to be furnished with nudge expertise.

Second, we identified the actors directly involved in the making of the LTITE campaign. Thus, MullenLowe was the advertising agency; Conrad Bird was the senior civil servant responsible for commissioning the videos and posters; the small behavioural-science team located in the Cabinet Office provided the behavioural-science input; and Matt 'don't-kill-your-gran' Hancock was the minister ultimately accountable for the sign-off.

Third, contrary to the claims of several prominent behavioural scientists – such

scapegoating.

Fourth – perhaps most strikingly – we revealed that the official Cabinet Office justifications for unleashing the harrowing LTITE materials upon the public included: the existence of a 'complacent' minority; the observation that young people had a stronger belief in their ability to recover from covid, and the perception that people were less terrified in January 2021 as compared to the first lockdown in March 2020.

Finally, there was zero input from ethical specialists into the development of the LTITE campaign; the Cabinet Office conducted their own 'insight research' which – apparently – indicated that ethical approval was unnecessary.

RH: In a 2023 *Telegraph* report, Halpern referred to people being 'miscalibrated' – that's scarcely believable de-humanisation. Can these disreputable 'scientists' be held accountable to any professional organisations for breaking ethical codes? – and if not, what can we do?...

GS: Totally agree, Richard; talking about human beings as if they are no more than inanimate machines is grossly unethical. It also conveys the contempt in which we are currently held by those in positions of power and influence.

I'm unsure what professional body Halpern belongs to. But I do know that other prominent behavioural scientists – like Michie and Reicher – are members of the British Psychological Society (BPS), the organisation tasked with overseeing the activities of practising UK psychologists. The BPS's Code of Ethics dictates that all its members should, and I quote: 'value the dignity and worth of all persons, with sensitivity to the dynamics of perceived authority... with particular regard to people's rights... Psychologists should consider issues of power: ... consent... self-determination'.

In early January 2021, with 47 other psychological specialists I wrote to the BPS, raising significant ethical concerns regarding the way behavioural science was deployed during the covid event. Alas, the BPS didn't want to know, stridently defending the activities of their psychologists who had deployed fearinflation, shame and scapegoating on the British people.

As for what we can do, increasing the awareness of the public about the dehumanising nudge strategies that they've had to endure will likely lead to more visible dissent — a necessary step if we're to halt the march of authoritarianism. Furthermore, in the second phase of my research project we will propose an optimal ethical framework that, hopefully, might constrain the state's future use of behavioural science. Watch this space!...

The power of doing without

AS I write this, I am in the last few days of a ninety-day challenge, which I chose to do as part of my main job, which is as a diet and lifestyle coach running 'The Big Fat Challenge'.

I was getting bored of hearing myself repeat the same story: that I had never needed to be really strict about my food because I wasn't sick, and that I envied some others who knew what it was like to eliminate all the crap.

So I decided to change the record. I made a commitment that, starting on the first of January, I would do ninety days of strict carnivore—just meat, fat, salt, and water. I can tell you, the first few weeks were torturous! I found myself having to fight cravings on a daily basis, and was fantasising about the enormous binge I would indulge in on day 91!

However, it proved to be one of the most life-enhancing things I have ever done. Within thirty days the cravings had subsided and given way to wave after wave of profound realisations. Now, with only five days to go, I have been 99% successful, and even the 1% where I chose to break my word were also extremely enriching.

The point is not to stir the reader's emotions (because nothing gets people so riled up as the topic of food), but to share with you that this pilgrimage of the plate has unexpectedly revealed a lifechanging sequence of insights.

Many of the most profound realisations have come as by-products of stepping away from the everyday addictions to sugar, carbs, alcohol, tobacco, and caffeine. I have discovered truths about myself, about human existence, and about the world we live in.

One of the most powerful recurring themes has been beginning to see more clearly how resilient, powerful, and beautiful we human beings are once we set aside the comforting—but numbing—addictions, whether it's stimulants, depressants, habits, or even relationships.

The message that has come through again and again is how we are enough, after all the distractions are stripped away. Perhaps that is even part of the allure of the comforts, covering up the fear that we fundamentally are not good enough?

Today is day 85, which means I have now published 85 short diary videos charting my journey (search "Big Fat Substack" to get them all). Another thing that has

really surprised me is how freely the ideas kept coming once I was in the flow. All I needed to do was open my mind to the universe and allow the next insight to illuminate

Today I was reminded of a quote by Immanuel Kant: 'We are not rich by what we possess but by what we can several hours, or even several days, at a time is little hardship. I remember how hangry I used to get as a vegetarian carb junkie if I failed to stuff something grainbased into my mouth every few hours! That weakness is now behind me.

But isn't that just a banal observation? What can the ability to fast intermittently

do without.'

As has happened so many times, this showed parallels between the mundane topic of food and nutrition, the more intriguing aspects of psychology and addiction, and beyond into the spiritual realm. Maybe that is because the body, mind, and spirit are in fact inextricably linked?

Let's take the principle of doing without revealing richness. Of course Kant was probably referring to the distinction between material wealth and more eternal forms of richness, the stuff that no court can confiscate and no bailiff can haul away.

Can a concept like that apply to the body? Absolutely! I have learned that, when your physical form is properly and fully nourished, going without eating for

have to do with this column's usual subject matter: the great energetic war that faces humanity today?

Well, we know that metaphors are powerful, even those based on food. 'Eat this, this is my body' to offer just one example. When our bodies are sufficiently nourished and energised by proper food, that allows us to go forth into the world with confidence and freedom, not having to return to the trough every few hours.

What message are we sending ourselves on an emotional level? Surely it says, 'I am enough, I have the resources to achieve what I set out to achieve.' The same goes for the artificial boost of energy that so many people depend on from sugar, carbs, caffeine, or nicotine. To acknowledge that we can do without those things is to own the truth that we

have enough energy.

To discover that life still goes on without depressants like alcohol, that you can still relax, still sleep, or still be sociable when sober does not impoverish your experience of life, but enriches it!

But keep peeling and the layers will continue to fall away. Imagine realising that you can even do without other kinds of props, like the support of certain relationships. How would that transform your day-to-day existence? It would mean discovering that you are enough, just as you are. Of course that does not preclude you from exploring the energy exchanges of partnerships and friendships, but rather to enter into them with a sure and certain sense of your own completeness.

There is only one way to discover what is left when all the imagined supports are removed, only one way to 'know thyself', which is to follow the path of withoutness that theologians have called the 'Via Negativa'.

To say to yourself that you need this energy drink (or whatever the drug of choice may be for that moment) is to send a profound negative message. You are telling yourself over and over again that you are lacking, that you don't have enough within you, even that the universe is fundamentally marked by cold scarcity. But what if it isn't true?

I would encourage you first to believe that you are richer than you imagine. You have physical, emotional, and spiritual resources available to you that no one can take away, which you can access all the more clearly and powerfully when stripped bare of all those petty little addictions, distractions, and comforts.

Surely to meet your true self, and to know that you are okay, you are on solid ground, that the universe is bountiful and abundant and has your back... would that not be a far sweeter comfort than the next chocolate bar, beer, or cigarette?

Am I saying we should never indulge in cake or wine or bread? Absolutely not! I stand for each individual's freedom to choose... but wouldn't it be ideal for that choice to be made positively, from a place of knowledge?

And perhaps we can take it even further. Quite simply, our current energy strategy should be predominantly modern, efficient gas-fired power stations complemented with hydro and tidal schemes, until realistic and environmentally acceptable generation is available.

Noting that gas-fired power stations could become more environmentally acceptable if fed with pre-heated geothermal water – if only the Romans were still in Bath so as to teach politicians a thing or two!




