Disorder created by the state

Government and media knowingly orchestrate Problem-Reaction-Solution

YOU would have thought that half of Britain was on fire for days, and there were nightly street battles between rival groups and the police, with tens of thousands injured, killed or imprisoned.

In fact, serious violent disorder only occurred in a few cities on a few occasions between the end of July and the start of August, with around 500 so far actually being charged by police. It is not known how many of those are for ‘hate speech’ and ‘non-crimes’.

This is classic policy play - create a crisis, whip up the people and let them react, and then come in with the solution which was the policy you

wanted to implement in the first place, but which would never have been accepted without the crisis you created. They will keep doing this for as long as people keep falling for the divide and rule tactics, using the media and social media, government agents and over 100 years of psychological know-how.

The solution is to realise their use of collectivisation, or putting you squarely in a particular box for a time.

We can all be described by many things: by our sex, race, religion, skin colour, ethnic origin, country of origin, our job, our sports team – you name it, we can put ourselves in several categories and groups that we identify with.

The point is that there is no single group you wholly and solely identify

with, because you are an individual and totally unique.

But if they can focus your mind for a time, and have you believe you are only part of one group, and worse, there is another group that is your enemy, then you will stop being an individual for that time. Group psychology is well studied in the field (just go to a football match).

That is how they keep us divided and ruled over – by focusing our attention on the wrong things from the wrong perspectives and for the wrong reasons. Our enemy is the state, not each other.

If you don't think this tactic is powerful, consider how they orchestrate wars and manipulate entire nations to hate all the people of other nations, using genuine hate speech. It is, of course, still continuing today, and the same tactic is used throughout the world to subjugate the masses, kill off the bravest young men, divide us into factions and keep the rulers in obscene wealth and power.

People have been entrenched into taking sides around all the complex problems we face today, and most of them are engineered by the state (the government, intelligence services and organisations that run through all public bodies) and international organisations (formed and directed by the banking cartel that seems to be directing policy for governments across the world now).

This is something we first saw with the covid era. That was another example of problem-reaction-solution, where the solution was to get everyone injected with experimental genetic weapons just

so you could have your normal life back.

They even created the phrase, ‘new normal’ – but how can that possibly be? New normal means you've changed things, by definition. Despite many reading George Orwell, we still don't notice the control of thought through the language that is used. The government has entire departments devoted to behavioural modification, or ‘nudging’ people – controlling what we think and do by using subtle but effective means. Three-word slogans during covid and endless repetition are prime examples.

Three girls were murdered by a 17-year-old of Rwandan origin, and righteous indignation at the crime was turned into racial incitement, division and violent disorder by the government, media and social media influencers, many of whom should be prosecuted under the Race Relations Act and reported to the Commission for Racial Equality.

The Prime Minister's role here cannot be underestimated, either. Having declared he prefers the autocracy of the World Economic Forum to the democracy of Westminster on the BBC, nobody should expect him to be the sound, calming voice of reason; and he hasn't been.

He will double down and stoke up tensions wherever he can, moving his government to implement more restrictions on our freedom and more ways to monitor and control us, for his real paymasters – the international money power that controls central banks.

Problem > Reaction > Solution.

Timeline of manipulation

JULY 14	Euro Football Championship Finals - England come close but lose to Spain at the final hurdle, dashing fans' hopes and national pride once again, and the beginning of the following sequence of events which stirred up strong emotions across the country, in all communities.
25	Manchester airport police video - whips up anger as one edited version is circulated only showing brutal police violence on muslims. The next day, a clip shows how muslims attacked the police first. Policeman is suspended for defending his colleagues; fear is whipped up on all sides.
27	Huge Tommy Robinson rally in Trafalgar Square attracts over 30,000 and is widely publicised in the media. Robinson illegally shows film and now has to be absent to what follows over the next two weeks, as he flees the country. This event stirs up English passion and pride once again.
29	17-year-old Ex-BBC Children in Need actor, of Rwandan origin, kills three girls and wounds ten others in Southport. An obscure website in Pakistan, Channel3Now, run by Mr Farhan Asif, who was later arrested, falsely circulates that the killer was a recent muslim immigrant named Ali Al-Shakati. This is then circulated by the world's media despite being disinformation from an unknown, unverified source. Right-wing influencers also repeat the wrong name and stir emotions in patriots who are rightly angered by the deaths. Killer identified the following day as Axel Rudakubana.
30-31	Riots in Southport, London, Manchester, Liverpool, Leeds, Bristol and around 15 towns over the weekend, with shops looted and damaged, police attacked and several immigrant centres targeted. The usual 'anarchy' signs are seen – a dead giveaway of police/agent agitators. In London, 111 arrests are made, mostly of those caught in a police kettle. Media report that over 100 people are arrested, and can portray the rally as more violent than it was. The peaceful rallies and the girls' deaths are now seemingly forgotten in the division and frustration whipped up.
AUG 1-3	Hope Not Hate's Nick Lowles falsely circulates that muslim women have had acid thrown in their faces, inciting muslim protests to begin attacking whites in cars and pubs, facilitated by police who told them to manage their own security. No mention of this racial violence on English people by Starmer or the media, fuelling yet more English anger. Lowles is not arrested for incitement to racial violence.
4-5	PM Starmer gives TV address stating rioters will face the full force of the law, and calling everyone who protested "far right thugs", making no mention of the reason for the anger, tension and public outcry to try and calm the situation. Predictably, more violence and riots ensue over the next few days in several towns and cities, though overblown by media and government and dying down by the following weekend.
6	Hate's Lowles then also circulates that over 30 'far-right' protests across Britain are being planned at immigration centres, and 'Stand up to Racism' counter-protests are held by the Socialist Workers' Party, with thousands of ready-made printed placards and many attendees bussed in by the trade unions. Though hardly anyone from the alleged 'far-right' protests show up, the front pages of the following day's press carry this supposed moral victory, with photos of the rallies spanning across the media.
7	Lowles takes full credit for the disinformation and subsequent media propaganda, but at a counter-protest in Walthamstow, ex-councillor Ricky Jones allegedly proclaims: "We need to cut their throats and get rid of them all!" to great cheers from the crowd. He was later arrested and charged with encouraging violent disorder, and has pleaded not guilty to the offence. But the crowd's response shows a very worrying glimpse into some people's minds, and we should find ways to de-escalate such hatred and division quickly. Yugoslavia is a stark warning from recent history of how a stable society can descend into chaos and destruction very quickly by 'othering' people.
7-20	Unusually harsh sentences are given to those merely shouting at police or making nasty comments online during the disorder. The real purpose of this whole episode is revealed: to silence all dissent for any reason, under the cover of 'hate speech', 'safety' and 'law and order'; to increase control by the state of the individual. Those who cheer the jailing of people for what they think or say are going to find their joy short-lived when they are themselves targeted. The parallel history of the Bolshevik Revolution is a stark warning from history.

THIS is unfortunately, exactly where the divide-and-rule tactics have led us – the planted agents, the false rumours, the responses by the government when they know exactly what is going on, because they are orchestrating all of it.

English people genuinely want their country back. They're not racist, which is probably the most weaponised word in the world right now, but they are peaceful, kind, tolerant and, when given the right motivation and environment, extremely talented and diligent.

British engineers built the world, and our system of justice is also the envy of most people, even if it has become more corrupted over the years, as insidious infiltration continues into every aspect of life.

Council tax - a question of authority

Judge to rule on law group's No Obligation Challenge

This month a judge is expected to return a judgement on a No Obligation Challenge case involving the non-payment of council tax. The challenge is being brought by human rights and law campaigners Peace Keepers

BY the time you are reading this we will already know whether we have won.

On August 12, District Judge Corkill sitting at Liverpool Magistrates Court committed to returning a reserve judgement in 28 days.

For the first time since the launch of the No Obligation Challenge back on April 1, 2022, we will have a written response from a court to a most pressing question - can parliament assert its will over a person?

We have been asking this question by entering into a dispute with councils up and down the country where we have been collectively withholding payment of council tax.

This is until they answer a request for them to provide the evidence of the obligation for anyone to pay it. To date, and despite some thousands of attempts to extract this information, we have yet to receive a reply which amounts to little more than: 'you just have to.'

This is also despite an offer of nearly £23,000 for anyone to be able to evidence any obligation to pay.

Some months back, District Judge Clarke, also sitting at Liverpool Magistrates Court, vacated a previously issued liability order for non-payment of council tax.

He ripped it up, much to the annoyance of Liverpool City Council.

The reason for the judge reversing the prior

decision to award the liability order was down to a failure in the due process of law. Married to that failure was his reading of the argument that we have been attempting to have tested, namely the No Obligation Challenge.

Most importantly, upon finding merit in our argument, and in voiding that order, District Judge Clarke gave Liverpool City Council the opportunity to have the original case reheard.

It was at this rehearing on Monday, August 12 that District Judge Corkill committed to giving us a reasoned verdict.

The issues can be briefly stated as 1) a bill 2) the summons 3) costs and 4) the tricky one – can parliament assert its will over a person?

A Bill

When is a thing not a thing? To the barrister for Liverpool City Council, it would seem the distinction is unimportant. The problem here is in receiving a council tax bill and not a council tax demand notice. A bill is legislatively defined in the Bills of Exchange Act 1882 and, to cut a long story short, it is a contractual agreement.

Clearly, council tax is not a contractual agreement; it is a thing which derives its legislative authority from the Local Government Finance Act 1992, which allows

for a council to issue a demand notice.

There is a world of difference between paying for a thing to which you have agreed and paying for something that someone demands of you – a distinction which is not lost on the councils.

The expectation here is that, despite the barrister not giving a care for the clear fact that there is no legislative authority for the council to be issuing a bill, the judge can only, rationally, find the same breach.

The Summons

The decision to issue a summons is a judicial decision. The issue is that up and down the country, council officers are emailing a list of unpaying persons to the court and a legal advisor (previously the clerk of the court) is sending those lists back as approved.

The council then issues a summons. A legal advisor has no authority to do what they are doing. They are not bound by the judicial oath and should have no part to play in this process. Thus, the summons are defective. In truth, despite its physical reality, it does not exist as no judge has authorised it.

Here the barrister relied upon The Justices' Clerks Rules 2005 which gives authority to the Legal Advisors to do what they are doing. The problem is that nowhere,

presently at least, does the authority exist for the transfer of a judicial function. The Justices' Clerks Rules 2005 assumes an authority to confer a power that it does not have.

There is no legislative authority for the legal advisor to be authorising a summons, and so the judge can only, rationally, find the same breach.

Costs

For a demand notice that has never been issued, a person then receives a summons which has never been authorised, which will carry upon it some arbitrary number of pounds as to costs.

The barrister informed the court that none of this really matters and that it is in the judge's gift to set costs. Only the problem here is that it is not. The court has no legislative discretion regarding costs, the complainant (Liverpool City Council) must provide the court with evidence that costs are reasonable. Consequently, as the council is just arbitrarily stating costs without evidence, the court has absolutely no discretion and cannot issue a liability order.

Despite the barrister guiding the court that it has discretion where it has none, and for which he was duly admonished by us, the judge can only, rationally, find the same breach.

The Tricky One

It all boils down to a simple constitutional question: can parliament impose its will on individuals? Parliament, much like anyone, can do whatever it wants. The question is whether what they have done is actually lawful.

The Local Government Finance Act 1992 upon which all council tax is based is itself not in dispute, it is plainly a thing which tells councils they can impose a demand upon you. The question is, on what authority is it relying and does that authority have the right to impose that demand?

We think not, and have evidenced why we hold with this understanding to the court.

And at that, we all stood while the judge retired to consider the arguments, to which, in 28 days, we will receive a considered reply.

Scottish Covid Inquiry exposes care home ‘culling’

WHY is no one talking about the Scottish Covid-19 Inquiry?

Could it be due to the fact that many of the witness testimonies focused on the suspicious deaths of the elderly and vulnerable in care homes and hospitals during the ‘pandemic’?

If it hadn’t been for a man on X (formerly Twitter), I probably wouldn’t have known about the Scottish Covid-19 Inquiry.

When I asked a journalist friend living in Scotland what she thought of the inquiry, even she said: “I don’t know anything about it.”

The man on X is called Dave. He’s not a trained journalist, he’s just a bloke; an interested citizen who’s been following, analysing and reporting on the inquiry since it first opened in July 2023.

It was only when he contacted me in February this year that he – and the Scottish Covid-19 Inquiry – entered my sphere of vision. The video clip Dave sent me showed a woman making a statement on the imprisonment of the elderly in care homes in 2020, saying how this decision should have been challenged.

A second clip showed retired nurse of 41 years, Marion McPartland, declaring that care home residents were deprived of basic human rights, and telling her own story about the horrors her mother had endured in a care home during covid lockdowns.

One clip showed a concerned Lord Brailsford, who allegedly came out of retirement to work on the inquiry, asking: “Was it signed?” He’s referring to a DNR (do not resuscitate order). A woman called Gillian Duncan, the daughter of a locked down care home resident, replies: “It was in block capitals... my name... not my signature at all.”

I was amazed to see these videos of ordinary people making the most extraordinary statements on subjects with which I was all too familiar. They spoke openly of the alleged overdosing of loved ones

Sister turns to police for help

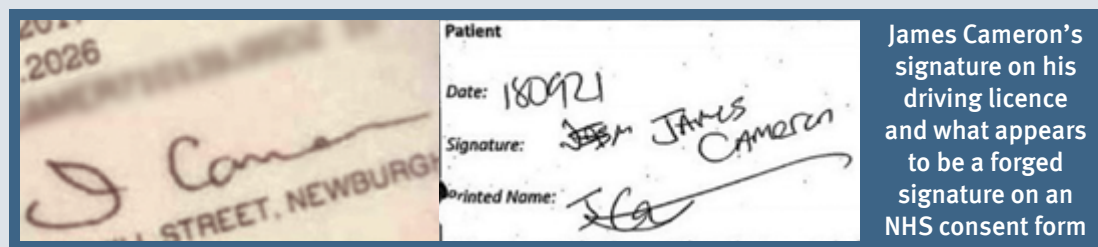
IN an inquiry video recorded on November 24, 2023, Pamela Cameron Thomas talks about the death of her brother, James Cameron, after he was admitted in hospital on September 17, 2021, with diarrhoea and dehydration. The family were not allowed to visit James in hospital.

Within days James was unable to communicate. She later discovered that antibiotics had been withheld and that James had been used as a ‘lab rat’, as he had been put on a randomised control trial to test new drugs to treat pneumonia. He never had pneumonia so this made no

sense. Pamela says he had not given his consent for this, as these photographs - of his real signature and that of another signature in his name that appears on an NHS consent form – appear to show.

On September 21, 2021, James was put on a ventilator unnecessarily and given three sedatives including Midazolam. He died as a result on October 5. He was 41.

Pamela says: “I’ve been fighting ever since to get answers as to what happened to my brother. I’ve had a meeting with the major crime team from Police Scotland. They asked me questions and I await a response.”

with midazolam and morphine – an issue I’ve been researching for four years.

They spoke of care home managers allegedly lying to families and GPs, of cruelty and neglect, of residents being denied hospital treatment, and instead, being put on ‘end of life’ protocols regardless of whether they were at the end of their lives.

At the inquiry, over a period of several weeks, these testimonies kept coming.

One witness believed her mother had been put on ‘palliative care medicine’ but she was told that only paracetamol had been given. She said to a social worker: “If you’ve given my mum palliative care medicine, I’m getting you charged with murder.” Her mother died shortly after.

Bill Jolly, the son of another alleged victim of midazolam and morphine, also spoke at the Scottish inquiry. He managed to get some publicity about his father William Jolly’s suspicious

and dreadful death in an interview with James Freeman on TNT Radio on January 16, 2024. Bill stated: “In my opinion, my father was euthanised.”

The covid inquiry in England, known as the UK covid inquiry – chaired by Baroness Heather Hallett – was launched in June 2022, but there was never a mention of what came to be known on social media as ‘the midazolam murders’.

That’s why it was so surprising that the Scottish covid inquiry didn’t hold back on this issue.

But no editor or journalist has wanted to get to the heart of it, nor report on the statements given by the relatives of alleged involuntary euthanasia victims.

Out of all the statements made during the inquiry, these were no doubt the most shocking, the most heartbreaking and the most horrifying.

But back to Dave, who has now had his X account suspended. On his Substack channel, he regularly updates his subscribers on the Scottish Covid-19 Inquiry, focusing mainly on all the stuff the English inquiry has, to date, failed to discuss. He says that his reports are ‘the culmination of months of independent citizen-led journalism. By and large, these testimonies have either been poorly covered by the mainstream media or ignored altogether... MSPs have also said absolutely nothing.’

What many of us want now is for the government to take a serious look at what was really causing the deaths of Britain’s most vulnerable during the pandemic. We want to hear real accounts of how lockdowns, isolation, medical neglect and malfeasance, starvation, dehydration,

forged signatures on DNRs and deprivation of human rights truly affected people, not just at home but in care homes, hospices and hospitals.

As Shelagh McCall KC stated: “Many families witnessed remotely a significant deterioration of their loved ones’ physical and mental health in lockdown that was nothing to do with covid-19. Some suspect that their loved ones were suffering from neglect, dehydration and starvation.” This amounts to, in the eyes of many, cold-blooded murder.

The Scottish Covid-19 Inquiry’s health and social care impact hearings have now concluded. Closing statements took place in June. You can view these statements exclusively on Dave’s Substack as there are no mainstream media reports. Dave has reached out to the Scottish media to cover this but has had no response.

The Scottish Covid-19 Inquiry website states it will start its hearings ‘investigating the impacts of the pandemic on education and certification on November 4, 2024, before moving onto the impact of the pandemic on the financial and welfare support given to businesses and individuals.’

While we should be thankful that the alleged midazolam murders got an airing during the Scottish inquiry, it is deeply disturbing that the failure of the media to report on this most important part of the inquiry means it may never be properly investigated.

Smartphones make us stupid

Technology stealing our precious time and talents

THE ubiquitous smartphone is possibly the most dangerous technology ever invented.

It has the potential to become the singular instrument of total control that will enslave us all. It is a piece of technology that masquerades as a tool to make our lives easier and simpler, but behind this facade of convenience the undercurrent is much more sinister: the aim is to make us totally dependent on this technology for our very existence.

Many people are aware of the dangers inherent in the smartphone, and they know full well that the globalist elite who seek to herd us into a transhuman slave state are dependent on technology to achieve their aims [thus discounting any notion that they are supernatural or in league with spiritual forces that still somehow need the internet. Ed.]

Many of us warn how social media and the use of smartphones are addictive. But what do we mean by addictive, and is it possible to become truly addicted to technology?

Prior to the 1950s it was thought that you could only become addicted to a substance, and addiction itself was thought of as a disease. Addicts therefore were seen as those hooked on heroin, alcohol, painkillers or other such forms of administered drug, whether legal or illegal.

An experiment conducted on rats in the 1950s by two scientists, Peter Milner and James Olds, found that behaviour of a certain type, which registered rewards in the brain, could surely prove just as addictive as any substance-based cause.

This discovery was made by accident when electrodes inserted in the rats' brains began to measure the effect on the 'pleasure centre' which would cause the rats to repeat the same behaviours repeatedly to gain the desired 'highs'. In fact, so acute was the rats' behaviour that they would carry on with the actions until they became exhausted.

This experiment caused quite a stir. If rats could become addicted to particular behaviours which gave them pleasure, could the same be said of humans? Initially behavioural addictions were doubted, but they are now recognised by the scientific community as being real.

It would appear that so long as an action is rewarding, pleasurable and serves to ease psychological discomfort, the brain responds to it in the same way as it would to a substance, and therefore the addiction mechanism is the same.

Addiction is not now classified as a disease, but is more thought of as a learning disorder, where an individual associates certain actions with pleasurable relief.

Overindulging in alcohol, injecting with narcotics or taking mood altering medication is similar to the hits one achieves when compulsively over-exercising, gambling, forever checking social media and constantly using a smartphone.

The evil few who are attempting to mould the world to their inhumane desires are certainly clever. If you want to get people to

do as you wish without too much coercion and resistance, then what better way to do it than to get as many people as possible addicted to pleasure, to the very means by which you can control every aspect of their lives?

This is why the most popular smartphone apps and social media sites are designed to trigger the pleasure centres of the brain. This is also why those who are at risk of underlying psychological issues are also at risk of developing full-blown addictions to these technologies.

Addiction to technology is a very real 'dumbing down' process. It undoubtedly deadens our brains. In the 1970s, a team of psychologists looked into whether or not it was the possession of inborn talents that manifested into excellence, or whether it was the application, over a long period, of determination and effort that improved performance in any given field.

The psychologist K. Anders Ericsson was satisfied that, in most cases, it was the latter. How is this relevant and what has it to do with smartphones? The answer

is simple: most people have a talent somewhere lurking inside them. As Ralph Waldo Emerson said, "every man I meet is my superior in some way, and in that, I learn from him."

The problem with modern day life is that most people are trapped on the treadmill of wage slavery and cannot pursue their talents, if indeed they have even identified them yet.

Of course, it is in the interests of governments to keep everyone on the treadmill. The last thing they want is a nation of self-motivated individuals pursuing their own agendas to excel at what they are good at, when they can be harnessed to the plough of the state and contribute to the enrichment of the few.

By what means does the state dumb down individuals to prevent them from becoming successful in their own right? Radio, TV, the press, formalised education, entertainment and technology, with the most efficient branch of that being the smartphone.

In the process, they are the supreme control mechanism for the rulers who sit back and laugh at how so many have willingly fallen into their trap.

In the wise words of Friedrich Nietzsche: 'In such a highly developed humanity as the present one, each man by nature has access to many talents. Everyone possesses inborn talent, but few possess the degree of acquired toughness, endurance and energy to actually become a talent; that is to say become what they are.'

Official 9/11 story fake but are we nearer truth?

THIS month sees the 23rd anniversary of history's biggest terrorist attack – the events of September 11, 2001.

Today, we know one thing for certain about 9/11: the official narrative cannot be true.

The collapse of the lesser-known third tower on 9/11, World Trade Centre Building 7 (WTC7), has been scrutinised by nearly 4,000 certified architects and engineers, and subject to an extensive forensic study by engineering experts at The University of Fairbanks, Alaska.

They all concluded that the official 'normal office fires' explanation for that building's demise is simply impossible. Even now, the U.S. authorities refuse to release their working data for the office fire hypothesis. It is because of simple, high-school physics that we know the official story of 9/11 is a lie.

In 2011, a British jury concluded there was reasonable cause to suspect the work of covert agents within British security services in bringing about the terror attacks of July 7, 2005 in London [See *The Light*, Issue 30 Page 4, 'British jury concluded taxes may have funded 7/7'].

I have at least three confirmations from law enforcement agencies that Anthony

John Hill's trial and verdict meets the legal criteria for reasonable cause to suspect 7/7 was a state-sponsored crime.

Imagine a shady looking character rattling a tin cup on the street corner. The home-made label wrapping the cup reads: 'Help Your Local Rapist'.

Rightly, you avoid the man and move swiftly on, only to be confronted by another beggar, this time holding out a tin can with a slot in the top. 'Help Fund Terrorism! Give Generously!' You turn the corner. Another creep sits with a blanket spread before him – his own change scattered across it suggesting a donation. A torn piece of cardboard is scribbled with charcoal: 'Help Me KILL You'. Dystopian or what?

Welcome to 2024 and the use of your taxes. It was, after all, your hard-earned wages which funded a royal prince who was never found guilty of abusing a trafficked and coerced American teenager. It was your money that, according to a British jury, could have paid for the explosives used to blow up the tube trains and bus on 7/7, plus the ongoing cover-up of 9/11.

And what about your money spent on the vaccine roll-out that we can now link to an inordinate rise in excess deaths both here and across the world; you'd have to be nuts to fund all that, right?

But we all did and still do. We are all guilty of breaking Section 15 of The UK's Terrorism Act 2000.

It's wording is clear: 'A person commits an offence if he invites or provides money or other property, and knows or has reasonable cause to suspect that it will or may be used for the purposes of terrorism.'

So what is 'reasonable cause to suspect' in law? In 2018 at the UK Supreme Court, this very question was answered thus: 'Those who had, objectively assessed, reasonable cause to suspect that the money might be put to terrorist use.'

'Those who had objectively assessed' seems to me the perfect description of a jury. While I no longer attempt to cite 9/11 in any litigation, I do cite the jury verdict at Regina V Hill, because the link between my council taxes and the events of 7/7 can be demonstrated. Because the Hill verdict gave us all reasonable cause to suspect the London bombings were an inside job and thus, a tax-funded operation.

It doesn't take much research to discover that council taxes make up a significant portion of HM Treasury's accounts each year [around five per cent] and that those monies are then distributed from the Consolidated Fund to the very same security services of which a jury of our peers deemed feasibly complicit in 7/7.

While 9/11 is legally trickier to incorporate into the offences proscribed by Section 15 of the Terrorism Act, it does serve as a useful illustration that successive British governments are quite content to do business with a country so obviously complicit in 9/11.

WTC7 could never have fallen due to 'normal office fires', so either our American allies are lying, or Isaac Newton is wrong about the laws of motion.

Sussex Police's Professional Standards Unit recently sent me an email that should concern you: 'Your allegations are of a nature that *no reasonable person could lend any credence* and issues or disputes

of any payment of council tax are not a police matter.'

Consider those words. It is the official position of Sussex Police that a British jury, multiple operatives at our Anti-Terror Hotline, plus serving and former police officers are all 'unreasonable'.

Worse, it is the official position of Sussex Police that the Terrorism Act 2000 does not apply if your reasonable cause to suspect points the finger at HM Government.

However, I also have another official statement. In 2012, I asked the Home Office if anybody, even Her Majesty's Revenues and Customs, enjoyed any exemption from our anti-terror laws.

Their response: they don't. Even HMRC are bound by Section 15 of the Terrorism Act, which means it applies to your local council too. That the magistrates courts, police and council staff all conveniently ignore that fact should make you realise just how corrupt and deranged everything really is.

After all, any one of us could have been on holiday in New York that dreadful day, and any one of us could have been riding the tube and buses in London.

If you wish to fund your own murder, I can only recommend a good psychiatrist. Your continued compliance with an establishment employing such dark and horrific double standards defies sanity.

It also sends that establishment a loud and encouraging message – you will tolerate anything. And that's what they count on.

Landmark ruling rejects mast bid

Health grounds among reasons given by planning officer

CAMPAIGNERS against the dangers of digital infrastructure springing up everywhere claim to have secured a major victory.

In the town of Stroud, Gloucestershire, an application to increase the capacity of a phone mast, already blighting an iconic art deco building at the top of the high street, was put forward by a telecoms company.

And it was refused, at least partially, on grounds that reference health.

What marks this as a first is the fact that the planning officer – following numerous objections received, including three from people with specific susceptibilities to electromagnetic frequencies – approached the applicant for confirmation of power output and exclusion zones of the proposed mast.

Having been unable to obtain such information from the telecoms company, the application was rejected.

The decision notice is available on the Stroud planning portal under S.24/1123/FUL.

Campaigners claim that rarely - if ever - has a demand for basic data such as this been put to an applicant by a case officer.

Ultimately, the planning officer stopped short of citing health as the overarching issue – with ‘heritage harm’ being the headline rationale.

A campaigner on the Stroud case, Sophie Gale, said: “In a world where due diligence from local planning authorities on matters of phone mast radiation is a rare to non-existent occurrence, this case sets an invaluable precedent.

“The mind-boggling reality is that a culture has evolved in which telecoms companies can self-certify compliance with radiation levels set by guidelines known as ICNIRP (International Commission on Non-Ionising Radiation Protection).

“They do not even need to show workings. Simply writing

a one-sentence ‘declaration of conformity’ – which no one checks – ticks the box.

“People are visibly shocked when you explain this. It is not in my comfort zone to go round knocking on doors asking if someone has a metal implant. But often people are grateful.”

Gale has had the support of Steven Thomas, a resident of nearby Cheltenham and himself someone with a metal implant, who earlier this year brought a judicial review of a mast sited close to a retirement home.

She said part of the judgement in this case states that councils are failing to protect those with metal in their bodies who are affected by EMFs below ICNIRP levels.

Gale added: “When local authorities wave through ICNIRP certificates, they are not following due process. It is impossible to know how many phone masts, up and down the country, have valid certificates.”

But the story does not stop there. As uncovered by activist Ian Jarvis and his team, hundreds of allegedly fraudulent certificates have been issued under the company name Three UK Limited, which was dissolved in 2015.

Are telecoms companies deliberately registering under a fictional name because they know radiation levels go well beyond those licensed by ICNIRP and want to sidestep liability? More broadly, the inherent problem in planning departments is that the correct hierarchy of law has been turned on its head, with humble guidelines placed over and above the legislation that is meant to dominate.

But there are signs the culture is changing. Over time, the cumulative efforts of campaigners bear fruit.

Clean energy a dirty business

Slave labour used to mine rare minerals for EV batteries

UNLESS you've been living under a rock, you are probably aware of the massive push to transition to so-called green energy.

The goal is to have wind and solar replace coal and natural gas, and the electric vehicle (EV) will supposedly replace internal combustion engines.

International directives are endorsed by the highest office in the land; the current administration has made green energy a large part of its agenda.

We are being told that these technologies are clean and will save the Earth from climate change. However, these alternative forms of energy being espoused are riddled with their own problems.

Hidden behind the solar panels, wind turbines, and EV batteries are dirty secrets that get swept under the rug and conveniently ignored by climate enthusiasts.

Natural fuels like oil and gas are constantly put under a microscope and condemned as evil, destructive pollutants, while green energy is put on a shiny pedestal. Green energy, however, is not as perfect as we are made to believe, and we are putting a lot of trust into these energy sources without considering their ramifications.

The American Consumer Institute recently released a report detailing many of the environmental impacts associated with the so-called green, renewable technologies being heavily promoted.

The entire life-cycle of all three – the wind turbine, solar panel, and EV battery – involve significant environmental damage that should not be overlooked, and need to be part of the discussion when implementing energy policies.

One of the biggest issues is the extraction and manufacturing processes of various critical minerals that are required for wind turbines, solar panels, and EV batteries.

Many under-developed nations, where there's an abundance of minerals, are at risk. The operations and procedures not only overtake land, but contaminate surrounding soil and water sources. In the worst cases, this work is accomplished through slave labour.

Various toxins and other chemicals are released into the atmosphere, where workers and even nearby communities are potentially affected. Landscapes are ruined, and various animal habitats are shrinking and/or experiencing stress. The massive amount of land occupied by both wind and solar may never be recoverable.

China dominates the green energy supply chains, but their environmental standards are subpar. CO₂ emissions associated with refineries in China are 1.5 times greater than those in the EU or U.S.

'Renewables' are also creating a huge waste problem. Since any kind of recycling is very limited on a large scale, more than 90 per cent of wind turbine blades, solar panels, and EV batteries end up in landfills.

By 2050, it is predicted that used turbine blades will exceed 43 million tons of waste worldwide. Solar waste is predicted to be close to 80 million tons. And with the U.S. projecting 33 million EVs on the road by 2030, that is a lot of batteries to end up in landfills.

Ironically, the same folks who want to charge customers for every plastic bag they use at the grocery store, out of fear of single-use plastics ending up in landfills, don't seem to have a problem with potentially toxic machinery filling that space instead.

Some of the environmental impacts and hazards posed by green energy are far more detrimental than fossil fuels, and yet the latter is often dismissed. Such risks associated with green technologies should actually be an argument against vigorous pursuit of them.

Each energy source, including natural fuels, should be considered as part of an all-of-the-above strategy for supplying the necessary energy to power homes,

businesses, and the economy at large.

All of them come with some degree of environmental concern, and each should be weighed and measured – along with costs, logistics, reliability, and geopolitical factors – when developing public policy. Instead of completely trying to phase out natural fuels, a robust and healthy energy mix ought to be established. We need a balanced approach that does not breed additional problems.

It is past time to come clean on so-called clean energy. The real-life consequences and detrimental effects of it demand more honest conversations and a thoughtful course of action.

Metrology a battlefield in war on woke

THE extreme far-left takes a dim view of traditional British measures (miles, acres, pounds weight) and a dim view too of traditional British people.

Self-styled ‘progressives’ are invariably ignorant of the former and seek to minimise the latter. Those who would combat the woke ruination of Britain should consider getting their heads round metrology, the science of weights and measures. The imperial system of customary units is not a medieval hotchpotch. It is a signal from the ancients.

These thoughts occurred to me when I contributed an item to the letters page of *Physics World* (PW), the monthly membership magazine of the Institute of Physics (IOP). My letter pointed out, among other things, that due to a surveying foul-up at its inception, the metric system’s metre is not geodetic, bearing no relation to the dimensions of the Earth, while the good old statute foot is geodetic. In the words of actor Michael Caine, ‘not a lot of people know that.’

Imagine my surprise when no readers’ letters appeared in the next issue of the journal or issues after that. I emailed PW’s editor and he told me that the correspondence page would henceforth only appear occasionally.

A recent issue does in fact have a correspondence page – one page, down from the previous two. Here are the names in short of all the letter writers in the March 2024 issue: John B, Jim G, Alan C, Matthew J & Colin W. You get the picture. PW has entered into a pact with other science journals that 40% of editorial material will be provided henceforth by women, which accounts incidentally for the preference for boosterish book reviews by women of books written by women. Is it a coincidence that a page provided by what sound like white males has been curtailed drastically?

A decline in heavyweight science articles is especially painful to this formerly loyal reader. The physics content of PW has slumped in favour of material on equality, diversity and inclusion: ‘Supporting black physics students’ (with a picture of a person of colour, inevitably female) and ‘Embracing neurodiversity in neutron science’ from the March 2024 issue sum up the situation.



Out with the new and in with the old?

The IOP’s own membership surveys every few years still report that nearly 90% of respondents are white, mostly men. Less than 1% of university physicists are Black (PW, June 2024). Yet the white male element in the membership of the ‘Institute of Political Correctness’ is being invited to make itself scarce uncomplainingly. A recent campaign was ‘Bin the boffin’. White male physicists, please climb into your nearest wheelie bin. My favourite article in the March 2024 of PW, describing a viscosity experiment, has this title: ‘Drop Tower Kilometrestone’. No, only kidding. The real title is ‘Drop Tower Milestone’. Customary measurements are handy in that way: mileage, footage, inch perfect. PW routinely ‘kilometricates’ UK and U.S. geography and history, which is as good a way as any of injecting clunk into your

writing. ‘Five miles’ vs ‘eight kilometres’: no contest. The (geodetic) imperial system of customary measures can coexist amicably with the (non-geodetic) metric system, and PW can stop falling over backwards into unmeritocracy and prejudice to redress yesteryear’s inequalities. In the meantime, PW provides a case study in wokification: metric monoculturalism; minimisation of white males; feedback aversion.

Go woke, go broke? No chance. IOP accreditation is essential for many working physicists. They have a captive audience. The members can always write in, of course, though with a diminished expectation of publication. PW has politically corrected itself down from a ‘must read’ to ‘narrowly worth skimming’. To see an old friend embrace cognitive decline is distressing.

One fears for the tenure of the white male editor of Physics Woke. Mind you, the president of the IOP is also a white male. He’s dedicated, he says, to diversity and inclusion. A new award was announced in the June 2024 issue of PW: the Physics Inclusion Award. Away from science, I chided a historical conservation society for their use of kilometres and hectares, which they do in the manner of the nauseatingly woke National Trust and English Heritage. The published response cited pounds, shillings and pence and even rods, roods, perches, chains and furlongs. The kicker was this: ‘Nostalgia is a good thing, but we must move with the times if we are to relate to a modern world,’ ‘M.R.’, the *Gower Society Newsletter*, Spring 2023.

No, the metrication of Britain’s history and geography is not moving with the times; it is an alienating betrayal of Britain’s heritage, a blotting out indeed of a signal from the deep past. The imperial system is not arbitrary, weird and retrograde. Wokery’s implicit espousal of mono-metrication is vandalistic. I quit a different local history society when it gave distances between milestones (sic) in kilometres. I voted with my feet – and inches and miles!

The purpose of my so far unpublished letter to *Physics World* was to act as a primer for the anti-woke. It makes the case for tolerant metrology. It was inspired by an article entitled ‘Let’s stick with metric’, PW, July 2023.

Sir,
A rural Scotsman complained recently that he would be expected to greet an inrush of rich American tourists by tugging his furlong (read ‘forelock’). So there is life in the old imperial system yet (a furlong being an eighth of a horseracing mile). Thomas Jefferson, who became the third president of the U.S., noticed that a cubic foot of rainwater weighed 1,000 ounces. He studied all known British measures and concluded in 1790 that the apparently arbitrary units ‘must have been the result of design and scientific

calculation, and not a mere coincidence of hazard... from very high antiquity.’ Britain’s megalithic monuments are laid out according to the megalithic yard (2.7 feet/0.83 metres), which is said to relate to the polar circumference of the Earth and thus be geodetic (i.e. refer to a physical dimension of the Earth). The metric system was meant to be geodetic, but due to an error in the original surveying, it isn’t. The imperial system embodies knowledge in a way that the metric system doesn’t. The megalithic people divided up the horizon into 366 degrees of arc. They then divided each degree into 60 minutes of arc and each minute into six seconds of arc. The Earth turns on its axis one megalithic second of arc in one modern second of time. Each megalithic second of arc measured exactly 366 megalithic yards on the ground, which equals 1,000 statute feet. This means that the foot is not merely the size of some yokel’s size

10 clodhopper, but a geodetic unit. A cube with sides of one-tenth of a megalithic yard holds an imperial pint of water and one imperial pound (lb) of barley or wheat grain. Doubling the length of the side produces a capacity of one imperial gallon, and doubling again produces a grain weight of one dry bushel. The megalithic pound had a value of 99.96% of the lb (e.g. of sugar), which latter can thus also be regarded as a geodetic unit. Light travels one foot in one nanosecond. Inserting 1 for the velocity of light, c, in $E = mc^2$, yields energy-mass equivalence. The metric system has multiscale utility, albeit without geodetic content and a clunky mouthful of syllables (kilometres, kilograms etc), and as scientists we must continue to use it; but it is the imperial system that has true class and geodetic pedigree. Yours, etc.

More atmospheric carbon dioxide

Unlike today, atmospheric carbon dioxide was a real threat seventy-five years ago

DURING the 1950s, many tests of bombs were carried out in the atmosphere. Britain tested a few, but the USA and the Soviet Union vied with one another, testing more and more powerful devices.

These tests created a great deal of concern about health risks from radioactive materials that were being released into the atmosphere. It turned out that most of these materials had short half-lives, meaning that they lost their radioactivity very quickly and would therefore be of minimal danger to health.

However, there were two whose half-lives were significantly longer. One of these, strontium-90, which has a half-life of 28.8 years, settled down to the ground and was detected in milk.

Health authorities were worried that it would be incorporated into the hard bones of children, who would then be carrying radioactive material in their bodies for the rest of their lives. Programmes were put in place to minimise risks from contaminated milk, and eventually, nuclear powers

agreed to stop atmospheric tests and signed the Atmospheric Test Ban Treaty on August 5, 1963.

Of more serious concern was that the tests also created carbon-14. This is a radioactive isotope of carbon that is highly reactive and so quickly combines with oxygen to form C(14)O (radioactive carbon monoxide). C(14)O then combines with oxygen to form C(14)O₂ (radioactive carbon dioxide). Since carbon-14 has a half-life of 5730

years, a major concern was that people and their descendants would be breathing radioactive carbon dioxide for the rest of their lives.

In addition, they would be eating food derived from plants that had incorporated C(14) into their leaves, stems, roots, flowers and seeds.

Luckily, however, nature came to the rescue in the form of the annual CO₂ Exchange. As discussed in the article entitled 'Atmospheric Carbon Dioxide' (*The Light*, Issue 46), every year, one-fifth of the carbon dioxide in the atmosphere is exchanged with the oceans, vegetation and other sinks. This process means that atmospheric CO₂ is quickly diluted with that from the oceans and from the decay of vegetation.

We were therefore very fortunate that the annual exchange of CO₂ between the atmosphere and the oceans removed dangerous long-lived radioactive carbon dioxide from the air people were breathing. Today, most man-made C(14)O₂ will have disappeared from the atmosphere.

The danger from the release of radioactive carbon dioxide into the atmosphere was real. If it had accumulated there, instead of being diluted in the exchange, everyone would have been breathing it and eating food containing it, leading to many serious health problems including cancer. The

authorities were right to be concerned as there would have been nothing they could have done about it.

In the case of CO₂ created from burning hydrocarbons, the Intergovernmental Panel on Climate Change has failed to take account of the exchange while it promotes the false anthropogenic global warming narrative based on man-made CO₂ accumulating in the atmosphere.

But man-made CO₂ does not accumulate in the atmosphere, because the exchange continually dilutes it. Moreover, the total amount of CO₂ in the atmosphere is controlled naturally.

There is nothing we can do about it and there is no need for any concern. Consequently, all the schemes that have been implemented at vast cost to taxpayers in attempts to limit the amount of carbon dioxide in the atmosphere are futile and a catastrophic waste of manpower and resources.

We find, therefore, that a natural event, the exchange, that was unknown at the time, removed C(14)O₂, a dangerous component of the atmosphere, to save us from harm. On the other hand, more recently the exchange, which has now been well documented, has been ignored as part of a dark agenda of perverted science to goad people into accepting the diktats of dubious unelected individuals.

Beyond the victimhood archetype

Psychological theory takes back ownership of our own lives

OVER 30 years ago, psychotherapist Jill Hall wrote one of the most important books regarding human consciousness – *The Reluctant Adult: An Exploration of Choice*.

The book (hereafter ‘TRA’) pinpoints a core characteristic of the human psyche at our current juncture, that we are very ‘reluctant’ to look at, or even acknowledge: viz. our individual and cultural addiction to victimhood.

I endorsed the first 1993 edition of TRA, thus: ‘Jill Hall’s central theory not only accounts for, and draws together all the most important issues facing humanity at this time, but also affords a possible way forward towards their solution’.

Other endorsers wrote of ‘the spiritual aspect of holism [being] expressed with such vision and authority’ (Sir George Trevelyan) and therapist Robin Shohet describing how TRA ‘changed his way of thinking about the world’.

Hall’s core thesis is that, to quote her directly: ‘Victimhood is our basic mode of human relating.’ That’s a huge claim, and the book compellingly substantiates it.

She argued we needed (simplistic) cause-and-effect thinking, especially in relation to the material world, to reach our current ego-centred stage of human consciousness.

But the core metaphysical belief that the victimhood mentality assumes is that we inhabit a deterministic universe in which human beings are caused (e.g. by external events, or by our genes) and that we are therefore the victims of whatever those causes might be.

But we make a fundamental error in assuming that such causal thinking is also appropriate for understanding the spirit-infused human psyche and the human soul. As soon as we realise this, we see how causal thinking distorts and does a major violence to how we understand and experience our humanity.

Once conscious of it, we see victimhood everywhere – not least in our language that unwittingly expresses it, as well as in the realms of politics and culture, and in our own behaviour and belief systems.

As soon as we hear the phrase ‘made me feel’, for example, the Victimhood Archetype is at work. Or when we read in the recent official covid-19 inquiry report that ‘the primary duty of the state is to protect its citizens from harm’, we see the state making us into victims for whom they then posit themselves as the rescuer.

For victims actively call forth rescuers and persecutors – and so we see the well-known Karpman ‘drama triangle’ of victim-persecutor-rescuer – a dynamic that unconsciously underpins and drives so much human relating. The recent covid madness was a classic example of this toxic dynamic playing out, with those caught up in it (sadly, the great



Some key quotations from *The Reluctant Adult: An Exploration of Choice*:

- Deep-seated attitudes of victimhood and blame underlie our civilisation. Material existence is far too intricate and subtle a phenomenon to be understood through a cause/effect mode of thought.
- The notion of cause and effect is so built into the very structure of our thought that we seldom question it. We barely recognise it as an assumption. The time has come to go beyond causal thinking. When we come to try and understand the psyche, causal thinking is not only inadequate but is even positively dangerous.
- We are so deeply and unconsciously influenced by the structure of our language... assuming that rational thought mirrors reality. Language prescribes for us a
- linear ordering of data suited to cause/effect thinking, and thus suited to ‘victim’ thinking. Our language thus serves the Victim Archetype.
- We are always looking for a cause to hold responsible for our difficulties, becoming as we do so an effect – a victim. The Victim Archetype is so embedded in our way of being that we are not really aware of it. Experiencing ourselves as victims simply feels like the way life is.
- Causal thinking, when we come to explain ourselves, is so easily translated into impotence and blame. We diminish our humanity once we view ourselves as an effect. Causal thinking leads straight to victimhood.

majority) becoming ‘victims’ of the ‘persecutory’ virus, from which only the covid jab (we were told) could be our ‘rescuer’.

This toxic drama triangle was at the core of the covid outrage in which the key actors unconsciously participated, quite literally, in a psycho-drama.

So victimhood (and, therefore, a blaming worldview) are a direct consequence of thinking about ourselves as effects. For as soon as we are a mere effect, it follows logically that there must be an (external) cause that led to the effect that we are; and from there, seeking something, or someone, to blame for something we find unpleasant or uncomfortable is pretty much inevitable.

The whole of modern psychology, with Freudian psychoanalysis at the centre, acts out this simplistic deterministic worldview.

A few renegade psychologists have managed to throw off the chains of victimhood thinking.

Jungian James Hillman shows in his 1997 book *The Soul’s Code* how well-known people who achieved great things in their lives had childhoods that couldn’t have been more obstructive to the adult accomplishments that they nevertheless went on to achieve.

With his ‘acorn theory’, Hillman shows how every human being is born with a ‘daimon’ (a guiding spirit), with each human life formed by a particular image that is the essence of that life and which calls it to a destiny.

Hall resoundingly concludes TRA thus: ‘New modes of human relating, with radically different social and political arrangements, will begin to emerge as victimhood ceases to be’. And it is replaced by what she calls an archetype of self-generation.

For truthers and lovers of freedom, TRA could not be more relevant. For it is only when we individually transcend the dynamics of the Victimhood Archetype, and the hold it has on us, that we can be truly free.

Awareness versus intelligence

THE events of the last four years have thrown into sharp focus the question of what constitutes intelligence.

We have realised with startling clarity that academic credentials are no guarantee of competence or integrity, that we cannot define where awareness will be present, or to what extent, and where it will be entirely absent.

Is awareness perhaps the real mark of what we call intelligence? Awareness encompasses not only a keen perception of the subtle shades and textures of what surrounds us, but provides us with access – through our ‘inner eye’ – to infinite information beyond that which we can see or hear. As a consequence, it tends to lead to a corresponding response in integrity.

Is technology, therefore, with its extreme narrowing of our attention, an enemy of functioning intelligence?

The New Zealander geneticist Guy Hatchard writes that psychologists struggle to define intelligence. Attempts at definition have included memory, fluid intelligence, field independence, creativity, spatial awareness, logical reasoning, analysis, pattern recognition, problem solving, musical ability, mind-body coordination, emotional capacity, linguistic ability, naturalistic insight, etc. And Hatchard asks if these are linked by a common thread.

He suggests that all these abilities are functions of intelligence, that they are manifestations of how well intelligence operates through sensory information and activity, how it discriminates and selects an action. But that this relies on a stable mind that is integrated with higher consciousness.

In other words, the structures of the brain with their computing functions and memory capabilities, which store the wealth of thoughts and experiences we accumulate, are part of the physiological structures which support intelligence, and through which we express it as coherent sense.

But intelligence itself is an infinite source of knowledge to which we are all connected, and draw upon to express ourselves in our uniquely individual way.

Universal intelligence is inherent in the perfect balance of nature and in the extraordinary design of the human body with its infinite capacity for regeneration.

As Hatchard explains: ‘Human life begins with a single cell which multiplies into 37 trillion cells. Each cell contains identical genetic material unique to

that individual. Each cell retains and defends its genetic identity, carrying out approximately 70,000 repairs every 24 hours.’

Imagination has to be the crowning quality which endorses both our individual uniqueness, as well as our connection to universal intelligence or consciousness.

Imagination hungers to express itself through speech, writing, painting, sculpture, architecture, musical composition and interpretation, all technical skills which require application, discipline and commitment, but which without imagination is meaningless. As Oscar Wilde said: ‘Nothing that is worth knowing can be taught.’

From where did Mozart pluck his sonatas, symphonies and operas? From where does J.K. Rowling produce the Harry Potter novels? What differentiated the voice of Luciano Pavarotti from that of any other well-trained tenor? When Pavarotti’s voice hit the high ‘C’ note, it produced a vibration in the ears of listeners capable of making them feel the universe had momentarily opened up. Some say it was the generous heart of the man, the childlike innocence of his spirit, a window to the divine.

The arrogance implicit in the term ‘gene-editing’ is best summed up by the expression, ‘fools rush in where angels

fear to tread.’

Hatchard points out that such is the sanctity of our unique personal genetics, the immune system makes genetic repair an absolute priority.

Yet, he informs us: ‘The biotechnology industry has grown since the structure of DNA was unravelled in 1953. Very few biotechnology applications work very well. Most fail completely, and have done so for the last 50 years. But biotechnology PR has become a runaway train that is out of touch with reality.’

There is now no shortage of evidence that mRNA gene-editing ‘vaccines’ can cause damage to every system in the body, including cognitive impairment and Alzheimer’s disease (see South Korean study of 558,000 residents of Seoul). Hatchard claims that the expression of intelligence relies not only on the coordination between cells, but on their genetic uniformity, thus, when mRNA ‘vaccines’ alter the genetic function of billions of cells, intelligence is affected.

As genetic engineering is being extended to every area of life, from altering human characteristics pre-conception to our food supply, he alerts us to this: ‘Natural foods based on DNA are an essential part of nutrition. The genetic intelligence in these foods supports immunity, protects against diseases like cancers,

neurological and inflammatory illness, and promotes growth. The proliferation of genetically altered foods and synthesised ingredients has introduced unquantifiable risks into our food sources.’

Hence, he invites us to sign up to the International Genetics Charter which sets out our individual and collective genetic rights, including:

- The right to full disclosure of substituted ingredients in foods that have been modified or copied by biotechnological processes.
- The right to refuse any intervention that may alter our genetic functions.
- The right not to be subjected to misleading propaganda, vaccine mandates, and other invasive interferences.

Compact magazine banned in Germany

COMPACT magazine, which is well-known in Germany and Austria and has a YouTube channel with 342,000 subscribers, was banned by the German Minister of the Interior on July 16.

During five house searches and confiscations, not only technical equipment but also private property such as a de-registered old Jaguar car, a coin collection and 10,000 euros in cash were confiscated.

The ban was overturned last month by a German court that accused the government of being disproportionate with its censorship bid.

Jurgen Elsasser, Compact's founder and editor-in-chief, said the ruling was a "victory of David over Goliath".

The justification to shut down the magazine was absurd: 'right-wing extremist, inhuman agitation'.

As a reader of the magazine and regular viewer of the evening TV programme on YouTube, I can say that Compact has never called for, condoned or used violence.

Instead, the aim was to restore the legal



German court rejects censorship

- On August 14, the Federal Administrative Court temporarily lifted the ban on the magazine, Compact. The court ruled that the immediate prohibition was an excessive infringement on press freedom. The decision regarding the main case is still pending.
- The court emphasised that the magazine's right to publish should not be completely revoked without thorough examination.
- The court indicated that less severe measures could have been applied instead of an outright ban.

system, and the free and democratic basic order that has been abolished by governments. And by legal means to inform the people about government lies and nonsense.

The ban by the Ministry of the Interior was based on a legal trick: the magazine's two limited liability companies were interpreted as an association, and banned under German association law. Even according to several mainstream lawyers, this approach is unlawful.

Before the ban was overturned, the editor-in-chief and all of his (up to) 20 employees were effectively banned from working in Germany.

Other publishers were found who published the August issue of Compact under a different name, NÄNCY, named after the Minister of the Interior, NÄNCY Faeser.

MEP calls for Von der Leyen to be jailed

AN MEP has told European Commission President, Ursula Von der Leyen, that she should be imprisoned.

Polish MEP Ewa Zajackowska-Hernik gave reasons that Von der Leyen is destroying the European economy and leaving Europe unsafe due to a migration pact.

She made her shocking call in July during a meeting focused on the EU Commission presidential election, after which Von der Leyen was re-elected.

Addressing Von der Leyen, the Polish MEP stated: "Madam President. Esteemed Members of the European Parliament. Mrs Ursula, it is high time that someone told you directly what the vast majority of Europeans think about you.

"Choosing you as the President of the European Commission in the previous term was a huge mistake and some people are still suffering from this decision.

"You are the face of the European Green Deal, which is destroying the European economy and agriculture, which is leading to Europe becoming an economic open-air museum."

Zajackowska-Hernik slammed her draconian climate change policies and

dangerous migration pact by saying: "You are the face of all the EU climate madness that is leading to us Europeans becoming increasingly poorer.

"Finally, you are the face of the migration pact and I address you as a woman to a woman, as a mother to a mother: how are you not ashamed to promote something like the migration pact that is leading to millions of women and children in Europe feeling threatened on the streets of their own cities?

"You are responsible for every rape, for every assault, for every tragedy caused by the influx of illegal immigrants. Because you are the one who invites these people here, to Europe."

The straight-talking Pole, branded the 'queen of Europe's right' finished by saying: "And for what you are doing, you should go to prison, not to the European Commission. Your presence as head of the European

Commission is the downfall, the further downfall of the European Union.

"And do you know what we think about your European Green Deal? Oh, that! Do you know what we think about the immigration pact? Oh, that! You don't even look in my direction. Shame. We want a Europe of free and sovereign nations, not a sick leftist ideology. And hands off Poland. And you should bow to all the soldiers who are currently defending the eastern border of the European Union."

Von der Leyen was re-elected as European Commission President for a second term in a controversial vote in Strasbourg, France. Her five-year term was cemented with 401 votes supporting her, with 284 against in the 720-member strong chamber.

The former German defence minister has promised flagship projects in air and cyber defence and has prioritised the green agenda for her next term.

Devoted supporter of the corrupt Zelenskyy regime in Ukraine, Von der Leyen has also made available \$121bn to Ukraine with a further \$54bn promised until 2027 to support Ukraine's recovery, despite a fragile economic climate across EU member states. She has also promised to push the 'Green Deal' over the line, including an EU target to reduce 90 per cent emissions by 2040,

further adding to the demise of farming.

Addressing a World Economic Forum (WEF) meeting in Davos, Switzerland in January, Von der Leyen stated that "disinformation and misinformation" is the EU's "top concern", adding that "polarisation" was a risk to the "globalist business community".

During the covid scam, globalist Von der Leyen exchanged numerous texts and phone calls in secret with Pfizer chief, Albert Bourla regarding the procurement of over one billion jabs. Dubbed 'Pfizergate', the secret contact between the EU commissioner and the Pfizer head resulted in excessive orders of the lethal mRNA jab, costing the EU (taxpayers) billions of euros. A Belgium lobbyist, Frederic Baldan, filed a criminal complaint citing corruption and the deletion of documents and messages.

In a press release, the General Court of the European Union ruled that the EU Commission, under the leadership of Von der Leyen, violated laws regarding the purchase of experimental jabs from Pfizer. The EU court stated that Von der Leyen "did not give the public sufficiently wide access to the purchase agreements for covid-19 vaccines".

Medical interventions were ‘assault’

Disturbing report exposes government role in excess deaths

THE UK covid-19 investigation, known as the Hallett Inquiry, has spent tens of millions to deliver a propaganda message that Britain needs to be better prepared for ‘the next pandemic’.

Meanwhile, Canadian non-profit Correlation Research in the Public Interest and the University of Quebec have released the results of a proper inquiry into excess mortality in 125 countries between March 2020 and May 2023.

The study was carried out by a large team of scientific researchers and statisticians led by Dr Denis Rancourt PhD.

They concluded that, based on their analyses and interpretations, the measures that governments applied to combat covid-19 amounted to forms of assault, all of which contributed to excess mortality.

The authors said: ‘We are compelled to state that the public health establishment and its agents fundamentally caused all the excess mortality in the covid period.’

The study found:

- Nothing special would have occurred in terms of mortality had a pandemic not been declared and had the declaration not been acted upon.
- The major causes of excess deaths worldwide stemmed from public health establishments’ response, including lockdowns that caused severe stress, harmful medical intervention – including denial of treatment – and the covid-19 vaccines.
- Excess mortality surged almost simultaneously across several continents when a pandemic was declared, while there were no comparable surges in areas that had not yet declared a pandemic.
- The high variability in death

rates within countries over time would not be an expected outcome if those deaths were caused by a pathogen.

- The theory that a virus caused the deaths is propped up by mass virus-testing campaigns that should be abandoned.

Rancourt said the authors of the study found “*the idea that the vaccine saved lives ridiculous*”, and based on flawed modelling. And the study found:

- Thirty per cent of the countries they analysed had no excess deaths until either the vaccine rollouts or the booster campaigns. And there were significant

correlations between the rollouts and peaks in excess all-cause mortality.

- Ninety-seven per cent of countries showed a late-2021 or early-2022 peak in excess all-cause mortality temporally associated with booster rollouts.

It is highly unlikely, the researchers wrote, that the vaccine-mortality associations are coincidental.

Rancourt told *The Defender* news site that if you structurally change society by preventing people from moving, breathing, working, leading their lives and locking them down at home, you induce huge biological stress, and there is very

compelling scientific evidence that biological stress is a massive killer.

He further pointed out that the stress of lockdowns affected poor people quite differently from people who could easily work from home, have food delivered and live relatively comfortably.

Researchers found significant variability in mortality rates across different political jurisdictions directly adjacent to one another, which again would not be the case if a pathogen had caused these deaths.

Last year, a citizen-led, citizen-funded inquiry into Canada’s covid-19 response, called the National Citizens’ Inquiry, held

hearings across Canada in Vancouver, Ottawa and Quebec City, at which scientific, medical and legal experts testified under oath, along with journalists and Canadian citizens who had pertinent testimony to offer.

By definition it was deemed that the inquiry could not be commissioned or conducted impartially by the government, whose responses and actions were the subject of the investigation.

Rancourt testified at that inquiry that he and a team of researchers had conducted a number of studies on all-cause mortality, analysing data from North America and, where available, from other Western nations, resulting in more than 30 scientific reports. He explained that his focus on all-cause mortality data was because it contains no bias. It is a simple counting of deaths per age group, by sex, geographical location, and as a function of time. In a testimony under oath lasting almost 100 minutes, he told the hearing: “Virologists have been exploiting us and screaming fire where there was none.”

These recently released results are from the expanded study of 125 countries, and confirm the previous research on a smaller sample of countries.

As the UK government appears to be talking up and gearing up for a repeat of the covid fraud at some point, the burning question is what percentage of the populace will fall for it again? One would expect far fewer than the first time around, and hopefully a critical mass will ridicule their unimaginative attempts at more of the same.

Fuellmich facing ‘rough justice’

Supporters of lawyer fuming over ‘show trial’ in Germany

REPORTS from Germany are suggesting that the trial of Reiner Fuellmich is becoming a farce.

Fuellmich – a renowned corporate lawyer who sought to expose the deep state’s alleged involvement in covid-19 through his Corona Investigative Committee – is facing fraud charges.

It is understood his defence team have been banned from giving oral evidence in the trial in relation to alleged embezzlement of committee funds. It is claimed that this ban violates the law of orality in German courts.

Reports from the trial also suggest his lawyers are not being given details of new charges being brought against him.

Fuellmich, who has been in custody for nine months after being extradited from Mexico, is understood to have claimed the charges are politically motivated.

A member of the Society of Doctors and Scientists for Health, Freedom and Democracy attended day 24 of the trial on August 14.

They said afterwards in a report that has been translated from German into English: “Reiner and the lawyers have to hand over documents, or send emails. Nothing is read aloud.

“The judge doesn’t even know why Reiner is in prison, or so it seems. He gave no answer to Reiner’s lawyers as to what he is actually being charged with.

“All of the accusations so far have turned into thin air, and have been refuted. The judge took refuge in his little chamber and stopped the hearing after being pressed for answers. He refused to give an answer.”

It is understood Fuellmich’s lawyers have been able to demonstrate that the amount paid to him for legal work done for the Corona Investigative Committee had been invested in a property and that this was done to mitigate the risk of those funds

being confiscated.

Allegations have also included that he overcharged for the legal work he provided.

After claims against him were refuted in court, it was reported that the prosecution focused on services the accused had ordered on behalf of the Corona Investigative Committee which had been financed from donations.

However, as this was recognised as normal business practice, the focus was on the question of whether the prices paid were excessive or were ‘sham contracts’.

It is understood much of the remaining trial will be taken up by these allegations.

Fuellmich’s supporters have claimed the allegations in no way justified the international arrest warrant, his ongoing detention, or the humiliating treatment he has received.

It is claimed that the role of German secret services was revealed to one of the defence lawyers in April this year in a leaked paper.

The leaked paper, it is alleged, recommended finding ways to prosecute Fuellmich because his popularity and involvement in a newly founded party could cause unforeseen political problems.

A Fuellmich supporter who has attended the trial claimed: “They have run out of charges that credibly justify a trial, let alone pre-trial detention.

“There has been no embezzlement or breach of trust; missing funds had not disappeared.”

After the judge abruptly ended day 24 of the trial, it was reported that Fuellmich stood up and held his hands out to his guard – to shake hands and to be handcuffed again – before leaving court.

It was also reported that those in the public gallery at Gottingen Regional Court then stood up and applause broke out.

A supporter who attended the hearing said: “It was a standing ovation for a man who, after being kidnapped from Mexico, has now been in prison for nine months.

“After working through and refuting a trumped-up charge, he only wants to know of what he is still accused – a question that his judge cannot answer.”

They claimed that this was a violation of Article 6 of the Convention on Human Rights which states: “Everyone charged with a criminal offence must be informed as soon as possible of the charge and be able to prepare his defence.”

As a mobile hairdresser, I was working with a lot of elderly people, some of whom were in care rest homes, and I was required to take the jab to continue my work with them. A lot of the care assistants left, as they had more sense.

I got in and just collapsed on the sofa. Two or three hours later I woke up and my neck had gone solid as had both sides of my stomach.

Eventually, I managed to get in my car and drive to the surgery to try and get some help. The receptionists had locked the doors. I pressed the buzzer and explained my symptoms and the fact I was a cancer patient and was not only in all this pain but also expelling blood and mess uncontrollably.

Her reply was that I should phone at eight the next morning. I replied that I had been doing that for weeks and they weren't answering the phones. I then saw an elderly lady arrive and a gentleman with some paperwork. The receptionist came to the door and was extremely rude and disrespectful to them both.

I gave up and went home.

I then phoned the colorectal nurse and she told my wonderful surgeon and he told her to get me booked in.

I had another scan and they found very unusual ulcerative colitis. It was patchy – not the usual blanket of ulcers you'd

expect to see.

I did some research and found that when your body detects something it considers to be a toxin, it tries to expel it through the bowels. So although I got through cancer and didn't have to have a bag, that jab destroyed my colon, and life will never be the same.

It was decided my only option was to have my colon out and an ileostomy (bringing the end or loop of small intestine out onto the surface of the skin) fitted. They also found spots on my liver and the nurse said they weren't there before.

Due to this I have bad circulation, terrible cramps and my skin never recovered from the effects of that jab. Health watchdogs are ‘drug pushers’

Doctor reveals Big Pharma tactics to get products approved

An American doctor, who wishes to remain anonymous, exposes how drug makers rig trials to make dangerous, ineffective drugs seem ‘safe and effective’

EVERY now and then, a highly profitable pharmaceutical product is launched but which is potentially very harmful.

And often, the harms are discovered in early trials (such as was the case with statins) but the drugs still get released on to the market, and concerns about safety and efficacy get ignored.

Tactics such as using subjective metrics, deliberately harming placebo groups, hiding suicides and other reactions, brief studies, recruiting only healthy subjects and burying incriminating documents are often used.

One of my aims is to review the scandalous history of some of the most dangerous drugs on the market, to help those being harmed by them (consider the story of statins and of nonsteroidal anti-inflammatory drugs).

This will illustrate that the horrendous malfeasance we observed from the U.S. Food and Drug Administration (FDA) throughout covid-19 has been its standard operating procedure.

For example, I recently covered the story of Merck’s Vioxx, an unsafe and unneeded painkiller that was kept on the market until outside investigators proved it was causing heart attacks and strokes (estimated to have killed 120,000 by the time of its withdrawal) – something Merck was fully aware of from the start.

Vioxx resulted in a wave of lawsuits that cost Merck billions of dollars but never resulted in criminal charges against any of the executives responsible for those deaths.

Immediately after the Vioxx lawsuits, Merck brought the HPV vaccine, Gardasil, to market, fully aware that it had minimal value to those vaccinated (in fact, it is

understood to have increased the risk of cancer in some groups).

More importantly, Gardasil had an extraordinarily high level of adverse reactions.

Once Gardasil hit the market, the Centers for Disease Control and Prevention (CDC) and FDA were hit with a wave of injuries being reported to them. However, rather than listen to these warnings, they doubled down on their claim that the vaccine was ‘safe and effective’, did everything they could to bury those injuries and allegedly worked with Merck to sell the vaccine to as many people as possible.

However, as bad as those stories are, I believe what happened with the SSRI (selective serotonin reuptake inhibitors) antidepressants is even worse. Since the SSRI saga provides the clearest case study I know of into the gross malfeasance of the FDA, I will review it in the hope we can better understand the agency’s behaviour with the covid-19 vaccines.

From this, we can see just how far the FDA will go to protect the pharmaceutical industry. It is worth noting that psychiatric medications are one of the most profitable drug franchises, making approximately \$40 billion a year – a figure that is expected to significantly increase in the years to come.

When physicians are asked to name what they consider to be the five most dangerous, mass-prescribed drugs in America, SSRIs and serotonin-norepinephrine reuptake inhibitors (SNRIs) almost always end up on the list as I believe they have many overlaps with illegal stimulants like cocaine.

The ‘side-effects’ caused by these drugs

include causing violent psychotic behaviour that leads to suicide and, less frequently, to homicide.

To illustrate, a peer-reviewed Swedish study looked at information on over 850,000 patients prescribed SSRIs within a national database, and compared the rates of violent crimes committed by these individuals when they were and were not taking an SSRI over a three-year period.

It found that SSRIs increased the rate of violent crimes committed by 43 per cent in those aged 15-24 receiving the drugs.

One study found 10 per cent of mentally healthy volunteers on an SSRI became suicidal, while a much larger survey of SSRI users found 39 per cent had experienced suicidal ideation while on the drugs.

The Swedish study showed SSRIs have been repeatedly shown to significantly increase the incidence of hostile (but not yet psychotic) behaviour:

- Causing 7.7 per cent of users each year to develop bipolar disorder (ultimately affecting between 20-40 per cent of SSRI users).
- Causing over half the users to no longer feel like themselves and in many cases as though they were losing their own minds.
- Emotionally anaesthetising 60 per cent of the users. This numbness frequently results in individuals losing the will to leave a toxic relationship or work situation (often for years if not decades), to stop emotionally reacting to things you should react to (e.g., someone being nasty to you or violating your boundaries) and to no

longer experience the joy or vibrancy of life.

- Caused sexual dysfunction in the majority of the users (59 per cent in this study), which often has an extreme impact on the patient’s life (40 per cent in this study). Keep in mind that sexual dysfunction is one of the quickest ways to make someone depressed.
- Increasing the risk of life-threatening birth defects.
- Causing severe withdrawal symptoms (frequent electrical ‘zaps’ through the brain) in 56 per cent of those who discontinue the drugs, with most (46 per cent) experiencing severe withdrawals.

This is particularly tragic because many of the SSRI suicides and murders are preceded by someone having their SSRI changed (e.g., dose increased, decreased or changed to a different medication).

Sadly, as well as these common side effects, SSRI patients also experience a variety of debilitating side effects such as palpitations, anxiety and insomnia.

Worse still, it is fairly feasible to identify who will have a good or bad response to SSRIs (e.g. from their genetics) but doctors are never taught how to do this, probably as it would reduce SSRI sales if they were only given to those who will benefit from them.

Similarly, much (but not all) of the harm that occurs from vaccines (especially in children) could be avoided if doctors were taught to recognise the initial adverse reactions children experience and pause giving those children additional vaccines.

Likewise, if the vaccines were spaced out rather than all being given together during the critical development of a child, the harm would significantly decrease.

However, none of that has been done since it would be equivalent to admitting that vaccines are not ‘100 per cent safe and effective’ and hence significantly reduce vaccine sales.

The 1986 National Childhood Vaccine Injury Act gave legal immunity to vaccine manufacturers to study the safety of existing vaccines so that safer ones could be developed – but Big Pharma has failed to do so ever since.

Of those four states of being, which one is the notable absentee from politics today? And from social media platforms? And from television news debates? And from the protests on our streets?

The answer is the last one: I'm OK, you're OK. It is the only one of the four that has removed feelings of superiority or inferiority. It is a state of being adult and calm – I'm OK, you're OK. It leads to peace and harmony.

And the beauty of this state of being is that it allows for that peace and harmony to exist between people who hold differing or opposing views.

There is no 'othering' of individuals or attempts to group people with opposing ideas as inferior.

When a disagreement or debate takes place with someone when you are in a state of being 'I'm OK, you're OK', the emotion is taken out of it.

As some of us may have noticed in our own lives, when emotions are involved, the chances of resolving disagreements are reduced. This is why politicians involved in matters of international conflict should be positioning themselves as 'I'm OK, you're OK'.

But they are not, and never have been.

Sabre-rattling is what they do instead. But why? Do they not realise that by bringing in emotions, and feelings of superiority and inferiority, that they are fanning the flames of conflict?

The D-Day rehearsal cover-up

- **Exercise Tiger – 1,500 dead**
- **A series of failures**
- **Eisenhower ultimately culpable**
- **No mention of any bodies**
- **Official threats?**

On April 28, 1944, more American soldiers died in a D-Day 'rehearsal' than during the real thing on June 6 at Utah Beach.

During the military operation rehearsal, German torpedo boats and 'friendly fire' cost around 1,500 American servicemen their lives.

During the months leading up to the D-Day landings in France on June 6, the Allies secretly trained for the invasion, code-named Operation Overlord. Slapton Sands beach in Lyme Bay on the southern coast of England was chosen.

This was because of its resemblance to Utah beach where, along with Omaha beach, the Americans would be invading. In the autumn of 1943, approximately 3,000 villagers in the area were evacuated - many against their will - so that the beach landings could be held in total secrecy.

In the early hours of April 28, eight fully-manned LSTs (tank-carrying landing crafts) were returning to Slapton Sands when several German E-boats discovered what they thought was a convoy, and at about 2am, LST-507 was torpedoed and burst into flames.

Its surviving crew abandoned ship but a few minutes later, LST-531 was torpedoed and sank in only six minutes, trapping most of its occupants below decks. LST-289 was then torpedoed

and badly damaged and at least one other LST was struck by a torpedo, but it managed to somehow survive.

Two LSTs had been sunk and at least one was badly damaged, while burning oil covered the waters, consuming many who had abandoned ship, and others who escaped the flames perished from hypothermia.

All other ships were ordered to continue the exercise, leaving the dead and dying to their fate, but the captain of LST-515 disobeyed these orders and threw cargo nets over the side to pick up survivors, saving more than 100 men. When it was all over, almost 1,500 U.S. soldiers and sailors had been killed, but no figures have ever been published for the number of men wounded in the attack.

A series of failures

On the Allied side, the disaster was compounded by a long list of highly conspicuous 'failures':

- U.S. naval commanders did not liaise with counterparts in the Royal Navy
- Royal Navy radar picked up movement of the E-Boats but did nothing
- Escort Corvette HMS Azalea knew about the E-Boats but did not inform the LSTs
- Radio frequencies given to Americans were changed without notice
- There was no emergency training so life jackets were not worn correctly

Eisenhower to blame

While the military has acknowledged the aforementioned facts, there are additional allegations regarding the orders from Supreme Allied Commander General Dwight Eisenhower,

that real ammunition be used during the exercise in order to acclimatise the men to actual battlefield conditions. HMS Hawkins, a British cruiser, fired live shells while the surviving American soldiers stormed the beach. The soldiers were meant to proceed no further than a white taped line that had been set, but in the confusion, many soldiers went straight on through it, resulting in a further 200 to 300 men being killed by 'friendly fire'.

The accounts of those present that day indicate that, as thousands of GIs swarmed ashore from the landing craft, they were cut down by bullets fired by comrades playing the role of German defenders, who had been given live ammunition, but for some reason had not been informed of this fact.

Live bullets whizzed past Hank Aaron from West Virginia, driver to a general who was observing the exercises. Aaron scrambled away from the line of fire, then looked up and saw five men dead. Generals Omar Bradley and Eisenhower watched 'the murderous

chaos' and 'were horrified and determined that details of their own mistakes would be buried with their men'.

No mention of any bodies

Yet there is not a single official mention of any bodies being found on Slapton Sands and nor has the Pentagon acknowledged any 'friendly-fire' disaster in Devon. What happened to the bodies provides another twist to the secret of Slapton Sands. Witness statements suggest they were interred in a mass grave nearby.

Suspicion that U.S. troops dumped bodies in hastily dug graves was first aroused when Dorothy Seekings, a baker's daughter who supplied bread to the troops during the exercises, said she had seen large numbers of GI bodies being buried near the village.

Seekings was ridiculed, yet her description and the location closely matches that of farmer Francis Burden, who sold the Americans fresh milk. One morning shortly after the event, Burden witnessed a huge pit, around two acres in size, being dug by U.S. troops

and large enough to take hundreds of bodies.

Official threats?

The farmer was asked if U.S. troops had ever been buried on his land. He replied enigmatically that Seekings "knew only a small part of it" but nevertheless vowed to take his secret to the grave. What more was he hiding and why was he so reluctant to tell? Was he officially threatened that if he ever told what he knew, then it would be the last thing he would ever do, and maybe his family, too?

Detailed records kept by the stationmaster at Kingsbridge railway station, five miles away, revealed that three trains were secretly loaded with the bodies of GIs under military guard in May. The carriages, each able to carry at least 100 corpses, were "cramped with men dug from mass graves", said local man, Ken Williams. Williams, who served in the Royal Navy also saw the bodies of dozens of men washed ashore on the sands. "The sea turned red," he said. The families, however, were told that their loved ones

had died in the Normandy landings, six weeks later.

People still refuse to accept that hundreds of U.S. soldiers may have been buried in the sleepy Devon countryside but such scepticism fails to explain the account of land girl, Joyce Newby, who helped to make hundreds of coffin lids at a nearby timber yard. She said they were for victims of "friendly fire at Slapton".

Everyone involved, including the doctors, nurses and other personnel in nearby military hospitals filling up with wounded and burned men, were sworn to secrecy on pain of court martial. The invasion was almost called off because ten senior officers who knew the locations of the actual invasion beaches were dead, and it could not be certain whether any of them had been captured by the enemy.

As a postscript to the sorry affair, when the survivors of 'Exercise Tiger' stormed Utah Beach on D-Day, 200 were killed or wounded.

U.S. Admiral Donald Moon was made the scapegoat and he paid the ultimate price last week, on August 5, 1944, when he shot himself. Close friends say that he never recovered from the debacle of Slapton Sands.

To this day, the only memorial to the incident is in the village of Torcross, Devon, where locals erected a plaque commemorating the dead. But there is no official memorial to those killed during Exercise Tiger, and probably never will be.
