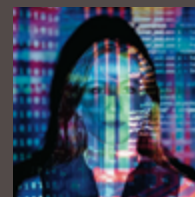

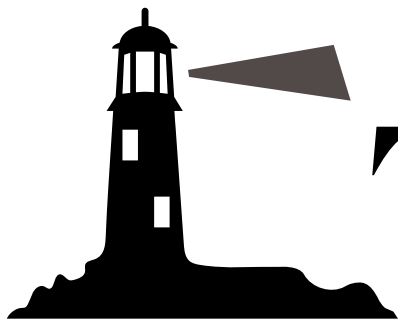

I lost my son to an NHS protocol

Mother hits out after son given midazolam and dies

ROSALIND Forshaw's son James died unexpectedly in hospital in 2021 after being admitted with a cough. He was 48.

Now she is telling her heartbreaking story for *The Light*:

In 2019, my son James, at the age of 48, was admitted to a mental hospital in Essex by the NHS. He was very popular with other young patients and would frequently advocate for them, always the caring soul.

Two years later, James refused the covid jab, which went down like a lead balloon in that institution.

In mid-October 2021, he phoned me to ask for his father's phone number. He seemed very subdued and thoughtful, not his usual self at all. He said to me: "Mum, I've had a terrible life, haven't I?"

I knew what he was referring to. At the age of 20, his two children were taken into care and adopted through no fault of his own. Those children were his life and it broke him. He fell into a spiral of depression, pills, drugs and alcohol. There was nothing his father and I could do.

The 16th of November 2021 was his 48th birthday. Before I had the chance to call him, the social worker at the mental hospital rang. She told me flatly that James had died in Basildon hospital on the 11th of November after being admitted on the 29th of October.

Died? James had DIED? How could that be? And why didn't anyone tell us at the time? I felt sick, confused and so shocked, as if I'd been kicked in the stomach. My beautiful son had gone through all that without me or anyone he loved knowing, and with no family at his side.

I asked why I hadn't been told about the hospital admission and the social worker said pathetically that they couldn't find my phone number. She said James had died of covid.

I contacted the hospital and got someone to read out his medical notes to me. He'd been admitted with a cough. One part said he'd refused his prescribed medication, then had a fall, then had a brain scan. He was transferred to a covid ward, put on a ventilator – unnecessarily, in my opinion – and given a toxic mix of midazolam and morphine. The intubation (a medical procedure that involves inserting a flexible tube into the trachea) was poorly done and this allegedly led to his death. I believe if he hadn't been so heavily drugged with midazolam, he'd still be here today.

When I contacted the coroner's office and told the secretary there that I did not believe James had died of covid, it was decided that one of the 'top coroners in the country' should do a post-mortem. This revealed nothing other than bleeding into the lung tree, caused by intubation. James's organs were in good condition and there was no mention of a respiratory illness. The coroner concluded it was a 'covid-type' death.

I was so angry. My son had just been cut into pieces, his organs shoved back into his body, then been given this final insult by the coroner.

The people at the coroner's office were helpful at first. I was assigned a very nice ex-police officer and a team. I was assured they would keep me in the loop and would carry out a full investigation.

For months I heard nothing, so I contacted them. I found out that my assigned officer and team were no longer investigating the matter and that an inquest had been held three months after the post-mortem without me knowing.

I started to understand how corrupt the system is. James was costing the NHS thousands of pounds a month and because he was a bit of a maverick – knowing covid was a hoax and refusing the jabs – I reckon he became a target.

I'd heard that the NHS were paid per 'covid death' and wondered if that was why he was listed as such. I wanted to fight but I was too distressed and tired, and knew in my heart that it was pointless to even try.

The social worker later told me that James caught covid because he was an 'anti-vaxxer'. She and the pastor at the unit were desperate to hold James's funeral service in Essex – I don't know why – but I decided to bring him home to Somerset. The social worker and pastor went cold on me after that.

My chosen funeral director fetched James's body. I was keen to dress him in his best clothes but was told the body bag wasn't allowed to be opened. They told me it was 'covid rules'. Because of those rules, I never saw my boy after he died and never

knew for sure if it was really my son in that body bag. The funeral director said he'd measured him at 6ft 6ins but James was just 5ft 4ins tall.

On the day of the funeral, the pallbearers struggled to lift the coffin. At one point, we rushed to help as they almost dropped him. My husband, who used to work as a crematorium manager, remarked that the coffin felt far too heavy to be James. Oddly, his ashes were really heavy too. So, was my boy in that coffin? Was it him or was it someone or something else? I guess we'll never know.

I believe I lost my beloved son to an evil protocol, a deathly plan that used end-of-life drugs and ventilators to kill, and which has affected and united myself and countless others in collective grief and heartache.

I feel James watching over me; I hear him say: "Go for it, Mum!" And that's what makes me certain that, by speaking out and by sharing James's story, I'm doing the right thing.

Midazolam uncovered

Registered nurse Elena Vlaica, whose husband Stuart died after being given huge doses of midazolam in 2021, and whose story has been shared in *The Light*, says that the staff who administer drugs like midazolam often don't know what they are doing.

She said: "An NHS protocol might say to give up to 60 milligrams of midazolam,

but you don't need to go up to 60mgs. "These doctors are paid to do what they're doing - for pocket money, they will follow the protocols and put you down like a dog."

Retired neurologist and Catholic priest Dr Patrick Pullicino claims that end-of-life protocols have been abused over the years.

He said: "Midazolam and morphine should never be given together because they both cause suppression of respiration and sedation."

In the 2024 documentary *Playing God*, Lawyer Anna de Buisseret said: "These medics are placing themselves in the position of God and deciding who should live and who should die."

Industrialism is face of evil

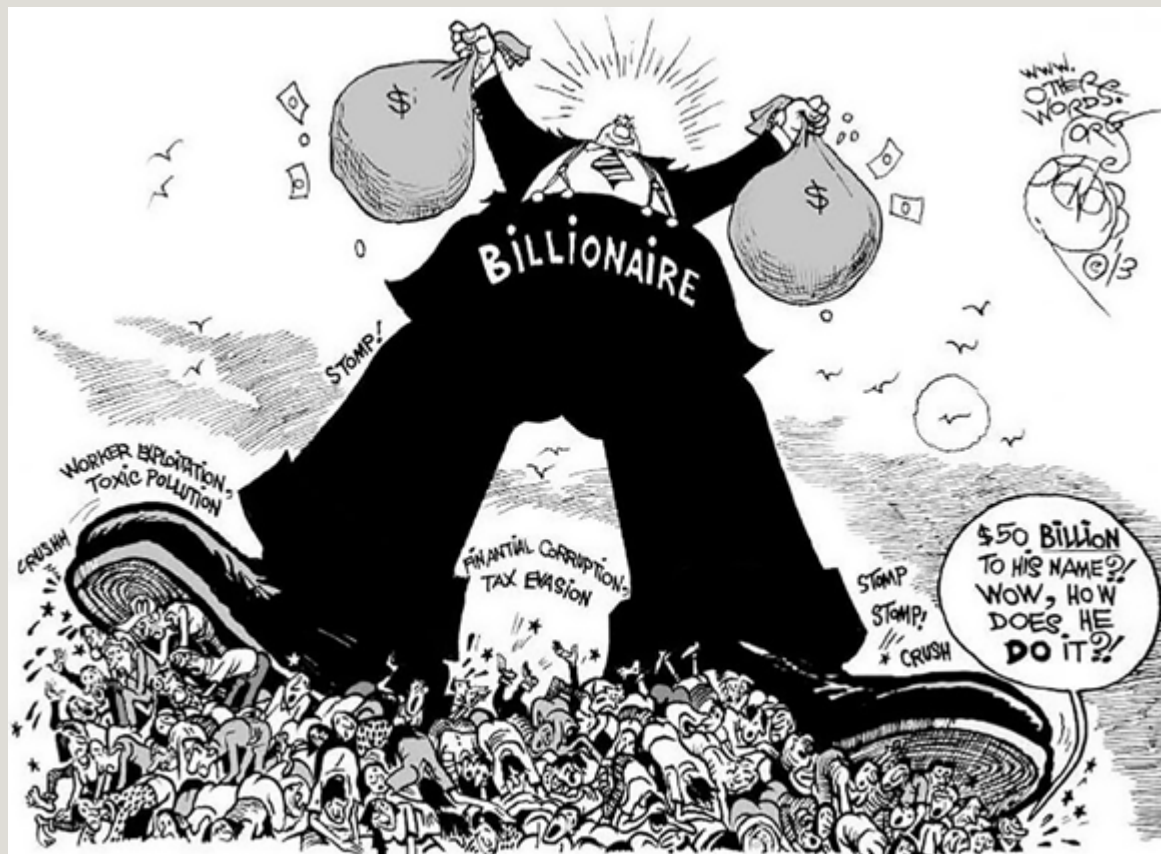
Within the human mind, we could identify this as the ego; the little self who is only interested in his own narrow desires and, thus, like soul-selling Faust, puts himself at the service of evil.

But when a world is dominated by individuals who have deliberately embraced selfishness, unashamedly and even jubilantly, this germ of inner evil will then expand to assume a social and physical form.

Certain apologists for the current industrial system like to claim that the enormous social and environmental problems associated with it are the result only of the specific way in which our society is being run at the moment.

The technology involved, they insist, is itself 'neutral' – it is merely the way in which it is used which is problematic. However, to fairly assess this so-called neutrality, we need to consider what lies behind the industrial impulse.

While the official narrative insists that its aim has always been to relieve people of the need for manual labour, to lift them out of poverty, to elevate humankind to greater cultural and civilisational heights, this is just window-dressing for something much less worthy. Industrialism is about profit. Labour-saving machinery has always been about saving the costs of human labour for the machine's owners and thus increasing their profit margins.

Increases in scale, in productivity, in efficiency, in quantity and in speed are likewise all aimed at increasing profit.

Those who 'invest' in the latest 'innovations' are doing so in the hope of extracting the greatest possible financial profit. Property development is about making profit from destroying our countryside and sustainable development is about continuing to profit from the pillaging of the living world while pretending to be 'green'.

Industrialism, from the First Industrial Revolution of steam engines and factories through to the proposed Fourth Industrial Revolution of transhumanism and nanotechnology, has always been – and always will be – a means of making money. This, in itself, is damning. Christian teaching tells us that 'the love of money is the root of all evil', and this understanding is part of traditional human wisdom.

But when we look at the effects of this industrialist money-love on our world, the force fuelling its advance becomes even more obvious.

While nature is beautiful, industrialism is ugly, on the inside and the outside.

For centuries, it has been ravaging, raping and defiling the sacred place to which we belong. Rivers poisoned, air blackened, seas polluted, forests felled, landscapes desecrated. Factories, pylons, motorways, airports, phone masts. Plastic, concrete, chemicals, fumes, radiation. And at the same time, generations of human beings have been ripped from their native soil, shipped all over the world and shovelled into the jaws of The Machine. Human capital. Fodder for

the investors.

Industrialism is, in fact, a physical manifestation of evil, as many have seen.

William Blake did not speak lightly of 'dark Satanic mills' blighting England's green and pleasant land, and neither was Mohandas Gandhi exaggerating when he declared: "Machinery is the chief symbol of modern civilisation; it represents a great sin."

It is true that evil also becomes real and physical in certain actions of human beings unrelated to industrialism. But the sheer scale of the industrial evil puts it in a different league to the little incidents.

After all, what could be more evil than an all-out assault on life itself?

Industrialism is the negation of divine nature in all its living beauty and authenticity. Of course, the Evil One is an expert in both deception and temptation and has succeeded in persuading the majority that his malevolent works are to our advantage.

Rendered helplessly dependent on his devilish inventions, people can no longer imagine a life without his little luxuries,

without his artificial light, without his constant supply of hell-heated water, without the flickering hypnotic images of his 'entertainment'.

And all the time, they force themselves not to be able to see where all this is heading – where it was always heading.

Perhaps in the 19th century, people could be forgiven – despite all the child labour and industrial disease – for imagining that technological progress was a real thing, that one day it would come good. But today there is no excuse. We have seen all too well what industrialism has done to us and we have heard all too clearly what it wants to do to us next.

The covid moment and the announcement of the Great Reset, aka the Fourth Industrial Revolution, was a wake-up call to which we urgently need to respond.

We face a future of genetically modified embryos grown in artificial wombs and sold to de-sexed, de-natured, de-humanised, locked-down, smart-city couch-consumers whose data is harvested, whose lives are tracked, traced and traded, whose illnesses are a source of profit and whose deaths are medically accelerated, bringing to a premature end an existence that has been meaningless, virtual, sterile and soulless. The trees will all have to be chopped down to generate more electricity to fuel the Matrix, with fields and hills smothered with industrial solar panels and wind turbines before these fall apart and have to be buried somewhere in Mother Earth's defiled flesh.

We will be trapped inside a world plunging towards a choking, toxic death, while everyone is forced to put on a synthetic smile and pretend that we are heading upwards towards a glorious, gleaming future. Do we want industrialism to continue its cancerous growth until it has killed everything and everyone?

Let nature look after CO2 levels

£22,000,000 project to tackle climate change a complete waste

THE government's insane plans to sequester a puny 8.5 million tonnes of carbon dioxide under the sea at enormous expense must be stopped.

The Department for Energy Security and Net Zero has pledged £22bn to install equipment to capture carbon dioxide and store it safely underground at sites in Teesside and Merseyside.

But questions regarding safety arise because there are instances of significant failures where carbon capture schemes have broken down and released large quantities of carbon dioxide with serious consequences for the health of the public.

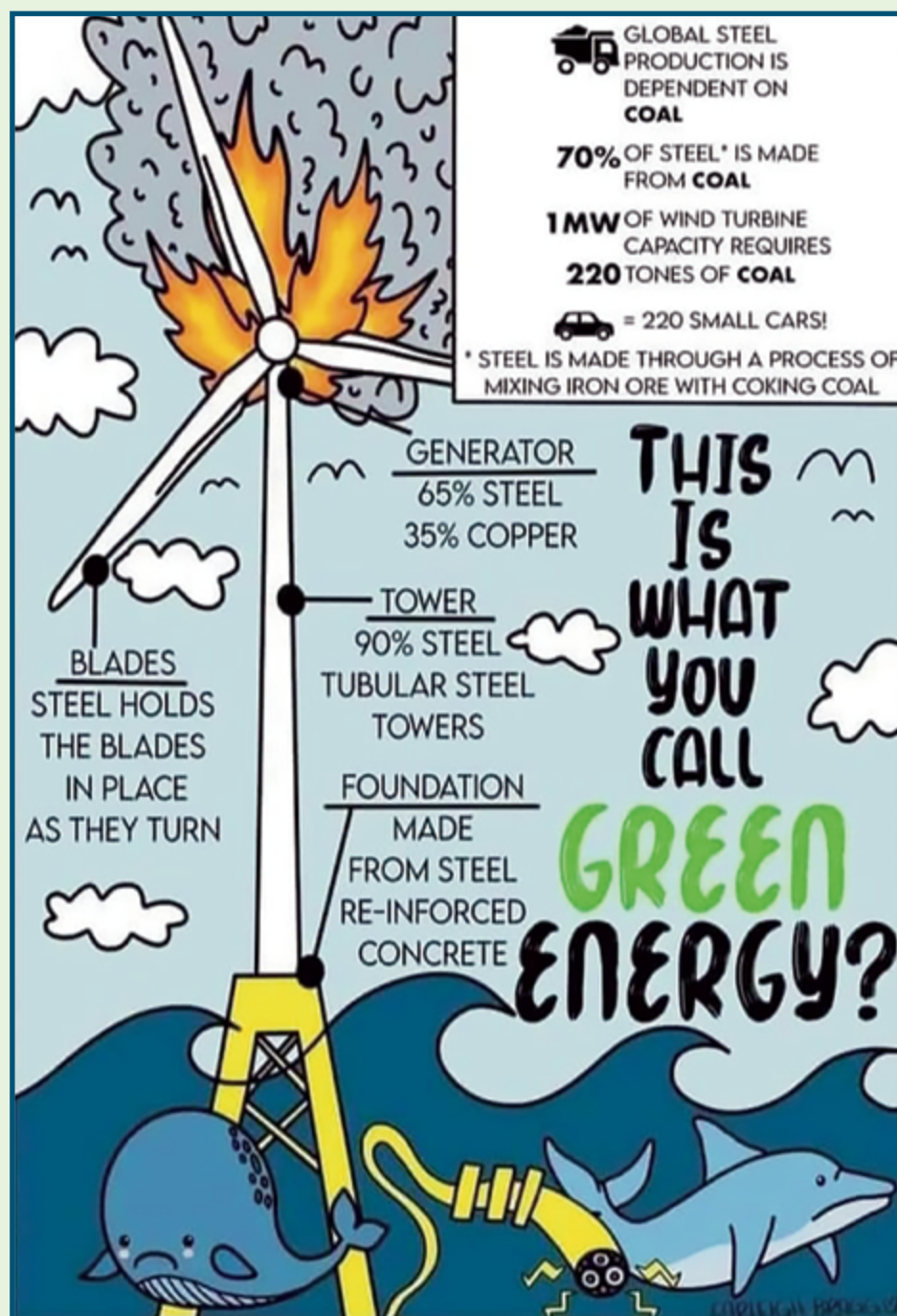
Such schemes benefit only those organising and constructing them. Also it should be noted that such facilities require significant amounts of energy to power them.

Natural processes isolate vastly greater amounts of carbon dioxide without any cost to us. In particular, the annual exchange of carbon dioxide between the atmosphere and the oceans, vegetation and other sinks dwarfs the government's proposal, highlighting the magnitude of their hubris and the inanity of their plans.

The exchange is a continuous process that takes place throughout the year. It maintains a balance of carbon dioxide between the atmosphere and the oceans, depending mainly upon temperature and pressure. Man-made carbon dioxide takes part in the exchange and becomes diluted in the atmosphere as the more abundant natural carbon dioxide from the ocean takes its place. Similar processes occur with other sinks, but on different time scales.

Over the course of each year the exchange transfers some 700 billion tonnes of carbon dioxide out from the atmosphere and into sinks. About one fifth of the exchange (140 billion tonnes) is man-made. About the same amount of carbon dioxide is transferred from the sinks into the atmosphere. This incoming carbon dioxide is depleted of the man-made component.

Each year, we burn coal, oil and gas that produces about 35 billion tonnes

of carbon dioxide and most of this goes straight into the atmosphere. Since the percentage of man-made carbon dioxide in the atmosphere is relatively stable, it follows that the same quantity – or 35 billion tonnes of man-made carbon dioxide – must be purged from the atmosphere each year and sequestered in the oceans, naturally, by the exchange.

If this purging did not happen, we would see an increase of about 1% in atmospheric man-made carbon dioxide each year – but this is not observed.

The exchange therefore sequesters almost 5,000 times as much carbon

dioxide each year as in the government proposal and costs us nothing whatsoever. Even if the government scheme were to be scaled up as envisaged, the natural exchange would still be 1,000 times more effective and still be free.

As usual, with government projects of this nature, the plan is a total waste of resources, manpower and money and, in any case, cannot change the total amount of carbon dioxide in the atmosphere, nor can it affect climate change. These plans should be abandoned forthwith and the £22bn used for the benefit of the people.

HOW MAN-MADE CO2 IS ABSORBED

- Man-made CO2 does not remain in the atmosphere
- It takes part in the annual exchange with the oceans and other sinks
- One-fifth of atmospheric CO2 is exchanged during each year
- The oceans hold at least 50 times as much CO2 as the atmosphere
- Man-made CO2 is greatly diluted by natural CO2 in the sinks

Going up against Big Pharma

Darren Smith interviews doctor turned film-maker **Andy Wakefield**

For those who may not know you, can you tell us a little about your story and background?

Andy W: My journey started in 1991 when I graduated from St. Mary's Hospital, Paddington, one of six generations to graduate from that medical school; medicine ran in our veins.

I was entirely mainstream: I became a physician and became a fellow of the Royal College of Surgeons and the Royal College of Pathologists. I ran a research team at the Royal Free Hospital in London – I was a gastroenterologist.

In 1995, I got a call from a mother saying her child was developing fine, and then it all went wrong after the MMR vaccines. Within a few days, they lost eye contact, verbal communication, ability to interact with their siblings, and they were diagnosed with childhood autism. I knew nothing about that – it was very rare when I was at medical school – so how could I help?

She told me he had intractable gastrointestinal symptoms – ‘I think what’s going on in his intestine is related to what’s going on in his brain, and vice-versa. Certain foods seem to make it worse.’

I heard this credible story so many times from so many parents who followed up after that lady, and I thought ‘we’ve got to look at this.’ The first rule of medicine is to listen to the patient. Other doctors and nurses had told them it’s to be expected with autism.

We investigated these children and found the parents were right while the medical profession was 100 per cent wrong. They also said there was no epidemic of autism; they had just become better at diagnosing it!

The numbers in the UK now approach 1 in 20. When I was a junior doctor, it was 1 in 10,000.

In advance of publishing our findings, I contacted the department of health, assuming they would have been interested in knowing about this potential problem. But they already had problems with the MMR jab that they had licenced causing meningitis – they had been forewarned but had ignored the warnings and run into trouble.

People are fully aware now of cancel culture and what happens to doctors when they speak out, but back then it didn’t exist. So when I came forward and made the suggestion that until it’s resolved, parents might opt for the single vaccines – because we only saw this problem with the combined vaccine – the world turned upside down for me.

There was me on one side, and then on the other, you had the all-powerful drug companies, the World Health Organisation, UNICEF, American Academy of Pediatrics, the Royal College of Paediatricians, the British government and the governments of the world lined up in support of the MMR vaccine, saying ‘it could not possibly be the vaccine!’ So it was a very difficult time because what do you do? Who do you turn to in those circumstances?

Then they came after me in a big way: James Murdoch, Rupert’s son, was put on the board of GlaxoSmithKline, Europe’s biggest MMR manufacturer, and his job was to protect the reputation of GSK, so he used News International to tear me down.

The dean of the medical school threatened me overtly by saying ‘if you continue this vaccine safety research it will not be good for your career’. So I decided to work at it twice as

hard, but he was right: it wasn’t good for my career!

Then the false allegations of fraud and abuse – they were accusing me and Professor John Walker-Smith of harming children. Not only did they have underlying inflammatory bowel disease, but they benefited enormously from the treatment. These children were in pain, but they couldn’t articulate it because of autism. The treatment relieved that pain and they started speaking again, started behaving normally again.

We lost many years of help for these children in this battle against the possibility that it was the MMR.

And now you’re an award-winning film-maker?

Andy W: I decided when everything was taken away from me to become a film-maker. A lot of whistleblowers had come to me over the years from the CDC and the manufacturers. They said ‘we’ve done a terrible thing and here’s the evidence’ and they presented me with compelling evidence of fraud and so I turned them into films.

The most pivotal so far was *Vaxxed*, which had a massive impact because it was a senior scientist from the CDC saying ‘we’ve found a link between the MMR vaccine and autism and we’ve destroyed the documents and covered it up for 14 years.’

Film-making is an incredibly powerful way of reaching a large audience in a way that first entertains and then educates. As long as you make films with integrity then you can have a huge impact on a large number of people. When you’re in the clinic, you can help one child at a time, but when you make a movie, you can help tens of thousands.

The first film I ever made was never meant to be a film; it was meant to be a fly-on-the-wall documentary about a child in Chicago called Alex Spourdalakis. He was a big child and terribly aggressive with his vaccine-caused autism.

When I heard about him he was in a paediatric intensive unit, chained to the bed with four point-locked restraints, and given 74 psychotropic drugs – a real testament to the failure of medicine to understand what is going on: because the medicine made him aggressive, he was chained to the bed.

We took him to New York and had him scoped; he had inflammatory bowel disease and was put on the right treatment; he was doing very well, but his parents were estranged, so his mother took him back to Chicago, where they were living hotel to motel, and every time Alex heard a siren he thought they were coming for him, so he would destroy the hotel room and they had to keep moving on.

They were exhausted, so he ended up back in the hands

of the neuropsychiatrists. He was on two intravenous medications and an intramuscular horse sedative, and was chained to the bed again. Polly Tommey and I went to try and find somewhere safe for him, but within that week, his insurance ran out and so he was put out onto the streets. A week later, he was dead: his mother had killed him and then tried to take her own life.

It was a tragic story – she was put in prison and the papers dressed it as a mother who hated her child. We had seen that she loved him dearly; but she could not bear to witness another moment of his suffering. She was beyond breaking point and she had been driven by the system to this.

She was going to go to prison for the rest of her life with no chance of parole, so we decided to make a film and tell the story of what really happened: *Who Killed Alex Spourdalakis?* I got a call four years later from her lawyer, saying he had been contacted by the state’s prosecutor, hearing about the film and wanting to see it. He got back to me a week after that and said ‘we can no longer prosecute this case in the same way – she will be released from prison next week.’

This is about the power of film to tell the truth and change people’s minds. It was the first time in American legal history this had ever happened. But it underscored for me just how powerful film can be, used judiciously, and so my future is in making films, and there’s no doubt the companies and the governments will give us plenty to write about!

Protocol 7 – what’s this film about and why should we see it?

Andy W: A whistleblower came to me in Chicago many years ago, and he said ‘I work at Merck’s MMR vaccine lab and have been asked to commit fraud and I refused and here are the documents proving it.’

At that time, I wasn’t a film-maker and I passed them on to a false claims act public interest lawyer. He decided the case should go forward, and I thought ‘this would make an amazing film’ and I was doing screenwriting as a hobby, so I wrote the movie *Protocol 7* although it wasn’t called that at the time. I finished it with a writer called Terry Rossio, who wrote *Shrek*, *Pirates of the Caribbean* and *Aladdin*, but the case had dragged out in court for over a decade, so I decided it was time to get it out in the public domain, because it was the public that were being defrauded. Although the government was the plaintiff, the people who were really deceived were those parents, children and doctors who were told ‘this vaccine works and it’s safe’ when it doesn’t, and is therefore dangerous.

When you’re making films in this genre – whistleblower stories – it’s usual that the court case or congressional hearing is over, someone writes a book about it and then someone adapts the book into a screenplay and the film gets made many years later, like *Erin Brockovich* or *The Insider* or *Spotlight*. In this case, we were right in the middle of the litigation; we made them release the film during the court case, out of conscience. The risk is that you’ve missed something and they sue you to the moon, but we knew the whistleblower was so credible and the evidence against Merck was so strong that we were prepared to take that risk.

Making of an energy crisis

High-level treason and plotting leaves us cold for winter

AS energy prices bite, and British householders wonder whether to turn on their heating, it is worth looking back to what caused this hardship.

It is over two years since the two pairs of Russian gas pipelines, known as Nord Stream 1 and 2, were sabotaged in the Baltic Sea, close to the Danish island of Bornholm.

What has the ‘investigation’ into this crime – the crime of blowing up a major piece of international infrastructure, and causing environmental damage – yielded to date?

The pipelines run 745 miles along the Baltic seabed from Vyborg in north-west Russia to Lubmin in north-east Germany. They are owned by Nord Stream AG, of which the Russian company Gazprom holds 51 per cent of the stock, and four European energy suppliers (two in Germany, one in France and one in the Netherlands) hold the remaining 49 per cent.

The project was intended to ensure the long-term security of Europe’s energy supplies. Since 2011, when the first pair of pipelines – Nord Stream 1 – was completed, Russia

had been supplying natural gas to Germany and Western Europe at a price cheap enough for Germany to resell the excess to other European countries at a profit. Germany’s industry, and European homes and businesses enjoyed a constant supply of energy at affordable prices.

Washington never liked this arrangement, and by September 2021, as the construction of the second pair of pipelines – Nord Stream 2 – was completed, which would double the amount of cheap gas available to Germany and Western Europe, U.S. hostility towards the supply reached a climax.

On February 7, 2022, weeks before Russia entered Ukraine, Biden received German Chancellor Olaf Scholz at the White House, and in the press briefing that followed, stated: ‘If Russia invades... there will no longer be a Nord Stream 2. We will bring an end to it.’

This reiterated a similar message delivered by undersecretary of state Victoria Nuland at a press conference in January 2022, when she said: ‘If Russia invades Ukraine, one way or another Nord Stream 2 will not move forward.’

The explosion on September 26, 2022 destroyed Nord Stream 2 outright, and damaged one of the pipelines of Nord Stream 1.

The entire project of building these supply lines had involved three decades of intense European diplomatic activity, and huge resources, and was to be the key to Russia’s most valuable source of income for the next forty years.

These facts never hindered the media line, duly parroted by the BBC, that the Russians had probably blown up their own pipelines.

But on February 8, 2023, U.S. veteran investigative journalist Seymour Hersh, whose exemplary record of detailed and accurate reporting goes back to the Vietnam

war, published a lengthy account of the sabotage operation he claimed was ordered by President Biden, planned by secretaries of state Anthony Blinken and Victoria Nuland and national security advisor Jake Sullivan, and executed by the U.S. Navy, in collaboration with Norwegian partners in NATO.

Norway had always had a policy of no foreign military bases until Prime Minister Erna Solberg allowed the U.S. to establish bases in Norway in 2021, which promptly destroyed Norway’s decades-long relationship with Russia.

In recent years, the U.S. military has vastly expanded its presence in Norway. NATO’s supreme commander until October 1 this year was former Norwegian prime minister Jens Stoltenberg, and, as Hersh explained, the Norwegians possess sophisticated expertise in deep water operations, as well as geographical knowledge as to where the explosives could be placed on the pipelines, at the shallowest point in their trajectory. According to Hersh, the Norwegians also suggested how to explain away all the diving activity associated with laying the explosives.

Every June, the American Sixth Fleet sponsors a major NATO exercise in the Baltic. In June 2022, the explosives could therefore be placed under cover of Baltic Operations 22 (BALTOPS 22).

Hersh added that the CIA flew in a compression chamber to load onto the submarine to enable the divers to go down to 260ft and return safely, as the initial plan had been to detonate the explosives 48 hours after laying them.

At the last minute, however, the CIA allegedly received new instructions from the White House that Biden wanted to be able to detonate the charges remotely at a future date of his choosing. According to

Hersh, this put the cat amongst the pigeons at the CIA, as the risks posed by delayed timing devices being accidentally set off by the heavy traffic of the Baltic Sea were considerable.

They were ultimately designed to be triggered by a sonar buoy dropped by a plane at short notice, and on September 26, 2022, this operation went ahead, taking out three of the four gas pipelines.

In Hersh’s long career, he has never betrayed a source, which makes him a reliable vehicle for those wishing to leak information from the CIA.

Therefore, though his account is unverified, there is little reason to doubt its veracity.

The burning question is why do economic transactions between sovereign nations have to benefit the U.S., or be considered a national security threat? And, why has Europe allowed itself to become a vassal of U.S. destructive policies? The ‘Wolfowitz Doctrine’ may supply some answers.

The doctrine, unofficially named after the then U.S. undersecretary of defence Paul Wolfowitz, was a 1992 foreign policy document that advocated U.S. unilateralism and pre-emptive military action in a post-Soviet world.

Leaked to the *New York Times* in March 1992, it sparked a public outcry. Nonetheless, American supremacy at all costs has been the dominant foreign policy for the past thirty years.

America’s karmic footprint of destruction and misery in the world is imploding.

We are not America’s allies, we are their vassals. And Britain’s acquiescence affects every citizen in this country.

Whistleblower ignored then sacked

Former teacher *Kevin Lister* is interviewed by *Richard House*

Transgenderism madness in the education system

Richard House (RH): Your recent excellent interview on UK Column News (tinyurl.com/2rvyn5tx) will have touched many. Tell us about your professional history.

Kevin Lister (KL): My first degree is in engineering, and I then worked in ship design, control-systems design, the oil and gas, and rail industries, and also gained masters degrees in business administration and mathematics.

As an engineer, I empathised with James Lovelock's ideas on how the planet's biological systems regulate the environment, keeping it habitable, so I moved into education as a maths teacher, aiming to equip young people with the skills to understand complex dilemmas. But our education system is transitioning towards training for specific yet precarious jobs. In the intellectual vacuum, it is easier to indoctrinate students to conform to ideological beliefs than help them to become critical thinkers.

When I started seeing students presenting as the opposite sex and supported by their school, I knew something very wrong was happening. I immediately raised safeguarding concerns.

RH: How did you raise concerns, and what was the response?

KL: I raised two formal safeguarding concerns, one to do with my student and the other to do with grooming concerns about a trans activist member of staff. Both were ignored. I raised my concerns with the Assistant Vice Principal. She did nothing. I raised my concerns at a staff training session on mental health; I was accused of being 'transphobic'. I explained in my subsequent investigation meeting that my safeguarding concerns had not been addressed; this was ignored.

I raised my concerns with the police and the safeguarding team at Swindon Borough Council – ignored again. I raised my concerns using the whistle-

blowing service at the Department of Education; I was told it was an employment issue.

I raised my concerns with Ofsted. They inspected the college and rated it as 'must improve in all areas' but praised the college for its LGBT+ club where staff and students were working together.

RH: What would have been a fair and proportionate response to your concerns? And what might this litany of ignoring what were legitimate concerns signify?

KL: 'Fair and proportionate' would have been for an evidence-based investigation of my safeguarding responses by the college when I raised them. Instead, the management used these against me by making counter-safeguarding accusations, and then fired me on this basis.

The college was then legally bound to report me to the Disclosure and Barring Service (DBS) to put me on the Children's Barred List (CBL). To do this, they lied to the DBS, claiming I'd harassed and bullied my student, with no supporting evidence, and making no comment on undermining my safeguarding concerns, thus lying by omission. Consequently I was placed on the CBL – and the employment tribunal then found in the college's favour because I was on it!

This is very serious. The safety of children is now subservient to adults' rights to pursue whatever ideological position they want, and whatever child abuse is perpetuated under the guise of ideology. It's more than the mere breakdown of law and order; it's the law actively being used to cause the harm it's supposed to stop. It's the result of the replacement of the laws that the judiciary should rely upon, and which we should expect them to rely on, with subjective decisions on rights under the Equality Act, where 'anything goes'.

So absurdly, a child's safety is now less important than an adult's desire to demand that others endorse whatever beliefs he or she has; and if that belief involved indoctrinating children into a cult with connotations of suicide, so be it.

The legacy? A society distrusting the law or the state's right to the monopoly of violence that we collectively grant to it; therein lies the route to chaos and breakdown, as people decide that their only option is to take the law into their own hands.

RH: Extraordinary, Kevin. Has a kind of 'mass formation psychosis' taken hold of mainstream culture, I'm wondering?

KL: Yes, I normally call it 'collective schizophrenic madness'. Twelve years

ago, I wrote how this would emerge because of a climate change issue: competitive tensions would build up, fractal-like, from street-fighting to nation states going to war. As I predicted, it's happening now. Everyone and every organisation has to maximise competitive advantage; and at a national level, this means doing the exact opposite of what we need to do.

Transgender ideology is one manifestation of the resulting collective schizophrenia, where the institutions of the state come to believe and embrace something that we all know we is false – that a girl is a boy.

It is a workable proposition that the madness of my case, which needed a systemic collapse in basic morals and common sense, is because the transgender ideology is a manifestation of our descent into collective schizophrenic madness, driven by the blatantly false narratives around climate change, transgender ideology and the rest that we are told to accept.

RH: Where has all this left you, personally and professionally?

KL: Personally, the damage to me is manageable, though painful. I can't teach, get any other worthwhile employment or do voluntary work with my partner. Yet resigning myself to being a social pariah is little compared with the testimonies I've heard about how this ideology has torn good families apart and destroyed their children.

The stress of experiencing at first hand the collapse of the systems we depend on is the worst, and it is causing me such serious health problems that it's conceivable I may not survive to the end of my legal cases.

RH: Can readers help in any way? And what advice would you give to others in comparable situations?

KL: On a personal level, readers can help with my crowdfunder (gofund.me/14f6bc95), but most of all, they can help by learning how a death cult in our schools and institutions became institutionalised, and to speak out against it whenever and wherever they can.

Finally, parents should make sure their children know they love them and should make sure nobody else takes their place.

Myth of EV battery ‘recycling’

Fundamental laws of science being ignored by green agenda

MANY people will know that lithium-ion (Li-ion) electric vehicle (EV) batteries can auto-ignite, in turn causing the vehicle to catch fire.

But what they don’t perhaps know is the massive problem that exists around battery recycling (or lack of it).

Essentially, recycling is necessary because the metals needed to make new EV batteries are scarce, and to achieve the amount of EVs required to supplant internal combustion engine vehicles, there are simply not the resources available on earth.

Salvage facilities currently don’t know what to do with EV batteries. There is a place in Belgium that smelts them down. But, generally, no-one knows how many are actually recycled, if any are recycled at all.

The problem is that EV batteries are not made to be recycled. Tesla’s Model 3, for example, is said to require the whole upper body removed from its chassis to access bolts that then need a special tool unique to the manufacturer.

But, the real issue is chemical: EV batteries are complex modules with internal layers bound together with hazardous fluorinated glue. Battery chemistry is not standardised, is never disclosed for proprietary reasons, and the marketplace is fast-moving and unregulated. All this makes dismantling both dangerous and difficult.

Into this arena step entrepreneurs, attracted by a large pot of government funding. Apart from pie-in-the-sky options, two recycling methods dominate: Pyrometallurgy (recycling using fire), and hydrometallurgy (recycling using many stages involving highly acidic and alkaline water). But neither can recycle without the other, so in fact they are primary and secondary stages of one long and complex process line, if this ever occurred.

A variant of pyrometallurgy is smelting, already mentioned. It destroys about 80 per cent of the battery mass, does not recover lithium, and burns graphite along with burning extra coke, which results in the release of four tonnes of CO₂ for every tonne of battery processed. So, it is not very good if you care about that.

A different variant of pyrometallurgy involves lower temperatures that create an intermediate product called ‘black mass’ - a sludgy mixture of chemicals.

And it is here that things become sinister. Essentially, making black mass is a lot about shifting waste around, but little recycling occurs. It is passing the toxic problem onto someone else. The process line is split into many stages which occur at different plants in different countries, thus blurring the audit trail.

The creation of black mass is not touted for its technical merit either – it has none. It is little better than smelting, in material recovery terms, as it doesn’t recover lithium or graphite. It is proposed because governments have set overly ambitious recycling targets.

Hydrometallurgy of black mass is in fact worse than smelting of whole EV batteries:

- The low temperatures used to make black mass are more likely to create toxic polyfluoroalkyl substances (PFAS) from the battery glue. These pollutants are termed ‘forever chemicals’.
- Large amounts of chemicals are used, and into these the batteries are soaked, like an acid bath, from which the liquor is further treated with more chemicals, etcetera. To improve the chemical reaction, and to speed up the process, the amount of chemical

used has to be between ten to a hundred times more than the actual battery mass.

Absurdly, EVs are called green because emissions do not occur when the vehicle is being driven. But the chemicals needed for recycling batteries are also dependent on the burning of lots of fossil fuels, and this is also kept hidden.

These hidden embedded carbon emissions are nothing new to the recycling industry. The same occurs with so-called advanced plastics recycling. Little recycling occurs, while greenhouse gas emissions are selectively brushed under the rug.

From a science and engineering perspective, in a sane society, scientific principles would guide decision making. But we do not live in a sane society.

The limits to any form of recycling, indeed any activity involving work and energy, are dictated by universal laws; specifically the laws of thermodynamics.

These say that no recycling can occur without the input of energy or resources. And, importantly, the more process stages there are, the more energy will be lost to the universe, increasing disorder and entropy, and creating more waste.

The best that can be achieved is

for resource and energy use to be minimised, which would limit waste and environmental impact.

And the way to do this would be to design and build products that are durable, reusable, and at the very least easily recyclable. But this is not done, because it would require policy-makers to tackle, and regulate, the large, behemoth corporations who profit from cheap throwaway goods.

And it would undermine the economies built on the same. In an insane society, we are instead persuaded to believe in novel back-end fix technocratic ‘solutions’ and the illusion of ‘sustainable’ recycling. Such is the world that we live in.

Health of the people is the highest law

THE noble pursuit of a healthier society has been distorted by the ideology of U.S. federal agencies and the interests of Big Pharma.

Covid-19 emphatically demonstrated policies that are less about saving lives – as presented to the public – and more about consolidating power and maximising profits.

A British variation is ‘saving the NHS’; a socialist facade for a monopoly benefiting the pharmaceutical industry.

The Labour government’s minister for health, Wes Streeting, is burnishing his credentials as chief sales rep for the pharmaceutical industry. Drugs will increasingly be used as a remedy for social problems.

It will be interesting to count how many pills people are taking by the end of this administration compared to now. Shake the average citizen and he or she will rattle.

Streeting has started how he means to go on by targeting the unemployed. He has launched a trial of a fat-busting drug for obese recipients of unemployment benefits.

He said: “The long-term benefits of

these drugs could be monumental in our approach to tackling obesity. For many people, these weight-loss jabs will be life-changing, help them get back to work, and ease the demands on our NHS.”

The 3,000 participants will receive Big Pharma firm Eli Lilly’s Mounjaro injection, a competitor to the highly publicised Ozempic jabs produced by Novo Nordisk. Streeting boasted that Eli Lilly has invested £280m in the scheme – what a great deal for taxpayers!

As Kit Knightly noted in *Off-Guardian*, this means that the British government is being paid by Big Pharma for the opportunity to test a potentially lucrative new drug on people who are dependent on the state. Following the ‘no jab, no job’ tyranny of the purported pandemic, Knightly asks: ‘How long before the overweight and unemployed are told no jab, no unemployment benefits?’

If the government was really concerned about unemployment, it would stop mass immigration. Everyone knows by now that jobs are disappearing, and the Ponzi scheme of sustaining GDP by importing ever more people (mostly for low-skilled work) is unsustainable. Wages have been cut to the bone, so that anyone on the dole is hardly attracted to get off the sofa. Streeting and his boss Keir Starmer, who

also waxed lyrical about the potential for weight loss drugs to get people back to work, are seeing the problem of obesity and unemployment in reverse.

Obesity is associated with unemployment because inactivity, low self-esteem, mental health problems and reduced income contribute to a sedentary and aimless life. And unemployment is a problem which has been caused and compounded by successive governments.

Smokers, drinkers, critical thinkers, or anyone making the wrong choices (from a twisted ‘public health’ perspective) will find themselves in a dilemma: either comply or face serious curtailments.

The government knows that most people will take the easy option. Aldous Huxley’s *Brave New World* was a society run on Soma, the ultimate medicinal control.

The fundamental difference between public health and healthcare is that the former is impersonal and collectivist, while the latter is (or should be) patient-centred.

Health ministers and Whitehall bureaucrats do not care about individual impact; they are only concerned with policy objectives and delivery.

Callous decisions by central government, such as withdrawing the winter heating allowance for older people, are made

without any lost sleep. Inevitably, pensioners will perish in the coming winter, as they succumb to the cold and damp of an inadequately heated home.

As Joseph Stalin said, the death of one man is a tragedy, but death of a million is a statistic. The very notion of public health detaches policymakers from patients, as shown by the reckless administration of covid-19 vaccines to children and pregnant women.

In the 19th century public health pioneers such as Edwin Chadwick saved countless lives by improving sanitary conditions and through provision of fever hospitals. But the likes of Bill Gates, a man without medical qualifications who played a leading role in the covid-19 debacle, deserve little credit.

Their goals are not primarily for your health and longevity, but to execute a ‘Great Reset’ of health as an instrument of power and profit.

Historian and philosopher Michel Foucault warned of this back in the 1960s. Health, a prime concern for any human being, is being manipulated as a means of totalitarian surveillance. To bring Foucault up to date, it has become the currency of a dystopian social credit system.

The Great Reset must be confronted – before it’s too late – with a Great Resist.

Limitations of current medicine

Exposing constraints of the current medical model

THIS is a question that comes up for every [cancer] patient – truly where we’ve missed the mark is in three primary areas.

First, I think health insurance has destroyed our health-care systems in America. I think it has stripped the rights of medical professionals and healthcare professionals in every single sphere – from being able to honestly and ethically practise medicine and healthcare with their patients. And for any company who can actually tell a healthcare professional, ‘we will not cover for this modality or this prescription medication or this therapy’, I think that’s evil, and it needs to be destroyed. I think the medical profession and healthcare professionals in the world know the history of their patients better than anyone else, and at the bedside, should be free to make the medical decisions as best as they can articulate and follow up on. So I think that self-insurance has been a huge problem.

Number two has been the specialising of medicine. I think when the medical profession decided to isolate various organ systems, and only look at one organ as a part of the human body, that’s a massive problem. The entire body is a system, and I think the entire body should be looked at by every healthcare professional as a whole, and I think that has been a huge problem in the world of medicine. It actually has left more mystery, more complexity and worse outcomes for patients, isolated and isolating them. To see a specialist only talking about your eyes, or to talk about your kidneys, or your lungs, or your heart, or your bladder, or your ovaries, and not educating the patients on the whole – or the professionals, actually – on the way the whole body and the whole system works.

Then number three, the use of pharmaceutical drugs to mask symptoms, to be proposed and marketed as a treatment for any symptom or illness, is a fraud. There is not a single symptom that a human being has ever had in their whole life – a fever, a cough, a sweat, a rash, a diarrhoea; no one has ever had a

symptom, ever, or a diagnosis of cancer, that was caused by a prescription drug deficiency.

And if that’s not what’s causing your symptom or your illness, why are you using those things as the therapy to dismiss the symptom or address the problem? In fact, as in the instance of scurvy, which was the most recent plague to mimic the death outcome such as covid’s pandemic (there were six million people worldwide supposedly dying of

covid – a four-year pandemic), scurvy killed over 2.5 million people. And what they found in scurvy wasn’t caused by a drug deficiency or the need for a vaccine, or radiation or chemotherapy, or surgery of any kind. What they discovered was that if individuals would eat one fruit, a citrus fruit – an orange, a lemon or a lime – no-one ever died from scurvy, and all scurvy symptoms disappeared.

It wasn’t for decades, if not a century later, when science finally caught up

to find what was in the fruit, that has prevented death and cured the world of scurvy even to this day. It took them almost a hundred years to figure out that in limes, lemons and oranges was something called vitamin C that was the cure for scurvy; and that the scurvy that killed millions in a very short time was due to a deficiency in vitamin C. And what they discovered was that each lime, lemon and orange had 10 mg of vitamin C only. Do you know that in a capsule today, that you buy at a store, there’s 1,000 mg of vitamin C in it?

And it’s no different with cancer worldwide: that it, it’s said, kills millions of people worldwide. There are actually nutritional deficiencies that are created that lead to all disease outcomes and symptoms. As long as you give the body what it needs, and take away from the body what is causing poison, toxicity or immune suppression, you can cure almost any disease. But you have to change the environment in which your body’s physiology and cells live to change your experience of living. You can either be healthy or you can be sick; you get to choose, but you have to make the choice.

Ignorance is not always bliss, so just to ignore the fact that you’re eating Pop Tarts every morning, that you’re starting your day with dairy, milk and cereal; that you’re starting with a frappuccino at Starbucks; if you haven’t figured out yet that these things you’re doing every day to yourself are causing problems, and you’re not willing to change it, these are going to be the individuals who are showing up looking for anybody with a cure to save them.

And those cures that are offered to you are going to be in a syringe; they’re going to be in radiation, they’re going to be in scalpels and none of those are solutions to any health problem whatsoever. In fact, they could possibly alleviate a problem but they’re not a cure for them. To cure something is to actually return it back to its normal state, and that’s not what cancer treatment or pharmaceutical drugs are designed to do.

Bill Gates faces trial in Netherlands

Case brought by vaccine-injured claims they were deliberately misled

SEVEN vaccine-injured Dutch citizens filed a lawsuit against Bill Gates, former Dutch prime minister and newly appointed NATO Secretary-General, Mark Rutte, Pfizer CEO, Albert Bourla and several members of the Dutch government's 'Covid-19 Outbreak Management Team'.

It alleges that they deliberately misled the plaintiffs as to the safety of the covid-19 injections, despite knowing they were neither safe nor effective. One of the plaintiffs has subsequently died from her injuries.

According to independent Dutch journalist Erica Krikke, the plaintiffs' names are redacted in the lawsuit's publicly available documents, but they are ordinary Dutch people.

Dutch lawyer Meike Terhorst, told *The Defender* that cases against the Dutch government relating to covid-19 are normally lodged in The Hague, where they are mostly unsuccessful. But the plaintiffs

filed their suit in the District Court of Leeuwarden.

In a procedural hearing on September 18, Bill Gates' lawyers argued that the court had no jurisdiction over him as he lives in the U.S.

Claiming lack of jurisdiction is a common ruse used by powerful individuals and

organisations to avoid judicial scrutiny. But Gates claims jurisdictional power over the entire world when he aims to force injections into everyone living in it. Consequently, one cannot have jurisdictional power without jurisdictional accountability. Therefore, Gates should be answerable in any and every court in the world.

Luckily, the Leeuwarden court also saw it that way, and on October 18, ruled that it does have jurisdiction over Gates. A hearing is scheduled for November 27.

The ruling also addressed the plaintiff's claims with regard to Gates' role in the WEF's 'Great Reset' project:

'The Bill & Melinda Gates Foundation is also affiliated to the World Economic Forum...an international organisation whose statutory objective is to unite "leaders from business, governments, academia and society at large into a global community committed to improving the state of the world".

'This is a project aimed at the total reorganisation of societies in all countries that are members of the United Nations... as described by WEF founder and executive chairman, Klaus Schwab, in his book *Covid-19: The Great Reset*:

'Characteristic of this political ideology is that this forced and planned change is presented as justified by pretending that the world is suffering from major crises that can only be solved by centralised, hard global intervention. One of these

pretended major crises concerns the covid-19 pandemic.'

Whether or not the case is ultimately successful should not deter the six remaining plaintiffs from proceeding with confidence.

On October 23, six former employees of transport company, BART, were awarded between \$1.2 million and \$1.5 million each by a federal jury who agreed that they had been unfairly dismissed for not complying with 'vaccine' mandates.

Of note is that the lawsuit began as three separate cases representing 35 employees fired by BART, which were consolidated into one case. But 29 of the plaintiffs settled with the company out of court.

This highlights the importance of proceeding to trial, despite the risks and anguish involved, to bring these cases into the public domain, because extra-judicial settlements normally have, as a condition, the signing of a non-disclosure agreement (NDA).

As cases mount up in multiple jurisdictions, and they are, there will be a groundswell, and every effort contributes to this outcome.

Mexico banning junk food in schools

WHILE Donald Trump was causing a stir by donning a McDonald's uniform for the cameras and making some fries in October, Mexico's new Secretary of Public Education, Mario Delgado, announced the launch of a new nationwide program that is unlikely to be replicated north of the border any time soon.

The goal of the programme, titled 'Vida Saludable' (Healthy Life), is to improve the nutrition and overall health of Mexican schoolchildren amid an epidemic of child obesity and diabetes.

The programme, enacted by the now-former AMLO administration on September 29, has four main pillars: prevent the sale of ultra-processed food and sugary drinks in school settings; promote the consumption of natural drinking water

through the provision of water fountains; train educators in healthy nutrition; and promote sports and physical activity. The Claudia Sheinbaum government, still in its maiden month in office, has said it will also train the heads of school cooperatives to sell fruits, vegetables and seasonal foods.

'Vida Saludable' will become mandatory for all state schools at all levels of the national education system on March 29. Schools will have just six months to stop selling all foods and drinks that have at least one health warning label, or their administrators could face steep fines.

Of course, many children bring food from home, but the government says it has no intention of sanctioning parents who put junk food in their children's lunchboxes. Instead, it will focus on explaining the harmful effects of these foods and the importance of eating a balanced diet.

Implementing 'Vida Saludable' is likely to

be difficult, however. At most of Mexico's 255,000 public schools, free drinking water is not available to students. Since 2020, only 4 per cent of them have managed to install drinking fountains.

There are also doubts about how the government will enforce the ban on the pavements outside schools, where vendors set up stalls of goods to sell to kids at breaktime. This being Mexico, one can expect a lively black market in *comida chata* [junk food] to spring up in many schools. Enterprising students will no doubt get rich.

Nonetheless, drastic steps are necessary to combat Mexico's soaring levels of child obesity and diabetes. An estimated 5.7 million Mexican children between the ages of 5 and 11, and 10.4 million adolescents between the ages of 12 and 19 are overweight or obese. In addition, an estimated 7 out of 10 schoolchildren and 5 out of 10 adolescents are physically

inactive, which further aggravates the country's public health crisis.

Mexico's secretary of education blames these trends on the high consumption of sugars, the lack of physical activity and the food policies of previous governments, driven primarily by the profit-maximising needs of the food industry:

"In the neoliberal era they were not concerned about this situation — on the contrary, the sale of these products was promoted and there were even campaigns against hunger promoted by the companies that produce these junk foods. The neoliberal model turned rights such as education, health and food into merchandise."

Water fluoridation poses ‘unreasonable risk’

Landmark U.S. court ruling enforces health watchdog to act

THE ruling requires the EPA to take regulatory action to eliminate the risk, in a decision that could end the use of water fluoridation chemicals throughout the U.S.

After a seven-year legal battle in the federal court, an historic ruling has ordered the U.S. Environmental Protection Agency to take regulatory action to eliminate the ‘unreasonable risk’ to children’s health posed by water fluoridation.

The United States District Court of the Northern District of California verdict is a significant loss for the EPA and the promoters of fluoridation like the American Dental Association and the U.S. Centers For Disease Control.

The court found that their claims of safety – made for over 75 years – were in fact not supported by evidence.

Senior Judge Edward Chen wrote: ‘the Court finds that fluoridation of water at 0.7 milligrams per litre – the level presently considered ‘optimal’ in the United States –



poses an unreasonable risk of reduced IQ in children.

‘The Court finds there is an unreasonable risk of such injury, a risk sufficient to require the EPA to engage with a regulatory response.

‘In all, there is substantial and scientifically credible

evidence establishing that fluoride poses a risk to human health; it is associated with a reduction in the IQ of children and is hazardous at dosages that are far too close to fluoride levels in the drinking water of the United States.

‘Reduced IQ poses serious harm. Studies have linked IQ decrements of even one or two points to, e.g., reduced educational attainment, employment status, productivity, and earned wages.’

The ruling did not specify exactly what measures must be adopted by the EPA, but under the Toxic Substances Control Act (TSCA), once the court rules that a chemical poses an unreasonable risk, the EPA is obligated by law to restrict or eliminate the risk.

Judge Chen described a range of options for regulating fluoridation, including banning it, but he warned: ‘One thing the EPA cannot do, however, in the face of this court’s finding, is to ignore that risk.’

The Fluoride Action Network’s attorney, Michael Connett, said: “The court has done what EPA has long refused to do - applied EPA’s risk assessment framework to fluoride.

“It’s an historic decision. And, as we await EPA’s rulemaking proceeding, policymakers would be well advised to ask, ‘Should we really be adding a neurotoxicant to our drinking water?’”

El Salvador issues stark warning

UN speech highlights globalist attack on freedoms in the West

El Salvador’s President, Nayib Bukele, recently told an audience at the 79th session of the United Nations’ (UN) General Assembly in New York that western societies are eroding their freedoms at a rapid rate, and warned of darker times ahead for the world.

In a wide-ranging impassioned speech on September 24, President Bukele proudly highlighted the rebirth of a safe and prosperous El Salvador, while cautioning against the rise of globalism “moving towards a scary infection point”, especially in freedom of speech, private property and overall security.

He told the 193 delegates: “I come here as the president of a country that now has a voice in the world. For decades we were in chains due to an imported civil war and then a false peace that left behind more dead than war itself, but over the past five years El Salvador has been born again.”

In a swipe at western nations and specifically the U.S., the popular president told the General Assembly: “Today, the free world is no longer free. This is not an exaggeration. Tragically, there is undeniable proof of this decline every day. When the free world indeed became free, it was thanks to its principles of freedom of expression, equality under the law, unity, and respect for private property. But now nations abandon the principles that make them free, it’s only a matter of time before they lose all their liberties completely.”

In a stark reality check, he told the UN that: “You cannot claim the title of leader of the free world if your people are not free to walk the streets without fear of being accosted, robbed or murdered. We are also bearing witness in real time to the erosion of freedom of expression. It’s been barely a decade since the West was the bastion of freedom of expression. And now it is lectured to by those who used to speak out. The largest social media platforms in the world are forced to censor its users at the petition of its governments.”

Bukele warned the General Assembly asserting that “As Salvadorans, we recognise these symptoms of the decline when we see them. Because we have experienced all of them. We lived these stages of the fall of our nation, one by one. And we are seeing all these stages once again, but this time on a global stage.”

However, he advised the delegates that “it’s not too late to build a bridge to escape the storm.”

Bukele told the delegates that as president, he will continue to protect his citizens’ fundamental rights and freedom of expression. “In El Salvador, we do not imprison our opposition nor censor opinions. We do not confiscate

property from those who think differently. We do not arrest people for expressing their ideas. In El Salvador, your freedom of expression, as well as your private property, will always be protected.”

Bukele has transformed the Central American country once known as the murder capital of the world to now one of the safest and prosperous countries in the region in less than five years. Bukele told the UN: “In El Salvador, we prioritise the safety of our honest citizens over the comfort of the criminals. Some say we have jailed thousands. But the reality is we have liberated millions. Now it’s good people that live free, without fear, with their freedoms and human rights respected.”

First elected as President in 2019, Bukele launched a tough stance on organised crime in an innovative and brave six-phase ‘Territorial Control Plan’ to reclaim territories from drug gangs such as MS-13 that once ruled with impunity in crimes of extortion and murder. His hard stance on crime has now seen over 75,000 gangland members arrested, resulting in a significant reduction in crime across the country. In February, Bukele secured a second term as President by romping home with 84 per cent of the vote.

In an interview with Tucker Carlson in June, Bukele spoke about how the country took back control from dangerous criminals in less than five years. He told Carlson: “The phases included building up the police forces and the army. We doubled the army to fight crime. And we equipped them like soldiers. We rolled up into their faces and then went after them.”

The charismatic leader concluded his speech at the UN General Assembly by saying “May God bless humanity.”

Reiner Fuellmich political prisoner

A report about prison conditions in his own words from *BAM!*

A REPORT by Dr. Reiner Fuellmich about his prison conditions in the Göttingen high-security prison in Rosdorf, in response to the author Kerstin Heusinger, German correspondent for the French-language online publication *BAM!*

7:00 a.m., court date for civil rights' activist and lawyer Dr. Reiner Fuellmich:

Heavily armed officers with pistols and submachine guns, equipped with bulletproof vests, receive me. They try to convince me to put on a bulletproof vest, which I consistently refuse. They then make me sign a waiver that releases them from liability if I am injured or killed by gunfire.

One of the officers searches my body and then, as always, forces me to kneel on a stool while he puts shackles on my legs.

He ties a wide leather belt around my waist and then puts handcuffs on me that are attached to the belt with chains, which in turn are secured with a large padlock.

The shackles force me to take very small steps, which makes it difficult to get in and out of the transport vehicle. If I were to stumble while shackled like this, I would not be able to break my fall and would probably break my wrists.

Prison officials told me they had never seen a defendant held in pre-trial detention for more than 11 months for a minor offence (rather than a serious crime or an act of terrorism), kept in solitary confinement and, most importantly, brought to court with his hands and feet shackled.

In court I was taken to the basement, to a tiled cell with a simple wooden bench, the basement is cynically called 'the cellar'. Another body search. Then I have to wait until I am led into the courtroom in handcuffs. Every time the trial is interrupted I am handcuffed again and taken back to the cellar.

Every time I returned from court, I was completely undressed in a transit room so that a thorough body search could be carried out.

Harassment, humiliation, punishment

Mr. D., the deputy director in charge of pre-trial detention, ordered my complete isolation on the grounds that my providing legal advice to other prisoners could incite them to revolt.

Rosdorf Prison is divided into two sections: criminal detention (400 inmates) and pre-trial detention (80 inmates), where I have been held since October 13, 2023.

Pre-trial detainees are distributed across 4 levels. Those deemed particularly dangerous or at risk are isolated on Level Ao, where security is increased and additional restrictions are imposed. I was placed there.

Like the other inmates on Level Ao, I am strictly forbidden from speaking to any other inmate.

For 11 months I have had no internet access, no computer and no cell phone. I am only allowed to watch TV. My only contact with the outside world is my lawyer and the 3 hours per month for visits or phone calls with my family. Yes, a total of 3 hours per month.

My isolation goes so far that even my daily walk in the yard

must be done alone. This hour-long walk is suspended if I am caught communicating with another inmate, even if it is just a hand gesture. Yes, if I exchange a greeting with a fellow inmate through the bars of a window, even if I only nod my head - he and I are immediately punished.

All disciplinary measures are imposed without giving reasons and without the possibility of appeal.

Everyone is guilty!

The treatment of pre-trial detainees is particularly bad and borders on torture. Mr. D., who manages pre-trial detention and also works as a social worker, makes no secret of his convictions: he believes that if you are in pre-trial detention, you are guilty.

His disregard for the presumption of innocence is the main reason for my placement in solitary confinement.

He committed serious and deliberate breaches of duty, which I witnessed. These breaches were covered up by the prison administration. With two exceptions, the security officers carry out the orders they receive without compunction, like robots.

On August 8, 2024, I asked to speak to the deputy director of the prison. I informed her that while I was away for court hearings, personal items and documents had disappeared from my cell. Cells are normally searched regularly according to strict rules. These thefts occurred outside of official inspections, which are recorded.

Persecution: Dr. Reiner Fuellmich refers to the Redzep case

The full seriousness of the situation is shown by the attacks on a remand prisoner, Kevin Redzep, who was seriously injured. He has given me permission to publish his name and his story. He is from Montenegro and although he is intelligent and speaks several languages, he cannot write or read German fluently. He was placed in a section where there were several violent prisoners or those accused of premeditated murder. He was called a gypsy by his fellow prisoners, threatened and asked for help from Mr. D., who refused to take him to the vulnerable prisoners. The next day, Kevin Redzep was attacked by three fellow prisoners while out walking. He was hit in the head with a glass bottle so badly that the cheekbone above his left eye was crushed and his eyesight was at risk.

On July 9, 2024, Kevin Redzep had to undergo surgery before returning to Rosdorf prison, even before he had recovered. Another physical altercation ensued with five or six prison officers, who threw him to the ground and injured his head again. Mr. D. then ordered the isolation of Kevin Redzep, who was already severely traumatized.

Kevin Redzep, who wanted to sue Mr. D., the prison and

the state of Lower Saxony for personal injury, asked me for help. When Mr. D. learned that I had advised this prisoner and provided him with a lawyer, Kevin Redzep disappeared. It is assumed that he was transferred to another prison. Since then, Attorney Wörmer, my lawyer, has been trying in vain to find him, hoping that he is still alive.

Glimmer of hope

Despite the disciplinary punishments they face, the prisoners show their solidarity with me. They encourage me. For example, they tell me: "Don't give up, keep going."

Some prison officials have seen through the pandemic hoax and know that my trial is a sham justice staged by the secret services. They let me know this and wish me a good outcome.

What helps me most is the enormous support from the international public. I receive a large number of letters that are no longer even read by the prison administration. I read all of them and am infinitely touched by the affection they show. I try to respond as best I can.

Sometimes I see the vigils and the people greeting me as I sit in the transport vehicle to court. I feel a remarkably strong connection with all those who support me. It is this connection that allows us to overcome adversity together.

I have to go to the medical service twice a week to be examined because I refused to have blood drawn. I argued that any medical procedure, especially any invasive medical procedure, is a violation of physical integrity if the patient does not give his or her consent voluntarily. I am therefore examined regularly because a prisoner suffering from tuberculosis could potentially have infected people with whom he or she came into contact.

One of the prison doctors expressed his sympathy for my work. He also explained to me that the medical staff believes that the health of many prisoners is incompatible with imprisonment, but the prison administration prefers to ignore this fact.

Having personally seen what happens in pre-trial detention – the suspension of the defendants' fundamental rights and their difficulties in gaining access to a defence that genuinely cares about their fate – I am convinced that prisons only benefit those who profit from them, with pre-trial detention being even more lucrative than post-trial detention.

I have not met any defendants whom I would describe as evil. I have met many, many prisoners on remand who seem innocent to me, or who, above all, need therapeutic treatment, as one prison doctor admitted.

If we didn't need some more prisons for some sociopaths, for example those responsible for the pandemic, the wars, the massacres like in Gaza and the corrupt of the system, I would be in favour of abolishing prisons.

One thing is very clear. 'They' aim to shame and break Reiner. The shame is all theirs, for subjecting Reiner to this abuse. And instead of breaking down, he is speaking out.

Horrific reality of ‘mental health’ illness

Research on sufferers of disease uncovers fibrous nanotech

ACCORDING to Wikipedia, ‘Morgellons is the informal name of a self-diagnosed, scientifically unsubstantiated skin condition in which individuals have sores that they believe contain fibrous material.

Morgellons is ‘not well understood’ by allopathic medicine, Wikipedia claims, but the general medical consensus is that it is a form of delusional parasitosis, on the psychiatric spectrum.

Despite Wikipedia stating that Morgellons is not well understood, leading independent researchers, such as Clifford E. Carnicom, and world-renowned scientists, such as Harald Kautz, have conducted over thirty years of research into this topic.

Their findings point to Morgellons’ fibres starting off as a fungi, which transforms into a cross-domain bacteria with self-assembling capabilities. It is made from plasmonic fibres (mycelium) and hexagonal plasmonic photonic crystals (spore-containing organs) of an unknown species.

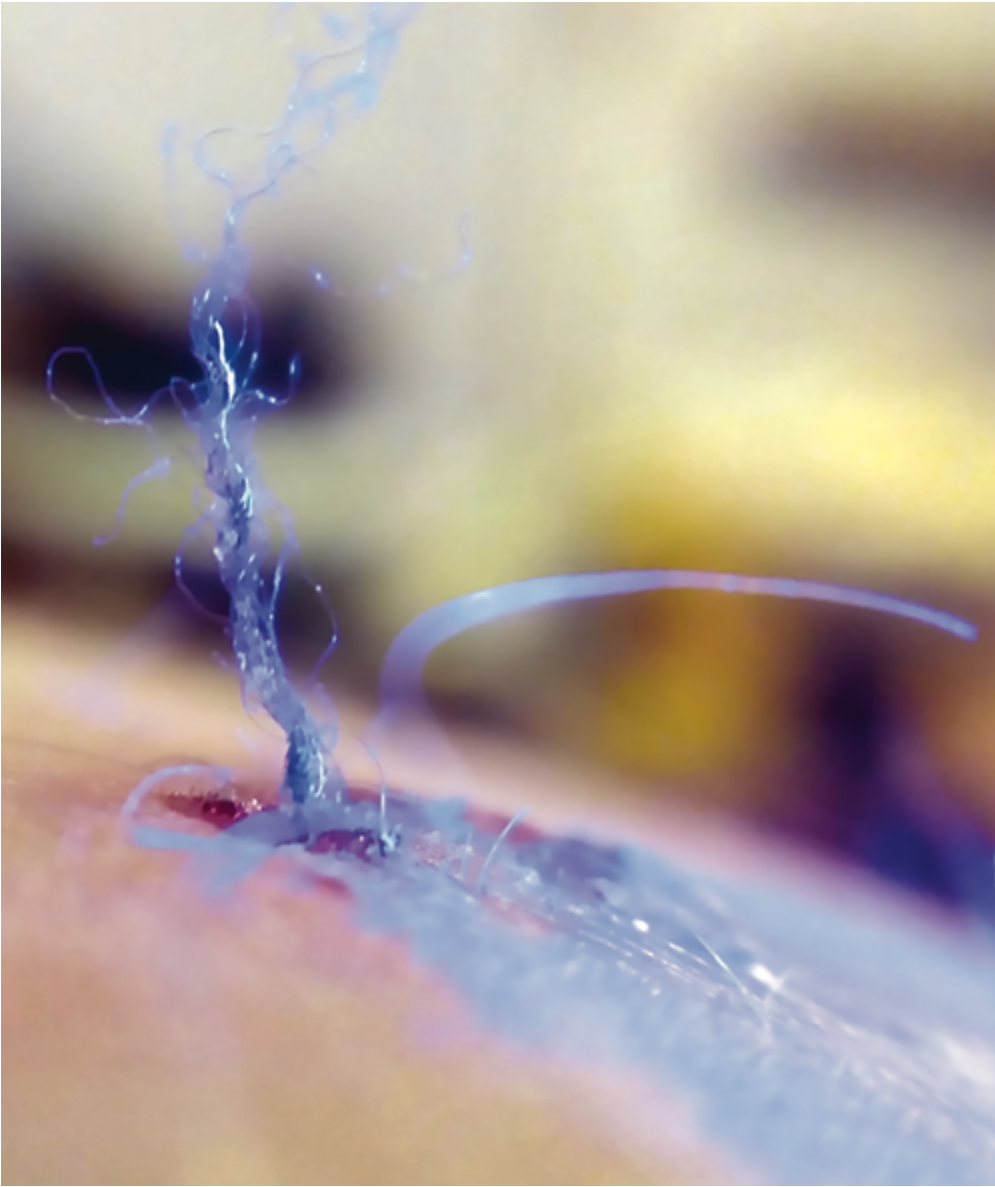
Morgellons’ fibres are easy to detect as they are often brightly coloured red or blue. Their unique colours have been clinically and chemically analysed and are due to the absorption of quantum dot dyes.

Quantum dots were first synthesised back in the early 1980s by Louis Brus and Bell Labs (now known as Nokia Bell Labs). Nokia Bell lab’s researcher, Louis Brus, was awarded the 2023 Nobel Prize in chemistry for his work in quantum dot technology, alongside two other scientists, Alexi Ekimov and Mounji Bawendi.

Quantum dots are man-made and classed as electronic devices in the form of nanocrystals. Due to their nano-size, their behaviour follows the rules of quantum physics. Quantum dots are commonly used in solar panels to convert sunlight into electricity and are also used to illuminate computer monitors (QLED) and LED lamps.

The first lab to commercialise quantum dots was the Center for Nanophotonics at the Fraunhofer Institute for Applied Polymer Research (Fraunhofer IAP) in Berlin. Fraunhofer IAP has been at the forefront of research in nanotechnology and photonics, and their work includes the synthesis of quantum dots and the development of various applications, such as in optoelectronics, bioimaging, and sensors.

In the medical field, quantum dot

technology will be used for diagnostic technology, gene-editing, and remote drug-delivery.

Quantum dot technologies are semiconductor nanocrystals that have unique optical and electronic properties which enable their use in upconversion and downconversion processes. This means they have two-way wireless communication capabilities, serving as nano transceiver antennas for microwave/ biophoton communication by using light frequencies that are detectable through satellites and ground stations.

In June 2015, Harald Kautz gave a presentation to the Bases Project YouTube channel. In his presentation, he estimated that 99 per cent of the population in Europe has been infected with Morgellons, due to the mass aerosol spraying from geoengineering projects.

Kautz said the dominant red and blue colours we see in the Morgellons fibres can affect human personality. The red quantum dots are able to control sexuality,

blue quantum dots control mental function and they work together as a read/ write unit.

The Morgellons’ self-replicating hollow fibres can read the light frequency of our DNA and transform it into an EM (Electromagnetic) signal that could be detectable via satellites and ground stations.

The hollow fibres of the Morgellons can also insert a radio frequency into a living entity to change its behaviour and biometrics.

But you can only shoot so many messengers. And shining a light on bad behaviour helps it to stop. We need to be brave and honest and up-standing. And if we don't do it in the truth movement, then who will?

Would you want to go to metaphorical war with someone who lacks morality, integrity and courage? Would you trust someone like this?

So, I say – be brave – call out this bad behaviour when you see it. Get involved. Don't turn a blind eye. We need to make it clear what behaviour we will allow. Not sit back and allow toxic nonsense.

Instead, let's end this toxicity. Let's finally demand integrity, courage, moral fortitude and the honest truth in the truth movement. It's about time.

Then maybe we will make real progress. All those microcosms make up one big macrocosm.

Some people have no idea what they're doing, and a lot of them are really good at it.

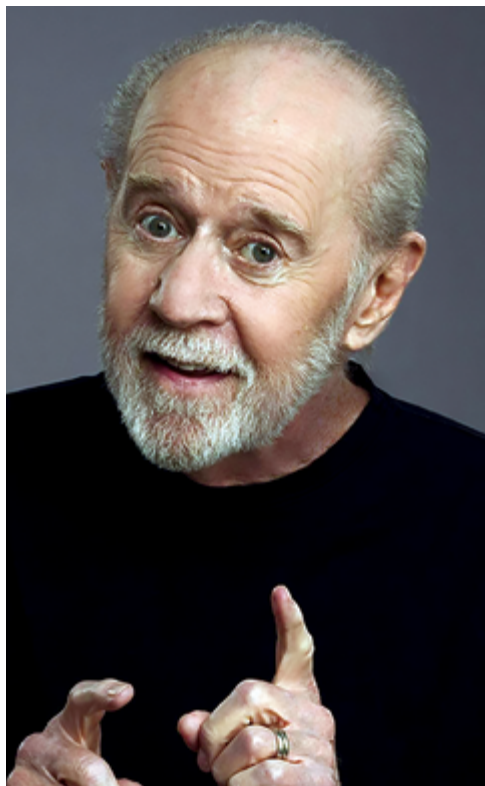
The news media are not independent; they are a sort of bulletin board and public relations firm for the ruling class – the people who run things.

Sinking of the Wilhelm Gustloff

War crime
leads to
loss of life
SIX times
worse than
Titanic

On January 30, 1945, with the brutal, rampaging Red Army rapidly bearing down on them, the German civilians of East Prussia, desperate to escape, fled to the Baltic ports hoping to be evacuated by sea. Many of those caught in the maelstrom of the Soviet advance had already been raped, murdered or both.

The Wilhelm Gustloff – A Luxury Cruise Liner
The cruise ship, Wilhelm Gustloff, along with many other serviceable ships, was pressed into service to aid the evacuation of German civilians from the Eastern zone. With forty-eight hours' notice before departure, there were scenes of chaos and blind panic in the frozen German port of Gotenhafen as people, frantic for a place, fought on the dock and surged aboard the ship. Wilhelm Gustloff, weighing 25,000 tons and almost 700 feet in length, was an impressive sight, and could carry almost 2,000 passengers and crew. Launched in 1937, it began its life as a luxury cruise liner for the German workers of Hitler's Third Reich. For

the first year of the war she had served as a hospital ship before being held in dock in the port of Gotenhafen on the Baltic coast where, until early 1945, it had served as barracks for U-boat trainees.

Appalling Weather Conditions
When the Gustloff left the relative protection of the harbour at Gotenhafen on January 30, 1945, the weather was extremely poor with a wind strength of 7, it was snowing, the temperature was minus 10 degrees Celsius, and there were copious amounts of sea-ice. In short, the chances of human survival in water in those conditions were zero, with or without a life-preserver. Once underway, the Wilhelm Gustloff began to battle its way through the choppy, blustery Baltic Sea, un-escorted and with

its only protection being the few anti-aircraft guns it had on-board. However, against a submarine attack the Gustloff was powerless.

Passenger Numbers
According to the ship's own records, the list of passengers on January 30 included 918 Naval officers and men, 173 crew, 373 members of the Woman's Naval Auxiliary units, 162 wounded, and 4424 refugees, an 'official' total of 6,050 people. This however fails to take into account the several thousands of other people that, one way or another, were able to make their way onto the seemingly safe haven of the Gustloff. In fact, research has now shown that the total number of people on the Gustloff at the time was actually 10,582 souls (40% of whom were children). In their blind

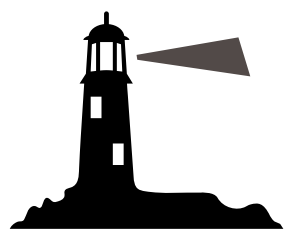
panic, they had crammed themselves onto a ship designed for less than 2,000 passengers.

The Soviets Attack
As Wilhelm Gustloff steamed slowly to the west, the captain of the Soviet submarine S-13, Aleksandr Marinesko, shadowed it, then, at 9.16pm, fired a spread of four torpedoes. Three of them hit home, striking Wilhelm Gustloff on the bow, stern, and amidships. She immediately listed to starboard, righted herself, and then listed once again, launched rescue flares and broadcast an SOS message. The tightly-packed ship was soon a scene of horror, with explosions, fires, children blown overboard, passengers slipping and sliding on the icy deck, and tumbling into the sea. No help was

at hand. Indeed, most of the ship's actual crew was trapped in the forecastle, behind watertight doors that had locked automatically upon impact. Less than 50 minutes later she was gone, sunk beneath the icy black waters of the Baltic, along with 9,343 men, women and children. Amazingly, 1,239 people were saved by the heroic and selfless work of a number of smaller German ships in the area but the losses were more than six-times greater than those of the Titanic. When the Gustloff sank, it was an event unlike any in naval history, if for no other reason, because of the sheer scale of the tragedy. Many ships have sunk with terrible loss of life, but never before or since have so many lives been lost on a single ship. As with all maritime tragedies, the scene was one

of absolute and complete horror. The suffering of those on board the Gustloff was unspeakable and whether these people were 'enemies' or not is irrelevant, they were fellow human beings, the vast majority of them 'innocents', i.e., women, children and non-combatants. It was such an horrific loss of human life, and one which has to date never been reported in the mainstream media. Indeed, Marinesko deserves the epithet 'war criminal' more than many other recipients of that label. He knew very well that the Gustloff was an innocent refugee ship and this in my view typifies the disgraceful, inhumanity shown by the Soviets as a nation, despite their being portrayed as the 'good guys' by the cabal-controlled media. Significantly, Marinesko was awarded the honour of 'Hero of the Soviet Union' for the 'heroic' act of murdering some 4000+ innocent children in cold blood and condemning them to an horrific death. The sinking of the Wilhelm Gustloff is in fact the greatest maritime disaster in history. So why is hardly anyone aware of it? This is of course a rhetorical question and the answer is obvious as anything that hints at sympathy for Germans or paints its adversaries in a bad light, is always 'brushed under the carpet', while anything to the opposite of that is constantly promoted and presented in a positive light by the totally compliant media.

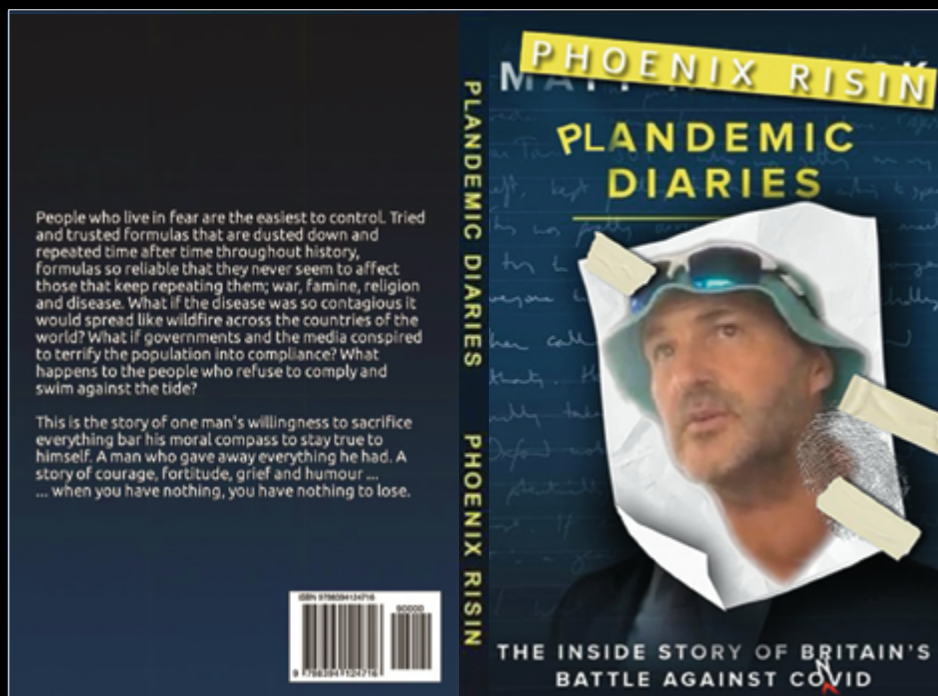

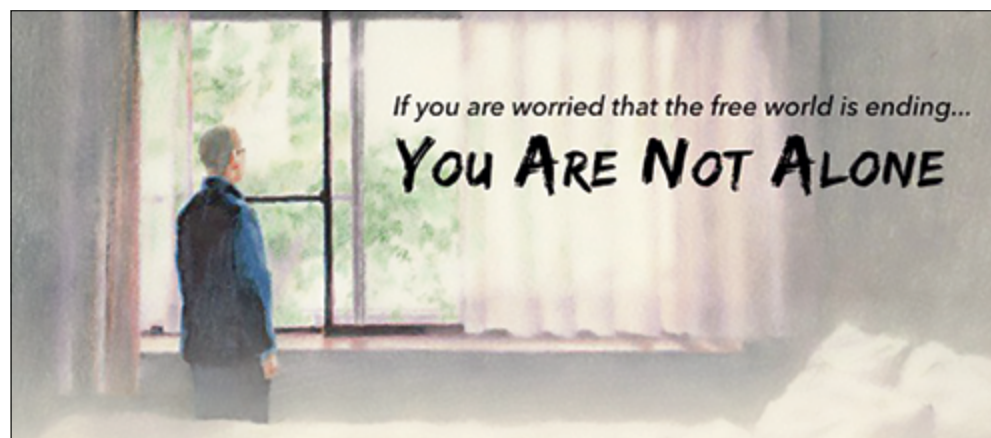
