Attack on farmers and food supply affects us all

THE revelation that Arla Foods, a dairy supplier to all major supermarkets, has been trialling Bovaer to 'reduce methane emissions' in cows is probably the final sign you need to change your shopping habits.

Inheritance tax is war on food

Farmers squeezed out so mega-corps can take over

THE British government's inheritance tax reforms aren't about class warfare or filling the black hole in the country's budget, they are about taking vital land off small and medium-sized family farms and handing it to mega-corporations.

It's yet another piece of the Great Reset agenda; specifically, the war on food.

Since 1984, working farms have been completely exempt from paying inheritance tax under the agricultural property relief (APR) system.

The justification for this was that working farms are needed to produce the food we all eat, and since British farming families are generally asset-rich but cash-poor, charging inheritance tax on farmland might negatively impact farm output. But Keir Starmer's government has announced that, as of April 2026, they are scrapping the APR scheme.

This means anyone inheriting a working farm will now have to pay up to 20 per cent of the value of the assets in tax, and since farmers operate on fine margins that will likely mean selling off parcels of land to raise money. Some farmers may be forced to sell all the land at once, since piecemeal buyers may be hard to find.

As you can imagine, the farmers are not happy about this. Nor is anyone who understands the potential implications.

This is being billed in the press as old-fashioned left vs right politics; the narrative is that the country needs revenue and that greedy hoarding farmers aren't paying their fair share.

But, in my view, this is a lie, or at best, a distortion. A noisy public debate that obfuscates the real intention of the policy. I don't think this has anything to do with raising taxes. I think this is about the land.

They know this policy will force medium-sized family-run farms to sell – in fact, they are banking on it.

As usual, it is the journalists and twitterati carrying the bag for tyranny, making bitter, snarky social media posts about millionaire farmers or rambling on about farmers deserving to lose their business because they voted for Brexit.

Just as with covid and climate change, the powers-that-shouldn't-be are safely relying on the educated middle class to not understand anything at all about the way the world really works.

I imagine the self-labelled leftists think the sold-off farmland is going to be snatched up by the state and run for the common good or something equally delusional.

In his article, Hutton even argues this will energise young farmers. He writes: 'Young farmers, now increasingly crowded out of the market, will get a chance to buy land: there is the prospect of a levelling off, even a fall, in farm rents. New life and ideas will be brought to the rural economy as innovative, energetic farmers enter the market – and production even increases.'

As if the country is full of aspiring independent farmers with nothing but a hoe, a dream and a few million pounds to spend on land.

It is a fantasy.

Common sense tells you any land farmers are forced to sell will be bought up by corporate giants who can afford to pay over market price. We've seen the same thing with the housing market in the U.S.

Big Farmer conglomerates that want to plant green deserts of monocultures for making vegan protein alternatives because meat and dairy are bad for the environment. And that's very much the best-case scenario. At least that's still food production, of a sort.

Alternatively, it will be bought up by energy suppliers who then lease the land at extortionate rates back to local councils to build solar plantations and/or wind turbines that don't work in the name of 'saving the planet'.

Or maybe it will be bought by climate-friendly NGOs or billionaire philanthropists who accept massive grants from the government to conserve the environment by just letting prime farmland lie fallow.

We know all this happens; they've been doing it for years.

The British government started paying lump sums to farmers who wanted to leave the industry in 2022.

Farmers were served compulsory purchase orders to make space to build high-speed rail links.

The Environmental Land Management scheme pays farmers to 'rewild' fields. Farmland is being flooded to create salt marshes, earmarked for cultivated forests and solar panels in the name of combatting (entirely imaginary) climate change.

This isn't just a British issue. It is a worldwide one.

In 2023, the EU reformed its Common Agricultural Policy to award subsidies based on sustainability rather than productivity; at the same time, they are securing trade deals with South America to import food rather than grow their own (French farmers are protesting this). Denmark is going to rewild 15 per cent of its farmable land to lower fertiliser usage. Like the UK, the U.S. has both federal and state programmes that pay farmers not to farm.

It goes on and on. It's a simple system:

- Make small or medium-sized farms financially non-viable
- Force families to sell their land
- Have mega-corps buy it up

In short, the endgame is total corporate control over the land and the food supply. The inheritance tax changes are just the UK government adding more pressure on farmers to accelerate this process.

Once that goal is achieved, they take the narrative anywhere they want it to go. They can engineer food shortages and price increases, then they can say those shortages show how badly we need food reform, and start instituting climate-friendly rationing and meat bans and forcing people to eat bugs and lab-grown goo.

They've got the land, they've got the food, so they can say – and do – whatever they want.

All the while, food prices will rise, family farms and organic products will begin to disappear, and idiotic self-styled communists on Twitter will smile smugly and think they won one for the little guy.

The farmers had a large protest on November 19, with over 25,000 showing up to flood central London and take the message to the government.

Their rallying cry was 'No Farmers, No Food!' Unfortunately for them, that is very much the point.

My sister ‘murdered by medics’

Heartbreaking account of midazolam death in hospital

Jacqui Deevoy speaks to Jane Roche, 54, from the West Midlands, about her sister’s last days in hospital

MY precious sister, Jocelyn Pettit, was 54 when her life was so cruelly ripped away from her.

On April 4, 2020, my dad died in hospital. It was 5am when he died. When I got home at around 7.30am, I numbly texted Jocelyn’s partner, John, to tell him to let my sister know our dad had died. I couldn’t phone her as she was partially deaf and I didn’t want to text her with such devastating news.

Within five minutes, John called me to say he was in A&E with Jocelyn. She’d had a cough for a couple of days but John said that when he’d tried to wake her that morning, she was really groggy and not her usual self. He’d been so worried, he’d called an ambulance.

He called me again at about 10am, saying that the doctors said she was ‘doing well and responding to treatment’.

Two hours later, my niece, Katie (Jocelyn’s 22-year-old daughter, who was six weeks off having her first baby) called me, crying hysterically, to say someone had phoned from the hospital and said her mum wouldn’t last the day. They told Katie and her 31-year-old brother, Sam, to go to the hospital. I told them I wanted to go too, and to ask the doctor if that was possible. Despite it being during the first lockdown, the doctor said I could visit.

When I got there, I joined John, Sam and Katie in a side room off AMU, the acute medical unit. We went one at a time onto the covid ward, where they’d put her, even though she hadn’t been tested.

With Dad, I could see he was dying - he looked dead but was gasping like a dog that had run a hundred miles. A horrific sight that is imprinted in my mind forever. Jocelyn looked different – peaceful, like she was sleeping. I presumed she’d been given a sedative, but didn’t ask.

The nurse said my sister had kidney failure. I asked what had caused that as she hadn’t had it previously, and the nurse said ‘dehydration’. This puzzled me. Jocelyn had been perfectly healthy apart from a slight cough, but now she was suffering kidney failure. It didn’t make sense.

I left after about an hour and, as I got round the corner from the hospital, my nephew, Sam called, excitedly telling me his mum was wide awake and saying she wanted to go home. He also said she was trying to get out of bed. This was fantastic news – Jocelyn was fine – and I felt so relieved.

At about 8pm, however, I received a phone call from John. He said when the staff had pushed her bed through the doors from AMU to a ward, they shut the doors on him, telling him he couldn’t stay with her and to go home.

I couldn’t sleep that night as I was so worried about Jocelyn, and I rang the hospital first thing the next morning. The ward sister said she could only agree to a one-hour visit per day and that the visitor had to be the same

person, and we agreed it would be John.

This carried on for the next few days and, each day, we rang the ward four times to check on Jocelyn, only to be told that she was ‘very ill and won’t last the night’. They’d said this from the day she was admitted on April 4, but she kept proving them wrong. I was starting to get suspicious.

On the evening of April 8, at about 6pm, Katie called. She was crying and saying that the doctor from the hospital called her about ‘end-of-life care’ for Jocelyn. I called the hospital immediately.

“I want to speak to my sister’s consultant now,” I demanded.

They got him on the line eventually and I asked him why Jocelyn was being put on end-of-life care without any consultation with her family.

He replied, “Because she isn’t going to last the night.”

“I’ve been told that every day since she was admitted,” I said, frustrated now. “We, as Jocelyn’s family, are not happy with what you are telling us.”

The harsh ringing of my phone jolted me awake at 3.30am. It was John, calling to tell me that my beautiful sister had

died. I cried out in horror. My sister was dead and had died alone with no family to hold her hand and tell her how much she meant to us.

A month later, I contacted the hospital and demanded to see my sister’s medical notes. They were horrific. I cried for a week after reading them. What I read was far worse than I could have ever imagined.

Jocelyn was given midazolam and morphine on the day she was admitted and every day after that, until she finally succumbed to the life-ending drugs they were pumping into her.

I now know that this was due to the combined effect of the benzodiazepine midazolam and the opioid morphine. No wonder they were telling us that she wasn’t going to last the night. They were trying to drug her to death but my sister, not being anywhere near the end of her life, was fighting back – my precious sister fought hard, but she fought alone and eventually lost the battle. I wasn’t there when she needed me most and I feel so guilty about that.

Rest in peace, my darling sister Jocelyn. Taken too soon. Taken for good. Murdered by medics. I will fight for justice for you forever.

Net Zero insanity into law

Alert your MP to dangers of Climate and Nature Bill

A PARLIAMENTARY bill is set to write Extinction Rebellion and Just Stop Oil-type extreme Net Zero demands into UK law.

Supporters of the Climate and Nature (CAN) Bill are claiming that ‘the people have spoken and now everyone needs to act’. They are claiming a public mandate when none exists.

The CAN Bill’s climate targets are so unrealistic, unachievable and unscientific that it equates to King Canute-like absurdity. Yet it is on track to become UK law, and next to no one knows about it.

Nature Bill will lock the science into law.”

So MPs don’t need to assess the science and hear all views, but have just one side of the debate around climate change presented to them.

This is contrary to the Nolan Principles of Public Life that bind MPs to avoid such bias and predetermination in public affairs.

There is also bias and predetermination by omission in the ‘science’ around nature recovery.

For example, a study by the National Oceanic and Atmospheric Administration, part of the U.S. Department of Commerce,

reports that human-caused CO₂ has resulted in significant re-greening, and is starting to rectify the current depleted CO₂ levels which are far below optimum for nature and plant growth.

The Climate and Nature Private Members’ Bill (and anything like it) must be challenged by us all and with utmost vigour.

Policies that the CAN Bill aims to make UK Law

- The Secretary of State for Energy Security and Net Zero must achieve the objective – to ensure that the UK reduces its overall contribution to global greenhouse gas emissions to Net Zero.
- The strategy must include financial support and retraining for people whose livelihoods and jobs will be affected by the proposed measures – including those measures that require transitioning out of industries characterised by high emissions and high impacts on ecosystems.
- Ensuring the end of the exploration, extraction, export and import of cheap, natural fuels (oil, coal and gas) by the United Kingdom as rapidly as possible.
- The Secretary of State must, within three months of the passing of this Act, procure, by open tender, an expert independent body to establish a Climate and Nature Assembly comprising a representative sample of the United Kingdom population.
- The Assembly must consider relevant expert advice and publish its recommendations for measures to be included in the strategy.
- But who defines ‘relevant expert advice’? Will it be independent if MPs are being told what to think by selected ‘experts’? This is simply a case of them marking their own homework and rubber-stamping their own plans, disguised as democracy.
- The Bill will support ‘rewilding’ that reduces farmland, reducing UK food production. Alongside the cutting of natural fuel powered shipping imports, this could potentially cause food shortages, rationing and even starvation.
- With its emphasis on legally binding nature and ecosystems recovery, the CAN Bill could require or facilitate authorities shutting off large areas of countryside, confining us to cities and controlled communities.

Taking a look at the evidence

Analysis of research into Manchester Arena event

FOLLOWING the alleged 2017 Manchester Arena bombing, investigative journalist Richard D. Hall published a book and an accompanying documentary film in 2020.

He proposed the incident to be a staged event – a false flag terrorist attack.

While he used some of the research of other investigators, it was Hall who first put a cohesive and compelling narrative together that challenged the official version of events.

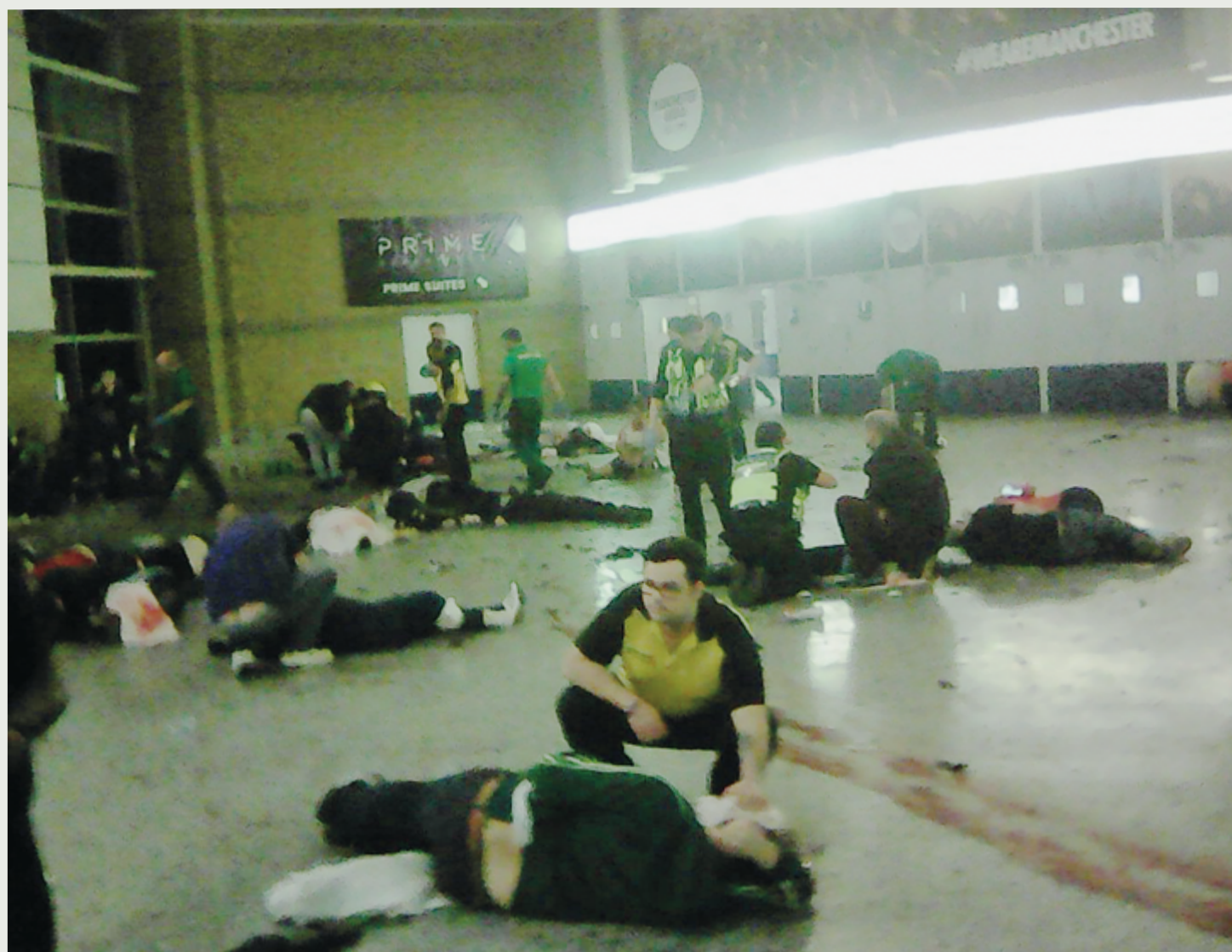
At the conclusion of a civil action brought against Hall last month at the High Court, he was found guilty of the harassment of two people involved in the Manchester Arena incident.

In my opinion, he did not break any journalistic code of ethics and there was never a legitimate basis for the claim made against him. It was accepted in court that Hall's opinions about what happened were sincere.

By analysing specific video evidence that remains in the public domain, it can be argued that Hall proved that this video footage could not have been filmed after the purported time of the bombing and was, therefore, shot before the bomb was said to have detonated. Thus, it can also be argued this is clear evidence of foreknowledge of what played out on May 22, 2017.

Hall also carried out extensive examination of the John Barr footage – a video of the scene shot in the immediate aftermath of the alleged bombing – and it is arguable that he revealed that there was no evidence of any structural damage, nor any injuries consistent with a large triacetone triperoxide (TATP) shrapnel bomb exploding in a crowd. Hall subsequently scrutinised the evidence presented in the official Saunders Inquiry of the Manchester Arena bombing. He argues that the described circumstances of the deaths of some of the deceased victims were false. Hall reported further evidence, including leaked police communications, indicating that Salman Abedi – the alleged suicide bomber – did not kill himself.

Hall contends that, beyond hearsay, there is a serious lack of evidence to support the state's official story of the Manchester

attack. It can be argued that the available, observable, physical evidence currently in the public domain appears to rule out the possibility that there was a bomb in the City Room of the Manchester Arena on that evening.

That there was no bomb can be argued because the statement is supported by all of the primary, observable evidence.

Other evidence may come to light which supports the establishment's story about a bombing. For example, there may be a rational explanation, supportive of the state's account, which explains why there is no observable, physical evidence of any structural damage in the City Room of the Manchester Arena, four minutes after the large TATP shrapnel bomb is said to have exploded in it.

It is up to those who contend that there was a bomb to provide some observable evidence to support their claim. The only

way anyone can do this is to address the evidence reported by Hall.

Remarkably, the High Court blocked that evidence from being addressed in a summary judgement.

A significant number of people are aware of the many unresolved questions that hang over major terror attacks, such as 9/11 in the U.S. and 7/7 in the UK.

Academic research shows that 28 per cent of the British public are sceptical about the official story of the Manchester Arena bombing.

Hall's investigative journalism provides evidence that Manchester was a false flag, in my opinion. The observable, physical evidence that Hall examined, and his reported findings are compelling.

His investigative journalism provides us with a logical analysis of hard, observable, physical evidence.

Some understand how the state, or

elements within the state, use false flag terrorism to manipulate us through the strategy of tension. Others can see the oppressive use of propaganda and deception that the state commonly relies upon to coerce our behaviour, and many people are justifiably concerned about the digital dictatorship and the biosecurity state that is currently being constructed in Britain and elsewhere. Manchester was another in a long history of false flag events designed to terrorise the population and keep defence budgets high, but they are staged by the state. Check the evidence for yourself.

Tackling mainstream science Goliath

Professor Norman Fenton interviewed by Richard House

Richard House [RH]: During covid, you were one of the main go-to academics for covid sceptics who intuitively knew that the so-called science was highly suspect. Tell us about your academic credentials.

Norman Fenton [NF]: I am Professor Emeritus of Risk at Queen Mary University of London (retired as a full professor in 2022), and a director of Agena, a company specialising in AI and Bayesian probabilistic reasoning; a mathematician currently focusing on using probability and statistics to quantify risk and uncertainty. With seven books and over 400 peer-reviewed articles, my research includes law, forensics and health, being highly respected internationally in my research area. In 2020, I began analysing data related to covid risk, showing that the mainstream covid narrative was driven by flawed, easily manipulated statistics. From then onwards, I was treated like an academic pariah.

RH: How soon into the ‘pandemic’ was it before you realised that something didn’t add up?

NF: Pre-covid, I was leading a large interdisciplinary project on chronic health conditions and medical decision-making. Once drawn into looking at covid data and decision-making, I was immediately sceptical of the Chinese scare videos of young people dropping dead, and knew that the wildly pessimistic Imperial College modelling was massively exaggerated. On March 13, 2020, the UK Government’s Advisory Committee on Dangerous Pathogens unanimously decided that covid was not a ‘high consequence infectious disease’. Announced on the government’s website on March 19, incredibly, the next day, the government immediately decided to go for full lockdown, something never tried before.

By April, I, along with colleagues like Martin Neil and Scott McLachlan, were showing (using limited public datasets then available) that covid was nothing like as deadly as claimed, even for old people with genuine symptoms. Fatality rates were like the flu. Even assuming that the PCR test was diagnostically accurate, the increasingly intense narrative of a ‘deadly pandemic’ was clearly being driven by the ridiculous decision to classify anybody dying from any cause within 28 days of a positive PCR as a ‘covid death’. Similarly, anybody testing PCR-positive within 14 days of hospitalisation – for any reason – was classified as a covid hospitalisation, as was anybody testing positive at any time during hospitalisation – even if they were there for another reason.

RH: How have your meticulously argued

critiques been received and responded to by the establishment and your academic colleagues?

NF: Academics like us challenging the official narrative were called conspiracy theorists and spreaders of misinformation. No prominent peer-reviewed journals even considered reviewing our many detailed evidence-and-data-driven papers. Preprint servers, who publish anything that’s not plagiarised or offensive, also rejected our papers, and social media platforms censored and banned us.

This mainstream censorship made it impossible to inform the public of our concerns. Clinical colleagues who were co-authors of papers unrelated to covid demanded that my or their names be removed, refusing any association with me. I was also ‘cancelled’ from giving public talks, even non-covid ones. Professionals like me were generally marginalised, ridiculed, hounded and subjected to demands for dismissal.

RH: Tell us about your new book, written with Professor Martin Neil – *Fighting Goliath*. What key conclusions about the state of science did you reach?

NF: It’s a complete scientific chronological record that challenges almost every aspect of the mainstream covid narrative. We challenge the notion that this was a deadly pandemic from which only lockdowns and the mass rollout of a novel, miraculous vaccine saved us. Our key conclusions:

- The only pandemic-like death peak occurred in March–April 2020 in a few cities. Most of these deaths were likely caused by the response to the ‘pandemic’, not by any alleged virus.

It wasn’t a natural peak. There was a combination of inappropriate ventilator use and end-of-life drugs (e.g. midazolam); bringing forward deaths of elderly in care homes by denying access to family support and contact; denial of antibiotics to patients who died of bacterial pneumonia.

- The vast majority classified as ‘covid deaths’ died of something else. No young people with no existing serious co-morbidities died from covid. Similarly, the vast majority of people hospitalised ‘with’ covid were hospitalised for something else.
- The PCR test was never a reliable diagnostic test. About 90 per cent of the people without symptoms testing PCR-positive never developed serious symptoms and, hence, should never have been counted as covid cases. Yet from late summer 2020, when the first lockdown was eased, millions of asymptomatic people were tested regularly at work or school. The ‘massive second wave’ of autumn/winter 2020–21 was driven entirely by mass testing of healthy people – probably with the intention of frightening people into getting the vaccine once available. Independent data, e.g., from 999 services, show there was no accompanying increase in people ill with covid-like symptoms.
- The mass hysteria in autumn 2021 claiming that almost all people hospitalised with covid were unvaccinated was a lie, based on false data and defining ‘unvaccinated’ as those not ‘fully vaccinated’. The intention was to tackle increasing vaccination hesitancy and force people to get boosted.
- Every major study claiming vaccine efficacy or safety had systemic flaws and biases, such as classifying people testing PCR-positive within 21 days of vaccination as ‘unvaccinated’, and people dying shortly after vaccination as ‘unvaccinated’.
- Adjusting for the flaws and biases, there’s no evidence that the vaccines were effective or saved any lives. But there is evidence that in most age-groups, all-cause mortality in the vaccinated is higher than in the unvaccinated.
- Flu mysteriously vanished in March 2020, before, just as suddenly, re-emerging in late 2022. There’s evidence that many flu cases were classified as covid.

- Lockdowns, social distancing and masks made no difference to the progression of covid cases.
- There’s no evidence that the UK’s track-and-trace programme, costing almost £40 billion before being abandoned, saved a single life.
- If covid was leaked from a lab via gain-of-function research, the research wasn’t very successful if the aim was to create a deadly virus.

RH: What hope is there that the capture of mainstream science can be reversed?

NF: Mainstream science is driven by academia, which is fundamentally corrupt because it’s totally captured by people with extreme leftist, authoritarian views who deny open discussion/dissent. The most prominent and influential specialist academics are essentially political activists over and above their specialist area. Quoting Professor Brett Weinstein, academia is like ‘a rabid dog’; there’s no saving it. The only hope? Donald Trump defunding universities that promote and enforce extreme woke, leftist policies.

In Britain there’s no hope, because even so-called Conservative governments delegated scientific decisions to corrupt leftist academics. It’s going to get even worse under Starmer: even more funding and enforcement for diversity, equity and inclusion (DEI), for AI research dedicated to clever ways to censor ‘non-approved’ speech, and for nonsensical climate-change research.

Glastonbury ‘over-tourism’ fears

Campaign to stop council’s World Heritage Status bid

I AM part of the campaign to stop World Heritage Status (WHS) for Glastonbury. Nearly 1,000 people have signed my petition [Stop World Heritage Status for Glastonbury on change.org](https://change.org) and in a local newspaper.

Somerset Live recently posted an article on November 3 focusing on locals’ fear of World Heritage Status being given to Glastonbury, which would prove extremely detrimental as it has at other sites.

The vision to obtain WHS was published in a Neighbourhood Plan survey, with the goal to become a World Heritage Site by 2040.

The local council has a Green party majority, and apparently the desire to impose World Heritage Status and UNESCO on Glastonbury began with their manifesto stating this as one of their intentions.

Over the past few weeks, I have been discussing this topic both online and offline with locals and visitors, and when they realise what it will mean, it is clear that the majority of Glastonbury residents and guests are totally against it.

Despite this consensus, the council hired two consultants at great cost back in December 2023.

Only a meagre contingent of the local population received the Neighbourhood Plan leaflet asking for their opinion. Just over 6 per cent responded. Further, no environmental or social impact assessments have been carried out.

There was a presentation in Glastonbury Town Hall on October 13, where the consultants presented a glossy brochure and answered questions from the public.

In a Neighbourhood Plan survey distributed in June 2024, the line ‘by 2040 Glastonbury will be a World Heritage Site’ was included under ‘Vision for Glastonbury’.

They also spoke of attracting ‘the right kind of tourist’ to our town. This sent alarm bells off for many present. It is clear that this is a marketing campaign designed to attract corporate interest and to commercialise our beautiful, quirky, magical, unique town.

A glossy red and black booklet was produced showing the local sacred places of interest.

UNESCO is the branch of the UN that would have jurisdiction of the Abbey and Tor. Their future appears to be technocratic and we are not in favour of greater surveillance, wifi and restrictions.

UNESCO would ultimately have more say over what those sites do and how they are run; the local people would have less autonomy. Locals are happy with the way that the National Trust is presently operating the Tor and the Abbey. With more visitors, there will be higher entrance fees and visitor centres.

Visitor numbers are manageable at present. Barriers and turnstiles could become a feature to deal with increased footfall to the Tor, and the subsequent erosion and damage caused – like in Venice and Pompeii, which was getting 36,000 visitors per day. They have recently had to reduce this to 20,000 per day.

Heritage tourism is big business, make no mistake.

While UNESCO claims to protect areas, in the case of the Stonehenge tunnel and harbourside development in Liverpool, protection from development was not given.

UNESCO makes over £100m per year in the UK and is primarily interested in WHS for profit, not the wellbeing of locals. WHS has had devastating effects on Bath, Stonehenge and the Giants Causeway, to name a few, where over-tourism is rife. I have spoken directly to friends

who have experienced nightmare scenarios in Bath and Ballycastle (the closest town to Giants Causeway).

Over-tourism results in greater air pollution, litter, parking restrictions, overcrowding, commercialisation and loss of a thriving environment in which to live.

Coachloads are likely to arrive for whistlestop tours, which Glastonbury does not have the infrastructure to deal with. The impact would be catastrophic, as it has been at other World Heritage Sites across the world.

To accommodate the ‘right kind of tourist’, there inevitably will be more big chain shops and eateries, hotels, more homogenisation and a loss of individuality.

Also a hike in taxes is likely for residents and independent businesses, and a rise in rental costs which have already pushed many locals out of town.

In Glastonbury Town, we have a homelessness crisis and food and fuel poverty. World Heritage Sites raise rentals by 20 per cent.

Should we not be using the council money pot more wisely to alleviate these immediate issues? We have a community food fridge; would this continue? How about those who lead alternative lifestyles, will they be moved on?

I hope that we will raise our voices about this and be heard, because it feels like another corporate takeover that appears to be happening to all our towns and cities.

I recently addressed the council on November 12 with local residents’ concerns, and was out on Market Cross in the town to discuss the issue with a paper petition and survey of locals.

I hope you can read and sign the petition (link below) before the wheels of this agenda destroy this quirky, unique, world-renowned Somerset town forever.

We are demanding a more reliable and inclusive survey that reflects the true local feeling and a proper, well-advertised, full public consultation.

Time to stop the stink

Authority must close this ‘suffocating’ landfill site

FOR years, the residents of Silverdale, Knutton, and Newcastle-under-Lyme in Staffordshire have endured the harmful consequences of Walleys Quarry.

This landfill site, operated by Walleys Quarry Ltd. and linked to Red Industries, has been accused of emitting harmful hydrogen sulfide gas into the community, impacting public health and diminishing quality of life.

Recent developments have cast an even harsher spotlight on the issue, as Staffordshire’s NHS struggles to cope with rising respiratory cases. The question remains: how much longer must the community suffer, and why haven’t authorities stepped up?

New figures revealed in a recent Westminster Hall debate on respiratory health show that nearly 5,000 patients in Staffordshire are waiting beyond the national target of 18 weeks to see a respiratory specialist.

Last year, 3,765 people were admitted to hospital in emergencies due to lung conditions.

While systemic NHS delays are partly to blame, Newcastle-under-Lyme MP Adam Jogee pointed directly to hydrogen sulfide emissions from Walleys Quarry as a significant factor worsening health outcomes.

He described the landfill’s impact on public health as ‘undeniable’, highlighting that residents with restrictive respiratory conditions are especially vulnerable.

The Currie family’s story is emblematic of this crisis. They were forced to relocate after their infant son, Mathew, developed life-threatening respiratory issues linked to the air pollution. Unfortunately, many other families remain trapped, grappling with worsening conditions as they wait for long-overdue care.

Even the most vulnerable settings are not spared. Silverdale Cemetery, located just across the road from the landfill, has seen funerals disrupted by noxious odours. Local schools and Newcastle College also report that the fumes disrupt learning and focus, while Royal Stoke University Hospital staff have noted the smell infiltrating wards, even affecting terminal patients’ final moments.

This isn’t just a health crisis – it’s an assault on basic human dignity.

The community has fought tirelessly to bring this to the attention of Walleys Quarry, but progress has been unnoticeable. The Environment Agency (EA) has spent over 1,000 days investigating allegations of illegal waste dumping and over 800 days reviewing compliance with environmental permits.

A suspension notice issued in March 2024 was shockingly withdrawn just 11 days later, leaving residents questioning the EA’s competence and resolve.

Newcastle-under-Lyme Borough Council has shown greater determination, issuing an abatement notice in 2021 and securing permission to prosecute Walleys Quarry with the support of top-tier barristers. Yet the legal process remains slow and costly, and the odours persist.

During the Westminster Hall debate, Health Minister Karin Smyth pointed to initiatives like the Tobacco and Vapes Bill, which aims to create a smoke-free generation, as part of the government’s broader strategy to tackle respiratory health issues.

However, while such initiatives are important, they do little to address the immediate crisis caused by hydrogen sulfide emissions from Walleys Quarry. Residents need solutions now – not future promises.

The disconnect between broader national initiatives and the urgent local problem has only deepened community frustration. As one resident put it: “We can’t wait for a smoke-free generation while we’re struggling to breathe today.”

Compounding the frustration is Walleys Quarry Ltd.’s troubling history. The landfill is linked to Red Industries, whose former chairman, Adam Share, previously served time for conspiracy to unlawfully intercept communications. Residents are left wondering how such figures are allowed to operate in an industry with such far-reaching public health implications.

Meanwhile, community voices like Dr Michael Salt, a 40-year-old nuclear scientist and prominent advocate, remain excluded from liaison committees meant to address residents’ concerns.

Dr Salt’s exclusion has led many to question whether these panels are more about maintaining appearances than

driving meaningful change.

Beyond the health impacts, the quarry’s operations are taking a toll on the local economy. Residents suspect that property values in the area have declined, as potential buyers avoid homes near the landfill. Businesses, especially in retail and hospitality, report falling foot traffic and lost income, as visitors choose to steer clear of the affected zones.

These economic costs add another layer of suffering to an already overburdened community.

This is not just about stopping the stink – it’s about securing justice for a community that has suffered for too long. Residents demand:

1. Immediate emission controls: enforce strict hydrogen sulfide limits to protect public health.
2. Transparency: provide regular updates from the Environment Agency and Newcastle Borough Council on investigations and legal actions.
3. Compensation: offer financial restitution for health impacts, suspected property devaluation, and diminished quality of life.

4. Accountability: launch an independent review into the EA’s handling of Walleys Quarry and explore whether stronger oversight is needed.

The people of Silverdale, Knutton, and surrounding areas have shown remarkable resilience, but their patience is wearing thin. It’s time for the government, the Environment Agency, and local authorities to act decisively. Residents cannot endure further delays while their health, homes, and livelihoods remain under threat.

Residents are urged to:

- Report incidents to the Environment Agency.
- Contact their MPs, sharing how the emissions are impacting their lives.
- Support ongoing legal actions and stay informed through local campaigns.

Together, we can demand the justice Newcastle-under-Lyme deserves.

Don't be dumb about smart meters

WITH so many things outside our control, it is crucial to focus our energies on those changes that we can make.

Especially so for the changes that we can make in private spaces, such as our homes.

I hear people in the UK moan and groan about being harassed by their electricity company to get a smart meter. People get frustrated by the constant letters and emails, and so they simply give in and go along with it, because ‘it is going to be mandatory soon so I may as well just get it done now.’

This kind of defeatist attitude is what has led to smart meter laws being implemented across the world, especially in Europe.

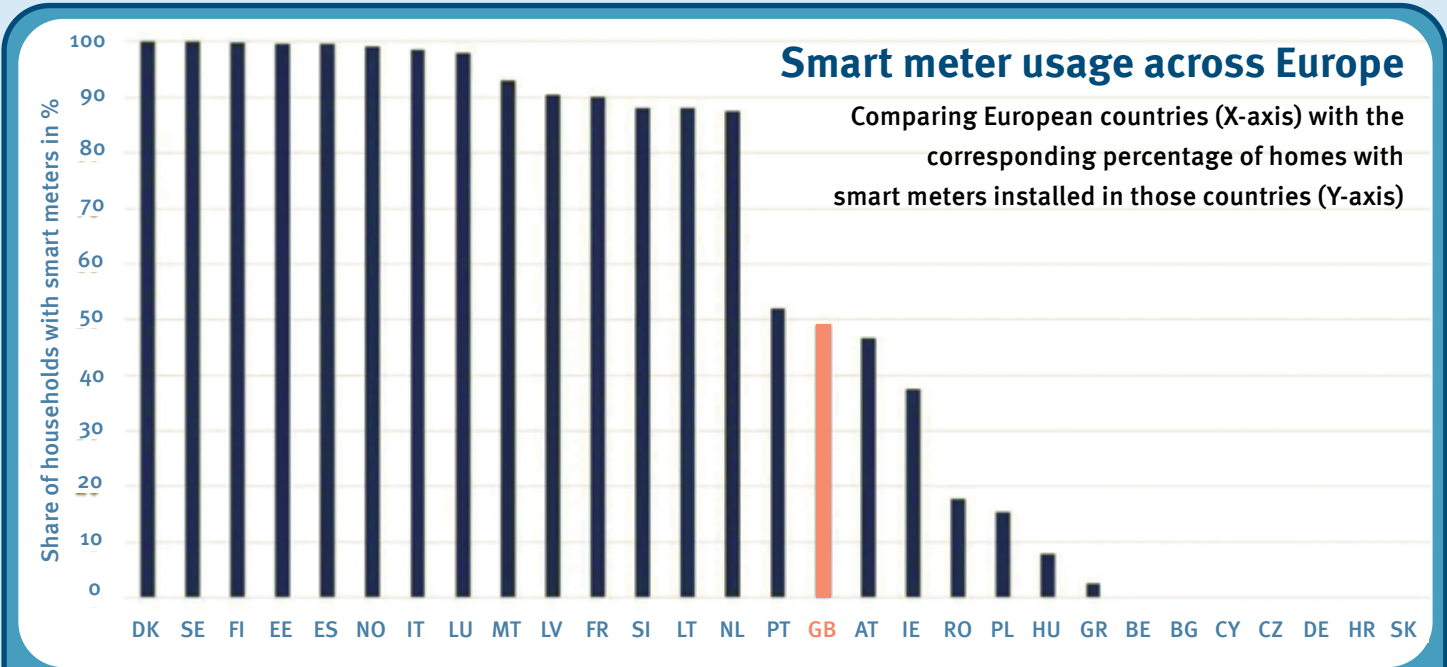
More worryingly, it is what has led to traditional analogue meters being completely destroyed by governments, so if you realise the harmful effects and change your mind and want your old meter back, this is not an option in many countries. While we still have the right to object in the UK, we must all exercise this right.

It is common knowledge, supported by peer-reviewed, scientifically-published research that smart meters:

- Are fire hazards
- Emit biologically harmful pulsed electromagnetic field radiation
- Collect personal data of private activities in the home, in violation of Article 8 of the Human Rights Act
- Cannot withstand typical grid surges
- Cause damage to homes and structures
- Put people out of jobs
- Are another step towards civilisation being completely digitised
- Can be controlled remotely, meaning your electricity can be cut at a moment's notice by companies
- Disturb pacemakers – the electromagnetic waves generated by smart meters can keep your ICD or pacemaker from functioning properly

Many apparently progressive European countries actually have laws in place (with no such thing as an exemption) making smart meters a legal requirement in every residential home.

Sweden was one of the first European countries to roll out smart meters, with residential regulations adopted in 2003. The country now has one of the highest rates of EHS (Electromagnetic Hypersensitivity) in the world.



‘Mandatory’ is often misunderstood. There is a difference between a nation’s laws and saying something is mandatory.

Mandatory is a consensual agreement, meaning it still requires informed consent from the individual. Mandatory sounds like you have no choice, but you do – you can decline and in some cases receive a fine or exemption.

Look at Denmark compared to Ireland. In Denmark, there are actually laws regarding smart meters; no exemptions, no opting out. However in Ireland, companies say it is mandatory, people comply assuming this means law, but legally you can easily opt out.



Say NO to harmful radiation while you still have the chance

Denmark decided in 2014 that smart meters should be in all residential properties. Denmark now also has laws regarding smart meters, meaning there is no such thing as opting out, paying a fine, or even a medical exemption. By 2020, all Danish homes had a smart meter.

After years of harassing customers, more and more Danes made the switch to a smart meter themselves, even before the laws were put in place. Traditional analogue meters were destroyed by the electricity companies and the Danish government.

From 2007, in Spain, all new meter installations were to be smart meters. The country concluded its smart meter rollout nationwide by 2017.

In Germany, customers using above 6,000 kWh per year are affected by a mandatory

rollout. The digitalisation of energy law 2023 enables smart meters to become mandatory from 2025.

Across in Flanders in Belgium, it is mandatory for newly installed meters in new builds and renovations to be smart meters. In Wallonia, it is mandatory for consumers of over 6,000 kWh.

In France, smart meters are referred to as ‘linky’. You can pay a fine of €50 yearly to not have a linky.

For Italy, the installation of smart meters became mandatory back in 2006.

Wisely, Poland has, comparatively, decided to hold back on the smart meter rollout. The Polish government’s aim is to install 65 per cent by 2025 and 80 per cent in 2028.

In Ireland, customers are told it is

mandatory, however, you have the option to opt out and there are no laws to enforce smart meters.

In Greece, Russia, Croatia, Bulgaria, Lithuania, Hungary and Czech Republic, there is currently no rollout on a huge scale, nor any laws regarding smart meters.

The more of us that voluntarily choose to have a smart meter when there are no actual laws in place, the more it will help the progression of new laws in the future. What seems an easy option to stop the hassle is not always the smart move.

If you already have a smart meter then you are part of the problem, but you can instead become part of the solution, and get it removed as soon as possible. Exercise your rights while you still have them.

In memory of a lawyer, mother and warrior

IN memory of Anna de Buisseret who left this world on November 30, 2024, aged 59.

Two years ago, at an event where she was speaking, I was chatting to lawyer and retired army officer, Anna de Buisseret, about the work she'd been doing since 2020. She helped so many people but charged them nothing. She mentioned how working for free would often backfire.

"I'd get desperate people asking me for help and then getting really angry if I didn't respond or help them quickly enough," she said. "Some could get quite nasty."

It was hard to believe that anyone would treat Anna in such an abusive way. Ever since we first met – when she'd started questioning the narrative on vaccines in general on Facebook and needed backup – she'd been kind, helpful and generous of spirit.

I'd initially become FB friends with her mother, Anne, and it was Anne who, realising her daughter and I would get on, introduced us. I'm guessing that was nine or ten years ago.

We didn't meet in person until 2020, when she came to visit me. We'd been online friends for long enough; it was time to meet! We went for a curry and she told me about

her life. She hadn't had an easy journey and her eyes would darken when she spoke of harder times. I wanted to tell her about how her eyes did that but I never did. She was supposed to stay the night at mine but – as the note I found the following morning explained – crept off while I slept, because one of her daughters needed her.

Over the last four and a half years, because we shared many of the same beliefs, Anna and I were in contact often. She was always available if I needed advice, and did her best to assist the people I passed on to her; people who needed legal questions answered but couldn't afford to pay. Anna couldn't help everyone, but she tried. It was only when she became ill that she had to turn people away, something she hated doing.

I invited her on my UNN talk show several times and she was always brilliant. She was also happy to stand in if any of my guests pulled out at the last minute. She would say: "Ok, give me five minutes...I'll just slap some make-up on..." and she'd be there, on time, the consummate professional, bright-eyed and ready to rock, even when she wasn't at optimum health.

That's just how she was; wanting to help, wanting to promote the truth, wanting to share her power along with the masses of information she kept stored inside her clever little pink-haired head with as many people

as she could reach.

She was an excellent speaker – she spoke at many protests – and would bravely face those she believed were doing wrong.

There are a plethora of videos showing her confronting those who were, knowingly or unknowingly, committing crimes. Anna would set them straight. She was good at that.

When I needed a legal expert to appear in *Playing God*, Anna was my first choice. She came to the studio, and we filmed her section pretty much in one take. No script or notes needed; Anna spoke with wisdom, experience and confidence and always from the heart.

The last – and final – time I saw Anna was

in June 2024 at the *Playing God* premiere in London. I hadn't expected to see her as she'd been feeling very unwell that week but, suddenly, there she was. She was walking with a stick and was a little unsteady but her skin glowed and her eyes were sparkling. Before the viewing, she chatted in the bar for ages with several people, including old friends of mine Toula and James. Toula, who's worked with many famous people, said she was more excited meeting Anna than she was meeting any 'big name' celebrity.

After I heard how Anna's health had suddenly deteriorated that dreadful Saturday, I sent her a private message in the hope she'd be able to respond. Her daughter replied: 'Thanks...your message brought a smile to her face xxx.'

I can't remember Anna's last words to me; they were probably, "God bless."

May God bless you too, Anna, as you embark on the next part of your journey. You left too soon, but I know you left prepared. May your passing remind us how short life is and to live each day with courage, love and conviction.

Rest in peace and rise in glory, Anna.

Biomedical psychiatry killing thousands

Inquiry must learn tough lessons from our failing mental health services

IT is long overdue for the spotlight to be shone on biomedical psychiatry, its harmful role in the lives of people experiencing emotional distress, and the managers of mental health services who allow it to continue its harmful practices.

All NHS Partnership Trusts have an annual toll of untoward deaths within their mental health services. But none are so shocking as that of the Essex Partnership University NHS Foundation Trust (EPUT), where over 2,000 deaths were recorded amongst people being ‘treated’ by its in-patient services between January 1, 2000, and December 31, 2023.

It is a national scandal and is currently being investigated by Baroness Kate Lampard (The Lampard Inquiry). Following the death of her son, Matthew, at the hands of staff in the Linden Centre, Melanie Leahy, a tireless campaigner for the truth, was key in bringing about this inquiry.

There are four entities here that should be having light shone on them. Firstly, biomedical psychiatry (mental health professionals using the medical model to treat people in emotional distress), with its emphasis on diagnostic labelling and drugging. For decades, the death toll and permanent harms caused by this outmoded approach have increased, year on year. Biomedical psychiatry has become an entrenched position within the NHS. Secondly, Essex Partnership University NHS Foundation Trust should be having the light shone on it for funding and promoting outmoded biomedical practices. The 2,000+ untoward deaths is unacceptable. How many of this number would still be alive if, instead, they had been offered talking therapies and other approaches which have been proven to work.

Despite the silence from those who run mental health services, what really goes on out of public view has been well documented by Frank McCutcheon in his book, *Mental Hospitals, Care Homes and Other Stories*. McCutcheon cites numerous examples of professional misconduct, negligence, inappropriate treatment, abuse, excessive force and neglect. Staff working within EPUT mental health services have allegedly been involved in cover-ups over many deaths, including that of Matthew Leahy. The Linden Centre, where he died, had 11 suicides between 2004 and 2015. EPUT was convicted over these deaths under the Health & Safety at Work Act and fined £1.5m. The third entity that should be coming under the brightest light is Big PsychoPharma - the psychiatric drugs manufacturing arm of the pharmaceutical industry. Research papers are churned out at an eye-watering rate, laden with impressive jargon and psychobabble, to show that their drugs are good for us. There have been many research studies – often funded by the Big PsychoPharma companies themselves – showing that their drugs either don’t work or are harmful. These studies have been withheld by those same companies. Dr Peter Gotzsche provided many examples of this in his book, *Deadly Medicines and Organised Crime: How Big Pharma Has Corrupted Healthcare*. It has been suggested that at least five of the SSRI (Selective Serotonin Reuptake Inhibitor) antidepressants increase thoughts of self-harm and/or suicide. How many of EPUT’s 2,000+ died because of these prescriptions? Biomedical psychiatry is fully supported and part-funded by Big PsychoPharma. The fourth entity that should come under the spotlight at this inquiry is the wider NHS and its provision of so-called mental health services. Billions of pounds are spent each year on outmoded biomedical psychiatry. Increasingly, thinking is shifting away from a mental health-mental illness continuum and towards one of emotional wellbeing-emotional distress. It is high time they addressed this. As a former NHS middle manager, I used to defend the biomedical model status quo. And, along with colleagues, I was involved in deflecting relatives’ complaints, defending professional misconduct and being involved in

cover-ups – it was part of my job! I call on my former manager colleagues and staff within EPUT to tell the whole truth to the Lampard Inquiry. This will not only help the grieving relatives of the 2,000+ untoward EPUT deaths, but could help avoid countless biomedical model deaths, nationwide, in the future. I call, too, on Wes Streeting, the Secretary of State for Health and Stephen Kinnock, the Health and Social Care Minister, to ensure that the Lampard Inquiry is not an expensive whitewash or yet another box-ticking exercise, with its report shelved alongside countless others of the past 70 or so years, to gather dust and be forgotten. Recommendations for change should be acted upon and enshrined in law. People experiencing emotional distress deserve better. Instead of a mental health service risking harm or death, they deserve a comprehensive wellbeing service which promotes all aspects of healthy living.

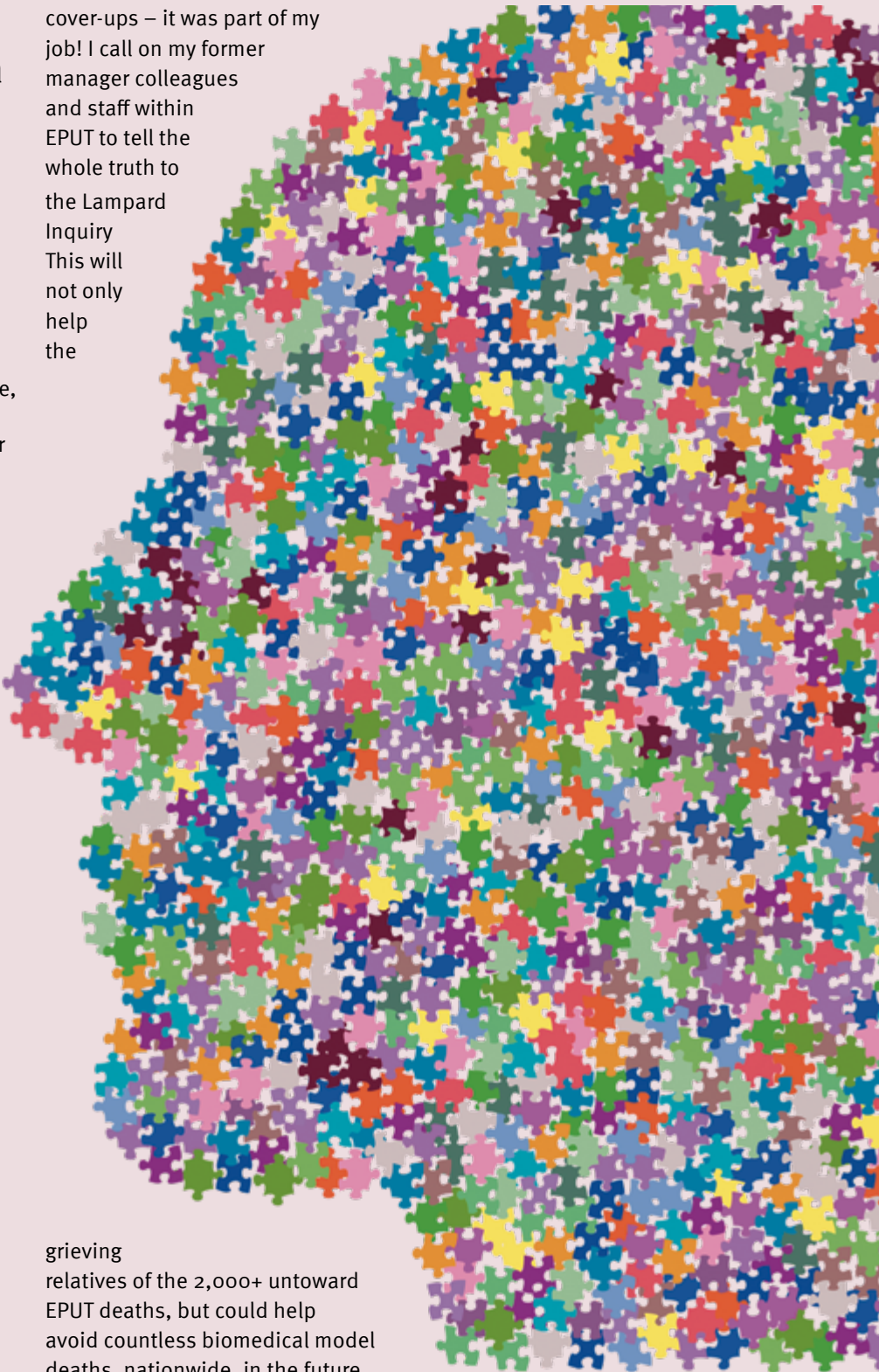

Slavery cloaked as sustainability

Volunteers needed to ‘monitor traffic’ but at what cost?

ON October 31, an article appeared in the free bi-weekly edition of the *Caerphilly Observer* in South Wales, asking for volunteers to assist in gathering street-use data for the local authority.

This would be done by placing a harmless inconspicuous device in their window. Nothing nefarious about that. Or is there? The device is manufactured by a company called Telraam based in Belgium and its reach is international.

Do we really need more surveillance in our lives? We’ve been able to count traffic flow for decades with pneumatic strips and aren’t there enough CCTV cameras in our faces to establish who and what is coming and going, and when?

On closer inspection, Telraam’s website and wider links have some tell-tale signs that suggest a deeper agenda could potentially be at play with this technology. They say that their device works by collecting anonymous aggregate data within a 15-minute resolution.

They also state that the devices collect detailed information on traffic on any street for local authorities...in smart cities.

These devices are also part of the

internet of things (IoT) framework and any prospective punter need not worry their little head about the device playing up as it can be managed and controlled remotely by Telraam’s AI. What could possibly go wrong?

The specifications state that the device has a built-in wide-angle, fixed lens to capture the required data; but don’t worry, you are assured the device does not detect faces, record personal data or is compatible with ANPR (automatic number plate recognition), and that no identifiable images are saved on Telraam’s devices.

On the face of it, that could set your mind at ease but, assuming you trust companies and authorities, do you believe that they would never manipulate or move the goalposts in the future to further an agenda?

Telraam are keen to state that these devices have the potential for improvements over time for gathering data. I suspect that the authorities will be rubbing their hands in glee at the prospect.

Is it any wonder that Caerphilly Borough Council and others are keen to recruit volunteers for this initiative? Telraam want all of you to join their ‘community of partners’ to improve urban mobility, promote smarter transportation and

foster sustainable cities’.

If one looks a little closer with an open mind, you won’t need to go too far to find that citizens of Brussels using Telraam sensors appear to be building the prison bars of their own dystopian future, by generating data to support the local monitoring of the Sustainable Development Goals (SDGs).

A recent study from Belgium states that ‘there is a critical need for high-quality, accessible, timely, reliable, and disaggregated data to facilitate the measurement of progress towards the SDGs.’ And at the helm of this data-collecting exercise is Telraam with the aim of localising the sustainable development goals in smart and sustainable cities.

Does Emily Kerr, a Green Party representative from Oxford (a proposed Fifteen Minute City,) know something we don’t about these Telraam devices? Many Telraam sensors have already been placed around the city and Ms Kerr suggests the devices are akin to doorbell cameras and will be ‘crucial for looking at the impact of new traffic measures’.

I wonder whether this will be for our benefit or for the state to impose further impositions on the public? Ms Kerr also points out that the data that sensors collect could surprise residents as she was shocked to learn

how many pedestrians walked down Bullingdon Road. So let’s make an issue of something we hadn’t noticed before, shall we?

As David Icke points out in his latest book, *The Reveal*, referring specifically to Oxford but noting how this is being coordinated across the world by a global network: ‘They are building the AI control system bit-by-bit and telling you that the parts are not connected.’

I’ll leave you to decide whether these devices – that were being promoted on October 31 – are a Halloween trick or a treat.

Toxic ingredients to avoid

Acrylamides

Toxic, cancer-causing chemicals formed in foods when carbohydrates are exposed to high heat (baking, frying, grilling).

Aspartame

Chemical sweetener that causes neurological disorders, seizures, blurred vision and migraine headaches.

Autolysed proteins

Highly processed form of protein containing free glutamate and used to mimic the taste-enhancer chemical MSG.

BPA (Bisphenol-A)

A hormone-mimicking chemical found in nearly all food packaging plastics. Active in just parts per billion, BPA promotes cancer, infertility and hormone disorders.

Casein

Milk proteins. Hilariously, this is widely used in soy cheese products that claim to be alternatives to cow's milk. Nearly all of them are made with cow's milk proteins.

Genetically modified ingredients

Nearly all conventionally grown corn, soy and cotton are GMOs. They're linked to severe infertility problems and may even cause the bacteria in your body to produce and release a pesticide in your own gut.

High fructose corn syrup

A highly processed liquid sugar extracted with the chemical solvent glutaraldehyde and frequently contaminated with mercury. It's also linked to diabetes, obesity and mood disorders.

Homogenised milk

The fats in the milk are artificially modified to change them into smaller molecules that stay in suspension in the milk liquid (so the milk fat doesn't separate).

Hydrochloride

When you see anything hydrochloride, such as pyridoxine hydrochloride or thiamin hydrochloride, those are chemical

forms of B vitamins that companies add to their products to be able to claim higher RDA values of vitamins.

Hydrolysed vegetable protein

A highly processed form of (usually) soy protein that is processed to bring out the free glutamate (MSG). Used as a taste enhancer.

Partially hydrogenated oils

Oils that are modified using a chemical catalyst to make them stable at room temperature. This creates trans fatty acids and greatly increases the risk of blocked arteries.

Phosphoric acid

The acid used in sodas to dissolve the carbon dioxide and add to the overall fizziness of the soda. Phosphoric acid will eat steel nails. It's also used by stonemasons to etch rocks. The military uses it to clean the rust off battleships. It absolutely destroys tooth enamel.

Propylene glycol

A liquid used in the automotive industry to winterise RVs. It's also used to make the fake blueberries you see in blueberry muffins, bagels and breads. (Combined with artificial colours and corn syrup.)

Sodium (Salt)

The processed white salt lacking in trace minerals. In the holistic nutrition industry, we call it 'death salt' because it promotes disease and death. Real salt, on the other hand, such as 'dirty' sea salt, is loaded with the trace minerals that prevent disease, such as selenium (cancer), chromium (diabetes) and zinc (infectious disease).

Sodium nitrite

A cancer-causing red colouring chemical added to bacon, hot dogs, sausage, beef jerky, ham, lunch meats, pepperoni and nearly all processed meats. Strongly linked to brain tumours, pancreatic cancers and colon cancers.

Soy protein

The main protein source used in protein bars, including many bars widely consumed by bodybuilders.

Soy protein is the junk protein of the food industry. It's made from genetically modified soybeans (often grown in China) and then subjected to hexane, a chemical solvent that can literally explode.

Sucralose

An artificial chemical sweetener sold as Splenda and other names. The sucralose molecule contains a chlorine atom. Researchers have repeatedly found that artificial sweeteners make people fat by actually promoting weight gain.

Sugar

The bleached, nutritionally-deficient by-product of cane processing. During sugar cane processing, nearly all the minerals and vitamins end up in the blackstrap molasses that's usually fed to farm animals. (Blackstrap molasses is actually the good part of sugar cane juice.) Molasses is often fed to farm animals because every rancher knows that farm animals need good nutrition to stay alive. Amazingly, conventional doctors don't yet realise this about humans, and they continue to claim that eating sugar is perfectly fine for you.

Textured vegetable protein

Usually made of soy protein which is extracted from genetically modified soybeans and then processed using hexane, an explosive chemical solvent (see soy protein, above). Widely used in vegetarian foods such as 'veggie burgers' (most of which also contain MSG or yeast extract, by the way).

Yeast extract

Hidden form of MSG that contains free glutamate and is used in many 'natural' food products to claim 'No MSG!' Yeast extract contains up to 14 per cent free glutamate. You'll find it in thousands of grocery store products, from soups to snack chips. I even once spotted it used on fresh meat!

Food additives to avoid

While the food regulatory agency lists additives on this list as 'safe', many people are concerned about the safety of many additives when consumed repeatedly.

Sulfites

Used to keep prepared foods fresh. Can cause breathing difficulties in those sensitive to the ingredient.

Azodicarbonamide

Used in bagels and buns. Can cause asthma.

Potassium bromate

Added to breads to increase volume. Linked to cancer in humans.

Propyl gallate

Added to fat-containing products. Linked to cancer in humans.

BHA/BHT

A fat preservative, used in foods to extend shelf life. Linked to cancerous tumour growth.

Propylene glycol

Better known as antifreeze. Thickens dairy products and salad dressing. Deemed 'generally' safe by FDA.

Butane

Put in chicken nuggets to keep them tasting fresh. A known carcinogen.

Monosodium glutamate (MSG)

Flavour enhancer that can cause headaches. Linked in animal studies to nerve damage, heart problems and seizures.

Disodium inosinate

In snack foods. Contains MSG.

Disodium guanylate

Also used in snack foods, and contains MSG.

Enriched flour

Used in many snack foods. A refined starch that is made from toxic ingredients.

Recombinant Bovine Growth Hormone (rBGH)

Genetically-engineered version of natural growth hormone in cows. Boosts milk production in cows. Contains high levels of IGF-1, which is thought cause various types of cancer.

Refined vegetable oil

Includes soybean oil, corn oil, safflower oil, canola oil, and peanut oil. High in omega-6 fats, which cause heart disease and cancer.

Avoid fast foods and sugary drinks
Avoid soda and sugary drinks
Eat hormone-free meat
Drink hormone-free milk

You will not find a list of banned food additives, as that would create negative impact on the food additive industry as a whole. Because of this reason, a list of permitted food additives is published. Any accepted food additive is permitted on the basis of its increasing the shelf value of food, ability to maintain the food's nutritional value, ability to increase its appeal, etc. - foodadditivesworld.com

Sodium benzoate

Used as a preservative in salad dressing and carbonated beverages. A known carcinogen and may cause damage to our DNA.

Brominated vegetable oil

Keeps flavour oils in soft drinks suspended. Bromate is a poison and can cause organ damage and birth defects. Not required to be listed on food labels.

Propyl gallate

Found in meats, popcorn, soup mixes and frozen dinners. Shown to cause cancer in rats. Banned in some countries. Deemed safe by Food and Drug Administration.

Olestra

Fat-like substance that is unabsorbed by the body. Used in place of natural fats in some snack foods. Can cause digestive problems, and also not healthy for the heart.

Carrageenan

Stabilizer and thickening agent used in many prepared foods. Can cause ulcers and cancer.

Polysorbate 60

A thickener that is used in baked goods. Can cause cancer in laboratory animals.

Camauba wax

Used in chewing gums and to glaze certain foods. Can cause cancer and tumours.

Magnesium sulphate

Used in tofu, and can cause cancer in laboratory animals.

Chlorine dioxide

Used in bleaching flour. Can cause tumours and hyperactivity in children.

Paraben

Used to stop mold and yeast forming in foods. Can disrupt hormones in the body, and could be linked to breast cancer.

Sodium carboxymethyl cellulose

Used as a thickener in salad dressings. Could cause cancer in high quantities.

Aluminium

A preservative in some packaged foods that can cause cancer and Alzheimer's.

Artificial sweeteners to avoid

Artificial sweeteners are regulated, just as food additives are, but this does not apply to products 'generally recognised as safe'

Saccharin

Carcinogen found to cause bladder cancer in rats (worst offender).

Aspartame

An excitotoxin and thought to be a carcinogen. Can cause dizziness, headaches, blurred vision and stomach problems.

Tert butylhydroquinone

Used to preserve fish products. Could cause stomach tumours at high doses.

High fructose corn syrup

Sweetener made from corn starch. Made from genetically-modified corn. Causes

obesity, diabetes, heart problems, arthritis and insulin resistance.

Acesulfame potassium

Used with other artificial sweeteners in diet sodas and ice cream. Linked to lung and breast tumours in rats.

Agave nectar

Sweetener derived from a cactus. Contains high levels of fructose, which causes insulin resistance, liver disease and inflammation of body tissues.

Bleached starch

Can be used in many dairy products. Thought to be related to asthma and skin irritations.

Artificial food colourings to avoid

Food colourings are used to give foods a more attractive appearance, but some experts believe they cause serious health problems, including asthma and hyperactivity in children

Red #40

Found in many foods to alter colour. All modern food dyes are derived from petroleum. A carcinogen that is linked to cancer in some studies. Also can cause hyperactivity in children. Banned in some European countries (worst offender).

Blue #1

Used in bakery products, sweets and soft drinks. Can damage chromosomes and lead to cancer.

Blue #2

Used in candy and pet food beverages. Can cause brain tumours

Citrus red #1

Sprayed on oranges to make them look ripe. Can damage chromosomes and lead to cancer.

Citrus red #2

Used to colour oranges. Can cause cancer if you eat the peel.

Green #3

Used in sweets and beverages. May cause bladder tumours.

Yellow #5

Used in desserts, sweets and baked goods. Thought to cause kidney tumors, according to some studies.

Yellow #6

A carcinogen used in sausage, beverages and baked goods. Thought

to cause kidney tumours, according to some studies.

Red #2

A food colouring that may cause both asthma and cancer.

Red #3

A carcinogen that is added to cherry pie filling, ice cream and baked goods. May cause nerve damage and thyroid cancer.

Caramel colouring

In soft drinks, sauces, pastries and breads. When made with ammonia, it can cause cancer in mice. Food companies not required to disclose if this ingredient is made with ammonia.

Brown HT

Used in many packaged foods. Can cause hyperactivity in children, asthma and cancer.

Orange B

A food dye that is used in hot dog and sausage casings. High doses are bad for the liver and bile duct.

Bixin

Food colouring that can cause hyperactivity in children and asthma.

Norbixin

Food colouring that can cause hyperactivity in children and asthma.

Anatto

Food colouring that can cause hyperactivity in children and asthma.

Food label tricks

Here's a trick that food companies frequently use to pack more sugar into their products, without making sugar look like the first ingredient:

Ingredient labels, you see, must list the most prominent ingredients first, and some consumers might freak out if they saw a box of cereal that said, 'Sugar, whole grain wheat, corn' and so on. Instead, the company uses 3 or 4 different forms of sugar to distribute them farther down the label, like this:

'Whole grain wheat, sugar, corn syrup, corn syrup solids...'

This way, the first ingredients looks like whole grain wheat when, in reality, the cereal might be over fifty per cent sugars!

How to buy honest food

- Shop at your local farm shops and markets, food co-op or producers.
- Ask about everything that went into producing your food.
- Always read the ingredients! If you see names of chemicals you can't pronounce, don't buy it.
- Buy more unprocessed food ingredients and make your own meals rather than buying ready-to-eat, processed foods, which are almost universally formulated with disease-promoting ingredients.
- GROW some of your own food! The best food you can ever eat is food from your own garden.

First televised genocide in history

But even international law powerless to stop it

THE International Criminal Court (ICC) arrest warrants for Israeli PM Benjamin Netanyahu and his former Defence Minister Yoav Gallant have set western governments scrambling for a response.

However, the warrants in themselves won't stop the ongoing massacre and starvation of Palestinians.

The warrants follow an International Court of Justice (ICJ) order of January 26, 2024, instructing Israel to take immediate measures to prevent a genocide of Palestinians in Gaza.

That case was brought by South Africa, which presented evidence of genocide being committed by Israel. Appended to the ICJ's order was a declaration by ICJ Judge Xue, who considered that 'as a result of the Israeli military actions, the very existence of the Palestinian people in Gaza is at stake, which challenges the most elementary principles of humanity and morality.'

Israel treated the ICJ's order with contempt and accelerated its indiscriminate destruction of civilian life and infrastructure in Gaza. Its military offensive has led to the estimated deaths of 43,972 civilians, including 17,492 children. An equivalent loss of life in the UK would entail 1.3 million deaths. With 80 per cent of its buildings, infrastructure, and agricultural land destroyed, Gaza is now uninhabitable.

Professor Richard Falk, an international law and international relations scholar who taught at Princeton University for 40 years, has observed: "In Gaza, the West is enabling the most transparent genocide in human history."

Amos Goldberg, professor of Holocaust History at the department of Jewish history and contemporary Jewry at the Hebrew University of Jerusalem, is in no doubt that a genocide is happening in Gaza.

He said: "What is happening in Gaza is genocide because the level and pace of indiscriminate killing, destruction, mass expulsions, displacement, famine, executions, the wiping out of cultural and religious institutions, the crushing of elites (including the killing of journalists), and the sweeping dehumanisation of the Palestinians – create an overall picture of genocide, of a deliberate conscious crushing of Palestinian existence in Gaza."

Matthew Hoh, Associate Director of the Eisenhower Media Network, is a former United States Marine Corps Captain and

State Department officer. He recently returned from a field trip to northern Gaza, where, as he described it, "Israel is carrying out a genocide within a genocide [by] systematically starving 300,000 Palestinians to death".

This macabre reality was made all the more perverse by the sight of Israeli children being taken on school field trips to Gaza's perimeter, where they were encouraged to observe, with the aid of telescopes, and celebrate the destruction of life and infrastructure.

Never before in history has a genocide been broadcast so immediately to a global audience. It is clear to the majority of those who have observed and reported on the unfolding horror that a genocide is indeed in progress.

However, it also appears that there is

no way of halting it. Legal structures are in place to make pronouncements on what is happening based on the evidence presented to the international courts, but Israel continues to slaughter Palestinians with impunity because it has the support of the world's most powerful economic and military bloc – the Western NATO alliance.

Not only have liberal democracies refused to take any preventive steps, they have openly facilitated the genocidal onslaught with contributions of weapons, providing targeting intelligence, and full-throated political support.

The prevention of genocide is a central obligation of the Convention for the Prevention and Punishment of the Crime of Genocide, which was adopted by the United Nations General Assembly on 9 December, 1948.

In the past, genocide prevention was more difficult when events typically remained largely concealed during the perpetration of the crime, and historical reconstruction emerged after the fact. This is not the case today in Gaza, where we are witnessing the first televised genocide in history, courtesy of real-time daily reports from brave journalists in Gaza.

While the ICJ and ICC pronouncements vindicate the call for an end to Palestinian suffering, the international legal framework has so far proved powerless to prevent the bombing and mass starvation of people in Gaza. The ICJ's January determination of a plausible genocide and its call for provisional measures have effectively set in motion a legal process that could drag on for years. The absurd logic of this process demands the complete extermination of Palestinians before the ICJ can rule that a genocide did in fact take place, and was not merely plausible.

The glaring irony is that the international legal framework is being discredited by the very nations that put it in place. The conclusion we must draw from this is that international law was never intended to apply to the strongest nations, who sponsored and promoted it only when it was expedient for them to do so.

This was confirmed in May 2024, when the ICC Chief Prosecutor, Karim Kahn, submitted the application for the warrants to be issued. In an attempt to intimidate Kahn, an unnamed senior Western leader explained to him that the international criminal justice system was "built for Africa and thugs like Putin."

The solution to the crisis is well understood, and has been routinely applied by NATO countries to weaker nations. The Euro-Med Human Rights Monitor calls for a total arms embargo on Israel, an end to all military and intelligence cooperation, the imposition of travel restrictions, the freezing of Israeli government assets, and political and economic sanctions on Israel and its accomplice states.

If ICJ orders and ICC arrest warrants are not enforced to halt the genocide in Gaza, not only is Gaza likely to become a graveyard for 2.2 million Palestinians, but the Genocide Convention will be buried with them.

Arrest warrant issued for Netanyahu

ON November 21, the International Criminal Court (ICC) issued arrest warrants for Prime Minister Benjamin Netanyahu of Israel and his former defence minister, Yoav Gallant.

The arrest warrants were for war crimes and crimes against humanity in Gaza, committed between October 8, 2023, and May 20 this year, when the prosecution filed the applications for the arrest warrants.

Between May and November, the court's officials were allegedly subject to enormous political interference in the form of intimidation and threats, and a smear campaign was launched against the chief prosecutor, Karim Khan KC. But the court resisted the pressure.

The charges of war crimes and crimes against humanity relate to the use of mass starvation of civilians as a method of warfare, murder, persecution and other inhumane acts, including the deliberate targeting of Gaza's hospitals, and the refusal to allow humanitarian and medical supplies into the strip: all part of a widespread and systematic attack against the civilian population of Gaza.

The arrest warrants impose a legal obligation on all member state parties to the ICC number 124, including Britain, to detain Netanyahu and Gallant if they enter their territory. The U.S. is not a signatory, and opposes the ICC's decision to issue these arrest warrants, although it offers no legal argument refuting the charges.

This blanket rejection echoes the U.S. default position of vetoing every UN Security Council resolution for a

ceasefire in Gaza, which has led China's envoy to the U.N. Security Council, Fu Cong, to say that repeated vetoes by the U.S. of the Security Council resolutions have reduced the authority of this body to an all-time low.

Israel is also not a state party to the ICC, and has challenged its jurisdiction over Israeli citizens. The court responded that the acceptance by Israel of the court's jurisdiction was not required, as the court can exercise its jurisdiction on the basis of territorial jurisdiction of Palestine, which is a party to the ICC.

The issuing of the arrest warrants is largely symbolic, but it is an important signal, and one that much of the world welcomes. U.S. isolation is increasingly palpable.

The UN General Assembly has adopted a resolution affirming the right of the Palestinian people to self-determination, independence, and freedom from

Israeli occupation. The resolution stresses that this right is inalienable, unconditional, and non-negotiable, rejecting any so-called 'security measures' imposed by Israel as preconditions.

The resolution refers to the advisory opinion of the International Court of Justice, which declared the Israeli occupation illegal and called for its immediate cessation. This stance, the resolution argues, is crucial to the Palestinian people's right to self-determination and statehood.

A total of 170 countries voted in favour of the resolution, including Canada, Australia, all EU member states, and the majority of nations from South America, Asia, and Africa. Only six countries voted against the resolution: Israel, the United States, Argentina, Paraguay, Micronesia and Nauru.

The resolution was co-sponsored by 119 UN member states, representing a broad coalition of African, European, Asian, and Latin American countries, highlighting the widespread international support for Palestinian rights.

The Palestinian representative asked the UN General Assembly: "Is there a UN Charter for Israel that is different from the charter you all have? Do they have the right to kill, and the only right we have is to die?"

Drones shooting children in Gaza Surgeon's shocking testimony heard in Parliament

ONE of the most shocking of all the harrowing accounts to come out of Gaza this year was provided by UK surgeon, Nizam Mamode.

He told MPs at a parliamentary hearing on Tuesday, November 12 how the Israelis deliberately and systematically send drones to shoot children in areas they had just bombed.

"This is not an occasional thing. This was day after day after day operating on children who would say, 'I was lying on the ground after a bomb dropped and this quadcopter came down and hovered over me and shot me.'"

Three days after this evidence was heard, Jersey police launched a 6.30am raid on the home of peace activist Natalie Strecker for speaking out against what Israel has been doing in Palestine.

According to the *Jersey Evening Post*, 'police confirmed that having received a complaint, they arrested a 49-year-old woman on suspicion of an offence under Article 13.1 of the Terrorism (Jersey) Law 2002.'

Natalie was not the first to undergo such treatment, but is part of a growing number of critics of Israel, including

journalists, targeted in this way by the pro-Zionist UK state. Mum Clare Rogers had this to say after her daughter, Zoe, 21, was locked up as a terrorist after a protest against Elbit Systems, one of the arms businesses enabling the slaughter in Gaza: "Someone who believes so passionately in justice, is lamenting the deaths of innocent civilians and children. To be called a terrorist? That really disgusts me."

The authorities' use of the word 'terrorism' and their deployment of 'anti-terror' measures is extremely twisted. Defined as 'the use of violence against non-combatants to achieve political or ideological aims', actual terrorism seems to have most obviously been deployed by the likes of the British Empire, Soviet Russia, the U.S. Empire and Israel.

However, through their usual inversion of truth, all these regimes have instead used the terrorist label to describe those resisting or even just criticising the state's terror-inflicting activities, whether in India, France, Iraq or, as we have seen, Palestine.

When you think about it, the cynicism behind this manoeuvre is simply staggering.

It's worth setting this out plainly, particularly with regard to what is currently happening in the Middle East.

Deliberately murdering huge numbers of children is nothing short of evil.

Deliberately murdering huge numbers of children while painting yourself as the perpetual victim is very evil indeed.

Deliberately murdering huge numbers of children while painting yourself as the perpetual victim and having your critics arrested under terrorism laws is simply off the scale.

I have, since June 2023, been using the word criminocracy to describe those who rule over us.

Over the course of 2024, I have increasingly come to the conclusion that, although perfectly accurate, it is not strong enough to describe the real nature of the child-slaughtering global imperialist mafia.

I now think that a more appropriate term would be demonocracy.

UN global pact for the future

Guterres bids to make global governance great again

Nationalism is thorn in side for United Nations

THE United Nations Summit of the Future in New York saw 193 member states adopt a sustainable development agreement to try and save the image of globalism.

The Pact for the Future, Global Digital Compact, and Declaration on Future Generations reveal a sense of desperation to save the global governance movement from distrust, lack of credibility, and outdated processes.

According to the agreed-upon Pact for the Future: “We are deeply concerned by the growing Sustainable Development Goal financing gap facing developing countries. We must close this gap to prevent a lasting sustainable development divide, widening inequality within and between countries and a further erosion of trust in international relations and the multilateral system.”

Antonio Guterres, the UN secretary-general, opened the General Assembly by saying: “We are here to bring

multilateralism [globalism] back from the brink. I called for this summit to consider deep reforms to make global institutions more legitimate, fair and effective, based on the values of the UN Charter.”

The Pact for the Future, Guterres made clear, was “about turbocharging the Sustainable Development Goals and the Paris Agreement, accelerating a just transition away from fossil fuels, and securing a peaceful and liveable future for everyone on our planet.”

One of the most ambitious objectives of the summit in September was to expand and rebuild the United Nations’ powers. The organisation sees its current abilities as outdated and weak, and according to Guterres: “The United Nations Security Council is outdated, and its authority is eroding. Unless its composition and working methods are reformed, it will eventually lose all credibility.”

This expansion to meet their objectives is labelled ‘UN 2.0’ and this includes granting the Secretary-General increased decision-making abilities and more authority during public health emergencies.

According to the UN website: “Halfway through the 2030 Agenda, the world is not on track to achieve the Sustainable Development Goals. It is not too late to change course if we all rethink, refocus, and recharge.”

UN 2.0 encapsulates the Secretary-General’s vision of a modern UN family, rejuvenated by a forward-thinking culture and empowered by cutting-edge skills for the 21st century.

While the Summit of the Future seeks to rapidly rebuild trust, legitimacy, and control, the anti-globalist, populist

movement across the world continues to push back. The Council on Foreign Relations (CFR) reflected that pro-sovereignty politicians like Donald Trump threaten UN funding and success.

The CFR said: “UN agencies, programs, and missions receive crucial funding from the United States. The Trump administration sharply reduced funding to some UN agencies, but President Biden largely reversed those cuts.

“The United States remains the largest donor to the United Nations. It contributed more than \$18bn in 2022, accounting for one-third of funding for the body’s collective budget. Despite Donald Trump’s efforts to cut funding, Joe Biden affirmed the United Nations’ importance to U.S. foreign policy and increased funding to the organisation.”

On September 25, 2018, President Trump addressed the UN Assembly, thundering: “America will always choose independence and cooperation over global governance, control, and domination.”

The Summit of the Future remains a developing story.

Russia is not the enemy

U.S. coordinated aggression sparks Putin pushback

THE doctrine of hatred for Vladimir Putin has been heavily instilled into the public consciousness by the U.S. Empire.

But this short-sighted policy of belligerence towards Russia by the political West has not always prevailed.

In 1983, Margaret Thatcher was persuaded by her Foreign Secretary Geoffrey Howe, and other foreign policy advisors, that it was time to re-examine Britain's relationship with Communist Europe, and establish some high-level contact with the eastern half of the European continent. A new policy of engagement ensued.

In 1984, Thatcher went to Hungary, Howe visited every Warsaw Pact capital, and an invitation was issued to Mikhail Gorbachev – who had become number two in the Soviet Communist Party hierarchy – to visit Britain. He came in December and significant discussions took place at Chequers.

Thatcher, whose relationship with Ronald Reagan was close and easy, immediately reported to him on the success of Gorbachev's visit at a specially convened Camp David meeting. Three months later, in March 1985, Gorbachev became Soviet leader.

Before becoming leader, Gorbachev was isolated in the Politburo (the principal policymaking committee of the communist party) in seeking radical political reform, and in his readiness to transform Soviet foreign policy.

But as party leader, he was able to bring in like-minded allies.

Reagan and Gorbachev were able to agree that 'mutually assured destruction' was insanity, and worked together to limit nuclear weapons and end the Cold War. By 1986, they even came close to agreeing a policy for ridding the world of nuclear weapons.

Gorbachev's domestic policy of supposed Glasnost (openness) and Perestroika (restructuring) allowed for enhanced freedom of speech and freedom of the press, and sought to decentralise economic decision-making to improve

efficiency, but he was cautious about adopting a market economy as his actions did not stem from economic necessity, as often assumed, but from a genuine desire for political reform.

In 1990, after the fall of the Berlin Wall, the U.S. pushed for a united Germany inside NATO. To get Gorbachev to agree to this, Washington pledged that NATO would not move "one inch further to the east". He trusted that the aim of developing a new common architecture of cooperation in Europe was a mutual one.

In 1991, the Soviet Union dissolved the Warsaw Pact. Soviet and Russian leaders gave up territory, military allies, and sacrificed security, trusting the West's assurances.

At the end of that year, Gorbachev was succeeded by Boris Yeltsin who, through dubious privatisations of key industries, became the midwife of the oligarchs. Western economists stepped in to sell off the country's most valuable resources for peanuts, which benefitted not only the Russian oligarchs, but also the West.

After Yeltsin's sudden resignation in 1999, Washington expected his successor to be another compliant puppet, but instead they got Putin. Putin renationalised the oil and gas industries to improve the standards of living of his people across the board. Privatisation is the Holy Grail of Western capitalism, so he was immediately condemned for 'errant behaviour'.

But if the 1990s were meant to herald a new era of peace and cooperation, the

U.S. Empire had other ideas.

They saw the end of the Cold War as removing any constraints on U.S. dominance, and an opportunity to implement the 'Wolfowitz Doctrine' of U.S. unilateralism and pre-emptive military action.

Their plan was to crush emerging centres of power at all costs, and rule the world for the next century. This meant betraying the trust that Gorbachev had placed in Washington and disavowing the undertakings given not to expand NATO eastwards.

Moreover, numerous international treaties and covenants stipulate that the concept of 'security' is indivisible. States may not enhance their security at the expense of their purported adversaries.

But the U.S. Empire broke all its promises, and lost no time in proceeding, through various means, to incorporate every single country on the European continent into NATO, right up to the border of the Russian Federation, where it positioned its weapon systems.

German intellectual and former journalist Prof. Dr. Gabriele Krone-Schmalz highlights the importance of understanding Russia's geography and history.

The U.S. has oceans to the west and east of itself. In the north it has NATO ally Canada, and in the south, Mexico. Russia has fourteen neighbours, and over 22,000 kilometres of land borders, which are difficult to defend over long stretches. With some of these countries,

relationships are strained. It also has a painful history of invasion.

By 2007, it was clear to Putin that the promise of a multi-polar world had been a deception. At the Munich Security Conference, he stated that Russia did not accept Washington's rules based on a uni-polar world. From then on, the campaign against him intensified.

In 2008, Washington sent a U.S. supplied and trained Georgian army into disputed South Ossetia, resulting in the deaths of Russian peacekeepers and civilians. The plot failed, but Putin took no steps to reincorporate Georgia into Russia, putting paid to NATO propaganda that Putin wants to reconstruct the Soviet Union. Unlike Washington, Putin has the wisdom to know he has enough managing the well-being of the Russian Federation.

So Washington turned its attention to Ukraine to goad Putin.

As secretary of state Victoria Nuland boasted, Washington spent \$5bn organising NGOs, students, and purchasing Ukrainian politicians, in support of a coup to overthrow the democratically elected Ukrainian government, and install a neo-nazi regime hostile to Russia.

The New York Times recently reported that the U.S. has been operating twelve secret CIA bases directly on the Ukrainian-Russian border for about eight years.

As an immediate neighbour with special historical and emotional significance for Russia, Ukraine was the breaking point.

The U.S. Empire has created a totally unnecessary morass, as Russia was not threatening anyone.

Empires are at their most reckless as they collapse, and their greed and hubris most visible. The insatiable appetite for war, and the endless diversion of funds and resources to this end, disembowels and impoverishes the nation at home.

Today, far more Americans than Russians live in poverty and, despite all efforts to the contrary, Russia's economic growth is outpacing every Western nation's. Germany's industry is in crisis due to the sabotaging of the cheap energy supply they previously had on their doorstep.

Remembering ‘Father of Reform’

Ex-naval officer laid foundations for democratic change

If you were to rescue four people from drowning, on four different occasions, you might expect to be famous for doing so.

Perhaps you would even receive a little medal or scroll, which you could modestly display in the downstairs loo.

But the achievements of Major John Cartwright were such that the four rescues he carried out during his lifetime are nothing but a curious footnote to the story of the man known to history as ‘the Father of Reform’.

He was born in Nottinghamshire, in 1740, to a landowning family which, while still well connected, had once been rich but was now merely comfortable.

John joined the Navy on leaving school, saved a comrade from drowning, and rose in rank rapidly. Serious health problems resulting from his service forced him to return home in 1770 as a convalescent. This turned out to have a significant effect on his life, since he spent much of his time reading – and he began to develop ideas about constitutional matters, which would eventually lead to this distinguished military veteran appearing in court at 80 years of age charged with sedition – the crime of organising or encouraging opposition to a government.

As the war between Britain and its American colonies approached, Cartwright became convinced that it was the Americans who had right on their side. Though still a serving naval officer, in 1774 he published a pamphlet arguing that the colonists had an inalienable right to govern themselves.

Despite this, the Navy offered him a commission in American waters the following year. He turned it down, and that was pretty much the end of his career. He became known for the rest of his life and to posterity as Major Cartwright because he was appointed to command his local county militia – though he was eventually sacked from that position due to his political activities.

Take Your Choice! was not an 18th century game show, but the title of the most famous of Cartwright’s eighty or so publications, issued in 1776. It was a seminal work, influential on generations of reformers, and arguably the first work in English to set out a modern view of parliamentary government.

The Father of Reform had come to the conclusion that humans are born with rights and liberties – we are not given them

The Six Points OF THE PEOPLE’S CHARTER.

1. A VOTE for every man twenty-one years of age, of sound mind, and not undergoing punishment for crime.
2. THE BALLOT.—To protect the elector in the exercise of his vote.
3. NO PROPERTY QUALIFICATION for Members of Parliament—thus enabling the constituencies to return the man of their choice, be he rich or poor.
4. PAYMENT OF MEMBERS, thus enabling an honest tradesman, working man, or other person, to serve a constituency, when taken from his business to attend to the interests of the country.
5. EQUAL CONSTITUENCIES, securing the same amount of representation for the same number of electors, instead of allowing small constituencies to swamp the votes of large ones.
6. ANNUAL PARLIAMENT, thus presenting the most effectual check to bribery and intimidation, since though a constituency might be bought once in seven years (even with the ballot), no purse could buy a constituency (under a system of universal suffrage) in each ensuing twelve-month; and since members, when elected for a year only, would not be able to defy and betray their constituents as now.

as gifts by rulers.

Only by a person’s own criminality could he lose those rights. Any attempt otherwise to deny or restrict them was, therefore, unconstitutional. *Take Your Choice!* (which he later reissued under the less eye-catching title, *The Legislative Rights of the Commonalty Vindicated*) put forward the demands that every man should have the vote, that voting should be by secret ballot rather than by public declaration, and that parliaments should be elected annually to

reduce the opportunity for corruption and power-grabbing.

The Major was what we might call a ‘popular front’ campaigner, forever trying to achieve unity in action between all who supported reform, from the most respectable moderates to the most determined revolutionaries. He was unusual among the prominent reformers of the 18th and 19th centuries, in that he doesn’t seem to have made enemies easily. He was known as a courteous, generous man, who rarely got on the wrong side even

of political opponents.

Despite the ill-health which had dogged him since his Navy days, Cartwright spent decades campaigning at a punishing pace. As well as the lost liberties of the British people, he organised against the slave trade and for the independence of small nations swallowed by empires. He routinely worked eleven-hour days, fitting his political duties in around his work as an innovative agricultural landowner.

In his sixties, he started the most exhausting activism of his life – repeatedly touring the country, giving speeches, collecting petition signatures, and helping to establish local pro-reform branches, despite the many laws designed to prevent doing exactly that.

His family’s position in society had protected him to a great extent from state persecution, but now he was going too far. His first arrest came in 1813, but it wasn’t until 1819 that he was finally brought to court and successfully prosecuted after having spoken at an ‘illegal’ meeting.

He asked the judge to jail him, but this was refused and he had instead to pay a fine of £100. He carried on his work until his death in 1824; his funeral was held in Finchley, near London.

There’s no doubt that Major Cartwright was a ‘gentleman reformer’ who saw a future in which the country would continue to be governed by much the same type of chaps as before, but in a less tyrannical, self-interested and corrupt manner.

He was certainly no revolutionary, nor a full-blooded democrat. But when you begin something, you don’t always have control over where it leads. The Major’s importance to the continuing struggle for democracy lies largely in the fact that his ideas provided a basis on which, later in the 19th century, working-class campaigns would build on. Long after his death, Cartwright was still being quoted as a constitutional authority by successive waves of reformers.

John Cartwright wasn’t the only famous member of his family. His brother Edmund, a clergyman, is remembered as the inventor of the power loom.

Covid-19 was a military operation

CONSENT is being manufactured for diverting taxpayers' money away from domestic spending to the so-called 'defence' budget. It's what Starmer calls: 'making the difficult decisions'. It's transparently nefarious.

The new Dutch minister of health, Fleur Agema, admitted in the Dutch Parliament on October 24 that "covid health policies" were dictated by NATO under "treaty obligations", and executed through the Dutch intelligence services NCTV. It's official: covid was a U.S. military operation that had nothing whatsoever to do

with healthcare.

Former pharmaceutical research executive Sasha Latypova explained two years ago that the pharmaceutical industry's main role in the pandemic project was to provide cover for a military bioterrorism programme. Pfizer and Moderna were effectively paid for their brand names, so that people would think they were getting a pharmaceutical product, when in fact the injectibles were under military control, and categorised as 'prototypes' or 'counter-measures'. Hence the immunity shield for the pharmaceutical companies. I reported Sasha Latypova's findings in issue 34 of *The Light*.

Whistle-blower Brook Jackson was hired by a Texan research group, Ventavia, that had been contracted by Pfizer to conduct notional clinical trials of 'covid-19 vaccines'. She was a regional director, and reported fraudulent practices she observed with the trials to the U.S. drug regulator (FDA), who chose to ignore them.

So she sued Ventavia and Pfizer under the False Claims Act, but Pfizer had the suit dismissed on the basis it was not subject to clinical trial regulations, or federal laws, regarding its vaccine development and marketing, because they weren't vaccines but 'counter-measures', transacted with the U.S. Department of Defense under military contract.

Further, according to Latypova, there is no legal requirement for 'counter-measures' to correspond to what the label says.

NATO's purpose is to wage covert war on the populations of its member states, and overt war on countries that threaten U.S. world dominance. It is not a defence alliance but a warmongering organisation.

Dr. Paul Craig Roberts wrote in an article on *Global Research* on 26th November:

'The insanity of the West is so extreme as to be incomprehensible. Not satisfied with taking the U.S. and Europe to war with Russia by firing missiles into Russia, the NATO military committee is openly discussing pre-emptive missile strikes on Russia. This is extraordinary. At the present moment, it is only Putin's patience that stands between life and death on Earth.'

The Dresden firestorm

Another appalling Allied war crime

The 1,000+ bomber raid commences

On the night of February 12, 1945, over 1,000 allied bombers attacked a non-military, civilian target in Germany, the town of Dresden.

Dresden was the adopted home of several hundred thousand refugees from the far east of Germany, who were attempting to flee the marauding Russian hordes rapidly advancing westwards towards Berlin.

There were no military installations in Dresden, or camps, no munitions factories and no heavy engineering that could have been linked to Germany's war efforts. Dresden is a medium-large sized historical town with no strategic importance whatsoever.

What happened in the space of twelve terrifying hours should live forever in the annals of shame of the human race. It is thought that as many as 4-500,000 innocent people died that night. In many cases, theirs was not a quick death but a slow agonising one through being 'eaten alive' by the phosphorus and subsequent firestorms generated by the nearly 4,000 tons of incendiary bombs dropped by the Allies.

More than 12,000 houses in the centre of the city were

reduced to dust, not rubble, during the hellish firestorm. In view of the fact that, in addition to the 600,000 inhabitants of Dresden, another 5-600,000 people, all refugees, had found shelter in the overcrowded city, one can safely assume that each of these 12,000 houses contained no fewer than 20 people. But of these houses virtually nothing remained and the people who had been sheltering in them were transformed into ashes due to a heat of greater than 3,000 degrees Fahrenheit being generated by the incendiary bombs.

No defence

At the time of the attack, Dresden had no anti-aircraft guns and no military defence. It possessed no military industry at all, and served as a shelter for refugees from the east, many of them ill, starving, emaciated and disabled. Indeed, many roofs of buildings where they were housed were marked with huge red crosses.

Churchill had said..."I don't want any suggestions how to destroy militarily important

targets around Dresden. I want suggestions as to how we can roast the 600,000 refugees from Breslau in Dresden."

But for Churchill, simply 'roasting' Germans was nothing like enough. On the morning after the firebombing of Dresden, he ordered low-flying planes to machine-gun the survivors on the banks of the river Elbe where they had dragged themselves to try and find shelter from the suffocating heat, by water immersion. Dresden's citizens barely had time to reach their shelters. The first bomb fell at 10.09pm and the attack lasted 24 minutes, leaving the inner city a raging sea of fire. Precision saturation bombing had created the desired firestorms.

The firestorms

A firestorm is engendered when hundreds of smaller fires join together and become one vast conflagration. Huge volumes of oxygen are drawn in to feed the inferno, causing an artificial tornado. Those unlucky enough to be caught in the rush of wind can be

hurled down the entire length of a street into the flames. Indeed, such was the power of the conflagration that night that air was sucked from basements and sewers where the populace hid in large numbers, suffocating many thousands to death.

An eyewitness who survived told of seeing "young women carrying babies running up and down the streets, their dresses and hair on fire, screaming until they fell down, or the collapsing buildings fell on top of them."

The second wave

There was a three-hour pause between the first and second raids. The lull had been calculated to lure civilians from their shelters into the open again. To escape the flames, tens of thousands of civilians had crowded into the 'Grosser Garten', a beautiful area of parkland nearly one and a half miles square in area. The second raid came at 1.22am with no warning, as the early warning sirens had been destroyed in the

first attack. Twice as many bombers returned with another massive payload of incendiary bombs. The second wave was intended to spread the raging firestorm into the Grosser Garten and it was a complete success. Within a few minutes, a sheet of flame ripped across the grass, uprooting trees and littering the branches of others with human body parts. For days afterward, they remained bizarrely strewn about as grim reminders of Allied sadism.

Others hiding below ground died, but they died painlessly - they simply glowed bright orange and blue in the darkness and as the heat intensified, they either disintegrated into ashes or melted into a thick liquid, three to four feet deep in places. Shortly after 10.30am on the morning of the February 14, the last raid swept over the city. American fighter-bombers pounded the rubble that had been Dresden for a full forty minutes, but this attack was not nearly as heavy as the first two.

Totally unjustifiable mass

murder of innocents

What distinguished this raid was the cold-blooded ruthlessness with which it was carried out. U.S. Mustangs appeared low over the city, strafing with machine gun fire anything that moved, including a column of rescue vehicles rushing to the city to evacuate survivors. One assault was aimed at the banks of the Elbe River, where refugees had huddled together during this terrible night.

In Dresden, the Allied airmen under the orders of the Allied butchers fronted by Churchill, murdered several hundreds of thousands of people in one single, hellish night and destroyed countless cultural treasures.

What justification is there for this utterly repugnant behaviour? Is it revenge, hatred, blood-lust or ritual sacrifice? It is a mixture of all of these, but no sane, rational human being behaves in this disgraceful, cowardly fashion.

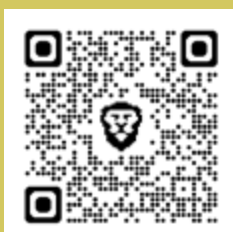
