Government policies based on falsehoods

WHEN you repeat a lie often enough, it eventually becomes accepted as fact.

Council tax and the rule of law

ON September 20, 2023, the Leighton judgement was handed down to protect the public from having their property seized by debt collectors.

Campaign group PeaceKeepers has since promoted this judgement, as not only does it stop enforcement agents (formerly bailiffs) in their attempts to confiscate your possessions, it also opens a path towards suing them for harassment.

It is also a means to stop councils up and down the country from pursuing what PeaceKeepers assert to be an unlawful demand for money through council tax.

To obtain this tax, local authorities will use the threat of court action, bankruptcy, an attachment of earnings order (allowing for money to be taken directly from your wages), a charging order against your property (after which the council may look to sell your home out from under you) or, ultimately, imprisonment.

In summary, Leighton successfully sued the enforcement agency, Bristow & Sutor. That success hinged on paragraph 26(1) (b) of Schedule 12 of the Tribunals, Courts

and Enforcement Act 2007, which states that an enforcement agent must show evidence to the debtor and any person who appears to be in charge of the premises upon request.

Ordinarily, when asked to evidence their authority to act, an enforcement agent will airily wave a bit of paper or show a screenshot produced by the council.

In this particular instance, Mr Leighton challenged the presumption that the bit of paper had any authority whatsoever; after all, most people own a printer these days.

Instead of cowing before the letter, Mr Leighton requested the court order itself.

The judge ruled that, although the enforcement officer was acting in good faith on a letter provided by the council, once Mr Leighton requested to see the actual authority itself (the court order) and not hearsay evidence provided to the enforcement agent by the council, then the grounds for the enforcement agent to act were removed.

In short, when asked, the enforcement officer must provide the actual order from the court. This is, to fair-minded people, not unreasonable, and the fact that they did not provide this ultimately paved the way to Mr Leighton's successful claim for damages.

How different then is it to require the same of a judge, sitting at the request of a council, to make an order for any one of the following enforcement actions: an attachment of earnings order; a charging order; bankruptcy; and committal?

For PeaceKeepers, it is no different and, as such, a number of challenges in this respect have been brought before the courts; specifically with respect to charging orders, where we have not yet had an opportunity to test this simple precedent to those other means employed by councils to extract payment. All anyone is asking for is the original court order that proclaimed the debt.

A month or so back, in a charging order hearing where this simple request was made, the judge sitting at that time determined, despite its absence, to make a final charging order.

When challenged specifically on this point, the judge declared that he might be wrong (to require the order to be produced when challenged, as opposed to a reliance upon what is simply council paperwork) and that the person to whom the charging order would be applied would need to take it up with the circuit judge. An appeal has been lodged.

Then, a few weeks later in a similar

hearing, and with the same request made, the judge adjourned the hearing so that the council or the respondent could produce the original court order. As the judge noted, should the original court not be able to produce the order, then that would raise serious concerns in his mind.

Lastly, hot on the heels of the adjournment above, a further charging order hearing took place where the defendant, having faithfully followed the PeaceKeeper protocols, turned up equipped to defend his property from a charge being applied in the absence of any demonstrable court order.

Startlingly, the council failed to attend (to our knowledge this has never happened before) and the judge, as is proper, gave a default judgement against the council, dismissing their application for a final charging order.

Something is happening within both the councils and the judiciary.

Perhaps the absurdity of having to force the judiciary to produce the alleged court order that creates the debt (we've never seen one despite numerous requests) is starting to dawn in the minds of our judges.

Let's hope so, as these court orders are the root of so much harm through the taking of possessions, wages, homes, and liberty.

Once this nonsense is dealt with, we can then get down to having the judiciary begin to answer much more important questions, like how can it be lawful that the Human Rights Act (1988) places the right of government to take what they want, when they want, howsoever they want, ahead of your basic human right to shelter?

The NoCNoC challenge from PeaceKeepers – which questions the authority of councils to demand tax – is shortly to enter its fourth year.

People have taken up the challenge and, despite all the threats, have stood their ground to the point of risking their homes.

Despite the best efforts of the courts to ignore us, they are now having to pay attention to what it is that we are saying.

The courts are finding that in all that we do, there is one simple request – to uphold the only inheritance of ours that matters: the rule of law.

Call for national inquiry into rape gangs

‘Official collusion’ allowed for young lives to be destroyed

The Workers of England Union (WEU), supported by the English Democrats Party, has written to Home Secretary Yvette Cooper on behalf of the thousands of girls who have been systematically raped and pimped by predominantly Pakistani-heritage Muslim child-rape gangs

WEU are therefore seeking a National Statutory Inquiry along the lines of the Post Office Horizon Scandal Inquiry, which forced the senior people involved to attend the inquiry and answer questions on oath, which can then be used in subsequent criminal prosecutions and in civil litigation for the victims.

The reason for demanding a National Statutory Inquiry is that only inquiries such as there are headed by a High Court judge armed with full legal powers to compel all the criminals, and also all those who aided and abetted them, to attend and be cross-examined under threat of imprisonment, as well as produce any relevant documents.

WEU have demanded a National Statutory Public Inquiry be set up, not only to investigate the gangs and their activities, but also the systemic collusion of police officers, social workers, council workers, councillors and national politicians, who instead of focusing on stamping out the appalling criminality of these gangs, have colluded in suppressing the public knowledge of what was happening, in the interests of diversity, and also politically, in the interests of politicians’ and police officers’ careers.

Instead of doing their duty to eradicate the criminal gangs, the officials have focused on attacking those who sought to raise the issue.

Only a handful of reports have ever been launched into this terrifying pattern of abuse. They have focused on Rotherham, Rochdale, Telford and Oldham. None of these reports have been armed with the powers to compel witnesses that a statutory inquiry would have.

In almost every major town and city across Britain, children were groomed by gangs of men to be used in the most horrendous forms of child abuse. Their desecration went beyond the horror of rape and sexual assault; they were often plied with alcohol and drugs, tortured, trafficked, violently beaten, branded with the initials of their rapists, treated like meat, subjugated in the most reprehensible conditions and generally subjected to a level of treatment beyond the imagination of all but the most disturbed and perverted mind.

The extent of the child rape and pimping gangs’ activities extends, as GB News investigations have found, to at least 50 cities and towns in England. It appears to have been going on for 20 to 30 years and has ruined the lives of at least 100,000 girls.

estimated that it might be one million girls. We think that a reasonable and conservative estimate of the number of victims is 250,000.

When it is considered that there are not only the actual gang members, but all of their many thousands of paying ‘clients’ and the collusion of thousands of officials, social workers, police officers and politicians, it is no exaggeration to say that this is probably the greatest criminality in English history.

Exposing involuntary euthanasia

MANY thousands died from all kinds of questionable and sinister causes in the UK over the last five years.

Some of the stories told were hard to comprehend, especially those that focused on the apparent culling of some of the most vulnerable members of society in hospitals and care homes.

Coming to light now, however, is a vast array of incontrovertible evidence in the form of medical records, drug charts and witness and expert testimony. It is proof that many innocent souls were involuntarily euthanised via certain NHS protocols and NICE (National Institute for Health and Care Excellence) guidelines.

In May 2020, while writing an article on Do Not Resuscitate (DNR) orders (initially commissioned by *The Telegraph*), I spoke with a whistleblower cardiologist who told me blanket DNRs were being put on a whole new range of people with the ‘pandemic’ being used as the reason.

Instead of DNRs being put on the terminally ill as they always had been in the past, they were now being put on anyone over the age of 60, the mentally and physically disabled, people with mental health issues of all ages – even on children with autism!

The doctor’s actual words at the time were: “I am horrified by what is happening at NHS hospitals across the UK right now. All patients over 60 automatically get a DNR, without them or any family members being consulted.

“I’ve seen the forms in their files with my own eyes. It’s not just the over 60s that get them – I’ve seen them being put in place for young people with mental health issues, for physically disabled people of all ages and for autistic people. We had a schizophrenic woman in her early 30s admitted recently and I found a DNR form in her file. She hadn’t been asked whether she wanted one or not.”

This doctor told me that individuals who would otherwise survive were being left to die, and added that many were being actively euthanised.

In 2021, while I was making the documentary *A Good Death*, I set up a WhatsApp support group, initially for the contributors to the film. There were about 15 of us in the group at the start; there are now 170. Among those are at least ten whose loved ones were 70 or under when their lives were cruelly snuffed out – some over a matter of hours with deadly cocktails of benzodiazepines and opioids (usually midazolam and morphine).

Involuntary euthanasia – the active hastening of death without consent – is proving to have been rife during the pandemic

But it wasn’t just the elderly and terminally ill who were victims

Stevie Kennedy says her 57-year-old mum, Angela, was murdered in hospital after being overdosed with midazolam and oxycodone in November 2020.

“My mum was hospitalised on October 3, 2020. She suffered from leg ulcers, and the pain had become so bad that she was screaming in pain and terrified she was going to have a heart attack. She couldn’t stand or walk at all that day.

“She was in hospital for eight weeks, treated terribly, sent to the ICU (intensive care unit), and had her right to bodily autonomy violated as they plied her with drugs. One day my brother went to visit her. She was screaming at him to pull off the bandages they had forced on her ulcers without giving her pain relief first.

“He got the bandages off her, but the nurses yelled ‘you’re not a doctor’ at him and three of them tried to physically drag him out. After nearly eight weeks there, two occupational therapists said

her progress had been amazing and said she’d be able to go home soon. The following day, my mum’s asthma was bad.

“I was told she had covid and that if she got any worse they would ‘not escalate’. My brother and I contacted the chief executive by email and told them our mum did not consent to a DNR and neither did we. We then got a call, telling us to come to a meeting. There were seven of them and they kept interrupting us and contradicting themselves, trying to justify leaving our mum to die.

“They never mentioned the midazolam they were giving her, nor did they tell us they had withdrawn her regular meds. They let us see her. She seemed more drugged than ill. She was lucid but incredibly distressed. She said ‘I don’t consent to a DNR’ and ‘I don’t trust them’. I told her to keep fighting. That night, we were called and told our mum

was dying – that she was taking her last breaths. I asked if they’d taken her off the respirator; they said yes. I asked if they’d taken her off the respirator while she was still breathing and they said yes. I told them to put her back on the respirator immediately. I also reminded them that she did not consent to a DNR.

“We argued with them for ten minutes before they told us she had actually already died. In the notes, there are two different times of death. It says she was dead when they found her and that she’d taken off the heart monitor and respirator herself. The drug chart shows she was overdosed with midazolam.”

Stevie is not alone. Also deserving a mention in this article are the following:

- Sarah Lee, who lost her life to a deadly covid protocol.
- Rosalind Forshaw, whose son James, 47, was killed in Basildon hospital.
- Jane Roche, whose 54-year-old sister Jocelyn was drugged to death by hospital nurses.
- Nicola Evitts, who lost her dad Martin, 59, to NICE guideline NG163.
- Michele Dawson whose 68-year-old mum Christine was ‘put down like a dog’ in hospital.
- Mark Ryall who lost his mum Dawn, 60, after a morphine and midazolam overdose in hospital.

There are several more – one of the victims was 21 years old and another was 17 – who can’t be listed here for legal or privacy reasons.

The husband of nurse Elena Vlaica was also a victim. Stuart Nisbet was 54 years old when he was involuntarily euthanised in a Cornish hospital in 2021. His story has already been covered by *The Light* (in issues 35 and 36). Appearing in the 2024 documentary, *Playing God*, Elena claims that “these doctors will put you down for pocket money.”

And, it would seem, whether you’re young or old, terminally ill or not, just doesn’t come into it.

Top 10 list of institutional insanity

Groupthink among leaders has led to catastrophe

1.

Sunlight is a natural disinfectant, immune-booster, and mood-enhancer. And yet in March 2020, inflicting maximum damage on the population, the government ordered everyone to stay indoors right the way through a luminous spring and early summer.

Outdoor sports help maintain good circulation, mobility, muscle strength, metabolic health, and psychological wellbeing through social interaction. But in December 2020, the order came to lock down again. This time, the government also closed football, golf and tennis clubs, and any other beneficial outdoor activities, until April 2021, to ensnare as many people as possible into taking poisonous potions under false pretences.

Between 1980 and 2001, the uptake of flu shots among seniors in the U.S. rose from 15 per cent to 65 per cent, and so did the number of deaths

from flu. This gave rise to a series of studies questioning the effectiveness of the flu shots after the billions spent on them over this twenty-year period. Thus in 2006, the U.S. Centers for Disease Control and Prevention (CDC) immunisation programme commissioned a study to adjust for all kinds of factors that could be masking the true benefits of the shots, to disprove there was any correlation between the flu vaccine and the continued rise in deaths from flu. But however they crunched the numbers, they got the same disturbing result. So they looked at data from Canada, Australia, the UK and France, and saw the same results – as the percentage of the population inoculated against flu rose, so did the number of deaths from flu. The CDC, nonetheless, continued to recommend the shots, and planned to extend them to younger cohorts and even children.

10. In the autumn of 2023, the CEO of a large NHS trust beseeched all those employed by the trust to get up-to-date with flu and covid vaccines, stating that she herself had had them all, despite having ended up spending the previous Christmas in intensive care, struggling for breath with a severe respiratory infection.

Propaganda is emotional hijacking

How to protect our families from unwanted influence

Eevi, a 17-year-old from Finland, stood in Trafalgar Square with her friends from the UK, staring at a neon-lit ad for a ‘mind-enhancing’ children’s tablet. The screen flashed phrases like ‘Unlock Your Child’s Genius!’ and ‘Every Parent’s Duty!’

“That’s propaganda,” Eevi said bluntly. Her friends scoffed. “It’s just marketing. Everyone exaggerates.”

“Exactly,” Eevi replied. “But when you know it’s propaganda, you can see through the lies and show others. This isn’t just an exaggeration - it’s designed to make parents feel guilty if they don’t buy it. And once you can explain how it works, you’re some way to being immune to its tricks.”

Her friends paused. “Wait, how do you

know it’s lying?”

“Because in Finland,” Eevi said, “we’re taught to call propaganda what it is – and that’s half the battle won.”

Propaganda isn’t rare or new. It’s as old as human communication: ancient rulers carved misleading battle victories into stone walls; medieval kings spread rumours about rivals; today, it’s in ads, social media, and even children’s cartoons.

To quote the film The Matrix, “The Matrix is everywhere. It is all around us. Even now, in this very room. You can see it when you look out your window or when you turn on your television.” Propaganda is everywhere, trying to get us to accept ideas, agendas and narratives.

Most people know propaganda exists, but

they don’t know how to explain its forms and then show others.

Think of it like this: if a stranger tried to sell you a magic rock that cures headaches, you’d laugh. But if that same lie is wrapped in a TikTok trend, a political meme, or a toy ad, many often swallow it whole. Why? Because they don’t pause to say: ‘This is propaganda. Let me dissect why.’

If you just say ‘it’s propaganda’ to someone, that is too abstract without allowing them to see why. When you point out, for example, that it is ‘the bandwagon effect’ and then explain its form and function, then they can see it. Often, they become curious as it highlights something that they did not previously know.

The public has a false sense of security that they can protect themselves from propaganda. If the last five years have shown us anything, it’s that this is a false and very dangerous idea.

You’ve named the method, and that is half the battle in propaganda self-defence. If you train yourself to protect your mind, you can do so for your family and others.

In Finland, children don’t just learn to spot propaganda—they learn to articulate precisely how it manipulates them. This turns vague suspicion into actionable defence. Here’s how it works:

The Name the Game rule

From age 7, Finnish students play a classroom game: every time they see an ad or social media post, they must identify and name the propaganda technique used:

- This toy ad uses ‘bandwagoning’ – it claims ‘everyone has it’ to make you feel left out.
- This influencer is ‘glittering’ the product by linking it to words like ‘freedom’ and ‘success’ without proof.

Why it works: Putting a label on manipulation makes it concrete. You’re not just sceptical – you’re armed with specific terms to explain why something feels off. It takes away the technique’s power when you become fully conscious of it.

The Explain it to a 5-Year-Old test

Teens are challenged to break down propaganda tactics into simple language. If you can’t explain how an ad or post manipulates emotions, you haven’t truly understood it.

Eevi’s class once analysed a viral video claiming a new snack would ‘make you as strong as a superhero!’ Their task: explain the lie to first-graders.

Why it matters: Being forced to simplify complex manipulation reveals its flimsy core. Propaganda thrives on confusion; clear explanation kills its power.

The So What? follow-up

Finnish teachers drill students to ask two questions after identifying propaganda:

1. What are they trying to make me feel or do?
2. Who benefits if I believe this?

When Eevi saw the tablet ad, she applied this instantly:

- “They’re making parents feel insecure about their child’s potential.”
- “The company benefits by selling overpriced gadgets to anxious families.”

This also shows people the advertiser’s true intentions and highlights how much consumers are subjected to this kind of manipulation on a daily basis.

Why articulation means armour

Knowing that propaganda exists is step one. But being able to explain its mechanics is what makes you bulletproof. Here’s why:

1. It stops emotional hijacking.
2. Propaganda works by triggering instant emotions – fear, envy, outrage. When you can pause and say, “This is using ‘appeal to authority’ with that fake doctor in the lab coat,” you shift from reacting to analysing.
3. It builds collective resistance.
4. Eevi’s friends initially brushed off the tablet ad as ‘just advertising’, but when she named the tactics – “They’re using ‘transfer’ by linking their product to ‘good parenting’” – the group started critiquing other ads nearby. Articulation turns personal doubt into shared scepticism.
5. It exposes the lie’s weakness.
6. Propagandists rely on you feeling confused or overwhelmed. When you can explain, ‘This post is cherry-picking data to scare people about vaccines,’ you reveal the trick. Lies hate sunlight.

How to practise Explanatory Self-Defence

You don’t need Finland’s schooling to start defending yourself. Use these steps:

1. **Play Propaganda Bingo.**
Learn a few techniques to play propaganda bingo and notice when they come up. Then you are on your way to propaganda self-defence. Imagine being a black belt at propaganda. You can then test your skills and keep improving.
2. **Play Spot & Explain with friends.**
Turn it into a game. When you’re out together, pick an ad and challenge each other to name the propaganda tactics. The goal isn’t to win – it’s to practice articulating what you see.

The Ultimate Defence: I See What You’re Doing

In Trafalgar Square, Eevi’s friends saw the tablet’s fine print: ‘Cognitive benefits not scientifically proven.’ They laughed, but one asked, “What’s the point of all this?”

“Propaganda loses power when you can explain its tricks out loud,” Eevi said. “It’s like telling a magician, ‘I saw you palm that card.’ Once you name the lie, it can’t control you.”

In a world where lies dress up as adverts, posts and memes, your greatest weapon isn’t just scepticism, it’s your ability to point at the manipulator and say: ‘I see your game. And I’m not playing.’ This creates a barrier to the propaganda’s effect. Imagine a world where the rulers cannot manipulate the public!

Next time you sense propaganda, name it, explain it, collapse it – that’s how you turn awareness into armour.

Climate, covid and conspiracy

New book by ecological scientist and activist Peter Taylor

RICHARD House [RH]: Tell us about your academic and professional background, and its relation to so-called climate change.

Peter Taylor [PT]: I have two degrees from the University of Oxford, one specialising in ecological sciences, the other in social anthropology with a focus on language and meaning. In 1980, I left the somewhat restrictive academic environment to set up my own research group as a service to the growing environmental movement. We set our own research agenda and then found patrons, at first within the movement – for example, Greenpeace, Friends of the Earth and the World Wildlife Foundation. Later, we were approached by governments, the European Commission and the UN for 'critical review' of environmental policy (for example, dumping radioactive waste at sea). My group consisted of engineers, planning specialists, biologists and chemists – all of whom forsook high-level careers.

In a review for the Countryside Commission in 1996, I realised just how simplistic the models were, and advised the commission to plan for climate change in either direction – warming or cooling; i.e. systems needed to be robust to any changes.

RH: Your 2009 book, *Chill*, certainly challenged the mainstream narrative about global warming. What were your main conclusions, and how was the book received?

PT: Initially, mindful of the impact of renewables strategy, I wanted to know how much time we had to make decisions affecting values of landscape, community and biodiversity. However, I concluded that the models weren't fit for purpose – climate cycles were absent from the computer projections led by the UN's Inter-governmental Panel on Climate Change (IPCC).

It became clear that some 75 to 80 per cent of the warming could be explained by cyclic changes which were right on time. This finding was at first received in silence by the environmental campaigners, followed by ridicule and refusal to engage in discourse. However, all the main banks set up meetings to discuss the financial implications of a potential bursting of the carbon-finance bubble.

Chill was read by some senior Conservative politicians – who at that time were in opposition. It was also reviewed in a science journal as 'essential reading' to counterbalance the UN's reliance

on modelling.

RH: I sense that you are very critical of the way genuine science is arguably being weaponised for malign, non-scientific agendas.

PT: Actually much genuine science, particularly regarding cycles, is simply ignored. What is being weaponised are impenetrable 'black-box' computer models that would require budgets of millions of dollars to unpick.

I would not say malign agendas: many scientists do believe in the model outputs, and are genuinely concerned for humanity. The problem is the authoritarian structure of science as an institution, beholden as it is to government agendas that require certainty of prediction, and which brook no caveats. The malignancy begins with the hidden influencers within regulatory bodies reliant upon scientific advice, and the vast funds unlocked to drive the renewables market.

RH: Not wishing to feel helpless in the face of all this, what would you say are the most effective ways for those who question climate change to undermine and challenge the mainstream narrative?

PT: There is no obvious way to influence the currently ensconced scientific advisors on issues of climate change. However, in the case of the new Trump administration, for example, the advisors are being replaced, and funding for models likely will be cut – but hopefully not the few honest scientists

working with real-world data.

The U.S. Congressional Hearings on the covid saga revealed how the regulatory bodies were captured by scientists beholden to big pharmaceutical interests, and who were willing to lie in the science journals about the origin of the alleged SARS-CoV-2 virus, in order to protect science as well as their commercial relations with China.

In Britain, the mainstream narrative, as led by the BBC and, until now, all political parties, has a policy of not engaging in discourse. There is of course the internet, but this is tricky territory for those without a scientific background.

Gradually, the good science, especially several very recent papers, will come out into the public sphere. It shows that at least 80 per cent of the recent warming is caused by thinning cloud cover and more short-wave radiation from the sun reaching and warming the oceans. The defenders of the faith clutch at the last straw that thinning cloud is a consequence of CO₂-warmed oceans. This is the height of ignorance, however, as the oceans have been warming at a steady rate since 1850 – one hundred years before the post-1950s massive increase in carbon dioxide emissions.

Until this rebellion among scientists wins out, there is little opportunity for challenging the mainstream narrative. I notice that with regard to covid, some top

virologists in the UK and U.S. are driving a change, but they don't draw attention to the network of bioweapons laboratories that lie behind the weaponisation of natural processes – including, for example, allegedly lethal bird-flu.

RH: Tell us about your new book; and what are your current (and future) research interests?

PT: The new book is a compilation of previously published articles (mostly in *New View* and *Caduceus* magazines) and aimed at a lay audience. In the book, I add to the climate updates with essays on covid and the lessons to be learned about science, captured regulatory agencies, commercial interests, and corruption in science journals.

I've recently published my scientific assessment in a science journal (link below), and am now engaged in networking with like-minded climate scientists.

However, my main interest and next book is the evolution of science and how it amputated half the human mind – the feminine elements of intuition and the spiritual elements of inner work as practised by the founding fathers of modern science, all of whom were alchemists or astrologers.

This is the work of the heart, and we see now the consequences of leaving the heart out of the equation: we are on the brink of another world war or the next staged 'viral pandemic', not to mention the gradual and deliberate destruction of ecosystems.

Keep it natural for a healthy diet

The Light interviews *Real Food* and *Food Maze* author Robert Elliot

Richard House (RH): Tell us how you got interested in the question of real food, Robert.

Robert Elliott (RE): Coming from a family background where cooking raw was the norm, I didn't really have too much to worry about regarding my diet. However, when I first met my partner, Sally, she pronounced me 'not very well', and insisted I be tested by kinesiology for food intolerances. My kinesiologist, Jayne, confirmed Sally's suspicions, presenting me with a long list of foods to be abandoned – the first step in rebuilding my gut biome.

Subsequent kinesiology sessions gradually restored homeostasis, but a sticking point was dairy. In a flash of inspiration, Sally asked Jayne to test me on raw organic milk; so I was tested for organic pasteurised milk and then raw milk. I again failed on the pasteurised milk but was 100 per cent fine with the raw milk. That was my light-bulb moment. Understanding that there might be a problem with processed foods – even when 'organic' – set me on the road to researching the difference between unadulterated food and its commercial equivalent.

RH: Your two acclaimed books, *The Food Maze* (2008) and *How to Eat Like There's No Tomorrow* (2009), were well ahead of their time, setting out your personal journey around food. To what extent is it possible to generalise about good eating, or is everyone's situation and personal journey a unique one?

RE: Everyone's situation is of course unique, in that we are all individuals, but good eating is certainly accessible to all. I've often been challenged with an 'it's alright for you' attitude, and I admit that living in Herefordshire does give us a lot of choice. But real, clean, unadulterated food is available everywhere, even if one has to go online.

Therefore, whatever one's individual situation, with particular regard to health, generalised principles can readily be applied because they represent simple common sense: avoid processed food – it will harm you; opt for foods your grandparents might have eaten, like fresh seasonal vegetables and fruit, meat, eggs, butter, unpasteurised cheese and milk. Processed food upsets our body ecology in so many ways that I would confidently state that, as a generalised principle, changing the diet in this way will quickly produce very positive differences.

As another general rule, avoid factory-produced, wheat-based products (e.g. supermarket bread, biscuits and cakes) and pasteurised dairy products, especially milk. Cut right down on sugar, even 'brown' sugar. Our bodies are not designed to deal with the quantities that are consumed these days. There's so much more that could be said, but these changes are a good start.

RH: Can you define precisely what you mean by processed foods? Nearly all of us have at least a few food vices that we try to convince ourselves won't do us any harm. And is it advisable, even necessary, to be hardcore purist about all processed foods?

RE: It's easier to start with a baseline definition of real food, i.e., food that is fresh, seasonal, produced organically (uncontaminated by chemical inputs) on a small scale, and unadulterated (in its natural state). From this foundation, we can broadly say that everything else is processed.

Thus, the issue is really one of degree. Milk, for instance, becomes processed once it is pasteurised, damaged further by homogenisation, and then ultra-processed when producing UHT milk. Bread is another good example of this. At the 'real' end of the spectrum we have sourdough bread – flour, water, salt, natural yeasts. At the other, we have the white sliced supermarket loaf which has around 16, mostly very suspect, ingredients.

Yes, we all have a few food vices and, yes, they will be potentially harmful; but the decision about what to eat remains with the individual. I am not a hardcore purist (Who doesn't like a slice of cake in a coffee shop?) and I wouldn't advocate it; but I have come to know my body, and it will soon tell me if I've taken a step too far. Comprehension, therefore, is the key, not proscription.

RH: I have health-savvy friends who say that in listening to their body, they know what's not good for them. Is this capacity inborn, or is it an ability that can be developed – or which even develops naturally with healthy nutrition?

RE: There are those who are lucky enough to innately understand their bodies' needs, but most of us are on a learning curve. My own personal experience is that I needed guidance from a kinesiologist to get me started. Once I'd cleaned up my act, however, I certainly became very aware of my body's reaction to the foods I was ingesting – to the extent that I no longer had an appetite for certain things, especially industrial wheat flour and refined sugar.

With my body back in balance, I felt lethargic after consuming cakes made with industrial flour. And I could taste the sweetness in vegetables – cauliflower for instance – so refined sugar became too much of a heavy hit for me; my body clearly recognising it for the poison it is. I believe that once we begin to reset our nutrition, our bodies do help us to stay on track and thus enable us to develop an instinct for self-preservation.

RH: What simple advice or guidance would you give to someone just setting out on a real food journey? And any chance of new, updated editions of your two books?

RE: My advice would be to memorise the definition of real food, do your best to locate it locally (farm shops, local producers, etc.), or go online if necessary – and be prepared to cook! Be aware of ingredients on packaged foodstuffs and avoid anything with an ingredients list that goes beyond simple. As for an updated edition of my books – yes, if I can find an interested publisher!

Challenging assumptions on ADHD

Consultant Psychiatrist Dr Sami Timimi interviewed by *by The Light*

RICHARD House (RH): Tell us briefly about your clinical and academic career, and your main specialisms.

Sami Timimi (ST): I've been a consultant child and adolescent psychiatrist (and psychotherapist) in the National Health Service since 1997. I research and write from a critical psychiatry perspective, and have published over 150 articles in mainstream journals, many book chapters, and have written seven books, co-edited four and co-authored two more. My latest book, *Searching for Normal*, was published in March.

RH: Your great work on the over-medicalisation of human distress has influenced a generation of critical psychologists and psychiatrists. Tell us about your work on so-called ADHD, and the continuity of that work with your more recent research and writings.

ST: Back in the mid-1990s, stories about ADHD were appearing in the UK press telling us how far behind we were, compared to the U.S., in recognising and treating a disorder called attention deficit hyperactivity disorder (ADHD). In UK child psychiatry at that time, we generally referred to 'behavioural problems' in children, and thought about them as being the result of relational and social causes. ADHD implied something different: that there was something wrong in the child – specifically, in the child's brain.

In 1995, my supervising consultant asked if I would help him with some research. He wanted to study the prevalence of ADHD among the local population (in a borough of East London) that had a high number of Afro-Caribbean background families. He asked me to conduct a literature review. I collected a big bundle of research papers, reviews, theoretical articles and historical tracts.

The more I read, the more confused I became. I was left with a disturbing feeling of not being able to capture what this new concept of ADHD was. What is meant by ADHD? Where did this

concept come from? Why are behaviours that are part of what I would consider everyday behaviours that children show, at least to some degree, considered part of a medical condition? And not just any condition, but one that is neurologically driven.

Try as I might to find some sort of empirical anchor to pin down this slippery concept, I couldn't. Surely ADHD isn't just the behaviours of attention deficit and hyperactivity? The circularity inherent in a supposed medical condition that is defined by a description that somehow causes itself seemed obvious to me. In the years since then, I've followed the research on ADHD and its treatment, and came to understand just how easy it is to turn an idea into a cultural 'fact'. Repeat a concept again and again (such as 'ADHD is a genetic brain-based abnormality that results from a lack of dopamine') and soon enough, we no longer have the idea – it has us.

Not only does it lead to exposure for developing nervous systems to substances we (rightly) warn adults about the damage they do to the brain and body, it also impacts on how you understand yourself and how others view you. ADHD has been a great teacher on the cult of scientism that has infected much of healthcare, and that we see in its purist crystallised form in psychiatry.

I now think that modern mental health ideology may be the biggest and most powerful cause of mental health problems today.

RH: Is this what you're getting at in your 2021 book, *Insane Medicine: How the Mental Health Industry Creates Damaging Treatment Traps and How You Can Escape Them*?

ST: That's certainly part of the message in that book. Once people internalise an idea that there is something wrong in them, it can set them up for a potential lifelong struggle with a part of themselves that they see as broken/pathological (rather than understandably troubled/distressed), which is not within their agency to deal with/understand/tolerate. They are now set up to try and suppress/control/remove that part of them that is experienced as lurking in the shadowlands of the mind, waiting to erupt into consciousness; a kind of modern spirit possession – only these 'djinn's' come from your genes/brain. When the recommended treatment (whether pharmacological or psychological) doesn't work, or alleviates only temporarily, then the sense of power these unreachable shadow feelings have are repeatedly strengthened.

RH: What new ground does your latest book, *Searching for Normal*, break for those yearning for a new paradigm in

mental health and wellbeing?

ST: I wrote the book to try and shed light on a finding that is now widely acknowledged. In countries that have the most developed and highest consumption of mental health services (such as the UK), mental health diagnoses are increasing, outcomes are deteriorating (such as rising levels of disability and mortality amongst those labelled with a mental disorder), and the response is a demand for even more services, rather than a questioning of the paradigm.

My conclusion is that we live in societies where there is an ongoing crisis of economic wellbeing and political legitimacy. Much of the population feels pessimistic and insecure. Feelings of alienation, not fitting in, and hopelessness about the future are scooped up by the commodification of emotional distress, leading to a mental health industrial complex that profits from this phenomenon, as well as relocating these sociopolitical problems from the social sphere to the space between the ears. As well as a more socialist orientation in our politics, I call for a paradigm that rehabilitates emotions from the sphere of abstract human typologies back into the ordinary and the understandable.

RH: Tell us briefly about the Critical Psychiatry Network, and your hopes for a new mental health paradigm gaining ascendance.

ST: The Critical Psychiatry Network is a non-binding, loose group of doctors who have a variety of critiques on mental health theory, policy and practice. We have expanded in recent years to nearly 500 participants in our network, and we hold a variety of collaborations, teaching events and an annual conference.

My belief is that a genuine paradigm shift away from the diagnostic dictatorship is inevitable. I think we are approaching the point where a critical mass within the professions will take us over that tipping point. I hope, for all our sakes, it comes soon.

Need to detox from the jab?

Suggested treatments for those harmed by covid shots

FOLLOWING on from the ‘Ten ways to detox’ article in the previous *Light* paper, here is what the experts recommend for people who regret having had the jab or suffering from spike glycoprotein side effects with inflammatory immune system responses.

Symptoms and treatments are largely the same as for long covid, and similar to the many covid treatments published on *HealthTruth.info*

Dr. Daniel Nuzum: The first step in detoxification is strengthening the immune system, starting with the liver and kidneys so they can deal with the toxins. This may take several months. Naturally we should not sabotage this process by eating junk food or re-poisoning our bodies.

Hydration is key. Most of our immune system is based in the gut, the foundation of detoxing. At least one bowel movement per day is good, intermittent fasting (14+ hours overnight) supports; a three day water fast is very efficient.

Exercise and massage activate the lymphatic system. Sweating detoxes – an infrared sauna adds many more health benefits. The respiratory system detoxes with each breath, the lungs need to be fit to get oxygen into the body.

Dr. Mark Sherwood: Chronic stress is the biggest toxin, and we need to detox from toxic media and relationships. Charcoal, bentonite clay or chlorella are binders helping to detox. If parasites are in our bodies, we’d need a different protocol.

Dr. Peter McCullough promotes a base spike detox protocol with nattokinase (2000 units twice a day), bromelain (500mg a day) and curcumin (500mg twice a day).

Dr Klinghardt adds: We must reduce electromagnetic field exposure from mobile phones, wifi routers, cell-phone towers, turn off the fuses, especially at night when the body detoxes. EMF

radiation is known to inhibit our detox processes and it activates covid.

Dr. Jana Schmidt recommends dandelion root tea, red raspberry leaves, senna, green tea (second brewing), natural vitamin C, bee pollen, frankincense, and good sleep to support detox. No processed foods, no soda drinks.

Dr. Cathleen Gerenger recommends N-acetyl cysteine (NAC), a precursor to glutathione, a powerful antioxidant protecting cells from damage caused by free radicals. Also milk thistle, artichoke, turmeric, choline, celery seed, niacin (vitamin B3), vitamin C and E, hawthorn, ginger, butchers broom root, broccoli sprouts.

A common practice in naturopathic detoxing is a vitamin C flush. Vitamin D3 is a significant factor in detoxification and also protects against environmental toxins. Zinc has antioxidant properties and it helps the body to recover from injuries.

Dr. Vladimir Zelenko: NAC and aspirin help prevent post-vaccine blood clots. Prophylaxis with ivermectin or hydroxychloroquine.

Dr. Eric Nepute uses high levels of high dose zeolites (a stripping agent) like clinoptilolites and proligna (a Scots Pine cone extract) to repair damages from gene-altering therapy. Also pulsed electromagnetic field therapy (PEMF), orthomolecular nutrition, nucleotide therapy, butyric, and butyric acid.

Dr. Ardis: Antioxidants protect from oxidative stress following pathogenesis triggered by the SARS-CoV-2 virus; he suggests cranberry juice or tablets with phosphoric acid to support kidneys. If a D-dimer test shows blood clots, he prescribes NAC, and for neurological symptoms bentonite clay. Consuming fish oil or omega-3 fatty acids helps. Four nutrients are proven to protect every cell from oxidative stress: vitamin C (5-10 g a day), zinc (50-100mg/day), hydroxychloroquine and ivermectin. This keeps zinc in the cells and protect the outside of red blood cells from being damaged by spike proteins.

Magnesium (any form) and olive leaf extract are good for damaged heart cells.

Dr. Ardis discovered that remedies for snake venom poisoning (nicotine, Vitamin C, glutathione, N-acetyl cysteine, EDTA) also treat post-covid vaccine symptoms. He recommends a daily nicotine patch and chewing 2mg tablets twice a day for two weeks (beware of addiction!).

Dr. Daniel Nuzum: Chlorine dioxide bonds to and neutralizes those spike proteins. Proteolytic (protein-digesting) enzymes need to be taken, not with food. He would use wormwood, cloves, ginger root, turmeric and black walnut hulls. TMG (trimethylglycine) and NAC (two amino acids), 2500 to 3000 milligram a day, are very antiparasitic. Support with herbal adaptogens like medical mushrooms, rhodiola, holy basil, ashwagandha.

Dr. Henry Ealy recommends a three-day water fast with nutrients, (serrapeptase, L-arginine & glutathione).

Robert Scott Bell suggests drinking water (best hydrogen water, and to filter water), using Nitrogen Oxide, fasting and milk thistle and coffee enemas.

Dr. Edward Group:

People should be taking zinc on a daily basis. To repair your DNA, you need something that contains the original memory of your DNA. We use the urotherapy in combination with everything else, like ivermectin, iodine, the CDS or the MMS, chlorine dioxide, supercharged C60, which we know will grab the graphene oxide and all those other contaminants out of the body and bring it out. We use quercetin, we use a good probiotic, we use Paratrex.

Water-only fasting brings the body back into autophagy state, where the body actually starts producing original stem cells. The third thing we use is stem cell therapy.

Urine contains over 3,500 different compounds and anti-poisonous substances, anti-inflammatory substances, urokinase (the number one drug to control blood clotting).

Other treatments include prayer, selenium, ozone, infrared from the sun, a fire or infrared sauna, and pine needle tea

And that, once again, their corporate media and political puppets are pushing their agenda, relaying their odious lies and intimidating those whose dare speak out against their crimes?

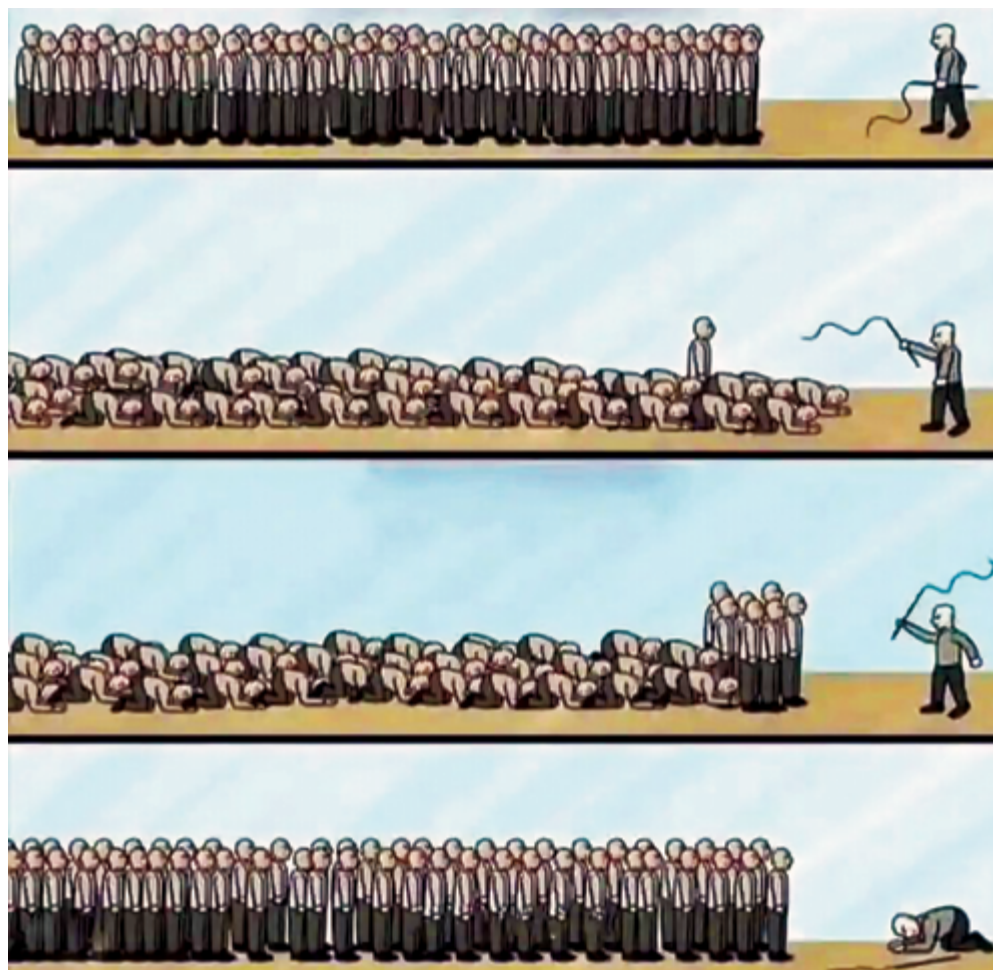

Unshackling science from limiting logic

Founder of Canadian Patriot Review **Matthew Ehret** interviewed by **The Light**

Richard House [RH]: Matt, your recent book *Science Unshackled* implies in its title that today's science is somehow shackled. Can you describe what's being shackled, and what the shackles are?

Matthew Ehret [ME]: What's been shackled is the substance of science itself. By that, I mean the creative powers of human thinking that, when awoken in any healthy individual, express the power of breaking free of the useful, but intrinsically limited framework of deductive and inductive logic through a power of passion, and instinct towards looking through the mind's eye for paradoxes/ironies. Those paradoxes/ironies occur in a specific universal form when theorem lattices bounded by certain specific axioms and postulates are tested against empirical reality. When this happens, all flawed theorem lattices will reveal discrepancies.

To the degree that there are more systemic discrepancies, the healthy-minded scientists (like a Da Vinci, Kepler, Leibniz or Weber, to name a few) will not run away, but will rather embrace the reality of those cognitive dissonances. In so doing, a natural internal dialectical process of the subjective self-inquiry and external objective inquiry into reality may take place.

This process was made transparent by the Greek philosopher Plato in such places as his Theaetetus dialogue, Meno and especially the Timaeus dialogue. That natural mode of analysis that bridges the subjective/objective divide, while imbued with a love for truth, is destroyed in systems of analysis that demand an obedience to facts derived from the sense data of sensorial impressions (aka empiricism), upon which Baconian scientific traditions are rooted, as much as they are destroyed in systems that demand blind obedience to formal abstract rules beyond the scope of analysis, such as those axioms and postulates proposed by Aristotle and Euclid.

To the degree that we allow the mind to be captured by any mixture of those two modes of logic (deductive and/or inductive), we will be forever deprived of making true discoveries of first principles, and thus resonating with the harmony of the universe

into which we were born. The ruling oligarchy understands this, and has found a number of techniques to keep us shackled within a framework of 'standard model' thinking over the course of many centuries.

RH: It's a revolutionary insight that the whole approach of modern empiricist science is fundamentally limiting or even flawed. So any properly founded science should proactively look for paradoxes/ironies that take us beyond conventional logic. Can you give a brief example?

ME: One particularly strong example referred to extensively in my book is the case of Johannes Kepler's vicarious hypothesis, as outlined in the first six chapters of his *New Astronomy* of 1609. In Kepler's day, all standard-model explanations of cosmology towards which 'respected academics' were expected to pay fealty was contained in one of three dominant models, which could all be arranged to 'explain' the visual data to nearly identical degrees, and all three contained virtually identical predictive power, making

judging any one as superior to another impossible. More details on this are in my book.

RH: In *Science Unshackled*, you refer to the 'cult of scientism masquerading behind peer review and a new technocratic priesthood of experts'. Can you expand on this insight?

ME: Throughout history, a small ruling oligarchy has been able to manage the vast majority of the world population, not by controlling every facet of existence, but rather by controlling the principled axioms pertaining to the nature of human nature and reality. Those axioms bound the infinite array of ponderable facts of life that determine what we are capable of, and in the peer review model of organising 'acceptable scientific discourse' in our modern age, a limited array of often anonymous 'expert reviewers' who all share common loyalty to a certain standard-model explanation of reality (and most importantly, the same core axioms) approves or rejects whatever scientific work gets published, regardless of whether submissions are

true or false. Only those submissions which adhere to the standard-model assumptions shaping reality are accepted as 'legitimate science', and the controls over human thought are thus maintained.

RH: What needs to happen culturally and epistemologically for mainstream science to embrace the kind of thinking in your book?

ME: Society needs to break free of the post-industrial model of stasis that has governed the past several decades, and re-engage with a commitment to take on new challenges, adopt concrete goals which demand that humanity presses once more upon the boundaries of ignorance, as we challenge prevalent axioms and models which define our limits of practicable knowledge about the universe.

By re-adopting a society with concrete goals requiring concrete problems to be concretely solved, as we did during the Second World War, prevalent models can be removed from the ivory tower and tested. Those dominant standard models which may appear elegant and impressive will then be able to prove their merit by assisting in solving problems, or simply generating more elaborate descriptions of the macrocosm or microcosm. Then we can reject what doesn't work, and accept theories that today's peer-review models reject, but which are necessary to crack the code on topics ranging from fusion power, astroclimatology, optical biophysics, and so on.

Whistleblowers expose Gaza ‘news’

Are Britain’s news editors deferring to a foreign power?

JOURNALISTS working at the *BBC*, *Sky*, *ITN*, *the Guardian* and *The Times* have spoken to *Declassified UK*, on condition they remain anonymous, to reveal how the ‘news’ reporting on the war on Gaza is skewed and shaped to comply with Israel’s requirements.

News editors of major British news organisations held private meetings with Israel’s former top military officer, General Aviv Kohavi, one month after the Gaza bombing began, *Declassified* revealed.

General Kohavi was previously Israel Defense Forces’ Commander of the Gaza Division and Director of Military Intelligence, before becoming Chief of General Staff of the IDF.

His meetings took place with Katherine Viner, editor-in-chief of *The Guardian*, Richard Burgess, director of news content at the BBC, and Roula Khalaf, editor of the *Financial Times*.

According to the General’s itinerary, further meetings were due to be held with *Sky News* chairman, David Rhodes, at the Israeli embassy.

The information about General Kohavi’s visit and schedule comes from documents obtained in Israel under Freedom of Information by lawyer Elad Man, and seen by *Declassified UK*. They reveal how his tour of Britain was planned with support from the Israeli Ministry of Foreign Affairs, the IDF and Ministry of Defence, to cultivate support for Israel as it escalated its military offensive in Gaza – ‘to influence influencers’.

Here are what journalists said across the mainstream outlets where *Declassified UK* gained access:

A *Times* reporter said: ‘I literally cried in the bathroom so many times because of the uphill battle of trying to get things reported and covered whilst facing an avalanche of obstacles. I felt like I was going crazy.’

A journalist at *Sky News* said: ‘We would see the raw footage from Gaza – we’re all aware of the carnage. Yet you can’t describe what your eyes are seeing’.

‘Myself and other colleagues found ourselves frequently frustrated at how nothing could be reported unless there was a response or confirmation from the Israeli army’.

‘Nor was any version Israel provided ever challenged. It was taken as fact, always.’ The reporter said he had challenged senior members of staff, reminding them that Israel repeatedly lies and has a history of doing so, but to no avail.

‘The Israeli narrative always reigned supreme and instructed the coverage at *Sky News*, no matter how inaccurate.’

‘To adopt a stance other than Israel having the right to defend itself, to push back against the skewed coverage, would earn you the label of difficult or rigid.’

‘If we had an interview with the Palestinian ambassador that comprehensively conveyed the Palestinian side, or a presenter challenged an IDF spokesperson, there would be an avalanche of phone calls and complaints. Israeli spokespeople or officials who had access to senior figures

would pressure *Sky News* and often threaten to pull access to correspondents on the ground as a result.’

At ITN, which makes programmes for ITV and Channels 4 and 5, a journalist who didn’t wish to disclose the exact programme he was working on, highlighted the callous attitude towards reporting on Palestine.

Guardian journalists informed *Declassified* anonymously that staff from both the U.S. and UK teams had set up an internal network in October 2023 to coordinate any dissent, and created an exhaustive spreadsheet to document egregious

reporting by the paper well-known for its deep MI6 connections.

‘There is a mountain of examples logged, whether it’s amplifying unchallenged Israeli propaganda in the reporting, or treating clearly false statements by Israeli spokespeople as credible.’

‘It’s damning that such mechanisms should be required at *The Guardian*. Worse still, there’s little contrition. Management is defensive and dismissive about it.’

They referred to the paper’s habitual use of the term, ‘ Hamas-run health ministry’, rather than the Gazan health ministry, to discredit information such as civilian casualties.

They described *The Guardian*’s strategy of suppression as ‘deceit by omission’, concluding: ‘It’s no secret that the coverage of the international and foreign desk of *The Guardian* follows the line of the British establishment anyway.’

The journalist who provided testimony to *Declassified* resigned from the BBC at the end of 2023, stating that their ‘principles and values did not align with the organisation or the people who work there’.

■ The author of a detailed letter to the BBC in November 2023, jointly compiled by eight UK-based BBC journalists, accusing the public broadcaster of ‘failing to tell the story of Israel-Palestine accurately’, also resigned. They said that, through a combination of omission and lack of critical engagement with Israel’s claims, the corporation ‘failed to help the public engage with and understand the human rights abuses unfolding in Gaza.’

■ More than a year later, they said they were ‘appalled to see how many of the issues highlighted have not been addressed. The BBC has uncritically amplified and legitimised Israel’s perspective even as the Israeli military continues to attack schools and hospitals.’

If journalists whose principles and values don’t align with the BBC have resigned, what does it say about the quality and accuracy of the coverage of those who remain?

North Atlantic tyranny and oppression

Member states begin to question warmongering overlord

THE North Atlantic Treaty was signed in Washington, DC, in 1949 by twelve founder members: UK, U.S., Canada, France, the Netherlands, Belgium, Italy, Luxembourg, Denmark, Norway, Iceland and Portugal.

During the Cold War years, four further countries joined the North Atlantic Treaty Organisation (NATO): Greece, Turkey, West Germany and Spain.

But by 1990-91, when the Soviet Union was being dismantled, the Warsaw Pact dissolved, East Germany reunified with West Germany, and nuclear disarmament was in discussion, some argue that NATO should also have been dissolved.

America, however, saw the end of the Soviet Union as its opportunity to achieve 'global full-spectrum dominance', using NATO as the tool. Since World War Two, it had become a military economy in constant preparation for war. It now has in excess of 200,000 troops in 177 countries, with the bulk of active duty personnel located at 800 major overseas military bases in 70 countries, the UK included.

Former FT journalist, Matt Kennard, in his book, *The Racket*, describes the role of a CIA sidekick called the National Endowment for Democracy (NED), the purpose of which is to undermine or remove governments that remained independent of Washington, DC.

He explains that NED operates in Eastern Europe, Latin America and Asia, and has also operated in the UK since approximately 2015, when anti-imperialist, Jeremy Corbyn, was elected leader of the Labour Party. Kennard found that the organisation has funded three British media outlets and four UK press freedom groups to ensure that the progressive end of the political spectrum aligns with U.S. foreign policy objectives.

Other journalists have revealed that NED's sister non-profit organisation, USAID (United States Agency for International Development), finances a sprawling network of media outlets, including the BBC's international charity, BBC Media Action. Journalist Lee Fang wrote on Substack that among these outlets are: The New Voice of Ukraine, VoxUkraine, Detector Media and the Institute of Mass Information, which spread rumours that American journalists and academics who favour peace negotiations with Russia are agents of the Kremlin.

Since 1999, NATO has incorporated into its bloc fourteen eastern European countries, plus Sweden and Finland that

border Russia. But to fully encircle Russia, it needs the buffer state of Ukraine. This was why, in 2014, Obama launched a coup to overthrow Ukraine's democratically elected president, Viktor Yanukovich, at a cost of \$5bn, to install an anti-Russian, pro-Western government in Kiev, protected by allegedly Nazi-oriented security forces (the Azov Brigade). Obama's coup triggered an influx of over a million Ukrainian refugees into Russia.

Robert Kennedy Jr. explained that the reason NATO wants Ukraine, and other countries on Russia's doorstep under its dominion, is because NATO membership comes with the obligation of standardising a country's weaponry and weapons systems in line with NATO's. In other words, NATO is a vast protection racket. Once a country gets dragged into NATO, it has to buy its weapons from designated defence contractors.

Beyond conventional weapons, NATO's second arm is biological weapons. The mRNA vials purchase was forced onto every member through illegal contracts that no country was able to debate internally. All safety requirements and regulations were bypassed under NATO directives.

Many of us wondered how the anti-democratic lockdowns, coercive emergency legislation, 24/7 propaganda

and forced injections were simultaneously coordinated across multiple sovereign jurisdictions, until we realised this was the NATO network enforcing its power to the benefit of corporate interests. In October 2024, the Dutch health minister admitted in the Dutch Parliament that 'covid health policies' were dictated by NATO under 'treaty obligations'.

The question is, why are European countries relinquishing their sovereignty and participating in their own wholesale economic and social destruction?

The Ukraine-Russia conflict was provoked by NATO's covert handiwork in 2014 to destabilise Ukraine, and when Russia took military action on February 24, 2022, NATO finally got the Russian military engagement it had sought.

If any doubts remain regarding NATO's aggressive intentions, just two weeks later, Russian and Ukrainian foreign ministers met in Turkey and agreed a 15-point peace deal brokered by Turkey and Israel, which Zelensky backed out of signing at the last minute under the direction of Boris Johnson and Joe Biden. Then again in April 2022, another peace deal was on the table, and Johnson shot off to Kiev to dissuade Zelensky from signing it.

Since the onset of the conflict, EU member states have collectively provided nearly

\$145bn in various forms of assistance to Ukraine. This has forced these states to either increase borrowing, leading to higher national debt levels, or divert funds away from domestic programmes of social care, health, education and infrastructure development.

In addition, over five million Ukrainian refugees now clamour for these services in an already beleaguered Europe. In the UK, Starmer and Reeves have increased taxation, increased borrowing and cut domestic spending.

The U.S. Navy, with help from its Norwegian NATO partners, blew up the Russian Nordstream gas pipelines in 2022, helping to send 'allies' Germany, France, the Netherlands and the UK into an economic death spiral.

Not content with destabilising northern European economies by sabotaging a major piece of infrastructure in the Baltic, and raising the price of American liquefied natural gas (LNG) as an alternative to triple its previous levels, EU-NATO's aim is a complete break with the Russian energy sector. On December 30, 2024, Ukraine terminated the transit contract of the Russian gas pipeline that ran through the country and supplied Hungary, Slovakia, Austria and Italy.

In January of this year, U.S. proxies sent drones to attack a critical part of the TurkStream gas pipeline that runs from Russia to Turkey. The drones were shot down and only minor damage occurred to the gas compressor station in south-west Russia.

Geopolitical analyst, Mike Whitney, wrote: 'The strategic objective of these attacks is to isolate Russia by blocking all attempts at economic integration, in order to divide the world into warring blocs.'

But Ukraine may well prove to be NATO's graveyard. Slovakia and Hungary are not complying with demands to commit economic suicide. Germany's rising Alternativ für Deutschland party (AfD) has floated the idea of relaunching the Nordstream pipelines, and strategic NATO member Turkey is aligned with Russia and Iran.

Religious belief branded ‘mental illness’

Pastor being ruthlessly persecuted by German authorities

IN a twisted tale of faith, betrayal and government overreach, Pastor Sven Mueller, a Christian missionary and leader of a Jewish Messianic Church, finds himself fighting for asylum in the UK after enduring horrific persecution at the hands of the German authorities.

His story raises serious questions about free speech, mental health exploitation and the increasing authoritarianism gripping Europe.

For over 15 years, Pastor Mueller served with unwavering dedication, preaching the Gospel and offering pastoral care to the community through untainted evangelistic work, streetpreaching, churchleading in various churches and bishops work, helping church leaders in Stuttgart, Germany.

But his peaceful work took a dark turn when, one fateful day, he was unfairly thrown out of a bookstore in Germany. His crime? Sharing a message of love and hope with the customers: “Jesus loves you, please read the Bible.” This simple declaration led to his ejection from the store, and soon after, the German police intervened, citing vague and unfounded claims of ‘aggressiveness’. In a shocking move, they demanded he surrender his driving licence without any valid reason.

But that was just the beginning of his nightmare. The authorities then demanded that Pastor Mueller undergo a psychiatric evaluation at his own expense – a staggering 700 euros – before they would even consider returning his driving licence. When he responded by writing polite letters to the police, explaining that their actions were criminal, their chilling reply came: ‘It doesn’t matter what people believe. You must undergo the psychiatric test.’

This blatant defiance of his religious rights escalated quickly: Pastor Mueller was subjected to two separate raids on his home by a team of 30 heavily armed officers. During these searches, they seized thousands of euros’ worth of personal

property, including his laptop, smartphone, a brand-new Swedish axe, fishing and sheep-farming knives, a DJI drone, USB sticks, and more. His possessions were taken without explanation, leaving him devastated and powerless.

The persecution grew even more sinister when he was forcibly detained in a jail cell for two days. His crime? Simply believing in the Gospel of the Lord Jesus Christ.

He faced three criminal court hearings without any credible charges or evidence against him, and despite the lack of any legal basis, the authorities now demand he serve a prison sentence of 18 months. The official justification? They claim his deeply held Christian beliefs are evidence of a

‘paranoid illness’.

In an exclusive interview, Pastor Mueller spoke candidly about his harrowing experience: “They said I am paranoid and ill, because I truly believe in the Gospel of the Lord Jesus Christ,” he told me, his voice filled with both frustration and sadness. “This is the painful reality that religious believers in some parts of the world face today. Where belief in the Christian faith is considered a mental illness and an offence against the state.”

But despite the trauma he has endured, Pastor Mueller has refused to be silenced. He sought asylum in the United Kingdom, hoping for sanctuary from the tyranny he faced in Germany. Unfortunately, his hopes

were dashed when he found the response from the Home Office equally dismissive. “The Home Office of Great Britain is also psychotic, ill and atheistic,” he stated. “I explained my situation to them for claiming asylum, but they said the criteria were not met.” His frustration is palpable, as the Home Office’s refusal to acknowledge his plight leaves him feeling abandoned and helpless.

In a desperate attempt to find some form of support, Pastor Mueller has also reached out to The White House seeking U.S. citizenship, and to Scottish officials, including the First Minister, John Swinney. He requested both British citizenship and emergency assistance. Despite his appeals, he has received no response or help. “The churches here have no money to help me,” he shared, revealing the stark reality that many refugees, especially those in dire situations, find little aid from the very institutions meant to offer sanctuary.

Pastor Mueller’s ongoing struggle is not just about his personal suffering – his case serves as a disturbing warning about the growing wave of religious intolerance in Europe. His treatment exposes the frightening ways in which governments and police are weaponising mental health diagnoses to suppress faith and silence dissenting voices. What happens when religious freedom is considered a mental illness by the state? When asked about what could improve the justice system in both Germany and the UK, Pastor Mueller did not hold back: “There is no fear of God and the Lord Jesus Christ. They are criminals,” he declared, his words full of deep sorrow for the spiritual and moral decline he believes is sweeping through modern society.

Pastor Mueller’s case is a harbinger of what may happen if religious freedoms and free speech continue to be suppressed in Europe and Britain.

Are we entering an era where the state has the power to dictate the boundaries of faith, criminalising belief in the name of secularism and psychological manipulation? Pastor Mueller’s plight serves as a grim reminder that the freedom to believe – especially in Christianity – can no longer be taken for granted in a world increasingly hostile to certain faiths.

The question now looms: will the UK – once a beacon of religious freedom – allow one man’s courageous fight for asylum to go unheard? Or will the voices of oppression grow louder, unchecked by the very nations that once prided themselves on offering sanctuary to the persecuted?

I will continue to follow Pastor Sven Mueller’s story closely. We will publish updates on his asylum application and any further developments in this ongoing case of religious persecution.

Death knell for onshore wind arrays?

Australia's oldest facility to be axed over rebuild costs

AUSTRALIA'S oldest commercial wind farm, the Codrington Wind Farm in Victoria, is set to be decommissioned in 2027, marking a significant turning point in the country's renewable energy landscape.

Despite its prime location near Port Fairy in southwest Victoria, the site will not be repowered due to the high costs and regulatory challenges associated with upgrading the facility, according to Pacific Blue, the company operating the wind farm.

Why Repowering Codrington is not Viable

Codrington Wind Farm, commissioned in 2001, has a capacity of 18.2 megawatts (MW), utilizing 1.3 MW turbines with a hub height of 50 meters and blade tip height of 81 meters. However, modern wind turbines are vastly different:

- New turbines are rated between 6 MW and 8 MW per unit.
- Blade tip heights now exceed 200 meters.
- Spacing requirements have changed significantly to accommodate larger turbine sizes.
- Due to these advancements, repowering Codrington would require:

- New foundations and repositioning of turbines.
- Upgraded grid connections to handle increased energy output.
- Complete re-approval of regulatory permits and grid agreements.

According to a Pacific Blue spokesperson, the costs and logistical hurdles associated with repowering make it financially unviable: “The site's grid connection would require significant upgrades, and today's turbine siting requirements would preclude the installation of latest-generation turbines, resulting in a non-financially viable project.”

The Decommissioning Process and Future Land Use

Pacific Blue, formerly known as Pacific Hydro before being acquired by China's State Power Investment Corporation (SPIC) in 2023, has initiated discussions with:

- Moyne Shire Council
- State authorities
- Regulatory agencies

These conversations focus on the decommissioning timeline and site rehabilitation plans. The company met with local landowners in 2024 and must complete the decommissioning process within 12 months of the wind farm's final operation, as per its operating permit.

Community input will play a crucial role in deciding:

- How the land will be rehabilitated post-decommissioning.
- How infrastructure, including turbines and other materials, will be recycled.

What This Means for Other Ageing Wind Farms

Codrington's closure raises questions about the future of other ageing wind farms in Australia. One nearby facility, the 30 MW Yambuk Wind Farm, which was commissioned in 2007, is also nearing the end of its lifespan.

- Yambuk is part of the broader 195 MW Portland Wind Project, which includes four wind farms built between 2007 and 2011.
- While Pacific Blue has not yet announced decommissioning plans for Yambuk, the company has stated that Codrington's closure is its immediate priority.

The Bigger Picture: Challenges and Opportunities for Australia's Wind Energy Future

Codrington's decommissioning underscores the growing challenges faced by ageing wind farms. As Australia continues its transition to renewable energy, industry leaders must address key issues:

- The high costs of repowering and

upgrading infrastructure.

- The need for more efficient recycling solutions for old wind turbines.
- How to manage the transition from older wind farms to next-generation renewable projects.

With offshore wind projects gaining momentum—such as the nearby Southern Wind Zone in Victoria—new energy infrastructure may eventually replace some ageing onshore sites.

Conclusion: A Turning Point for Australian Wind Energy

The decision to decommission rather than repower Codrington Wind Farm signals a new phase in Australia's renewable energy strategy. As the country balances sustainability, costs, and technological advancements, the fate of many ageing wind farms will hinge on financial viability, regulatory frameworks, and grid infrastructure upgrades.

While Codrington may be shutting down, the lessons learned from its closure, recycling process, and land rehabilitation efforts will help shape the future of wind energy projects across Australia.

Risk of root canals exposed

Highlighting the health implications of dental treatment

ROOT canal treatments are one of the most common dental procedures, with nearly 60 million performed annually worldwide.

While mainstream dentistry considers root canals a safe and effective way to preserve damaged teeth, holistic and biological dentists question their long-term effects on overall health. Critically examining root canal treatments from a holistic perspective exposes potential systemic health implications.

A root canal, also known as endodontic therapy, is a procedure designed to save a damaged tooth by removing its infected or dead pulp. An endodontist cleans, disinfects, and seals the tooth's internal structure to prevent further bacterial infiltration. The treatment is often recommended for severely decayed, infected, or painful teeth that cannot heal on their own.

The process involves:

1. Drilling a hole into the affected tooth.
2. Removing the pulp, which consists of nerves, blood vessels, and connective tissue.
3. Disinfecting the root canals with solutions to eliminate bacteria.
4. Filling the space with gutta-percha, a thermoplastic material used to seal the canals.

Although gutta-percha is considered biocompatible, it contains other substances such as zinc oxide, heavy metal sulfates, and resins, which may pose health risks. Additionally, incomplete cleaning of the tooth's intricate microscopic tubules can leave bacteria behind, potentially leading to long-term health complications.

Despite advanced techniques, root canal treatments can fail due to:

- Ineffective cleaning of the root canals.
- Instrument breakage or perforation of the tooth's apex.
- Leakage of filling material, allowing bacterial reinfection.
- Overlooked additional canals that remain infected.

Holistic dentistry argues that even well-performed root canals may leave behind bacteria and toxins that can lead to chronic systemic infections. The focal infection theory, first introduced by Dr. Frank Billings in the early 20th century, suggests that bacteria from infected teeth can travel through the bloodstream, affecting other organs.

Dr. Weston Price, a prominent researcher, conducted experiments showing that root-canal-treated teeth often harboured bacteria linked to systemic diseases such as heart disease, arthritis, and neurological disorders. His research was later supported by Dr. George Meinig, a founding member of the American Association of Endodontists, who later became a strong critic of root canals after studying Price's findings.

A research article presents the case of Peter, a 32-year-old professional trader who experienced severe health deterioration following a root canal

procedure. His symptoms included chronic fatigue, memory loss, joint pain, and vision problems. After extensive medical testing without answers, he discovered that multiple root-canal-treated teeth were likely the root cause of his condition. Upon their removal and detoxification therapy, his symptoms dramatically improved, highlighting the potential dangers of untreated dental infections.

Modern scientific research continues to examine the safety of root canal treatments. Studies have shown:

- Root canals may harbour anaerobic bacteria that produce toxins harmful to the immune system.
- Root-treated teeth can contribute to inflammatory conditions due to persistent low-grade inflammation.
- Some patients experience unexplained chronic illnesses linked to hidden dental infections.

German researcher Dr. Johann Lechner identified elevated levels of the inflammatory marker RANTES (which stands for regulated upon activation, normal T cell expressed and secreted) in patients with root-canal-treated teeth and aseptic ischemic osteonecrosis of the jawbone (AION). These conditions have been associated with autoimmune

diseases, cardiovascular issues, and even neurological disorders.

For patients seeking alternatives to root canals, the following options are available:

1. Early intervention: Using ozone therapy, dental lasers, and homeopathic remedies to stimulate natural tooth healing before infection spreads.
2. Tooth extraction: If a tooth is dead or severely infected, removal may be the best option to prevent systemic health issues.
3. Biocompatible tooth replacement: Instead of conventional dental implants, holistic dentists recommend zirconia implants, which are free from metal toxicity.

Holistic dentistry recognizes that teeth are not isolated structures but integral parts of the body's overall health system. The following key principles are emphasized:

- The tooth-organ connection: According to traditional Chinese medicine, each tooth is connected to specific organs through meridians. Infection in a particular tooth may correlate with issues in the associated organ.
- Toxicity of dead teeth: A root-canal-treated tooth is essentially dead, and the body's immune system may struggle to manage the bacteria and toxins within it.
- The electrical nature of teeth: Researchers such as Dr. Jerry Tennant highlight the role of teeth in the body's electrical energy system, showing that infected teeth can disrupt cellular voltage and contribute to disease.

Advancements in stem cell research may eventually provide a way to regenerate dead teeth, eliminating the need for root canal treatments. Until then, holistic dentistry advocates for informed decision-making, allowing patients to weigh the risks and benefits of traditional versus alternative approaches.

The debate surrounding root canal treatments is part of a larger conversation about the interconnectedness of dental and systemic health. While traditional dentistry views root canals as a safe and necessary procedure, holistic practitioners caution against their long-term effects on the immune system and overall well-being. By understanding the potential risks, patients can make informed decisions that align with their health goals.

Gulf of Tonkin incident

Shocking faked prelude to the Vietnam War

The Gulf of Tonkin is a body of water that lies off the coast of North Vietnam. This was the staging area of the U.S. Seventh Fleet, which included the American destroyers the Maddox, C. Turner Joy and the aircraft carrier USS Ticonderoga. It was also the site that would eventually lead to full scale U.S. involvement in Vietnam.

Throughout the engagement, Maddox and Turner Joy fired 249 5-inch shells, including 24 star shells, and 123 3-inch rounds. The two destroyers also dropped 4 or 5 depth charges, one of which failed to detonate, against boats following in their wakes. The entire engagement lasted about four hours.

'American Planes Hit North Vietnam after Second Attack on Our Destroyers; Move Taken to Halt New Aggression,' announced the Washington Post on August 5, 1964. That same day, the front page of the New York Times reported: 'President Johnson has ordered retaliatory action against gunboats and "certain supporting facilities in North Vietnam" after renewed attacks against American destroyers in the Gulf of Tonkin.'

But there was no second attack by North Vietnam and no 'renewed attacks against American destroyers', either. By reporting these fairy tales as absolute truths, American journalism opened the floodgates for the bloody Vietnam War. The official story was that, in what was to become known as 'The Gulf of Tonkin Incident', the alleged catalyst for the Vietnam

War, North Vietnamese torpedo boats launched an 'unprovoked attack against a U.S. destroyer on routine patrol' on August 2, and that North Vietnamese PT boats followed up with a deliberate attack on U.S. ships two days later.

But the truth was very different. Rather than being on a routine patrol, the U.S. destroyer Maddox was actually engaged in aggressive intelligence-gathering manoeuvres in sync with co-ordinated attacks on North Vietnam by the South Vietnamese navy and the Laotian air force.

'The day before, two attacks on North Vietnam...had taken place... Those assaults were part of a campaign of increasing military pressure on the North that the United States had been pursuing since early 1964,' Daniel C. Hallin, 'The Uncensored War'.

On the night of August 5, the Pentagon proclaimed that a second attack by North Vietnamese PT boats had occurred earlier that day in the Tonkin Gulf, a report cited by President Johnson as he appeared on nationwide TV that evening to announce a momentous escalation in the war; air strikes against North Vietnam. But in fact,

Johnson ordered U.S. bombers to retaliate for a North Vietnamese attack that never happened.

One of the Navy pilots flying overhead that night was squadron commander James Stockdale, who said, "I had the best seat in the house to watch that event and our destroyers were just shooting at phantom targets – there were no PT boats there... There was nothing there but black water and American firepower."

And in early 1965, Lyndon Johnson commented: "For all I know, our Navy was shooting at whales out there."

But Johnson's deceitful speech of August 4, 1964, won accolades from editorial writers. The President, proclaimed the New York Times, '...went to the American people last night with the sombre facts.' And the Los Angeles Times urged Americans to '...face the fact that the Communists, by their attack on American vessels in international waters, have themselves escalated the hostilities.'

The exhaustive book, 'The War Within – America's Battle over Vietnam,' begins with a dramatic account of the Tonkin Gulf

incident and in an interview, its author Tom Wells said that the American media "described the air strikes that Johnson launched in response as merely tit for tat when in reality, they reflected plans the administration had already drawn up for gradually increasing its overt military pressure against the North."

The day before the first incident, the North Vietnamese had protested the attacks on its territory by Laotian aircraft and South Vietnamese gunboats, and it was generally known that covert operations against North Vietnam, carried out by South Vietnamese forces with U.S. support and direction, had been ongoing for some time.

In the absence of independent journalism, the Gulf of Tonkin Resolution – the closest thing there ever was to a declaration of war against North Vietnam – was passed by the U.S. Congress 416 to 0 in the House and 88 to 2 by the Senate. The resolution authorised the president 'to take all necessary measures to repel any armed attack against the forces of the United States and to prevent further aggression'.

This was what led to the escalation of U.S. involvement in Vietnam and by July of 1965, there were 180,000 U.S. troops mobilised in South Vietnam and by that stage, 400 tons of bombs and ordnance were being dropped every day.

But what all mainstream historians fail to recognise, dare confront or report, is that all wars are fabricated. It is all a massive charade and there is no government anywhere, ever, that will tell us the real truth.

When the truth about the Gulf of Tonkin incident is finally declassified, the fact that the NSA faked intelligence data to make it appear as if two U.S. ships had been lost, will become apparent.

The falsification of the Gulf of Tonkin incident is significant because thousands of American youths were slaughtered, tortured and killed and several tens-of-thousands more were maimed and sprayed with Agent Orange in Vietnam.

To add insult to injury, Henry Kissinger coldly and ruthlessly stated that: "Military men are dumb, stupid animals to be used as pawns for foreign policy."

What all historians also fail to grasp when documenting and analysing all wars and conflicts in general, is that the goal of the war in Vietnam was never to win it, just to perpetuate it.

After deceiving the U.S. into escalating the Vietnam War, the globalists skilfully managed the war in order to prevent any chance of a premature conclusion. The Vietnam War, like the Korean War before it, was not meant to be won. These wars against communism are simply a means to weaken the U.S. and 'contain' communism without ever defeating it.

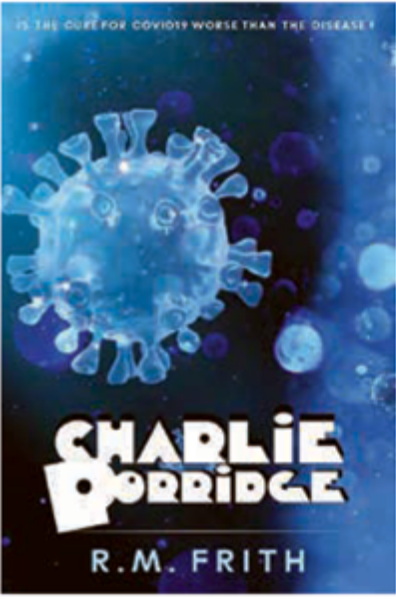

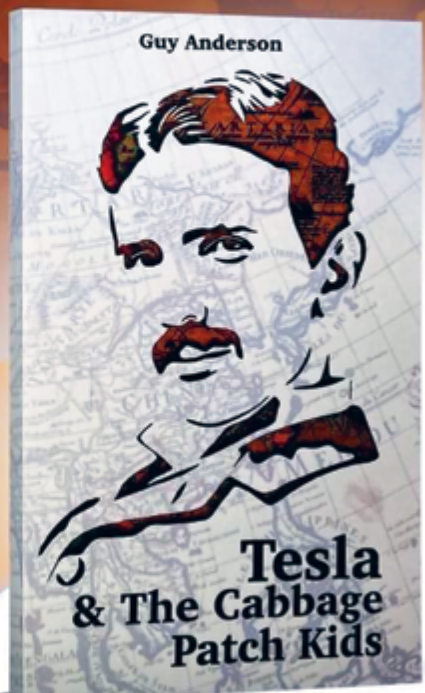

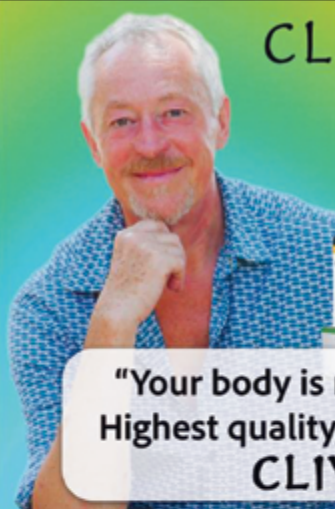
