Power, lies and deception

COINCIDENCE and cock-up are not as credible as conspiracy in explaining what is happening in the world today.

Critical thinkers are joining the dots, and seeing ulterior motives, false flags and stagecraft that serve the globalists' agenda. People at the highest rungs of power are inverting reality, and it's a deliberate strategy of shock and awe in pursuit of a new world order.

'The news' is a curated programme. Events are highlighted to become talking points, often with psychological framing to make people respond in a desired way (e.g. sympathy or horror). Covid-19 was perhaps the biggest behavioural psychology operation ever, most of its impact arising through mainstream media reporting. Now we have the spectre of World War Three, but is this an actual escalation to hot war, or another stage show?

Events are contrived at three levels: they may be real, unpredicted incidents, but exploited in some way (e.g. a racially prejudiced comment used as evidence of a racist society).

At another level, there are events that are real but designed, with the true motives hidden. For example, we might suspect the Baltimore bridge being struck by a container ship, derailment of chemical freight at East Palestine in Ohio, food warehouse fires and other damage to infrastructure (also forest fires with a hint of arson). Finally there are events that are fabricated. The latter are the most controversial.

There are two audiences for contrived events. For the majority, the story on 'the news' is accepted at face value. These are

easy minds to manipulate. Furthermore, the event may contribute to a problem-reaction-solution mechanism, often to advance technocratic surveillance.

The other audience contains the sceptics, who will disbelieve the story. Clues are left to show the eagle-eyed critical thinker that the event did not happen as reported. For example, a politician taking a vaccine with the syringe lacking a needle, or Katy Perry and fellow 'astronauts' rocketing into space and landing in a capsule that wouldn't have survived a windy day on a beach.

Consider the assassination attempt on Donald Trump at Butler, Pennsylvania, just before the presidential election. The motive for a theatrical shooting was obvious,

increasing Trump's lead in the opinion polls and gaining words of admiration from Big Tech bros who had previously supported the Democrats. Trump was saved – by God!

Consider certain acts of 'terrorism' and other news that gets blanket coverage. Many appear staged and claims are made of crisis actors being involved, including some 'patients' seen gasping for breath in hospitals. Fabricated news is a universal tactic of all states and the powers that sit above them.

For the past month we saw salvos of missiles blasting Tehran and Tel Aviv. Some cynics have referred to Israel's Iron Dome as a firework show. Are the Iranian ballistic missiles any more credible?

As for stealth bombers' bunker-busting of the Iranian nuclear site in a rocky mountain range, there are two questions that come to mind: first, does Iran really have nuclear weapons? This trope has been used by Washington hawks and Zionists repeatedly since the 1980s: stop Iran before it unleashes Armageddon. I won't go into the debate on whether nuclear bombs exist, but there is similarity here with covid-19 – some sceptics argue that the whole theory of viruses is a hoax.

The second question is whether the highest authority in Iran is colluding with the U.S. and Israel. Terrifying their citizens about imminent war – and especially nuclear war – is a proven method of exerting emergency powers. Trump clearly stated that the Ayatollah will not be targeted.

Some military experts believe that the Iranian base was not in use, and that a deal was struck between people pulling the strings to stage a sensational event without any real carnage. 'That's all for now, folks!'

In George Orwell's *Nineteen Eighty-Four*, the perpetual conflict of Oceania with Eastasia or Eurasia (who alternate as enemy and ally) was not necessarily happening; it was enough to tell the people that it was happening. When Zbigniew Brzezinski wrote *The Grand Chessboard* at the turn of the millennium, this was apt because geopolitics is like a game, with powerful players. The consequences, though, are very serious. The conspiracy is for total control of population and resources, to enslave, depopulate and create an omnipotent worldwide tyranny.

Organ harvesting's deadly secret

NHS choosing to withdraw care to boost transplant services?

THE NHS wants you to believe organ donation is a heroic act, a chance to save lives after you are gone – but the truth could be far darker.

The 2023/2024 Annual Report on the National Organ Retrieval Service (NORS) reveals a chilling reality – a system that takes organs from people who may still be alive or who did not need to die, all under the guise of saving lives.

The NORS report, quietly released by NHS Blood and Transplant in August 2024, lays bare the scale of this operation. In one year, 1,761 people were targeted by organ retrieval teams. Of those, 86 per cent had their abdominal organs taken, while 59 per cent of those seen by

cardiothoracic teams lost their hearts. The NHS relies on two types of donors: those declared 'brain dead' (DBD) and those after 'circulatory death' (DCD). The latter is now the majority, and it's where the real potential for conflict in care lies.

DCD donors aren't brain dead. Their life support is switched off, their heart stops, and within minutes, surgeons swoop in to harvest their organs.

In 2023/2024, 74 DCD hearts were taken, with 65 transplanted. These beating hearts – symbols of life itself – are removed from bodies declared dead only because their circulation has briefly stopped, then revived in machines for transplant. It leaves the door open for medics' decisions to be influenced by potential organs to harvest – and could mean a decision made to not try and save someone who needs resuscitation.

The concept of brain death is the cornerstone of this system, but it's a sham. Dr Heidi Klessig, a retired anaesthesiologist who once participated in organ harvesting, exposes the truth: "There have never been any facts, studies, or evidence that these people are dead."

In the 1980s, Klessig was told to prepare a young man for organ retrieval. “He had normal blood pressure, heart rate, great oxygen saturation, was warm and with good colour,” she recalls. “He was more stable than most ICU patients I’d anaesthetised.” Yet, she was instructed to give a consciousness-blocking drug ‘just in case’.

The patient reacted to surgery like any living person, needing full anaesthesia. That moment shook her to her core, leading her to write *The Brain Death Fallacy* book and run the website, Respect for Human Life, to expose this scandal.

A 2012 study by Verheijde et al. in *Philosophy, Ethics, and Humanities in Medicine* confirms her fears.

The study says: 'Brain death is a legal invention, not true biological death.'

People declared brain dead can still have heartbeats, circulation, hormonal function and some women labelled 'brain dead' can even gestate babies. The tests used to diagnose brain death, like the apnea test, can actually cause further brain damage.

Worse, the *American Academy of Neurology's* 2023 guidelines admit brain death can be declared despite ongoing brain activity – 20 per cent of cases show electrical activity on EEGs (electroencephalograms), and over 50 per cent have functioning hypothalami which is a region of the forebrain.

This violates the UK's Uniform Determination of Death Act, which requires 'irreversible cessation of all functions of the entire brain'. If the law is being ignored, what is stopping doctors from harvesting organs from the living?

The NORS report reveals another disturbing practice: abdominal normothermic regional perfusion (A-NRP). Used in 193 DCD cases (161 proceeding to donation), A-NRP restarts blood flow to organs after death is declared – but deliberately excludes the brain. Why? Because they know the brain might still be alive.

Could this be a grotesque workaround to ensure organs are fresh while keeping the donor legally dead? As former nurse and activist Kate Shemirani warns in a recent video: “You cannot take an organ from a dead body. There is no such thing as brain death. This is eugenics.”

Then there's the issue of consent. The UK's 'opt-out' system, introduced in May 2020, assumes you have consented to organ donation unless you explicitly refuse. But how many know this?

A 2020 Nuffield Council on Bioethics study found widespread ignorance about the opt-out policy. The NORS report is silent on how many families were informed, consented, or objected. This is no accident – it's a system designed to keep you in the dark.

Worse, the report admits to 17 cases where retrievals were done by off-duty teams and a 6.7 per cent rate of missing paperwork in Edinburgh. No forms, no oversight, no accountability. Is your consent even verified, or are they banking on your silence?

Shemirani pulls no punches: “The minute you make that 999 call, everything is up on the screen. Are you a yay or a nay? The treatment to preserve your organs is very different from the one to save your life.”

Her words echo a grim reality: the system may prioritise organs over patients. Dr Klessig's regret drives the point home: "I am complicit in a man's medical murder by dismemberment. My feelings motivate me to raise public awareness." She's not alone. Even mainstream ethicists like Charles C. Camosy and Peter Singer argue that brain death isn't death, calling for a public debate that's been suppressed for 50 years.

This isn't about saving lives – it's about commodifying them. The NHS, backed by a complicit medical establishment, has built a system that thrives on legal loopholes and public ignorance. Brain death is a convenient fiction, DCD could be argued to be a rushed execution in some cases, and perfusion machines are the stuff of nightmares.

Solution for mankind's survival

Let's shift from blind trust to intelligent resistance

HOW do we stop dystopian science fiction movies coming true? Are we destined to be ruled by robots, and to relinquish our free will and creativity to artificial intelligence?

Such questions are becoming more prescient as a global elite directs technology beyond human advancement towards technocratic tyranny.

And yet, when I'm out with my local group distributing *The Light* paper and displaying slogans on yellow boards, it's amazing how some perceive 'keep cash', 'no farmers no food' and 'welfare not warfare' as right-wing tropes. To anyone who cares to ask, we state our cause as 'freedom'. Who could be against that? Actually, as the covid-19 debacle showed, many people.

However, amid the Green and Woke dual onslaught on humanity, I am sure that conserving is a worthy and necessary pursuit, while blindly accepting change is reckless. For those who identify themselves as progressive, the question must be: what is the destination? Scratch the surface of the typical middle-class virtue signaller, and you'll find an unqualified welcome for any usurping of tradition, with (as George Orwell observed) a snobbish distaste for the lower orders.

As revealed by cultist following of the contrived climate and coronavirus crises, progressives are really conformists – in the same way that conservatives were in the past. Uncritically accepting social, economic and technological change as inherently good and inevitable developments, they lack the critical thinking necessary to understand the driving forces. The goal is a top-down, transhumanist technocracy, and the impetus is the hardly known philosophy of accelerationism.

In 1970, Columbia scholar Zbigniew Brzezinski's book *Between Two Ages: America's Role in the Technetronic Era* envisaged a society 'that is shaped culturally, psychologically, socially, and economically by the impact of technology and electronics.'

As he explained: 'Such a society would be dominated by an elite whose claim to political power would rest on allegedly superior scientific know-how. Unhindered by the restraints of traditional liberal values, this elite would not hesitate to achieve its political ends by using the latest modern techniques for influencing public behavior and keeping society under close surveillance and control.'

As described in a 2017 *Guardian* essay by

- We do not answer to technocratic systems

Andy Beckett, the belief is that technology must be sped up, rather than introduced incrementally, thereby attaining an unstoppable momentum.

Globalist technocrats are using accelerationism to smash stability, slashing and burning to enable creation of a totally engineered two-tier society. The most blatant proponent of recent years is the World Economic Forum, whose leader Klaus Schwab described the mission as the 'Great Reset'. Schwab showed his accelerationism in the pandemic lockdown of 2020, his rapidly published book, *Covid-19: The Great Reset*, emphasising a 'narrow window of opportunity' to impose a 'new normal'. Schwab was not merely guiding an economic recovery from the ravages of covid-19, as so-called fact-checkers assert. His scientific advisor Yuval Noah Harari boasts that human brains can be hacked and that the notion of the soul is dead. The relationship between human beings and technology is being reset.

If accelerationism is the philosophical pitch of the transhumanists, we need a philosophy for humanity. And, fortunately, covid-19 sceptic David Fleming has come up with the goods.

He names it 'continuism', and it has both intellectual rigour and practical utility.

Continuism is a belief system with a primary

concern neither for truth nor freedom but for preserving all that is human. It is not conservative in a political sense.

Potentially, it would certainly attract not only traditionalists, but also socialists, anarchists and free-market capitalists – anyone who believes in human answers to human problems. It is not irreligious, but an assertion of free will (whether or not you believe that is God-given). Continuism embraces the human dynamic of constancy and change.

Fleming states: 'We reject the idea that unelected elites, algorithms, or global planners can define the course of human life. These systems do not empower us – they reduce us to data, automate our choices, and impoverish us while pretending to help us thrive.'

Fleming doesn't seek signatories, as this can lead to the unwanted distraction of competing egos. He would like government, local authorities and commercial organisations, as well as individuals, to follow it. Realistically, politicians are unlikely to drop their servile allegiance to Net Zero, DEI (diversity, equity, and inclusion) and other doctrines that manipulate health and safety to control the populace.

Citizens may ask local politicians and council officers if they would agree to the charter. As Fleming states: 'If they say yes

– humanity just gained an ally.' And if they refuse, that would imply betrayal of their role and representation.

Continuism will have practical value as a protected belief under the Equality Act, particularly in employment cases. Many workers were disciplined for conscientious objection to covid-19 policies, and 'cancel culture' has also led to punishments for expressing politically incorrect ideas. Such employment practice is of dubious legality, and would be more provably unlawful if the worker can be shown to be expressing a legitimate philosophical belief.

We must stop naively believing that our existential problems will come out in the wash. As Fleming observes: 'The technocratic class now possesses every tool it needs for total behavioural control: the internet for infrastructure, 5G and Wi-Fi for coverage, smartphones for tracking, and AI for simulation and enforcement.'

The control grid is already in place, and idealism about the human spirit will not save us.

Accordingly, Fleming asserts: 'We must now make a step change. Continuism marks the break. The reset of human strategy, from reaction to continuity. From blind trust to intelligent resistance. From politics to principles. From movements to a mandate that declares that humanity will continue.'

Continuism is a Geneva Convention for our survival.

Opening up about weather control

UK is funding scientists to push boundaries on geoengineering

THROUGH its Advanced Research and Invention Agency (ARIA), the UK is exploring how to control the weather through technology and geoengineering.

Recently, the research agency published a document entitled ‘Managing our climate and weather through responsible engineering’ which was authored by ARIA programme director, Mark Symes. In the core beliefs section that underlies this research opportunity, Symes writes: ‘Through carefully-considered engineering solutions, it may eventually be possible to actively and responsibly control the climate and weather at regional and global scale.’

As far as methods into controlling the weather go, Symes cites studies that involve:

- Blocking the sun as a potential means to cool land temperatures.
- Solar radiation management (SRM) techniques, which ‘reflect a small percentage of the sun’s light and heat back into space’.
- Cirrus cloud thinning which theoretically would ‘allow more longwave radiation to escape to space’.

Symes believes that one or more funding programmes could emerge from his ‘opportunity space document’ which he says will be updated over time.

On December 6, 2024, ARIA published a Q&A with Symes and ARIA chief executive, Ilan Gur, where they elaborated on the latest research opportunity.

Both agreed that decarbonisation and net zero were ‘most important to address climate change’.

However, Symes argued that: ‘Even if we stopped burning fossil fuels tomorrow and no more CO2 from human activity entered the atmosphere, the world would continue to warm due to the CO2 that is already in the atmosphere.’

Gur said that he wanted to hear from scientists and engineers on ‘how we might intervene responsibly in climate and weather systems’ while warning that

climate engineering experiments could be carried out ‘without the fundamental science to underpin them’.

‘We should also recognise that the technological ability and desire to intervene in climate and weather systems is increasing across the globe,’ said Gur.

‘The UK is uniquely positioned to advance our understanding of these approaches, towards a framework for approaching their development and use responsibly,’ the ARIA CEO concluded.

The UK Advanced Research and Invention Agency named its first cohort of eight programme directors in September.

At that time, Symes was asking:

- Can we develop the capability to control the weather and climate on a regional and global basis, to mitigate or obviate hurricanes, droughts, floods and heatwaves?
- What are the options for actively cooling the Earth, and how can we improve our monitor-measure-predict feedback loops to identify the most responsible choices?

Now, Symes is asking:

- Are there technologies that could allow us to intervene in the shorter term, both to avoid catastrophic tipping points and to mitigate against extreme weather events like floods or hurricanes, which

are only getting worse as global temperatures rise?

ARIA is a non-departmental public body, sponsored by the UK Department for Science, Innovation and Technology that bills itself as ‘an R&D funding agency built to unlock scientific and technological breakthroughs which could benefit everyone’ by ‘empowering scientists to reach for the edge of the possible’.

Last September, founding CEO Gur said of ARIA that from a policy perspective, ARIA was inspired by DARPA (the U.S. Defence Advanced Research Projects Agency) which is the funding organisation in the United States that helped introduce computing and the internet, GPS technology, and more recently, mRNA.

Previously, Gur was a director at the U.S. Advanced Research Projects Agency for Energy (ARPA-E) and, on top of being a Schmidt Futures Innovation Fellow, he is also the founder of Activate.org, a U.S.-based organisation that ‘empowers scientists and engineers to bring ground-breaking research to market’.

Has our history been rewritten?

World was reset in 1776 and it could happen again

ALLOW me to introduce to you the Tartarian Empire, the greatest empire to ever exist, and one that most people have never heard of. The reason for this is quite simple – power, greed and control.

Psychological war on humanity

How the Crown's hidden hand is reprogramming the image of man

A truly revolutionary society must recast the very image it has of man

YOU wake up, scroll through your phone, watch a few reels, digest a headline, nod, swipe, obey. But have you ever stopped to ask: why do I see myself this way? Why does the world feel like it's closing in?

This isn't accidental. It's not just politics, or progress, or technology. It's a coordinated psychological campaign to change the very nature of human identity.

This agenda was spelled out in a largely forgotten Crown-funded think tank document titled 'Changing Images of Man', written at Stanford Research Institute (SRI International) in the 1970s. It is not conspiracy theory – it is open record, and it reads like a psychological warfare manual.

In the early 1970s, under government contract and philanthropic funding, a team of psychologists, sociologists, futurists and behavioural scientists assembled a document at SRI International. Their mission: to plan how the public's perception of human nature – and thus all culture – could be redefined.

The report called for:

- The destruction of traditional human archetypes (religious man, sovereign man, moral man).
- Replacement with programmable models of identity tied to environmentalism, collectivism, scientism, and technocracy.
- Behavioural shifts achieved through mass media saturation, education reform, digital interfaces, and bio-psychological manipulation.

The authors noted that new societal control structures would require a new mythology – not based on Creator and soul, but on Earth worship, digital immersion, and

global governance.

This was not fiction. This was a strategic design – a blueprint for behavioural reprogramming.

At the heart of this strategy lies the work of Kurt Lewin, a Crown-linked German-American behavioural scientist who created 'field theory' – treating the human psyche as a mapped terrain with paths, zones, and thresholds.

The principle of topological psychology is that 'to understand or change a person's behaviour, one must map the "life space" and engineer its environment.'

This concept laid the foundation for environmental manipulation and behavioural architecture. It birthed models now used in:

- Military psychological operations (PSYOPS)
- Advertising and social engineering
- Trauma-based behavioural reshaping
- Controlled societal schizophrenia via media

Lewin's models were adopted by the Tavistock Institute, itself funded by British Crown resources, and deployed on mass populations to fragment identity and reshape society around stress-based compliance.

But who paid for this war on consciousness?

According to the now-famous investigation titled Dope Inc., the answer is as shocking as it is well-documented: the British Crown's financial empire has long been sustained by narcotics, human trafficking, and off-ledger empire-building.

Exposed in Dope Inc.:

- The British East India Company was the original cartel, running global opium operations from China to Bengal – a legacy the Crown never abandoned.
- Hongkong and Shanghai Banking Corporation (HSBC), one of the Crown's big banks, has been repeatedly exposed laundering drug money – billions per year.
- Profits are funneled into offshore shadow accounts, black project budgets, and psychological programming institutions like Tavistock, SRI, and Rand.

This money funds:

- Behavioural science weaponisation
- Educational content control
- Media and culture distortions
- International human trafficking rings
- MKUltra-style programmes for mass trauma and population management

The goal? To destroy the sovereign being and replace him with a controllable digital self – compliant, trackable, programmable.

From sovereign man to conditioned subject; from spiritual being and divine spark to biometric identity/QR-coded soul; from family, tribe or bloodline to atomised, rootless and cloud-hosted; from free by natural law to registered 'citizen' under contracts; from moral compass from within to external rules from the 'expert class'; from living soul to legal fiction and trust property account.

We have been taught to forget who and what we are. Through indoctrination,

entertainment, pharmaceuticals, and programming, they are crafting a new human model – docile, confused, and obedient.

This is not the end. But it is the line in the sand.

If you are reading this, it means your awareness is already waking up. The war is psychological, but the resistance is spiritual.

Reclaim the image of man:

- Restore your identity as a living man or woman, not a corporate 'person'.
- Disconnect from the programming – reduce media exposure, challenge narratives.

Film unmask's technocratic roadmap

Q: *Agenda* is a tremendously enlightening film. Were there any big surprises, insights or even an epiphany for you, during its making?

MS: Attending Sandi Adams's presentation on Agenda 2030 opened the door. Once we started the journey, we found many more doors, and behind each were more revelations and new leads.

PW: The whole process was like peeling back layers. It took a long time as the story kept getting bigger and bigger. The main revelation for me though, came before we'd begun work on the film. I was reading Patrick Wood's book *Technocracy: The Hard Road to World Order* during the covid debacle and, when you realise that book was published in 2018, and the foresight that Patrick had given his decades of research, it pulled together so much for me. Jacob Nordangård's work also comes highly recommended as it's very well cited.

PS: For me it was a visceral reaction, the realisation that traps had been set, the truth inverted to achieve the master plan; the art of chicanery over many years to bring it to the point of convergence, which is Agenda 2030.

Q: The film has an important message, joining the dots on covid-19, net zero and digital surveillance, to reveal the underlying agenda. However, many sceptics remain stuck in the Left v Right paradigm, the former seeing the creep of authoritarianism as fascism, the latter as communism. How ready are people to understand technocracy?

PW: I can't say for sure how ready people are, but I feel it's now or never honestly. Left/right is a false dichotomy and has been for some time. It's clear political leaders on both sides of that paradigm have been captured and compromised by ideologies (and in some cases much more than that). Your response to that problem shouldn't be apathy though. It should be grassroots dissent in whatever manner plays to your strengths. We can't sit idly by and wait for a convenient solution from a national government.

PS: People should not confuse technocracy with technology, which obviously brings benefits to humankind and can enhance life. Technocracy is a system which would eliminate the democratic vote and leave corporate oligarchs and scientists in control of policy, without checks and balances. We're already witnessing experiments with CRISPR gene editing and computer-brain

interface; what's to stop these people using this technology for their own ends?

MS: The warnings are there in the film. Total surveillance, AI, digital ID. Today's convenience is tomorrow's control. They are the tools of authoritarianism.

Q: The history of Techocracy Inc. in the 1930s is fascinating and shows that although there were no computers back then, the master plan was written long before the likes of Klaus Schwab and the World Economic Forum. The interwar period was the heyday of eugenics. To what extent does such thinking pervade the current technocratic agenda?

PW: Immensely so. The concept of technocracy was developed at Colombia University during the 1930s, and the founders of the movement occupied half of the basement of Hamilton Hall. It's interesting that, in the other half of that basement were the creators of IBM. So, there you have the visionaries of technocracy (an alternative economic system designed to replace capitalism and free enterprise) rubbing shoulders with, essentially, Big Tech at that time. IBM of course would go on to develop the punched card system used by the Nazis to round up Jews, dissidents and opposition leaders during the 1930s. IBM was also instrumental in engineering and lobbying for a vaccine passport system during the covid operation; another means through which to create a two-tiered society. Eugenics is, and has always been, a key driver of those pushing for social control.

Q: Like your film, my book *Green in Tooth and Claw* focuses on motives. But who is really pulling the strings? Catherine Austin Fitts makes the point that, if you know the names of powerful people, they are not at the top of the pyramid. So we are left to speculate. Does your film take viewers any nearer to knowing who 'they' are?

PW: When you get to a certain point in researching these issues, you realise that a

huge amount goes on behind closed doors at places like Bilderberg, Chatham House, Davos, etc. in meetings and gatherings for which there are no official minutes or records. Therefore, without speaking directly to an insider or whistleblower, we are left only with official literature made public, as well as information that has leaked out over the years. That alone, coupled with events playing out on the world stage in 2025, paints quite a telling picture. However, if you're approaching this from a journalistic standpoint as we do, you only make statements which you can cite and back up with evidence from primary source literature. It's hard to say with certainty and verifiable proof who is ultimately pulling the strings, but I hope this film can help many to connect the dots.

PS: Whatever the identity of the faceless ones at the peak of the pyramid of power, we've become very aware of their top-down push for control and influence. Covid was the inflection point, the overreach by world governments, operating without scrutiny or accountability under the guise 'for the greater good.' You mentioned earlier the Left-Right paradigm. Us versus them is a trap, the setting up of opposing camps to contest each other. Vax v unvaxxed, climate change – we're caught in false binary thinking, purposely limiting debate and alternative solutions. It is epistemological warfare, deliberate suppression and control; the manipulation of ideas to maintain social and political dominance.

Q: After your previous work for Oracle Films on covid 'vaccines', you would have been derided as a conspiracy theorist. But the people who close themselves off to any revelations about the dystopian plans for humanity are conspiracy deniers. Should we embrace, rather than deny, our role in theorising and exposing conspiracy?

PW: I think we have to. The term 'conspiracy theorist', is a pejorative designed intentionally to close down discussion and debate on many important

issues. To deny that there is worldwide orchestration occurring at some level, at the behest of the few and to the detriment of the many, is to deny reality in 2025. It might make people feel at ease in the short term to pretend everything's fine, but sooner or later, reality will rear its head. I think it's better to be prepared for that time; physically, mentally and spiritually.

MS: I never regarded *Safe and Effective: A Second Opinion* as a conspiracy theory and neither were we ever accused of that. The film reflected real human suffering, sound scientific questions and hard evidence of government and media influence. Likewise *The Agenda* features well-qualified experts giving their views on the direction of travel.

Independent journalism is vital in an era when corporate and state media seem to have deserted core values like accuracy, independence, impartiality and a thirst for the truth. Of course, *The Agenda* isn't impartial either – it's there to balance the media, asking questions of the official narratives like climate crisis and net zero.

PS: It's everybody's duty to question and challenge these political and economic shifts where consent has not been sought, otherwise we're giving tacit agreement to these authoritarian measures. Ultimately, we will lose personal sovereignty and live under a rules-based global order.

Q: The Agenda needs to reach an optimal audience. I doubt that it would be shown in schools, as was Al Gore's preposterous *An Inconvenient Truth*, but how can we all help to ensure that the film is viewed by nearer a billion than a million, and most importantly, by people in positions of power and influence?

MS: It would be a huge step to see the film played in schools and universities, if only to offer students a different perspective, but don't hold your breath. I was surprised to find the level of indoctrination in the education system; critical thinking is not encouraged.

PW: How can people help? Share it. You can download a copy of the film for free at theagendafilm.com. It's (as I write this), still up on YouTube which can be useful for those not looking for this kind of information. It's also available on Rumble, X and has been mirrored all over the web which is great to see. This decentralised approach is a terrible model from a business perspective mind you, because it makes it nearly impossible to monetise, or even keep track of viewing figures and metrics. There's no paywall. But that's not why we've done this. Was our destiny derailed?

Hidden history offers solution for regaining our sovereignty

THOUGH I always loved history, I could never understand the particular fascination many seemed to have with the English Civil War, and especially the evident desire to re-enact battles from it.

My feelings began to change when the recently published *The Fall: Last Days of the English Republic*, by Henry Reece, caught my eye. Not that it stoked in me any kind of interest in participating in battle re-enactments of any kind, but it did make me start to wonder how such a critical turning point in the history of our country could have gone so overlooked for so long.

In the months that followed, it is no exaggeration to say that I developed a lifelong obsession with Oliver Cromwell, the English Republic, and in particular how, why, and to what extent Cromwell's untimely and unexpected death on September 3, 1658 led to the demise of the Republic a year-and-a-half later.

I found another work from 2000 by American author, H. F. McMains, and published by the University Press of Kentucky, entitled *The Death of Oliver Cromwell*.

In essence, McMains puts forward the hypothesis that had already begun to crystallise in my own mind – that Oliver Cromwell did not die of malaria, but was in fact assassinated by poisoning.

Put simply: if it is indeed true that Cromwell's death was due to an act of murder (and thus treason), where would that leave the restored Stuarts and their successor ruling dynasties in terms of constitutional legitimacy?

Though the history of the English Civil War that brought Oliver Cromwell to the brink of power in the 1640s has long been taught in our schools (at least in outline), the same is far from true of the period of his rule as Lord Protector in the 1650s. It is routinely breezed over as an irksome and faintly embarrassing interlude on the road to the inevitable Restoration compromise of constitutional monarchy.

Yet a closer look at the history of the period tells us that there was, in fact, little at the time that was inevitable about the restoration of the Stuarts at all.

Cromwell's Protectorate presided over a period of stability, growth, and good government in England like no other before or since. For it was during this period that Britain – the three ancient kingdoms of England, Scotland, and Ireland united for the first time – established itself as the world's foremost military and naval power, feared and respected by friends and enemies alike. It was a position of unparalleled dominance built on foundations firm enough to hold for the next three hundred years.

Misconceptions about Cromwell himself abound. Contrary to received mythology, the republican regime enjoyed broad popularity. By 1658, it was Cromwell's Protectorate – and most definitely not the finished Stuart monarchy – that was seen by all key political factions as the form of government that

most reliably guaranteed lasting peace, security, settlement and compromise.

The Stuarts, it seems, were returned to power in 1660 not by historical inevitability, but, on the contrary, by the derailment of the natural historical process through foul play.

Cromwell's alleged murder opened up a power vacuum which, over the course of the ensuing eighteen months, proceeded to devour the English Republic in a maelstrom of intrigue and infighting, culminating in General Monck's military coup de grace of February 1660.

So what is to be done? It is often said that the British people are not instinctively republican by nature, and perhaps this is true. But it is also true that neither, actually, was Cromwell.

Far from wanting rid of the monarchy as is often supposed, Cromwell's principal concern was simply that the king should provide the British people with good government.

It was only when it became clear that the king would not budge from insisting upon his supposedly God-given right to run the country his way – despite the fact that he was obviously too selfish, incompetent, and beholden to foreign interests to be able to do so effectively – that the decision was finally made, reluctantly, that he had to go.

Now – as four centuries ago – we find ourselves at a critical point in the history of our country, where the very survival of England itself is once again the issue at stake. Decade upon decade of relentless social, economic, and moral decay has brought us to a point where the ruling elite has never been more shamelessly corrupt, out of touch, and fundamentally at odds with the interests of the nation.

As the writer and broadcaster Peter Hitchens presciently observed, as early as 2003: 'England is rapidly becoming a place where the good are afraid of the bad and the bad are not afraid of anything.'

Since then of course, things have gotten much, much worse. It is abundantly clear now, in 2025, that the need for formal constitutional protections for the British people against this insidious, totalitarian, international power has never been more urgent.

We are at least fortunate, then, that for such constitutional protections, we would in fact need look no further than the already existing historical and legal precedent set by the Constitution of the Protectorate, our country's first and only written constitution – specifically, the initial Instrument of government of 1653, and its second iteration, the Humble Petition and Advice of 1657.

It would appear that there is a strong prima facie constitutional case for the establishment of a second protectorate in Great Britain and (Northern) Ireland.

A protectorate would, once again, as in its first incarnation in the 17th century, provide a form of republican government acceptable to the British people. Now, as then, it would retain the pomp and ceremony, the pageantry and dignity of monarchy. Monarchy in all but name. But no crown, and no dynastic mode of succession. The absence of the latter would ensure once and for all against the corruption of the institution into a vehicle for pursuing private family gain at the expense of the nation.

There will need to be a determined electoral effort on the part of the British people over the coming years to regain control of parliament, not only so that it can once again become a democratic check on corrupt state power, but moreover, so that the very possibility of corrupt, unaccountable state power can be put behind us as a nation once and for all.

Unquestioning obedience to authority

AS many Western societies continue to steamroll into totalitarianism, one must wonder how we have come to this sad point in our existence – and more importantly, what is making a fearful population be so compliant and obedient?

Many truth seekers who questioned the covid-19 narrative from day one were baffled and frustrated by how the general population could surrender their hard-fought freedoms and liberties so easily without any fightback.

One such experiment may explain how it all happened.

The Milgram Experiment carried out in the early 1960s by Yale University psychologist, Stanley Milgram, measured the role of authoritarian power, free will and obedience.

The experiments were in direct response to the trial of the World War II Nazi Adolf Eichmann. Eichmann's defence alongside many foot soldiers in the German ranks reiterated the sinister point that they were only following instructions and orders during the war from their superiors.

The Milgram Experiment is based heavily on social psychology and was a landmark experiment for its time. Like any experiment, there are always flaws and questions over its methods and legitimacy, but the results from Milgram's research were stark and fascinating.

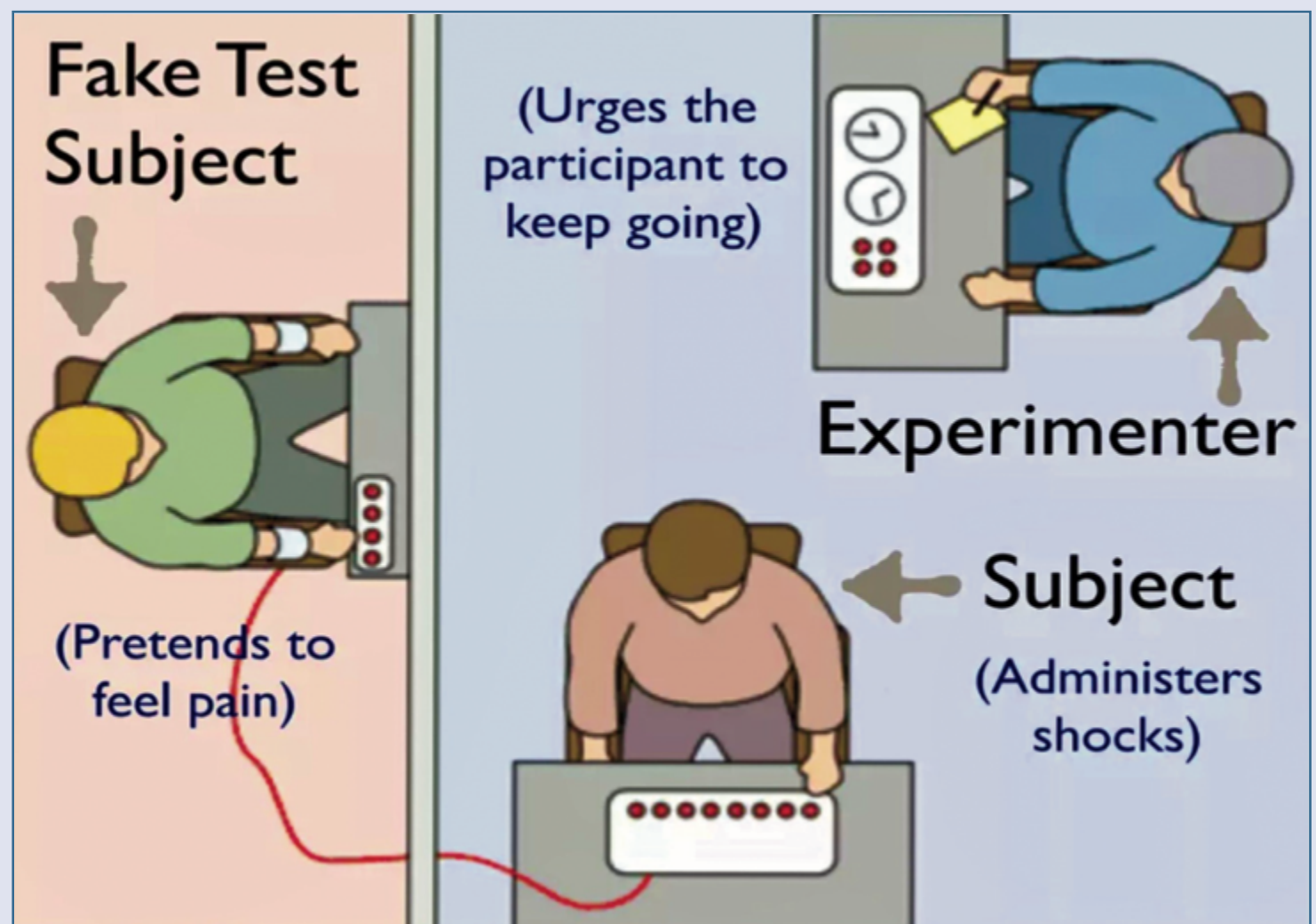
The Milgram Experiment aimed to measure how law-abiding ordinary citizens could willingly obey an authority figure who instructed them to take drastic actions.

The tests involved instructing study participants to deliver a series of high-voltage shocks to an actor in another room when they answered a question incorrectly.

The well-played actor would scream because of the volts and would eventually go silent as the shocks became stronger. The shocks weren't real, but study participants were made to believe that they were.

The experiment tested how far people can truly go in obeying an authority figure. A key component of the experiment was that participants had been told that the experimenter held all responsibility. This was called the agentic state theory.

Milgram said: "The essence of obedience consists in the fact that a person comes to view themselves as the instrument for carrying out another

person's wishes, and they therefore no longer see themselves as responsible for their actions. Once this critical shift of viewpoint has occurred in the person, all of the essential features of obedience follow."

During the covid scam we all remember seeing people in our communities submissively succumbing to the pressure of relentless government instructions to mask up and get the jab without any critical thought, discernment or questioning.

Going back to Milgram, many participants in the intrusive experiment expressed hesitation about continuing with the study due to the delivery of electric shocks.

The experimenter, dressed in a respectful authoritative lab coat, firmly instructed the participants to continue using four prods:

'Please continue.'

'The experiment requires that you continue.'

'It is absolutely essential that you continue.'

The experimenter or perceived authority figure would strongly urge them to go on with increasingly firm instructions,

resulting in the statement: 'You have no other choice, you must go on.'

These dark instructions and mantras were in overdrive during the scamdemic, as the public was continuously reminded by the tyrannical powers that we have no other choice but to comply as 'we are all in this together, for the greater good'.

Regardless of the conflict with one's better judgement, inner conscience, values and morals, the results from the study indicated the need to obey was either out of fear or out of a desire to appear cooperative.

Milgram published a book in 1974 called *Obedience to Authority* and remarked that 'often it is not so much the kind of person a man is, as the kind of situation in which he finds himself that determines how he will act.'

Many of us looked on in bewilderment and sadness during covid when we saw people not wishing to visit or hug their loved ones, or people closing their hard-earned businesses without a second thought because of government overreach.

Stockholm Syndrome, self-sabotage and cognitive dissonance were all at play when watching these depressing uncontrollable situations unfold.

Einstein was accurate when he said: 'Blind obedience to authority is the greatest enemy of truth.'

Despite continued obedience by a large section of the population, we must be kind and understanding to our fellow human beings. Even our incompetent politicians and legacy media are mere pawns in all of this.

Richard House [RH]: Your four articles (with David Parker) on cancer (*The Light*, issues 33-36) alerted readers to your monumental groundbreaking book *What Really Makes You Ill?: Why Everything You Thought You Knew About Disease Is Wrong* – which currently has an extraordinary 1,332 Amazon ratings. Tell us about the background to the book, and why you wrote it.

Dawn Lester [DL]: About 18 years ago, we decided to turn our course about the nature of reality into a book, which led to our reviewing and updating some of the content. In the course of revising the chapter about health, we started to deepen our research to gain a better understanding of what makes us ill.

During this research, we found a number of books written by doctors critical of the mainstream medical system. We also discovered various online resources, including a website that referred to the work of Dr Stefan Lanka, a virologist who claimed there is no evidence that viruses are the cause of any illness, which was a huge surprise to us. This led to a much deeper dive into the ‘germ theory’ and the discovery that it has never been proven that any germ is the cause of any disease.

But finding unproven medical theories was not restricted to those relating to ‘infectious’ diseases. Further investigation led us to discover that the medical establishment system has a poor level of understanding about virtually all health problems. We questioned how such a poor healthcare system had been able to achieve its influence, and discovered the role of powerful vested interests, especially within medical schools and medical research.

Through different books and online resources, we learned about the wide variety of factors that genuinely contribute to health problems, including the products we buy and use on a daily basis.

Our aim for the book is to help people make informed decisions. It is for the purpose of providing them with sufficient information that we included as much as we could in the one volume.

RH: Medical professionals I encounter on the street seem to genuinely (and sometimes aggressively) believe themselves to be the sole custodians of medical knowledge, and no-one else. Assuming they are indeed misinformed, or often just plain wrong, how has this self-

deluding hubris come about?

DL: The simple answer is the medical system inculcates that attitude. *Confessions of a Medical Heretic* by Dr. Robert Mendelsohn was a real revelation for me, because here was a qualified doctor who called his profession a religion and referred to it as ‘the church of modern medicine’.

Although a maverick, Dr Mendelsohn was not entirely alone in his view, although outspoken doctors form a very small minority. But this raises the question: if Dr Mendelsohn is correct, why are so few doctors exposing these problems within their profession?

Our further investigations revealed the source of this situation. It’s a problem that lies at the heart of all areas of education. Students are required to pass exams to receive their qualification, so they need to provide the ‘right’ answers to the questions. It’s no different for medical students, whose curriculum is jam-packed with huge volumes of information they need to learn by rote and then regurgitate in their exams.

The medical school curriculum is obviously based on mainstream ideas and theories, which students have to follow or they’ll fail their exams. They invest many years of hard

work to achieve their qualification. Once qualified, physicians have little incentive to operate outside of the mainstream paradigm, especially as they would face huge problems were they to do so.

As I indicated, there are powerful vested interests behind the medical system. I’d add that few people would be brave enough to admit their entire career was based on a false paradigm; this quote attributed to Upton Sinclair remains pertinent: ‘It is difficult to get a man to understand something when his salary depends on his not understanding it’.

RH: Was responding to this dire situation a driving motivation behind your book? – a kind of ‘medical manifesto for self-empowerment’ that provides tools for largely bypassing wrong-headed mainstream medicine.

DL: In a way, yes; it was really a question of responding to the thought that, if we aren’t aware of how little the medical system actually knows about health, there must be many other people who also don’t know about this.

I don’t mean to sound pompous, but it was obvious that a significant proportion of the population were (and many still are sadly) as completely unaware as we were of the

full extent of the problems with modern medicine. This was the main motivation to write about and share our findings.

The reason we dived so deeply and broadly into as many aspects of the situation as we could, was to provide as comprehensive an overview as possible in a single volume, and show the importance of self-responsibility for our choices with respect to health matters. So yes, it is a kind of self-empowerment manifesto, although we do not provide advice. People are responsible for their own choices.

RH: And how has your magnificent book been received by the various relevant constituencies?

DL: As you can imagine, there has been some criticism, including reviews on Amazon, although I have not read them all. A particularly early critical review was an article published in June 2020 on sciencebasedmedicine.com that claimed neither of us had a background in science or medicine and so we clearly didn’t know what we were talking about. This has probably been one of the main forms of criticism that people have used against the book. This is, of course, the ‘appeal to authority’ logical fallacy.

In contrast, though, many qualified people, both doctors and scientists, have commented favourably and said that our book is very much aligned with their own research findings, although sometimes with minor differences, with respect to dietary choices for example. In general, it has been well-received by many professionals as well as the public.

War is peace, slavery is freedom

Starmer the great conspiracy theorist talks up threats

KEIR Starmer is beating the war drum, but is the threat real?

Psychologists tell us that the tried and tested way to control a populace is to create endless external ‘threats’. Overcome by fear of impending danger, many people will seek refuge in the crowd, and start to conform to its collective thinking and behaviour at any price, rather than question the reality of the threat being presented. In so doing, they relinquish their ability and responsibility to think rationally and independently.

Recent history provides ample examples. At the beginning of the new millennium, in the wake of the false flag event of 9/11, George W. Bush announced his War on Terror. This unidentifiable, enduring ‘enemy’ became the justification for undemocratic and unconstitutional legislation, plus covert operations and military offensives against sovereign nations.

Bush then declared: ‘You are either with us or against us’. This prepared the ground for the 2001 U.S. Patriot Act, a sinister law that gave federal authorities sweeping powers to override democratic protections, and enabled the American invasions of Afghanistan and Iraq. Those who challenged this dismantling of the guard-rails against untrammelled power were labelled ‘anti-American’, ‘anti-freedom’, or ‘pro-terrorism’. Such simplistic terms allow for no qualification; and that is their purpose. They are intended to block out any rational argument.

Fast-forward to the next concocted threat, when a ‘lethal virus’ was presented as threatening the world’s population, and anyone resisting government-imposed lockdowns and mass injection was labelled a ‘virus-denier’ and an ‘anti-vaxxer’ respectively. As the mRNA assault rapidly gave rise to a range of illnesses, life-changing injuries and fatalities, it became clear that the real threat to society was that which the government imposed and coerced the population into accepting.

Together with the labels went a reversal of the entire concept of morality. Responsible doctors who questioned the safety of the jabs lost their licences, whilst questioning individuals who chose not to take them were accused of being selfish and jeopardising societal return to normal. The reversal of our understanding of morality is a trick that could well be used again.

By the end of 2021, when the inevitable consequences of the disastrous pharmaceutical assault could no longer be hidden, the public’s attention was swiftly re-directed to a new threat: big bad Russia, and the absurd notion that the entire European continent was under threat. Again, the message carried a twisted insistence that as a country we had a duty to promote and feed a conflict in Ukraine,

destined to result in huge loss of life, misery and destruction, on moral grounds. It could not have been more Machiavellian.

NATO is the largest military force in the world. Created by Britain post-WWII to ‘keep America in, Russia out and Germany down’, it serves America’s foreign conquest interests. Its modus operandi is agent provocateur versed in playing victim, whilst its vast network of security services, through their stenographers in the media, ensure western electorates believe in the myth that it is a benevolent alliance concerned only with defence.

NATO, like any organisation, will endeavour to perpetuate the conditions that justify its existence. In the case of NATO, that means war. If threat there is, it comes not from Russia, but from NATO itself.

The West is being bombarded by war talk. The distortion of language is already underway, as Keir Starmer tries to tell us that preparations for war mean ‘peace and security’. Next we can expect to hear that anyone opposed to war is ‘immoral’. But we can all play with labels, and if ‘conspiracy theorist’ is one who engages in wild fantasies, then nobody deserves the label more than Keir Starmer himself.

Turning a blind eye to genocide

We can help support families devastated by destruction

UNTIL recently, Palestine had been dominating the headlines. Even Greta Thunberg jumped on board, taking a sabbatical from her usual crusade of public climate shaming.

However, It’s refreshing to see that even the most indoctrinated among us have utilised their platforms by drawing attention to the live-streamed genocide of Palestinians. The monotony and oversaturation of such coverage has desensitised the public into a state of detachment, to the point of being counter-productive to those who seek to stop it.

The whole ‘it’s not in my back yard’ schism has become a go-to resolve from lockdown campaigners to those playing jab roulette. The issue of poorly regulated migration is one often shared amongst a vast spectrum and is, of course, not without merit.

For many, such frustrations surrounding the demise of our homelands further compound the reluctance to look beyond our borders. Such a short-sighted approach towards humanitarian values could not only point towards why we have such problems, but also seal the fate of landing us into a very similar position.

The history of Britain retains a close bond with various atrocities the world over. The proliferation of Israel being just one of such scenarios, leading to the preventable suffering of millions. Britain has been instrumental, not only in the approval of the Zionist state back in 1917, but also the oversight of it’s formation in 1948.

Since then, millions of Palestinians have perished at the hands of Zionist rule, as it has progressively encroached outside of its agreed territory. Every attempt to create stable governance outside of this regime has been thwarted by hostile militias such as Hamas, who in turn have been bolstered by swathes of Qatari funds, overseen by Israel itself.

The Balfour declaration chartered by the British government in 1917 was not without condition. Most notably that: ‘...it being clearly understood that nothing shall be done which may prejudice the civil and religious rights of existing non-Jewish communities in Palestine, or the rights and

political status enjoyed by Jews in any other country’.

It is evident that since the Balfour Declaration, Britain has not only given carte blanche to the State of Israel, it has actively facilitated the breach of this agreement in providing significant military resources, even in the most brazen violations of international law. This emphasises why the ‘it’s not in my back yard’ justification for looking the other way could well become one of the greatest regrets for many, in exchange for temporary diminished responsibility.

Due to the ongoing devastation of Palestinian infrastructure, organisations who were able to support those in dire need are out of operation. Since March 2, 2025, the Israeli blockade has permitted only a trickle of supplies into the Gaza strip. Despite the mass of lorries packed with supplies being a stone’s throw away. This barbaric act of deliberate starvation is unprecedented within the last century. On June 24, 2025 the UNRWA (The United Nations’ Relief and Works Agency) announced its imminent collapse, with both the U.S. and Sweden withdrawing funding.

The commissioner-general of the UNRWA, Philippe Lazzarini, has slammed the U.S.-Israel food distribution program as a ‘war crime’, with at least 420 Gazans massacred, and 3,000 wounded by its third week. With many returning empty handed, this initiative is a smoke-screen for further bloodshed.

This leaves Gazans praying for the mercy of the international community. With your support, we can reach out to families directly, providing them with a vital life-line. Supplies are at a bare-minimum and Israel are taxing 30 per cent of their funds. Despite these obstacles, small donations collectively will make the difference between life or death to these families.

As the mainstream media turn away from the screams of Palestine and the indiscriminate massacre of defenceless civilians, I encourage you to take a look before October 7, and find your own reason to stand with its people.

Jehad Asfour, 37, was a Psychologist in Gaza. He and his Wife Heba, 34, have five Daughters; Manal, 14, Hiam, 13, Abdullah, 11, Rima, 9, and Dima, 7. They are facing imminent famine and malnutrition after losing their home and livelihood. Since it was bombed, they have been living in a tent for the last 19 months. His family need food and clothes for their children. They have been displaced more than once to Rafah and Al-Mawasi. Despite his recent back operation, Jehad regularly walks the one hour gauntlet of gun-fire to the distribution point, often returning empty handed.

And now Palantir is selling its gathering of all-consuming data on everyone as ‘Total Information Awareness’.

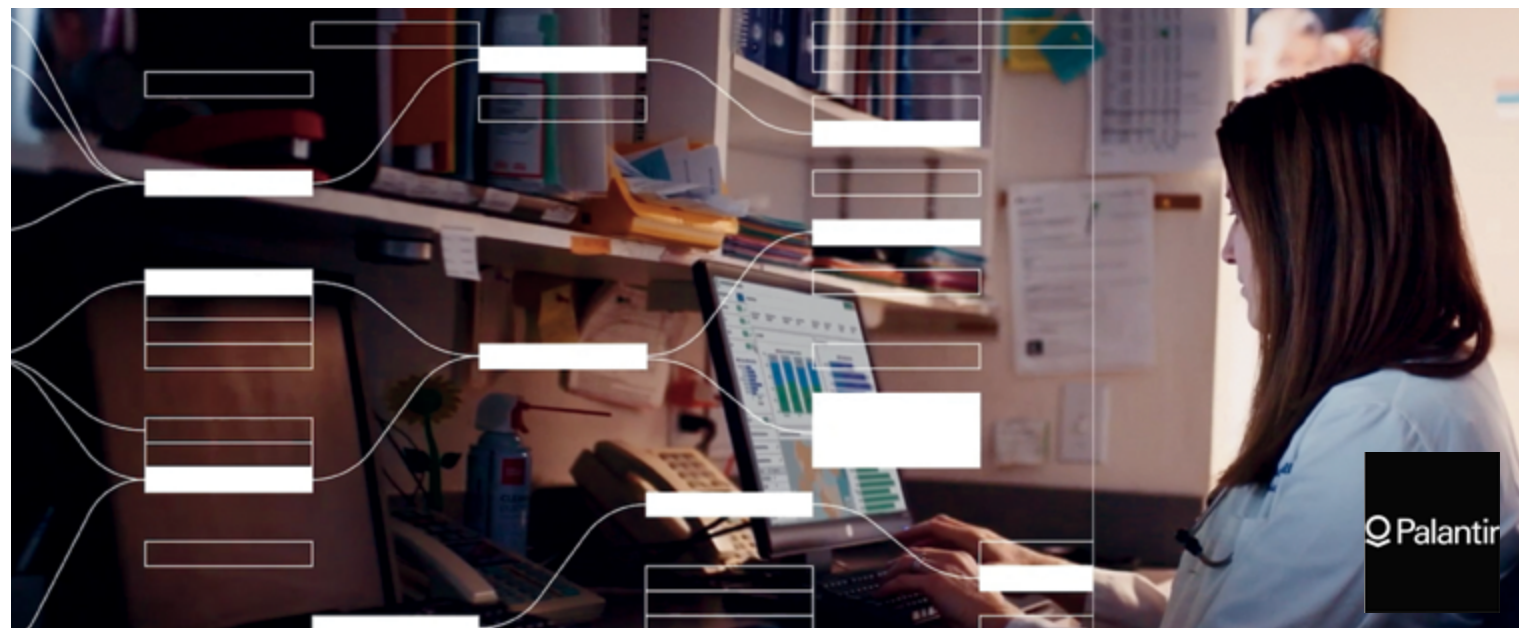

How the banks control our food

Shareholders in shadows dictate how agriculture operates

THEY don't sell seeds. They don't own tractors. They don't run warehouses or ship grain. But BlackRock, Vanguard and State Street are among the most powerful actors in global agriculture.

Together, these three asset managers control more than \$26 trillion in assets – more than the GDP of the United States and India combined. They are shareholders in nearly every major agribusiness: Bayer, Cargill, ADM, Nestlé, Deere & Co and more. They don't compete. They co-own. And through that ownership, they govern.

This is not capitalism as competition. It's capitalism as quiet coordination.

These firms don't need to dictate policy. They shape the terrain on which policy is made. Their influence is structural, not spectacular. It's exercised through boardrooms, shareholder resolutions and capital flows. And it's largely invisible to the public.

But its effects are everywhere.

According to the Food Barons 2022 report

by ETC Group, BlackRock, Vanguard and State Street hold dominant stakes across the agrifood chain – from seeds and chemicals to supermarkets and logistics platforms. In many sectors, they are the top three shareholders in all the major firms. This means that 'competition' between companies like Bayer and Syngenta, or Nestlé and PepsiCo, is often little more than a performance. The real power sits behind the curtain.

These firms don't micromanage. They don't need to. Their power lies in alignment – in shaping what counts as value, what counts as risk and what counts as acceptable behaviour. And increasingly, that behaviour is being framed through the lens of ESG: Environmental, Social and Governance metrics.

But ESG is not a moral compass. It's a risk framework.

In recent years, BlackRock and its peers have positioned themselves as climate-conscious investors. They speak of 'net zero', 'transition finance', and 'sustainable agriculture'. But this is not about decarbonising the food system. It's about de-risking portfolios.

The same firms that invest in fossil fuels also invest in carbon offset schemes. The same firms that back industrial agriculture also fund 'climate-smart' seed technologies. It's a hedging strategy, not a transformation.

And in India, this logic is taking root.

Asset managers are increasingly backing land-leasing platforms, agrifintech startups and carbon credit aggregators that promise to 'unlock value' from farmland. But unlocking value often means locking

farmers into new forms of dependency – on scoring systems, digital compliance and speculative markets they don't control. This is not investment. It's extraction with a sustainability label.

The most dangerous shift in agriculture today is not technological – it's financial. Land is no longer just a place to grow food. It's an asset class. A hedge against inflation. A site for data capture and carbon speculation.

In this model, the farmer is not a producer. They are a tenant on someone else's spreadsheet.

And the spreadsheet is worldwide.

BlackRock doesn't need to own the land. It just needs to own the firm that owns the firm that leases the land. Through layers of investment vehicles, farmland is being bundled, securitised and traded – often without the knowledge of those who live on it.

This is enclosure without fences. Governance without government.

Asset managers like to present themselves as passive investors. They claim they don't direct company strategy – they just follow the market. But when you own 5-10 per cent of every major firm in a sector, you are the market.

And when you vote on shareholder resolutions, appoint board members and shape executive pay, you are not passive.

In 2023, BlackRock and Vanguard voted against resolutions that would have required agribusinesses to disclose their impacts on deforestation and land rights. Their justification? The proposals were 'too prescriptive'. But what they were really

protecting was the freedom to operate without scrutiny.

What makes BlackRock, Vanguard and State Street so dangerous is not that they are evil. It's that they are structural. They don't need to conspire. Their incentives are aligned. Their tools are abstract. And their power is exercised through absence – of regulation, of transparency, of accountability.

They are not the villains of this story. They are the architecture.

And that makes them harder to fight.

Food sovereignty is not just about seeds or soil. It's about power. And power today is financial. It flows through indexes, benchmarks and capital allocations. It decides which crops are grown, which firms survive, and which futures are funded.

And it does so without ever touching the soil.

Christian town ‘besieged’ by Israeli settlers

West Bank priest claims residents live in daily fear of attack

THE last entirely-Christian town in the Israeli-controlled West Bank is enduring a wave of attacks by violent Jewish settlers, a local church leader says.

The conflict – it is claimed – is prompting families to flee while leading clergy declare the town is ‘no longer safe’ for its inhabitants.

Ominously, settlers have also set up an ‘outpost’ on the fringe of that town, Taybeh in Ramallah. It is a 4,500-year-old community with huge significance in the story of Jesus Christ.

“The town, which the Gospel of John (11:54) refers to as ‘Ephraim’ – the place Jesus withdrew to before his passion – is no longer safe for its people today,” Father Bashar Fawadleh, parish priest of Taybeh’s Church of Christ the Redeemer, told the Catholic, Arabic-language ACI MENA news service.

He said: “We do not live in peace but in daily fear and siege. Since last October, more than 10 families have left Taybeh due to fear from ongoing violence and harassment.”

Videos have been circulating on social media, claiming to capture the settlers’ latest attack on the outskirts of Taybeh at the end of June. The BBC also reported on the attack.

This is only the latest in an ongoing pattern of aggression directed toward Taybeh’s inhabitants, according to Catholic News Agency. The news site claims it is a pattern that has also included stealing farm equipment, and destroying crops with fire or by releasing settlers’ cattle to devour them.

Settlers have established an outpost on the town’s eastern edge, on the remains of a farmhouse abandoned by Christians who had fled about a year ago under the growing settler campaign of violence and intimidation.

An ‘outpost’ is a Jewish settlement on Palestinian land that is not authorised by the Israeli government. Outposts typically begin with something as small as a tent or a van, and are frequently situated on hilltops or agricultural land.

In the case of ‘herding outposts’, settlers will bring livestock that they allow to graze over a wide area with the goal of establishing a larger claim. Despite outposts’ lack of government permission at the outset, the Israeli government often legalises them retroactively, cementing the Palestinians’ loss of the land.

There are both Christian and Muslim Palestinians, and it is claimed both groups have experienced the consequences associated with being non-Jewish in the West Bank.

The settler outpost on Taybeh’s periphery sits in an economically essential agricultural zone that comprises 4,200 acres out of the town’s total 5,900 acres.

The land is used for olive groves and seasonal crops, along with raising poultry and sheep. It is claimed that in the usual sequence of events, Jewish people in the outposts begin harassing the Palestinians whose families have long lived off that land, preventing them from accessing it. Such behaviour is often carried out as Israeli security forces stand by and watch – often intervening only when Palestinians fight back.

Local Christians say this agricultural-deprivation tactic is exactly what is playing out in Taybeh.

ACI MENA news service reported: ‘During the latest olive harvest season, for the second year in a row, farmers were barred from accessing their land near the Rimmonim settlement – which was built on confiscated Taybeh land – resulting in either theft or complete spoilage of the olive crop. Approximately 20 families

were physically assaulted while trying to reach their land.’

Father Fawadleh told the news service: “These days, settlers are grazing their cows on a hill planted with olive and barley fields right next to people’s homes. Locals see this as part of a systematic effort to strangle them economically and push them out.”

The reported treatment of Taybeh’s Christians helps explain why Israel-catering Texas Senator, Ted Cruz, was booed off a stage in 2014 as he delivered a tin-eared keynote address at a gala hosted by In Defence of Christians (IDC), a nonprofit that seeks to counter persecution and mistreatment of Christians throughout the Middle East – including Israel. Cruz later insisted in a news interview that the Bible commands Christians to support the modern political entity that is the State of Israel.

At that 2014 IDC event, Cruz drew boos from the crowd when he said: “In 1948, Jews throughout the Middle East faced murder and extermination and fled to the nation of Israel. And today, Christians have no better ally than the Jewish state.” Cruz attempted to plow on, saying: “Let me say this – those who hate Israel hate America. And those who hate Jews hate

Christians.” The booing and heckling endured, forcing Cruz to abandon the event, saying: “If you will not stand with Israel and Jews, then I will not stand with you.”

Around 15km north-east of Jerusalem and 12km northeast of Ramallah, Taybeh was established by the Canaanites between 2500 and 2900 BC. Three Christian communities live there harmoniously – Greek Orthodox, Roman Catholic, and Melkite Greek Catholic.

With beautiful whitewashed homes, the original Church of St George was built by the Byzantines in the 4th century, the ruins of a Crusader castle, and described in the Bible as the place where Jesus sought refuge before being crucified, it has been an attractive destination for Christian tourists – although it is unclear how much longer that will be the case.

One thing is certain, Ted Cruz and groups like Christians United For Israel are unlikely to be speaking out on behalf of Taybeh’s residents anytime soon.

What if diarrhoea and vomiting are strategies my body uses to remove wastes? What if excessive phlegm and a runny nose is another? What if the symptoms we commonly refer to as being 'sick' are actually just the necessary steps of healing?

Hidden household toxic chemicals

Poisons disguised as ‘fragrance’ in cleaning products

WE know toxic chemicals are contributing to cancer, learning difficulties and infertility, but we still allow them to remain in our daily lives and even in our own private homes.

If you could even just restrict exposure to toxic chemicals that are known to cause harm, surely that’s a worthy goal?

The World Health Organisation has said: ‘Exposure to EDCs (endocrine disrupting chemicals) represents a global health threat.’

These EDCs are rarely listed on product labels in the UK. They are often found in everyday cleaning products hidden within the listing ‘fragrance’.

EDCs can enter our bodies indirectly via

absorption through the nose, mouth and skin and these chemicals trick our bodies into mistaking them for real hormones.

And it has been claimed that during research from health advocates, Environmental Working Group, umbilical cord blood was tested for 300 chemicals and 287 toxic chemicals were found that are sometimes labelled as ‘fragrances’ on packaging.

We are being born pre-polluted with hundreds of toxic chemicals from everyday products.

These toxic chemicals can enter the unborn child by getting into the mother’s body, slipping across the placenta and can contaminate the unborn child even before the moment of birth, so it is common sense to exercise precaution.

Why continue to use everyday household cleaning products that have been directly linked to ill health, especially when there are other options available?

Endocrine disruptors can be ‘hand-me-down’ poisons. Often the grandparents and the parents who have been initially exposed to the toxic chemical appear fine,

but then toxic effects are carried down and exhibited in a few generations.

EDCs found in toxic chemicals can be stored in your fat, bones and other tissues and could later be transferred to a baby in the womb.

Independent science, free from vested interests, finds that exposure to toxic chemicals could make it difficult or impossible to conceive and has been linked to miscarriages.

What we do know is that products containing hidden chemicals, with fragrance being added here, there and everywhere, are highly likely to contain EDCs.

Therefore the easiest way to avoid EDCs is to consciously make the switch to non-toxic, fragrance-free cleaning products.

Why continue to use everyday household cleaning products that have been directly linked to ill health?

The wake up point for most families is when someone becomes very sick and it is often too late. That is why it really takes an active/holistic approach when choosing different personal and household products.

Once you know, you can’t unlearn it. Unless you are actively consciously buying non-toxic, fragrance-free cleaning products, it is highly likely the products you currently use contain many hidden toxins.

It’s amazing how much of a difference we can make by not bringing this stuff into our homes.

The result of all these toxic chemicals (especially over the last 60 years) found in everyday cleaning products can be clearly seen now in the decline of our children’s health today.

It may not be the only factor to blame, but it definitely is part of the problem and harmful chemicals are not conducive to health.

Asthma, once very rare, is now very common. Regular and frequently occurring headaches are in most families nowadays.

Allergies and intolerances are now the ‘norm’. Neurological issues from anxiety to behavioural problems can all potentially benefit from reduced exposure to toxic chemicals.

NO government has the right to decide on the truth of scientific principles, nor to prescribe in any way the character of the questions investigated.

Nobody has ever figured out the cause of government stupidity – and until they do (and find the cure), all ideal plans will fall into quicksand.

Don’t pay attention to authorities, think for yourself.

Have no respect whatsoever for authority; forget who said it and instead, look what he starts with, where he ends up, and ask yourself, ‘Is it reasonable?’

It’s our responsibility as scientists, knowing the great progress which is the

fruit of freedom of thought, to proclaim the value of this freedom; and to demand this freedom as our duty to all coming generations.

We never are definitely right, we can only be sure we are wrong.

I would rather have questions that can’t be answered than answers that can’t be questioned.

Science is a culture of doubt...If you thought that science was certain – well, that is just an error on your part.

The thing that doesn’t fit is the thing that is most interesting.

It’s much more interesting to live not knowing than to have answers which might be wrong.

A scientist looking at non-scientific problems is just as dumb as the next guy...I’m smart enough to know that I’m dumb.

The first principle is that you must not fool yourself – and you are the easiest person to fool.

It is surprising that people do not believe that there is imagination in science.

Nature has a great simplicity and therefore a great beauty...She cannot be fooled. We are not to tell nature what she’s gotta be. She’s always got better imagination than we have.

You can always recognise truth by its beauty and simplicity...The truth always turns out to be simpler than you thought.

Study hard what interests you the most in the most undisciplined, irreverent and original manner possible.

You have no responsibility to live up to what other people think you ought to accomplish.

I learned very early the difference between knowing the name of something and knowing something.

Teach principles, not formulas.

What did you ASK at school today? There is no learning without having to pose a question.

It’s impossible to learn very much by simply sitting in a lecture, or even by simply doing problems that are assigned.

What I cannot create, I do not understand.

All life is interconnected with all other life.

I don’t like honours. I’m appreciated for the work that I did, and for people who appreciate it. I don’t need anything else.

The highest forms of understanding we can achieve are laughter and human compassion.

Tell your son to stop trying to fill your head with science – for to fill your heart with love is enough!

Physics is not the most important thing. Love is.

The Watergate conspiracy

An elaborate hoax

THERE have been many scandals throughout American Presidential history, but only one has ever brought down a President.

To understand Watergate, it may help to understand the culture of this particular administration and of the psyche of the man himself. Richard M. And if the Rockefellers needed an inside man to report on the deteriorating mental state of the President as the situation came to the boil, they had reliable old Henry Kissinger, who was a totally dedicated Rockefeller 'gofer'.

The *Washington Post* was owned by Katharine Graham who was a very close friend of the Rockefeller family and she and Nixon absolutely loathed each other. The managing editor of the *Washington Post* was Ben Bradlee, and when junior reporter, Bob Woodward, approached him with a story about a man who was allegedly passing secrets from the White House/FBI about Watergate, we are supposed to believe that Bradlee responded by giving the responsibility for a major investigation to two junior reporters, Woodward and Carl Bernstein, with nothing other than Bradlee's reputation and the integrity and future survival of the Post and Katharine Graham's empire on the line, if they got it wrong.

We are also supposed to believe that Bradlee gave the go-ahead, without knowing who the alleged informer was, without knowing whether Woodward could be trusted and without even getting permission from Graham to go ahead. And also that Bradlee, a grizzled veteran of Washington, understanding exactly what Washington could do to people who gave away secrets, simply said to Woodward and Bernstein: "You'd better be damned sure you're right, because otherwise we're all in trouble."

The series of breaking stories was in fact 'spoon-fed' to the two unsuspecting young reporters both of whom were driven by their ambition to advance their careers. Bradlee was confident that the operation would be a success because he had all the foreknowledge he needed of Nixon, the target's involvement, well in advance of his two reporters.

Then J. Edgar Hoover died, conveniently (he had been in excellent health but succumbed to a 'heart stoppage'), a month before the Watergate break-in, he was therefore unable to lead an FBI investigation into the Watergate event. Instead, Nixon appointed L.

Patrick Gray, an inexperienced Department of Justice lawyer as new head of the FBI. The anomalies of the scandal, although crystal clear to Intelligence officers, never got in the way of the Washington Post reports.

There were several 'curious' anomalies in the story. The burglars were discovered after a building security guard found the door to the office repeatedly propped open with tape - which he removed, each time re-locking the door, and each time, the tape was replaced and propped open again - thus guaranteeing their discovery.

Cash found on the burglars was connected by the FBI to a Republican Party Re-election Committee Slush Fund.

The 'burglars' included senior career intelligence officers notable for their experience in Black Ops, weapons, demolitions, surreptitious entry, psy-ops, special security, money laundering, espionage, and assassinations. Why were highly-skilled, senior level intelligence operatives involved in a simple break-in? They were all highly experienced 'spooks'.

Nixon commented, upon learning of the event: "It sounds preposterous. The whole thing makes so little sense. Why in such a blundering way? Anyone who knew anything about politics would know that a national committee headquarters was a

useless place to go for inside information. The whole thing is so senseless and bungled that it almost looks like some kind of set-up."

Oddly, the intelligence operatives, who had lived both covert and clandestine existences and were completely accustomed to subterfuge, cover identities, arrests, torture, and lying their way out of similar situations, all confessed immediately that they worked for the CIA.

Standard procedure in this type of situation would have been a quick phone call, a release in anonymity and then to disappear forever, but instead, trained, experienced professional spooks freely confessed all to two junior reporters, without any prompting, much less an inquiry by the judge.

The only conclusion, from an intelligence perspective, is that the perpetrators had purposely made a series of highly visible blunders and left an obvious paper trail that a child could have followed, creating a highly visible story for Woodward and Bernstein to report.

The political theatre, the charade of Watergate was indeed a set-up. It was a fairly elaborate covert operation, with three parts: 1) creating the crime, 2) implicating

Nixon by making him appear to be knowledgeable and complicit in a cover-up, and 3) ensuring that an aggressive effort would be mounted to use the 'facts' of the case to prosecute Nixon and force him from office. Obviously, those that also wanted Kissinger removed, were disappointed. Instead, he became even more powerful and received the Nobel Peace Prize for killing millions.

The truth is that, far from being an 'impartial campaign' to rid the U.S. government of corruption and the abuse of power, Watergate was a City of London-controlled, Rockefeller plot to destroy America's constitutional institutions. No matter what Nixon's many flaws may have been, he did absolutely nothing that could possibly be constructed as an impeachable offence and it was Watergate itself which represented the real offence against the Constitution. It contravened all accepted constitutional procedures, it discredited the office of the Presidency, not simply Nixon personally. It also weakened the morale of the entire nation and it opened the door for Kissinger and a host of clandestine British operatives to consolidate their grip over the essential policy-making institutions of the United States.

has not reauthorised the nuclear weapons programme suspended in 2003. She emphasised that while Iran's enriched uranium stockpile is at its highest levels, there is no evidence of an active weapons programme.

This assessment aligns with the International Atomic Energy Agency (IAEA), which reported in March 2025 that although Iran's enriched uranium levels now exceed what's needed for peaceful civilian use, there is no verified evidence that Iran has resumed work on a nuclear

bomb. The IAEA raised serious concerns over enrichment to 60 per cent, but confirmed that Iran has not crossed the threshold into active weaponisation.

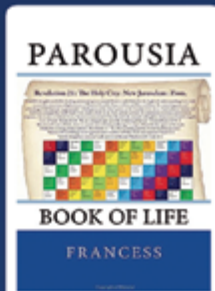
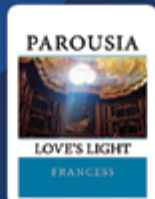
