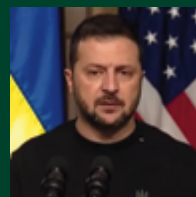

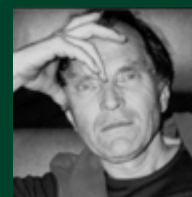

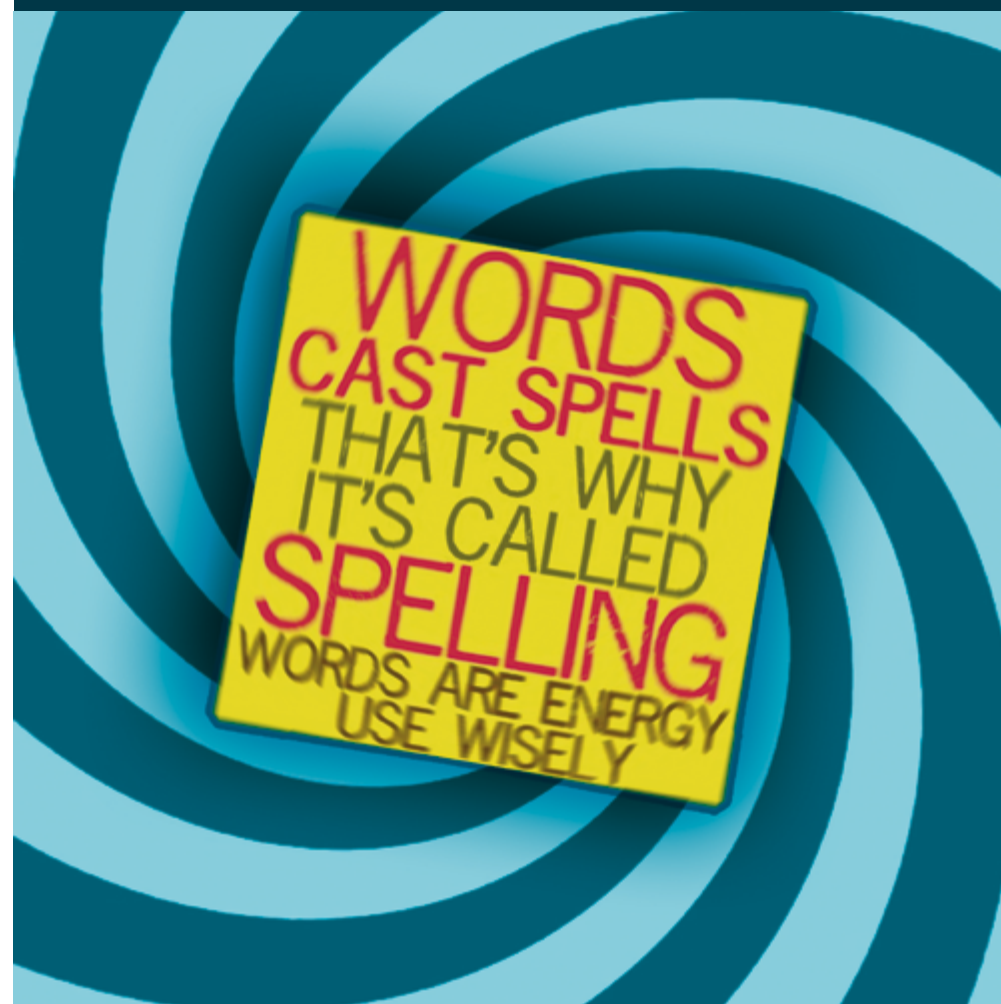

unimaginable things, like forcing children to die alone in hospital.

Credible challenge for Starmer's seat

Feinstein's campaign to stop Labour leader's bid to become Prime Minister

July 4 election could see a sweep of independents

ANDREW Feinstein served under Nelson Mandela as an African National Congress MP in the first democratic South African parliament.

He describes Mandela's leadership as "selfless, principled, accountable, transparent and honest" which, he says, shaped his own political outlook, as well as his involvement in the South African struggle against Apartheid.

Andrew Feinstein resigned from the ANC after seven years, on a matter of principle, due to a corrupt arms deal, which involved members of his party.

For the past 23 years, he has lived and worked in Camden in North London, writing about and exposing the impact of 'the remarkably corrupt global arms trade.' And nowhere, he says, is the link between corruption and cruelty more clear than in the 'ongoing genocide in Gaza.'

On May 21, he launched his campaign to oppose Labour leader Keir Starmer at the general election in his Camden constituency of Holborn and St Pancras.

According to *The Morning Star* newspaper: 'The contest is likely to be one of the most high-profile of a range of independent challenges from the left to Labour MPs, arising from the party's shift to the right under Sir Keir Starmer, and its position on Gaza in particular.'

Such challenges from independent MPs, unbound by party politics, may

be the model needed for those who wish to dismantle the dysfunctional system of politics in Britain.

Feinstein added: "I want to pay tribute to Jeremy Corbyn, who is a friend as well as a colleague." And he strongly denounced Starmer's use of anti-semitism slurs as a weapon to fight factional political battles within the Labour Party.

It is understood Starmer has expelled large numbers of members from the party over anti-semitism allegations, including more Jews than at any other time in the party's history.

Feinstein points to policy pledges Starmer made in 2019 of nationalising water, energy, rail and Royal Mail, which have since been withdrawn.

And in regard to the Israeli conflict, Feinstein claims more than 70 per cent of the people in Britain have wanted a ceasefire in Gaza for the last seven months, and that not one senior mainstream politician had supported that call.

Feinstein claims that Starmer – a former human-rights lawyer – has yet to comment on the fact that the highest court in the world, the International Court of Justice, has ruled that there is a risk that Israel is committing genocide in Gaza.

And he claims that Starmer has supported the prosecution and extradition of Julian Assange, a journalist who revealed war crimes across the world.

Looking at Starmer's career as head of the Crown Prosecution Service, Feinstein claims there are no instances that he knows of in which the now Labour leader recommended indicting agents of the state who had committed crimes while working for the state.

Feinstein believes that a government led by Starmer would be a continuation of permanent austerity, forever wars, and climate alarmism, with all of the socio-economic degradation that will encompass.

Mindset that enabled pandemic psyop

Our tendency to obey authority can lead to great atrocities

2020 will always be known as the year when everything changed.

The whole world was plunged into a frenzy of fear thanks to mass propaganda churned out by the world's institutions, corporations and legacy media.

But why did hardly anyone even try to ask questions?

More than four years on and people are still comatose, clicking onto Netflix, back into work, acting like it was nothing but a bad dream.

And how were entire nations hoodwinked into falling for this biggest of psyops, perpetuated by unelected globalist bureaucrats?

A psychological experiment conducted by Professor Stanley Milgram can shed light on the psychology behind this phenomenon.

In 1974, *Obedience to Authority*, the book about the groundbreaking studies, was published by Milgram, who had been conducting experiments since the early 1960s on how people trust and obey those in power without question.

The result of these experiments showed how far a person was willing to go, when listening to the one who applied pressure, to obey to the point of causing great harm or even death.

The experiment involved three characters: a professor, a subject, and a learner. The learner was wired to a machine, from which they would receive electric shocks. The learner was expected to memorise a pair of words and recite them back to the subject in the correct order.

The subject's role was to push the lever, and incrementally increase the voltage, each time the learner gave an incorrect answer. The professor's role was to make sure that the subject kept increasing the shocks as part of the experiment by prodding them. However the subject was unaware that they were the ones being tested and the electric shocks were fake. The learner's reaction was part of a script to gauge how far the subject would go in the experiment and obey the authority of the professor.

What Milgram found was that subjects were more than willing to go beyond the level of shocks that they would initially administer. At least 65 per cent were willing to administer life-threatening shocks as prompted by the professor, whom they trusted, despite hearing the protestations and screams of the learner from a separate room.

Milgram wrote: 'Many subjects will obey the experimenter no matter how vehement the pleading of the person being shocked, no matter how painful the shocks seem to be and no matter how much the victim pleads to be let out.'

The subjects justify their actions by disassociating with the harm they are causing to the learner. Their moral attention shifts. Milgram explained: 'His moral concern now shifts to a consideration of how well he is living up to the expectations that the authority has over him.'

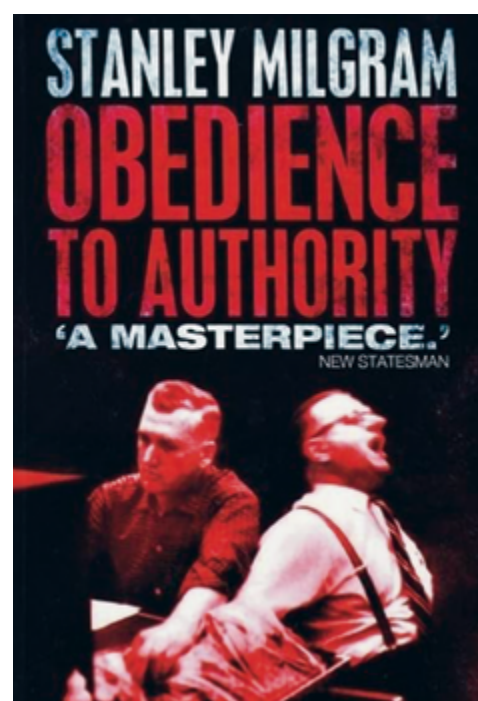
This psychological shift that occurs is labelled by Milgram as 'the agentic shift'.

This agentic state is arguably responsible for many of the atrocities committed throughout history.

During the alleged pandemic, there were also mass agentic shifts occurring in the minds of the population.

People let go of their agency over their actions, and placed their minds into the hands of their superiors, e.g. doctors, the NHS, and Health Secretary Matt Hancock. Their actions were no different to those that were seen in Milgram's experiment with the subject obeying the professor.

The hierarchical nature of society with unquestioning attitudes is how mass tyrannies are created. The response to the alleged pandemic wasn't a random process, but was carefully planned and staged to reach an end goal of total control of minds



through fear-based programming.

Those who were in the agentic state shirk the active part that they played in causing the covid ruse to reach its devastating consequences. Those shirkers include many doctors and nurses who went against their Hippocratic oath and blindly listened to instructions from above.

They put an end to many innocent lives of the elderly by injecting them with midazolam, and placed them on

resuscitation machines which sped up their demise. They were no different to the subject obeying the professor in Milgram's experiment, knowing full well the harm they were causing.

Many mainstream journalists were also a major cog in the psyop. If it wasn't for their blatant fearmongering and over-inflation of numbers diagnosed, there wouldn't have been such a widespread panic that created this mass agentic shift.

Make the government accountable for its expenditure

We could raise standards in our schools and make educational establishments less stressful places. We could reinvigorate our town centre and make it a really attractive place for shopping and entertainment.

I had a dream. I was in London and suddenly found that I had just been elected to parliament. Oops. I was reorganising my commuting timetable between London and Halifax. I might not be able to do all the things I'd promised, but never mind; it's someone else's fault.

Well, yes, without significant funding from the government, we'd have to cut back. More government money could be forthcoming via the West Yorkshire mayor. The regional mayors are becoming regional dictators, taking power from the local councils. But never mind; that's someone else we could blame, too.

Imagine a company registered with Companies House holding an Annual General Meeting. Could they get away with what the government gets away with in running the country? The nearest thing they have to an AGM is Budget Day. Imagine a company AGM where just a budget is presented, with no annual statement of accounts.

Imagine a company whose annual report is like the King's Speech, outlining what they will do, but not accounting for what they have done. Where does the money go? Amending our unencoded constitution to make it compulsory for the government to present an annual report and set of accounts every year would go a long way to giving us some answers.

The rich are getting richer, and the poor are getting poorer. The powerful are getting more powerful and the powerless are becoming more powerless. The government should be made accountable to the people under company law.

Two of the main reasons for government expenditure are interest on loans and war. War is good for bankers because it usually results in more loans to governments, and therefore more interest payouts to the banks. The economy works on debt.

Perhaps more people would come to believe this if it were written as a fairy story for children. Central banks have the power to create money out of nothing - just by pressing the right buttons on some computer - and then loan that money to governments. That puts governments into debt that they can never pay off without incurring more debt to run the country.

It is said that there is now more debt in the world than can possibly be paid off. Something has to give. Perhaps there will be war with Russia or China. Perhaps there will just be a financial crash.

So who has the power to change things? If I were your MP, looking for excuses of course, I'd have to say: "Sorry, that's above my pay grade."

Wars come under the royal prerogative. International treaties come under the royal prerogative (though there was some modification of that recently). Will the Pandemic Treaty of the World Health Organisation be debated and voted on in the chamber of the House of Commons? That was debated recently in parliament, and the government was evasive. The advantage of the UK's unencoded

constitution is its flexibility. That's what we were told in the ruling by the Supreme Court in the case against Boris Johnson on the prorogation of Parliament.

It's not flexible for me and the hoi polloi; it's flexible for the Supreme Court. What message does that convey other than, 'we can decide what the hell we want to, and you lot can't do a thing about it.'

So, if we want better local services in Halifax, the way to start is by electing an MP who will effectively campaign for the abolition of the royal prerogative, at least in the case of military action abroad, and ratification of international treaties.

But that's not enough. No one should have the right to create money out of nothing and loan it to governments. The public should not be paying taxes in order to pay off such debt. If more money needs to be created, it should be interest-free, and that would mean creation of money by the government.

But to get there we need firstly to implement company law in government, with the MPs deemed to be not-for-profit shareholders. That would give us a much clearer idea of where our money is really going. There should also be a clear declaration by us, the people, that we will not be bound by any legislation brought in under the royal prerogative.

That is why I am sitting for parliament for Halifax in the forthcoming General Election.

Mainstream education designed to indoctrinate

Social credit starts at school with rewards for compliance and removal of freedom for any defiance

IN April, *The Times* published an article titled *Exposed: the 'illegal school' teaching children conspiracy theories*.

Below, we look to highlight the paranoid delusions and smear tactics that the article deploys. We ask what could have motivated this hit-piece on Manchester's Universallkidz alternative school?

And we ask: what is making an increasing number of parents take their children out of school or keep them away from school altogether?

We have spoken to parents who have recently removed their children from one of the thousands of state teaching centres across the land, and what we have heard is deeply disturbing.

An elder of the freedom community told us: "Frankly, it's shocking that these indoctrination centres masquerading as schools have been operating with impunity for so long and poisoning the minds of young people.

"In the future, local communities will ensure that families are free to introduce their children to the world as they wish, free of registers, state surveillance and mind control."

It's clear that the responsible modern parent is looking for more humane, compassionate options.

Universallkidz is just the kind of group that offers such compassion. Authentic educators getting to know the children in their charge, building a relationship of trust that motivates children to volunteer to learn more, and to self-educate.

Coercive schooling is toxic and is guaranteed to switch children off, if not destroy them.

It's also a fast-track to enslavement. In the UK, anyone making someone do something against their will is committing the crime of 'exploitation', an offence under the Modern Slavery Act 2015 as defined in s3(5).

Shocking as this sounds, most state teachers, most of the time, are routinely breaking the law. They are also in contravention of international law when they humiliate or bully a pupil into compliance or submission. The UN Convention on the Rights of the Child 1989 Article 28 says that 'treatment of children in schools should respect human dignity.'

Should this schooling criminality and unlawfulness surprise us? Not if we know history.

Modern schooling was never meant to be child-centred or friendly. It came from a nineteenth-century Prussian model aimed at generating compliant, obedient citizens to send to war, who wouldn't question what they were doing or why. But in recent years, it has clearly deteriorated to what is tantamount to a different type of crime against humanity. A pupil is a prison inmate in an enclosed bootcamp, being trained to join and fit into a mindless workforce.

Inside the school fencing, children seen as rebellious or uncooperative find themselves labelled with a psychiatric disorder, like Oppositional Defiant Disorder or ADHD. A litany of toxic, brain-altering psychoactive drugs are then ready to be administered in order to control 'miscreant' children and ensure they are kept in line and compliant – ensuring that any children who do display dissent against, or defiance of, the system are rendered lifelong slaves to, and victims of, pharmaceutical bio-medicine. A child simply being a child is now a medical issue.

As if this weren't bad enough, children are ripped out of a familiar home environment at an age (four, five or six) when they are too young to understand why. How can they be sure that they will see their parents again?

This can, and often does, mark them for life. This is the foundation trauma that, allied to the whole schooling process, has been termed 'menticide', or the killing of the human spirit. The outcome: delinquency, depression, addiction and violence, referred to as 'the cycle of co-dependence' in the book *School – No Place for Children*.

The system needs broken individuals for corporate profit and social control.

Even worse, over 90 per cent of pupils now use biometric technology to gain access to the school itself, or to facilities inside. Artificial intelligence is taking over. Acceptance of electronic control and surveillance, with minimal to zero human input, is being normalised.

Social credit also starts at school, with rewards for compliance and removal of privileges or freedom for any defiance.

Permission is routinely needed to go to the toilet. Some toilets are even fenced off! Children are developing urinary tract infections due to dehydration. A teaching assistant recently revealed that one in six children at his school is off sick at any one time.

One million children nationally are believed to have clinical depression, anxiety, or other mental health issues. The system itself generates its most rapidly growing industry – children's mental health.

And what is not available in the classroom? Key life and survival skills, exercise, fun and engagement with others. Talking to your classmates is penalised, classed as disruption, and mercilessly stamped out. Any wonder that many adults end up with socialisation and personal confidence issues?

The teacher is morphing into a machine, with children commonly sitting around a screen. Into a sterile, loveless environment, the system introduces sex and relationship education for pre-teens, and even tiny tots, that's essentially sexual exploitation. The lunatics have well and truly taken over the asylum.

Doesn't the article in *The Times* make it an accessory-after-the-fact of criminality? We don't question the author's right to a private opinion. But when, fraudulently, in breach of trust and in trespass, he gains access to a private group, profiting from that breach, defaming the good name and work of a collective fashioning a vital educational remedy, is he perhaps not only losing all credibility and covering himself in shame, but even risking prosecution for fraud and defamation?

Our wise elder told us that, after reading our report: "Parents with no choice but to send their children to these centres should henceforth be challenging their practices and ideologies at every available opportunity – and removing their children from them whenever they can."

Modern-day tale of David and Goliath

Political leaders on left and right supporting Israel

IN the 1960s, mass demonstrations were held at American universities against the war in Vietnam.

Officially, both major political parties supported the futile intervention, but for the Democrat administration, this was a particularly contentious policy.

How could politicians who claim to stand for civil liberties and a fairer world send so many young men to their deaths while slashing and burning a poor, feudal land far away?

Society turned against the war, and the protestors could take credit for their righteous resistance.

Supporters of the upstart David would be portrayed as far-right extremists bent on division and disorder.

At Socoh, the massed ranks of the Philistine army stood ready. Their leader Goliath issued twice-daily challenges to the Israelites for single combat. Understandably, nobody volunteered to fight the ten-foot giant heavily armoured in bronze, with his huge spear tipped in the finest iron.

And so David stepped forward, convinced that right would prevail against might.

Wearing his shepherd's tunic, and bearing a sling with five pebbles, he faced the colossus. Bemused, Goliath strode towards his prey. But he was struck in the forehead by a well-aimed stone, and tumbled to the earth, where David finished him off.

Such an amazing feat by an underdog would be less celebrated today. After decades of indoctrination, governments are in control of the narrative, with the majority of citizens meekly believing

whatever they are told to believe: ‘Israel good, Palestine bad.’

But as shown by a series of huge rallies in London, a growing number of people see through the lies of MPs and mainstream media presenters.

Freedom is a state of mind

Without critical thinking we become nothing but slaves

FREEDOM. What a supercharged word that is. What does it mean? How do we define it? What are its limitations?

How do we square individual freedoms with responsibilities to any given society and community in which we live? Everyone shouts to the rooftops that they want to be free, but do people have any idea what this means?

Philosophers and thinkers throughout history have put freedom as one of the mainstays of any given desired system of living together.

But how do we equate freedom with, for instance, corporatism, whereby wealth is desired at the expense and exploitation of others? Or socialism, where ambition and motivation are sapped due to restrictions imposed to serve the state?

The irony is that whatever political system one lives under, individual freedom is always challenged. The only difference being the degree to which it actually constrains our lives.

The covid years showed that even in so-called enlightened countries, the very act of choosing how to live can be severely curtailed and restricted at the whim of the state and its agents.

If the government of the day makes a decision for whatever reason, and they frighten people enough, not by the threat of the gulag, but by an allegedly deadly virus or a fictitious climate emergency, people can be controlled and manipulated, and to all intents and purposes lose their freedom.

It seems to me that the biggest threat to an individual's freedom, in whatever system one lives under, is brought about by fear – fear of repercussions if you don't conform to the diktats of the state.

How can we still be free in a state of living which restricts our travel, prevents us from receiving adequate health care, and forces some to have their bodily autonomy compromised at the risk of losing their livelihood?

Can we ever be free, as individuals, in a war-torn world where we are confronted daily by propaganda and a post-truth legacy media?

Just what constitutes freedom, and how can we, as individuals, attain it in our short lifespan? Moreover, psychopaths, lacking in feeling and compassion, exist

among us and are adept at rising to positions of power and authority through their single-minded, cold-hearted determination to exert control and influence over the rest of us for their own selfish and nefarious ends.

Freedom, then, is something we kid ourselves into thinking we have, when we have nothing of the sort. Or do we? Is it possible to be truly free, and, more to the point, does everyone want this state? Yes and no would be my answers to these two questions. We can get an idea of how others in the past have addressed this dilemma, and their experience can teach us a lot.

Take, for instance, Viktor Frankl and his experience of being a Jewish prisoner in a series of German concentration camps. His wonderful memoir, *Man's Search for Meaning*, is a testament to the power of mind over matter, and how true freedom is a factor that has its bedrock

in the spirit.

Frankl's day-to-day existence, with the threat of death hanging over him constantly, only served to consolidate his inner life and the serenity it could bring him.

This inner freedom is something that was addressed in George Orwell's futuristic work, *Nineteen Eighty-Four*, which was set in a dystopian state. Published in 1949, this novel focused not only on physical control of citizens, but more importantly on their powers of thought.

The Party realised that until you controlled the thoughts of individuals, they were still free in the true sense of the word.

With spiritual freedom comes the always present threat, to the governing order, of rebellion.

Erich Fromm (1900-1980) was a German-American social psychologist and

philosopher who wrote at length about freedom. One of his landmark works is *Escape from Freedom*, a brilliant account of how people are conditioned to behave as their society dictates, and, while professing to value freedom, are only too happy to give it up for the right incentives.

He proposes that people are conditioned by the society in which they live to gradually abandon their powers of critical thinking as they rely more and more on the state to control many aspects of their lives.

People 'forget' how to be independent and how to be critical thinkers because it is in their best interests to do so. As this happens, it makes many of them abandon any desire to rebel and increases their tendency to conform.

However, psychopaths apart, people still have a conscience, and deep down they know right from wrong. Throughout their lives, they encounter instances where their actions and attitudes are at loggerheads with their own spiritual freedom. This awareness can be nurtured and encouraged to gradually become a torrent for change in their own lives and collectively for changes in society.

We see this currently more and more. Never has the ruling system of government been viewed in such an appalling light. The sight of the Prime Minister standing in the pouring rain delivering a pathetic speech calling a general election just about sums up the hopeless situation they now find themselves in.

Never have the press and their lackey journalists been so despised. Never have the BBC and corporate media been so roundly condemned. Never have organisations like the NHS, the WEF, the WHO, the United Nations and many more fallen into such disrepute.

People are regaining their freedom because they are allowing their powers of thought to resurface to give them a voice.

Freedom is in the spirit and no one can take that away from us. No matter how hard they try, and even if sometimes we have to conform for expedient reasons, our thoughts can always reinforce the fact that they haven't captured our souls.

And it is in this uplifting and wonderful realisation, just as Viktor Frankl discovered in the concentration camp, that true freedom lies. It lies within us, and we just have to make the choice to never give it up.

Driven to question everything

From engineering to investigative journalism

***The Light* speaks with Richard D Hall about his journey into journalism**

*After taking legal advice, all references to an ongoing court case have been removed from this article and **The Light** offers no opinion on those proceedings.*

YOU have been a well established investigative journalist for over 15 years. What's your story?

It started in the 1990s. As an engineer, I am interested in how things work, and I heard an interview with an American whistleblower called Bob Lazar on a local radio programme. He claimed he'd worked on recovered flying saucers at a secret base in the Nevada desert, and the way he described the physics of the craft fascinated me.

The UFO mystery and alleged secret technology, which may have been gleaned from recovered UFOs, is what first triggered my interest in government cover-ups and opened my eyes to a degree.

Of course, many of the unexplained craft in the sky may well be man-made advanced aerial vehicles whose technology has not yet been disclosed to the public.

I used to read *The Observer* every Sunday, and was a fan of one journalist in particular named John Naughton. Naughton wrote a book in 1999 called *A Brief History of the Future – the Origins of the Internet*. The book describes the history of how the internet came to exist in its present form. Naughton was an advocate of allowing people the right to communicate privately, and was highly critical of the government's 2000 RIPA (Regulation of Investigatory Powers Act).

The Act made it possible for the government to impose a prison sentence if somebody refused to hand over the encryption keys to their private messages, thus allowing the government to decipher their private communications.

It appears now that things are about to get much worse, with further clampdown on the freedom to communicate being proposed in the current Online Safety Bill. I think John Naughton's work taught me a lot about the importance of freedom of information, and also about why the internet would become such an important part of our lives, and now, it seems, an information battlefield.

In 2008, I set up a website, <https://www.richplanet.net>, to publicise my interest in UFOs, and the site initially covered famous UFO incidents and the work of UFO

researchers. I was approached by a new TV channel, Edge Media Television, who had seen the website and asked if I would produce a series of weekly half-hour TV shows to be aired on the Sky and Freesat platforms. I duly obliged.

I met people through Edge Media Television who were talking about 9/11 and other coverups. When I started looking at 9/11, I hadn't questioned the official story up until around 2008 or 9 and didn't realise there were alternatives to the official narrative.

I became aware of the work of Dr Judy Wood and met 9/11 researcher Andrew Johnson for the first time at a conference in 2009. Their investigation into 9/11 was thorough and highly scientific, and in my opinion, their conclusions provide the best explanation about what happened on 9/11, which is presented in the book, *Where Did the Towers Go?* Finding out about 9/11 was the biggest influence on me becoming 'awake'. From 2009, I started producing investigative films covering a range of high-profile subjects and cases that appeared to me to involve high-level cover up or deception. All the films are free to watch on my website.

Are they going to use the tech to sell the Great Reset?

Yes, although not necessarily secret tech.

The technology that they are using to bring about the Great Reset is all standard technologies which are being used to bring in the worldwide technocracy.

CBDC (Central Bank Digital Currency) is slowly being rolled out across the world. If they succeed in implementing CBDC and manage to phase out cash as well, the world will become a very different place.

People should consider the capabilities of CBDC, not the immediate intent, because the intent will change, and the capabilities are so Orwellian it's almost unimaginable what the world would be like.

I recently made a short 15-minute film warning about the possibilities which can be watched on my site. It is imperative that we keep using cash, because having the alternative of cash available, instead of just CBDC, would mean that there is always another choice – a safeguard if you will, that people can use if and when CBDC becomes too restrictive.

What are your criteria for investigating stories?

I usually choose a case where I believe the coverup or lie is at a very high level. I'm more interested in cases where I suspect there is government agency malfeasance, i.e., coverups that go right to the top.

In the mainstream media in general, there are very few stories that are told in a completely factual manner; most stories involve some degree of propaganda.

Propaganda can be true information, it can be false information or manufactured information, but the key thing that makes something propaganda is whether the person receiving the information understands why they are being fed it – if they don't, that makes it propaganda. Cherry-picked stories to push an agenda, even though the information may be true, can be propaganda.

Challenging universal childcare

Richard House interviews *Dr Maria Lyons*

If children's needs were the priority, everything would be directed towards encouraging stable families and strong communities

Richard House [RH]: Maria, your Civitas report on universal childcare (UC) benefit courageously takes on what's typically an unquestioned shibboleth of modern culture. How did you come to question UC?

Maria Lyons [ML]: It didn't start out for me as a question about childcare. For me, the beginning was mothering. Growing up, I always took for granted that when I had children I would be there to look after them.

Fortunately, when I did have children, my decision to embrace full-time mothering was accepted and supported by everyone around me. The question of childcare only came into my focus because it is being so relentlessly promoted across society.

Mothers are under so much pressure to separate from their babies almost as soon as they've given birth. One of the most obvious pressures is coming from government. What really spurred me to investigate childcare in detail was the announcement that the state is going to provide a free childcare place for 30 hours a week for all children over nine months old.

The issue here isn't the availability of professional childcare for those families who want or need it. Rather, it's that parents are being strongly incentivised to 'choose' childcare, and they're being told that this will be good for their children – indeed, that it will be good for all children. Can you imagine a more sweeping generalisation?

So I suppose on some level, I've always instinctively known that there are major problems with the childcare narrative. But it only became absolutely clear to me when our politicians started to insist so vociferously that removing children from the care of their mothers when they're still babies and placing them in group care for most of the week will give them 'the best start in life'. That really sent alarm bells ringing.

RH: The assumption that early childcare will be 'good for all children' flies in the face of so much research evidence. So is there a political agenda operating here, with the needs of the economy taking precedence over young children's needs? Or perhaps an even more nefarious agenda, e.g. a deliberate attack

on family life?

ML: There are so many layers to that question, and the so-called 'needs of the economy' are only one part of it. If children's needs were the priority, everything would be directed towards encouraging stable families and strong communities.

Relationships are the foundation of healthy development, and nurturing them requires not merely physical presence but plenty of time and space. Small children need consistent, loving care, initially from one primary attachment figure.

Ensuring that mothers can remain at home with their babies for as long as possible during the crucial bonding period, with minimal stress and proper support, would give children the best start in life. Policies would then be focused on longer maternity leave, a gradual rather than sudden transition into formal childcare as children get older, a tax/benefits system recognising the family and caring responsibilities, affordable housing, etc.

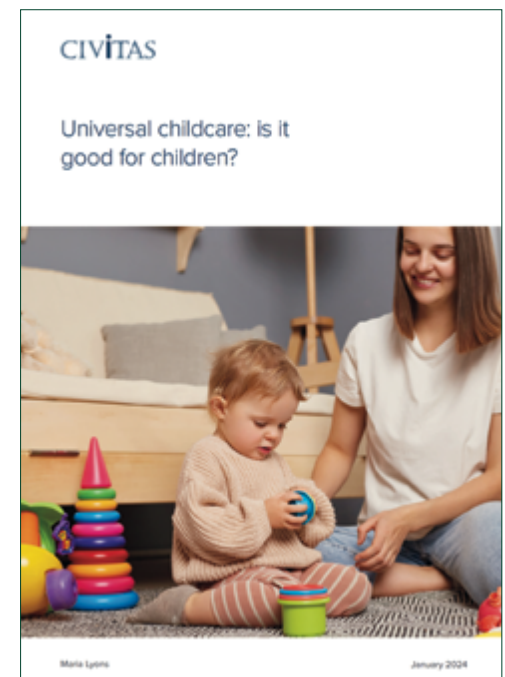
Yet, everything on the political agenda is moving in exactly the opposite direction. Policies are making it ever harder for children to thrive. The needs of children most certainly aren't the primary concern.

The so-called feminist or progressive ideology has completely captured our political and media establishments. In this ideology, women can only achieve equality through employment, and children are at best an inconvenience – or even seen as a barrier to overcome, a burden needing removal so women can become empowered (see, for example, Chancellor Jeremy Hunt's Spring 2023 Budget).

Recent moves by governments, councils and various organisations to erase the word 'mother' from their policy documents is hugely symbolic of this general disregard for the basic need of children to be loved and nurtured.

Over the long term, this hardly serves the economy; and in the short term, the soundness of free universal childcare as an economic investment must be questioned. So yes, there is something else going on.

RH: The forces ranged against healthy family-centred early development are certainly formidable, Maria. Based on your research and experience as a mother, what

can concerned parents do?

ML: There are two main obstacles facing mothers who wish to raise their own children: money and culture. The financial pressure to work is really a top-down issue which, as individuals, we can do little about, beyond political activism.

But cultural and social pressure can be resisted. Parents are essentially being subjected to a psyop designed to influence their behaviour. They are repeatedly told that professional childcare benefits all children, when in fact there is no evidence to support this claim.

What we can do is trust our own instincts, have faith in our own judgement, and strive to live in accordance with our own values. This is what being empowered really means. To parents, my main message would be this: move heaven and earth if you must, but spend more time with your children!

How I pictured the end of the world

IN February 2023, I thought it would be a good idea to create my own stage show, based around my cartoons from the last few years.

I came up with a title, Art-Pocalypse, and a subtitle, How I Pictured The End Of The World, and then realised I had no idea what to do next. I was going to need some help.

I'd met the brilliant stand-up comedian, Tania Edwards, a couple of times. I also knew she was a talented writer, and had worked on scripts for stage and television. Fortunately for me and everyone else, she agreed to collaborate.

We spent last summer writing the script and building the show. Our aim was to give people more than just a presentation. We wanted to make it accessible for everyone, whether they had complied with the machine or raged against it. A properly entertaining evening out, presenting an illustrated alternative to the official narrative, while explaining the mechanics of the news cycle.

It was difficult to find a venue that would meet us, let alone host us. Eventually, we got a positive response from The Bloomsbury

Theatre. I suspected they hadn't checked who I was. My suspicions were confirmed when I sent them my poster design, and received back a panicking email asking why there were masks in the image.

We were summoned to a meeting at the theatre. After stressing several times how much they supported free speech, getting sweatier with each assertion, they told me I couldn't feature any of my cartoons about the 'trans community' in the performance. As it happened, I never planned to, but I didn't mention that. The point of the show, I explained, was that nobody could tell me what I can or can't draw anymore. They informed me that the show could be cancelled at any point, even during the performance, if anyone felt offended.

I did my best to ignore their nonsense. It's challenging to attempt something you've never done before, in a venue that doesn't like you, with the possibility that it could be shut down at any moment if a barman/barthelme is upset by a drawing.

To the Bloomsbury's credit, they allowed the two shows to go ahead last November. The auditorium was packed and the atmosphere was electric. Many people had brought along

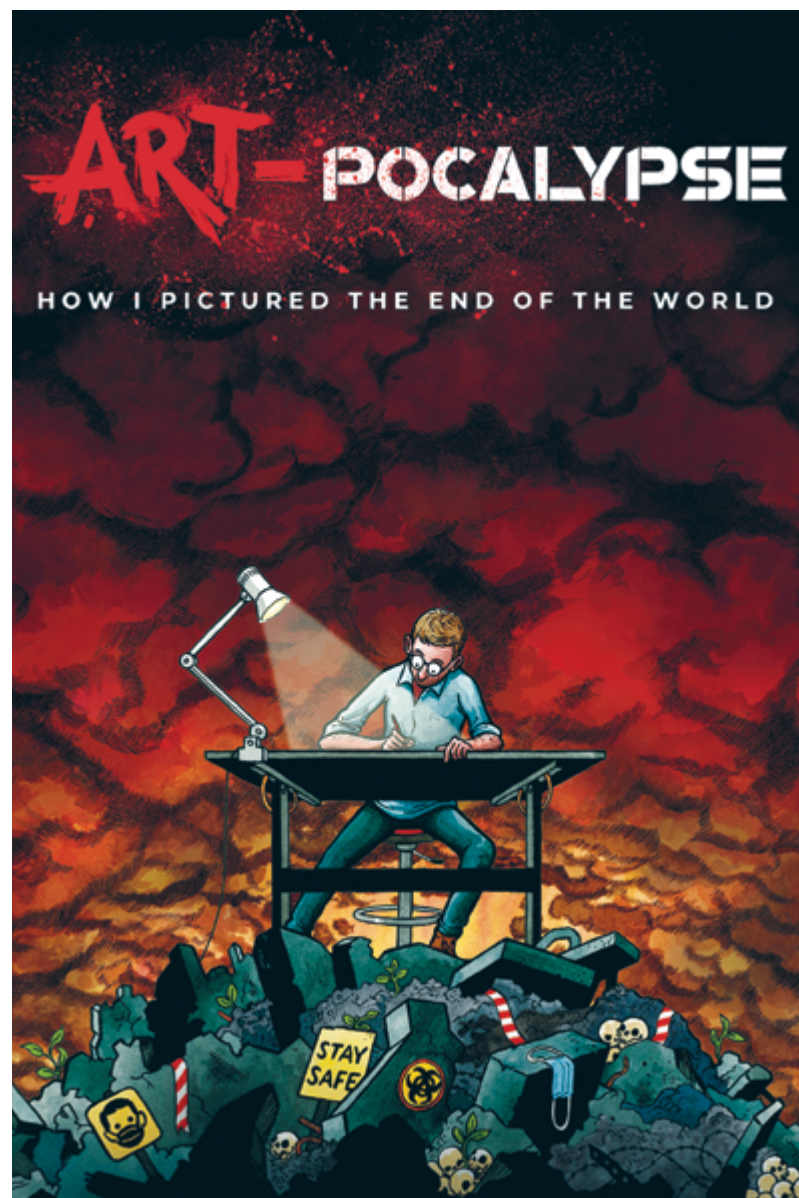
friends who were not 'on side'. Nobody complained. Lots of the uninitiated told me afterwards that they finally understood where we were all coming from.

I was optimistic about taking Art-Pocalypse on tour, and signed a contract with the Tyne Opera House in Newcastle to perform the show in January. Four days after tickets went on sale, they cancelled without warning or explanation. It became clear that the UK theatre industry didn't want to host shows about critical thinking and moral principles.

Having ruled out a circus tent in a field, a disused prison and a strip club, we found Dingwalls, a music venue in London. We did the show there in March. It was an amazing night, and great to bring some authentically anti-establishment energy back to Camden. A few weeks later, we booked The Savoy Cinema in Stockport, but they also cancelled without explanation.

It seems that the powers-that-be do not want this show performed live. We have now released the recording of Art-Pocalypse at Dingwalls online, so that everyone can see what all the fuss was about.

‘You really shouldn’t be here’

The Light interviews **Alex Mitchell** – vaccine damage victim and campaigner

ALEX Mitchell is believed to be the first person in the UK to have received compensation for adverse effects from a covid jab through the Vaccine Damage Payment Scheme.

This was after losing his left leg as a result of an AstraZeneca shot in March 2021.

He is now part of a group of 51 people who are legally challenging the pharmaceutical company for vaccine damage and deaths caused by the jabs. Here he talks about his experiences over the last three years.

My life since March 2021

It has been a time of re-evaluating everything I knew. At the age of 56, I was the most content and happy man in the world, but they took everything from me. Nothing is ever going to give me my leg or my health back, so what I am doing now is about injustice and the fact that they think it is okay to abandon us.

I aim to do three things: to get help and support for those like me; to stop these things, because there is clearly a problem with them; and, above all, the children. If you are a parent, I want to tell you that, scientifically and medically, your child already has a 99.7 per cent probability of not having a problem with this disease.

The job

The health secretary, Matt Hancock, had said at the time that the AstraZeneca jab was 100 per cent safe and effective. Did I know anything at that point? No. The nearest I got to conspiracy theories was YouTube, watching UFO programmes.

On March 20 2021, I got my first and only vaccine. I was told that I might experience slight pain in my arm and flu-like symptoms. I went to work on the Monday and was fine. On April 1, I lifted a heavy loading frame, stepped back, and I thought I had pulled both my calf muscles. I struggled on for a couple of days. Then, on Sunday April 4, I just collapsed. I had to pull myself headfirst, backwards, down the stairs, because my legs wouldn’t work. I told my wife to phone an ambulance. I don’t remember too much after that.

I came-to in the hospital with a nurse in front of me. She took me for a CT scan then straight to the operating theatre. I remember saying to her: “I take it I am in trouble?” and she said: “the worst kind.” I phoned my wife and two daughters and basically said goodbye to them. I spent seven-and-a-half hours in surgery having multiple clots removed from both legs. Back on the ward, I opened my eyes and the same nurse said: “you really shouldn’t be here.” My left leg was still a big concern and they had to amputate. Eight days later, I left hospital, with my discharge notes citing ‘thrombopenia and thrombosis’ – eventually reclassified as ‘vaccine-induced thrombopenia’.

I am the first person to survive at this level of damage. I am also the first living person to benefit from the UK Government’s Vaccine Damage Claim Scheme (VDCS).

The claim

The claim process is the most horrific experience ever. The DWP were running it at the time. After receiving my application, they told me they had to prove two things: 1)

that it was most likely to have been caused by the vaccine, and 2) that I was likely to be over 60 per cent disabled because of it. I thought: ‘That’s me in both cases’. They also told me that, because the vaccine was based on new technologies, it may take some time to investigate.

I waited six weeks, then phoned every week for about four months. My MSP Claire Houghey wrote two letters to the DWP – both ignored. They then sent a letter saying they were transferring the case to the NHS Businesses Authority. I phoned again on December 28 2021, and was told that my medical records had been sent for. When I contacted them in late February, I was told: ‘we are just sending for your medical records’. I then called them out on Twitter, and tagged them in. They eventually got in touch, and I was asked a series of questions that were neither pertinent nor appropriate. I wrote a complaint to the chief executive of the NHS Business Authority, Michael Brody. The response I got, for the request for a full timeline review of my claim, was embarrassing. He lied that they had contacted me to give them an update – something that only happened after I had called them out on social media.

I was eventually awarded the claim – on June 22 2022, and have spent most of my time since lobbying for change; 98.3 per cent of claims are rejected. Only 1.7 per cent have ever been upheld. There have been a total of over 9,500 claims made. Other than state benefits, there is no support for those disabled by the jabs.

AstraZeneca

In the last 20 years alone, AstraZeneca has been charged in connection with 32 company acts, and fined \$1.5 billion for different contraventions. It is incredible how they are allowed to influence anything to do with healthcare.

I was interviewed on Indian TV today and I found out that

they have administered 1.7 billion doses of AstraZeneca over there. Half the population. I was told they are having a massive problem because their government won’t talk about it.

Every day I look down and that’s missing. It reminds me of injustice. We can go back to Thalidomide and see that these companies have been putting out products that have been harming ordinary people for a long time.

Speaking out

I don’t blame the public; most are just going with what they have been told. If they see papers like *Rolling Stone* [Alex was on the front cover in January 2023] labelling me as an antivaxxer, then that gives them free game. You wouldn’t believe some of the things that have been said to me: ‘you should have died’; ‘we wish you had have died’; ‘why don’t you just go and die’; ‘you should have lost both legs’; ‘could you not have lost your tongue?’ I have been called a grifter. I am still trying to get my head around that one. A crisis actor – I was also called that once.

I am not here for your pity. You don’t know how strong you are until that is all you’ve got. The reality is this could have happened to anyone. My trust in 99 per cent of the medical profession is gone. The last time I trusted people in the medical profession, it didn’t go so well for me.

Judgement

I say to people, move beyond asking people, ‘who got it and why?’ It doesn’t matter. I have had negativity from the anti-vaxxers because I took the vax, and negativity from the pro-vaxxers because I am speaking out. Meanwhile, these politicians are still saying: ‘this is safe and effective’. The only judgement I want to hear is against the perpetrators of all this.

Stop the climate swindle!

One world governance is prime motive for fake narrative

THIS article highlights the fact that the amount of man-made CO₂ in the atmosphere is severely limited. We also point to simple observations that show how small the blocking effect of CO₂ actually is.

Why man-made emissions make no difference

Each year, we burn coal, gas and oil that all contribute to the total CO₂ in the atmosphere.

A simple-minded conclusion might be that in 100 years, humans could double the amount of CO₂ in the atmosphere. But, however, there is a catch.

Studies show that, during each year, about one-fifth of the CO₂ in the atmosphere is exchanged with the oceans, plants and other sources.

This exchange will include any man-made CO₂ that is present in the atmosphere. In other words, the man-made component of CO₂ in the atmosphere becomes less significant when the exchange takes place.

The assumption is that all man-made CO₂ goes straight into the atmosphere and stays there. However, we release most of our CO₂ close to the surface of the Earth, where plants and the oceans will immediately absorb some of it, leaving even less to mix with the air.

Measurements by Kenneth Skrable, George Chabot and Clayton French (2022) found that just 12 per cent of atmospheric CO₂ was man-made.

And because of the CO₂ exchange between atmosphere and oceans, it is unlikely that this figure will change significantly in the short term, because the oceans can hold about 50 times more CO₂ than the atmosphere.

The increased concentration of CO₂ in the atmosphere is caused primarily by the warming of the oceans.

Suggestions that man-made emissions might directly cause a doubling of atmospheric CO₂ are a physical impossibility and so have zero credibility.

The climate scam is scheduled to cost 5 per cent of GDP (about £15bn) – your taxes for years to come – and includes severe restrictions and controls to be placed on the population.

Remember, the controls are only for you and I, not for the super-grifters and their organisations ranging from the World Economic Forum to local councils – all

of whom are working to run the western world into oblivion, with the intention for it to be resurrected as a totalitarian hell for most of us and debauched luxury for the few.

We are in an existential war for the future of humanity. We have not voted for what is happening in schools and wider society.

The tyranny of the minority is being implemented and upheld in this country by vaguely-worded parliamentary legislation voted into law by complicit or uncomprehending parliamentarians, who have abandoned their commitment to their oath of office and to serve the public's best interests.

Co₂: A very thin blanket

An example of how small the blanketing effect of carbon dioxide actually is can be observed in deserts.

Such areas often have periods of extremely low humidity with almost no water vapour present above them.

On these occasions, temperatures can be very warm in the daytime, but fall very rapidly to well below zero at night.

This happens because carbon dioxide, together with other trace gases, cannot block the loss of heat from the ground over their narrow wavelength ranges.

When humidity is higher, the nights in such places are much warmer, because water vapour blocks the loss of heat over a much wider range of wavelengths.

In the UK, for the same reason, clear skies at night in winter often signal frost.

Yet the meagre blanketing effect of the less than 5 per cent contribution of atmospheric man-made carbon dioxide is cited as THE cause of climate change/global warming, and is driving the most far-reaching and eye-watering expenditures on an international scale.

The only benefit is to those who already have an abundance of wealth, whereas the burden of complying with, and paying for, the destructive programmes is placed on those who can least afford to fund them.

These programmes are fraudulent, aimed at destroying societies, impoverishing populations worldwide and eventually consolidating everything into a worldwide, digital, totalitarian system of government.

Consequences

The Climate Scam is going to cost at least \$150 billion – this money does not just disappear; it ends up in the bank accounts of those who can afford to invest in those industries prospering from the edicts dreamed up to mitigate the fictitious climate crisis.

The controls are only for the little people, not for the super-rich and their hangers-on from the WEF, WHO, UN, EU, The City of London, the Universities and even officials in your local town hall, all of whom are working to run the western world into oblivion, most with little understanding of the destruction that they are blindly and dutifully helping to inflict upon us.

Assassination attempt on leader critical of covid shots

Investigators looking at possibilities other than 'lone wolf' gunman theory

QUESTIONS are being asked around the assassination attempt on Slovakia's Prime Minister, who had vowed to carry out a probe into covid vaccines and excess deaths.

Initial reports suggested a 'lone wolf' was responsible for the multiple shooting of Robert Fico, 59, in what is thought to be the first attempted killing of a European political leader for more than 20 years. However, *Sky News* reported later that officials in Slovakia were investigating whether the attacker who shot Fico was not acting alone.

The incident has echoes of the sudden

deaths of two political leaders in Africa who were dismissive of World Health Organisation covid protocols.

The death of John Magufuli, 61, the president of Tanzania, was announced in March, 2021. It was reported that Magufuli, who revealed how a pawpaw fruit and a goat tested positive for covid, died from a heart condition.

Burundi's president Pierre Nkurunziza, 55, who refused to impose covid restrictions in

his country, was also reported to have died 'unexpectedly' in June, 2020.

Fico, who survived the attempt on his life but remains in a serious condition, recently delivered a powerful speech in the Slovakian parliament that was reported by *The Light* in March.

He announced an investigation into the country's handling of the covid pandemic, explicitly linking the excess death toll of 21,000 to government mismanagement and the influence of pharmaceutical companies.

He said: "We have 21,000 deaths, which we connect with the fact that the governments since 2020 were not capable of managing the pandemic and cared only about economic gains and bowing to pharmaceutical companies."

In his address, Fico criticised the previous administration's purchasing of vast amounts of what he termed 'useless medical equipment' and vaccines without proper trials. He questioned the transparency and ethics behind these

decisions, pointing to the 'secret' dealings between European Commission President Ursula von der Leyen and Pfizer CEO Albert Bourla.

Fico's remarks highlighted the opaque nature of the largest vaccine purchase in European history, demanding accountability and clarity on these transactions.

He vowed that his government would thoroughly investigate these issues, aiming to provide the Slovak public with answers regarding the injections' efficacy, the extent of state-wide testing, and the financial implications of these decisions.

Fico was shot multiple times while greeting supporters in the small town of Handlova, Slovakia, on May 15.

As well as asking uncomfortable questions about the covid injections, Fico had also ended official military support for Ukraine.

Step towards legalising assisted suicide

THE Oireachtas (Irish parliament) Joint Committee on Assisted Dying in Ireland has issued a controversial final report recommending the legalisation of assisted suicide in health conditions that are 'advanced, incurable, irreversible, and progressive'.

On March 20, the same day Leo Varadkar resigned as Taoiseach (Irish Prime Minister), the Joint Committee on Assisted Dying in Ireland outlined 38 recommendations for assisted suicide in a detailed report after hearing from experts and speakers since January 2023.

Recommendation One from the report states: 'The Committee recommends that the Government introduces legislation allowing for assisted dying, in certain restricted circumstances as set out in the recommendations in this report.'

The committee recommends that assisted suicide would 'primarily apply to a person diagnosed, with an illness or medical condition that is incurable, irreversible, progressive, and advanced and will cause death within six months.' The proposed legislation says a time limit of twelve months would be set for those with

neurodegenerative conditions.

On March 6, committee members voted nine to three in favor of making it a statutory right to assist a person to end their life. One member abstained from the vote, and another was not present during voting.

Committee members Senator Ronan Mullen, Deputy Robert Troy, and Deputy Michael Healy-Rae (chairman of the joint committee) voted against the legislation of assisted suicide. They have issued a minority report outlining their concerns about assisted suicide with a strong emphasis on funding palliative care services instead.

In October 2020, People Before Profit legislator and committee member, Gino Kenny, tabled the Dying with Dignity Bill to the Oireachtas. The aim of the bill is to allow the option for assisted dying at the end of life for people suffering from a terminal illness.

On Jan 24, 2023, a special parliamentary committee was set up to discuss the legal, medical, and ethical issues of assisted suicide, as well as the practicalities of introducing such a law in Ireland.

The Joint Committee's work over the past year included an exploration of how provision for assisted dying might operate in Ireland; an examination of safeguards

relating to the provision for assisted dying; an examination of the constitutional, legal and ethical issues relating to such a provision; and identification of possible unintended consequences of such a provision.

The 14 committee members heard from a broad range of professionals, medical experts, groups, and individuals from Ireland and abroad advocating for and against assisted suicide during the special parliamentary meetings held in Dublin. Last Autumn, the Irish Catholic Bishop's Conference released a statement entitled, *Care at the End of Life*.

They appealed to legislators to 'respect the integrity of healthcare as a service to life from conception to natural death.'

The bishops warned that 'assisted suicide is often presented as something that would be rare and exceptional. Once assisted suicide is accepted in principle, it becomes very difficult to draw a line.'

They concluded by asking people to 'join us in prayer for those who, at this time, are coming to terms with a diagnosis of terminal illness, that they may have the blessing of a community of compassion and care.'

Psychiatrists, palliative care consultants,

and international experts on assisted suicide also strongly advised the committee not to legalise the introduction of assisted suicide in Ireland.

Galway Senator Ronan Mullen observed: "What was most striking at the hearings was the consistent international testimony of how euthanasia and assisted dying regimes can, and do, freewheel out of control."

Despite the alarming key evidence from experts during the hearings that assisted suicide is morally, ethically, medically, and legally wrong, most of the committee, which included numerous far-left leaning politicians and groups advocating for assisted suicide, predictably ignored the evidence provided.

The Irish government will now scrutinise and debate the proposed legislation. To become law, the legislation will need to be approved in both Houses of the Oireachtas (Dáil Éireann and Seanad Éireann) before the next general election, otherwise it will not pass through the legislative process.

Zionism's political influence

Israel lobbyists 'can elect or defeat nearly any congressman'

THE Zionist takeover of the Anglo-American political process is a vast and far-reaching story of corruption.

It has wrought havoc in the Middle East for over 100 years, and is accelerating its destruction of democracy in the West. The takeover has always operated in the shadows through secret channels, protected from public gaze by carefully crafted media propaganda.

But it has been forced into the open, where it is unfamiliar, and losing control.

The people of Palestine, at great cost, are sparking this great awakening in the populations of the western world.

In response to greater public awareness, the denigration of citizens by politicians has reached fever pitch. The list of names attributed to the thoughtful grows wider by the day. The label 'anti-vaxxer' has given way to cries of 'right-wing extremists', 'anti-semitic mobsters', 'terrorist sympathisers', 'violent protesters', to describe anyone with a conscience. Yet these attacks sound ever more hollow, and those hurling them from their seats in Parliament and Congress look like caricatures.

For over a century, the Palestinians have been dispossessed, displaced and disenfranchised. Following the first Zionist Congress in Switzerland in 1897, the Zionists began a vigorous campaign to colonise Palestine, which they had chosen for their proposed Jewish state, notwithstanding that 96 per cent of the indigenous population were Muslims and Christians, who owned 99 per cent of the land.

The Balfour Declaration of 1917, engineered by prominent Zionists on both sides of the Atlantic, was devised to lend a veneer of legitimacy to the Zionist imperialist project.

However, to give this much relied-upon letter its true perspective, it was merely

a political statement made by the British Foreign Secretary to a prominent private individual, Lord Rothschild, stating that Britain would 'view with favour the establishment in Palestine of a national home for the Jewish people,' and 'use their best endeavours to facilitate the achievement of this objective.'

International law experts argue, therefore, that it is of dubious legal standing as a commitment binding on the UK, and at the time it was issued, Britain had no authority over the territory in question, which was under the Ottoman Empire.

During WWII, U.S. State Department officials and English diplomats grew increasingly concerned about Zionist activities, and in July 1943 were preparing to issue a counter Balfour Declaration. Powerful Zionists took emergency action to block the declaration through secret back channels to officials in Washington, which had by then been well established in the last years of Franklin D Roosevelt's presidency, and the critical first years of Harry Truman, after Roosevelt's death in 1945.

In 1947, Britain relinquished its troubled mandate over Palestine and handed over the latter's fate to the newly-formed United Nations. Fair, democratic elections through which the inhabitants could create their own independent country should have followed.

But this was not the Zionist plan. Instead, they pushed for a General Assembly resolution to give them a disproportionate 55 per cent of Palestine and, while not publicly declared, stated in journal entries and letters that their plan was to take the rest of the country.

U.S. officials were adamantly opposed to this partition plan. They wrote that the U.S. would lose moral standing in the world if it supported Zionism, believing it to be contrary to both fundamental American principles and U.S. interests. They further warned that partition 'would guarantee that the Palestine problem would be permanent and still more complicated in future.'

President Truman ignored his experienced advisors in the Middle East State Department and bent to Zionist pressure. His Secretary of State, George Marshall, author of the Marshall Plan, was incensed, condemning what he described as 'a transparent dodge to win a few votes' which would greatly diminish the office of President.

However, despite U.S. backing, the partition plan did not have majority support in the UN General Assembly. Zionists applied their habitual tactics of pressure to each delegation which opposed it.

They threatened France with the loss of U.S. post-war aid, they told the Latin American delegates that the Pan-American highway project might be in jeopardy if they failed to vote in favour. Delegates' wives were sent mink coats.

The following year, in the 1948 U.S. presidential elections, wealthy businessman Abraham Feinberg and the Zionist lobby played a critical role in financing Truman's campaign, which enabled him to come from behind to defeat his rival, Thomas Dewey, unexpectedly.

Feinberg was to play a similar role with Lyndon Johnson, John F. Kennedy's vice-president. Johnson won the presidential

election of 1964 in a landslide victory, the year following Kennedy's assassination.

In January of 1963 the American Israel Public Affairs Committee (AIPAC) was formed. And in April 1973, Senator William Fulbright noted that Israel controlled the Senate. By 1989, he wrote in his book, *The Price of Empire*: 'AIPAC and its allied organisations have effective working control of the electoral process. They can elect or defeat nearly any congressman or senator they wish.'

Currently, Congress is passing The Anti-Semitism Awareness Act which violates both the First and Fourth Amendments of the U.S. Constitution: the right to freedom of speech and the right to privacy, respectively.

The new legislation will join the recently approved Foreign Intelligence Surveillance Act (FISA), which allows the U.S. government to spy on citizens without a warrant. According to Philip Giraldo of the Council for National Interest, the bills were pushed by Zionist organisations such as the infamous Anti-Defamation League (ADL).

Meanwhile, as the International Criminal Court (ICC) prepared to issue arrest warrants for Israel's Prime Minister Benjamin Netanyahu and two other senior Israeli officials in connection with war crimes, it is understood that 12 Republican senators sent a letter to the chief prosecutor, Karim Khan, threatening to discredit the court.

Students at U.S. colleges and universities demonstrating against the crimes being committed against Palestinians are being clubbed, gassed and arrested, and in some cases denied the degree that they earned from four years at college.

On April 17, during a House of Representatives' hearing on the new 'anti-semitism' bill, congressman Rick Allen declared that he personally viewed Jerusalem as 'the centre of the universe.'

Forced conscription backfires in Ukraine

THE Ukrainian army is facing waves of desertion from conscripts as the popularity of their president, Volodymyr Zelenskyy, plummets.

After the Russian incursion into Kharkiv province, Ukrainian intelligence chief Kyrylo Budanov admitted in an interview with the *New York Times*: ‘All our troops are now either in Kharkov or in Chasov Yar. I used everything we have. Unfortunately, we don’t have anyone left in reserve.’

The French news agency, AFP, reported on Russia’s push into Kharkiv, stating: ‘The Ukrainian army is struggling to line up 250,000 men on the front line. In all the brigades, there is a 40 per cent shortage of personnel.’

A Ukrainian officer admitted: “We are facing a wave of desertion among young conscripts.”

While a French soldier returning from the front after an observation mission noted: “In Kiev, they no longer talk to us about arms but about recruitment problems.”

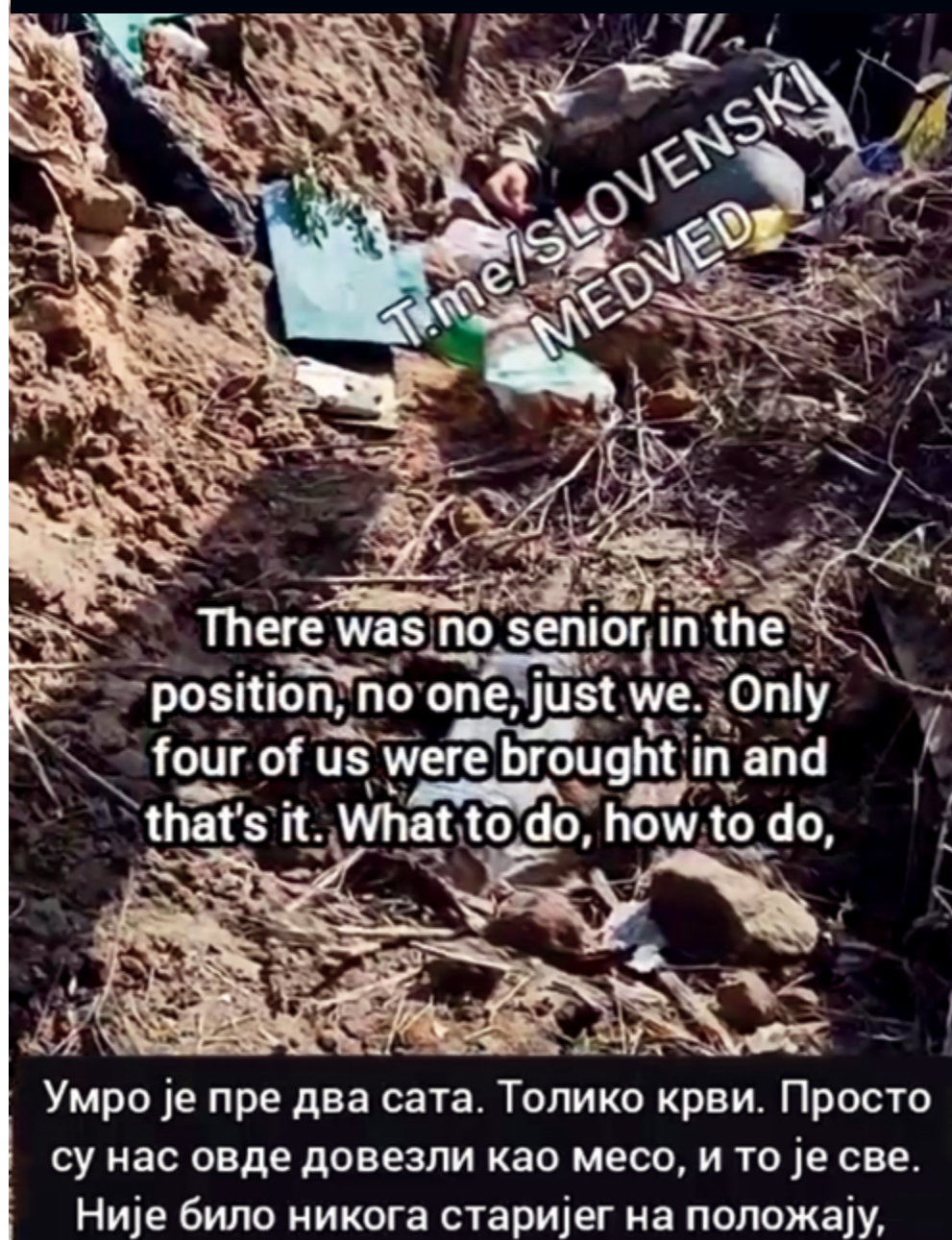
Since the coming into force of the new troop mobilisation law on May 18, the streets of Ukrainian towns are deserted. Big firms with predominantly male workforces are warning of loss of workers to the army, and production cuts.

Meanwhile, workers are protesting and many are committing petty crimes in order to seek the sanctuary of imprisonment, rather than be a victim of the ruthless TCC (official recruitment offices) and their press gang methods. Ukrainian MP Anna Skorokhod said in Parliament: “Ukrainians are massively committing petty crimes in order to get to prison, not to the AFU (Armed Forces of Ukraine).”

There are increasing signs of citizens fighting back against army recruiters on the streets and 46 per cent of Ukrainians of military age say they will not fight in the war.

A Ukrainian soldier’s video (screenshot centre) from the front line relates the process of forced recruitment from the streets to death in the trenches for his three colleagues. He said of his three dead colleagues that they were taken to the trench with no officer and no training. The soldier said: “This is Mozerenko Pashko. Four days ago on the streets in

Ternopil region he was taken away. Now he lies here. Here is Gontarenko Kolka; he was taken three days ago in Dnipro – here he lies. They just drove us here like meat. There was no senior officer – just us. What to do or how to do it, they did not tell us.”

This is the fate of thousands of Ukrainians, as armchair warmongers in London, Washington and the Baltic states pump in billions of dollars which do no more than buy Ukrainian corpses.

Due to the scale of losses, the Armed

Forces of Ukraine cannot report on the dead in a timely manner, writes the *New York Times*.

Relatives note that everywhere they encounter neglect and inaction, bodies are identified from aerial footage taken from a drone, their deaths are reported by colleagues, but Ukrainian commanders will not lift a finger for months to find out the fate of Ukrainian servicemen or take their bodies.

The Ukrainian military leadership is simply overloaded with losses and is unable to properly account for the thousands of dead, which of course makes Ukrainian dead and wounded figures totally unreliable.

A resident of Zaporozhye, the owner of a small mobile phone store, said that there were almost no people left in the city.

They said: “There are no people on the street, no passers-by, no one goes anywhere. Almost no cars. In half a day, only two grandmothers came... I just give up.”

In the comments on the video, people write that the same thing is happening in all major cities. On the day the new law came into force, the beaches of Odessa were empty and there was not a single man on the street.

Meanwhile, hundreds of trucks blocked the highway protesting against the new law on mobilisation. According to a participant in the rally: “Truckers are protesting against the draconian laws of the semi-legitimate ‘Ze-government’.”

After mounting troop losses, the loss of Bakhmut, Avdeevka, and dozens of towns in western Donetsk, the loss of northern Kharkiv province to Russian troops and their advance towards Kharkiv city, President Zelenskyy’s popularity has never sunk so low.

Since there is little hope in the West that the latest financial package from the USA and a similar one proposed by the EU will alter the course of the war, there is now a growing move in the Western press to undermine Zelenskyy – since he is the main obstacle to peace negotiations.

True Pearls: On politics, ‘democracy’ and the state

Neither ‘left’ nor ‘right’ – just truth

THOSE who are not interested in politics will be forever ruled by those who are... It is the duty of every citizen to be informed and engaged in the political process.

When governments claim to derive their authority from any source other than the governed, it always leads to the destruction of liberty.

In many cases, politicians are just little recording devices. They have no feelings for what they are saying; they have only one goal and that is to get elected. And it is hard to find a person who you can say does not fit into that category... The candidates are basically performers, like actors.

They think: ‘how can we elitists rule the world at the same time as we want to let the average person think they’re living in a “democracy”, they’re living in a system where their vote counts, they’re living in this world where they think they must participate in their own political destiny?’ This is a carefully nurtured myth that they want to create so people will be content with whatever happens – because ‘I voted for it... This government is my government, no matter how bad it is’... ‘How do you let people believe that

they’re directing their own political destiny when at the same time WE, the elite, are the ones who must direct their political destiny without them knowing that?’ Answer? – it’s very simple: you’ve got to have two major political parties – both have the same goals and the same fundamental principles; and they’ll argue with each other on the surface with slogans, and leadership and style and so on; but we [the elite collectivists] will control them both. There’s the strategy; there’s the scam behind this whole left/right paradigm.

It’s a great scam for people to think that they have to choose between the right and the left, not realising that whichever way they go, they’ve accepted basically the same ideology.... When you understand this reality, the left wing and the right wing are just two wings of the same ugly bird – and that bird is called collectivism.

This left/right paradigm is a political ploy: it works very well for those who know what they’re doing. The two parties are in the hands of a relatively small group of people – the Council on Foreign Relations. These are the people really pulling the strings in both parties.

We have been conditioned to laugh at conspiracy theories, and few people will risk public ridicule by advocating them. On the other hand, to endorse the accidental view is absurd. Almost all of history is an unbroken trail of one conspiracy after another. Conspiracies are the norm, not the exception.

Criminals gravitate into government positions like natural law... To oppose corruption in government is the highest obligation of patriotism.

Citizenship means every four years, you put a mark somewhere and you go home and let other guys run the world. It’s a very destructive ideology.

The main reason [people don’t vote] is because they understand without reading political science texts that it doesn’t make any difference how they vote. Democracy is a danger to any powerful group... Democratic societies can’t force people. Therefore they have to control what they think.

The smart way to keep people passive and obedient is to strictly limit the spectrum of acceptable opinion, but allow very lively debate within that spectrum – even encourage the more critical and dissident views. That gives people the sense that there’s free thinking going on, while all the time the presuppositions of the system are being reinforced by the limits put on the range of the debate.

The U.S. has essentially a one-party system and the ruling party is the business party... It has two factions, called Democrats and Republicans, which are somewhat different but carry out variations on the same policies.

The media are a corporate monopoly. They have the same point of view. The two parties are two factions of the business party. Most of the population doesn’t even bother voting because it looks meaningless.

I am not too happy with terms like ‘the

left’; I don’t use it much.

The key element of social control is the strategy of distraction that is to divert public attention from important issues and changes decided by political and economic elites, through the technique of flooding continuous distractions and insignificant information.

Work can be undertaken to create an authentic independent political party, a real party, based on popular participation from the ground up, not a top-down candidate producing organisation like the two official parties.

What are elections? You know, two guys, same background, wealth, political influence, went to the same elite university, joined the same secret society where you’re trained to be a ruler – they both can run because they’re financed by the same corporate institutions.

Unfortunately, you can’t vote the rascals out, because you never voted them in, in the first place.

The time to be political is not when you have parties and carnivals, it’s kind of a show, the election. It affects something but not that much. And focusing all the attention on it is a mistake.

Political campaigns are designed by the same people who sell toothpaste and cars.

Anything that you are achieving that undermines and threatens systems of power will meet with oppression. Systems of power don’t say ‘thank you.’

One of the greatest dangers is secular religion – state worship... States are not moral agents, people are.

As long as the general population is passive, apathetic, diverted to consumerism or hatred of the vulnerable, then the powerful can do as they please, and those who survive will be left to contemplate the outcome.

I try to encourage people to think for themselves, to question standard assumptions... Don’t take assumptions for granted. Begin by taking a skeptical attitude toward anything that is conventional wisdom. Make it justify itself. It usually can’t.

If you assume that there is an instinct for freedom, there are opportunities to change things, there’s a chance you may contribute to making a better world. The choice is yours.

Protecting society from science

EXACTLY half a century ago, the great philosopher of science, Paul K. Feyerabend (1924-94), gave a historically prophetic talk to the Philosophy Society at Sussex University.

The talk was provocatively titled ‘How to defend society against science’, with Feyerabend speaking of the authoritarian nature of mainstream science long before such tendencies became recognised in mainstream culture.

Were he alive today, Feyerabend would surely be writing for *The Light* about the flagrant abuse of science evident in the course of the covid atrocity.

I first came across Feyerabend when studying the philosophy of science at university in 1976-7, shortly after his iconic 1975 book, *Against Method: Towards an Anarchistic Theory of Knowledge*, was published.

That book blew me (and many others) away, but only later did I discover his ultra-radical counter-cultural writings about the tyrannical inclinations of modern science. In *Against Method*, Feyerabend wrote that ‘[science] is not infallible and it has become too powerful, too pushy and too dangerous to be left on its own.’

In his uber-critical 1974 presentation, Feyerabend made many claims that make for breathtaking reading today. Here are just a few sumptuous gems from that talk:

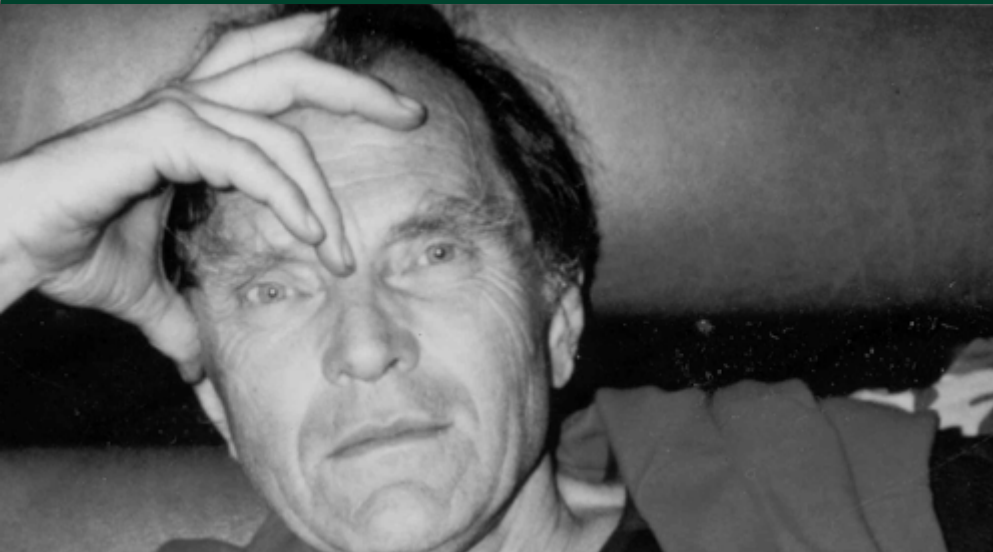
‘I want to defend society and its inhabitants from all ideologies, science included. There is nothing inherent in science... that makes it essentially liberating... Science has now become as oppressive as the ideologies it had once to fight.

‘Heretics in science are still made to suffer from the most severe sanctions this relatively tolerant civilisation has to offer... Science has become rigid, [and] it has ceased to be an instrument of change and liberation... Modern science... inhibits freedom of thought...

‘Science is just one of the many ideologies that propel society and it should be treated as such... The competence... and the successes of science are vastly exaggerated... The progress of... good science depends on novel ideas and on intellectual freedom... Most scientists today are devoid of ideas, full of fear, intent on producing some paltry result so that they can add to the flood of inane papers that now constitutes “scientific progress” in many areas.’

In 1978, Feyerabend wrote his most controversial book, *Science in a Free Society*, arguing that science was far from being a liberator of thought.

Philosopher Paul K. Feyerabend, 50 years on

Scientific rationality now acts as a form of suppression, often inhibiting and silencing any rivals to its narrowly dogmatic worldview.

It imposes a set of doctrines and procedures administered and institutionalised by ‘experts’ that effectively stifle most if not all criticism.

Feyerabend believed science had become authoritarian, with an out-of-control scientific rationalism threatening democracy itself by the way in which what he calls ‘an unholy alliance of science, rationalism and capitalism’, an ‘intellectual fascism’ was crushing all opposition.

Instead, he championed a society of free interchange in which science is just one

of many voices, advocating a fundamental reassessment of the role of science in society. For Feyerabend, freedom was the ultimate human value, and he was challenging a core enlightenment premise – that intellectual and societal progress can only be achieved through the control of reason with the help of science.

Many things Feyerabend wrote have an eerie relevance to the recent covid-jab atrocity. He insisted that non-scientific alternatives may sometimes work as well or better than mainstream scientific procedures.

He said: ‘Our ancestors and “primitive” contemporaries had highly developed... medical theories and biological doctrines that are often more adequate and

have better results than their Western competitors... We know what science does, we have not the faintest idea whether other traditions could not do much better.’

And he further wrote that ‘man once possessed complex knowledge concerning his place in nature [but this] knowledge has been replaced by abstract theories he does not understand and must take on trust from experts.’

And even more poignant – [scientific] ‘unanimity is the result of shared prejudices: positions are taken without detailed examination of the matter under review... A unanimity that rests on internal considerations alone often turns out to be mistaken.’ Sound familiar?

Feyerabend was predictably contemptuous of ‘the incompetence of scientific medicine as a whole.’ For him, ‘every patient must be the supervisor of his own treatment... just as every group of people and every tradition must be able to reject [government] projects [they] do not regard as adequate.’ And he further implored us ‘never to rely on experts entirely.’

Even more prophetic: ‘Research... often produces monsters... Comprehensive mistakes involving the basic ideology of the field can be often revealed only by outsiders or by scientists with an unusual personal history.’

And ‘an independent science has long ago been replaced by the business science which lives off society and strengthens its totalitarian tendencies.’

For ‘many parts of science [are] now [becoming] businesses when the aim is no longer to find truth... but to keep the money coming in.’

And so ‘today, science prevails not because of its comparative merits, but because the show has been rigged in its favour... The superiority of science is not the result of research, or argument; it is the result of political, institutional and even military pressures.’

Referring to the ‘narcissistic chauvinism’ of science, Feyerabend wrote that: ‘scientists have now the power to impose their ideology on almost everyone... with a large part of the general public [being] hypnotised by science... [They] are parasites of the mind and they will continue in their path until democracy puts them in their place.’

Perhaps unsurprisingly, many mainstream scientists at the time, and even some philosophers, hated Feyerabend with a vengeance – just as mainstream psychiatrists hated Ronnie (R.D.) Laing for outing their outrageously inhumane practices.

A greater badge of honour can scarcely be imagined.

The great mental decline

Manufacturing mass conformity through the use of neuroscience

WITH the enormous advances in neuroscience and technology, the potential to misuse both these tools for nefarious ends is evident.

In an age where the institutions with power over our lives have manifestly ceased to adhere to the rules of ethics, it is crucial to understand how our brains can be altered through psychological and physiological manipulation, and how we can protect ourselves from this onslaught.

German physician and molecular geneticist, Dr Michael Nehls, recently published a book titled *The Indoctrinated Brain*, in which he explains some of the brain's key features and mechanisms, and how these can be rendered dysfunctional through the constant stream of government-generated and media-repeated anxiety messages, as well as through toxins which produce neuro-inflammation.

The book's cover tells us: 'Throughout the world, mental capacity is declining, especially among young people, while depression rates are rising dramatically. Meanwhile, one in forty individuals suffers from Alzheimer's, and the age of onset is falling rapidly. But the causes are not being eliminated, quite the opposite.'

Dr Nehls does not believe that this is accidental, but rather a targeted attack on the brain to reduce people's ability to think for themselves, and thus to challenge the rise in authoritarianism.

He explains that the brain is made up of hundreds of billions of nerve cells, each of which is part of a unique network of hundreds of thousands of connections.

The genetic make-up of each individual provides the first level of uniqueness, but the brain is plastic and malleable, and each personal experience influences its pathways and structure, so that even identical twins develop different personalities.

Individuality is created and moulded through our unique thoughts and experiences, the recording of which Dr Nehls calls 'writing our autobiographical memory'. The benefits of this are that the enormous diversity of human individuality gives rise to a rich pool of creative thoughts and innovative solutions

to problems which are tested, verified, modified or rejected. At a personal level, it constitutes the very essence of the human journey. It is this individuality that Dr Nehls believes is under attack from all angles, with the goal of standardising human behaviour, and gaining mass control over it by reducing mental capacity.

A healthy brain continues to develop its autobiographical memory throughout life, retaining its plasticity into old age, and is essential to psychological resilience and cognitive-emotional health. The main focus of his book is the hippocampus, two small structures resembling seahorses located either side of the brain in the temporal lobes, and the need to preserve their vital memory-forming capacity.

Dr Nehls refutes the notion that Alzheimer's is causally related to old age, insisting that it is an avoidable degradation of the hippocampal function brought about by psychological and physiological factors.

The two hippocampi together make up only one per cent of human brain volume, but are the control centre of the memory function, and that in order to be able to 'write' our autobiography throughout our lives, the hippocampus has had to make adaptations to overcome its limited storage capacity.

First, only those experiences and thoughts which provoke emotion (i.e. they are exciting, intriguing, shocking, unexpected, etc.) are permanently recorded by index neurons. This is done by filing them according to place and time, content, and the feeling they provoked. Second, as the hippocampus can only hold a day's worth of memorable events, overnight it transfers the contents of the day's

significant memories into a larger storage facility in the neocortex, but in various locations and fragmented form. However, the index neurons stored in the hippocampus retain the access codes to these memories through its time, place, type, and feeling signatures, enabling the conscious mind to retrieve and reconstruct these past experiences and thoughts.

Third, during nocturnal sleep, the hippocampus generates thousands of new neurons for use the following day, to ensure we have sufficient indexing neurons to form new memories and distinguish them from previous ones. This process is known as 'neurogenesis'. Hippocampal neurogenesis is considered vital for psychological and mental resilience, but new neurons can only survive if they are actually used to encode new experiences.

They need to be fed with new content to record. In other words, natural human curiosity, the willingness to interrogate assumptions and ideas, and to discover new horizons are key to maintaining cognitive health throughout life. A prolonged absence of interesting thoughts, conversations and experiences, which stimulate the index neurons, diminishes their production, leading to depression and, ultimately, hippocampal dementia (Alzheimer's).

Dr Nehls' thesis is that, given the pivotal role of the hippocampus in mental ability and psychological resilience, it is impossible not to consider that there is a deliberate, targeted attack on this region of the brain in order to impair its function.

Mental manipulation is far more effective at controlling populations than force alone, as

natural non-conformist, critical-thinkers are a danger to totalitarian ambitions.

By triggering continual emotional reactions with stories of existential threats, they induce chronic anxiety which floods the brain with glucocorticoids, creating neuro-inflammation through the toxic effect of a constant release of stress hormones, which in turn inhibits hippocampal neurogenesis.

Without a productive hippocampus with its daily supply of new index neurons with which to record new significant experiences and thoughts, our memory shrinks and we start to lose a sense of self. Furthermore, old index neurons stored in the hippocampus, which give us access to previous memories, under unrelenting stress, can be overwritten with the dominant fear-stoking narratives.

This causes the loss of the associated long-term memories, part of our autobiography which constitutes our individuality, and replaces them with propaganda.

Dr Nehls' recommendations to physiologically protect our brains from this continual onslaught include many nutritional supplements, especially algae oil as a source of essential aquatic omega-3 fatty acids, and a range of vitamins because our food increasingly lacks essential nutrients.

He also emphasises the importance of having a discipline of regular sleep patterns and an overnight fasting interval of at least twelve hours between our evening meal and breakfast. However, the single most important factor for our psychological welfare is our natural curiosity.

In the words of Alfred, Lord Tennyson: 'To strive, to seek, to find, and not to yield.'

Titanic Sinks - Huge Loss of Life!

- 1,500 feared lost
- Captain Smith missing, presumed dead
- Board of Trade Inspector hints at insurance fraud
- Captain Lord of SS Californian officially blamed

NEWS agency reports state that RMS Titanic sank in the early hours of April 15 with only 700 souls surviving the disaster.

The overwhelming assumption was that Titanic had sunk as a result of a collision with an iceberg. This one fact has dominated the story. But with the benefit of compelling new evidence coming to light from survivors' testimony, the official enquiries and their subsequent statements, a shocking truth begins to unfold:

- That the sunken ship at the bottom of the Atlantic is not RMS Titanic but its sister ship, RMS Olympic.
- That the White Star Line together with the British government were responsible for possibly one of the greatest frauds and sea tragedies in living history

WHY AND HOW COULD THIS OCCUR?

Olympic and Titanic represent White Star Line's survival strategy in the highly competitive North Atlantic Passenger trade. When launched, Olympic and Titanic were virtually identical, built from the same plans and drawings.

The White Star Line was already in a precarious financial position. The two new ships had cost around £1.5m each and White Star

Line needed a full six years of continuous service on the North Atlantic route from both ships to achieve a return on J. P. Morgan's considerable investment.

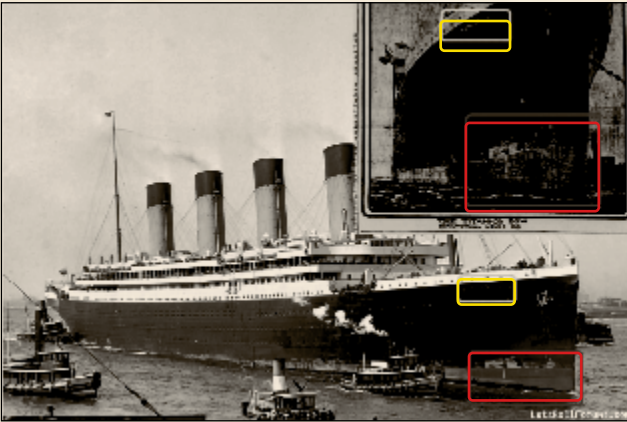
Harland & Wolff shipbuilders in Belfast had an exclusive contract with White Star Line to build all their ships. If the White Star Line were to fold, Harland & Wolff would follow and the major workforce in Belfast would be unemployed, along with all the many dependent suppliers which would fold as a result.

As part of the deal to allow an American company (JP Morgan's International Mercantile Marine) to take over a British company (White Star), the British Government obtained an agreement that all White Star line ships could be requisitioned as Royal Navy Reserve ships in time of war. And with war in Europe looking increasingly likely at this time, this was an important consideration for prime minister H.H.Asquith's Liberal government.

So the ultimate owner, J.P. Morgan, was both banker and main creditor and if White Star Line should go bankrupt, Mr. Morgan would be entitled to repossess all White Star Line's ships.

If White Star Line had been allowed to fold and because Harland and Wolff's business is heavily dependent on White Star Line, the result would have been massive unemployment in Belfast – 60,000 at Harland and Wolff, 20,000 at White Star, plus countless thousands at dependent organisations.

This would mean the loss of valuable seats in Belfast and effectively eliminate Prime Minister Asquith's

narrow majority at the upcoming General Election. It is for this reason that the government colluded in a coverup.

Damage to Olympic

On September 20 1911, the Olympic was involved in a major collision with HMS Hawke in Southampton Water causing severe damage (HMS Hawke is a naval battleship designed to ram enemy vessels):

- Holed above and below water line on the starboard side by Hawke's bow ram.
- Damage to front of ship is remarkably similar to that done to TITANIC by iceberg a few months later. (H&W records)
- Patched up in Southampton – wood and steel plates placed over the damaged area.
- The middle engine, the turbine engine, works exclusively from steam recycled from the other two engines. The fact that this engine was not used clearly suggests that the propeller shaft, which runs directly above the keel, is damaged. Therefore, the keel itself must also have been damaged: a bent or twisted keel means a scrapped ship.
- Despite repair in Southampton, the ship

was taking on water at an alarming rate.

- On the way to Belfast there is a pronounced list to port.

On the maiden voyage of the Titanic, some of the surviving passengers and officers reported a noticeable list to port.

On October 12/13 1911, an inspection revealed...

- Triangular hole above the water line and large hole below the water line
- Starboard propeller and crankshaft damaged (all three blades seriously damaged)
- Crack between crank arm and crank shaft
- Possible shock loading of engine
- Hull steel plating dislodged over D, E, F, G Decks
- D, E, F, G Decks penetrated to a distance of 8 feet
- Steel frames buckled
- Thousands of rivets burst
- Stern frame bearing cracked (this is the worst damage – it was fitted at construction and never meant to be replaced – kept turning after collision)

The above takes the ship beyond reasonable financial repair.

Any accident involving a Royal Naval ship was investigated by the Admiralty. The Admiralty found Olympic to be at fault for the accident and therefore White Star's insurance declines to pay out on the claim.

The cumulative effect of the damage listed above was that the Olympic was damaged beyond economic repair and would never pass another Board of Trade inspection.

Olympic was then patched-up enough to get it through some suspiciously easy sea trials, and a maiden voyage as confessed by the Board of Trade inspector, Mr. Carruthers. The two ships, lying together side by side in Belfast, were then switched over the weekend.

April 10, 1912

With its name changed to Titanic, Olympic heads at full speed into a known ice field, with a dangerous fire burning in coal bunker number 10.

Another IMM ship, The Californian, under the command of Captain Stanley Lord, was standing by for the rescue operation.

On Titanic, B deck was supposed to be an enclosed space taken up by 1st Class cabins. There was no through route, yet some passengers claimed they were able to board boats from a footpath on B deck, proving that they were in fact on the Olympic.

The Coverup

A 'committee of passengers' wrote a statement aboard the rescue ship, Carpathia. It neatly shifts the blame from the White Star Line to the Board of Trade. The language used suggests it was written for them by one of Titanic's officers, probably Lightoller as the senior surviving officer. The British Government,

through U.S. Ambassador Brice, moved heaven and earth to dissuade the U.S. Government from holding their own inquiry.

Ismay attempted to sneak the surviving crew out of the U.S. on the SS Cedric, but failed.

Titanic's surviving officers stonewalled the U.S. Inquiry, as did Ismay himself.

On their return to Britain, all 172 surviving crewmen were told not to make any public statement concerning the disaster. They were then forced to sign the Official Secrets Act before being released to their families, some after as long as 24 hours.

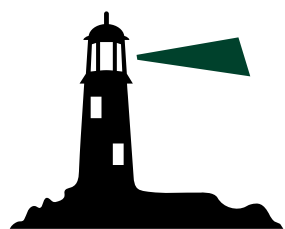
Was someone trying to suppress something here... some vital piece of information...?

Was he made a scapegoat because he had failed to do what he had been engaged to do on the night of the disaster? Lord Mersey persistently interrupted the testimony given by the officers of the Californian.

In conclusion, all evidence points to the fact that the identities of the two ships were switched in a desperate attempt to save J.P. Morgan's shipping line, and it has been facilitated by the British government's all too transparent whitewashing of the events.

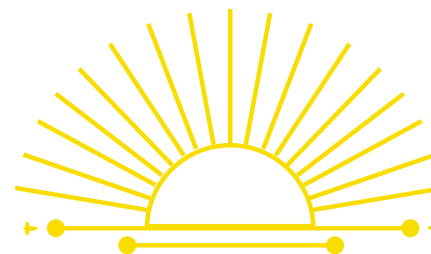
