

SUPPLEMENT TO THE VOTES AND PROCEEDINGS

Observation by the Secretary of State for Defence on the Petition [7th November 1995] from Residents of Plymouth and Devon for redress for illness caused by exposure to asbestos at Devonport Dockyard.

Service personnel exposed to asbestos prior to 1987 are subject to the provisions of Section 10 of the Crown Proceedings Act 1947. This means that they may be eligible for an award of war pension but would be precluded from suing for common law damages.

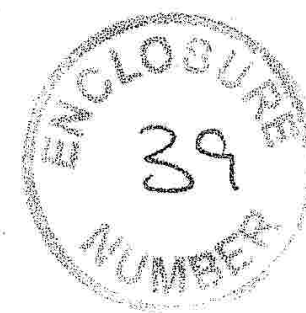
Whilst the repeal of Section 10 enabled damages to be awarded on common law principles for Service Personnel exposed to asbestos after 1987, this duplicates, to some extent, what is available on a no-fault basis through the war pension scheme.

The possibility of making the repeal retrospective was debated in the House in 1987 and it was decided that it could not be made retrospective without causing further injustices and anomalies.

Former Service personnel can claim War Disablement Pensions or Gratuities from the War Pensions Agency of the Department of Social Security irrespective of when exposure to asbestos dust took place, although an award of war pension depends on the degree of disablement. These entitlements are tax free, index-linked and periodically reviewed. The benefits are not just the entitlement award but also lead to supplements depending on need, eg: war pension mobility supplement or the constant care allowance. The capital value of these entitlements can be substantial.

LETTER FROM DENNIS CANAVAN MP - US 1306/97

1. Councillor William Buchanan wrote to the Prime Minister in Sep 94 to say that in the preceding two years over 600 people had come forward with reports of "UFO" sightings in the Falkirk District. He urged the Prime Minister to order an enquiry into the sightings to alleviate the concerns of his constituents.

2. Sec(AS) replied to the letter stating that the Department had received only two or three reported sightings over the period in question and none were of defence significance. The letter went on to say that we were not aware of any phenomena in the Falkirk area which would warrant investigation, but that if we received any further reports (or substantive evidence) they would be assessed to establish whether they indicated any physical threat.

3. Nothing else was heard from Councillor Buchanan until Jan 95 when the local MP, Dennis Canavan asked if the Councillor and a local 'ufologist' might meet officials to discuss the "UFO" sightings. It was considered that such a meeting would probably perpetuate the myth that the Department had a role in "UFO" research and Lord Henley's reply (copy attached) declined the request. In so doing we emphasised, once more, that should Councillor Buchanan wish to provide any further information we would assess it in the normal way.

4. In the two years since that time we have not heard at all from Councillor Buchanan. There have been a handful of "UFO" sightings reported to us from the Falkirk area during this time. This would not be unusual given the number of sightings received for the UK as a whole (over 600 in 1996 alone). Those from the Falkirk area were not deemed to have defence significance. Geographically, Falkirk sits between Glasgow and Edinburgh airports, and an aerodrome (Cumbernauld) is close by. It is likely that civil aircraft activity accounts for much of what has been seen.

Thank you for your letter (ref: DC/AT) of 10 March addressed to Michael Portillo enclosing one from Councillor William Buchanan of Municipal Buildings, Falkirk, about unexplained lights over Falkirk and Bonnybridge. I am replying as this matter falls within my area of responsibility.

As you will recall from Oliver Henley's letter of 1 February 1995, my Department examines any reports of 'UFO sightings' sent to us solely to establish whether what has been seen might have some defence significance, namely, whether there is any evidence that the UK Air Defence Region might have been breached.

I should wish to assure Councillor Buchanan that the integrity of the UK's airspace in peacetime is maintained through continuous policing of the UK Air Defence Region by the Royal Air Force and we remain vigilant for any potential military threat. However, unless there are defence implications we do not attempt to identify the precise nature of every "UFO" sighting reported to us. We believe that rational explanations, such as aircraft lights or natural phenomena, could be found for them if resources were diverted for this purpose, but I am afraid that it is not the function of the MOD to provide this kind of aerial identification service. It would be an inappropriate use of defence resources if we were to do so.

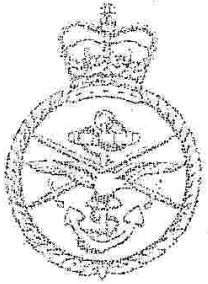
As we have said previously, if Councillor Buchanan has information to support his concerns that Falkirk and Bonnybridge are experiencing phenomena of defence significance then my officials would be happy to examine this further.

In the absence of such evidence we remain satisfied that there are no phenomena in the Falkirk area which are of defence concern.

I hope this explains our position.

Thank you for your letter of 18 January about the approach you have received from Councillor W Buchanan on the subject of unidentified flying objects.

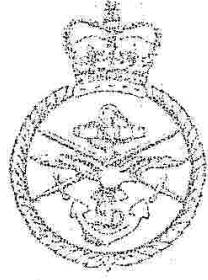
Councillor Buchanan wrote to the Prime Minister at the end of September last year expressing his concern that there had been 600 UFO sightings in his District and requesting a Government enquiry into the matter. This letter was passed to my officials who explained the Department's role and responsibility with respect to unexplained aerial sightings, namely that our interest is confined to establishing whether the reports indicate evidence of the presence of a physical threat to the United Kingdom's air defences. They also pointed out that my Department has received only a handful of reports of such sightings from the Falkirk area over the last few years, none of which were deemed to be of defence significance. Councillor Buchanan was invited to send us any additional information he may have and my officials explained that we would look carefully at all reports received. Nothing has been received from him and we therefore remain unaware of any evidence which would indicate that the original assessment was incorrect.

Given the specific responsibilities of my department in this matter, and the continued absence of any evidence that would indicate phenomena of defence significance, I do not believe that a meeting with Councillor Buchanan and **Section 40** would serve any useful purpose. Should Councillor Buchanan wish to submit any further information, my officials will of course assess this in the normal way.

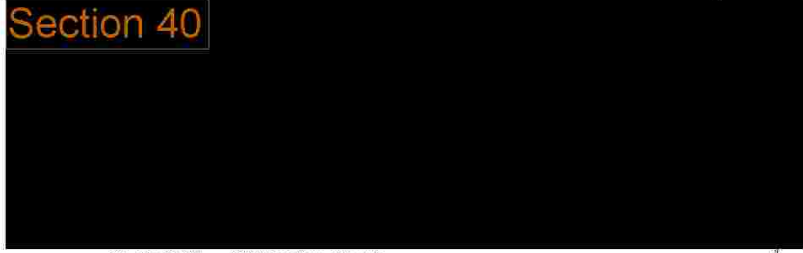

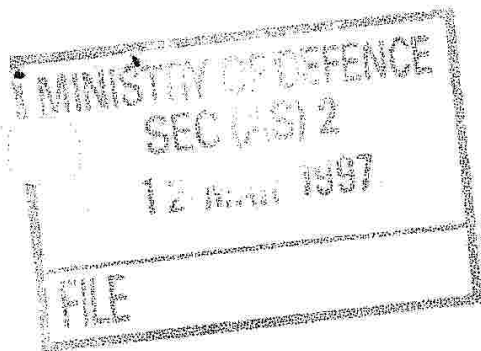

"I am sorry I cannot be more helpful"
"I am sorry to send what I know will be a disappointing reply."

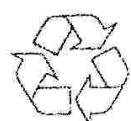
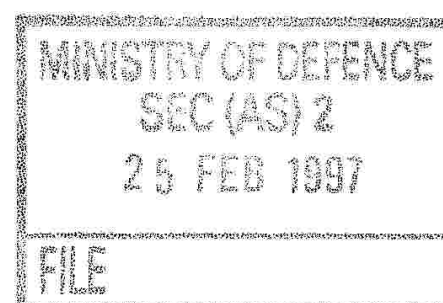
Dear Roger,

Thank you for your letter of 1 February to Nicholas Soames on behalf of your constituent, **Section 40** of **Section 40** **Section 40** Margate, about "unidentified flying objects". I am replying as this matter falls within my area of responsibility.

My Department examines any reports of "UFO sightings" solely to establish whether what was seen might have some defence significance, namely, whether there was any evidence that the UK Air Defence Region might have been breached. Unless there are defence implications, and to date no "UFO sighting" reported to us has revealed such evidence, we do not attempt to identify the precise nature of each report. From the descriptions we do receive, aircraft or natural phenomena probably account for most of the observations.

Section 40 has asked about a "UFO" sighting on 5 October 1996 off the Lincolnshire coast and I must say that the events concerned received a certain amount of media attention at the time, much of it incorrect, ill-informed and speculative. Our air defence system found no evidence of unidentified flying craft throughout the period in question. Two quite separate phenomena were reported: an unexplained radar plot and lights in the sky. The radar plot observed, which was identified on the National Air Traffic Services Claxby radar in the position of Boston, was judged by experienced operators at two separate locations to be a permanent echo, caused by a natural phenomenon (something that does occur in certain weather conditions). It was not suspicious in nature nor of any significance to air or maritime safety, and of no air defence or air concern. The characteristics of the radar plot confirmed beyond reasonable doubt that this judgement was sound.

There was very little reliable or accurate bearing or elevation information in connection with any of the reported sightings of the lights which were observed in the area of The Wash. From that provided, the Greenwich Observatory advised that they were of celestial origin and likely to have been Venus which was exceptionally bright during the week in question.

I am confident that there was no evidence that the UK Air Defence Region was compromised and there was, of course, no reason whatsoever, in the light of the above for any further military action.

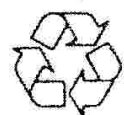

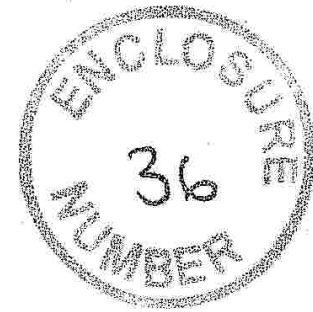

It has been the policy of successive Governments not to provide information on the functions of individual intelligence branches when this discloses the more recent nature of their duties.

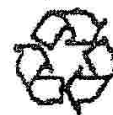

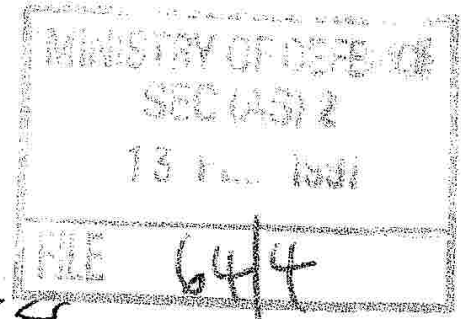

I am sorry I cannot be more helpful, but I hope this explains the position.

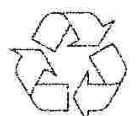

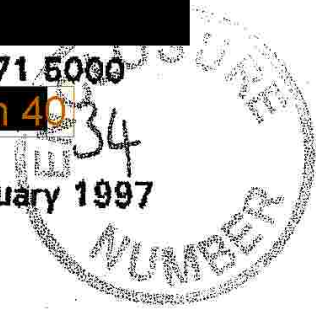

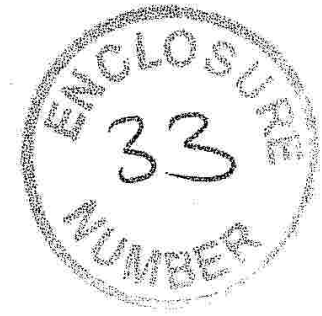

1. Mr Gale's constituent, **Section 40** is not known to Sec(AS)2. However, from the attachment to the MP's letter it is very likely that another member of public, **Section 40** has a hand in this enquiry. **Section 40** has initiated three Parliamentary Enquiries on the subject of "UFOs" through the MP for Anglesey, Ieuan Wyn Jones, and has been responsible for numerous letters to the Department, on the same subject, requiring official action replies.
2. The main theme of the enquiry centres on a "UFO" sighting on 5 October 1996 in "The Wash" off the Lincolnshire Coast which received a fair amount of media attention at the time. The sighting, and follow up MOD involvement was the subject of a PE from Martin Redmond MP (US 4168/96), the background note of which sets out the position (attached at ANNEX A). A more detailed analysis is available if required.
3. The MP has written in similar terms to the Department of Transport. I have agreed with DoT officials that MOD will address the air defence aspects of this enquiry, while they will concentrate on the question of near misses with civil airliners.
4. Given MOD's limited interest in reports of "unexplained" aerial sightings to those only occurring within the UK Air Defence Region, we have not addressed those questions directed at the FCO or Home Office. Mr Gale could have included both Departments in his circulation of the attachment in a similar way to the DoT.
5. There can be no justification for a Press Conference about the sightings of 5 October. There was no evidence of any defence interest; information about our findings is already in the public domain and is readily available to anyone who requests it.

6. The line taken in the draft reply to Mr Gale is consistent with that given to Martin Redmond in November last year (US 4168/96 copy attached at ANNEX B.)

My Department examines any reports of "UFO sightings" solely to establish whether what was seen might have some defence significance, namely, whether there was any evidence that the UK Air Defence Region might have been breached. Unless there are defence implications, and to date no "UFO sighting" reported to us has revealed such evidence, we do not attempt to identify the precise nature of each report. From the descriptions we do receive, aircraft or natural phenomena probably account for most of the observations.

Section 40 has asked about a "UFO" sighting on 5 October 1996 off the Lincolnshire coast and I must say that the events concerned received a certain amount of media attention at the time much of it incorrect, ill-informed and speculative. Our air defence system found no evidence of unidentified flying craft throughout the period in question. Two quite separate phenomena were reported: an unexplained radar plot and lights in the sky. The radar plot observed, which was identified on the National Air Traffic Services Claxby radar in the position of Boston, was judged by experienced operators at two separate locations to be a

permanent echo, caused by a natural phenomena (something that does occur in certain weather conditions). It was not suspicious in nature nor of any significance to air or maritime safety, and of no air defence or air concern. The characteristics of the radar plot confirmed beyond reasonable doubt that this judgement was sound.

There was very little reliable or accurate bearing or elevation information in connection with any of the reported sightings of the lights which were observed in the area of The Wash. From that provided, the Greenwich Observatory advised that they were of celestial origin and likely to have been Venus which was exceptionally bright during the week in question.

I am confident that there was no evidence that the UK Air Defence Region was compromised and there was, of course, no reason whatsoever, in the light of the above for any further military action.

I hope this explains the position. We have already provided the above information on request to any interested parties, and are content to continue to do so.

LETTER FROM MARTIN REDMOND MP - US 4168/96

1. I attach a draft reply for USofS to send to Martin Redmond MP. The deadline was extended to COP today with the agreement of the Parliamentary Unit.

BACKGROUND

2. The substance of Mr Redmond's letter alleging 'unidentified flying craft sightings' is based on various reports some incorrect, ill-informed or speculative, which appeared in the local press.

3. Initial Observations. At approximately 0205Z on 5 October [REDACTED] Section 40, a Skegness police officer on mobile patrol at Addlethorpe observed stationary multicoloured lights in the sky which he reported to Skegness control room who relayed the message on to Great Yarmouth Coastguard Maritime Rescue Coordination Centre (MRCC) suspecting it might be related to an incident at sea. The MRCC, unaware of any maritime activity, asked the Air Rescue Coordination Centre (ARCC) at RAF Kinloss about any air activity or incident in The Wash area, and with nothing to report, they in turn asked the Control and Reporting Centre (CRC) at RAF Neatishead to check their radar for that area. Neatishead confirmed they had no unidentified radar contact on the air defence radars being used to provide air surveillance in the area. ARCC subsequently checked with the Distress and Diversion (D&D) Cell (which is located at the London Air Traffic Control Centre (LATCC) West Drayton and not RAF Northwood as the Coastguard erroneously assumed and the press subsequently reported) for advice. The D&D Cell advised a radar plot on the NATS Claxby radar over Boston and this information was passed through ARCC to MRCC. CRC Neatishead having by now conducted a search on all available radar displays, observed the same plot on the same Claxby radar in the same position. For reasons that are unclear, MRCC associated the police officer's report of lights with the radar return over Boston.

4. Actions by Air Defence System. CRC Neatishead's inquiries revealed no sign of air movements or military exercises in the area and there was no evidence of unidentified air activity. The stationary radar plot, without associated height or IFF/SSR (Identification Friend or Foe/Secondary Surveillance Radar) was judged by experienced operators at both Neatishead and the D&D.

Cell to be a permanent echo. The separate, stationary, lights were judged to be some form of natural phenomena, not suspicious in nature nor of significance to air or maritime safety, and of no air defence or air concern. No flying craft had either penetrated the UKADR or was present on any radar and no recommendation to scramble a Quick Reaction Alert aircraft from RAF Leuchars to investigate either the permanent echo showing on the stationary radar plot, or the reported lights, was sought.

5. Subsequent Reporting. MRCC assumed a coordination role and continued to seek further information on both plot and lights. At the instigation of the coastguard, further interest in the radar plot was kept alive and involved LATCC(Civil), LATCC(Military), Anglia Radar and Waddington Approach; and with the involvement of a tanker vessel at sea (Section 40), Boston and Skegness Police Forces and LATCC(Civil) in the lights until they disappeared with the dawn.

INVESTIGATION OF RADAR PLOT AND VISUAL SIGHTINGS

6. The Boston Radar Plot. The radar Plot was observed in the position of Boston on the NATS sensor at Claxby by the D&D Cell and CRC Neatishead, although neither uses that radar on a routine basis for surveillance or aircraft control in The Wash area. Later, the plot was observed by Anglia Radar at Stanstead and the Claxby radar display. The radar plot was always single and stationary and defied attempts to obtain height or IFF/SSR information on it. Significantly, it was never present on radar displays from the NATS sensors at Cromer and Debden nor on the air defence radar at Trimmingham. The characteristics of the plot confirm beyond reasonable doubt that it was a permanent radar echo. The fact that it could only be detected by the closest sensors indicated a relatively low physical feature which appears as a permanent radar echo only in certain weather conditions and was most likely the 273ft Spire of St Botolph's Church, Boston (the 'Boston Stump').

7. Stationary Lights. Various sightings of lights were made between approximately 0205Z and dawn by observers at Skegness and Boston and on board the Section 40 some 8 miles to the east of Skegness. However, neither the police at Kings Lynn when asked at 0227Z, nor the cargo vessel, Section 40, some 16nms ENE of Skegness, at 0240Z observed any lights which they considered unusual. The crews of two civilian airliners flying through the area at 0557Z reported no sightings of lights when asked by LATCC(Civil). Only the original report by Section 40 was unsolicited. Although there is little reliable or accurate bearing and elevation information in connection with the sightings the observations have been assessed by the Royal Greenwich Observatory. They surmise the likely source of the Boston Police sighting as the planet Venus which was exceptionally bright in the early morning sky on 5 October. Their assessment of the Skegness Police video film (which was not, as reported, forwarded to MOD at the time but only after repeated requests for sight of it), was

that it was also likely to be the planet Venus. They could offer no explanation for either set of lights observed from the **Section 40**

CONCLUSION

8. Detailed research has not revealed evidence or admissions that alarming or extraordinary events were witnessed on 5 October. The radar plot observed in a position at Boston was a permanent radar echo. It was correctly assessed as such by CRC Neatishead and no further air defence related action was necessary. The bright stationary lights observed from Boston and Skegness were probably the planet Venus.

ADDITIONAL FACTORS FOR CONSIDERATION

9. Mr Redmond has tabled 33 'UFO'-related PQs during the last four weeks and is keen to exploit any opportunity to draw attention to what he perceives to be the Governments unwillingness to investigate each reported sighting in depth. This investigation was only considered necessary in view of Mr Redmond's serious allegations about the effectiveness of our Air Defence systems and involved the RAF staffs in very detailed work over a significant period. It is indicative of the effort that would be required to investigate all sightings, something Mr Redmond is keen we should do. We have explained to Mr Redmond on a number of occasions the limit of MOD's interest in 'UFO'-related issues, which is simply to determine whether there is any penetration of the UK Air Defence Region but it is unlikely he will be deflected from his attempts to discredit MOD's handling of 'UFO' reports. On balance we do not believe that the draft letter should provide a full and detailed explanation of the events of 5 October since to do so would only encourage Mr Redmond to write more frequently with this in mind. Mr Redmond has already informed the Media of his letter to MOD (The People, 10 Nov 96, copy attached) and it is likely that he will seek to interest them in the reply.

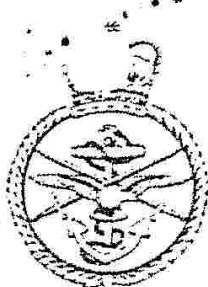

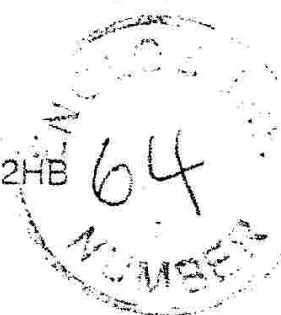

Dear Mr. Redmond,

Thank you for your letter of 24 October to Michael Portillo expressing concern about the effectiveness of the UK air defence system. I am replying as this matter falls within my area of responsibility.

I must say at the outset that much of the content of the press reports enclosed with your letter is incorrect, ill-informed and speculative. Much of what you say in your letter is also incorrect.

The facts are that our air defence system found no evidence of unidentified flying craft throughout the period in question. The only radar plot observed, which was identified on the National Air Traffic Services Claxby radar in the position of Boston, was judged by experienced operators at two separate locations to be a permanent echo, caused by a natural phenomena (something that does occur in certain weather conditions), not suspicious in nature nor of any significance to air or maritime safety, and of no air defence or air concern. The characteristics of the radar plot confirm beyond reasonable doubt that this judgement was sound.

There is very little reliable or accurate bearing or elevation information in connection with any of the sightings of lights observed in the area of The Wash. From that provided, including the video which was not forwarded to us by the Lincolnshire Police HQ until 5 November, the Greenwich Observatory view is that the lights were of celestial origin and likely to be Venus which had been exceptionally bright during the week in question.

1. Mr Gale's constituent, Section 40 is not known to Sec(AS)2. However, from the attachment to the MP's letter it is very likely that another member of public, Section 40, has a hand in this enquiry. Section 40 has initiated three Parliamentary Enquiries on the subject of "UFOs" through the MP for Anglesey, Ieuan Wyn Jones, and has been responsible for numerous letters to the Department, on the same subject, requiring official action replies.

2. The main theme of the enquiry centres on a "UFO" sighting on 5 October 1996 in "The Wash" off the Lincolnshire Coast which received a fair amount of media attention at the time. The sighting, and follow up MOD involvement was the subject of a PE from Martin Redmond MP (US 4168/96), the background note of which sets out the position (attached). A more detailed analysis is available if required.

3. The MP has written in similar terms to the Department of Transport. I have agreed with DoT officials that MOD will address the air defence aspects of this enquiry, while they

will concentrate on the question of near misses with civil airliners.

4. Given MOD's limited interest in reports of "unexplained" aerial sightings to those only occurring within the UK Air Defence Region, we have not addressed those questions directed at the FCO or Home Office. Mr Gale could have included both Departments in his circulation of the attachment in a similar way to the DoT.

5. There can be no justification for a Press Conference about the sightings of 5 October. There was no evidence of any defence interest; information about our findings is already in the public domain and is readily available to anyone who requests it.

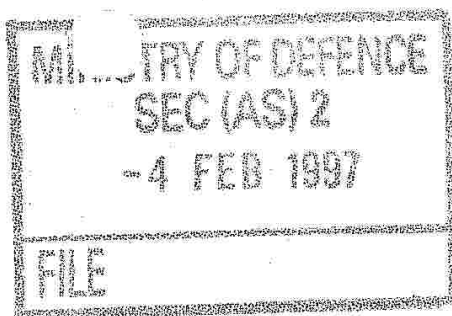

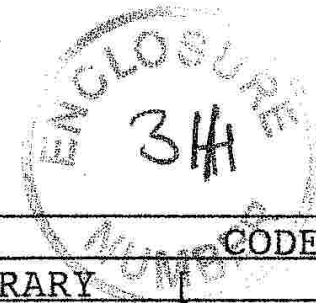

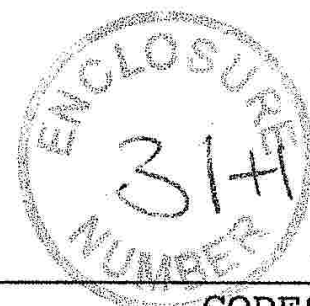

3. If none of the above is the correct procedure I should be grateful for any further guidance.

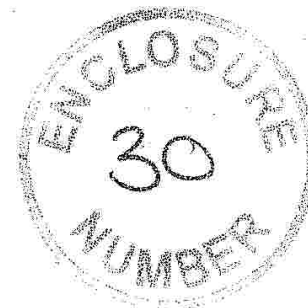

1. Mr Dorrell's constituent, Section 40, is known to Secretariat(Air Staff)2 in that he has written, and received replies, to three letters as well as two Parliamentary Enquiries since December 1994. All correspondence relates to the subject of "unidentified flying objects". Section 40 is asking that details of his name and address be removed from our files.

2. We do not know why Section 40 is suddenly concerned about his details being held on MOD files. Sec(AS) holds only the five letters Section 40 has sent to the Department and our five replies. 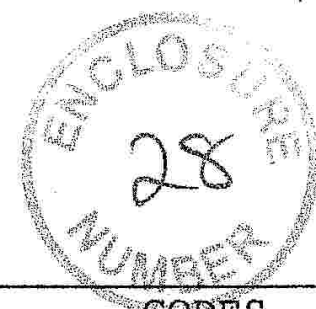

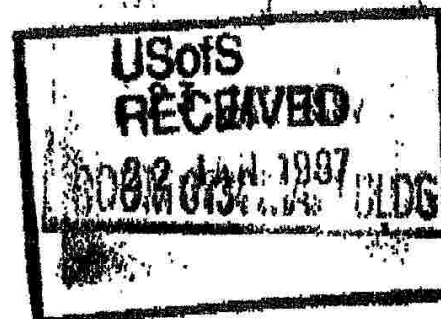

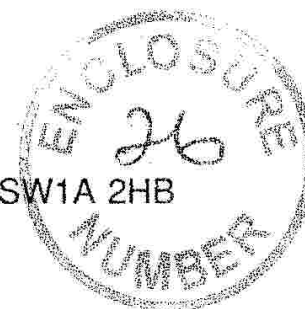

Thank you for your letter of 13 January to Michael Portillo enclosing one from **Section 40** of **Section 40** Southport about the UK Air Defence Region and uncorrelated radar returns. I am replying as this matter falls within my area of responsibility. **Section 40** also wrote direct to my officials and I hope he will accept this in reply to both his letters.

By way of background I should say that my officials wrote to **Section 40** in September last year to explain my Department's interest in 'unexplained' aerial phenomena which is limited to that required solely to establish whether what has been reported may have any defence significance.

The focal point within my Department for reports of sightings is Secretariat (Air Staff)2a and all sighting reports, whether relating to something witnessed over land or sea, are passed to them. Detailed investigation of the reports, by the appropriate experts within the Department, would only be initiated if there was some evidence to suggest that the UK Air Defence Region may have been breached.

I can confirm that there is no 'Aerospace Intelligence' branch within the Ministry of Defence, nor any separate department which deals with 'UFO' sightings at sea.

I hope this explains the situation.

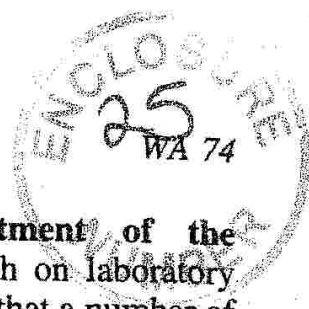

Treaty of Rome: Ministerial Advice

Lord Pearson of Rannoch asked Her Majesty's Government:

Whether they agree with the advice given on 14th December 1960 by the then Lord Chancellor, Lord Kilmuir, to the then Lord Privy Seal, the right honourable Edward Heath MP, about the effect of British sovereignty of the United Kingdom's participation in the Common Market under the Treaty of Rome.

The Minister of State, Foreign and Commonwealth Office (Baroness Chalker of Wallasey): It would not be sensible for the Government to comment on advice given by one Minister to another 36 years ago. The Government made clear in the *Partnership of Nations* White Paper that "common European decision making, as opposed to co-operation, can only be justified where it brings benefits for British security, prosperity and quality of life which are so significant that they justify some loss of unfettered national control over decision making in the area concerned, or where common action enables nation states to exercise joint control which is not open to them individually".

Pilotless Aircraft

Lord Kennet asked Her Majesty's Government:

What, if any, are the limits on the right of owners of remote-controlled unmanned aircraft (or their agents) to fly them within other countries' national air space.

The Parliamentary Under-Secretary of State, Department of Transport (Viscount Goschen): The use of pilotless aircraft is governed by Article 8 of the Chicago Convention on International Civil Aviation. This states: "No aircraft capable of being flown without a pilot shall be flown without a pilot over the territory of a contracting State without special authorisation by that State and in accordance with the terms of such authorisation. Each contracting State undertakes to ensure that the flight of such aircraft without a pilot in regions open to civil aircraft shall be so controlled as to obviate danger to civil aircraft".

Hormone Mimics

Lord Kennet asked Her Majesty's Government:

Whether, to their knowledge, the release (whether intended or unintended) of endocrine and hormone mimics into the environment is taking place; and if so, whether these have, or are suspected of having, an effect on the human genome and if, therefore, such a release is lawful.

The Minister of State, Department of the Environment (Earl Ferrers): Research on laboratory animals such as rats and fish has shown that a number of substances, both man-made and naturally occurring, have the potential to act as hormone mimics. Many of these substances are widely used in industrial processes and consumer products; some occur naturally in foods. They are therefore both present in the environment and released through processes and products.

In some circumstances such chemicals can interfere with the endocrine (hormonal) system, for example by acting like the hormone oestrogen to cause female traits to be manifest in male fish. This action does not effect the genome or the heritable material in cells. The department is not aware of any research to suggest that hormone mimics are acting in a way which would affect the human genome. Of course chemicals can have more than one type of biological activity, and substances with endocrine disrupting activities may also for example be carcinogenic and therefore be controlled for those reasons.

Releases into the environment of hazardous chemicals (including those potentially interacting with human genetic material, such as mutagens and carcinogens) are controlled under the provisions of Part I the Environmental Protection Act 1990 and the Water Resources Act 1991.

Current scientific opinion is that there is no proven link between observed trends in human reproductive health and exposure to putative hormone mimics in the environment. The question of hormone mimics is the subject of considerable research both in this country and elsewhere in Europe and in North America.

Millenium Exhibition Site

Lord Sefton of Garston asked Her Majesty's Government:

What contribution has been paid by British Gas toward clearing pollution caused by them on the proposed site of the Millennium Exhibition.

The Parliamentary Under-Secretary of State, Department of National Heritage (Lord Inglewood): I understand that British Gas is committed to meet in full the costs of cleaning up the part of the Greenwich peninsula which it owns to comply with the Environment Act 1995 and using methodology agreed with the Environment Agency. This includes the proposed site of the Millennium Exhibition.

The initial land reclamation project, paid for by British Gas, will finish on time at the end of this month, at a cost of £10.5 million.

What is the current rate of unemployment in (a) the United Kingdom, (b) the United States of America; and (c) Japan.

Thank you for your letter of 12 December to William Hague enclosing one from **Section 40** of the West Wales Paranormal Group about 'UFO sightings' on 21 November. **Section 40** also wrote in similar terms to the military staffs at the London Air Traffic Control Centre, West Drayton and I hope he will accept this as a reply to both letters.

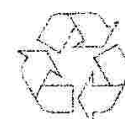
My Department examines any reports of 'UFO sightings' sent to us solely to establish whether what was seen might have some defence significance, namely, whether there was any evidence that the UK Air Defence Region might have been breached. Unless there are defence implications, and to date no 'UFO sighting' reported to us has revealed such evidence, we do not attempt to identify the precise nature of each reported sighting. From the descriptions we do receive, aircraft or natural phenomena probably account for most of the observations.

I should wish to assure **Section 40** that the integrity of the UK's airspace in peacetime is maintained through continuous policing of the UK Air Defence Region by the Royal Air Force and we remain vigilant for any potential military threat. Our enquiries reveal that on the day in question there was no unusual air defence activity, no penetration by hostile military aircraft of the UK Air Defence Region, no unknown aircraft activity on any military radars and that no Quick Reaction Alert aircraft were scrambled.

We have also checked whether the Aberporth Range was being used that day since the range danger area extends into Cardigan Bay. The Range regularly fires air-to-air missiles but, although

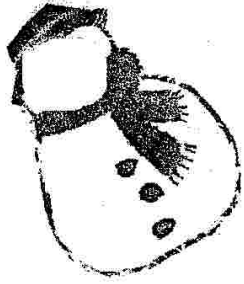

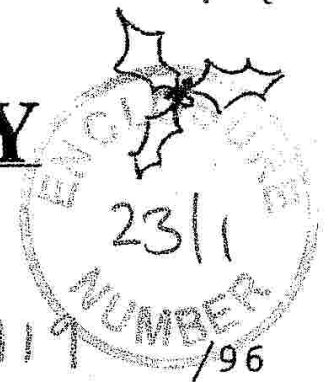

Dear Dr Williams,

I am writing to you concerning the events in Cardigan Bay and over Cardigan on the evening of Thursday 21st November 1996. I expect you may have seen the reports in the Cumbrian News and the Tivyside Advertiser, but not be aware of other witness statements that have been made to us. I also understand that BBC Radio Wales + Radio 1 carried reports on this matter but I have to admit to having missed them.

As far as we can piece together the evidence we have it would appear that there were 3 separate "UFO" events that took place locally

- ① At 4.10pm a glowing metallic object, elliptical in shape with a tail fin passed N/NE over Swansea. An eye-witness has told me that he looked at this from just off the Carmarthen Road through his binoculars that he carried in his car. The object had a hazy outline and emitted a white "smoke" trail behind it. It was moving at "airliner" speed at approx 2,000 feet. When the object passed in front of the Moon it shone more brightly than it.
- ② At 8.45pm, a triangular shape craft flew over the Teifi Estuary and then Cardigan before "shooting off like a bullet" in the direction of the Preseli Mountains. At one stage the craft emitted red and blue lights and when over Perpoze area of Cardigan was flying very low

and slowly. One witness has described how her attention was drawn to it by a loud rumbling noise she heard whilst indoors watching TV. She went out into her back garden to see a large triangular craft low overhead.

③ The light show in Cardigan Bay. At 9.10pm one witness saw what she described as a pillar of light very white, a few miles out to sea. Another witness has described how, for 2/3 seconds the entire sky lit up "as if it was day". Someone in Llangrannog informed us of there being a bright light every few seconds. A bus driver in Cardigan saw a "flash of light" then a series of lights, first blue + red, then green + yellow over a period of 10 minutes. He was also aware of crackling/static noise. Shortly after 9.50pm an editor at the Cambrian News, having previously been told about some lights out at sea was driving south from Aberystwyth when he saw an enormous "burst of white light" to his right (ie in Cardigan Bay.) I understand the Dyfed-Powys Police received a great many calls and were reported on the radio to be co-operating with the RAF + their "UFO unit". The local coastguards confirmed that there was no ship in distress and the MoD denied any military activity. The only "explanation" for the light show was "probably lightning" but none of the witnesses ever considered this a possibility due to the nature: colour, variation, frequency etc of the lights and the I phoned the Met Office who said that they had not had any reports of lightning off the Welsh coast that evening. The following day the Police contacted the first witness to say that someone in Hereford had seen an identical pillar of light at exactly the same time 9.10pm! Although the radio reports did mention sightings in the West Midlands I have been unable to find any confirmation of this.

I would like to make the following observations.

1 The West Wales Paranormal Group have received at least 25 reports of "UFO" activity in the past year and have heard of many more. These range from small 'balls of light' (which I have seen from bedroom window!) to strange "flashes" - glows to cigar, circular, triangular and simply unusual shaped craft. Some hovering, some going slowly some going really fast. Fortunately no "aliens" have been spotted and why go to some lengths to look for rational explanations for people's sightings and try + steer journalists away from their tired clichés

2] I do not believe that we are in any way a unique area in experiencing this. For example a month or so ago there was a very similar set of light 'events' off Skegness in the Wash, about which I believe Martin Redmond MP has or is going to ask questions. The triangular craft has been seen many times over the past few years - most famously over Belgium. I have heard that one such craft was seen over Synod Ior last year (but do not yet have details.)

3] The explanation of 'lightning' for the light events does not accord with the Met Office records - considering how bright, widespread + long-lasting they were I simply do not believe that such a "storm" would have been missed by the Met Office. But when it appears the RAF were unable to track track a large triangular craft flying slow + slow over Cardigan?

I would therefore like to ask you if you could do the following for me acting on behalf of all local people who have experienced the strange events:

1) Can you please find out all that you can about the investigation into the events of Thursday 21st November 1996 undertaken by the MoD "UFO unit", what evidence it gathered, whether the craft over Swansea + Cardigan were tracked and/or identified, what was in Cardigan Bay putting on the spectacular light-show + people from Aberystwyth to Cardigan (and possibly beyond.)?

If the craft over Swansea + Cardigan were identified - what was the identification, were any interceptors scrambled - or if they were "friendly" craft why did they need to announce that their 'UFO' unit was investigating them.

If the craft are "friendly" (RAF/NATO) can we have assurances that they won't be

flitting low over our part of the world again. Brightening people and causing confusion and wasting the time + energy of the police + coastguards.

However if the craft or not "friendly" (RAF/NATO) then what steps is the MoD taking to prevent such craft approaching, let alone entering UK Airspace. How can they reassure people that they do not represent a threat if they do not know what these craft are and who controls them?

4) Please support any attempts by fellow MIs to get more information about all the various type of "UFO" and related phenomena from the Government and press the Labour Party to commit itself to "No More Cover-Ups" on the UFO issue. The longer this remains a mystery and the Government and the Media refuse to take the issue seriously the greater the feeling grows that perhaps some of the wilder conspiracy theories relating to aliens and such like, might just be true!

Thank you for taking the time to read this letter. I look forward to your reply and I trust you will be able to get some sensible answers that relate to the evidence people present and not worn-out excuses that few people will believe.

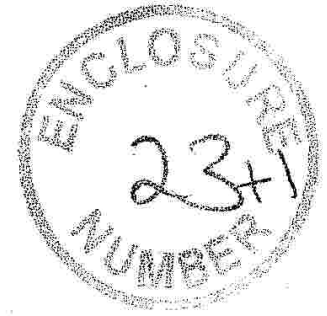

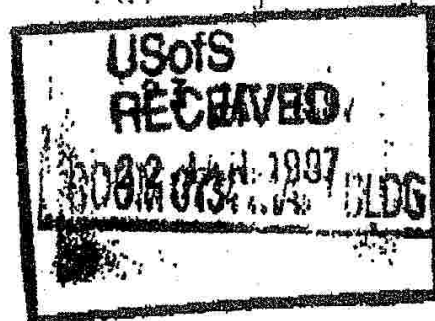

Any help or advice would be most appreciated or if you can intervene on my behalf I would be very grateful. I look forward to your reply,

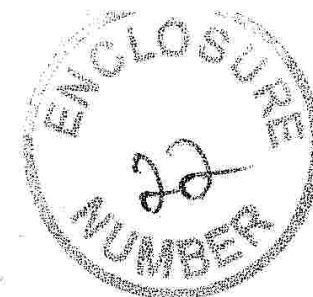

1. Mr Banks' constituent, **Section 40** , contacted Sec(AS) in September to ask about 'UFO' sightings and was advised of the limit of the Department's interest in an official action reply (Annex A).
2. It is not clear why **Section 40**  has now written to his MP since a similar letter was sent to us direct on the same day. He may have been prompted into his latest line of enquiry by the recent Martin Redmond PQs on uncorrelated radar tracks (Annex B), or his Questions about the functions of Intelligence Branches (Annex C). It may, of course, be speculation prompted by media interest in 'UFOs'.
3. Sec(AS)2a is the focal point within the MOD for all reports of 'UFO' sightings. Reports can be made direct to the desk officer concerned or, if made locally to a military establishment, they are passed on to Sec(AS)2a for action. As a matter of routine, Sec(AS)2a copies all sighting reports to the Defence Intelligence staff (DI55) for information and, where appropriate, to the Air Defence staff for evaluation.
4. There is no 'Aerospace Intelligence' branch within the DIS or the MOD. Neither is there a naval/admiralty branch dealing with 'UFO' reports. In the circumstances I attach a short draft reply for USofS to send to Matthew Banks MP setting the record straight.

Thank you for your letter of 13 January addressed to Michael Portillo enclosing one from **Section 40** of **Section 40** **Section 40** Southport about the UK Air Defence Region and uncorrelated radar returns. I am replying as the matter falls within my area of responsibility. **Section 40** also wrote direct to my officials and I hope he will accept this as a reply to both his letters.

By way of background I should say that my officials wrote to **Section 40** in September last year to explain my Department's interest in 'unexplained' aerial phenomena which is limited to that required solely to establish whether what has been reported may have any defence significance.

The focal point within my Department for reports of sightings is Secretariat (Air Staff)2a and all sighting reports, whether relating to something witnessed over land or sea, are passed to them. Detailed investigation of the reports, by the appropriate experts within the Department, would only be initiated if there was some evidence to suggest that the UK Air Defence Region may have been breached.

I can confirm that there is no 'Aerospace Intelligence' branch within the Ministry of Defence, nor any separate department which deals with 'UFO' sightings at sea.

1. I said I would write to you following our conversation earlier this week when you asked if the MOD might be able to shed any light on a "UFO" sighting you are investigating which took place on 29 Aug 96 between 2115 and 2200 hrs over Kendal, witnessed by 20 or so people.
2. As briefly explained during our telephone conversation the Ministry of Defence examines any reports of "UFO" sightings it receives solely to establish whether what was seen might have some defence significance; namely is there any evidence that the UK Air Defence Region might have been compromised by a foreign hostile military aircraft? The reports are examined, with the assistance of the Department's air defence experts as required. Unless there is evidence of a potential military threat, and to date no "UFO" sighting has revealed such evidence, we do not attempt to identify the precise nature of each sighting reported to us. We believe that down-to-earth explanations are available for most of these reported sightings.
3. First I can confirm that the MOD received only two "UFO" reports for 29 Aug 96, one in Clwyd and one in Dundee, neither were deemed to be of defence significance. With regard to the possibility of the sighting being attributed to a military aircraft/helicopter I have ascertained that as Kendal has a relatively large population it is a military low flying avoidance area. As such no military low level flying would have been permitted over Kendal and this rules this option out, unless the sighting occurred on the very outskirts of Kendal. This would not of course rule out the possibility of it being a civil helicopter.
4. The other potential option is that the shape seen was some form of advertising dirigible. Advertising balloons would of course be deliberately flown over centres of population to attract as much attention as possible. A dirigible which is manned is subject to the same air traffic regulations as other aircraft and would be required to display green and red navigation lights. This might also account for the humming sound you mentioned some

of the witnessess heard which would be caused by the light engines these balloons possess. You may in this respect care to approach the Civil Aviation Authority public relations department who should be able to advise you of the regulations governing manned advertising balloons and inform you if operators of such balloons have to seek permission from any particular authority to operate over built up areas.

Highly Indebted Poor Countries Initiative

Mr. Bill Michie: To ask the Chancellor of the Exchequer what assessment he has made of the recently agreed highly indebted poor countries initiative; and if he will make a statement. [1329]

Mrs. Angela Knight: I refer to the answer I gave to the hon. Member for Newham, North-East (Mr. Timms) on 14 October, *Official Report*, columns 705-706.

Mr. Soames: The targets were identified as Russian maritime patrol aircraft and were in the northern portion of the UK air defence region. They did not penetrate UK airspace. Information covering the period from 1979 is not held in a readily available form and could be provided only at disproportionate cost and effort.

DEFENCE**Nuclear Weapons**

Mr. Llew Smith: To ask the Secretary of State for Defence what assessment he has made of the report of the Canberra Commission on the elimination of nuclear weapons. [2931]

Mr. Soames: We have noted the conclusions of the Canberra Commission. We remain committed to the pursuit of negotiations in good faith on effective measures relating to nuclear disarmament, as set out in article VI of the nuclear non-proliferation treaty. But nuclear disarmament cannot realistically be pursued independently of the broader security context. We and NATO continue to judge that nuclear deterrence plays an essential role in maintaining peace and stability in Europe.

Unidentified Flying Objects

Mr. Redmond: To ask the Secretary of State for Defence if he will make a statement on the circumstances of the two occasions referred to in his answer of 24 July, *Official Report*, column 424, when RAF aircraft were scrambled or diverted from task to investigate uncorrelated radar targets; if the objects were identified;

Mr. Redmond: To ask the Secretary of State for Defence when United Kingdom military personnel were briefed about the scrambling of Belgian F-16 aircraft on 30 and 31 March 1990; when the unidentified flying object concerned was detected on United Kingdom radar systems; and if RAF aircraft were scrambled. [3185]

Mr. Soames: The Belgian authorities did not notify adjacent countries because no threat was perceived. There is no evidence of radar contacts within the UK air defence system.

Radiation

Mr. Redmond: To ask the Secretary of State for Defence if the radiation readings, reported to his Department by Lieutenant Colonel Charles Halt on 13 January 1981, were judged to have posed any threat to Lieutenant Colonel Halt and his team; who assessed the readings; how the radiation compared with background radiation in the area; and if he will make a statement. [2934]

Mr. Soames: There is no record of any official assessment of the radiation readings reported by Lieutenant Colonel Halt.

DEFENCE

Plutonium

Mr. Llew Smith: To ask the Secretary of State for Defence if the United States Government have since 1966 requested the United Kingdom to provide reactor grade plutonium for the purpose of conducting a nuclear test explosion under the provisions of the US-UK mutual defence agreement on atomic energy co-operation. [38500]

Mr. Arbuthnot: No such requests have been made by the United States.

Small Businesses

Mr. David Shaw: To ask the Secretary of State for Defence if he will make a statement on the impact of (a) his policies and (b) the work of his Department in helping small businesses in the last 12 months as against the previous 12 months; and if he will publish the performance indicators by which his Department monitors the impact and the statistical results of such monitoring. [39141]

Mr. Arbuthnot: The Government recognise the crucial role played by small firms in the UK economy and aim to help them by providing sound economic conditions—keeping inflation and interest rates low; reducing legislative administrative and taxation burdens; and where appropriate provide direct assistance in the form of specialist advice and support and easing access to finance.

My Department supports the DTI's small business measures and initiatives. I am the Minister within this Department for small businesses and I attend or am represented at the DTI's regular meetings.

The Defence Suppliers Service assists companies, including small businesses, in making contact with appropriate contracts branches. It also arranges for details of many forthcoming tenders to be published in the fortnightly MOD *Contracts Bulletin* which is available to any interested party on subscription. This enables small businesses either to seek to tender directly for specific requirements or, more commonly, to become sub-contractors to larger companies.

Since the Procurement Executive of the Ministry of Defence moved to the new procurement headquarters at Heywood near Bristol earlier this year, the Defence Suppliers Service is in contact with the Bristol chamber of commerce and DTI's business links, whose South-west regional supply network office has become their national focal point for the defence industry. Other areas of the country can reach my Department, and be reached by us, through the business links network.

As much of the assistance provided by my Department to small businesses tends to be in the sub-contractor sector, it is not possible to establish suitable performance parameters and therefore no statistics are available.

Rendlesham Forest (Incident)

Mr. Redmond: To ask the Secretary of State for Defence (1) what response his Department made to the report submitted by Lieutenant Colonel Charles Halt

relating to events in Rendlesham forest in December 1980; what interviews were held; and if he will make a statement; [39247]

(2) who assessed that the events around RAF Woodbridge and RAF Bentwaters in December 1980, which were reported to his Department by Lieutenant Colonel Charles Halt were of no defence significance; on what evidence the assessment was made; what analysis of events was carried out; and if he will make a statement. [39249]

Mr. Soames: The report was assessed by the staff in my Department responsible for air defence matters. Since the judgment was that it contained nothing of defence significance no further action was taken.

Uncorrelated Radar Tracks (Investigations)

Mr. Redmond: To ask the Secretary of State for Defence on how many occasions RAF aircraft have been (a) scrambled and (b) diverted from task to investigate uncorrelated targets picked up on radar; and if he will make a statement. [39218]

Mr. Soames: In the past five years RAF aircraft have been scrambled or diverted from task on two occasions to intercept and identify uncorrelated radar tracks entering the United Kingdom air defence region.

Unidentified Craft

Mr. Redmond: To ask the Secretary of State for Defence (1) what is his Department's assessment of the incident that occurred on 5 November 1990 when a patrol of RAF Tornado aircraft flying over the North sea were overtaken at high speed by an unidentified craft; and if he will make a statement; [39245]

(2) if he will make a statement on the unidentified flying object sighting reported to his Department by the meteorological officer at RAF Shawbury in the early hours of 31 March 1993. [39246]

Mr. Soames: Reports of sightings on these dates are recorded on file and were examined by staff responsible for air defence matters. No firm conclusions were drawn about the nature of the phenomena reported but the events were not judged to be of defence significance.

Mr. Redmond: To ask the Secretary of State for Defence what assessment his Department made of the photograph of an unidentified craft at Calvine on 4 August 1990; who removed it from an office in secretariat (air staff) 2a; for what reasons; and if he will make a statement. [39248]

Mr. Soames: A number of negatives associated with the sighting were examined by staff responsible for air defence matters. Since it was judged that they contained nothing of defence significance the negatives were not retained and we have no record of any photographs having been taken from them.

Publicity

Ms Hodge: To ask the Secretary of State for Defence what is his Department's budget in 1996-97 for consultants to assist with information, publicity, press and media. [39353]

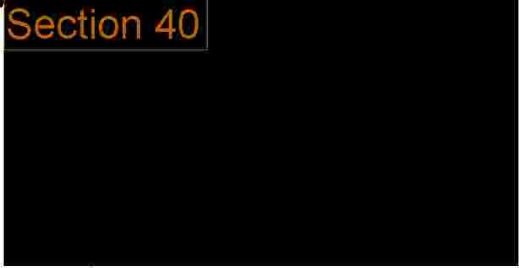

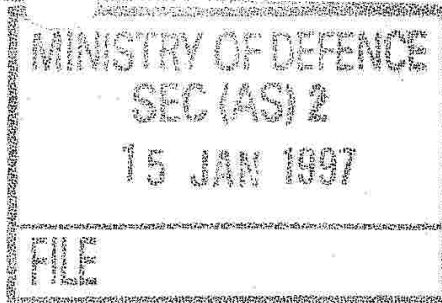

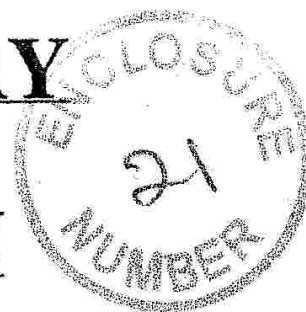

"I am sorry to send what I know will be a disappointing reply."

Deadlines If, exceptionally, you cannot meet the deadline let me know at once - an interim reply might be needed.

Departmental action Action on the same case should be held until the Minister has sent a full reply.

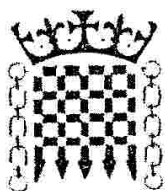

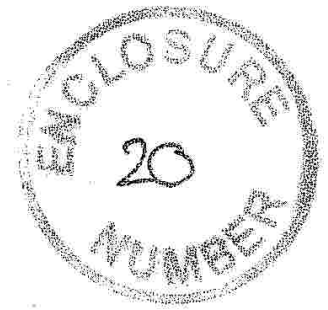

1. I said I would write to you following our conversation earlier this week when you asked if the MOD might be able to shed any light on a "UFO" sighting you are investigating which took place on 29 Aug 96 between 2115 and 2200 hrs over Kendal, witnessed by 20 or so people.
2. As briefly explained during our telephone conversation the Ministry of Defence examines any reports of "UFO" sightings it receives solely to establish whether what was seen might have some defence significance; namely is there any evidence that the UK Air Defence Region might have been compromised by a foreign hostile military aircraft? The reports are examined, with the assistance of the Department's air defence experts as required. Unless there is evidence of a potential military threat, and to date no "UFO" sighting has revealed such evidence, we do not attempt to identify the precise nature of each sighting reported to us. We believe that down-to-earth explanations are available for most of these reported sightings.
3. First I can confirm that the MOD received only two "UFO" reports for 29 Aug 96, one in Clwyd and one in Dundee, neither were deemed to be of defence significance. With regard to the possibility of the sighting being attributed to a military aircraft/helicopter I have ascertained that as Kendal has a relatively large population it is a military low flying avoidance area. As such no military low level flying would have been permitted over Kendal and this rules this option out, unless the sighting occurred on the very outskirts of Kendal. This would not of course rule out the possibility of it being a civil helicopter.
4. The other potential option is that the shape seen was some form of advertising dirigible. Advertising balloons would of course be deliberately flown over centres of population to attract as much attention as possible. A dirigible which is manned is subject to the same air traffic regulations as other aircraft and would be required to display green and red navigation lights. This might also account for the humming sound you mentioned some

of the witnessess heard which would be caused by the light engines these balloons possess. You may in this respect care to approach the Civil Aviation Authority public relations department who should be able to advise you of the regulations governing manned advertising balloons and inform you if operators of such balloons have to seek permission from any particular authority to operate over built up areas.

Mr. Bill Michie: To ask the Chancellor of the Exchequer what assessment he has made of the recently agreed highly indebted poor countries initiative; and if he will make a statement. [1329]

Mrs. Angela Knight: I refer to the answer I gave to the hon. Member for Newham, North-East (Mr. Timms) on 14 October, *Official Report*, columns 705–706.

Mr. Soames: The targets were identified as Russian maritime patrol aircraft and were in the northern portion of the UK air defence region. They did not penetrate UK airspace. Information covering the period from 1979 is not held in a readily available form and could be provided only at disproportionate cost and effort.

DEFENCE**Nuclear Weapons**

Mr. Llew Smith: To ask the Secretary of State for Defence what assessment he has made of the report of the Canberra Commission on the elimination of nuclear weapons. [2931]

Mr. Soames: We have noted the conclusions of the Canberra Commission. We remain committed to the pursuit of negotiations in good faith on effective measures relating to nuclear disarmament, as set out in article VI of the nuclear non-proliferation treaty. But nuclear disarmament cannot realistically be pursued independently of the broader security context. We and NATO continue to judge that nuclear deterrence plays an essential role in maintaining peace and stability in Europe.

Unidentified Flying Objects

Mr. Redmond: To ask the Secretary of State for Defence if he will make a statement on the circumstances of the two occasions referred to in his answer of 24 July, *Official Report*, column 424, when RAF aircraft were scrambled or diverted from task to investigate uncorrelated radar targets; if the objects were identified;

Mr. Redmond: To ask the Secretary of State for Defence when United Kingdom military personnel were briefed about the scrambling of Belgian F-16 aircraft on 30 and 31 March 1990; when the unidentified flying object concerned was detected on United Kingdom radar systems; and if RAF aircraft were scrambled. [3185]

Mr. Soames: The Belgian authorities did not notify adjacent countries because no threat was perceived. There is no evidence of radar contacts within the UK air defence system.

Radiation

Mr. Redmond: To ask the Secretary of State for Defence if the radiation readings, reported to his Department by Lieutenant Colonel Charles Halt on 13 January 1981, were judged to have posed any threat to Lieutenant Colonel Halt and his team; who assessed the readings; how the radiation compared with background radiation in the area; and if he will make a statement. [2934]

Mr. Soames: There is no record of any official assessment of the radiation readings reported by Lieutenant Colonel Halt.

DEFENCE

Plutonium

Mr. Llew Smith: To ask the Secretary of State for Defence if the United States Government have since 1966 requested the United Kingdom to provide reactor grade plutonium for the purpose of conducting a nuclear test explosion under the provisions of the US-UK mutual defence agreement on atomic energy co-operation. [38500]

Mr. Arbuthnot: No such requests have been made by the United States.

Small Businesses

Mr. David Shaw: To ask the Secretary of State for Defence if he will make a statement on the impact of (a) his policies and (b) the work of his Department in helping small businesses in the last 12 months as against the previous 12 months; and if he will publish the performance indicators by which his Department monitors the impact and the statistical results of such monitoring. [39141]

Mr. Arbuthnot: The Government recognise the crucial role played by small firms in the UK economy and aim to help them by providing sound economic conditions—keeping inflation and interest rates low; reducing legislative administrative and taxation burdens; and where appropriate provide direct assistance in the form of specialist advice and support and easing access to finance.

My Department supports the DTI's small business measures and initiatives. I am the Minister within this Department for small businesses and I attend or am represented at the DTI's regular meetings.

The Defence Suppliers Service assists companies, including small businesses, in making contact with appropriate contracts branches. It also arranges for details of many forthcoming tenders to be published in the fortnightly MOD *Contracts Bulletin* which is available to any interested party on subscription. This enables small businesses either to seek to tender directly for specific requirements or, more commonly, to become sub-contractors to larger companies.

Since the Procurement Executive of the Ministry of Defence moved to the new procurement headquarters at Abbey Wood near Bristol earlier this year, the Defence Suppliers Service is in contact with the Bristol chamber of commerce and DTI's business links, whose South-west regional supply network office has become their national focal point for the defence industry. Other areas of the country can reach my Department, and be reached by us, through the business links network.

As much of the assistance provided by my Department to small businesses tends to be in the sub-contractor sector, it is not possible to establish suitable performance parameters and therefore no statistics are available.

Rendlesham Forest (Incident)

Mr. Redmond: To ask the Secretary of State for Defence (1) what response his Department made to the report submitted by Lieutenant Colonel Charles Halt

relating to events in Rendlesham forest in December 1980; what interviews were held; and if he will make a statement; [39247]

(2) who assessed that the events around RAF Woodbridge and RAF Bentwaters in December 1980, which were reported to his Department by Lieutenant Colonel Charles Halt were of no defence significance; on what evidence the assessment was made; what analysis of events was carried out; and if he will make a statement. [39249]

Mr. Soames: The report was assessed by the staff in my Department responsible for air defence matters. Since the judgment was that it contained nothing of defence significance no further action was taken.

Uncorrelated Radar Tracks (Investigations)

Mr. Redmond: To ask the Secretary of State for Defence on how many occasions RAF aircraft have been (a) scrambled and (b) diverted from task to investigate uncorrelated targets picked up on radar; and if he will make a statement. [39218]

Mr. Soames: In the past five years RAF aircraft have been scrambled or diverted from task on two occasions to intercept and identify uncorrelated radar tracks entering the United Kingdom air defence region.

Unidentified Craft

Mr. Redmond: To ask the Secretary of State for Defence (1) what is his Department's assessment of the incident that occurred on 5 November 1990 when a patrol of RAF Tornado aircraft flying over the North sea were overtaken at high speed by an unidentified craft; and if he will make a statement; [39245]

(2) if he will make a statement on the unidentified flying object sighting reported to his Department by the meteorological officer at RAF Shawbury in the early hours of 31 March 1993. [39246]

Mr. Soames: Reports of sightings on these dates are recorded on file and were examined by staff responsible for air defence matters. No firm conclusions were drawn about the nature of the phenomena reported but the events were not judged to be of defence significance.

Mr. Redmond: To ask the Secretary of State for Defence what assessment his Department made of the photograph of an unidentified craft at Calvine on 4 August 1990; who removed it from an office in secretariat (air staff) 2a; for what reasons; and if he will make a statement. [39248]

Mr. Soames: A number of negatives associated with the sighting were examined by staff responsible for air defence matters. Since it was judged that they contained nothing of defence significance the negatives were not retained and we have no record of any photographs having been taken from them.

1. Mr Banks' constituent, **Section 40** contacted Sec(AS) in September to ask about 'UFO' sightings and was advised of the limit of the Department's interest in an official action reply (Annex A - currently Enclosure ^{TWO} ~~ONE~~).
2. It is not clear why **Section 40** has now written to his MP since a similar letter was sent to us direct on the same day. He may have been prompted into his latest line of enquiry by the recent Martin Redmond PQs on uncorrelated radar tracks (Annex B), or his Questions about the functions of Intelligence Branches (Annex C). It may, of course, be speculation prompted by media interest in 'UFOs'.
3. Sec(AS)2a is the focal point within the MOD for all reports of 'UFO' sightings. Reports can be made direct to the desk officer concerned or, if made locally to a military establishment, they are passed on to Sec(AS)2a for action. As a matter of routine, Sec(AS)2a copies all sighting reports to the Defence Intelligence staff (DI55) for information and, where appropriate, to the Air Defence staff for evaluation.
4. There is no 'Aerospace Intelligence' branch within the DIS or the MOD. Neither is there a naval/admiralty branch dealing with 'UFO' reports. In the circumstances I attach a short draft reply for USofs to send to Matthew Banks MP setting the record straight.

Thank you for your letter of 13 January addressed to Michael Portillo enclosing one from **Section 40** of **Section 40** **Section 40** Southport about the UK Air Defence Region and uncorrelated radar returns. I am replying as the matter falls within my area of responsibility. **Section 40** also wrote direct to my officials and I hope he will accept this as a reply to both his letters.

By way of background I should say that my officials wrote to **Section 40** in September last year to explain my Department's interest in 'unexplained' aerial phenomena which is limited to that required solely to establish whether what has been reported may have any defence significance.

The focal point within my Department for reports of sightings is Secretariat (Air Staff)2a and all sighting reports, whether relating to something witnessed over land or sea, are passed to them. Detailed investigation of the reports, by the appropriate experts within the Department, ^{would only be} ~~is~~ ^{if} initiated ^{only} where there ^{is} ~~is~~ ^{was} some evidence to suggest that the UK air defence region ^{may have} ~~has~~ been breached.

I can confirm that there is no 'Aerospace Intelligence' branch within the Ministry of Defence, ^{nor any separate department}

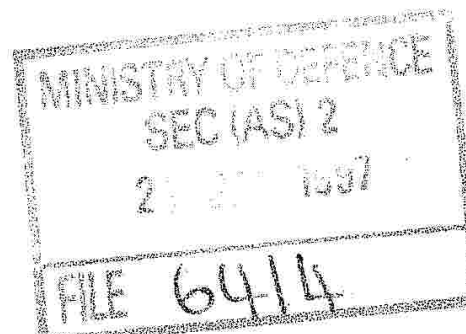

Training also stresses that there is no substitute for a comprehensive visual check of the surrounding sky, even when aided by on-board or ground-based technology designed to alert pilots to danger. Initial training is followed up by regular coverage of this topic in aviation publications, including the Civil Aviation Authority's own General Aviation Safety Information Leaflets, one of which deals specifically with the avoidance of collision by correct visual techniques.

Advice and training given to the private pilot is enhanced for professional pilots by training in crew resource management to ensure best use of the available crew to meet all flight deck tasks adequately, including visual lookout.

Should these technical and visual safeguards fail, pilots are required to report any situation where they considered that there was a risk to the safety of the aircraft caused by the close proximity of another, particularly if no warning was received. These reports, known as Aircraft Proximity Reports or 'AIRPROX', are investigated by the Joint AIRPROX Advisory Panel - a group of experts drawn from CAA, all sides of the industry and the military. The circumstances and Panel's findings are published regularly by the Authority and are circulated to all areas of the aviation community.

I trust that this information adequately answers your question to the Secretary of State.

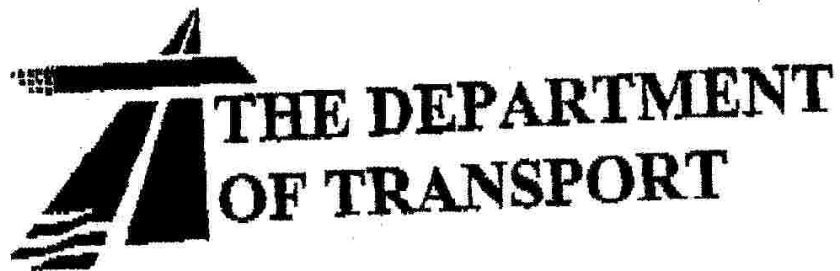

You asked what assessment had been made of the benefits of retaining an on-site presence at BOD Donnington and Chetwynd Barracks until APTs are fully established. The requirement for Ministry of Defence Police is made by discussion between the Establishment, the budget holder and the Chief Constable, taking into account the views of specialist complementing teams. This procedure has been undertaken for BOD Donnington and Childwell/Chetwynd Barracks, amongst others, and considered the best and most economical means of meeting those requirements without lowering in any way the necessary security standards.

You asked which establishments are to be covered by the APT to be based at Chilwell/Chetwynd Barracks. The Area Policing Team based there will cover those Ministry of Defence establishments within reasonable range of their base, and give assistance according to the assessed priorities on the calls on their time.

You wished to know the authorised complements for the APTs proposed for Dishforth, Donnington and Chilwell. The APT complements at Donnington and Chilwell will each be 11 officers; and in addition 8 MDP officers will be retained at Donnington for policing duties. No decisions have yet been taken on Dishforth.

Mr. Tipping: To ask the Secretary of State for Defence (1) from which budget holders the funding for (a) the Ministry of Defence police area policing teams at Chilwell/Chetwynd barracks and (b) the Military Provost guard service at Chilwell/Chetwynd barracks will be provided in 1997-98; [9691]

(2) what consent has been (i) sought and (ii) received from the chief constable of Nottinghamshire constabulary in respect of (a) armed and (b) unarmed off-base patrols by the Military Provost guard service at Chilwell/Chetwynd barracks; [9694]

(3) what anti-terrorist patrols will be included in the off-base activities of the Military Provost guard service at Chilwell/Chetwynd barracks. [9695]

Mr. Soames: I will write to the hon. Member and a copy of my letter will be placed in the Library of the House.

Nuclear Weapons

Mr. Cohen: To ask the Secretary of state for Defence what has been the total cost in each of the last five years, for acquiring and operating nuclear weapons and their delivery systems. [9670]

Mr. Arbuthnot: The strategic nuclear deterrent is the UK's only dedicated nuclear weapon delivery system. I refer the hon. Member to the Trident procurement and Polaris and Trident operating costs for 1991-92 and 1992-93 given in answer to the hon. Member for Wakefield (Mr. Hinchliffe) on 27 October 1993, *Official Report*, column 702), for 1994-95 given in answer to the hon. member for Tooting (Mr. Cox) on 6 March 1996, *Official Report*, column 232 and for 1995-96 given in answer to the hon. Member for Meirionnydd Nant Conwy (Mr. Llwyd) on 26 November 1996, *Official Report*, column 193. The figure for 1993-94 is £1,082 million. The operating costs of the WE177 free-fall nuclear bomb and the Lance nuclear artillery system, which was withdrawn from service in 1992-93, are not recorded separately.

Great Lakes Region

Mr. Luff: To ask the Secretary of State for Defence, pursuant to his oral statement of 14 November, *Official report*, column 487-89 what contribution United Kingdom forces have made to the resolution of the humanitarian crisis in the great lakes region; and if he will make a statement. [10399]

Mr. Soames: British forces deployed to the region have made an extremely valuable contribution to the action taken by the international community. The Canberra PR9 has flown 24 sorties, playing a pivotal role in determining the precise location and numbers of refugee groups in eastern Zaire. Our liaison personnel in Rwanda have provided unique information about the situation on the ground, and have assisted in the co-ordination of work in the area.

Substantial numbers of refugees have returned home to Rwanda, and aid agencies now enjoy greater ease of access to eastern Zaire. In the light of the dramatic change in the humanitarian situation, the steering group overseeing the multinational mission to the region has recommended to the UN Secretary-General that the multinational force be withdrawn by 31 December. The focus now must be on efforts to obtain wider access for the aid agencies on the ground and to enable them to assess the scale and nature of humanitarian needs and how these can best be met.

Our forces in the region will accordingly return to the UK this week. Our international partners are making similar plans for the withdrawal of their own forces.

The UK will continue to lend full support to the humanitarian mission in the region and to regional efforts to find a lasting political solution. In that context we welcome the outcome of the Nairobi summit of 16 and 17 December.

Convicted Soldiers (Cyprus)

Mr. Cox: To ask the Secretary of State for Defence what Army pension payments will be made to each of the three soldiers convicted of the manslaughter of the Danish tour guide in Cyprus; when such payments will commence; and what is the current value of such pensions. [8639]

Mr. Soames: I can confirm that the three former soldiers had accrued sufficient military service to qualify for a preserved Army pension, which will be payable from their 60th birthday. Under the code of access to Government information, it is not our policy to release information relating to an individual's financial affairs on the grounds that to do so without their consent could facilitate an unwarranted invasion of privacy.

Unidentified Craft

Mr. Ieuan Wyn Jones: To ask the Secretary of state for Defence if his Department will adopt a policy on the reporting of unidentified craft of releasing to the press details of (i) shape, flight-pattern, colour and size of craft, (ii) where and when the craft was seen, (iii) what action his Department took and (iv) the radar profile of the craft. [9410]

Mr. Soames: No.

Mr. Jones: To ask the secretary of State for Defence what assessment his Department has made of the incident on 16 October 1990 involving two unidentified craft in the vicinity of Wylfa nuclear power station on Anglesey; what estimate the intercepting helicopter pilots made of the departing speeds of the two unidentified craft; if they showed up on radar; and if he will make a statement. [9561]

Mr. Soames: None, so far as we can establish from existing records.

Mr. Jones: To ask the Secretary of State for Defence what assessment his Department has made of the two attempted interceptions of unidentified craft that occurred near Anglesey in September and November 1995; what other attempts have been made to intercept unidentified craft in this vicinity; and if he will make a statement [9562]

Mr. Soames: From records available, and from the limited information given in the question, we are unable to identify any incidents of this kind.

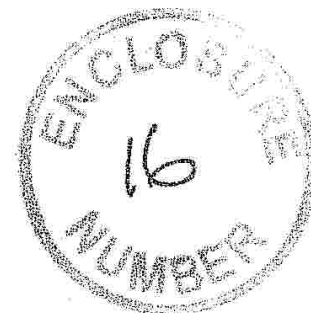

LETTER FROM DR ALAN WILLIAMS - US 5119/96

1. Dr Williams constituent, **Section 40**, is seeking information on alleged 'UFO' events in the Cardigan Bay area on 21st November and, assuming these events to be soundly based, poses a number of questions about them. He gives weight to this assumption by commenting that:

- Dyfed-Powys police were reported to be co-operating with the RAF and their 'UFO unit';
- MOD denied there was any military activity in the area.

Section 40 wrote in similar terms to the military staff at the London Air Traffic Control Centre, West Drayton seeking information about what they had observed on their radar.

2. The Air Defence Staffs have confirmed that on the day in question there was no unusual air defence activity, no penetration of the UK Air Defence Region, no unknown aircraft activity on any military radars and that no Quick Reaction Alert aircraft (QRAs) were scrambled. Three reports of alleged 'UFO' sightings were received by Sec(AS) for 21st November but these were for the Twickenham area, two-three miles off Newhaven/Brighton, and Althorpe near Scunthorpe. There were no reports from, or about, the Cardigan Bay area.

3. The Aberporth Range danger area extends into Cardigan Bay and the Range regularly fires air-to-air missiles (on average two each week). On 21st November two missiles were fired, the first at 10.45 and the second at 15.29. Neither of these firings accord with the timings of the reported 'UFO' sightings and we cannot, therefore, suggest any connection.

4. **Section 40** mentions Martin Redmond's interest in the 'events' last year off Skegness and The Wash. Mr Redmond wrote, at length, about the effectiveness of the UK air defence system following media reports of 'UFO sightings' in the area on 5th October. Much of this reporting was media hype. USofs replied to Mr Redmond (copy attached for information) and the content of this letter is known in 'ufologist' circles. **Section 40** should, by now, be aware of what was said and we consider there is no need to resurrect this issue.

5. As is usual with reports of this nature (and Sec(AS) received some 600 reports last year), the draft reply (attached) simply sets out the MOD position in respect of 'UFO' sightings. Where it is clearly the case that there is no threat to the UKADR, no attempt is made to investigate what the witnesses might have seen.

D/USofs/FH/5119/96

Thank you for your letter of 19th December enclosing one from **Section 40** of the West Wales Paranormal Group about 'UFO sightings' on 21st November. **Section 40** also wrote in similar terms to the military staffs at the London Air Traffic Control Centre, West Drayton and I hope he will accept this as a reply to both letters.

My Department examines any reports of 'UFO sightings' sent to us solely to establish whether what was seen might have some defence significance, namely, whether there was any evidence that the UK Air Defence Region might have been breached. Unless there are defence implications, and to date no 'UFO sighting' reported to us has revealed such evidence, we do not attempt to identify the precise nature of each reported sighting. From the descriptions we do receive, aircraft or natural phenomena probably account for most of the observations.

I should wish to assure **Section 40** that the integrity of the UK's airspace in peacetime is maintained through continuous policing of the UK Air Defence Region by the Royal Air Force and we remain vigilant for any potential military threat. Our enquiries reveal that on the day in question there was no unusual air defence activity, no penetration by hostile military aircraft of the UK Air Defence Region, no unknown aircraft activity on any military radars and that no Quick Reaction Alert aircraft were scrambled.

We have also checked whether the Aberporth Range was being used that day since the range danger area extends into Cardigan Bay. The Range regularly fires air-to-air missiles but, although on 21st November two missiles were fired, the timings do not accord with the events documented by [Section 40](#)

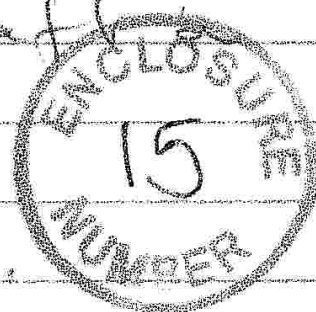

Dear Mr. Redmond,

Nicholas Soames undertook to write to you in his reply to your recent Parliamentary Questions about UFOs. (Official Report, cols 1092-1093 and 1095, copies attached). I am replying as this matter falls within my area of responsibility.

The MOD's interest in 'unexplained' aerial phenomena (Question 1) is limited to whether the UK Air Defence Region might have been compromised. Unless there is any evidence that this is the case, and to date no sighting has provided such evidence, we do not investigate further or seek to provide an explanation for what might have been observed. We have no expertise or role with respect to 'UFO/flying saucer' matters and, so far as the existence or otherwise of extraterrestrial lifeforms is concerned, we remain open minded but know of nothing that proves they exist. Our policy in this respect has not changed during the last thirty years.

RAF Standing Instructions (Question 2) require all RAF Station Commanders to forward reports of all 'UFO' sightings whether made by members of the public or on-duty Service personnel to the Secretariat (Air Staff), Branch 2a. Sec(AS)2a look at all 'UFO' sighting reports (Question 3) whether military or civilian reported. Reports are assessed in consultation with other MOD branches as required to determine whether there is any defence interest in what has been reported. Over the last twelve months there has been one instance of an on-duty member of the Services reporting an 'unexplained' aerial sighting, and this was not judged to be of any significance.

We have no evidence (Question 4) that any structured craft of unknown origin has penetrated the UK's Air Defence Region. I am unable to provide the information you seek about reports of alleged landings (Question 5) since records are maintained only of 'UFO' sighting reports which are not broken down further into specific categories.

You ask at Questions 2a, 2b and 6-12 about collaboration and consultation with a number of foreign governments. My Department has regular discussions with a number of countries on a wide range of topics of mutual interest but such discussions have not extended to 'UFO/flying saucer' issues or the existence or otherwise of extraterrestrial life forms.

I can confirm (Question 13) that my Department's Scientific Intelligence Branch holds no records under extended closure for any period in excess of 30 years. So far as the information sought at Question 14 is concerned, the PRO has confirmed that the class list giving details of preserved records is available to researchers at Kew.

Finally, I can also confirm (Question 15) that there is no unit within the Flying Complaints Flight (FCF) based at RAF Rudloe Manor (or anywhere else) specialising in investigations into unidentified flying objects. I should add that despite continuing misunderstandings about the role of RAF Rudloe Manor in alleged 'UFO' investigations, the Station is not and never has been involved in this way.

BACKGROUND - POS 2747H, 2748H, 2753H, 2757H

1. Mr Ieuan Wyn Jones MP has tabled four PQs on 'UFO'-related issues.

2. Since March 1996 the MP has written three times, either forwarding correspondence, or on behalf of, a constituent, **Section 40** **Section 40** who is a member of a local group of 'UFO' enthusiasts calling themselves the "Wales Federation of Independent Ufologists". **Section 40** regularly writes direct to Sec(AS) and recently sought the Department's endorsement of his recommendation to the Royal Society of Chemistry that they should establish a scientific division to investigate 'Anomalous Aerial Phenomena'. **Section 40** is, apparently, a Research and Development Chemist for a local Chemical company. As the PQs mirror the content of the Parliamentary Enquiries arising from **Section 40** it is likely they have been tabled as a result of his contacts with the MP.

3. PQ 2753H - In an answer given to a question tabled by Martin Redmond MP in October (Official Report attached at Annex A), the Prime Minister made it clear that he has no plans to allocate resources to researching extraterrestrial phenomena. The answer given to this PQ maintains the previous line.

4. PQ 2747H - Mr Jones is aware of the Department's policy on reports of 'UFO' sightings, most recently set out in a letter to him from USofS dated 9 Oct 96 (copy attached at Annex B, Tab A). There are no plans to alter that policy and we believe a more substantive answer is not required.

5. PQ 2748H - Mr Jones wrote to Ministers in October about the 16th October 1990 sighting which allegedly occurred near Wylfa Power Station on Anglesey. A copy of his letter is at Annex B, Tab B. There were two Wessex squadrons operating at RAF Valley in 1990, 22 Sqn and the Search and Rescue Training Unit (SARTU). At

1930 hrs on the evening in question, records show that 22 Sqn were not operating. SARTU records no longer exist but, because of the nature of their task, it would have been highly unlikely that any of their helicopters would have been airborne. However, the area in question is a SARTU training area and without records it is simply not possible to determine whether a helicopter might have been in the area at that time. It certainly would not have been 'scrambled' for interception purposes. From surviving local records there is no evidence to support the claim of an alleged incident and, as such, that any assessment was ever made by the Department. The PQ answer therefore reflects this position.

6. PO 2757H - Although specific dates have not been given in the PQ, the Station Commander at RAF Valley received a letter (Annex C, Tab A) from the MP about a report of a 'UFO' sighting on 4 Nov 95. USofS replied (Annex C, Tab B) that there was no evidence to support a sighting of air defence interest. There has been no previous interest by the MP in an alleged sighting for Sep 95. The air defence staffs have confirmed that no Quick Reaction Alert aircraft were scrambled for practice or real operations on the West Coast during September or November 1995, although QRA aircraft were scrambled for no-notice missile firing at Aberporth Range on 7 Sep 95 and 22 Nov 95 respectively. Without precise dates from the MP it is simply not possible to provide a more detailed answer to his question.

Radioactive Scale (Disposal)

Mr. Meacher: To ask the Secretary of State for the Environment what provisions exist for the offshore disposal of radioactive scale arising from oil exploration and drilling in the North sea and Atlantic. [41251]

Mr. Clappison: Discharge of naturally radioactive scale from oil exploration and drilling in UK waters is regulated under the Radioactive Substances Act 1993, as amended. The Environment Agency is the regulator for the English and Welsh sectors. The Scottish Environment Protection Agency is the regulator for the Scottish sector.

World Conservation Congress

Mr. Meacher: To ask the Secretary of State for the Environment what contribution his Department made to the World Conservation Congress held in Montreal this month; if his Department was represented at the congress; and what plans he has to assess the conclusions of the congress. [41252]

Mr. Clappison: The UK is a state member of the International Union for the Conservation of Nature and Natural Resources. Officials from my Department are leading the UK delegation at the World Conservation Congress which began on 13 October and will finish on 23 October. My Department contributed towards the costs of the UK IUCN committee's report on the UK's contribution to IUCN 1994 to 1996, which will be launched during the congress.

PRIME MINISTER

Government Policies

Mr. Milburn: To ask the Prime Minister what are his latest estimates of the expenditure on all external consultants, including management consultants, for each year since 1992, in 1996 prices, for his Department and its agencies; and what are the quantified annual cost savings which such expenditure has resulted in. The Prime Minister: For these purposes my Office is part of the Cabinet Office, Office of Public Service. My right hon. Friend the Chancellor of the Duchy of Lancaster will write to the hon. Member.

Unidentified Flying Objects

Mr. Redmond: To ask the Prime Minister if he will allocate to a department the assessments of the non-air defence implications associated with unidentified flying objects; and if he will make a statement. [40822]

The Prime Minister: The air defence and air traffic implications of unidentified flying objects are the responsibility of the Ministry of Defence and the Civil Aviation Authority respectively. The Government have no plans to allocate resources to researching extraterrestrial phenomena.

Terrorist Damage

Mr. Soley: To ask the Prime Minister if he will extend the Northern Ireland compensation scheme for terrorist attacks to mainland Britain. [40934]

The Prime Minister: I refer the hon. Gentleman to the reply given to the hon. Member for Manchester, Blackley (Mr. Eastham), by my hon. Friend the Minister for Trade on 27 June 1996, *Official Report*, column 202.

New Buildings and Premises

Mrs. Bridget Prentice: To ask the Prime Minister what was the total expenditure on new buildings and premises by his Department and its agencies; and if he will indicate the square footage of new office space purchased or newly rented in each of the last five years. [41148]

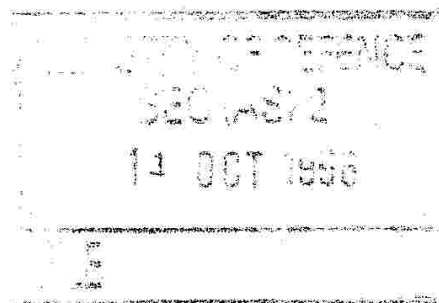
Thank you for your letter of 24 September (reference: IWJ/2/96/36) to Michael Portillo enclosing one from your constituent, **Section 40** of **Section 40**, Beaumaris, about "unidentified flying objects". I am replying as this matter falls within my area of responsibility.

As you may know, my Department examines any reports of "UFO" sightings sent to us solely to establish whether what was seen might have some defence significance, namely, whether there was any evidence that the UK Air Defence Region might have been compromised by a hostile foreign military aircraft. Unless there are defence implications, and to date no "UFO" sighting reported to us has revealed such evidence, we do not attempt to identify the precise nature of each reported sighting. From the types of descriptions we receive, however, aircraft or natural phenomena probably account for most of the observations.

Enquiries have revealed that as **Section 40** telephone call to RAF Valley was made outside routine working hours, a record of his call would have been logged in the Station Duty Officer's Report. However, Station Duty Officer's Reports are not kept indefinitely but routinely destroyed and Reports for 1990 are no longer available.

You may wish to be aware that we do not routinely contact or reply to every witness who reports a "UFO" sighting to us (on average the Department receives 200-300 such reports annually). Such contact is only necessary if what has been seen has a defence interest and it is necessary to interview the witness further.

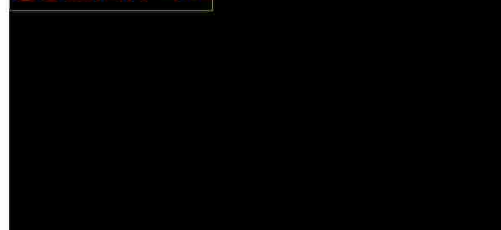
1. The attached is the second "UFO" PE received from Ieuan Wyn Jones in four weeks on behalf of **Section 40**. A further "UFO" PE was received from the MP in March 1996 written on behalf of an unnamed constituent who lived in Llanfaes, and it is more than likely that that PE was also on behalf of **Section 40**. This enquiry concerns a "UFO" report which was allegedly made to RAF Valley nearly six years ago on 16 October 1990.

2. According to the letter, the phone call to RAF Valley would have been made at approximately 1940 hrs and thus 'out of hours'. RAF Valley have advised that any record of the event would have been detailed in the Station Duty Officer's Report. These Reports are kept for a few years and are then routinely destroyed. The earliest such reports held by Valley date back to 1992. The CRO's office can find no trace of any "UFO" reports dating back to 1990 still held at the Station.

3. Although Sec(AS) has records of two reports of "UFO" sightings for 16 Oct 90, both were in the London area.

4. In the two previous PE replies to Mr Wyn Jones it has not been necessary for us to spell out the Department's specific interest in "UFO" reports, but on this occasion it is felt appropriate that we do. I attach a draft response for USofS' consideration.

REVERSE MINISTERIAL - IEUAN WYN JONES MP

1. The Station Commander at Royal Air Force Valley has received the attached letter from Ieuan Wyn Jones MP, who has been asked by a constituent to make enquiries into a "sighting" witnessed on 4 Nov 95 near RAF Valley.

2. The constituent has asked whether an object seen at 1905 hours over Llanfaes could have been an aircraft from RAF Valley. The expression "sighting" used by Mr Jones might indicate that his constituent believes the craft seen could have been a so-called "unidentified flying object".

3. RAF Valley confirm that none of their aircraft were operating on the evening in question, and records show that neither were any aircraft booked into Night Low Flying Sector 5D conducting military low flying training. Furthermore, this office did not receive any "UFO" reports which would tie in with this sighting.

4. As there is no evidence to confirm that the sighting was a matter of defence concern, we have no further role. I attach a draft for Lord Howe's consideration, which reflects the standard line in response to such queries.

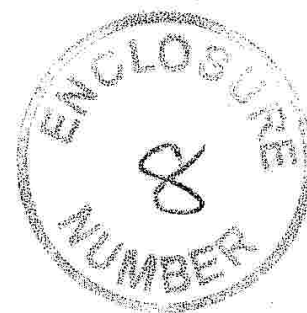

1. PO 2748H - UFO Report 16 Oct 90. As already reported, RAF Valley have no record of this incident. There were 2 Wessex squadrons operating at RAF Valley in 1990, 22 Sqn and the Search and Rescue Training Unit (SARTU). On the evening in question at 1930, 22 Sqn were not operating; SARTU records no longer exist but, because of the nature of their task, it would have been highly unlikely that any of their helicopters would have been airborne. Nevertheless, the area in question is a SARTU training area and the possibility cannot be discounted entirely. Without records, it is impossible now to determine whether a helicopter, airborne on a training sortie, might have just happened to be in the area, or been asked to have a quick look; it certainly would not have been 'scrambled' for that specific purpose.

2. PO 2757H - UFO Report 4 Nov 95. It has already been established that no aircraft were operating out of RAF Valley on the night in question and that no military aircraft had been scheduled to use the Low Flying Area 5D. I can find no evidence that this sighting generated air defence interest and QRA intercept aircraft were not scrambled to investigate. No date for the Sep 95 report has been given, however, no QRA aircraft were scrambled for practise or real operations on the west coast that month. A QRA aircraft was scrambled for a no-notice missile firing at Aberporth Range on 7 Sep at 1330Z.

LETTER FROM NIGEL EVANS MP - US 4752/96

1. I attach a draft reply for USofS to send to Nigel Evans MP.

BACKGROUND

2. Mr Evans' constituent, **Section 40**, is seeking information on an alleged crash into the North Sea (near Morecambe Bay) on 26 Oct 96, the inference being from his letter that the accident may have had something to do with an "unidentified flying object".

3. Enquiries have revealed that there were no crashes involving military aircraft on 26 Oct, and the CAA have confirmed that there were no corresponding civil aircraft accidents in the Morecambe Bay or surrounding areas on that day. The air defence staff have confirmed that there is no RAF air defence radar site in the North West of England and without more information about who the "UFO" group allegedly contacted it is not possible to establish the facts behind the statement in the third paragraph of **Section 40** letter.

4. It may be that **Section 40** is seeking more information following media reports of an explosion in the air, initially attributed to a mid-air collision, north of the Butt of Lewis on the evening of 26 Oct. An extensive search of the area was carried out by RAF and Coastguard Search and Rescue assets but this search was later abandoned after it became clear that no aircraft had been reported overdue. Media reports subsequently focused on the possibility that the incident was caused by space debris, although the Ballistic Missile Early Warning System at RAF Fylingdales, which tracks all satellites in orbit within the UK's area of responsibility, has no evidence to support this theory. Only one report of an "unidentified flying object" was received for 26 Oct but that was reported in the Glasgow area.

5. The Department has corresponded previously at official level with **Section 40** and explained the MOD's position in respect of "UFO" sightings. The attached draft therefore does not repeat this information and confirms only that there were no aircraft crashes

involving military or civilian aircraft on 26 Oct in the Morecambe Bay or surrounding area.

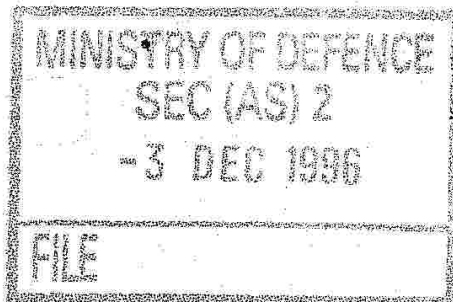

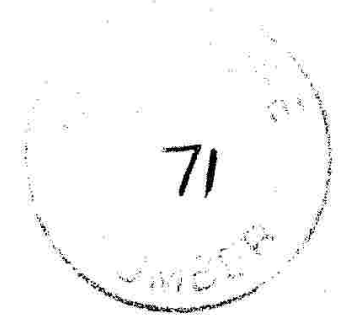

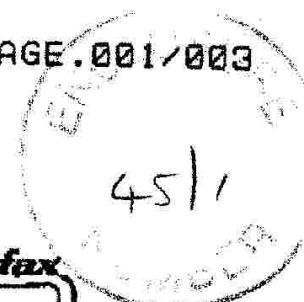

Thank you for your letter of 17th October on the subject of the Tornado F3 that crashed near Blackpool on 28th September.

I can confirm that the flight, conducted by British Aerospace, was intended to be the final element of the company's work on the aircraft before its return to the RAF and to demonstrate that the work had been performed satisfactorily. No question of DASA approval arose as BAe act as the design authority for the UK for the Tornado F3.

To the date of the accident, eight Tornado F3 aircraft, of the sixteen for which such a programme was planned, had undergone recovery work at BAe Warton. All eight had been successfully returned to service with the RAF, and there are no plans to review the programme.

The loss of this Tornado aircraft is, as you know, the subject of a Ministry of Defence inquiry and it would not be appropriate to offer any speculation as to the cause of this accident.

Finally, this accident has no bearing on the Department's claim for damages, currently in preparation, to be lodged against Bricom, the former owners of Airwork.

I hope this answers your queries.
