## a. Action Reported: None

- b. During this period of time four tapes were produced and shipped to the PYREX station for broadcast to the USSR. These broadcasts will cover the period of time up to and including the 21st of April. In addition to the production of scripts and tapes, the panel has prepared several articles for the proposed English language publication designed to promote the ideological nationalism as a political and social force opposed to Communism of the Soviet brand. The submitted articles by the panel have been reviewed and edited by the case officer and returned to the panel for corresponding corrections and changes.

In connection with the promotion of this publication, ABCASSOWARY I, as a group, is making plans for sending their representatives to the Middle East countries in order to publicize their nationalistic ideological drive. The itinerary of the ABCASSOWARY members will take them to several European and mid-Eastern political centers where they will hold discussions exposing the Soviet internal colonialism and the oppressions exercised by the Soviet regime over the national minorities in the USSR.

During this time, no action was taken concerning the plans prepared for submitting to UNO the message received by ABCASSOWARY I from the inmates of the Nordovia camp in the USSR. No action has been made, however, concerning these specific plans because of the delay necessitating the coordination of these plans with the State Department.
