Action Reported

a) By the Field

The publication of the newspapers "Suchasna Ukraina" and Ukrainsky Semostiynik" is carried on on the same basis until the end of this fiscal year at which time, a reduced budget will be introduced for the subsidy of the newspapers. A dispatch to this effect will be sent out to the field in order to organize the activities of the project in accordance with the new administrative plan and the reduced budget.

b) By Headquarters

1. The fourth issue of the UHVR Bulletin will be distributed during the month of May.

2. The Prolog Associates have submitted the accounting of their expenses in accordance with the new administrative plan and the new accounting system established for them by the comptrollers office.

3. The future of the AERODYNAMIC Project has been under review and discussion by the joint staffs of SR/PP, SR/7, and SR/3. As a result of this meeting, it has been agreed upon to :

- a. Reduce the 1957 - 1958 appropriations for the project by C
- b. Implement the plans for seeking private support of the project activities.
- c. Develop the Prolog Associates potential in carrying out operations of the Redskin type.

4. The PYREX Broadcasts are continuing according to the previous schedule.

5. The support of the Ukrainian Broadcast from Radio Nacional in Madrid is continuing on the same basis until the end of the fiscal year and then it will be reduced in line with the general reduction of the budget.
