SUBJECT : AERODYNAMIC/AETENURE
Swiss Bank Account

1. [] of your office has asked for my views on what if any disposition should be of the AETENURE Swiss bank account balance at this time. I understand that beginning with FY-1970 all funding of AETENURE is attributed to devised, domestic commercial sources, and that adequate attribution has also been arranged for the Munich based AETERRACE group. Thus, it appears to me that the maintenance of the Swiss account (current balance should be \$25,017.00) no longer serves a useful cover or funding purpose and the balance should be withdrawn, closing the account, and refunded to the Agency.

2. As the bank account is not recorded in the formal, financial records of AETENURE and as it does not appear as an asset on the balance sheet of the corporation, no "bookkeeping" difficulties should result from its closure. I would guess that closing the account would be no more involved than having AECASSOWARY/2 draw a check in the amount of the verified account balance, with payee as directed by the Monetary Division.

3. Attached for your information is a copy of the most current bank statement.


