This is the sketch of the EBE at Papoose Lake, Nevada, made by Bill Uhouse who accompanied "him" to a Project Review Conference at AEC Headquarters at Los Alamos, New Mexico in 1968, on the attempt to bridge the gap from the alien technology over to ours. Bill had learned to "communicate" with this speechless being, also known as Jay-Rod, over the course of 4 years working directly with him in the bridging attempt, and was here to translate if necessary.

The bridging attempt never succeeded because their instruments and technology needed a mental input to function, which we never learned to impart. Bill worked nearly 15 years on this until he retired and never succeeded in solving the problem.

PREFACE

In 1988 I would have laughed at anybody trying to tell me about a joint operation between extraterrestrial beings and our United States Government at Dulce, New Mexico. As a matter of fact, I also laughed inside in 1980, about reports of certain vast underground tunnels and digging machines that made them. And this was even after Gerald Schultz brought me a copy of the Rand Report describing such machines. That was until I met a man who built the machines that dug the tunnels.

It all happened this way. In 1978 when I came back from Switzerland where my team had received examples of four states of metal used by some alien extraterrestrials visiting Eduard "Billy" Meier there. We took these specimens to responsible metallurgical laboratories for analysis beginning with the School of Mines Laboratory at the University of Arizona here in Tucson. Dr. Walter W. Walker, Professor at the university and head of the laboratory, and incidentally a friend of APRO, headquartered here in Tucson, conducted the analysis personally. He found some very unique properties which he described to us verbally, but refused to make a report, allow us to quote him, record his voice or photograph his laboratory. He said that the University was not in that "UFO Business" and did not want that reputation.

The same "peer pressure" prevailed every place we went. We learned to respect that. We took the metal specimens to other metallurgical laboratories with similar results, even to the laboratories we took them to in Switzerland where one small

piece of the material carried in a small plastic envelope in Meier's pocket for weeks deteriorated to a fine black pepper-like dust.

Dr. Marcel Vogle at IBM found that a sample he was carefully examining under a scanning electron microscope began to decompose under an intense beam of bright white light focused through a quartz lens. He said the crystal stacking was unique, and that the specimen showed no ash or evidence of bubbles, meaning that that specimen had to have been synthesized in a cold process in a vacuum. We have no such process here on Earth.

We went to other metallurgical laboratories with similar results. Several of those scientists suggested we take our samples to Boeing Aircraft at Renton, Washington for analysis as they had the best researchers and equipment for such analysis in the U. S.

We did that, and after our meeting with executives at the Boeing Plant, and discussing and showing our samples, they asked us to step out of the room for a moment while they discussed this. When we were readmitted a few minutes later, they told us that they did not want anything to do with this, and we thanked them and then left.

Later that evening, their plant metallurgical department chief, who had been in the meeting, contacted us at our Hotel and now invited us to bring the specimens back the next morning, but to come to the employees entrance and ask for him.

We did this and they tested for several hours, but again we had the "no evidence" restrictions and carried nothing away with us. As it turned out, that man's bosses discovered this testing and now our friendly laboratory supervisor was summarily fired, discharged and sent home.

He was devastated, was living on a relatively high income that was now curtailed, and needed a similar job desperately. He

turned to “HEADHUNTERS” an agency that finds employment for CEOs and Supervisors.

Several weeks later “HEADHUNTERS” found him a new job at an acceptable pay scale as Foreman at a manufacturing facility and he went to work. He found that he was to be Construction Engineer in a big “tractor company” building digging machines, tunnel boring machines – mechanical “moles” that dug scores of yards of 60’ diameter tunnels in solid rock strata per day in a continuous operation. These machines were so big that they were made in modules that were shipped to the operations site and assembled for work there. (Shades of the Rand Corporation Report) That Company did no advertising, had no company sign out in front, and all their production was picked up by huge government trucks and hauled away as they were manufactured.

This man called me several times over the next years, until he retired from that job and took a Professorship at a major public University. He told me of a successful bid to manufacture new machines to dig 80’ diameter tunnels as well, and other exotic machines. They had been doing this for many years, since the late 1960s, and had produced a great number of such machines.

Now I had to believe there were big tunnels and that our government was digging them at a furious pace. He told me of having to send repair crews many miles underground to remote sites to repair disabled machines on site, and that there was a vast network of such tunnels.

Another event in my life tended to support this story and an extension of it.

I used to stop at the Groom Lake Naval Auxiliary Airfield in Nevada for gasoline service as I delivered airplanes around the country at that time in the early 1960s. It was convenient, never busy, and the service was good and always prompt. I could get a

sandwich and cup of coffee at the little sandwich bar there near Operations. One day, when I landed, I was chastised for not carrying a special Letter of Authorization permitting me to land there.

It seemed the Navy was moving out and a new operation was being prepared. A reinforced U.S. Marine Construction Battalion (CBs) was moving in. I later learned that they were working on a project called "Red Light" to modify the facility.

At a lecture in Las Vegas some time later, a man came up to me after the presentation, introduced himself, and said he was a Medical Corpsman at the Base Hospital at Groom Lake when the Navy tenants were all transferred away, except the Base Hospital, which remained, and the CBs came in and took over. He told me of some of the changes they made.

He said that the CBs took down some of the buildings near the runway, erected camouflage to obscure the fact from the air, took up some of the runway there and built some kind of installation underground. He heard rumors that it contained a "habitat" of some kind, and other laboratories. Then the buildings were put back up and the runway relaid again, and the camouflage netting was removed. New personnel gradually replaced all the hospital staff and employees, and he moved on.

It was years later, in 1988, when I was visiting a friend here in Tucson, who also had another visitor at the time, a friend of his, an ex-Marin CB man who said he had worked on "Project Red Light" at Groom Lake before he left the Marine service by not re-enlisting again. This made me pick up my ears as Marvin Hodges described the work done there. He said he did not re-enlist and left the Marines.

I asked him what he did after that, and he replied that he foolishly went right back into the construction business, He said he went to work for Page Construction Company.

Well, I knew Page Construction as a big company that built bridges and causeways and the like, and so I asked where he worked for them. When he said:

“Well, we went to a little town over in New Mexico, north of Albuquerque called Dulce” My ears picked up again. I was already quite familiar with the Paul Bennewitz case over in Albuquerque where he claimed he had observed, filmed and photographed disc-shaped craft over the Arqueleta Plateau above Dulce, from his private lightplane. He even thought he saw them come out of and go into the plateau!

Paul Bennewitz was arrested on rather ridiculous charges, referred for psychiatric treatment, unnecessarily, but to intimidate him, was found perfectly sane and was then released... He was later rearrested again and referred for treatment again, until they could make a case that they began to treat him for aberrations, and finally with electric shock treatments so as to derange his memory so that he could no longer recall what he had seen, filmed with his 8mm movie camera and photographed with a 35mm still camera!

Here was the owner and operator of a successful electronics manufacturing company that had been reduced to a vegetable, and his son had to take over the company and run it.

Christa Tilton and Paul Shepherd both filmed video interviews with Paul Bennewitz near his end. Christa Tilton had gone to Paul for information after she claimed she had been taken inside the Dulce facility there.

Paul Shepherd still has his video interview with engineer Paul Bennewitz. During that interview Shepherd left Bennewitz in disgust and left without finishing the interview.

Bennewitz had actually photographed the remains of a downed ET vehicle on the Arqueleta Plateau and had the pictures to prove it. However, while Bennewitz was in "treatment" he was shown his own pictures of the crash site and a big rock prominently in the foreground. In an altered state of consciousness Paul had been shown that same picture with a battered ET body losing green blood onto the rock that had been added to the scene. Whenever Paul saw that picture after that, he also saw the doctored scene in his mind.

When he showed this picture to Paul Shepherd, the ploy now worked beautifully. When Bennewitz pointed out the ET body on the rock, that only he could see in his own mind, Paul Shepherd rolled his eyes in his head and made an excuse to break off the interview and leave, which he did, not knowing at the time that this was the way Paul Bennewitz had been prepared to be his own best witness against himself.

Paul Bennewitz is a basket case today, and is protected by his daughter.

Well, now Marvin Hodges was telling me how his new Page Construction team "went downstream about four miles from Dulce, crossed a bridge, and back up the other side six to eight miles and then bladed a road up into the Arqueleta Plateau. Then they dug a vertical shaft down 250feet, created an offset, and went down another 250 feet. There they made a big room. Then they started a fan of three tunnels running out from that room. A barn was erected over the first opening."

Later, according to Marvin, other big contractors were brought in, and all working under the Army Corps of Engineers

dug three levels of three tunnels each 4 miles long and fanning out 3 1/2 miles wide at the extremities. Marvin thought there was 500 feet separation between the levels. Marvin made me a sketch and some diagrams of the dig. He said the tunnels were designed for permanent Atomic Waste storage. The tunnelers finished their digging and then turned the tunnels over to the Atomic Energy Commission to finish the walls, install the power and ventilation facilities, and lay the tracks for the push engines and flatcars that would take the loads of lead barrels of atomic waste to the ends of the tunnels and seal them off.

A new candidate for State Governor ran on a platform of "No more Atomic Waste in New Mexico" and was elected. He then promptly closed the borders of the state to all atomic waste traffic and the vast and extremely expensive tunnel complex became useless for all but the State's own atomic waste.

Thus the completed tunnel complex with finished walls, power, ventilation, air filters and all was available unused when the new contact was supposedly made in the late 1960s with some new ET beings who had asked us to provide them a safe surface base in exchange for technology. What better use to put the tunnels to?

Now, with all this other information, all doubts of validity for the Dulce story were erased from my mind, and I find the rare allegations actually credible.

Mr. Craig Sebree, an Insurance Salesman, Musician and student of the Eckankar Teachings was traveling from Tucson, Arizona to Denver, Colorado via Dulce New Mexico with friends.

At about 9:00 PM on Wednesday, 11 May 1988, Mr. Jay Huff, operator of a Karate Studio in Tucson, received a telephone call from the wife of Craig Sebree stating that she had heard from Craig on the road.

According to her, at about 17:00 PM on that same day, 11 May 1988, her husband had called home saying that they had seen two silvery-metallic disc-shaped flying objects about 100 feet in diameter that flew past the van that Craig and his party were riding in. They passed with a whooshing sound and slowly landed approximately 1,000 to 2,000 yards down range on the mesa. This sighting lasted about 8 minutes. Craig drove directly to the craft landing site, losing sight of it several times on the way. When they got there the craft were gone and a search of the area revealed no trace of landing tracks or other evidence. The ground looked completely undisturbed there.

Craig called his wife in Tucson and asked her to report it to Huff, a friend of his here in Tucson. He also said that he was going to spend an extra week in the Dulce area and try to photograph the craft coming and going. We received no further report on this affair.

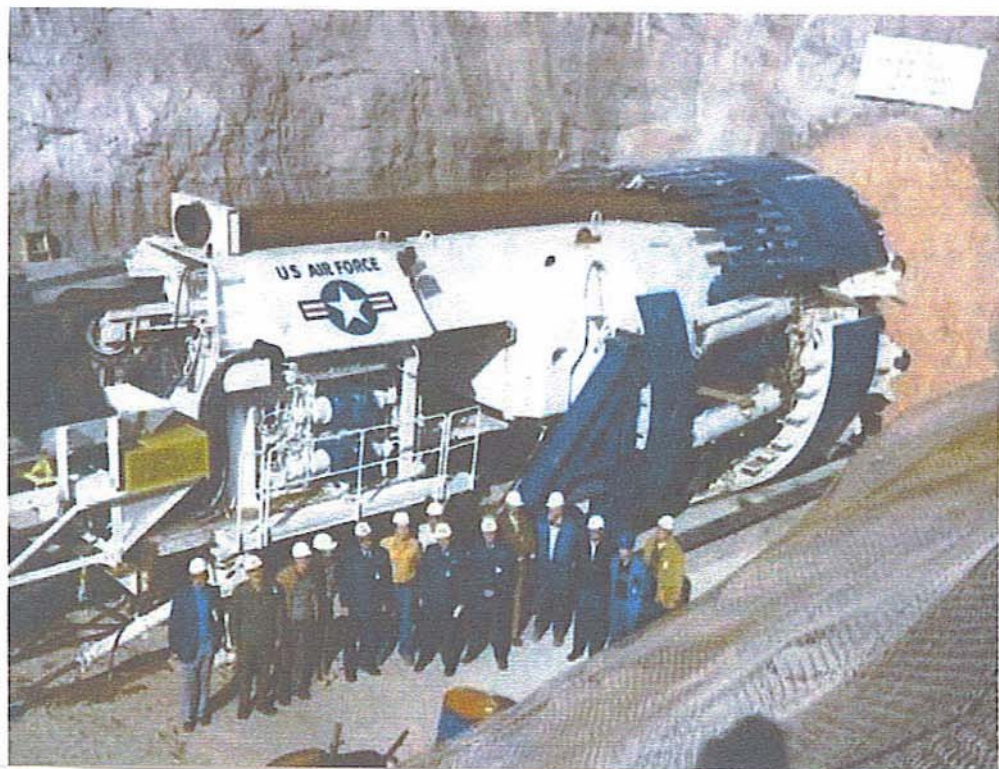

INTRODUCTION

For many years highly controversial rumors of the existence of an Alien ET Base at Dulce, NM, kept popping up.

Before that, but now with hindsight, and almost contemporary in time, were the equally exotic and controversial rumors of a U. S. Air Force officer meeting with alien ET visitors in the desert near Holloman Air Force Base in New Mexico. In the dialogue that followed, we supposedly reached an agreement to provide those ETs with a safe operating base on the surface of our planet in return for alien technology.

All of this was carried out in such secrecy and obfuscation that very little could be established as fact at that time.

And equally unbelievable was an offshoot of these rumors that seemed to indicate that a second exchange was taking place at Papoose Lake in the Area 51 part of the Atomic Energy Commission Facilities, the most secret and also most secretive locations in this country, all under the direct supervision of the AEC Headquarters at Los Alamos in New Mexico, all on Indian Reservations. Perhaps it is no coincidence that this was all unfolding on Indian Reservations. United States laws are applied differently there.

Most of our recovered alien vehicles were taken to these locations. Dr. Edward Teller supervised the AEC Headquarters at Los Alamos.

I wouldn't have believed these stories either until I met Mr. William Uhouse (not his real name). Bill was a simulator engineer building and maintaining the flight simulators that teach pilots to fly new aircraft that have never flown before.

Bill once told me how, in the 1960s, he had been given the job of designing and building a new habitat facility for alien ETs who would be coming to his base to live for an indefinite time.

The sanitary facility he constructed was some different from ours. There was no toilet bowl to sit on and no urinal on the wall. The shower stall had two nozzles. One dispensed an enzyme culture provided by the ETs. The other dispensed water. He said those ETs with no anus or genital organs excreted through their different kind of skin. They lathered themselves with the enzyme first and then washed that off with water. The residue was collected and the enzyme filtered out and put back in the tank before the water was drained away.

Bill said we also had to synthesize their food alimentation from cultures brought from their home planet.

His main job, however, was to try to bridge the gaps between their technology and ours, which in a whole career he failed to do because their devices required a mental input we were unable to learn.

That alien ET was called Jay-Rod, and Bill was even jokingly called Jay-Rod II. He learned to communicate with Jay-Rod in the course of his labors with him, and told me that in 1968 he and Jay-Rod had participated in a Progress Review Conference at AEC Headquarters in Los Alamos, chaired by none other than Dr. Edward Teller himself. Around a big oval conference table Jay-Rod was seated on one side and Bill on the other. During that conference Bill sketched a portrait of Jay-Rod, now dressed in an open necked white shirt and earth style business slacks, to help

reduce his alien aspect. But his pale hairless skin, big black oblique eyes with no eyebrows and disproportionately large head were less easily disguised.

Bill told me at that time, and this was well before the Santilli film, that those black onyxlike eyes were normal eyes with iris and pupils covered by dark variable density lenses installed under the eyelids to protect the large sensitive eyes under them. When working with Jay-Rod in dimmer ambient light he said he could see an iris and a big pupil behind the black shield. In brighter light the black became denser until nothing could be seen behind the lenses. The reason, supposedly, those lenses were worn that way was because Jay-Rod had no prominent ears or nose to wear external lenses on. Whether these two situations are connected or not we do not know, but they are both highly exotic.

EXCLUSIVE INTERVIEW WITH SARGEANT CLIFFORD STONE, ON ASSIGNMENT AT ROSWELL, NEW MEXICO

In the course of my UFO investigations, I established contact with Aileen Edwards, Director of the UFO Contact Center International, Seattle, Washington. For several years, Aileen has been doing excellent work getting people released from mental institutions that do not understand the UFO contact or abduction phenomenon. Many of these unfortunate patients have been given dangerous neurolyptic drugs as a means of "treating" their "illness."

As a result of our conversations, Aileen placed me in touch with Sargeant Clifford Earl Stone of the United States Army, who is currently stationed at Roswell, New Mexico, which is near the site of the most famous crash UFO case of all time which allegedly took place in 1947, and involved the recovery of several alien bodies by the military.

What I have found out by speaking with Sargeant Stone can only be labeled "sensational." But before we get to the main body of our interview, I should point out that much of his testimony can now be verified by others connected with the intelligence community. For example, recently there was aired on national television a two hour special, "UFO Coverup — Live from Washington." Among the most interesting features of this program were the on-the-air confessions of two mysterious individuals whose true identities remain a secret, but who go by the code names "Falcon" and "Condor." Their faces were hidden at all times, and their voices altered through a muting device. From what I have discovered, however, Falcon is an OSI agent, while Condor is a scientist working for the U.S. government.

On the show, Condor told of a deal the government made with the aliens: "Essentially, the agreement says that we won't disclose your existence if you won't interfere in our society, and we allow you to operate from a designated base in the United States. It's in the state of Nevada, 'in area called Area 51.' Extraterrestrials have complete control of this base. My understanding is that three different aliens of the same species has resided

in the U.S. from 1948 or 1949 until the present day. The first alien was captured in the New Mexican desert after its craft crashed. The alien, which was named EBE by the government was kept in captivity for three years and we learned a great deal of information about the alien's race, culture and spacecraft. The second alien was part of an exchange program. The third alien was also part of an exchange program and has been a guest of the U.S. government since 1982."

Falcon, when asked where he had learned so much about the ETs stated: "This book — it's called the bible within the MJ-12 community — contains historically everything that occurred from the Truman era up through the three aliens being guests of the U.S. Technological data that are gathered from the aliens, medical history gathered from dead aliens that were found in the desert, autopsies, information from dead aliens and information obtained from the extraterrestrials regarding their social structure and information pertaining to the universe." When asked where the aliens came from, Falcon said their home planet was located in the Zeta Reticuli star group.

According to Sargeant Stone, there are further implications to this matter of diplomatic relations with the aliens. As most UFO UNIVERSE readers realize, this knowledge has long been classified at exceedingly high levels, and has not been released even though various court battles have been fought to obtain the truth under the Freedom of Information Act. The much talked about MJ-12 briefing document was a "leak" made by sources unknown, there have been several others, and yet future revelations have been promised by those working inside the "establishment" who are convinced the public must be told *everything* and NOW!

At the start of our interview Sargeant Stone wanted to make it perfectly clear that his duties in the army "have nothing to do with my interest in UFOs. It is purely personal and is based solely on the experiences that I've had as a child with visual sightings of UFOs." With that statement our conversation branched out into many directions as the following interview will clearly

show.

UFO UNIVERSE: Describe for us one of your most important sightings.

CLIFFORD STONE: There is one sighting I had when I was seven years old in 1957. The object I saw was sort of a white opaque disc. It had an inner ring and an outer ring. The inner ring was going clockwise and the outer was going counter clockwise.

UU: Like a Saturnian ring?

CS: Basically, that's correct.

UU: In reference to Condor's statement about Area 51 in the state of Nevada, what do you personally feel about this in your studies?

CS: I believe that the American public has the right to know what is going on. I can't believe that an intelligent race that could traverse the billions of light years perhaps to get here to planet Earth would get here and give us technology to go ahead and kill our fellow man in exchange for our silence about being here. If they're doing it with the U.S. government, they're definitely doing it with other governments of the world.

UU: Do you feel there's a war going on perhaps between different types of aliens?

CS: Yes, I do. I believe what is presently termed as the "greys" may very well be the people that the U.S. government has the pact with right now, and they are not necessarily the "good guys."

UU: Do you feel that these grey guys are evil?

CS: Well... there are some things I prefer not to talk about. But I'll tell you this much. First, I believe that there is a God. And I firmly believe that God made man and all intelligent life to be a free agent, to choose of his own validity. Abductions are real. Abductions are taking place. People are being forced to undergo — partake in various experiments — for whatever reason by our alien visitors.

UU: What else would give you the impression that these guys are evil, cut and dry? Is there a case you can cite?

CS: O.K., this is supposition. One gentleman who was doing research into it reported a military intrusion on an alien base, right here in New Mexico. Well, the military tried to go in and take over the base. (It was also mentioned that a similar event took place in Nevada.) Sixty-six servicemen were supposedly killed there. The aliens had the base, it was an underground base and allegedly the military sent in some of their elite forces, probably equated to a Delta force, elite, anti-terrorist force, if you wish.

UU: How did they find this base?

CS: Well, it was part of the allegedly secret agreement that we would let them have bases, therefore we knew about the base. There was some type of argument that broke out between our people and the aliens.

UU: So there are many bases throughout the country?

CS: There are rumors of many bases. Given that these stories are true, I think that they probably have 12 or fewer bases. The greys may have various, let's say, hideouts. As far as actual full scale operational bases, there's probably 12 or fewer.

UU: And where are you getting your information?

CS: From, we'll say, other researchers that wish to remain sort of silent.

UU: What position are you in the army at present?

CS: I'm in an ROTC assignment.

UU: How long have you been in the army?

CS: Twenty years.

UU: Your friends who remain anonymous are within the different services of the government I take it?

CS: Well, for example, I was stationed at an Air Force base and one guy went and came to my home and identified himself as a fighter pilot and told me about an aircraft that he was piloting. I believe it was over the Pacific Ocean. Anyhow, it got real dark all of a sudden. He reported looking up and he and the other crew members saw what they described as a vehicle that was 3 miles long. (Three miles in a circular expansion.) As far as I know it stayed with them for 15 or 20 minutes and then went straight over the aircraft and got out in front of them and shot



straight up, out of sight.

UU: Where did you derive the idea that our government is making deals with aliens? What gave you this type of notion?

CS: The Snowbird document. This document refers to us making primitive contact with the aliens in 1959. On April 25, 1964, we managed to carry on a 3 hour conversation which was the onset of the agreement at a base here in New Mexico. I believe that base was Holloman Air Force Base. The agreement involved an exchange of technology and our silence. By going ahead and not having any interference with the aliens, in exchange they gave us the technology and we agreed to keep quiet about their presence. That right there is sinister in itself.

UU: How do you mean, sinister in itself?

CS: We have to go back to the abductions. For some reason they don't want the people to remember what happened. Well here you have people who had contact with alien beings who have lost everything. They've went ahead and have family problems, they've lost their jobs, a lot of them have become reclusive, they have mental problems because they can't cope with what happened to them. They know that they've had some type of experience, but a lot of the time they would have nightmares. They can't explain these.

UU: Because it was repressed in their subconscious?

CS: Correct. Maybe by design, or it may be just because the body's own self-defense mechanism is trying to cope with something that is beyond it's comprehension.

UU: Can it be that they work with us the same way that we as conservationists work with animals?

CS: If you can equate this with our being the guinea pigs, i.e. the situation is like us going, let's say, to an island and finding primitives there. What we want from there, we simply take. And we may feel that the people there are so backward that we may not even recognize them as being on a level to us and not even, should I say, subhuman.

UU: What about the benevolent beings that are said to exist, who abide by higher laws that do not allow them to interfere — aren't they trying to help?

CS: The good guys are, well, I like to refer to them as being nomadic. What you're talking about, about the non-intervention with other intelligent life forms is a universal law. The nomadics go along with that. The greys violated the universal law.

UU: What else can you say about the benevolent space beings?

CS: They have a high regard for life. I believe, shall we say, "the good forces" they don't really want any interaction with

us. They choose to just go ahead and just observe.

UU: Silent guardians. So it seems what they're trying to do is balance what the greys imbalanced.

CS: I would agree with that.

UU: Are some of the Reticulans working on a different level than the other greys that are causing problems?

CS: Yes. You may equate the one trading center in Zeta Reticuli — that's a dual star system — to the one trading center there, like say, to a port — a seaport — maybe even to Atlantis. It's a very highly developed society there. They have various groups that come here. Only, I would say, three of what we classify as the greys, three groups of the greys are probably the ones that are the hostiles. But you've got to keep in mind also the planets from which they came died out long ago. So they're really a dying race. And what they're trying to do is revitalize their race. Unfortunately, they have adopted planet Earth as the place where they want this to happen.

UU: When you were describing that there are approximately 3 different types of hostile aliens from Zeta Reticuli, would you describe further what you mean by that?

CS: At present time, I believe that the government has identified several groups. We break these down by EBE (extra-terrestrial biological entities) type 1, 2, 3 — I think we are about up to 7 that they have identified. Well... seven types of space travelers, or inter-dimensional travelers, if you wish. When I refer to inter-dimensional travel, I am referring, utilizing the Einsteinian, Rosen, Bridges for that travel.

UU: Have there been any contact with similar type entities that clearly indicate that there are those that are helping, rather than offsetting, our evolution?

CS: Well, one person that I know has a contact with an individual that he calls Corona. And Corona — I do not know how you would really describe him — only that he sort of has a greenish glow. You might attribute him to a grey by virtue of him being small in stature. He's not like your typical space creature because he has a sense of humor.

UU: Has any information been given by that entity pertaining to some of these experiences of the hostile greys?

CS: I'm going to tell you the situation as I understand now. The greys will eventually come forth and try to state that they created Christ. This is not the case. They did not create Christ. Christ was and is a divine entity. He was sent here by the Creator, not the Creator of just the world, but the universe.

UU: So in other words they are going to establish themselves as being like those of the Light, actually those who sent forth Christ, when in reality they are just trying to revitalize their race through our race?

CS: That's correct. Whitley Streiber knows this. Whitley Streiber I believe would tell you that their good is our evil, our evil is their good.

UU: What about the cattle mutilations?

CS: I believe that they are involved with the actual cattle mutilations. Now there are some copycats, and the government tries

to get mileage off the copycats, and the government may have even went ahead and staged some — just to throw off the extra terrestrial connection.

UU: Can you give more detail on the information from Corona regarding the greys, the subtleties ahead, and how to avoid any mishap?

CS: You mean how to identify if you're working with a good guy or a bad guy? For one thing there are the religious artifacts the bad guys are not going to be happy with. For example, there was an instance where they tried to pick up a farmer who I believe was Catholic. Anyhow, he started to pray and they couldn't take him aboard the craft. They asked him to go ahead and throw away his crucifix. He wouldn't throw it away. He was too scared He kept praying and finally they gave up trying to abduct him.

There was also an incident in Vietnam where a UFO set down in a field. It terrorized some of the villagers, and there was a soldier who was out visiting his girlfriend, who would later become his wife. Anyhow, he got tied up there and the UFO was trying to convince some of the people they should go. It wanted to take some of the people. The soldier stood his ground and wouldn't let the entities do it. The M16 that the soldier had was impervious to the aliens, but the cross that he always wore, and he always carried a Bible, they had regard for that. Finally, they gave up and decided not to try to take any of the people.

UU: So even technological entities of an advanced order that have other than the highest regard for the individual would be offset by positive energy?

CS: The individual that I was telling you about before — the one that a friend of mine has had contact with since he was a child (Corona) — clearly comes forth and states that if you want to know if you're dealing with a good entity or a bad entity, the only thing you have to do is bring up the subject of religion. Good entities won't argue who's right and who's wrong. The situation is, that the divine Creator is the same for us here and to the furthest ends of the universe. And what unites us all is our love and compassion for others.

UU: What type of mentality are we dealing with when we're talking about the secret deals made with ETs?

CS: Let's go back and look at what happened as far as our deepening involvement at the onset of the Vietnam war. Take a look at what happened with the Iran affair. The situation is that there are elements within our government that sometimes act all on their own without congressional restraints, or even without presidential restraints, which ultimately affects the entire American population. In this case, it will ultimately have an effect on the entire population of the world. Up until about 1985, I would not have believed any of this. As a result of coming into contact with the Snowbird document, and the stonewalling the U.S. government has done in my efforts to refute or confirm the Snowbird document, I am left with no recourse but to believe that we have made these agreements — rightly or wrongly. I believe what is going to eventually happen is that they will make themselves known and immediately go ahead and try to

destroy society as we know society and convert it to their social standards, if you wish.

UU: On the broadcast UFO Coverup Live, they spoke of an exchange program where we sent two of our guys up into their crafts. This aspect of doing an exchange program, do you feel any of this is true?

CS: It follows accepted diplomatic precedures.

UU: What is the purpose of revealing this information at this time?

CS: I think it's to try to prepare the American public for the ultimate disclosure of the existence of the alien beings. I think there is the effort for the good guys to make contact with the people within our government, but I think now what is happening is that the U.S. government learned in 1983 or thereabout that they are NOT dealing with the good guys, but really don't know what to do about it.

UU: So how can they get out of this? What would your suggestion be?

CS: Well, my suggestion would be to stand up to the greys. Let them know that this is a free society, that we are not going to sit back and let anyone — be they from outer space or some other foreign country — convert the people of the United States.

UU: You said that the government didn't know that they were dealing with the bad guys at first. How would the government figure out that these entities were evil? What would make them think that? What would make them decide all of a sudden?

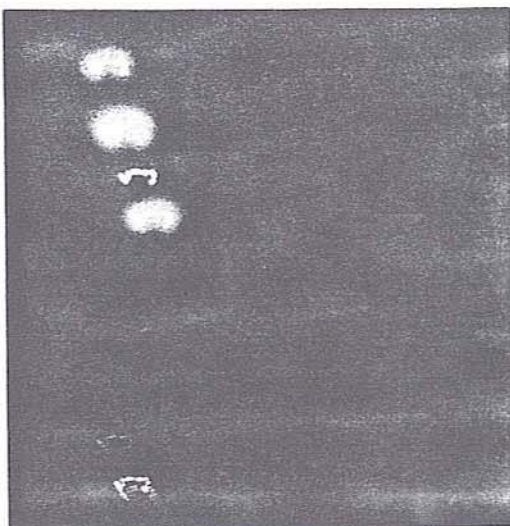
CS: Let us suppose that we make a deal with a group of aliens. Among other things we agreed that they can have prearranged bases. We will provide security and we will not acknowledge their existence to the general public. In return, they're going to go ahead and give us some technological advances. They're going to go ahead and carry on certain experimentations, gathering various minerals, getting various flora, various animal life. They're also going to go ahead and conduct some experiments or some research on human beings. Now this troubles us because we don't want that to get out of hand, so we bargain a little deeper and we come to the agreement that, okay, if you abduct anyone we need to know who they are so that if there are any problems in the future we can go ahead and take care of those people who may need medical or psychological attention, so we can assist with this. They say, fine, we will provide you with say a listing of all abductees. Later, we find out that they are providing us with maybe a hundred to two hundred abductions maybe every couple of months, but we discover that the number is really into the thousands. We also find out that this scientific curiosity is also being used to tag these people, i.e. the implants, and we are not being told why they are doing this. Now we no longer have control over the abductions. We might even find that there might even be a scarier aspect to it — let's say some of these abductees appear to be "sleepers," there is some type of information that they're being fed, a post-hypnotic suggestion for lack of a better term. But don't think that this is hypnotic at all — it's not. It is a very much advanced technological process. Anyhow, they are being told at a certain time, a certain place in the future, they are going to be required to recall things that they are being told at this time, right toward the end of the experimentation of whatever is going on. However, alien forces want this to be kept so secret that if you try to pull this out of them while they're under hypnosis, it will cause the body functions to become under stress.

UU: Have there been any intervention with benevolent beings in this matter?

CS: I would say that we know of several, should we say, intergalactic fights that have taken place — dogfights.

UU: An obvious dispute among aliens themselves? What do you feel was the outcome?

CS: The good won. Right now I think that the good are trying to "build up their forces." I think the greys were very concerned about the crash at Roswell, New Mexico, because we had something that they were identifying as a weapons system — and that was a very strong radar tracking system. They lost several ships to that. The aliens initially, having identified that as a weapons system of ours, adjusted their craft so that the



high powered radar would not cause on-board difficulties. The greys assisted in keeping the story quiet about the Roswell incident without — how can I put this — "open contact" with the government at that time.

UU: Have you heard of such a thing as MIB or Men in Black in relation to such incidents as these?

CS: Yes. There is a well known newspaperman who was involved with the UFO crash here at Roswell in 1947. He had his life threatened if he tried to go ahead and break the story. He's maintained silence ever since. He's talked a couple of times, but will never come out and fully tell the whole story.

UU: Did any of the occupants make themselves known to our people at that time?

CS: Here again, I'd have to go back to the reporter who was approached by an entity. And I don't think the entity that he was approached by was of this Earth. It was your classic MIB saying, "Look, stay out of this one!" Point blank he was told, "If you try to break this story, you'll die."

Around that time we also started to lose jet aircraft that were sent aloft to intercept UFOs. Most of the time these were written off as aircraft having malfunctioned that caused their crash. Some of the aircraft simply vanished without a trace. One incident happened here in Roswell, probably early 1950s. The family still lives here. Two aircraft were sent aloft to intercept a UFO and make the identification of the object as picked up on radar. One plane returned. To this day, one plane and a pilot never returned.

UU: Is there any information in reference to the joint operations that such an govt.-alien alliance is doing beneath the Earth?

CS: Supposition there's a lot of genetic work going on down there. For example, there have been people who have claimed to have been taken to underground installations where they observed comatose people in these underground installations. There are also reports of various vats with human parts. One woman reported seeing what appeared as a very Earthly male who was in a vat of some type of fluid in one of the underground installations. Quite a few of the people have alleged that they have been taken to these underground installations and have been kept there for days.

UU: And why were they let free once they knew of such an installation, let's say, if they're trying to hush that up?

CS: The vast majority, the man on the street isn't going to believe them anyhow. There are allegations that some are either military or working with the government that were brought down there.

UU: Are you saying that you are not very clear on what goes on down there? You've never met anyone who had anymore to

say on it?

CS: I'm saying I can't be very clear.

UU: In other words, it's a little too intense to talk about?

CS: Yes. I have an interest in UFOs and I've had to recently go through one heck of a battle with the military to express my first amendment right to voice my dissatisfaction with the U.S. government keeping this information suppressed. There are certain things that even as a private citizen that I have to be very careful about suggesting.

UU: What part of the government would have jurisdiction in association with these aliens?

CS: They would probably be the National Security Agency, they report directly to the National Security Council. As a matter of fact, it sets in on the National Security Council.

UU: Are there people within this agency that realize that they've gotten into a little mess?

CS: Yes, I think so. I think right now those that are in the know are sort of divided as to whether they should go public or try to keep it secret. The TV show *UFO Coverup*, wasn't really well handled. They didn't really know how to go about bringing out the information that they do have. The situation is that of a programming process, the government wanted some of that information to be released. That I feel is a fact. Now they took that program from Washington and they really wanted to see what the reaction of the American society would be as a whole. How we would react to it. If the U.S. government ever comes forth and states — and eventually I feel within a very few short years, possibly even months — they're going to have to do that. They're going to have to come out and say that UFOs are a reality.

UU: I heard you were going to Germany?

CS: I will be separated from my family for at least two years as a result of it. They were going to put me out of the Army because of my interest in UFOs. I want to stay in right now — when I get out I want it to be my choice, not because they forced me out.

Are you aware that this is a very, very hard subject matter. I mean it's so far out on the left field I avoid it...but I'll bring it up anyhow. Do you know that there are reports that some of the alien ships do a harvest of the souls. In other words, they feed off the living energy, which is in fact the living soul.

UU: Have you read Budd Hopkins' books?

CS: Yes, I read both of Budd Hopkins' books. Budd is very close to the truth, but the full truth is a horror story that is beyond any science fiction that you have ever read.

UU: Are there entities of the more benevolent sort that are abduction people (Reticulans)?

CS: That's correct. What they do, I would say, that they have more of a scientific curiosity about how we are evolving.

UU: They have more of a compassion, you would say?

CS: Correct. As a matter of fact, if there was a situation where you had a weapon that could kill them and they could not escape, other than to do you harm, they would permit themselves to be killed. The situation with abduction cases, in dealing with the bad guys, is that they will go ahead and make a person try to recall the bad times of their lives. Then the people relive those experiences, they go back to the way they felt when that experience was happening, they bring to mind the things they fear the most, they bring this out because they actually absorb something similar to osmosis these feelings that they actually feed off of.

UU: So you're saying that these particular entities that are working in this fashion are the very entities that our government made these deals with?

CS: Yes.

UU: Are the people within these government installations who are working with these entities experiencing such traumas, or are they left alone?

CS: I don't think that they are experiencing trauma because they need those people as part of the grand deception. Keep in mind, while they're dealing with them on the physical plane they're also actually dealing with an interdimensional phenomenon.

UU: Like an astral phenomenon?

CS: Yes.

UU: The nature of our conversation is everything but what was mentioned on the broadcast. They didn't mention anything about them being bad, deals with the government and such. Why wasn't that disclosed?

CS: The deals about the government was touched on, but very lightly. The situation about them being negative entities — a lot of people don't believe that that is the case — even a lot of people within the government. For example, Falcon and Condor definitely don't believe that they are negative entities. They believe that they are the positive, for the good.

UU: You had mentioned earlier that the three entities within the custody of the government were not associated with those of the bases. So maybe the ones they were dealing with were good entities, we were learning from them and they were learning from us. Do you think that the government is dealing with two types of aliens?

CS: I definitely think that they are dealing with two types of entities, but you've got to keep in mind one thing — the good guys are not going to give us anything to kill our fellow man.

UU: If you were to see this in an article, is there something that you would like to say?

CS: Definitely. "Shut me up and shut the other people up that are like me. Go ahead and have an unbiased congressional investigation into the UFO matter. Give across the board immunity to any or all service members and civilian government workers who have any knowledge of crashed retrieval aircraft or underground bases to let them come talk freely to a congressional committee on UFOs so that they might talk and clear the air. Get it out that UFOs are a reality. They are here now, they have underground bases. If they go ahead and grant that immunity you'll have people come forth and talk. But they will not talk unless that immunity is granted. Now if I'm wrong — go ahead and offer it, set up a committee, a congressional committee to hear all the evidence, weigh all the facts — then it's a put up or shut up proposition."

UU: Why haven't the aliens just simply infiltrated in relation to these government deals?

CS: The U.S. government may believe that there's no defense and that they are highly evolved and technologically superior to us. There are those of us, however, that firmly believe — or should I say know — that there are defenses against these folks. In unity there is strength. That strength is derived from knowledge. The knowledge that must be had is the knowledge of the truth. With the truth we can go ahead and combat these entities.

UU: Such as with positive energy? What you're saying is that good, positive networks of people would create a further wall of light that would block off these negative crafts?

CS: That is correct.

UU: How far up in government do you think is aware of this? Are Reagan and Bush?

CS: If they do not know, if they are not a member of the in crowd, then we have a definite problem with the U.S. government. They have the classification, they have the security clearance to be in the know. Keeping in mind, of course, that they are debriefed and that they have a moral obligation not to talk about what they do know. Go back to Reagan, on several occasions he has tried to tell the people something because he mentioned how we would be united if we were suddenly confronted with a possible invasion by aliens from some other planet. And I have copies of two of those speeches (which were published in UFO UNIVERSE).

In focus...

Gabe Valdez

Though no one has yet nailed down indisputable evidence of alien underground bases at Dulce, New Mexico, one man can at least claim to have hung around long enough to have observed many strange airborne objects flitting around the place, largely at night. "Sophisticated aircraft" is what I call them," says New Mexico State Policeman Gabe Valdez. "I don't call them UFOs."

Valdez, who's married and has two sons, has been with the State Police for twenty years, most of which have been spent at Dulce, a small, sparsely-populated town nestled in the picturesque, rugged hill country of northernmost New Mexico. By request, Valdez has recently been relocated to the Albuquerque office, where his UFO interest rarely involves more than memories of his days in Dulce and the times he has taken visitors to Archuleta Mesa, a region where an opening to the base is said to be located.

Last year, *UFO* was treated to a rumbling up-hill ride in his weathered pick-up truck, which refused to go more than a few yards up the steep, rocky ravine that led to the site. The passage was choked with thick, tangled underbrush, yet Valdez valiantly tried to coax the truck up and on. He wanted to point out at least one bit of what Bennewitz had called evidence. "I've seen it," Valdez said, "A burned tree branch where Paul said a nuclear craft crashed up there."

Though Valdez says he's never seen anything close to what the rumors would have UFO buffs believe, he admits that high strangeness has indeed been evident. The first glimmers came along when Valdez looked into a local cow mutilation in 1972. Other mutes occurred over a 10 year period, but stopped in 1982, just about the time Bennewitz and his research were

cresting into the awareness of some UFO researchers.

Valdez now calls the Lear-Bennewitz info an 80-20 proposition: "There's 80 percent accuracy in that there's been a lot of military activity sighted around Archuleta Mesa," he explained. "I've seen big, dark green

Chinook helicopters flying around there all the time . . . I don't have any proof (that the military is involved in UFO phenomena) but I can see it's true that the military have been here. What they're doing I don't know.

"The 20 percent is theorizing—not factual stuff. Not necessarily accurate."

But he doesn't completely write off the rumors: "Like I told you. (The info) has not only come from Bennewitz, but from other people, too, who I don't think have a connection with Bennewitz. I know four or five other people, different cases, who have been hypnotized and came up with the same information as Bennewitz. Or some may have read the Bennewitz stuff and are trying to fabricate it—that I don't know."

But his recall of "sophisticated aircraft" summons a sort of low-key amazement from the lawman. "What I saw could fly right up against the walls of the canyon," he said. "Pilots know if you do that there's a good likelihood of crashing."

"If (the craft) came from another planet, I don't know. But if we have that technology with *our* aircraft, we don't have to worry about our national security."

In brief...

Bill Poynter

Bill Poynter is a clinical social worker specializing in marriage and family counseling. With some recent new additions to his clientele, his approach has illumined a largely-unrecognized facet of what the psychotherapeutic community has called *post-traumatic stress syndrome*.

Practicing in Van Nuys, California, Poynter was recently put in touch with organizers of the Southern California Abduction Research and Support Group, who recently channeled several abductees into his care. In assisting these unusual clients, Poynter has

discovered their psychological condition closely matches that of rape or assault victims—with one outstanding difference. "Abduction is different than other forms of PTSS in that the condition can be continuing," he comments. "These people exhibit a lot of fear of the unknown, believing the stressful events can happen again at any time."

Poynter has used hypnosis, but his approach is less investigative than clinical: "I prefer a relatively indirect technique," he says. "When these people go back to the source of the trouble, digging up repressed material, I want to help them know there are ways to deal with their lives effectively," he says.

"Direct hypnosis suggests the hypnotist has the power . . . I want to empower *them* as much as possible."

Into The Underground:

Bennewitz Legacy Begins With UFO Sightings At Kirtland Air Force Base

Just who is Paul Bennewitz? To the general public, that name means virtually nothing, but to the ufological underground, the name Paul Bennewitz easily conjures up visions of true UFO celebrity: a little bit mad scientist, a little bit victim, a dash of doomsayer and a whole raft of unsubstantiated stories that circulate madly throughout ufology.

Bennewitz' meteor of fame first arced over the UFO community almost 10 years ago. Since first becoming involved in UFO events at Kirtland AFB while doing high technology instrumentation at his own Thunder Scientific Corp. the man has faded into semi-obscurity, another casualty of the ufological meat-grinder.

Perhaps "meat-grinder" is an all-too-appropriate word; if any one named individual can be tabbed as a main source of what is currently referred to as the Lear material—grisly talk of underground UFO bases where aliens are processing human bodies for their own nourishment, while systematically and cruelly betraying the U.S. government—it's Bennewitz.

Sightings at Manzano

But it took awhile for his claims to reach that level of horror. Bennewitz says that in 1979 he viewed several UFOs taking off and landing in the vicinity of Manzano Weapons station, adjacent to the base and near his home, and after setting up a video system was able to capture footage which allegedly shows the UFOs.

Armed with this footage and still photos of alleged alien craft, Bennewitz alerted officials at Kirtland AFB, who subsequently interviewed him at his home and later at the base itself.

In documents retrieved through the Freedom of Infor-

mation Act by C.A.U.S. (Citizens Against UFO Secrecy), Bennewitz is described as having presented before Air Force officials the film and photographic "evidence" he'd collected over the months, which apparently showed a number of UFOs flying over the Albuquerque area.

One of the FOIA documents, a "Multipurpose Internal OSI Form" dated Oct. 28, 1980, states, "(Bennewitz) has several pieces of electronic equipment pointed at Manzano and is attempting to record high frequency electrical beam pulses . . . After analyzing the data collected by Dr. Bennewitz, Mr. Miller [Jerry Miller, GS-15, Chief Scientific Advisor for Kirtland AFB

Test and Evaluation Center] related the evidence clearly shows that some type of unidentified aerial objects were caught on film; however, no conclusions could be made whether these objects pose a threat to Manzano/Coyote Canyon areas."

Perhaps conclusions seemed premature to Miller, but in Bennewitz' mind, the UFOs were indeed an evil threat, and not just to military security at KAFB. "Paul became totally obsessed with this work and was convinced that the aliens were hostile," says John Lear, who himself promotes the same sort of information. "He was also obsessed with proving that the government was dealing with these aliens."

But according to more mainstream ufologists, the Air Force listened to Bennewitz' UFO claims as a courtesy, more interested in determining if he'd photographed identifiable classified aircraft rather than UFOs invading restricted areas. Much of his photographic "proof" was confiscated by the Air Force, according to some reports.

Alien Base At Dulce? Answer Still At Large

The debate over the existence of an alien base located under the Archuleta Mesa near Dulce, New Mexico has raged on since the early '80s. The scenario apparently started with claims of scientist Paul Bennewitz, who was recently reported to be under "alien surveillance." According to some reports, he has also been under psychiatric care, and "he never goes out anymore."

UFO researcher John Lear has more recently resurrected the issue, and although some noted researchers vehemently denounce the Bennewitz claims, others have stepped into the fray in support of the underground base information. One such individual, William Cooper, has flooded the UFO field with reports in which he confirms the existence of an alien facility in the mountains outside of Dulce. Yet Cooper, like Lear, is assailed by most ufologists as a perpetrator of dissension and disinformation.

Gabe Valdez, a New Mexico state trooper living in Dulce, has visited the location of the alleged site on five different occasions, yet still has not seen enough evidence to convince him that such a facility exists. But he won't dismiss the possibility.

Last fall, Valdez escorted a team of scientists to the cliff area. After the trip, one of the scientists reported seeing extraordinary UFO activity at night, witnessed in the company of one of the other members of the team. He also reported evidence of a crash at the site, possibly UFO-related. The discovery of broken and partially-burned trees in the area was upstaged by the recovery of a U.S. Government-issue ink pen, indicating evidence not only of a possible UFO crash, but the possibility of a government crash-retrieval operation as well.

Further discussions about Dulce with San Francisco-based ufologist Jim McCampbell, who for several years investigated Bennewitz' astounding claims, has revealed that *not one* of those claims—embedded in a 4½-inch thick file—was ever substantiated. He suggests gross in-

It is interesting to note that when C.A.U.S. received the Kirtland documents in response to their FOIA request for information about various UFO sightings alleged to have taken place on the base, the Air Force went beyond the terms of the request and supplied additional documentation *specifically revealing the story of Bennewitz' involvement.*

"Strangely enough, if OSI (Office of Special Investigations) hadn't volunteered the other documents, we wouldn't have known any better," writes Fawcett and Greenwood in *Clear Intent*. Greenwood now adds, "The point we tried to make in the book is that here was genuine Air Force interest at a time when they were not supposed to be doing any civilian investigation." Yet C.A.U.S. got the scoop from the Air Force without even asking. As *Clear Intent* establishes: Had the military not generously gone beyond the terms of the original FOIA request, "The story of Bennewitz involvement would still be safely locked away."

vestigative incompetence on the part of an Air Force colonel who apparently investigated the claims, possibly on behalf of the military. The colonel was assisted by the former Air Force intelligence agent whose name divebombed to ignominy in the MJ-12 imbroglio—Richard Doty.

With such suspicious characters, and material that can only loosely and very dubiously be considered as "evidence," it's impossible to make conclusions about

the existence of an underground alien base. Conceptually, however, such a base at Dulce is not all that far-fetched. New Mexico, after all, ranks right up there at the top in terms of UFO case history. The UFO crash and recovery documentation at Roswell, largely due to the efforts of Stanton Friedman and William Moore, stands as the most thoroughly researched and corroborated case in crash-retrieval history, with over 90 witnesses interviewed. (Friedman recently received a \$16,000 research grant from the Fund for UFO Research in order to determine or disprove existence of MJ-12.)


There does appear to be other evidence suggesting that Paul Bennewitz was not the only source of the Dulce claims; Lear has denied the rumor that his initial source, a female abductee, is the same female abductee connected with Paul Bennewitz. While I have not contacted either of these women, at least they have different names!

Len Stringfield's recent report on an Air Force photographer's assignment to record the close-up details of a 30-foot craft, inside and out, is indeed a benchmark of possibilities in the science of physics—the photographer reported that the inside of the craft was *ten times* the size of the space occupied on the outside! What force or dimension could account for this spatial contradiction?

And what with all the other recent events and information regarding MJ-12, Gulf Breeze, anonymous government intelligence informants and nationwide UFO radio and TV broadcasts such as "UFO Cover-Up? Live!," how long can we plead the "show me" Missouri state slogan? Something awesome seems to be taking place.

Even our children are being fed a steady diet of alien manipulation of humans. On Friday, Feb. 24 of this year, the nationally-syndicated cartoon show called "Gumby" was aired at its usual time slot. This episode showed the sudden appearance of a flying saucer, from which a swirling vortex descended and encircled Gumby, floating up and into the craft. In a small, round room, Gumby was met by two small grey aliens with large heads and big, black eyes. The aliens, standing beside an examining table, told Gumby that they needed his "vitality" because they were having trouble with their own DNA. An agreement ensued, involving a swap for technology. Sound familiar? Is someone trying to tell us something?

As the research continues, we continue to broaden our perspective. If an alien craft can be ten times larger on the inside than its outer dimensions, then the scope and capacity of the technology involved clearly suggest dimensional consideration. As for the cover-up and veil of secrecy around the UFO phenomenon, the most plausible justification to date could be the issue of economic impact, especially if we are consumed by a precarious David and Goliath technological scenario, as suggested by the Dulce underground base material. Possession of alien craft technology and the ability to duplicate it and utilize it could destroy all fossil-fuel related industries, and possibly diminish the value of precious elements as we now know them.

One thing we can all agree on is the obvious fact that we are tinkering with a cosmic Pandora's Box. Let's not forget—it could be ten times larger on the inside!

'Alien Terror' Might Be Deadly Disinformation

At the beginning of 1989, I received my copy of the January edition of *Missing Link*, a monthly newsletter published by UFO Contact Center International (UFOCCI) in Seattle, Washington. In it was a rather shocking article entitled "Summary & Report of Status—Project Beta," written by investigator-physicist Paul Bennewitz, the man who had made many of the original claims of underground bases run by devious aliens in conjunction with our government. Bennewitz has been able to walk in the light of some credibility due to his contribution to William Steinman's book, *UFO Crash at Aztec*.

But Bennewitz' article in the UFOCCI newsletter disturbed me greatly, making me feel as though well-cultivated seeds of *disinformation* were being planted, and would take root and induce new fears and unwarranted paranoia in UFO groups. His story presented self-conceived ideas about "saving us from the soulless alien force," and that this force is well-established on planet Earth in underground bases.

On Jan. 28, an open meeting of UFOCCI was

scheduled in Seattle, and although I half-way knew what to expect after reading *Missing Link*, I wanted to see what material would be presented.

The two-hour program produced by Aileen Edwards and associates was chock full of food for thought. It began with the MJ-12 operation list being written on a blackboard in front of us. Then we were presented with an array of oral readings, some of which we were allowed to examine afterwards. We were shown the "Dulce Papers," 14 xeroxed pages of vague description and obscure sketches of mutation tanks, baby aliens being grown in strange sacks and other bizarre aspects of what was alleged to be a particular underground base. We were told the origin of these papers was "unknown."

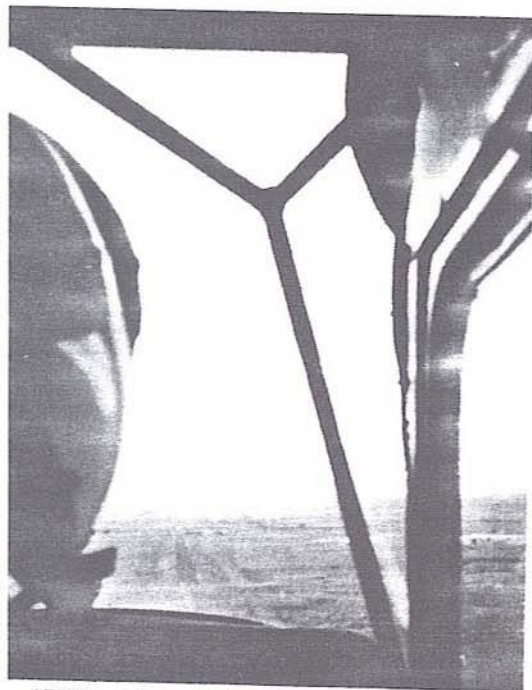
For the main course, we were read a long interview whose sources have asked to be kept confidential. Those interviewed not only indicated that Earth government superpowers are in league with these grey aliens in an underground base somewhere in Europe, but also mentioned involvement by the Mafia and the Pope! It *did* leave a person wondering . . .

Also on the evening's menu was a letter from the "Alien Nourishment Project," asking for first-hand information on alien dietary habits. Then a so-called cattle mutilation was offered as dessert. After all this and more, a question-and-answer period was provided in which no questions were really answered, because they couldn't be. Then it was lights out and movie time—I found this a good opportunity to leave before making an ass of myself.

Fear and Loathing . . .

Now, I wish to express my opinion of the fear-and-loathing tactics being used by many people currently associating themselves with the field of ufology. I believe Paul Bennewitz is one of those people, utilizing the openness and receptivity of UFO organizations and publications such as UFOCCI and *Missing Link* to pass on scenes of terror. I should state, however, that the UFOCCI meetings are very important to many of us in the Northwest, and that Aileen Edwards devotes herself wholeheartedly to guiding many through the initial impact of what some have termed the visitor experience (me included.) She also devotes considerable energy, time and money in producing a paper in which she gives everyone equal time to express their own opinion. (I have written for it under the pseudonym Rene DeSoto.) Her organization now has chapters all over the country which aid in the support and study of personal UFO and alien encounters, as well as hosting contact meetings which are closed to the public. Edwards presents the information she gathers and asks people to form their own opinions. I do not intend to discredit any of her operations; I only wish to express my concern for the direction that people like Bennewitz may be leading already emotionally-strained individuals.

Bennewitz claims to have monitored one alleged alien base for two continuous years, by means of electronic surveillance and constant reception of video transmissions from the alien's ships and underground bases. If the story had focused on just that information alone, it would have been digestible. But it did not. Bennewitz

proposes an all-out war, the total annihilation of these "mad dog" invaders. He calls on us as Americans to band together against these totally deceptive, death-oriented greys.

Nazi Overtones?

Yeah, right! Let's all go out and join with the government to kill this menace to American society. Where do I sign up? To marshal support for Mom, apple pie and the American way, Bennewitz engages our emotions of fear, hatred and prejudice. His suggestions evoke the essence of Nazi Germany, another "patriotic," nationalistic call-to-arms to rid the planet of an inferior race, something I seem to remember of recent Earth history.

When I reached the Bennewitz story in William Steinman's otherwise invaluable research book, and read about the dastardly alien deeds, I found it all scary but a little hard to swallow. My first thought was, "Someone has gotten to that boy. I don't know if it's aliens or the government, but someone has gotten to him . . ."

Now it appears it's just the tip of the iceberg of what Bennewitz and others like him are capable of unleashing. Only a few years ago, Bennewitz was labeled a kook and was highly discredited. Now, in light of so much new information on government UFO cover-up and scandal, it's not surprising that this type of disinformation is being fed to the public and in turn impressing and infiltrating the minds of those in UFO organizations.

Disinformation was once explained to me as a lie masquerading as the truth, then pulling a 180-degree turn and becoming the truth appearing to be a lie. What ap-

pears on TV is a good example of how this works. The images are so real that they can sell us anything, yet are based oftentimes on full or semi-falsehoods dreamed up in Hollywood or on Madison Avenue. Take the popular TV series, "War of the Worlds," which just happens to parallel the type of information Bennewitz purveys. In this new weekly take-off on an old sci-fi movie, a group of young and attractive special forces government agents runs around doing a pretty successful job in stopping this alien threat to all that is sacred.

Image Formation

After seeing an episode recently, I was all but convinced that Bennewitz was on the staff of "War of the Worlds" writers. What we are being shown on a mass

media level is that the aliens are *bad* and that the well-armed "agents" going after them are *good*. The images we form from this may or may not have anything to do with reality—to me, it appears to be just another government plot to throw us off the track. For years now, the government has been telling people who have had UFO experiences first-hand and have seen aliens with their own eyes that the really *haven't* seen these things, that they're crazy or victims of mass hysteria. But now things on the "alien front" are coming to a head, the pimple has to pop sooner or later and now the government is working on a new plan. Since they've found they can't make us *not* believe in flying saucers or space people, they're trying like hell to scare us off or re-direct the energy into a vein of skepticism and distrust. Perhaps the government has a tricky little code name for it: Operation SCARED—Sabotage Civilian Alien Reactions by Engendering Distrust. Of course I am just making this up, but it does seem to fit!

Fear, hatred and intimidation have always been the most successful weapons in any form of combat. In 50,000 years of human life as we know it on this planet, very little has changed. We are still mighty afraid of things that go bump in the night—and if that's not enough to worry about, we have a fundamentalist version of the Almighty God to fear, a God who oversees our every move and helps us make judgements on ourselves and others. In my opinion, there is no separation of Church and State. If one were to collapse, the other in turn would go to hell.

Small Town Racists

In the same way, if entrenched racism were to disappear, the government's Operation SCARED would also fall apart! It was kind of ironic—I received my copy of the newsletter with Bennewitz' wild claims on Martin Luther King day, right after I had left a small-town pub where

I'd witnessed two men happily talking about it being "open season on niggers" day. I asked them why, and was told because they are a different color from us, didn't belong here and should go back to Africa where they came from. I laughed aloud and thought to myself, "Boy, are these good ol' boys in for a surprise!" and then hustled out of there before I got myself in trouble.

When I got home, the newsletter was awaiting me in the mailbox. Upon finishing it, I laughed out loud and yelled to the sky: "The only good alien is a DEAD alien!" I didn't think anyone could take the man seriously, and yet on the last Saturday in January discovered I was wrong. I also had the disturbing feeling that I was the only one in the room with a contrary opinion. Bennewitz claims to have developed a beam weapon that will bring down alien ships, and says the weapon is marketable. After sitting in on that open meeting of UFOCCI, I think it would be fair to say that if Bennewitz had been there selling it, everyone in the room would have bought. It's the alleged "greys" who are held responsible for all this ungodly traipsing around in the dark, yet they are said to make up only two percent of the alien activity on our planet. Why, then, shall we give them so much power? Because we are afraid? Just who is sparking that fear?

The inculcated scenario of abductions and mind implants can indeed set up dominoes of paranoia—but it's not the aliens I would be afraid of. Couldn't those in authority use the scenario to foster an all-out manhunt? *You know who you are . . . the greys are liable to flip the switch and turn you into an android alien Army, bent on destruction of God, country and everything sacred . . . What, then, should we do with you? . . . You can't be trusted . . . You are marked . . . You are one of them . . . Concentration camps might not be such a bad idea . . . There, the government can keep an eye on you and do experiments to find out how alien you really are! . . . That might keep the planet safe . . . Besides, building these camps might be good business . . . lots of new federal jobs . . . Real good for the nation's economy . . .*

You get the idea. But if my theory is correct, we really have nothing to worry about. I don't think we're advanced enough to be any trouble at all. And perhaps it's our turn to be the chimpanzee. What I do know is that we cannot fight a technologically advanced civilization and expect to win; the American Indians tried and failed. They were conquered and absorbed by the almighty white man, and most of their peoples were slaughtered. Now their ancestors reside in a softened kind of concentration camp known as reservations.

In the last 50 years, close encounter stories have become commonplace, or at least more frequent. More and more of us have had some kind of strange experience which we try to fit into our framework of reality. More and more of us are looking up and knowing we're not alone. More and more of us want to know what the government knows but won't tell us. It's the government that does the real damage in this situation—the truth of the matter is that the largest percentage of aliens aren't hurting anyone, other than blowing a few minds, perhaps. The aliens just get in their vehicles, come here to visit, collect a few samples and split. In many cases they cultivate relationships and even

friendships; their actions seem very human to me. And with the attitude of prejudice on the planet as strong as it is, you can hardly blame them slipping in covertly. To hell with their motives. They know what their motives are.

It's our own motives we should be concerned with. Paul Bennewitz and others like him who lean toward this kind of terroristic sensationalism ought to limit their brand of poison pen to the supermarket tabloids. Serious UFO investigation has neither the time nor the room nor the patience for it. The kind of b.s. he hands out would be impossible even for the aliens to swallow—and I'm told they'll eat anything.

But this intense brand of fear is conquerable, through the unsinkable human spirit. If it weren't conquerable, people like me couldn't continue to investigate the phenomenon and keep a sense of humor at the same time.

Bennewitz' Allegations May Have Factual Basis

Many dependable UFO researchers denounce the entire underground bases-hostile aliens scenario, some questioning Bennewitz' mental stability. Yet his wild claims have some basis in legitimate UFO events which continue to trouble the military. In a number of instances, "unidentifieds" have invaded restricted airspace and compromised otherwise secure weapons installations, if FOIA documents validating such events can be believed. Some people further believe that because he got too close to the real story, Bennewitz was quickly "handled" by the intelligence faction of government. "I firmly believe he was on to something but by design was distracted and discredited," says Army ROTC Sergeant Clifford Stone, another renegade involved in UFO phenomena.

Paul Bennewitz could not be reached for comment. His son Jeff says his father has not been responding to other media inquiries. Jeff Bennewitz described his father's life-long interest in the UFO subject, however: "I remember when I was a child he used to pull out scrapbooks and photos filled with UFOs," he said. "But my father has been quiet with his research. He's not the type to take out banner headlines." And, refuting one counter-rumor, Jeff Bennewitz said his father has never been hospitalized for mental difficulties.

In the early stages of the saga, ufologist Jim McCampbell interviewed Bennewitz, obtaining many incredible details about the alleged alien bases and active though regretted participation by high-level agencies of the U.S. government. Lt. Col. Ernest Edwards, security official at Kirtland Air Force Base and one of the principals involved in the official meetings with Bennewitz, at one point indicated some sympathy for him and did verify the UFO incidents that had occurred at the base.

When contacted again by *UFO* for their comments, both McCampbell and Lt. Col. Edwards refused to discuss any aspect of the matter. —V.C.



The Dulce Base

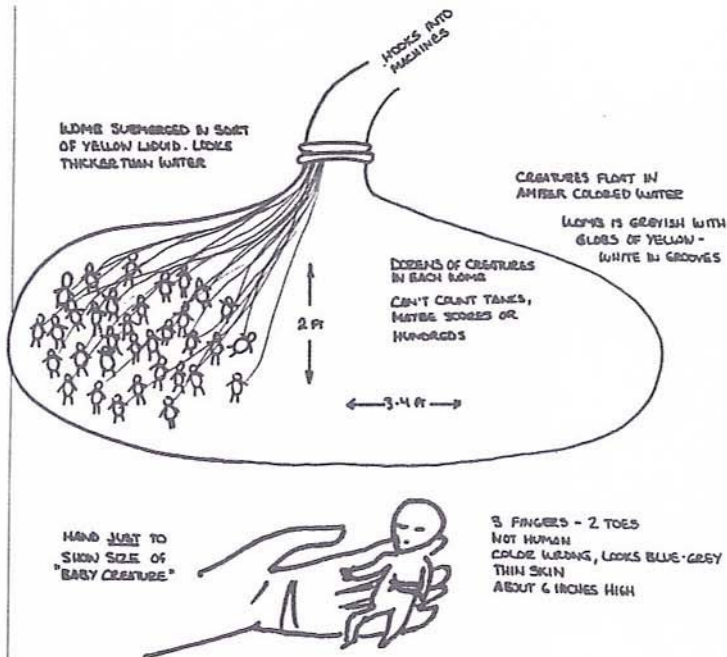
Jason Bishop, III (pseudonym) sent UFO a seven-page written report of his "ongoing investigation" into the Dulce base, from which the following is excerpted. Other "reports" from other "researchers" harp on the same general theme.

This information is meant for those who are seriously interested in the Dulce Base. For your own protection, be advised to USE CAUTION while investigating this Complex.

This facility is a "GENETICS LAB" and is connected to Los Alamos via a tube shuttle. Part of their research is related to the Genetic Effects of radiation (mutations and human genetics. Its research also includes other "intelligent species" (Alien Biological

Whose Planet Is This . . . ?

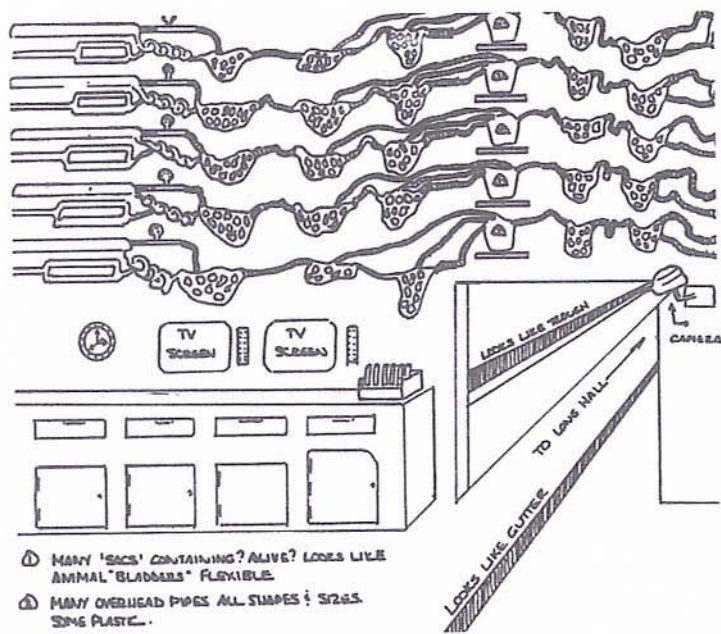
These aliens consider themselves

"Native Terrans."

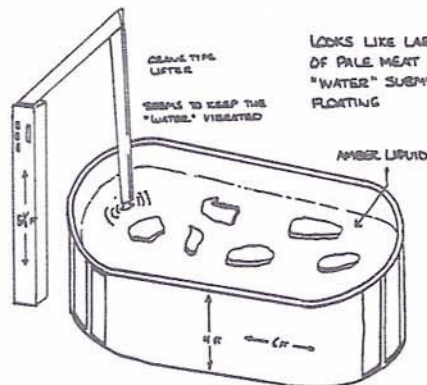

"Surviving The Future"

The DULCE FACILITY consists of a Central "HUB," the Security Section (also some photo labs). There are over 100 Secret Exits near and around Dulce. Many around Archuleta Mesa, others to the south around Dulce Lake and even as far east as Lindreth. Deep sections in the Complex connect into natural Cavern Systems.

A person who worked at the Base, who had an "ULTRA 7" Clearance, reports: "There may be more than seven Levels, but I only know of seven. Most of Aliens are on 5-6-7 Levels. Alien housing is Level Five."

Level No. 6 is privately called "Nightmare Hall." It holds the Genetic Labs. Reports from workers

who have seen bizarre experimentation are as follows: "I have seen multi-legged 'humans' that look like half human/half-octopus. Also Reptilian-humans, and furry creatures that have hands like humans and cry like babies. It mimics human words . . . also huge mixture of Lizard-humans in cages." There are fish, seals, birds and mice that can barely be considered those species. There are several cages (and vats) of Winged humanoids, grotesque Bat-like creatures . . . but 3½ to 7 ft. tall. Gargoyle-like Beings and Draco-Reptoids.

Level No. 7 is worse, row after row of thousands of humans and human mixtures in cold storage. Here too are embryo storage vats of Humanoids, in various stages of

development.

"I frequently encountered humans in cages, usually dazed or drugged, but sometimes they cried and begged for help. We were told they were hopelessly insane, and involved in high-risk drug tests to cure insanity. We were told never to try to speak to them at all. At the beginning, we believed that story. Finally in 1978, a small group of workers discovered the truth. It began the Dulce Wars" (and a secret resistance Unit was formed). Note: There are over 18,000 "Aliens" at the Dulce Base.

In late 1979, there was a confrontation (over weapons), a lot of Scientists and Military personnel were KILLED. The base was closed for awhile . . . But it IS currently active. Note: Human and animal abductions (for their blood and other parts) slowed in the mid-1980s, when the Livermore Berkeley Labs began production of artificial blood for Dulce.

ABDUCTIONS

In the Fifties, the EBES ("Greys") began taking large numbers of humans for experiments. By the Sixties, the rate was speeded up and they began getting careless (they didn't care). By the Seventies, their true colors were very obvious, but the "Special Group" of the Government still kept covering up for them. Note the number of high ranking commanders (CC) in that meeting with Dr. Bennewitz, Including Gen. Brooksher.

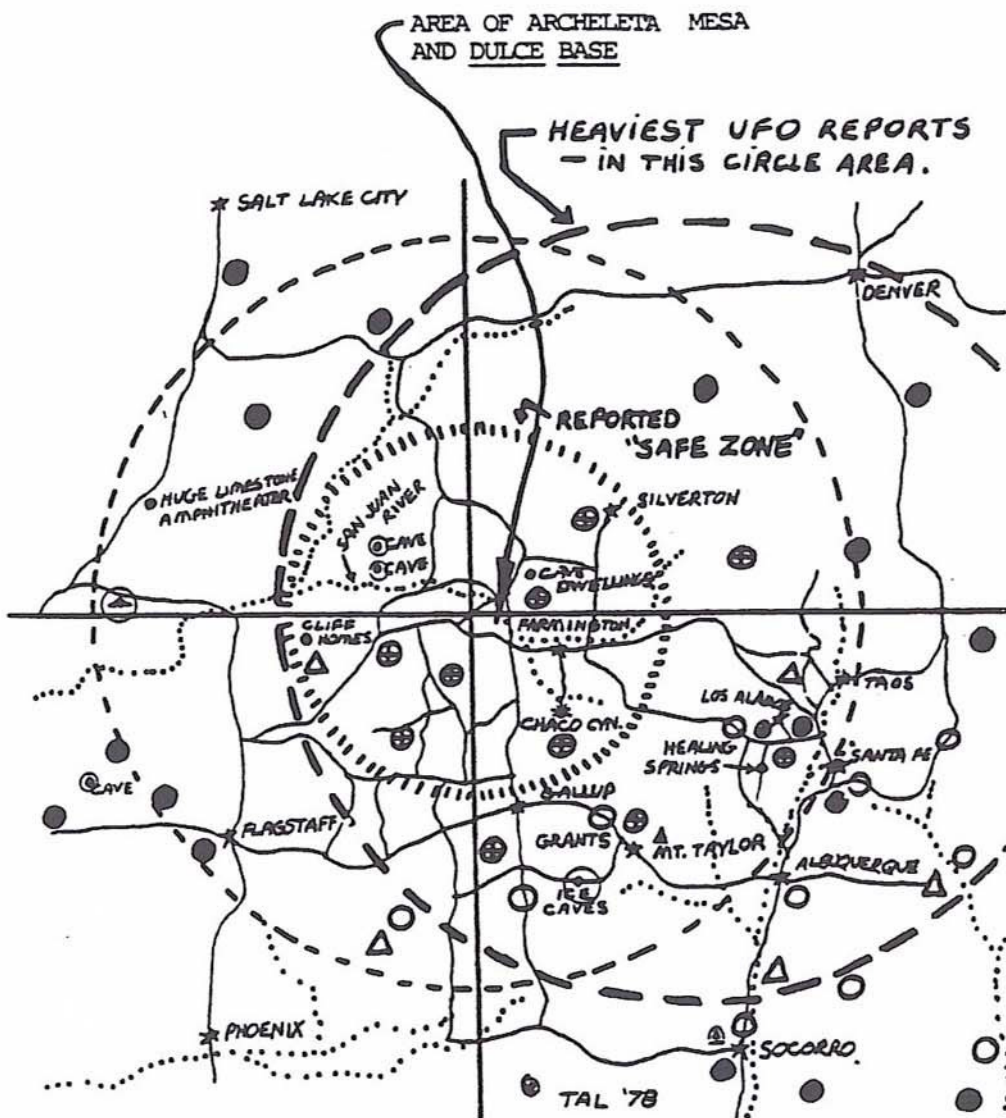


THE DULCE PAPERS

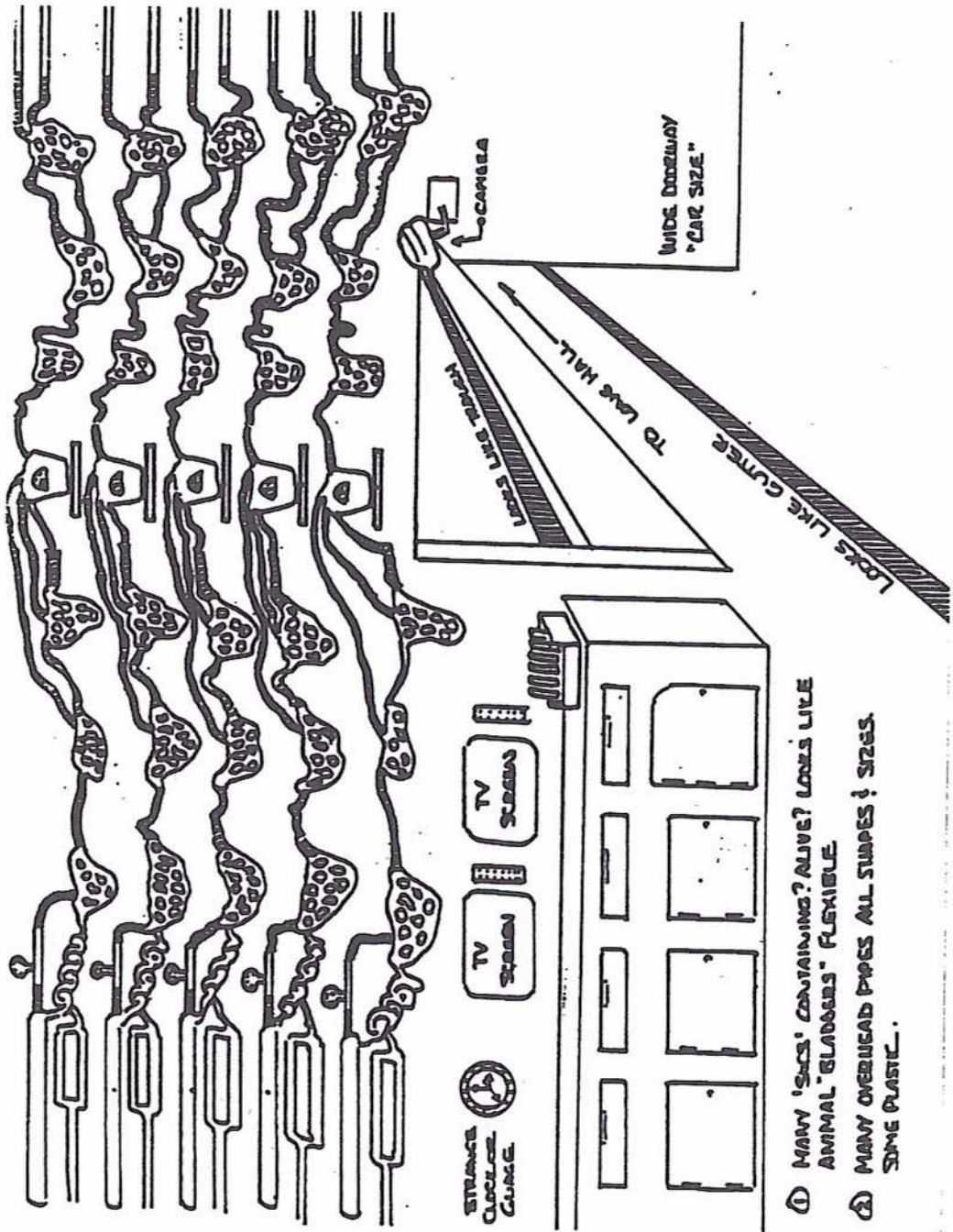
The Dulce papers were comprised of 25 black and white photos, a video tape with no dialogue and a set of papers that included technical information of the alleged jointly occupied (U.S.-Alien) facility 1 kilometer beneath the Archuleta Mesa near Dulce, New Mexico. Several persons were given the above package to hold for safekeeping. Most of those given the package were shown what the package contained but were not technically oriented and knew very little about what they were looking at. The following was written by one of these persons about what the papers contained. This person described the scenes that the video tape showed and made the attached pencil drawings of some of the photos. What you see is what you get; I can't decipher what is written or drawn anymore than you can. I pass these papers on only in the interest of getting to the truth. From other information I have I believe the information contained herein is true. I believe the facility exists and is currently operational. I also believe that there are 4 additional facilities of the same type, one located a few miles to the southeast of Groom Lake, Nevada. What is the truth? Only God, MJ-12 and the aliens know for sure.

Dulce papers: Lots of papers—documents that discuss copper and molybdenum, also papers about magnesium and potassium, but mostly about copper. Lots of 'medical terms' that I don't understand. A sheet of paper with charts and strange diagrams. Papers that discuss ultra violet light and gamma rays. Papers that discuss color and black and white and how to avoid detection through use of certain colors. In addition to these papers there are about 25 pictures, black and white, plus one video tape with no dialogue, all taken inside of the Dulce facility. These papers tell what the aliens are after and how the blood (taken from the cows) is used. Aliens seem to absorb atoms to 'eat'. Aliens put hands in blood, sort of like a sponge, for nourishment. It's not just food they want, the DNA in cattle and humans is being altered. The 'Type One' creature is a lab animal. "They" know how to change the atoms to create a temporary "almost human being". It is made with animal tissue and depends on a computer to simulate memory, a memory the computer has withdrawn from another human being. The 'almost human being' is slightly slow and clumsy. Real humans are used for training, to experiment and to breed with these "almost humans". Some humans are kidnapped and used completely (even atoms). Some are kept in large tubes, and are kept alive in an amber liquid. Some humans are brainwashed and used to distort the truth. Certain male humans have a high sperm count and are kept alive. Their sperm is used to alter the DNA and create a non-gender being called "Type Two". That sperm is grown some way and altered again, put in large wombs, many destroyed, certain are altered again and then put in separate wombs. They resemble 'ugly humans' when growing but look normal when fully grown which takes only a few months from fetus size. They have a short life span, less than a year. Some female humans are used for breeding. Countless women have had a sudden miscarriage after about 3 months pregnancy. Some never knew they were pregnant. Others remember contact some way. The fetus is used to mix the DNA in types one and two. The atomic makeup in that fetus is half human, half "almost human" and would not survive in the mothers womb. It is taken at 3 months and grown elsewhere.

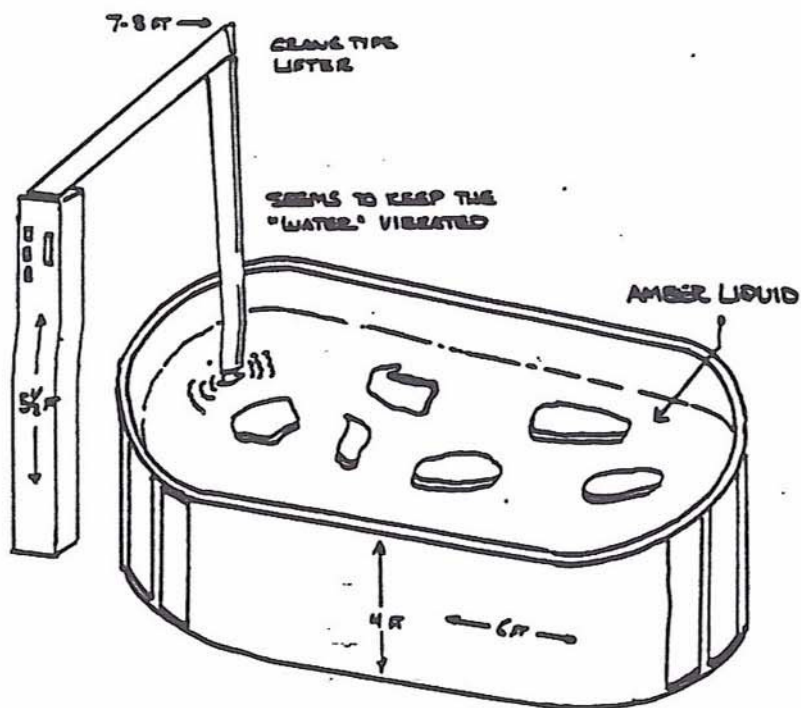
Event Characteristics of Four Corners Area



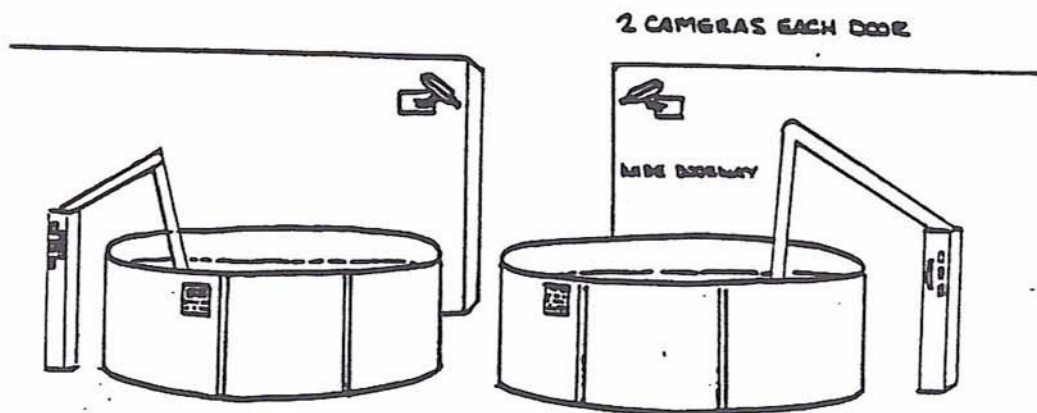

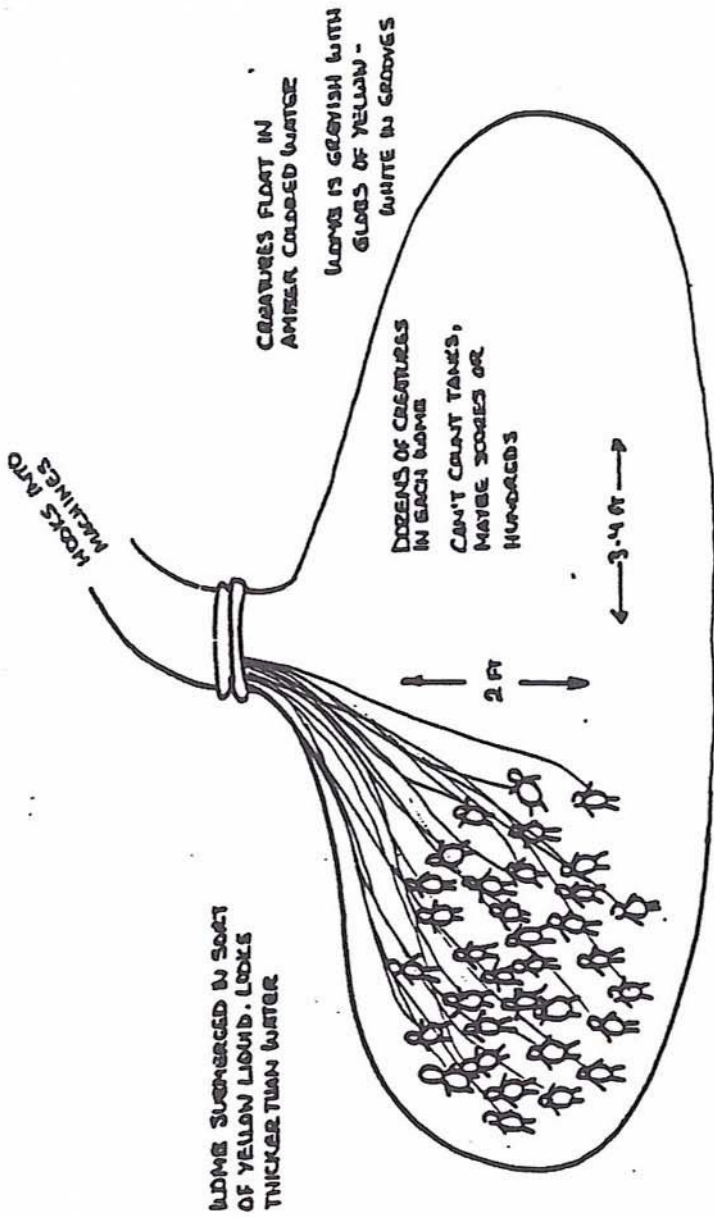

THE CASE OF PAUL BENNEWITZ

Paul Bennowitz, who prefers to be called Dr. Bennowitz, is President of Thunder Scientific Company in Albuquerque, New Mexico.

He lives next to the Manzano Weapons Storage Area, near Sandia Base in Albuquerque. Paul noticed strange activity over the area and decided to put his resources together and photograph what he saw. After thousands of feet of film, he was convinced that something was happening there, and decided that he should try to communicate with whatever was flying over the area. Through a computer, using a code, he succeeded in making contact with whomever was flying the disks over the area. Gradually, he learned that whoever the aliens were, they were basically not friendly, and after a while he was able to develop a psychological profile of the aliens based on his contact with them.

The following list of items was extracted from a report called Project Beta, which Bennowitz apparently gave to the United States Government in 1983. Also in the report were his recommendations for dealing with the aliens, which the Government (already aware of the aliens) decided to ignore. As publicity grew regarding what Paul has discovered, he withdrew his public contact and would no longer have contact with anyone. We were fortunate to have contact with him, and we understand that as of May 88 he is talking with people again.

Be advised. Paul has undergone a lot of stress, both from his experiences and from the government. If you do decide to contact him, take it easy, ok?

The attached papers are known as the "Kirtland Documents". Most are available through the Freedom of Information Act. One notable exception is the telex from Bolling AFB DC//IVOE (Air Force Intelligence/Counterintelligence) to Kirtland AFB BID (Base Investigative Attachment). This document was obtained by Ufologist William Moore from undisclosed sources. There is a rumor that Moore made several changes on the document. One of these changes is reported to be the change of NSA to read NASA near the end of the telex. Below are several abbreviation definitions:

Dr. Paul F. Bennowitz, President of Thunder Scientific Laboratories in Albuquerque, who is mentioned in several of the documents claims to have about 6000 feet of 8mm and video pictures of UFO's operating in the Manzanera nuclear weapons storage area taken from his porch which had an unobstructed view of the depository. He also claims that while some of the film was being developed by Kodak, that someone removed various sections of the film that contained close up shots of UFO's. One particular movie film took 2 months to process and was received with several feet missing and was on a different negative than that originally filmed, according to Bennowitz.

SUMMARY OF INFORMATION

On 13 Aug 80, 1060 COMSg Maintenance Officer reported Radar Approach Control equipment and scanner radar inoperative due to high frequency jamming from an unknown source. Total blackout of entire radar approach system to include Albuquerque ART was in effect between 1630-2215hrs. Radar Approach Control back up systems were inoperative.

On 13 Aug 80, Defense Nuclear Agency Radio Frequency Monitors determined, by analysis, the interference was being sent from an area (V-20 degrees or due) on DAF Map coordinates E-28.6. The area was located NW of Coyote Canyon Test. It was first thought that Sandia Laboratory, which utilizes the test range responsible. However, after a careful check, it was later determined that no tests were being conducted in the canyon area. Department of Energy, Air Force and DNA were contacted but assured that their agencies were not responsible.

On 13 Aug 80, Base Security Police conducted a physical check of the area but due to the mountainous terrain, a thorough check could not be completed at that time. A later foot search failed to disclose anything that could have caused the interference.

On 13 Aug 80, at 2215hrs., all radar equipment returned to normal operation without further incident.

CONCLUSION: The presence of hostile intelligence jamming cannot be ruled out. Although no evidence would suggest this, the method has been used in the past. Radar maintenance specialists cannot explain how such interference could occur. Radar equipment to become totally inoperative. Neither could they suggest type or range of the interference signal. DNA frequency monitors reported the interference beam was wide spread and a type unknown to their electrical equipment. Further check of the area was being conducted by Technical Services, AFOSI.

SUMMARY OF INFORMATION

REMARKS

- On 2 Sept 80, SOURCE related on 8 Aug 80, three Security Policemen assigned to 1608 SPS, KAFB, NM, on duty inside the Marzano Weapons Storage Area sighted an unidentified light in the air that traveled from North to South over the Coyote Canyon area of the Department of Defense Restricted Test Range on KAFB, NM. The Security Policemen identified as: SSGT STEPHEN FERENZ, Area Supervisor, AIC MARTIN W. RIST and AMN ANTHONY D. FRAZIER, were later interviewed separately by SOURCE and all three related the same statement; At approximately 2350hrs., while on duty in Charlie Sector, East Side of Marzano, the three observed a very bright light in the sky approximately 3 miles North-North East of their position. The light traveled with great speed and stopped suddenly in the sky over Coyote Canyon. The three first thought the object was a helicopter, however, after observing the strange aerial maneuvers (stop and go), they felt a helicopter couldn't have performed such skills. The light landed in the Coyote Canyon area. Sometime later, three witnessed the light take off and leave proceeding straight up at a high speed and disappear.
- Central Security Control (CSC) inside Marzano, contacted Sandia Security, who conducts frequent building checks on two alarmed structures in the area. They advised that a patrol was already in the area and would investigate.
- On 11 Aug 80, RUSS CURTIS, Sandia Security, advised that on 9 Aug 80, a Sandia Security Guard, (who wishes his name not be divulged for fear of harassment), related the following: At approximately 0020hrs., he was driving East on the Coyote Canyon access road on a routine building check of an alarmed structure. As he approached the structure he observed a bright light near the ground behind the structure. He also observed an object he first thought was a helicopter. But after driving closer, he observed a round disk shaped object. He attempted to radio for a back up patrol but his radio would not work. As he approached the object on foot armed with a shotgun, the object took off in a vertical direction at a high rate of speed. The guard was a former helicopter mechanic in the U.S. Army and stated the object he observed was not a helicopter.
- SOURCE advised on 23 Aug 80, three other security policemen observed the same

aerial phenomena described by the first three. Again the object landed in Coyote Canyon. They did not see the object take off.

5. Coyote Canyon is part of a large restricted test range used by the Air Force Weapons Laboratory, Sandia Laboratories, Defense Nuclear Agency and the Department of Energy. The range was formerly patrolled by Sandia Security, however, they only conduct building checks there now.

6. On 10 Aug 80, a New Mexico State Patrolman sighted a/aerial object land in the Manzano's between Belen and Albuquerque, NM. The Patrolman reported the sighting to the Kirtland AFB Command Post, who later referred the patrolman to the AFOSI Dist 17. AFOSI Dist 17 advised the patrolman to make a report through his own agency. On 11 Aug 80, the Kirtland Public Information office advised the patrolman the USAF no longer investigates such sightings unless they occur on an USAF base.

7. WRITER contacted all the agencies who utilized the test range and it was learned no aerial tests are conducted in the Coyote Canyon area. Only ground tests are conducted.

8. On 8 Sept 80, WRITER learned from Sandia Security that another Security Guard observed a object land near an alarmed structure sometime during the first week of August, but did not report it until just recently for fear of harassment.

9. The two alarmed structures located within the area contains HQ CR 44 material.

Dr. BENNEWITZ presented film and photographs of alleged unidentified Aerial Objects photographed over KAFB, NM during the last 15 months. 3. On 26 Nov 80, SA DOTY received a phone call from an individual who identified himself as U.S. Senator HARRISON SCHMIDT, of New Mexico. SEN SCHMIDT inquired about AFOSI'S role in investigating the serial phenomena reported by Dr. BENNETTZ. SA DOTY advised SEN SCHMIDT that AFOSI was not investigating the phenomena. SA DOTY then politely referred SEN SCHMIDT to AFOSI Dist 17/CC. SEN SCHMIDT declined to speak with 17/CC and informed SA DOTY he would request that SAF look into the matter and determine what USAF agency should investigate the phenomena.

THE CASH-LANDRUM INCIDENT

Note also the references to the so called Cash-Landrums Incident, where at 9:00 PM on 29 December 1980 Dayton, Texas Café Owner Betty Cash 56 and former waitress Vickie Landrum 67 and Landrum's grandson, Colby Landrum, 11, driving to their home in Dayton along a two lane road about 30 miles northeast of Houston, encountered a brightly glowing craft the size of a city water tower hovering at tree top level. It had red and orange flames flowing from its bottom that bathed the party in intense heat for several minutes before it was *escorted away by at least 23 helicopters.*

The case was investigated by John Schussler who suggested that the craft must have belonged to the U. S. government, because nobody else could put up 23 helicopters all at the same time. Cash and Landrum now suffering from radiation effects brought suit against the U. S. Government for failing to warn and protect them. The suit was dismissed by U. S. District Judge Rosa Sterling, but the government ended up paying for the party's medical treatments for radiation exposure before they died.

Now we find that the U. S. Government was culpable after all, because they were the actual owners and operators of that craft in trouble over Texas. And that craft was one of several that were delivered to us by alien extraterrestrial beings in exchange for operating facilities on the surface of our planet!

The Cash-Landrum Incident

This incident was well-publicized at the time. The newspaper article below goes into some of the overt details. Several "inside" sources have revealed, however, that this was one of the craft that the EREs gave to the U.S. Government, and that it was having critical problems that prompted its descent. The people involved were bathed in neutron radiation from the craft. It is interesting to note that in the next to the last paragraph of the article, the lawsuit changes to one claiming that the craft actually belonged to the government. Note the reference to 23 helicopters. Think about it....

They claim it was an unidentified flying object that was escorted away by military helicopters. They say they suspect it was a secret U.S. military experiment. In any event, they say, the government should have warned residents that a UFO was in their area.

The military says it had nothing to do with the alleged occurrence Dec. 29, 1980, on a rural road northeast of Houston. Even if there were UFOs, a U.S. attorney says, the government has no duty to warn people about them because the government does not know whether they are dangerous.

With such straightforward arguments, the government is urging U.S. District Judge Ross Sterling to throw out a lawsuit filed here last year by former Dayton, Texas, cafe owner Betty Cash, 56, former waitress Vickie Landrum, 61, and Landrum's grandson, Colby Landrum, 11.

The suit claims that about 9 p.m. on Dec. 29, 1980, while headed for their homes in Dayton along a two-lane road about 30 miles northeast of Houston, the three encountered a brightly glowing craft the size of a city water tower. It hovered at treetop level, had red and orange flames flowing from its bottom, and bathed them in intense heat for several minutes before it was escorted away by at least 23 helicopters, they assert.

Their lawsuit, filed under the Federal Tort Claims Act, claims that the government failed to warn them of the UFO and "negligently, carelessly and recklessly" allowed it "to fly over a publicly used road and come in contact with the plaintiffs."

As a result, all suffered stomach pains, vomiting, diarrhea, radiation burns, deteriorating eyesight, and the women's hair fell out and grew back with a different texture. The suit claims it also says they became highly sensitive to sunlight, suffered blisters and headaches, and that Cash developed breast cancer.

Despite the plaintiffs' report that there were no markings on the "large, unconventional aerial object" or on the helicopters, the lawsuit has recently moved from simply suggesting that the government merely knew about the UFO to saying that the government owned the UFO.

The government has offered affidavits from high-ranking officials that it had nothing to do with the UFO.

The report that follows is called " Project Beta ". Only 16 of 17 pages were available. Despite many errors in grammar and punctuation, it stands as an excellent report about the aliens that Bennewitz observed at Manzano Weapons Storage Area near Sandia Base in Albuquerque, New Mexico. It is the same report that Bennewitz presented to the U.S. Government. Bennewitz was unaware that the people to whom he submitted the report already knew of the alien activity. He also was not aware of interactions with other alien groups that were taking place.

SUMMARY & REPORT OF STATUS
[WITH SUGGESTED GUIDELINES]

PROJECT BETA

Investigator - Physicist - Paul F Bennewitz

The following are key mile posts established or discovered during the continuing scientific study concerning Alien intervention and the result. (Study limited solely to New Mexico)

- 1) Two years continuous recorded electronic surveillance and tracking with D.F.^o 24 hr/day data of alien ships within a sixty (60) mile radius of Albuquerque plus 6000 feet motion picture of same - daylight and night.
- 2) Detection and disassembly of alien communication and video channels - both local, earth, and near space.
- 3) Constant reception of video from alien ship and underground base viewscreen; Typical alien, humanoid and at times apparent Homo Sapien.
- 4) A case history of an Encounter Victim in New Mexico which lead to the communications link and discovery that apparently all encounter victims have deliberate alien implants along with obvious accompanying scars. The victim's implants were verified by x-ray and Cat Scan. Five other scar cases were verified.
- 5) Established constant direct communications with the Alien using a computer and a form of Hex Decimal Code with Graphics and print-out. This communication was instigated apparently after the US base was vacated.
- 6) Through the alien communication loop, the true underground base location was divulged by the alien and precisely pin-pointed.
- 7) Subsequent aerial and ground photographs revealed landing pylons, ships on the ground - entrances, beam weapons and apparent launch ports - along with aliens on the ground in electrostatically supported vehicles; charging beam weapons also apparently electrostatic.

- 8) Cross correlation and matching by triangulation, etc., to official NASA CIR (color infrared) high resolution films confirmed base locations and resulted in revealing US Military involvement yielding precise coordinates and the US base layout.
- 9) Prior alien communication had indicated military involvement and the fact the USAF had a ship but due to studied alien psychology this was ignored at the time.
- 10) Subsequently, the alien communicated following verification with the CIR, that there was indeed a ship; actually more than one - that two were wrecked and left behind and another built - this ship is atomic powered and flying. The alien indicated it's basing location.
- 11) It was learned as stated that two women and a boy near Austin, Texas were exposed to severe radiation at close range and the ship was last seen going West with helicopters. In addition, the US Government was quietly picking up the expenses.
- 12) Subsequent inspection of motion picture photographs taken during the study revealed the US ship or one like it flying with the aliens. These match the CIR where two can be seen on the ground and in the later photographs taken on the ground after the base was abandoned.

So in very brief form the prologue to learning within reasonable accuracy what transpired prior to the end of 1979 or shortly thereafter.

The computer communications and constant interaction with the alien in this manner without direct encounter has given a reasonably clear picture of the alien psychology, their logic and logic methods and their prime intent.

It is important to note at the outset, the alien is devious, employs deception, has no intent of any apparent peace making process and obviously does not adhere to any prior arranged agreement.

In truth they tend to lie, however their memory for lying is not long and direct comparative computer printout analysis reveals this fact. Therefore much "drops through the crack" so to speak; and from this comes the apparent truth.

It is not the intent of this report to criticize or point fingers. Obviously whoever made the initial agreement was operating upon our basis of logic and not that of the alien and in so doing apparently walked innocently, in time, into a trap.

The alien indicated that the "Greys", apparently the group initially involved in the agreement were still upset about the initial capture and subsequent death of the first eight of their co-fellows.

Another group, calling themselves in the Computer language, the "Orange" - their base is on the west slope of Mt. Archeleta - directly west of the south end of the US base and near NW of the apparent main landing area they call, in the Computer language, "The Diamond". This, because from a distance, it looks diamond shaped in the photographs. When looking somewhat south west past the observation tower toward the ridged peak SE of Mt. Archeleta. This ridged peak has no name, I call it South Peak. The base extends north of this peak to the edge of the cliff down which goes a road past a large alloy dome thirty-eight (38) foot across the bottom and with a twenty (20) foot hole in the top.

Based upon some of the aerial photographs during which the alien was caught in the open and launching - some launches appear to be coming from the direction of the dome. I would guess it is an underground launch egress facility. In the NASA CIR there is what appears to be a black limousine alongside the dome on a ramp. Surprisingly it is precisely the size of my 79 Lincoln Town Car. Wheeled vehicles and what appear to be Snow Cats or Catapillars can be seen throughout the CIR - car and truck tracks, trucks and jeeps. I don't believe aliens have wheels - humans do.

Numerous road blocks extend northward through the US base along a well maintained road thirty some-odd feet wide - apparently gravel - near all weather - numerous turn arounds and wheel tracks into launch preparation areas with the ships; pads marked with twenty-six (26) foot Xs and servicing facilities, tanks, etc. - two domed polygon high voltage buildings on north on the east side of the road, also an apparent foundation for another or a helo pad - test stands, human housing, water tank (thirty-two foot across) - and at one of the main road blocks, two large vehicles parked across the road. Also at that point another apparent black limousine with tracks leading to it to the west of the road. All tracks and vehicles have been dimensioned and match military vehicles. If I were to make a guess, I would estimate the likelihood that the apparent black limousines are CIA.

This is but a limited inventory of what was there on Sept 8, 1978 - included only as evidential matter for your perusal and confirmation. The road, which incidently the natives, the tribal chief, reservation police and highway patrolman know nothing about, comes in off of a trail from the north. Starting at the trail, line of sight to the large plateau area and the alloy dome, the road, in the middle of nowhere on the Jicarilla Reservation, is precisely 12,888 ft. long airline distance. The total alien basing area, which apparently contains several cultures(now all under the designation "Unity" in the Computer language) is approximately three (3) Km wide by eight (8) Km long. A conservative guess based upon the number of ships presently over this area and the number on the ground in the CIR and photographs; the total alien population at this point is at least two thousand (2000) and most likely more. The alien indicates more are coming or on the way.

I won't attempt to speculate in this report as to how the initial US contact was made - what transpired, nor how many were able to escape. The alien has communicated his account, and if totally true, it certainly is not palatable.

Much detail has been omitted for future discussion if desired - however the import is this. Constant computer communication - full on line in February of this year - manual prior to that - has allowed a constant accounting of what is and has been going on - conditions of morale and a total insight into "what makes the alien run". This is very valuable data.

- 1) Most importantly, the alien will allow no one to go without an implant and after knowledge of it is wiped out. They simply will not allow it. All indications are that communication or language cannot result without the implant. (with the exception of the Binary and the Computer) This would indicate a possible immediate threat or danger for anyone - military, Air Force, or otherwise that has been at the base. They will not remember the implant in any case (the contactee here included)

The reason for the implant is multiple for both language or communication by thought (there is no apparent language barrier with thought) and also complete absolute control by the alien through program - by their beam or direct contact.

I have tested this and found that during this programming the person is totally alien; once one learns to recognize the signs and the person then has no memory of the act/conversation afterward. If this has happened to the military, I need not elaborate as to the possible consequences. The victim's "switch" can be pulled at any time and at the same time they are "walking cameras and microphones" if the alien chooses to listen in with the use of their beams. No classified area of any endeavor in the US is inviolate under these conditions. However - realize - the scars, barely visible - can be seen - all are exactly located and all are accessible by x-ray.

- 2) Also note that all of the aliens - human, humanoid alike - all must have implants - without them, no direct communication is apparently possible. So one can most generally arbitrarily say that if a person states he/she communicated by thought with an alien - he/she most likely has been implanted. They may also claim to be overly psychic and be able to prove this - again through the link transplant, he/she is given the information by the alien and does not realize.
- 3) Most importantly, the alien, either through evolution or because the humanoid is made - will exhibit tendencies for bad logic (bad by earth logic comparison) so they are not infallible - in point of fact they appear to have many more frailties and weaknesses than the normal Homo Sapien. To the alien, the mind is key and therein lies a great weakness which will be discussed later.
- 4) They are not to be trusted. It is suspected if one was considered a "friend" and if one were to call upon that "friend" in time of dire physical threat, the "friend" would quickly side with the other side.

The computer indicates in comparison, that no known earth protagonist - Russian or otherwise exhibit these tendencies to any major degree indicating the danger involved in making any kind of agreement with these aliens - at least of this species.

- 5) The alien does kill with the beam generally. Results on a human will exhibit a three to four cm purple circle. If done from the rear, on one or both shoulders. The results on cattle are the same, essentially exhibiting purple beneath the hide, with burned circles on the outside.

6) Cattle mutilations are the other side of the coin and will not be delved into here though they are a part of the overall. It appears the humanoids are fed by a formula made from human or cattle material or both and they are made from the same material by gene splicing and the use of female encounter victim's ovum. The resultant embryos are referred to by the alien as an organ. Time of gestation to full use as a utility, ready to work appears to be about one year. A year in alien time - I do not know.

Solution: I doubt there is an immediate total "cure" per se - however, they must be stopped and we have to get off dead center before we find time has run out. They are picking up and "cutting" (as the alien calls it) many people every night. Each implanted individual is apparently ready for the pull of their "switch". Whether all implants are totally effective I cannot predict, but conservatively I would estimate at least 300,000 or more in the US and at least 2,000,000 if not more worldwide.

Weaponry and Inherent Weaknesses

Weaponry is one of the keys and in the alien's present state we can prepare an effective offense.

One tends at the outset (I did) to look at their machines and say - there is no defense or offense. One is overwhelmed by their speed, apparent capability of invisibility and "cloaking", and other covert capabilities not discussed at this time. In particular - the beam weapons are themselves a direct threat and obviously one that must be seriously considered but not overly so.

Let us first look at just what this weapon is. It is an electro-static weapon with plasma generating voltages - and an internal storage device - it is pulse powered. The beam, totally effective in atmosphere can be loaded with hydrogen or oxygen. Range? Average, ground weapons - maximum two (2) Km if it is dry, capable of sustaining just so many full power discharges - slow leakage occurs continuously.

therefore, they must be recharged periodically. If it is raining the weapon becomes ineffective and is swamped thus discharged. The range is near totally lost at that point.

On the disks and saucers, the weapon is generally on the left side or top center and has a maximum range of two hundred (200) meters at which point it will plow a trench in desert soil. When fired - it fires both to the front and to the back equally. Reason? Because of their mode and methods of flight. If equilibrium is not maintained, the saucer will spin out.

Hand weapons? Estimate based upon visible damage observed, not too much velocity nor staying power but at short range - deadly (less than a .45 cal automatic). At one meter range, estimate of beam temperature 1600°F or higher; it can vaporize metal.

Apparently the disks and weapons operate from a storage source. In time, without periodic recharge, this storage is depleted. The design they traded to us was at least thirty years old - employing an atomic source. Possibly they may still have some - it would appear so - their staying power is obviously much longer.

Aircraft Helicopter Vulnerability

Any of our aircraft, helicopters, missiles or any air flight vehicle can be taken down instantly with no use of weaponry. The alien simply need do no more than make one invisible pass and their bow wave or screen or both will take the air lift vehicle down. The pilot obviously will not even know what hit him.

For human on the ground, the alien can use weaponry or bow wave. The partial pressure envelop can hit with the power of a tornado - shock rise time and G force is instantaneous.

However, they dare not hit the craft physically because they are fragile and in fact, under slow flying conditions within our atmosphere, hold a very tenuous position. Without power, balance or equilibrium, they loose it.

In brief - these are apparent capabilities observed and gleaned through the computer communication and observation. You may know of these, however, they are directly related to the last and final portion of this report. What can be done?

- 1) Because of the alien's apparent logic system (they appear to be logic controlled) a key decision cannot be made without higher clearance. All are under the control of what they call "The Keeper"; yet it would appear this is not the final say. Therefore, dependent upon urgency, delays of as long as twelve to fifteen hours can occur for a decision. How short/long this time frame under battle conditions may be, I do not know.

Because of this apparent control, individual instantaneous decision making by the alien is limited. If the "plan" goes even slightly out of balance or context, they become confused. Faced with this, possibly, the humanoids would be the first to break and run.

The same applies to their Mission Master Plan, if one can call it that. If pushed out of context, it will come apart - they will be exposed to the world so they will possibly run before they fight in the open. They definitely do not want that to happen.

Psychologically, at present, their morale is down - near disintegration. There is pronounced discension in the ranks; even with the humanoids. Communication can encourage this (no necessity to expound upon this other than to say because of their own internal vulnerability mind-wise to each other, therein lies a prime weakness). Inter-echelon or individual "trust" appears to be totally lacking so suspicion of each other is rampant. They are highly segregated as to levels - a "low" dare not conflict with a "medium" or "high" or it literally means death. Death being, to the humanoid, deprogramming or, in the end perhaps total physical death.

They appear to be totally death oriented and because of this, absolutely death-fear oriented. This is a psychological advantage. The computer also gives indications of a real possibility of adverse or "ground programming".

- 2) Consider their ships - most if not near all run on charge. That source depletes and so dependent upon size - depletion can occur for some within a week or less. Ships can replenish each other but only up to charge balance. This is done with antennae-like extensions and the charge is distributed observing conservation of energy laws. They can replenish from power lines - but again only to a point - so time of flight is limited. Deprived of their base recharge capability, it is indicated that all ships will come down within six months to a year unless they can get transported out - that is back to the prime launch ship.

The disks and saucers in general cannot fly in space because of their mode of flight. Therefore, deprived of home base, it is not likely they can survive. Their capability in power survival outlasts their capability in food or formula survival. If they do not get formula/food within a certain period of time they will weaken and die.

In the case of Mt Archeleta and South Peak, they are dependent upon the Navajo River for water supply and water to them is totally life. Without water they have no power; without power, no oxygen or hydrogen to service the ships and weapons. No water to sustain the organs and feeding formula.

Simple? Not really. However, there is a water intake and there is a dam upstream that can be totally cut off and the water re-routed to Chama, New Mexico. Should this occur, at least three of the internal bases will go down. They could possibly go atomic periodically but obviously problems without cooling.

Once the bases are pressed on a large scale, all disks and saucers will go airborne immediately. Troops on the ground can gain terrain cover to quite a degree - it is rough terrain.

- 3) Our need is for a weapon, workable and preferably not like the alien's. I believe unless the alien is caught unawares (with their screen up their weapons are equal so they are like children pillow boxing) there can be no result; the weapon must penetrate their screen and it must also penetrate the ground. I believe I have that weapon. Two small prototypes have been funded and constructed by my Company. Tests conducted to date indicate they do work and work rather well considering their small size. Because of this weapon's present status and proprietary nature (a basic patent is in process), the theory will not be explained here. However, the weapon appears to do two things at very low power. 1) The disks within its range begin to discharge when exposed to the weapon beam. To counteract, they must apply more power and so doing consume more power. Again conservation of energy laws strictly apply.

This effect can be observed on the detection instruments as they back away in response to slow discharge. Discharge, at low power is slow but at high power in the final sophisticated weapon, the rate can be increased by many orders of magnitude. 2) Most importantly, this weapon can penetrate the screen - hull alloy, everything. They cannot shield it in any way. Lastly, because of the implants, the weapon's beam gets to them mentally; they lose judgement and indicate almost immediate confusion, particularly the humanoids.

It is believed at this early stage - based upon present testing that the weapon when full on and full size will kill or bring down disks at substantial range. The alien weapons operate substantially the same as their disks using a charge source and charge distribution. So, in the same sense it is indicated that this weapon design will pull their charge weapons down very rapidly.

The range of my weapon exceeds that of their present weapons and in its most sophisticated form can be readily computer controlled to allow extremely rapid tracking and lock-on regardless of speed along with electronic wobulation of the beam. It is a beam weapon and even at this early stage of miniature prototype testing and development, it indicates eventual superiority to their weapons.

4) Initial logistics would indicate a plan sequentially implemented as follows:

This plan does not include all requirements and preparatory safety measures to be employed by the ground force; however, if Air Force Intelligence desires to pursue the approaches suggested in this report, each significant requirement will be discussed in depth.

An attack must be directed near entirety on the ground for obvious reason. One would, if familiar with the alien capability, indicate that vehicle ignition problems will be encountered. This is precisely true; however, the reason for this is not mysterious but is based upon good solid laws of physics and are known. Experience gained through my study, it is now known how to prevent this from happening and will be discussed in detail at some later date. All electrical and electronic equipment must be "hardened" using these specific techniques prior to implementation. Because of the known capability of the alien (by use of scanning beams to know in advance details of planning) only the initial outline is presented in this report.

Again through the communicative interaction with the alien, testing has simultaneously been done upon this facet, i.e. eavesdropping and ways to abort this capability have been tested and proven.

The program would be instigated in phases. The first phase - planning and logistics - would include continued implementation and testing of the final weapon prototype

thru the pre-production stage. Production of at least fifty minimum quantity should be planned. Additional backup spares should also be included.

On a full time shift basis, it is estimated that at least one year or less would be required to arrive at the pre-production stage. A team would be organized by Thunder Scientific to accomplish this. The key work is now and would be done by an associated company, Bennewitz Labs., Ltd.

Specific attack phases would be incorporated.

- 1) The first procedure would be to close the gates of the dam above the Navajo River. This dam would be held closed for the duration. Internal to the one cave, there is a small dam for water storage. It's capacity is small. There is also a discharge outlet downstream that could be closed causing waste water to back-up into the caves. The water is vacuum pumped apparently by some electrostatic means from the river. At close range, the weapon will take out this capability.
- 2) Once deprived totally of water for a minimum period of four weeks, conditions in the alien bases under discussion will have badly deteriorated. Psychological shock is extremely effective with the alien; total advantage can be taken by instantaneous action or planned observable deviation from the norm. At least three bases will go down.
- 3) If they follow their normal strategic patterns when pressed previously, they will launch most if not all ships.
- 4) Prior to the implementation of water deprivation, the weapons should be deployed at strategic hardened locations and activated in a certain pre-planned manner determined by final weapon coordinate locations.
- 5) This will put an immediate power drain upon those airborne and the alien weapons ringing their bases.

- 6) Because of the inherent psychological aspect of the alien, much can be done in the open with no attempt to preserve secrecy. Much of what is done can be of a diversionary nature. Under most conditions they will attempt to harass but will not openly attack.
- 7) Throughout and prior to this, the open computer communications link will be operational for continued psychological interrogation.
- 8) At some point in time - again resting upon battle status, the deployment of offensive forces will begin. This deployment should be done in a near instantaneous manner under certain special conditions that can be discussed.
- 9) The weapon system should be kept powered up throughout. In this manner, the disks will be made to stay airborne. They cannot land in the interval the system is powered.
- 10) When the weapon is used in one specific power mode, in addition to continuous discharge on the disks that are airborne and the ground based weapons, the mind confusion and disorientation will build in those personnel at the base and underground. At the end of four to five weeks or less, all weapons should be totally discharged and power out on the bases. Most personnel if not all, will be totally incapacitated. The feeding formula will be down and it's critical processing ruined. All embryos should be dead and all hydrogen and oxygen consumables depleted.
- 11) Based upon data gathered on the miniature prototype weapons, the full power weapons should have no problem holding off the disks. In many cases some will break within the first forty-eight hours without being directly hit.
- 12) At that point, standard weapon technology and logistics can come into play and used to the extent of destruction desired at the direction of those in charge.
- 13) The communications can be used throughout to determine status and near the end to attempt to instigate surrender. If no response results, then they should simply be closed in and waited out.

Summary

It is important to note that the initial implementation of the computer communications was not instigated for the purpose of talking to the alien for the "fun of it"; but was deliberately instigated to use as a tool to study, in depth, long term without physical confrontation, the strengths and weaknesses of the alien.

The weapon theory and prototypes were built to capitalize upon and test the two key and prominent weaknesses discovered. This in-house funded program has been expensive, in excess of \$200,000; done on behalf of our nation and handled in the best representative manner humanly possible.

1) The prime and weakest area discovered, probed and tested is exactly what they have used thinking it is their key strength - that being, the manipulation of and control of the mind; not only of command but also humanoid. Manipulated in reverse psychologically and by the language (computer) and due to the extreme of mental distortion and incapacity caused by the weapon, it has been found that this facet is for them a disaster and a directly vulnerable integrated weakness.

2) Though their ships are magnificent, they are also weak - solely because of their method and unique mode of flight. They do not have a stable fighting platform. Charge distribution can also be discharged. The weapon does this - even in it's present miniature prototype stage.

It is not the purpose of this report to imply that the overall problem will be solved with the capture of these bases. Obviously it will not, but it is a firmly based beginning with a high degree of rated projected success ratio. It is not intended to imply the alien will not fight; they may - though their inclination is generally the opposite - this basing area is key. Without it, their mission is in very deep

trouble. It is noted that these are not the only bases on earth there are others. With a conservative estimate using typical logistic support numbers, it is not unrealistic to say there are 50,000 aliens within the ecosphere of earth and near space. Some of us will be lost in the endeavor that is obvious - however, done now the advantage is gained along with new additional technology to prepare for the next stage. The key to overall success is - they totally respect force. And with them, the most effective method is to stubbornly continue to pick and pull at their defense with no letup. Faced with the total loss of a base that has taken years to construct, it is believed that their mission will be grossly weakened and badly slowed.

As Americans, in this particular instance, we must realize - that we in this case cannot rely upon our inherent moral principles to provide the answer. Negotiation is out. This particular group can only be dealt with - no differently than one must deal with a mad dog. That method they understand. They have invaded our country our air and they are freely violating the personal and mental integrity of our people. Therefore, in eliminating this threat most certainly we cannot be called the "aggressor", because we have literally been invaded.

In final conclusion A) They cannot under any circumstances be trusted. B) They are totally deceptive and death-oriented and have no moral respect for human or human life. C) No negotiation, agreement nor peaceful compromise can be settled upon in any way. D) No agreement signed by both parties will ever be adhered to nor recognized and respected by the alien, though they might attempt to make us believe otherwise. E) Absolutely no quarter can be allowed under any circumstances. Once the offense is instigated, it cannot be abandoned. If it is, reciprocal reprisal will immediately result. They must be made to come down - destruct themselves which is a standing order if the ship is failing or leave earth immediately - no leeway of any kind can be allowed nor tolerated.

TELEPHONE INTERVIEW

On 10 September 1985, well known author and investigator James Mc Campbell in California conducted an in depth interview with Dr. Paul Bennewitz in Albuquerque, New Mexico, on his alleged sightings, film and photographs of what he was observing over Albuquerque and the Arqueleta Plateau in New Mexico.

Ms Campbell audio taped the entire interview and then transcribed it as follows:

SUMMARY OF NOTES TAKEN BY JIM MC CAMPBELL CONCERNING TWO TELEPHONE INTER-VIEWS WITH DR. PAUL F. BENNEWITZ - Side A of Cassette

This is Jim McCampbell making a recording of a remarkable episode on July 13, 1984. It has to do with a UFO base, cattle mutilations, advanced weaponry, contact with aliens, etc.

The episode began about a week ago when I received a little semi-annual periodical titled Stigmata. It is number 21, the First Half of 1984. This little bulletin is prepared by Thomas Adams at P.O. Box 1094, Paris, TX 75460. He has a hotline for reporting possible or concurring mutilations at (214) 784-5922. (confirmed)

He has a rather lengthy article. One finds point of interest on page 9 and I suppose the only way to pursue this is to read what he has here as it is fundamental to the entire story.

Quoting "In May of 1980 a most interesting event occurred in northern New Mexico. An event similar in many respects to the Doraty Case. A mother and her young son were driving on a rural highway near Cimarron, New Mexico. They observed two or more craft and as Judy Doraty did, they observed a calf being abducted. Both observers were themselves abducted and taken on separate craft to what was apparently an underground installation, where the women witnessed the mutilation of the calf. It has been alleged that she also observed a vat containing unidentified body parts floating in a liquid, and another vat containing the body of a male human. The woman was subjected to an examination and it has been further alleged that small metallic objects were implanted into her body as well as into her son's body. More than one source has informed us that CATscans have confirmed the presence of these implants.

Paul Bennewitz, President of his own scientific company in Albuquerque and an investigator with the Aerial Phenomenon Research Organization, has been the principal investigator of the case. Interviewed in his office in

April 1983, Bennewitz reports that through regressive hypnosis of the mother and child and his own follow-up investigation, (including communications received via his computer terminal which ostensibly is from a UFO-related source), he was able to determine the location of the underground facility; a kilometer underground beneath the Jicarilla Apache Indian Reservation near Dulce, New Mexico. (Since 1976, one of the areas of the U.S. hardest-hit by mutilations coincidentally or whatever). Bennewitz's information is that this installation is operated jointly as part of an ongoing program of cooperation between the U.S. government and extraterrestrial UFO-nauts. The story continues that, after initial contacts years ago, the aliens agreed to give us certain technological advantages while we provided them with the location for the New Mexico base and at least three others. Plus, the aliens were to be allowed to carry out certain operations, abductions and mutilations without our intervention. The mother and son, by the way, were returned back to their car that night. Since the incident, they have suffered repeated trauma and difficulties as they attempt to recover from the episode. We pass this along because the account is, of course, most crucial if true; but we are not in a position to confirm the alleged findings. Hopefully, more information regarding this incident will be aired in the near future. We can only consider such reports while continuing to seek the evidence to refute or confirm." That's the end of this remarkable quotation from Stigmata.

As I have been studying the idea of bases for aliens for some time, this has caught my attention and I also suspected cooperation between the U.S. government and the aliens. It also gives the name and location of a man who has his own scientific operation, Dr. Paul Bennewitz. I tried to get in touch with him. Through the telephone information service I was able to do so.

I got in touch with Dr. Bennewitz by telephone and indicated that I had seen this reference to him and his work and I wanted to find out whether he was being misrepresented or whatever. I told him that I would xerox a copy of it and forward it to him for comments, which I did. This morning, July 13, 1984, he telephoned me and said that he, having looked over the article, found that it was substantially correct. I forgot to mention that in my letter to him I said that none of the details that were in this particular article gave me any strain. Then Dr. Bennewitz, who I will refer to as Paul....He took time to close the door to his office and elaborated upon the whole story and the conversation lasted somewhere near an hour. It is rather mind boggling and here is the substance of that telephone conversation.

The article is basically accurate and he does have the coordinates of the base. He is a physicist and he started four years ago to determine in his own mind whether UFOs exist or do not and he has gotten much more deeply involved than he ever intended. It has caused him a great deal of trouble from the government intelligence groups. He has pictures from the location. He went with a Highway Patrol Officer and they saw a UFO take off from a mesa at the location. He obtained photographs and what he calls launch ships were 330 ft. long and 130 ft. across. The cattle rancher named Gomez and he went back to this location which is a mesa and saw a surveillance vehicle which was about 5 ft by 10 ft, like a satellite, he said. He had been using a Polaroid camera and then got a Hausel-Eladd to produce much better pictures. He set up a monitoring station and observed that UFOs are all over the area. He was also able to pick up signals and obtain video pictures that are transmissions from the aliens screens. He has been dealing heavily with a Major Edwards (somebody) who was with Monsanto

* MY WIFE & I

Security and two of them saw four objects outside of a warhead storage area at a range of about 2500 feet and obtained movies of them. He now has about 6000 feet of movie footage, of which 5000 ft. is in Super Eight. The objects have the ability to "cloak," that's his word, spells CLOAK like cloak and dagger, like cover up and he says that they can cause themselves to go invisible by a field that causes the light waves to bend around the object and that ~~one~~ ^{* ONE} ~~was~~ ^{SEES} (?) - the sky behind them.

He confirmed the fact that the woman was picked up when she accidentally observed the calf being abducted. He has paid for a pathology work and a medical doctor work. The pathologist is a former head of the microbiology department of New Mexico University. They have done CATscans to show that the woman and her son did infact have implants in their bodies. * WE CONFIRMED THE WOMAN - NOT HER SON She has a vaginal disease like streptococci-bulbie and tried many antibodies to destroy the bacteria. That it has survived off the antibodies themselves. The aliens keep hassling her. * STILL TRUE TO DATE

Paul kept the woman and her mother at his house and the UFOs were flying overhead constantly. There is no ESP involved, but it is just plain physics.

* THEY SEND A BEAM DOWN - NOT "BEAM DOWN"

They beam down. They have a beam through which they can sense her thoughts. They can communicate through this beam. She picked up their transmissions. He devised a means of communication based upon hex ^{alpbic} code; one is equal to "no" and two being "yes." Through this code he has been able to talk to the aliens. He then computerized the system that would reject extraneous inputs. He said that they can be very threatening and malevolent. One of them he talked to said that he would drop off communication if he became to familiar. He was told about the base.

He then told the O.S.I. of the Air Force and he ^{* DID GIVE} has been requested to give several presentations to high level Air Force people in briefings on the subject, wing level Command and many others including this fellow Edwards.

And he took a helicopter to the site - no no no. It turned out that the

wing commander, after a presentation that this fellow made, then took a
helicopter to the ^{SITE} side and made photographs.

He says that you can see saucers on the ground. He says there is a
kind of a cone - a large cone and the larger vehicles come and land on top
of the cone with the top of the cone fitting into a hole in the bottom.
There is an elevator inside of the cone and that goes down into the
mountain or ground about one kilometer. You can see the aliens running
around the base getting into the vehicles and stuff. They use small
vehicles to get around that have no wheels. They are rectangular in shape
and they levitate. They do not show up in color because they are highly
reflective, but in B & W they are visible. He says that there are beam
weapons that are floating in strategic locations and there is a road into
the base. He obtained infra-red photos of the area from an altitude of
* 14000 FT.
1400 feet. There is a level highway going into the area that is 36 ft wide.
It is a government road. One can see telemetry trailers and buildings
that are five sided buildings with a dome. It is standard military pro-
cedure. There are many guard points and ["]stakes["] and there are launch
domes that one can see. Next to the ^{LAUNCH} watch dome he saw a black limousine
and another at some distance off. * APPARENTLY
The careful measurements showed that
the limousine was the same length as his Lincoln Town car. It is a C.I.A.
vehicle. Also there was a blue van. He has been cautioned about these
limousines as they will run you off the road if you try to get into the
area and in fact somebody has been killed in that manner. To the north is

a launch site. There are two wrecked ships there: they are 36 feet with
wings, and one can see oxygen and hydrogen tanks. There are four cylindrical
objects Socorro type -- two carrying something while flying. The whole
operation is based upon a government agreement and a technology trade. We
get out of it atomic ships that are operated by plutonium. The Cash-Landrum

base was one of them. The doors jammed open and neutron radiation came out.
 They are based at Kirtland AFB and Holloman AFB and some place in Texas.
 (1/2/86 Based at Kirtland AFB) ** NO - ONLY KNEW OF ONE BASED AT HAFB. Possibly Ft Hood, Texas - a guess*
 He said the government is paying the hospital bills for the Cash-Landrum ** OSI INPUT - Found out later unless someone covering - not true*
 victims. A Refueling of the plutonium is accomplished at Los Alamos. He had
 traced pictures of this base back to 1948 and it has been there staring in
 1948. Pictures in 1952, you can see many saucers and the base and trucks in
 winter time. The road was "passed off" to the local inhabitants as a lumber
 contract. He has photographs (I believe) of the firing of a beam weapon that
 projects in two directions. (That would be necessary on a flying saucer. The
 reaction forces would impede the vehicle.) He has computed the speeds of
 flying saucers at 15,000 mph and indicates that the pilots are from N.S.A.,
 the National Security Agency. The aliens have had the atomic propulsion
 system for 48 years and the saucers themselves operate on an electric charge
 basis having to do with a crystal semiconductor and a super lattice. I
 think he said "as you increase the voltage, the current goes down." (Now
 typically). At present there are six to eight vehicles, maybe up to ten
 over the area and sometimes up to 100. They can be seen in the clouds.
 They go into the cumulus clouds and produce nitrogen nitride. You will see
 black spots in the cloud. They eat holes in the cloud. If you can see
 black spots in a cloud, then you can tell that a vehicle is in there.

He says that they come from six different cultures and in his communi-
 cations that some come from a binary system, possibly Zeta Reticuli and from
 distances up to and larger than 32 light years away. They also have one to
 three ships in earth orbit at 50,000 KM altitude. He had to form the words
 to try to communicate and he produced a vocabulary of 600 words in a matrix
 form and uses a computer. The Flying Saucers are limited to operation in
 the atmosphere.

Now with regard to the cattle problem, the aliens are using the DNA
 from the cattle and are making humanoids. He got pictures of their video

screen. Some of these creatures are animal like, some are near human and some are human and short with large heads. They grow the embroyos. After the embroyos become active by a year of training, presumably that is required for them to become operational. When they die, they go back into a tank. Their parts are recovered.

In 1979 something happened and the base was closed. There was an argument over weapons and our people were chased out, more than 100 people involved. (Someplace later he indicates further details on this point.)

The base is 4000 ft. long and our helicopters are going in there all the time. When it became known that he was familiar with all this, the mutilations stopped. ^{- * TRUE} They are taking humanoid embroyos out of this base to some-
^{Note: 1/2/86 - looks like it is Albany.} where else. I asked if it was Albuquerque or Los Alamos, but he said he didn't know. He said there are still quite a few of the helicopters in operation. ^{* ALL UNMARKED} They fly at night. He went up there himself in a helicopter and the O.S.I. briefed the copter pilot and he thought perhaps the copter pilot himself was an undercover man. They saw helicopter pads up there - Viet Nam type, with bearing markers and the trees pushed off away from the location. It is such a wild area he said. He agreed to send me the coordinates of this base.

Regarding abductions of people, they pick out medium to low IQ personnel. They are able to scope out each one. ^{(I DON'T KNOW THIS PART - WORD MIXUP - DR. P.} So we can do the same thing with electro-magnetic spectrum analyzers. They pick up these people and then put implants into them and then take tissue samples, including ovum from the women, sperm from the men and DNA.

They can program these people as slaves to do whatever they wish and they will have no memory of it. ^{* THE HARD CORE TYPE} They staunchly refuse to be xrayed or hypnotically regressed. You can recognize them because of their eyes. He ^{* AN EXPRESSION} says peculiar look in the eyes and a funny smile. Hynek knows about all of this and has been in contact with Coral (Lorenzen). He regards Hynek as a

* NOT REALLY - I JUST THINK HE IS STILL A GOV. COVER.
threat. At his house, he showed Hynek films and out in the back yard a flying saucer. He asked Hynek about his view with regard to abductions as to how many people might have been abducted. Hynek, unhesitatingly said about one out of forty.

He said that many people come to his door to see him, just "out of the blue" and he sees scars on the back of their necks. That previous old scars are easy to detect and that new ones are hard to detect. He feels that this is a sickening situation.

The aliens have gone wild and use hypodermics [and notes a parallel four times.] (McCampbell: I don't know what that means) He has been paralyzed four times and has been hit 250 times by hypodermics. He says they knock you cold and they do whatever they want to do and the above points have been verified medically. * I DON'T KNOW EITHER

A man came to see him with a top secret document that was dated in the 50's, indicating if anybody found out about all of this they would kill them. He was asked "doesn't that bother you?" He said "no it didn't."

He said he had sent in some film to Kodak and there were seven rolls. They were Ectrokrome G which could not be processed locally, so they had to go to Kodak. He does all of the film work commercially so that nobody could claim that he had monkeyed with the film. His films came back, but one of them--one was plain Ectrochrome, but nine feet was missing and this was close-ups of UFOs that he had taken. The missing pictures of the nine feet showed up in a top secret document that he studied and the code name is Aquarius and it is a project of the National Security Agency. * WAS MISSING FOR 2 MONTHS - WHEN RECEIVED * I WAS TOLD NASA

They are the ones that kept his film and copied it with deletions on Ectrokrome and sent it back- * I SUSPECT

There have been indirect threats by the Air Force Intelligence against him.

The location of the base is 2½ miles northwest of Dulce and almost

overlooks the town. It is up on a mesa. We discussed the similarity between everything we have been talking about here and the movie Close Encounters of the Third Kind. He said he speculated that seemed to be a plan of disclosure, that is the movie. The coordinates of the location are not far off and the mountain where the actual base is looks much like the mountain in the movie.

The next thing was -- Discussing the trade-off -- alright. Here is what we got in the trade off. We got the atomic technology, the atomic flying ships. Several of them, the first one was wrecked on the ground and it can be seen and photographed from the air. A second one was wrecked. A third one was wrecked. Apparently this last one was repaired and was the one that was in Houston -- near Houston in the Cash-Landrum case. The second item that we get out of it, are the beam weapons, the beam technology and third, ^{★ I SPECULATE} is the thought beam, That is the means by which communication is accomplished. It is a electrostatic in character with a magnetic ^{★ ARTIFACT} component and it is the only way of communicating with people. They have to have the implants in order to use it. In the crash that occurred at the base when there was a disturbance of some sort, the aliens killed 66 of our people and 44 ^{★ ALIEN COMPUTER INPUT - TRUE? I DO NOT KNOW.} got away. Over an argument -- they turned on us.

I discussed with him whether he wished me to relay any of this information to other people. He said he had no objection. He would like to review any writing that I might do, to make sure that it is right in advance, and also to make sure that the source of the information was given: I mentioned in particular, John Schuessler, who would be extremely interested in part of this data.

I gave him a summary of my analysis of the electromagnetic environment around UFOs related to propulsion. He was going to study that, but he did not comment off-hand. He was familiar with what the aliens called MPS which means manipulations per second -- no, manipulations per sequence. In

an electrostatic field that can be manipulated into many configurations and the craft can stall. In order to prevent that, this field is adjusted once every forty milliseconds. He has studied the trails from UFOs and they seem to break down into a pulse rate of 60² per second. Based upon the color movie pictures, there seems to be a blast of light and a spectral components and composition in there, with a Bow-Wave in front of the UFO with nitrogen showing green and oxygen showing blue, but with the saucer being invisible. They can run into a car or airplane and this Bow-Wave will destroy them. Rockets can hit this Bow-Wave and be destroyed. They can't penetrate it. At White Sands he was shown pictures of an F-15 shooting rockets with a missile at a target and the saucers came in behind the missile, 30 ft. behind, and then flew thru the explosion. He didn't know what the purpose of the demonstration was, but suspected it might be just to show how invulnerable they are. But sometimes the saucers get into trouble and they are all consumed in some kind of way.

When he went up to Dulce in a helicopter, they landed and left some equipment there, but then when they came back the pilot was extremely nervous. Paul wanted to land on the base, but the pilot wouldn't do that. They came back to Dulce and landed at a small strip there, where they found two large Huey helicopters. ^{★ HIGHWAY PATROLMAN} The Indian-in charge there named Valdez went aboard one of the choppers and they found them to be full of commandos. They estimated a total of 75 commandos, fully armed with ^{★ NO - M16'S} M-1 rifles and ^{★ & LAUNCHERS} rockets. They did not have any indication of rank. They only had shoulder ^{★ VALDEZ SAYS NO - NOT TRUE - MY MISTAKE - I DID NOT GET THAT LOSS} patches on and the helicopters had no identification other than numbers. The helicopters were part of a project called Blue Light and they were ^{★ OSI INPUT} from Ft. Carson, Colorado. When they left they were escorted by these two large Huey helicopters. As they were flying along -- in the background, they saw rise up one of the advanced space technology vehicles that looked like a manta ray with a negative dihedral and projections coming down. It

flew vertically past the two accompanying helicopters. Paul feels that it is imperative that this information be released because he feels that it is unconstitutional for the government to be involved in such an arrangement that invades the privacy of the individuals by the implantations. He said that "once they have been tampered with by the aliens, they are never the same." (I suppose one can easily believe that.) (Jim McCampbell comments) So it appears that the -- for the privilege of ^{if}correcting the biological materials in the mutilation of and the abductions and the operations on board the craft, the government has allowed this to go on and even to assist for the privilege of getting the nuclear flight technology, the beam weaponry and the thought beam technology, plus also the embryos which are flown out of the base. (A rather fantastic story.) (Jim McCampbell comment) Paul strikes me as being an extremely conservative, extremely knowledgeable and reliable scientist, who was intimately familiar with sophisticated laboratory equipment. He is thoroughly scientific and reliable. (Jim McCampbell evaluation) The base was started in 1948 and in the text above, I indicated a reference to 1942 that should be 1952. showing major construction of the base from the photographs that were studied.

This the end of the message. - Jim McCampbell

(Side B of tape to follow of conversation on July 17, 1984)

This is a continuation of the episode or the saga of Dr. Paul Bennewitz. He telephoned shortly after noon today, on July 17, 1984 and excused himself then to close the office door and I suggested I would use that time to pick up some note paper, which I did. He indicated that in a separate incident; it must have been a court order or something like that to Kodak Corp. to intercept some of his film; to either take it or copy it. He has a secret report where apparently his pictures that were missing are included. There are some reference numbers involved there and also including his case number. He is going to be sending me that information. He asked if MUFON would search it out and I said I couldn't say, although I might have sufficient interest to pursue it myself, and asked why he would not do it and he said that "perhaps somebody else could be more successful." This material came to him anonymously and I'm being very specific because it has some bearing on a piece of paper that we know about in northern California. "It is a piece of paper," quote. It describes this film and the tests that were performed on them, being very sophisticated. He indicated something else about a case number and referring to intelligence groups access, to a very highly classified--up in the 20 hundreds, which is a reference figure that I am not familiar with. The Air Force has claimed that this document is a forgery. The former Major Edwards is now a Lt. Colonel.

Paul offered, because he just voluntarily offered this information that Edwards is at Hann A.F.B. in Germany and his home telephone number is ^{1/2/86 - New Vice Commander AF Security - AFHQ} dial 0 11-49-6543-3115. He is in charge of security there and has around 500 people. (They happen to be seven hours ahead of us on the west coast.) He said that Edwards might be somewhat reticent to speak freely because he knows that the National Security Agency monitors all the international calls.

I inquired about the other bases that were referred to in the Stigmata report or article. He said all that he knew that one was to the south, one to the west and one to the east and he doesn't want to know anything more

about it.

I discussed the prospect of using the paper in the MUFON 1984 UFO Proceedings to try to find the center of gravity for the mutilation cases from those maps that run from about 1972 to 1982 or 1983. The word gravity triggered in his mind another connection having to do with the Dept. of Interior that has a gravity dept. and they do in fact survey the United States and publish maps indicating the gravity contours. There is a very weak gravity at the site near Dulce. He said that the craft are very sensitive to the gravity levels and that suggested that perhaps the other sites might also be located relative to weak gravity.

He indicated that the objects fly in a wobbly way. His pictures have shown that. He says "like the rocking of a boat." He has measured many right angle turns and also full 180° turns in a 20th of a second with the object still inside of the bow-wave. He has also observed and photographed the object or lights moving in a triangular pattern and square patterns. He says high powered radar can interfere with them. I reported on the meeting that we had on Sunday afternoon and raised some of the questions that came out of that meeting. One of them was why not remove the implant? He said that this had been discussed and the lady witness finds that acceptable if she can be assured that there can be no nerve damage. He then went into great detail, which exceeds my knowledge of anatomy, in describing the location of the implants. One appears to be adjacent to and ^{external} extend to the cortex, which I think he indicated was at the base of the brain. The image in the CATscan is of a very small helix, like it was joining two major nerves near the spinal column. Then on the lateral right side from the back, there is an implant of perhaps like the one above. Another is on the left side. Two others are on the forward part of the skull, which appear to be small 2 millimeter electrodes against the radial nerve. There is a shape to these things which he indicated is like a baby bottle nipple upside down, not the

cap part, but just the nipple itself. (I raised the question of the U.S.S.R. ^{* BASE} satel ites seeing this ~~face~~.) He acknowledged that and also that ours can ^{* ? OSI PHOTO ANALYST} certainly see it. He had a discussion with some full analyst who indicated that he had seen tracks up a hill and a launch location that was definitely not a rock but some kind of artificial construction. On the hazard of entering area, I asked about that. He said that there is a risk if we went in on foot, but if a person tried to do that likely that the people would ^{* I SAID "ZAP" THE ODOS ARE ONE MIGHT BE ACCESTED.} "wack them." But he thinks that a helicopter would be safe. But he wants ^{what} to do is to do additional aerial surveillance. Then go in with a group, the larger number of people the better. A Highway Patrolman, a friend of his, is ready to go in at any time. He says one can't act on impulse. You have to plan out a program. He said four times he had near encounters and one was with this Major Edwards. ^{NO - NOT RECEIVED - I ASKED THEM MENTALLY -} He had received a mental communication ^{THEY WERE APPARENTLY SCANNING ME - I DON'T "RECEIVE" ANYTHING MENTALLY} while watching some UFOs and he asked to be picked up. He asked for them to blink their force field twice if they were willing to do it and all four UFOs under surveillance did blink twice. He asked to be picked up on Sunday if he received one blink from all four UFOs, which were reported about 300 ft. from each other. He took this to mean no. He asked if they were not authorized and he got a similar response. This established a code system by which some further communication was accomplished.

At some later time, an agreement had been reached for a meeting. He was on his roof and observed a UFO on the ground near an interference. ^{* - OUTER FENCE OF BASE} (This appears to be in reference to a government reservation.) An agreement seemed to have been reached to meet at the northeast corner of the inner compound. Major Edwards picked him up and they went to this meeting place. He said "don't use the radio." They encountered two guards in India Section who had been ordered to fire upon anything that moves. They stopped their jeep and walked into the desert. There had been a miscalculation and they were in the wrong place. On three other occasions on some property he owns on 95

acres, UFOs came within 400 yards of him during daylight. Apparently, both he and the aliens "chicken^d out" on a definite meeting. We had a recorder at one time and waited until after dark (8 pm) and then pulled back for he said ^{★ MY VOICE ON THE RECORDER SHOWED CONFUSION.} on his (?) recorded was messed up and this rather frightened ^{★ YOU MONITOR YOURSELF CONSTANTLY FOR CONFUSION AND PSYCHOLOGICAL VARIATION} him. I asked who was flying the UFOs? He said aliens. He says they call it ^{"leisure=cool or alteration."} He thinks something should be done about all this and quick. ^{★ DON'T RECOGNIZE THIS. - "ALTERATION" IS THE ALIEN WORD FOR IMPLANT.} UFO activity is still going on all around Albuquerque. It is hard to separate their activity from ground lights because they move slowly at less than 200 ft. elevation, particularly over West Mesa where a lot of lovers go. He has been observing that area with binoculars and then he talked about rotating the binoculars. (I inquired about this in some length.) If you rotate the ends of the binoculars, you will get a blur into an oval and if you try this on a street light you get vertical stripes that represent 60 cycle input to the light. For airplanes, you get 400 cycles -- you get the same type of bright stripes with different separation. On D.C. one sees only a circle. On a saucer you see the oval, but the bars that are spread out change their positions so apparently what he calls the M.P.S. (manipulations per sequence/second) changes its frequency on a periodic basis, I guess. I suggested it would be helpful if he had a photographic record of this spec and he said that this could never be (?) possible. ^{★ THE MPS IS VISIBLE ON FILM IN COLOR AT NIGHT. (MOTION PICTURES)} ^{★ WHAT I MEANT WAS THE BINOCULAR PHENOMENON HAD TO BE OBSERVED. DATA SAYS THE PHENOMENON WOULD BE DIFFICULT TO OBSERVE THROUGH BINOCULARS.} I inquired about his business and his solid state physics. I told him that was my bag too and I studied physics at night school in years after college and got just up to doctoral level, but never got a Ph.D. because I was skipping around the country trying to maximize my income and raise three children. He said that was his experience also. Specifically, he did not acquire a Ph.D. He is president of Thunder Science Corporation, a well known operation there, with their speciality being temperature and humidity devices. Their equipment has been on the shuttle and most of their business is with the top 500 corporations.

His company is in Sandia on $\frac{1}{2}$ acre and now building an additional 3500 sq. ft. building. There is another organization called Bennowitz Laboratory which is the research arm of Thunder Science Corporation owned 90% by the latter and operated by his three sons. They have invented a hearing device that has no moving parts that makes totally deaf people able to hear and in addition, expanding the frequency range plus 1000 HZ on the high side and down ^{to} less than 10 HZ on the low frequency end.

He said that he got involved in all of this merely as a hobby and it became an obsession. He simply wanted to know what was going on and to develop instrumentation to measure data, etc. Since the signals from the UFOs are very low frequency, down around 200 HZ and with an analyzer you just think you are looking at some noise. But I believe he said it was a memory scope that was able to filter out the signal involved there whereas ordinary filters do not. They trigger signals in an on and off fashion, instead of 0 and 1 volt representing that type of communication or signal a distinction is made between a narrow pulse and wide pulse. Each communication is preceded by four or five pulses. He had previously been in touch with the O.S.I. which has been verified in Clear Intent. But now he says that when he calls them, they won't speak to him so he is in a "shut out" situation. I pointed out that there were two O.S.I.'s (Office of Special Investigation) and the other is C.I.A. (Office of Scientific Investigation) He assured me that it was not the C.I.A. group. He said the actual title ^{of the} group that he was dealing with was the "Office of Secret Investigation." He says there is also a new pattern or called Human Intelligence, that is they investigate the humans, that is the government. I mention^d to him that in Clear Intent that it said he was under surveillance. That happens to be in error. That information comes from somewhere else. But he quickly ^{said} saying "I know that I am under surveillance." They set up a site across the street from his house with computers and recorders. A girl rented the house. He had a detective look

into this and found that she was operating under an assumed name and she had no social security number. He has photographs of people coming and going with NORAD license plates, Air Force, A.F. weapons lab. He thinks N.S.A. is orchestrating this. For an entirely separate subject, he thinks this whole operation, the UFO base detail is classified higher than the President. *THAT IT WAS BY A WASHINGTON SOURCE.* *★ I WAS TOLD* That is, he thinks the President doesn't know about this. *★ TRUE* *(Not in total depth)*

He is also concerned that there are two levels of security involved (1) Project Aquarius which is TOP SECRET and another (2) higher than that; where people in charge of the higher level information having these new vehicles could simply take over the government. He called the Air Force intelligence headquarters in (Washington) *★ YES - TRUE - AF INTEL.* (He didn't say Washington, but that was the idea.) The Commanding Officer was not present but he talked to a Captain who was the adjutant or executive and started talking. He said "I know all of these facts, and this and that and what do you think about that?" The Captain said "just write us a report and tell us what we should do." *★ ABOUT "IT"* So he prepared a 20 page report and Edwards saw it. He forwarded it by Federal Express and also a copy to the White House in a double envelope, indicating that sensitive material was in the inner envelope. Edwards got a call from Colonel *★ NOT SMITH DON - ? HAVE TO CHECK FILES.* Smith who was the White House Liaison to inquire who this Bennewitz fellow was. Edwards gave a positive report. The White House was extremely interested and issued orders "to get on with it; to do something, assuring Edwards that Bennewitz would receive a letter within two weeks." Such a letter was never received. Finally, Col. Smith from the Air Force Secretary sent him a letter eventually just pursuing the "old party line." That said "he should not be troubling the headquarters of the Air Force and the Executive offices of the White House with all of his stuff." Bennewitz showed this letter to Edwards who blew up and called *★ Col. DON* Smith. They got an answer from the Air Force that they were not interested and knew nothing about it. On another point: referencing the Stigmata article where

The farmer thought that the two humanoids may have been naked. In the case with which he is dealing with -- the woman and the son, the boy upon being questioned laughed, and he said "they had no fronts or behinds." I asked no sexual organs, and he said yes, no organs at all. He has received information concerning a high metabolism rate of the creatures, even birdlike. One of the witnesses, I think the woman who was being taken by the hand, said the hand of the creature was "red hot." And he guesses that it must have been 115°F. The creatures cannot stand uncontrolled environment. They wear suits for protection against excessive heat.

They are fed by a formula and if they are short of that intake, they will ** TURN GREY - THEY ARE A LIGHT YELLOW GREEN WHEN HEALTHY, TURN GREEN.* The heart is on the right side and they have one lung.

Elimination is through the skin. The creatures are very strong. (He seems to have very little knowledge of the literature and the organizations working on UFOs. I promised him to scare up a copy of my book to send to him and also a personal resume to give him an idea of my background and copies of one or more of my papers.) I asked about his reaction to the summary of the UFOs fields that I deduced that I relayed to him in the first call. (He thinks that I may probably be right.) He says that the UFOs can be detected by radar detectors and they also trigger highway patrol radar or Police radar guns. His friend Valdez, at his suggestion, was looking for a water intake to the site and within about a 1½ miles he came upon a flying saucer at a distance of about 300 ft. The Indians own the area -- are quite scared and very superstitious and 90% of them have moved into town. The Chief of Police told him about an experience he had. A tribal chief had gone deer hunting on a mesa south of Dulce. Two days went by. When he didn't return, a search party was sent out. In the daylight on the mesa, a ship "hopped up" from down below and came up above the mesa. Two guys (human) kicked the tribal chief to the ground. Then they got into the ship and disappeared. He had been hunting and had "fell". He had a broken leg and he was picked up

★ NO-NO - THE SHIP WAS BLACK
by these human people in the craft. They were blacks - specifically negro
humans. He discussed something about some devices called sphericals that
are optical in sound (?) and apparently remotely controlled little vehicles..
Spheres from 14" to 12" in diameter. We discussed weapons used by aliens and
whether or not they are used to paralyze people. Yes, they consist of a
cube about 2" on a side -- called a lens hung around the neck that emits a
beam. Another on the ship produces a blue light that he has seen. It comes
from a device about 4" high and 14" long with grid black lines on it. The
color produced is very light blue which is like ionized oxygen. He has not
sought publicity on any of this. He is interested only in getting the facts
. He did not object to the idea that I would send a copy of our telephone
conversation to Tom Adams when I told him about my plan. He had received a
call from a William Allen from Seattle, concerning an English publication
of the Kirtland AFB case. I told him that if it was the same Bill Allen that
I knew, it was a good contact, since I had become very well acquainted with
Bill Allen at the 1983 MUFON Symposium in Pasadena. (William K. Allan
lives in Kelowna, B.C. Canada). The English publication seemed to be the
Flying Saucer Review which I assured him was the leading publication of its
kind in the world. (So there is some more information that we can put into
the equation of Paul Bennewitz and it is indeed a puzzling situation. I
continue to get a reassurance that the guy is continually on the level and
what he has to say should be taken seriously and not look into it in great
details without being over skeptical at the outset.) Jim McCampbell comments.

Dear Gerald:

It is either just coincidence or you are the same one that worked for APRO some time ago. The name just dawned on me.

Apparently, you sent out a memorandum concerning a 624 page document re: Top Secret UFO Activity from 1942 through 1951. And - then later a memo to Tom Adams releasing APRO on the matter.

Having known Jim Lorenzen when I was associated with APRO years ago for a brief time, I would say based upon his reactions when I did feed him data - he never could relate to reality - particularly the cold reality of this. All statements made in that memorandum are for all intents & purposes cold reality.

I have seen color photos of a live alien lifeform and have seen the reactor vessel employed in one type of ship. It is however much larger than a football. The "unsavory" statements would also appear to be true although any prior attempt on my part to discuss them in detail on a scientific analytical level led to dispersonal comments upon my character so I tend to avoid that part. QUESTION - When exactly was the Archuleta installation constructed?

ANSWER - I heard Dulce was started in 1937-38 by the Army engineers, enlarged over the years, most recent work was completed 1965-66 to connect tunnels to the Page [Arizona] Base, site of one of the older underground facilities. The four corners base is called PERICA. Most of the Native Americans living in that area are aware of that base, and could tell us about the underground life forms that frequently are spotted near those communities, Bigfoot, etc.

Q -- By what means was the installation constructed? Are

you familiar with the alleged developments made by the Rand Corporation of a highly-efficient bore or mole machine capable of melting rock using nuclear powered wolfram-graphite tipped 'drill-cones'?



A -- According to several senior maintenance workers, part of it was blasted by nuclear devices in the sixties. There are sections, like the shuttle tunnels, that were formed by an advanced tunneling machine that leaves the tunnel walls smooth. The finished walls in those tubes resemble polished black glass.

Q -- By WHOM was the Dulce installation originally constructed?

A -- Nature started the caverns. The Draco used the caverns and tunnels for centuries. Later, through RAND Corporation plans, it was enlarged repeatedly. The original caverns included ice caves and sulfur springs that the

'aliens' found perfect for their needs. The Dulce caverns rival Carlsbad caverns in size.

Q -- Are the various electromagnetically-controlled air or space craft -- that have been seen leaving from and arriving at Mt. Archuleta -- manned by humans, the 'alien entities', or both?

A -- Archuleta Mesa is a minor area... the craft leave and are stored in five areas. One is SE of DULCE, one near Durango Co., one at Taos, N. M., and the main fleet is stored at LOS ALAMOS.

Q -- Others have suggested that some of the entities below Dulce are not of 'extraterrestrial' ORIGIN, and that they are actually descended from saurian or reptiloid beings such as the Velociraptors or Stenonychosaurus Equallus -- a 'serpentine' race or races similar to that hinted at in the third chapter of the book of Genesis?

A -- Yes, some 'reptoids' are native to this planet. The ruling caste of 'aliens' ARE reptilian. The beige or white beings are called The Draco. Other reptilian beings are green, and some are brown. They were an ancient race on Earth, living underground. It may have been one of the Draconian beings that 'tempted' Eve in the Garden of Eden. Reptoids rightly consider themselves "native Terrans." Perhaps they are the ones we call the Fallen Angels. Maybe not, either way, we are considered the 'squatters' on Earth.

Q -- Where do the little grey Aliens fit in?

A -- They work for, and are controlled by the Draco. There are other gray skinned beings that are not in league with

the Draco.



Q -- Did you ever talk to any of the 'Aliens' at the Base?

A -- Since I was the Senior Security Technician at that base, I had to communicate with them on a daily basis. If there were any problems that involved security or video camera's, I was the one they called. It was the reptilian "working caste" that usually did the physical labor in the lower levels at Dulce. Decisions involving that caste were usually made by the white Draco. When human workers caused problems for the working caste, the reptoids went to the white Draconian 'boss', and the Draco called me. At times, it felt like it was a never ending problem. Several human workers resented the "no nonsense" or "get back to work" attitude the working caste lives by. When needed, intervention became a vital tool. The biggest problem were human workers who foolishly wandered around near the "OFF LIMITS" areas of the "Alien Section." I guess it's human nature to be curious and to wonder what is past the barriers. Too often someone found a way to bypass the barriers and nosed around. The camera's near the entrance usually stopped them before they got themselves in serious trouble. A few times I had to formerly request the return of a human worker.

Q -- Are there other sites tied-in to the 'shuttle network' other than those which you mentioned, and if so, where are the entrances?

A -- WHERE!?! EVERYWHERE! THEY CRISS-CROSS THE WORLD AS AN ENDLESS SUBTERRANEAN HIGHWAY. LIKE A FREEWAY, EXCEPT THIS ONE IS UNDERGROUND... The subterranean highway in America is like a freeway except it's underground. That highway depends on electric motors for the paved roads, and it is for limited travel. There is another style of transit for freight and for passengers that is for rapid travel. That world wide network is called the "Sub-Global System." It has "check points" at each country entry. There ARE shuttle tubes that 'shoot' the trains at incredible speeds using a mag-lev and vacuum method. They travel at a speed that excels the speed of sound. Part of your question involves the location of entrances to that base. The easiest way to answer is to say every state in the U.S.A. has them. Frequently, the entrances are camouflaged as sand quarries, or mining operations. Other complex portals are found on military bases. New Mexico and Arizona have the largest amounts of entrances followed by California, Montana, Idaho, Colorado, Pennsylvania, Kansas, Arkansas and Missouri. Of all the state's Florida and North Dakota have the least amount of entrances. Wyoming has a road that opens directly into the subterranean freeway. That road is no longer in use, but could be reactivated if they decide to do so, with minimal cost. It's located near Brooks Lake.

Q -- Are there any 'bases' in the state of Utah? Have you heard anything about an alleged underground installation within the Wasatch Mountains...?

A -- Salt Lake, Lake Powell Area, Dark Canyon, Dougway Grounds, Modena, Vernal. All have exits there. Others too.

Q -- Does the Mt. Archuleta "shuttle system" connect with a shuttle system which allegedly radiates from Mt. Shasta in northern California?

A -- Yes. Mt. Shasta is a major site of Alien - Elder Race - Reptilian Race - Human meetings. Beginning Cleveland, Grover every president in U.S. history have visited Telos City. Truman was supposed to have visited the Lower Realms as a High Archon on Earth. He was supposed to have met the King of the World there, and gave him the "Keys to the U.S.A." Truman received assurance to new high tech knowledge, and victory over all enemies on Earth. He then was introduced to Samaza and Khoach, aliens from Bootes and Tiphon, both reptilian 'kings' or Embassadors. Truman updated the '100 Treaty' and requested magnetic advance, space knowledge and experiments. Khoach agreed, Samaza partially agreed. He exchanged hostages for genetic experiments and magnetic advance, but vetoed space and beam weaponry.

Q -- Did you notice any involvement of high-level Freemasons, Rosicrucians or Jesuits within the underground installation and/or with the aliens?

A - Yes I did, but that is a loaded question, and I won't comment further. I'm not a Mason, or member of any other secret fraternal group. There is one organization I am a member of. That group is commonly called the "Central Unit." It is a pleasure to tell you that I AM a member of the "Sub-Galactic League" of Costa Rica.

Q -- Is there any truth to the allegations that the

CIA/'Aliens' have established 'bases' on the moon, and also Mars?

A -- I've HEARD that too, but I haven't seen proof with my own eyes. The 'aliens' do allegedly have bases on several moons of Jupiter and Saturn. The CIA operates in other COUNTRIES, but I've never heard they operate on other PLANETS.

Q -- Have you heard any hints or rumors suggesting that there may be lower levels beneath the ULTRA-7 level of the Dulce base, and also, where these might lead to and what they might consist of?

A -- YES. Your guess is as good as mine... Sure, there was lots of TALK but that doesn't mean it's there. However, I will tell you I saw elevators that were "off limits" unless you had an UMBRA or higher security clearance. At that base, information is supplied to me at a "need to know" basis ONLY! My clearance was ULTRA-7.

Q -- Some insist that the U.S./Secret government has developed it's own disk-craft based largely upon top secret antigravity experiments carried out by the Nazi-German scientists during World War II. Have you heard anything referring to this?

A -- When I was working in Photo-security, heard a lot of talk, never saw the proof, but once in the Air Force I developed a roll of film that showed a craft LIKE ADAMSKI'S, WITH A SWASTIKA ON THE SIDE.

Q -- Tom, did you have access to the alien craft? Were you ever inside any of them?

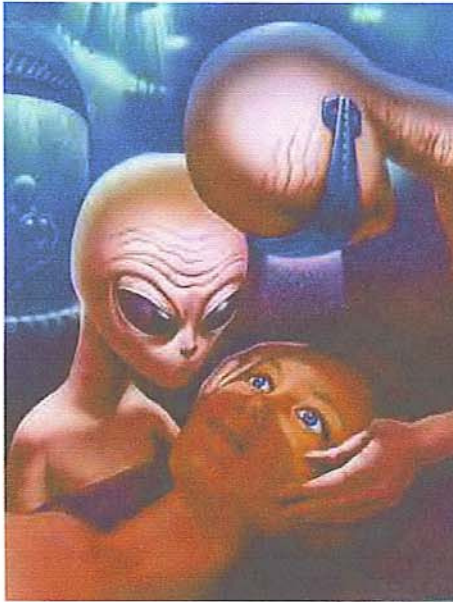
A -- Yes, I frequently saw them in the garages, there are quite a few of them. The main fleet is stored at Los Alamos. Yes, I entered several crafts. There were two things that stick in my mind, the odd spongy feeling of the floors, and the unusual pinkish purple color of the lighting. The crew stated the floor becomes ridged in flight, and the purple tint of the lighting changes to bright blue white. The entire inside of the air craft are scaled down in size, when compared to the average human. The halls were curved and narrow, but some how, when inside it appears bigger than it looks. Certain areas, the outermost sections, almost felt and looked alive. I was never taken up in one.

Q -- Can you give me more information on the reptilian race, what do they do on the sixth level?

A -- The worker caste does the daily chores, mopping the latex floors, cleaning the cages, bringing food to the hungry people and other species. It is their job to formulate the proper mixture for the type one and type two beings that the Draco Race has created. The working caste work at the labs as well as at the computer banks. Basically speaking, the reptilian races are active at all levels of the Dulce Base. There are several different 'races' of aliens that work on the east section of level six. That section is commonly called "the alien section." The Draco are the undisputed masters of the 5-6-7 levels. The humans are second in command of those levels. I had to ARGUE with one large Draconian 'boss' frequently. His name is difficult to verbalize, Khaarshfashst [pronounced throaty kkhahh-sshh-fahsh-sst]. I usually called him 'Karsh,' and he hated it.

The Draconian leaders are very formal when talking to the

human race. These ancient beings consider us a lower race. Karsh called me "Leader Castello," but it was used in a sarcastical way. However the worker caste is friendly enough, as long as you allow them to speak first. They will answer if you address them. They are very cautious beings, and consider most humans to be hostile. They always seem surprised when they found many of the humans were open and trustworthy. There is no fraternizing with the aliens off hours. It is forbidden to speak to any alien race without a clear business oriented reason. Humans can talk to humans, and aliens can speak to aliens, but that is as far as it goes. At the work site, however, it's different. There is "free speech" in the labs. The camaraderie found in the labs also reaches the computer banks section. In those areas, everybody talks to anybody. However, everything changes the minute you cross the threshold of the hall. Instantly, all conversations become strictly formal. Hard as it was, several times I had to arrest some one, simply because they spoke to an alien. It's a strange place.



Q -- Exactly what first made you aware that something was wrong at Dulce? Seems to me that a place as obviously horrible as this one wouldn't need an Einstein to know that this is a CRIME site! What took you so long? Are you the guy who blew the whistle?

A -- There are several things you should know about. I took an oath, under the penalty of death, that no matter what I saw or heard I would never divulge the information. Also, I signed a waiver that states I would willingly give up my life if I was found guilty of 'treason'. At the Dulce Base treason is "ANYTHING that mentions the details of daily operations at this facility, when outside the confinement of this base." When I first arrived, a "need to know" policy was in effect. The story the 'honchos' told us was that "this is a Tri-Biotransfer Facility with Advanced Technology, doing advanced adventurous methodology for medical and mental gains." Which is a fancy way of saying they do really risky things with human life just to

see what would happen. If a medical cure happens, it will be heralded on the surface of the earth as a marvelous new cure, saying it was found after years of research at some well known medical lab. The real story of the cure is never explained. After all, the Dulce Base IS A SECRET FACILITY! These people are very good at what they do. They do not tell the truth about the unfortunate people that end up in "Nightmare Hall."

I worked with aliens. With that in mind, you should get the idea of the secrecy and the security at that place. Yes, I know this was not the usual hospital type job site, but in the beginning I 'bought' the whole package. I was reminded daily by intercom, in the elevators, that "this site does high risk advanced medical and drug testing to cure insanity, please, never speak to the inmates, it can destroy years of work." I'm sensible, when doctors say don't speak to them, who was I to destroy the delicate situation? But one man some how caught my eye. He repeatedly stated that he was George S----- and that he had been kidnapped and he was sure someone was searching for him. I don't know why he sticks in my mind, I found I was remembering his face, thinking he sure didn't look or sound insane, but many inmates said that. The next weekend I convinced a friend of mine, a cop, to run a check on the guy, saying I had a run in with him and was curious. I didn't mention the base at all. It was a sickening feeling when the computer confirmed that George S. was missing. What's worse, the cops thought he was just another guy that got tired of the daily grind and split.

That was the beginning. Am I the one that blew the whistle? No. The next Monday, I searched for George, but he was gone. There were no records that explained what

happened to him. It was another security officer that came to me saying he and some lab workers wanted an off duty meeting at one of the tunnels. Curiosity took over and I said OK. That night, about nine men showed up. They said they knew they were risking me turning them in but they wanted to show me some things they thought I should see. One by one they showed records that proved many inmates were missing people. There were newspaper clippings, and even photos that they had some how smuggled into the base. They hoped to smuggle them back out, without me turning them in to head honchos. I could see the fear in their faces as they spoke. One man stated he would rather lose his life by trying, than to lose his soul by not doing anything at all. It was that remark that turned the tide. I told them about George and the things I found out about him. After a few hours we pledged to attempt to expose the Dulce Base.

Q -- The name Nightmare Hall is descriptive, but surely there was a 'regular' name, what was it called in the manuals?

A -- In the manuals it was called "The Vivarium". It describes Dulce Base as a "secured facility for tending bio-forms of all types." In their report it is retold as "a private subterranean bio-terminal park, with accommodations for animals, fish, fowl, reptile, and mankind." After SEEING this 'park' the name Nightmare Hall is far more accurate than the manual. The 'accommodations' for the inmates at Nightmare Hall fall short of the pretty picture the manual describes.

Q -- You mentioned one reptilian leader, Khaarshfashst, do you know any thing about him, like where is he from? Is

he from Earth or some other planet?

A -- His name means "keeper of the laws". They receive their name after they reach the "age of awareness". They do not recognize time as an important factor in "being aware" the way humans do. Upon their "age of awareness" they are cognitive of the station or position they are destined to fulfill. At that time they chose or allow someone to choose their name. Their name will include the position they hold and several personally chosen letters. Each letter has a personal meaning, known only to the alien and the one that chose their name. Since Karsh's name means keeper of the laws his name includes kaash [memory or keep, base word for 'Akashic' record] and fashst [law, base word fast or bind]. Reptilians choose to be not only private but secretive of the location of their natal place. To them birth, or emergence of life, is considered as one of the sacred rites of life. They consider Earth or Terra their "home planet", but several reptoids discuss several star maps. Most of those stars were within the Milky Way. Within those star maps lies the stars and planets of the Planets of the Allegiance. Earth being one of the planets in their trade routes. If any human asked clear questions about the Allegiance, the Aliens referred the questions to the Draco. The Draco in turn, referred the questions to their supervisor [me]. I did not have that information about the stars, because information was supplied on a "need to know" basis. I didn't 'need' that information.



Q -- Did any of the working caste join in the revolt? Could you give me some names?

A -- A few of the reptilian janitorial crew let us know that THEY knew WE were attempting to sabotage the work going on in the sixth and seventh levels. One of them, with the name Schhaal, secretly formed a small group of reptoids with the same mind set as my group. Sshhaal took upon himself the danger of informing me. He was as open as is possible in a unique situation. On the day I found out about it, I was inspecting a camera near an exit tunnel. He approached, stooped down, seemingly scraping some non-existent dirt, and he quietly said, "A few of us agreed that you are singular in your interest in missing-human reports. If true, walk away. I'll reach you. If it's untrue, destroy my life now!" My heart almost leaped out of my chest, but I silently walked toward one of the wide halls.

For the rest of my life I'll remember those words! It was the first time I KNEW reptilians could have individual thoughts and opinions! Basically, they formed a uniform front with a small variety of interests. Or at least, that was what we had thought. It was a couple days before I heard from him again. As he walked beside me in the sixth level's infamous hall, I heard him say "Enter the exit tunnel on the sixth level, north, after your shift." The next few hours were long and filled with thoughts of betrayal, or worse,

but I shouldn't have worried. I contacted one of the original nine men, and let him know, just in case. Gordon wanted to go with me, but I convinced him to wait a few feet from the exit and pretend he was having trouble with his cart. When I got there, there were three of them. SSHHAAL formerly introduced FAHSSHAA and HUAMSSHAA [name base word is SSHHAA or assist]. With that, I quickly grabbed Gordon from the hall and the five of us talked and walked in the dark tunnels about three hours. After that day, the joined resistance group got bigger and bolder.

Ultimately, it ended when a military assault was initiated via the exit tunnels and they executed anybody on their list, human or reptilian. We fought back, but none of the working caste had weapons, nor did the human lab workers. Only the security force and a few computer workers had flash guns. It was a massacre. Every one was screaming and running for cover. The halls and tunnels were filled as full as possible. We believe it was the Delta Force that chose to hit at shift change, an effort that killed as many as named on their list. We, to this day, do not know who BETRAYED us. Gordon Ennery ran beside me as we ran into the third level exit tunnels, and he died when several bullets slammed into his back. I vaporized that assassin and kept running. And I'm still running. Gordon will be remembered.

Q -- Tell me more about the flash gun. Is it difficult to operate, or is it like the weapon on Star Trek, that can stun or kill on different modes?

A -- It is an advanced beam weapon that can operate on three different phases. Phase one, like Star Trek, can stun

and maybe kill, if the person has a weak heart. On phase two, it can levitate ANYTHING no matter what it weighs. Phase three is the SERIOUS BUSINESS mode. It can be used to paralyze anything that lives, animal, human, alien and plant. On the higher position on the same mode, it can create a TEMPORARY DEATH. I assure you, any doctor would certify that person is dead, but their life essence lingers in some strange limbo, some kind of terrible state of non-death. In one to five hours the person will revive, slowly; first the bodily functions will begin, and in a few minutes, consciousness followed with full awareness.

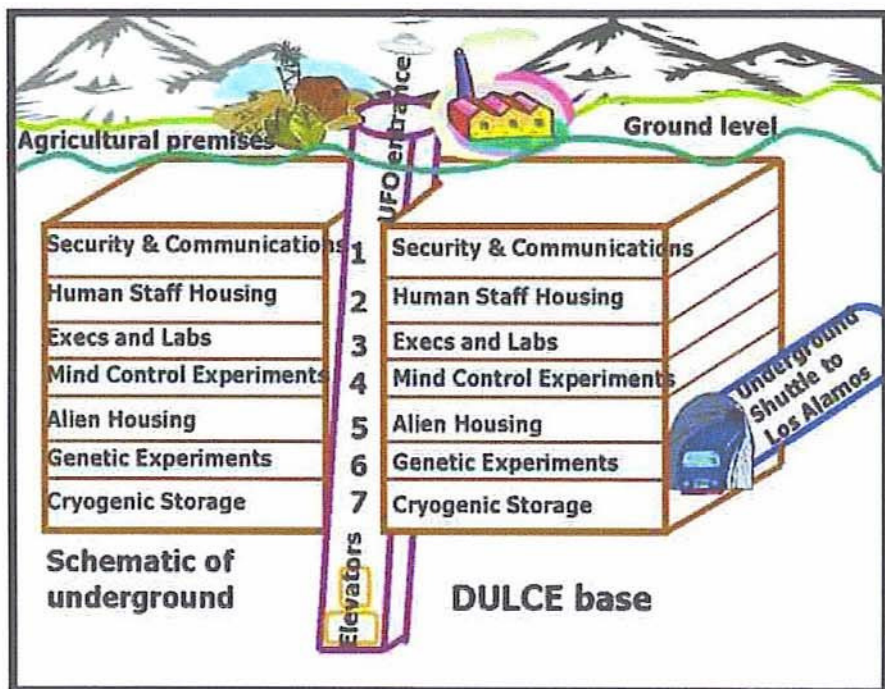
In that mode the alien scientists re-program the human brain and plant false information. When the person awakes, he 'recalls' the false information as information he gained through life experience. There is no way for a person to learn the truth. The human mind 'remembers' and believes completely the false data. If you attempt to inform them, they would laugh or get angry. They NEVER believe the truth. Their mind always forgets the experience of re-programming. You asked if the flash gun is difficult to operate. A two year old child could use it with one hand. It resembles a flash light, with black glass conical inverted lens. On the side are three recessed knobs in three curved grooves. Each knob is sized differently. The closer the knob to the hand the less the strength. It's that simple. Each knob has three strengths also, with automatic stops at each position. The strongest position will vaporize any thing that lives. That mode is so powerful it will leave NO TRACE of what it vaporized.

Q -- Is the weapon called a Flash Gun or is there a different name in the manuals?

A -- Everybody calls them Flash Guns, or more commonly "The Flash" or "my Flash" when talking about it. In the manual it is first introduced as the ARMORLUX Weapon. After that, it is explained as the Flash Gun.

Q -- What type of security is found at the Dulce Base? What else is used against espionage or unauthorized entry?

A -- I'll mention a few, but it would be nearly impossible to cover it all. The weapon, besides the Flash Gun, mostly used is a form of sonic. Built in with each light fixture is a device that could render a man unconscious in seconds with nothing more than a silent tone. At Dulce there also are still and VCR cameras, eye print, hand print stations, weight monitors, lasers, ELF and EM equipment, heat sensors and motion detectors and quite a few other methods. There is no way you could get very far into the base. If you made it to the second level, you would be spotted within fifteen feet. More than likely, you would become an inmate and never see the light of the surface world again. If you were 'lucky', you would be re-programmed and become one of the countless spies for the Ruling Caste.



Q -- According to certain reports, the Dulce Base is host to other aliens that live in level five. Is that true? Can the humans freely roam or meet one-to-one in the halls or is some type of protocol in effect?

A -- There is protocol from the first time you enter the base and it MUST be followed every time you SEE an alien there. From the working caste, to the visiting aliens, to the Ruling Caste, there is a never ending check list of rules, law, and strict protocol. There is never a chance to roam on the fifth level. The alien housing area is off limits to any human. The Hub is surrounded by security, arsenal, military and CIA\FBI sections. The area past the security is one of the most secured areas because it houses so many classified files. The entire east side of the fifth level is off limits except for security personnel holding ULTRA-7 security clearance or higher. The garage on the west side of the fifth level requires ULTRA-4 clearance.

Q -- What about the elevators, do they drop from the surface to the seventh level in a couple of seconds? Do you know anything about them? Are they electrically lifted? Every where on the surface world there are elevators made by Otis Elevator Company. Does that company make the elevators at Dulce?

A -- I failed to notice what brand was available in the elevators at the base. I could tell you that there is no elevator anywhere at Dulce that drops from the surface to the seventh level. The security blue prints show the levels are 'stepped' down. Each level drops one floor only. Not even the Hub has an express elevator. After the third level, not only would you change elevators, you are weighed and color coded, before you re-enter the car. All the elevators are magnetically controlled, even lights in elevators, as well as all lights on all levels are magnetically induced. The light bulbs are not the type bought on the surface, but a totally different type of light system. The illumination found there is a closer match to natural sunlight than any artificial light on the surface world. The shape of the elevators is unique. If you have ever seen a Tupperware sugar bowl, you could see the shape copied in the elevator. Sort of like an open ended oval with another half oval on each side. The elevator shaft matches the shape perfectly. The magnetic controls are in the half oval shape. If you could stand in or close to the half ovals, you would feel the slight pull of the power of those magnets. The motion is smooth and silent, there is a nearly unnoticed surge when the motion starts or stops. There are no cables needed, because the lift is magnetic, not electric.

Q -- A mysterious security man calling himself agent

"Yellow Fruit" says he worked at Groom Lake [Area 51]. The Security Officer states that he's been in contact with benevolent aliens, at the Groom Lake facility -- are you aware of such a group?

A -- Yellow Fruit is one of the slang names for Yellow Jack, or Yellow Flag, that shows quarantine and caution in the labs. There are so many different slang names at Dulce labs that meant quarantine that the workers published a booklet to show the meanings. At Dulce, Yellowfruit are the lab workers. Banana is the older workers, lemon is the new guys and so on.

Q -- Is there an alien installation under Groom Lake or Papoose Lake at the Nevada Test Site, and are they conducting biological research at these sites?

A -- Most of the stuff at the Groom facility deals with defense, but there is a large storage area in the tunnels that holds thousands of alien craft parts. From what I have heard, the medical tests at the Nevada Test Site are conducted by and for the Navy.

Q -- According to my sources, the Aerospace companies have a secret underground installation in the Tehachapi Mountains, not far from Rosamond near Edwards AFB. Insiders refer to the Tahachapi Installment as the Ant Hill. They are experimenting with advanced technology such as antigravity disks. Some have seen basketball sized floating orbs patrol the facility, do you have any further information on this?

A -- The California mountains all have alien security methods and equipment. The basketball size orbs are used for unmanned patrol. They are silent, but when

photographing living beings there is a humming sound. The glow that emits light is magnetic aura. This is in the visible spectrum, 3900 angstroms. You can see the light, but the light does not reflect off any thing.

Q -- How do the aliens use magnetism? Do they use it as an energy source? Is there more we need to know about magnetism?

A -- The aliens use magnetics for EVERY THING! They use magnetics as the basic structure for their energy source. The more you learn about magnetics, the better. The Human Race calls them 'magnets', the Aliens call them 'lodestar'. They have been harvesting lodestars for centuries. Not only that, they want ALL the magnetic power on Earth. They intend to continue harvesting that power, now and in the future. As long as we were only using magnetic power as an oddity, there was no problem. But in recent times, the human race has begun using magnetic power and finding more ways to utilize that commodity.

There was a treaty made. In the original treaty, the human race didn't mind at all, 'we' considered magnets as hardly more than useless. As people searched for another source for power, we turned to magnetics. The aliens wanted a new treaty. What could we offer? They chose land, underground mining rights, animals and humans for new experiments. The general public NEVER KNEW about the treaty. The governmental heads of the world chose another treaty in 1933. This time 'we' got high-tech knowledge in exchange. So now, the more we use magnetics, the more they claim humans, and the lands of the U.S.A. We were 'sold' in exchange for magnets. If you

doubt it, look around -- there are token companies that 'really' utilize magnetic power, but are depending on electric based or ceramic magnets, NOT lodestar based magnets.

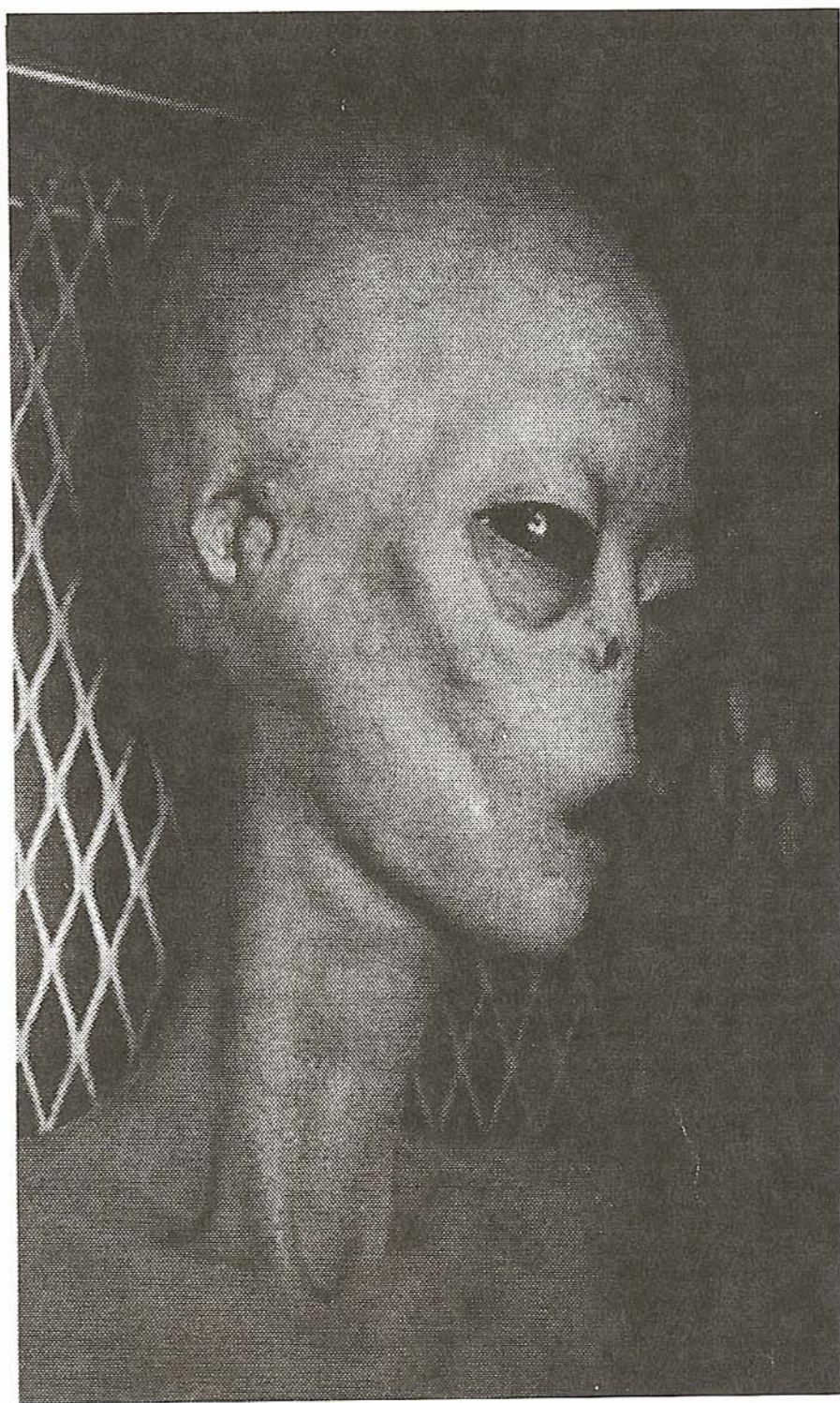
Q -- What do the aliens do with the cow blood and other parts from mutilated animals? Do they need these fluids for research or survival?

A -- The aliens use the blood and body parts for formula to keep them alive and for use in the growing vats, and for the artificial wombs. Plasma and amniotic fluid are the two most vital ingredients for their lives. Also, the 'sap' of some plants can keep them alive for months. Most of the plants are parasitic in nature, but red grapes and okra plants can also be added to the formula to keep them alive, if they have no 'regular' formula.

Q -- Female abductees report being inseminated by aliens. Are they trying to hybridize our species?

A -- Yes, they are breeding slave-warriors for the upcoming war with the alien races. The serpentine races are in orbit around Earth, Venus and Mars.

Gerald Schultz' letter from Paul Bennewitz

In 1988 Gerald Schultz, an office staffer at APRO (Aerial Phenomena Research Organization) in Tucson, Arizona was returning from Colorado when he stopped in Albuquerque, New Mexico to see Dr. Paul Bennewitz and ask him some questions.

Gerry did in fact make contact with Paul Bennewitz and spoke with him at length at the time. After returning to Tucson and APRO, Gerry thought of more unasked questions and wrote a letter to Paul seeking some more answers. Paul answered with some detailed explanations of the answers which satisfied Gerry.

A couple of years later, Gerry, needing money sought to sell this letter to a friend in Tucson. The friend bought it and preserved it until this day. This letter is written in Paul Bennewitz' own hand, and we publish it here just as Gerry received it long ago.

11/16/85

Dear Gerald:

Your letter received and appreciated; happy to make your acquaintance.

First - yes - I do have a family three boys 28 to 32 yrs of age.

I own a Research and Manufacturing plant here in Albuquerque and am a Physicist.

As to the subject of interest - I would like to know how you came to hear of me and the happenings at Dulce.

To tell and explain all I may know about the saucers - and I do not call them UFO's would take a book to outline the subject.

I might also explain I am not what is called a "UFOlogist", but rather a Scientist who has employed Scientific methods to prove absolute data from a totally empirical point of view.

I have deliberately kept myself isolated from others such as Hynek, Vallée, etc. To me because of what the near eight years of research on this basis has revealed, ~~the~~ sightings, interviews and Government backup documents are spurious. That may sound quite self-centered but is fact.

I would also add that one should not be concerned about saying they saw one or had an experience first hand with one or its occupants but should be totally open and say so.

To "Heck" with anyones opinion, it is fact. To "gill" an individual to disprove or discredit is no way to move forward. I say this to set your mind at ease in that I have observed and seen so many and learned the truth about them that there is no remaining doubt.

Instruments, in addition to direct observation have a way of being very adamant - they have no imagination but are rather direct tools to rely upon

if one knows how to employ them accurately. Their "opinions" including that of the cameras "are quite direct" - they do not "speculate".

Initially I will just make direct statements based upon total involvement at all levels with the alien lifeforms and Government in New Mexico.

Not speculation - and upon the last near eight years of intensive research. To totally understand you should try to do two things. 1) Learn that it is not a "belief system" nor is it critical to that.

2) Broaden and open up your, as I call it, "Reference Frame". To absorb all the ramifications and truth of it with a normal "Reference Frame" is totally impossible. In addition, the following:

3) You literally, in learning and understanding all of it, are stepping thru a "Time Window" with vast jumps in total knowledge at all levels.

4) Throw out the Psychic, ESP, Magic, Witch Craft, Bermuda Triangle, Big Foot, and all of those "other" belief systems, relate only to fact - the other will divert you and waste your time.

5) Realize you are not dealing with "superior" beings per se; you are dealing with "Life Forms". They have their strengths as we do and they have their weaknesses. They may do some things in a different way but they have ego, resentments, social structure failures, moral weaknesses, logic faults, and emotions - particularly anger, joy - empathy? Sometimes I wonder but hopefully it is there somewhere.

They do not respect, apparently, one's privacy - both mind and body and feel they can sit in judgement in many instances - but the logic distortion really denies or tends to deny that.

They have "ships of light" but are lacking in many other ways.

So - the following statements, are, all true.

- 1) They do exist, and have underground bases in New Mexico - I imagine there are bases elsewhere however all that is related pertains to only this state.
- 2) They did make an agreement with the U.S. faction very early for obtaining the present locations and various technology trades, presently in progress.
- 3) The U.S. has people at their bases. The U.S. has advanced ships at their bases.
- 4) The key reason for cover-up by the Gov. is not totally aligned to population fear or panic. There is some alignment to National Security for obvious reasons - and other more serious parameters not discussed at this time, that I believe are the key crux of the matter.
- 5) They helped the Gov. forces to design an Atomic Ship and have built several. The ships can make it from one coast to the other in less than 10 minutes and I have photos of it. It is very dangerous because of the Plutonium Pellet fuel used in its reactor.

- 6) The ^{alien} ships generally seen in the biosphere of Earth cannot fly in outer space - a transition to other propulsion methods must be made. In later correspondence perhaps I can clarify this for you.
- 7) The ship you drew is quite accurate and is one of many configurations the Lifeforms use.
- 8) They would have you think they are Gods - they are not. Some are reasonably good - some are very bad - some display an unmitigated ignorance others are the opposite - there is a good and a bad force as in all legends and fairy tales although unfortunately in this case it is ^(legend or fairy tale) neither if they exist.
- 9) They come from Zeta Reticulae a Binary system. Others may be from other areas in the universe. They are not limited by the speed of light in space.
- 10) They range from very small humanoids - apparently "made" by recombinant DNA methods - the "workers" - to grey-brownish large cranium, large eyes about 4 to 4.5" tall, to taller near dead white or yellowish appearing individuals six feet or more tall. Some are of a greenish-yellow cast, eyes moved back, with large pupils - slit mouth - small nose - and in most cases - no hair of any kind.
- 11) They generally communicate by thought even ship to ship - with apparent nerve modifying implants - not ESP in the most strict sense.



Q -- Abductees have reported that the aliens can pass their bodies and that of the abductee through window glass. Is this a feat of magic achieved by advanced technology or is it a psychic power?

A -- The aliens have mastered atomic matter. They can go through walls like we go through water! It is not magic, just physics. We can learn to do the same thing. It has to do with controlling atoms at will.

Q -- Are you in communication with benevolent aliens or do you have contacts that are? If you are, can you tell us how we can communicate with their teams?

A -- I am not at liberty to discuss communications with any friendly alien life forms. I can tell you there is a friendly factor active in Costa Rica, I am in direct communication with that factor. I am an active member of the Sub-Galactic League of Costa Rica. This organization, using a small

satellite dish, a television set and ham radio equipment reached this factor. I might suggest that by using similar equipment and a low band frequency, you may reach the same factor.

Q -- Do you stay in the U.S.A., or do you live abroad? Do you work now? I know you have been on the run for several years.

A -- Yeah, quite a few years. I visit the U.S., but it's really dangerous when I do. I've lived in several countries. I spent a few years in Mexico, working as a mercenary soldier. It's rough work, frequently living in the bush, eating what ever I can find. I spent time in South America, fighting the drug cartel. I settled in Costa Rica, 'bought' a small house in Limon. Actually it is a shanty that some one abandoned. I paid the equivalency of \$11 to one of the local constables for the right to call it 'mine'. My name changes when I think some one is asking questions. I've worked in one of the underground bases near the Panama border. It's in the mountains, not very far from a passive but 'active' volcano. It is not as fancy as Dulce, but the people are wonderful.

Q -- Are there any other security level names?

A -- There are many other security clearances, here are a few, UMBRA, STELLAR, G2-7Z, TRIAD, UMT [Universal Military Training] and UMS [Universal Military Service], ASTRAL and SUB-ASTRAL. UMBRA is higher than ULTRA.



Q -- Since you have lived in Spanish speaking countries, it's obvious that you are bilingual. What other languages do you speak?

A -- Other than English, the only other languages I speak are Spanish and Eusshu, the common language spoken at Dulce. I speak Spanish fluently, and enough Eusshu to keep my self out of trouble. Shortly after I first transferred to Dulce, I took a course to learn the basics. Other wise, you are required to wait for an escort to get around. All the signs at that base are written in the universally recognized symbolic language. Eusshu is logical and easy to learn. rash course in Eusshu. Any one that plans to spend more than one week working at that base, they are

Q -- What are the eating habits of the aliens? Are they carnivores?

A -- That depends weather they are one of the gray worker caste, one of the reptilian worker caste, or one of the higher developed Draconian Leaders. Also, the created beings, replicants, type two being, or one of the really strange genetic mixtures. I'll try to cover a little of each.

The formula includes amniotic water, plasma and several other body parts. This nearly clear mixture with a texture of pureed peaches, and almost in that color. The grays make the attempt not to 'eat' around the humans, because the odor of it is VERY unpleasant to ANY human. They can spend days or even weeks between feedings. The working caste of the reptilians eat meat, insects and a large variety of plants including vegetables and fruit. They prefer their meat raw and very fresh, but have learned to enjoy some cooked meat like rare beef steak. Unlike the Greys, they eat frequently and usually carry or send for food on their breaks.

The Ruling Caste is SECRETIVE about their foods. They have created several dietary myths that they carefully embellish when the chance arrives. One of their favorite legends involves one of their ancestors' ability to eat an entire flock of geese in one setting. They RARELY eat in sight of any other species. They carefully choose their food, then carry their meal to their quarters. It was only when dignitaries arrive at the base did they join their meals. They enjoy the same foods we do, and they have been seen secretly munching on a freshly found snail. The "human looking" replicants eat some cooked vegetables. They rely on vitamins and liquid protein for sustenance. If they have to eat on the surface world, they can eat what ever they are served, but as soon as possible they regurgitate. Their digestive systems frequently fail to process the food properly. The engineered beings have a special diet, created for their dietary needs. The mixture includes several organ foods blended with plasmatic fluids, amniotic liquids and parasitiplasm materials. These unique 'animals' also enjoy occasional green plants, usually grasses or lettuce. The creatures that are designed

to become warriors, eat protein filled liquids.

Q -- In the Dulce Papers, copper seems to be high on the importance list. In what methods is copper used?

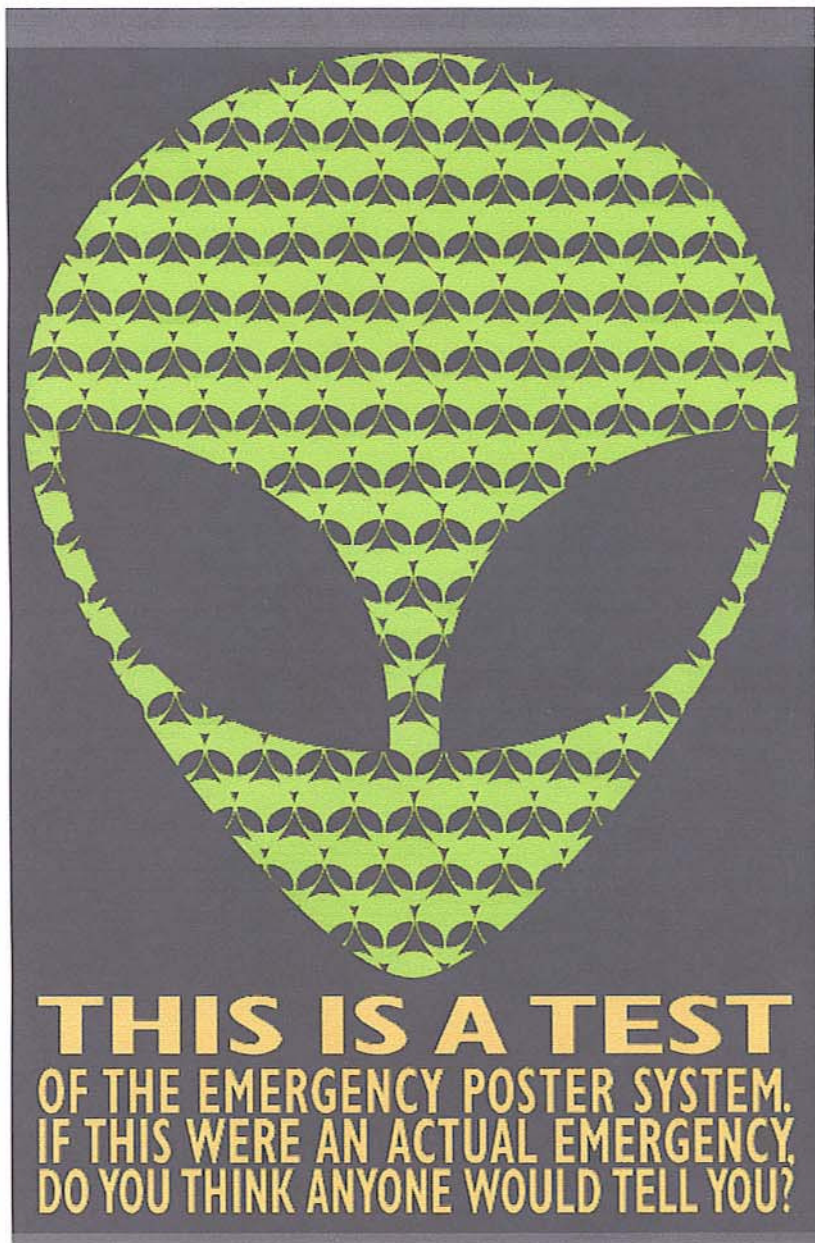
A -- One of the main uses of copper at Dulce is containment of the magnetic flow, magnets are used every where at that base. The infamous vats' interiors are lined with copper, and the exterior walls are clad with stainless steel. The mechanical arm that stirs the liquid is made of a copper alloy. Other uses include dietary needs in a few of the transbiotic beings. There are several specially made cells or rooms built first with lead, then magnetic steel then clad in copper. It is in those cells on the Fourth Level that contain living aural essence. This essence is what you would call 'soul' or..."astral body".

Q -- Growing multi-species beings, blood formulas and human parts in vats sounds like a bad plot to a science fiction movie. The doctors and scientists of the world claim you can't mix the species. The concepts mentioned in the Dulce Papers sounds far fetched. Could you provide information that the average "surface world" reader could understand about similar things?

A -- The doctors and scientists on the SURFACE world may say that, but underground, away from the prying eyes of ethics boards, they DO GROW TRANS-GENUS BEINGS! There is a lot of written material available at libraries. One of the best sources is an easy to read book published back in 1969, by Prentice-Hall International, with the title of "THE SECOND GENESIS, THE COMING CONTROL OF LIFE" by Albert Rosenfelt. In this book, they discuss "animals that may be especially bred to supply genetically reliable organs for people." -- and "...the use of fetal or

embryonic material from which adult sized organs and tissues may be grown..." Also he discusses the fact that embryonic tissue has no immunological activity, therefore it cannot provoke the defense mechanism in the recipient. IT WILL JOIN THE BODY NOT AS A FOREIGN ANTIGEN, BUT AS A NATURAL PROTEIN. He further discusses solitary generation, commonly called virgin birth, but also known as parthenogenesis.

With one "virgin birth" in 1.6 million births average ON THE SURFACE of the world, in Dulce that rate is reversed. Occasionally, a "normally born" human infant is born in the hospital wards on the Seventh Level. Parthenogenesis is the method used to grow type two beings. The now common transsexual surgery on the surface world, began at the Dulce Base. Men became women on a whim in the Seventh Level labs, and with the Fourth Level technology, the brain washing the "eager desire to become a woman" and that poor man FIRMLY BELIEVES he always wanted to be a woman. No one could convince him to believe the truth. ALL THINGS ARE TWISTED AT DULCE. A quote by Dr. Ralph W. Gerard [in THE SECOND GENESIS] put in his now classic statement: "There can be no twisted thought without a twisted molecule". MOST have originated at Dulce.



Q -- How are the human workers stopped from telling everything about Dulce?

A -- Implants, fear threats to harm the families, EM control, also reprogramming with ELF [Extremely Low Frequency]

and drugs are the most common methods to 'encourage' the workers not to divulge the location or daily routine.

Q -- A construction worker at "The Ant Hill" [The Northrup's Tehachapi Base] reports seeing 10-12 foot tall human looking beings in lab coats. Who are these guys, are they from the hollow earth?

A. They are probably inner earth drones. The deeper you get, the stranger the life forms. The tall men are from the subterranean levels, lower yet are the dwarfed deformed forms. I don't trust either of them. There are other forms, that both the tall men and the dwarfed men fear and loathe, they are similar to Bigfoot in appearance, but extremely violent and enjoy eating what ever they find while it is still alive! They are subhuman and demented, with an IQ around 15. The reptiloid life forms stay in caves or caverns that aren't very deep. They prefer the desert mountains. They use camouflage rather than fighting, but they do carry vril rods for protection. They do have a symbol, not the hokey "snake-with-wings" that I keep seeing in the public. The REPTOIDS use a dragon with its tail in its mouth with seven pointed stars in the middle.

Q -- Is there a specific location where the public can set up their cameras and equipment to DOCUMENT an alien-government base, and/or their activities?

A -- The problem is, most of the meetings are held in military bases or underground. The Groom Lake Facility does fly several alien craft that regularly fly over unpopulated land that go back and forth from several bases, Southern California has several notable areas. Twenty Nine Palms -- Lancaster or Chocolate Mountains are well know for such activities.

Q -- Could you provide us with a copy of your badge or card you used at Dulce?

A -- Badges or cards never leave the bases. All exits have bars or walls of metal... to open, to go out requires using the card. When you use it for an exit slot, the card won't come out. Each time you leave the base, you are issued a new card, with all the usual data about you, plus your weight added, corrected daily. There are several mines in the Chocolate Mts. that open into a base highway, but be aware that they are patrolled regularly and there are cameras there.

Q -- What are the dimensions of the Dulce Facility?

A -- There are 1,700 paved miles of roads under Dulce and Northern New Mexico., towards Los Alamos is another 800 miles of tunnels. The base is STILL GROWING.

Q -- What is the top depth?

A -- The First Level starts 200 feet from the surface. Each level has a ceiling of seven feet, except levels six and seven, the ceiling there is 45 and 60 feet. There are approximately 45 feet or more between each level. The average highway ceiling is twenty five feet. The HUB at the base is 3,000 feet wide. Use a 7.5 minute scale map to try to comprehend the size of the place.

Q -- Are there "regular vehicle" exits that can be observed from the ground?

A -- Yes, but they are inside Los Alamos.

Q -- Are their aerial exits that can be observed?

A -- Twenty miles due north of Dulce is a large hanger, it is hidden by a facade of cliffs. Look for an isolated short road on the top of a mesa, with no road to or from the top.

Q -- Are the ventilation shafts visible?

A -- The ventilation shafts are hidden by bushes or vents inside caves. There are five on the top of the mesa, be aware there are cameras inside most of the vents.

Q -- Is there external security, and could we recognize them in or around the town itself?

A -- There is minimal security on the surface, most of the men are Air Force or "highway crew" men. There used to be a Best Western motel that hosts or hires a lot of Base workers from Level One. I don't know if that motel is still operational. Most of the security force live in Santa Fe. Others live at White Pine [Los Alamos].

Q -- Are there security sensors? What type? If so, what is their power source?

A -- Yes there are many types of sensors, radar, infrared, heat sensors, microwave, EMGW, and satellite. Most of the sensors are powered by magnetic power. The only thing you may notice on the surface, would be an occasional satellite dish.

Q -- If you can, give us some information on the upcoming war with the aliens. When does it start? Do you recommend going underground?

A -- The war has already begun. To start, they use "weather control" devices that can cripple a city in hours. Storms, flood and drought -- with those few things they

can bring any country to their knees in a hurry. Yes, I do recommend going underground. Choose a location that has a higher elevation than the surrounding terrain. Pick out a cave or even an abandoned mining shaft or two, bury a cache of supplies near these locations. Place the supplies in heavy plastic boxes that have tight lids. Then plan to live like a squatter when it becomes necessary. If you own land, create a system of tunnels and tell no one. Use your tunnels to secrete your supplies, and plan to live in those corridors when you must.

Q -- What about the reptilian ships that are in orbit around the equator, are they cloaked?

A -- They are not cloaked the way you may think. It's more like nobody is learning to SEE, even though it is in plain sight. Like the mail man becomes invisible because you are so used to seeing him you never noticed he is alive. One of the favorite methods of covert activities is to 'hide' their operation in such an OBVIOUS way that no one would suspect it is covert.

Q -- What are the Greys susceptible to?

A -- The greys are photosensitive, any bright light hurts their eyes. They avoid sunlight, and travel at night. Camera flashes causes them to back up. It could be used as a weapon against them, but they recover quickly. It could buy enough time to escape. Use commands, or nonsensical words in the form of commands and they will back up. Their brain is more logical than ours and they do not create 'fun'. They do not understand poetry either. What really confuses them is saying things in "pig-latin". We learned that in a hurry, and used it against them in the Dulce Wars.

Q -- Can greys read your intentions if you came up behind one?

A -- Yes. They read your INTENT, because they use your body's frequency. The human race broadcasts a frequency, that they recognize as an electromagnetic impulse. Each person has a slightly different frequency, that difference is what we call 'personality'. When a human thinks, they broadcast strong impulses, in the case of 'fear' the frequency is 'loud' and easy to recognize.

Q -- Can we shield ourselves against their mental control?

A -- We CAN shield ourselves against them, however 95% of the human race never try to control their thoughts, and controlling our own thoughts is the best weapon. The average person rarely thinks in a clear pattern. That allows the brain to think in a chaotic way. Control your thoughts, AND YOU CAN STOP THE ALIENS ATTEMPTING TO ABDUCT AND CONTROL YOU. Controlling my own thoughts have kept me alive for years.

Q -- Could you shed some light on the type of human the aliens are looking for when they abduct?

A -- I can tell you that the most common are petite women in their early twenties or early thirties, dark haired boys between five to nine, small to medium size men in their mid-twenties to mid-forties. But, let me stress that there are ALL TYPES of people being held against their will in the Dulce Base! There are tall heavy men and women, teenagers, elderly folks and very young girls in the cages AND the vats. I only mention the most common age-size are the small young men and petite women. The boys are favored because at that age their bodies are rapidly

growing, and their atomic material is adaptable in the transfer chamber. The young small women are frequently very fertile. The men are used for sperm. I have no idea why they prefer small to average size men.

Q -- What is the prevalent human race at the Dulce Base? I am curious about both the human workers, and the inmates.

A -- The human work force is made of people from every nation on the surface world. The one thing they share is that they all speak english. If you are asking if there are white, black, red, yellow and brown skin color, again I'll have to say that there is no 'prevalent' race there. As for inmates, I could see ALL races there. From what I could see, it looked like there were more 'white' people, but again, I saw a constant flow of different people, many I think, were only there for a few hours.

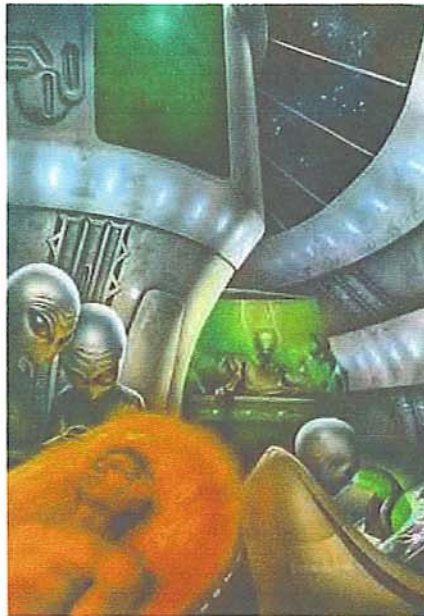
Q -- Please explain the method they use to identify each inmate.

A -- No one has a name. When first brought to this facility, they were issued one large 'number'. Usually that code has a mixture of numbers and letters. They show the place, how, and by who, followed by the time, age, sex and finally the personal number. For example it might look like this: NVLV-00A-00700-P00:00:00-00-M-000-00-000.

Q -- You have been through so much, and yet keep fighting, what is your biggest fear?

A -- That the general public will forget THE TRAPPED INNOCENT PEOPLE in the despicable place, and will ignore THE HUNDREDS OF CHILDREN, WOMEN AND MEN

ADDED TO THAT PLACE EVERY MONTH.

Armed guards patrol constantly, and in addition to weight sensitive areas there are hand print and eye print stations. Here, is the device that powers the transfer of atoms.

Level 6 - Level 6 is privately called 'Nightmare Hall'. It holds the genetic labs. Experiments done on fish, seals, birds, and mice that are vastly altered from their original, forms. There are multi- armed and multi-legged humans

and several cages (and vats) of humanoid bat-like creatures up to 7- feet tall. Aliens have taught the humans a lot about genetics, things both useful and dangerous.

Level 7 - Humans in cages here, usually drugged or dazed, sometimes crying out for help. Level 7 is the worst. "Row after row of 1,000's of humans & human-mixture remains in cold storage. Here too are embryos of humanoids in various stages of development. Also, many human children's' remains in storage vats. Who are (were) these people?"

Below Level 7 - Unknown other levels unexplored by humans. Aliens here. Exits into a vast underground cavern series, unexplored by humans, but suspected to be a huge alien culture area. Tunnels to: Colorado Springs, Colorado Creed, Colorado Datil, N.M. Los Alamos. Page, Arizona Sandia Base Taos, N.M.

Notes: The Dulce installation (upper levels) was originally constructed by the **RAND Corp.** There are reported to be over 3000 cameras at various high-security locations. Deep sections of the Complex may **CONNECT INTO (EXTENSIVE) NATURAL CAVERN SYSTEMS.**

CONCLUSIONS

Now with the benefit of hindsight and considerable supplementary and confirmatory information, all coming together in this assembled material, the Dulce Story is becoming more credible, as exotic and unbelievable as it is, but there are stranger things still that are entirely true when all the facts are known. Witness the case of Jay-Rod, a real extraterrestrial being, and one of his handlers, Bill Uhouse, sitting in conference with 16 other scientists, in a meeting chaired by none other than Edward Teller, The head of the AEC himself. Nothing was ever published on that outside of the Atomic Energy Commission, and quite probably very little inside that agency.

And you likely have never heard of another anecdote involving the headquarters of the AEC at Los Alamos. After the recovery of another alien ET vessel that came down out of control some 8 miles north of Kingman, Arizona in about 1958, the four live occupants were taken to Los Alamos and the craft to Area 51 in the AEC Area north of Las Vegas, Nevada. The craft was "beeping" a tone the whole time during the recovery and even after it was taken to Area 51. Technicians were unable to enter the vehicle to stop the beeping. Finally somebody suggested they bring the alien occupants back from Los Alamos and have them turn off the tone. They did just that, brought them back from Los Alamos, and when the aliens understood what they wanted them to do, and indicated that they would have to enter the ship, there was some doubt of the advisability of that. Finally, after some more discussion it was allowed, and the ETs unlocked and entered the craft. A sentry sent aboard with them came back out immediately, vomiting, but the ETs aboard did stop the beeping and then returned to the door

and presented themselves for return to Los Alamos. That was reported to me by an eyewitness.

I, myself, didn't believe any of this at first, but slowly as the gathered information and confirming evidence accumulated, I was forced to reconsider a lot of things. I now accept the fact that an underground base at Dulce, New Mexico, does in fact exist. I also accept the fact that we have recovered remains of alien vehicles in storage and under study at Area 51 in the AEC Area in Nevada. These both offer the potential for scientific and technical breakthroughs that we may even be now benefiting from in our lives today. Let us hope we learn to use these new technologies wisely, and not destructively as we did with the atomic sciences.

UNDERGROUND BASES LECTURE, MAY 1995
Lecture By Phil Schneider

Phil Schneider, the lecturer of this article, was executed under mysterious circumstances in January 1996. According to some, he had been tortured repeatedly before his death. Phil Schneider was an ex-government engineer who was involved in building underground facilities. He was one of three people to survive the 1979 fire fight between the Greys and the U.S. intelligence/military forces at the Dulce underground base in New Mexico. In May 1995, Phil Schneider lectured on what he had discovered during his career. Seven months afterward, he was tortured and killed by those whom he had previously been employed by.
Lecture Starts:

"It is because of the horrendous structure of the federal government that I feel directly imperiled not to tell anybody about this material. How long I will be able to do this is anybody's guess. However, I would like to mention that this talk is going to be broken up into four main topics. Each of these topics will have some bearing on what you people are involved in, whether you are patriots or not.

I want you to know that these United States are a beautiful place. I have gone to more than 70 countries, and I cannot remember any country that has the beauty, as well as the magnificence of its people, like these United States.

To give you an overview of basically what I am, I started off and went through engineering school. Half of my school was in that field, and I built up a reputation for being a geological engineer, as well as a structural engineer with both military and aerospace applications. I have helped build two main bases in the United States that have some significance as far as what is called the New World Order. The first base is the one at Dulce, New Mexico. I was involved in 1979 in a firefight with alien humanoids, and I was one of the survivors. I'm probably the only talking survivor you will ever hear. Two other survivors are under close guard. I am the only one left that knows the detailed files of the entire operation. Sixty-six secret service agents, FBI, Black Berets and the like, died in that firefight. I was there.

Number one, part of what I am going to tell you is going to be very

shocking. Part of what I am going to tell you is probably going to be very unbelievable, though, instead of putting your glasses on, I'm going to ask you to put your "scepticals" on. But please, feel free to do your own homework. I know the Freedom of Information Act isn't much to go on, but it's the best we've got. The local law library is a good place to look for Congressional Records. So, if one continues to do their homework, then one can be standing vigilant in regard to their country."

Deep Underground Military Bases and the Black Budget

"I love the country I am living in more than I love my life, but I would not be standing before you now, risking my life, if I did not believe it was so. The first part of this talk is going to concern deep underground military bases and the black budget. The Black Budget is a secretive budget that garners 25% of the gross national product of the United States. The Black Budget currently consumes \$1.25 trillion per year. At least this amount is used in black programs, like those concerned with deep underground military bases. Presently, there are 129 deep underground military bases in the United States.

They have been building these 129 bases day and night, unceasingly, since the early 1940's. Some of them were built even earlier than that. These bases are basically large cities underground connected by high-speed magneto-leviton trains that have speeds up to Mach 2. Several books have been written about this activity. Al Bielek has my only copy of one of them. Richard Souder, a Ph.D architect*, has risked his life by talking about this. He worked with a number of government agencies on deep underground military bases. In around where you live, in Idaho, there are 11 of them.

The average depth of these bases is over a mile, and they again are basically whole cities underground. They all are between 2.66 and 4.25 cubic miles in size. They have laser drilling machines that can drill a tunnel seven miles long in one day. The Black Projects sidestep the authority of Congress, which as we know is illegal. Right now, the New World Order is depending on these bases. If I had known at the time I was working on them that the NWO was involved, I would not have done it. I was lied to rather extensively."

Development of Military Technology, Implied German Interest in Hyperspatial Technology, and More:

"Basically, as far as technology is concerned, for every calendar year that transpires, military technology increases about 44.5 years. This is why it is easy to understand that back in 1943 they were able to create, through the use of vaccum tube technology, a ship that could literally disappear from one place and appear in another place. My father, Otto Oscar Schneider, fought on both sides of the war. He was originally a U-boat captain, and was captured and repatriated in the United States. He was involved with different kinds of concerns, - such as the A-bomb, the H-bomb and the Philadelphia Experiment. He invented a high-speed camera that took pictures of the first atomic tests at Bikini Island on July 12, 1946. I have original photographs of that test, and the photos also show UFO's fleeing the bomb site at a high rate of speed. Bikini Island at the time was infested with them, especially under the water, and the natives had problems with their animals being mutilated. At that time, General MacArthur felt that the next war would be with aliens from other worlds.

Anyway, my father laid the groundwork with theoreticians about the Philadelphia experiment, as well as other experiments. What does that have to do with me? Nothing, other than the fact that he was my father. I don't agree with what he did on the other side, but I think he had a lot of guts in coming here. He was hated in Germany. There was a \$1 million reward, payable in gold, to anyone who killed him. Obviously, they didn't succeed. Anyway, back to our topic - deep underground bases."

The Fire Fight at Dulce:

"Back in 1954, under the Eisenhower administration, the federal government decided to circumvent the Constitution of the United States and form a treaty with alien entities. It was called the 1954 Greeda Treaty, which basically made the agreement that the aliens involved could take a few cows and test their implanting techniques on a few human beings, but that they had to give details about the people involved. Slowly, the aliens altered the bargain until they decided they wouldn't abide by it at all. Back in 1979, this was the reality, and the fire-fight at Dulce occurred quite by accident. I was involved in building an addition to the deep underground military base at Dulce, which is probably the deepest base. It goes down seven levels and over 2.5 miles deep. At that particular time, we had drilled four distinct holes in the desert, and we were going to link them together and blow out large sections at a time. My job was to go down the holes and check the rock samples, and recommend the explosive to deal with the particular rock. As I was headed down there, we found ourselves amidst a large cavern that was full of outer-space aliens, otherwise known as large Greys. I shot two of them. At that time, there were 30 people down there. About 40 more came down after this started, and all of them got killed. We had surprised a whole underground base of existing aliens. Later, we found out that they had been living on our planet for a long time, perhaps a million years. This could explain a lot of what is behind the theory of ancient astronauts.

Anyway, I got shot in the chest with one of their weapons, which was a box on their body, that blew a hole in me and gave me a nasty dose of cobalt radiation. I have had cancer because of that.

I didn't get really interested in UFO technology until I started work at Area 51, north of Las Vegas. After about two years recuperating after the 1979 incident, I went back to work for Morrison and Knudson, EG&G and other companies. At Area 51, they were testing all kinds of peculiar spacecraft. How many people here are familiar with Bob Lazar's story? He was a physicist working at Area 51 trying to decipher the propulsion factor in some of these craft."

Schneider's Worries About Government Factions, Railroad Cars and Shackle Contracts:

"Now, I am very worried about the activity of the the federal government. They have lied to the public, stonewalled senators, and have refused to tell the truth in regard to alien matters. I can go on and on. I can tell you that I am rather disgruntled. Recently, I knew someone who lived near where I live in Portland, Oregon. He worked at Gunderson Steel Fabrication, where they make railroad cars. Now, I knew this fellow for the better part of 30 years, and he was kind of a quiet type. He came in to see me one day, excited, and he told me "they're building prisoner cars." He was nervous. Gunderson, he said, had a contract with the federal government to build 107,200

full length railroad cars, each with 143 pairs of shackles. There are 11 sub-contractors in this giant project. Supposedly, Gunderson got over 2 billion dollars for the contract. Bethlehem Steel and other steel outfits are involved. He showed me one of the cars in the rail yards in North Portland. He was right. If you multiply 107,200 times 143 times 11, you come up with about 15,000,000. This is probably the number of people who disagree with the federal government. No more can you vote any of these people out of office. Our present structure of government is "technocracy", not democracy, and it is a form of feudalism. It has nothing to do with the republic of the United States. These people are god-less, and have legislated out prayer in public schools. You can get fined up to \$100,000 and two years in prison for praying in school. I believe we can do better. I also believe that the federal government is running the gambit of enslaving the people of the United States. I am not a very good speaker, but I'll keep shooting my mouth off until somebody puts a bullet in me, because it's worth it to talk to a group like this about these atrocities."

America's Black Program Contractors:

"There are other problems. I have some interesting 1993 figures. There are 29 prototype stealth aircraft presently. The budget from the U.S. Congress five-year plan for these is \$245.6 million. You couldn't buy the spare parts for these black programs for that amount. So, we've been lied to. The black budget is roughly \$1.3 trillion every two years. A trillion is a thousand billion. A trillion dollars weighs 11 tons. The U.S. Congress never sees the books involved with this clandestine pot of gold. Contractors of stealth programs: EG&G, Westinghouse, McDonnell Douglas, Morrison-Knudson, Wackenhut Security Systems, Boeing Aerospace, Lorimar Aerospace, Aerospacial in France, Mitsubishi Industries, Rider Trucks, Bechtel, *I.G. Farben*, plus a host of hundreds more. Is this what we are supposed to be living up to as freedom-loving people? I don't believe so."

Star Wars and Apparent Alien Threat:

"Still, 68% of the military budget is directly or indirectly affected by the black budget. Star Wars relies heavily upon stealth weaponry. By the way, none of the stealth program would have been available if we had not taken apart crashed alien disks. None of it. Some of you might ask what the "space shuttle" is "shuttling". Large ingots of special metals that are milled in space and cannot be produced on the surface of the earth. They need the near vacuum of outer space to produce them. We are not even being told anything close to the truth. I believe our government officials have sold us down the drain - lock, stock and barrel. Up until several weeks ago, I was employed by the U.S. government with a Ryolite-38 clearance factor - one of the highest in the world. I believe the Star Wars program is there solely to act as a buffer to prevent alien attack - it has nothing to do with the "cold war", which was only a toy to garner money from all the people - for what? The whole lie was planned and executed for the last 75 years."

Stealth Aircraft Technology Use by U.S. Agencies and the United Nations:

"Here's another piece of information for you folks. The Drug Enforcement Administration and the ATF rely on stealth tactical weaponry for as much as 40% of their operations budget. This in 1993,

and the figures have gone up considerably since. The United Nations used American stealth aircraft for over 28% of its collective worldwide operations from 1990 to 1992, according to the Center for Strategic Studies and UN Report 3092."

The Guardians of Stealth and Delta Force Origins of the Bosnia Conflict:

"The Guardians of Stealth: There are at least three distinct classifications of police that guard our most well-kept secrets. Number one, the Military Joint Tactical Force (MJTF), sometimes called the Delta Force or Black Berets, is a multi-national tactical force primarily used to guard the various stealth aircraft worldwide. By the way, there were 172 stealth aircraft built. Ten crashed, so there were at last count about 162. Bill Clinton signed them away about six weeks ago to the United Nations. There have been indications that the Delta Force was sent over to Bosnia during the last days of the Bush administration as a covert sniper force, and that they started taking pot shots at each side of the controversy, in order to actually start the Bosnia conflict that would be used by succeeding administrations for political purposes."

Contract With America:

"I don't perceive at this time that we have too much more than six months of life left in this country, at the present rate. We are the laughing stock of the world, because we are being hoodwinked by so many evil people that are ruining this country. I think we can do better. I think the people over 45 are seriously worried about their future. I'm going to run some scary scenarios by you. The Contract With America. It contains the same terminology that Adolph Hitler used to subvert Germany in 1931. I believe we can do better. The Contract With America is a last ditch effort by our federal government to tear away the Constitution and the Bill of Rights."

Some Statistics on the Black Helicopter Presence:

"The black helicopters. There are over 64,000 black helicopters in the United States. For every hour that goes by, there is one being built. Is this the proper use of our money? What does the federal government need 64,000 tactical helicopters for, if they are not trying to enslave us. I doubt if the entire military needs 64,000 worldwide. I doubt if all the world needs that many. There are 157 F-117A stealth aircraft loaded with LIDAR and computer-enhanced imaging radar. They can see you walking from room to room when they fly over your house. They see objects in the house from the air with a variation limit of 1 inch to 30,000 miles. That's how accurate that is. Now, I worked in the federal government for a long time, and I know exactly how they handle their business."

Government Earthquake Device, AIDS as a Bioweapon Based on Alien Excretions:

"The federal government has now invented an earthquake device. I am a geologist, and I know what I am talking about. With the Kobe earthquake in Japan, there was no pulsewave as in a normal earthquake. None. In 1989, there was an earthquake in San Francisco. There was no pulse wave with that one either. It is a Tesla device that is being used for evil purposes. The black budget programs have subverted science as we know it. Look at AIDs, invented by the National Ordinance Laboratory in Chicago, Illinois in 1972. It was a

biological weapon to be used against the people of the United States. The reason I know this is that I have seen the documentation by the Office of Strategic Services, which by the way is still in operation to this day, through the CDC in Atlanta. They used the glandular excretions of animals, humans and alien humanoids to create the virus. These alien humanoids the government is hobnobbing with are the worst news. There is absolutely no defense against their germs - none. They are a biological weapon of terrible consequence. Every alien on the planet needs to be isolated.

Saddam Hussein killed 3.5 million Kurdish people with a similar biological weapon. Do we, the people of this planet, deserve this? No, we don't, but we are not doing anything about it. Every moment we waste, we are doing other people on the planet a disservice. Right now, I am dying of cancer that I contracted because of my work for the federal government. I might live six months. I might not. I will tell you one thing. If I keep speaking out like I am, maybe God will give me the life to talk my head off. I will break every law that it takes to talk my head off. Eleven of my best friends in the last 22 years have been murdered. Eight of the murders were called "suicides." Before I went to talk in Las Vegas, I drove a friend down to Joshua Tree, near 29 Palms. I drove into the mountains in order to get to Needles, California, and I was followed by two government E-350 vans with G-14 plates, each with a couple of occupants, one of which had an Uzi. I knew exactly who they were. I have spoken 19 times and have probably reached 45,000 people. Well, I got ahead of them and came to a stop in the middle of the road. They both went on either side of me and down a ravine. Is this what its going to take? I cut up my security card and sent it back to the government, and told them if I was threatened, and I have been, that I was going to upload 140,000 pages of documentation to the internet about government structure and the whole plan. I have already begun that task."
